FIG. 1 is a front view of a high visibility sheet material showing my new design.

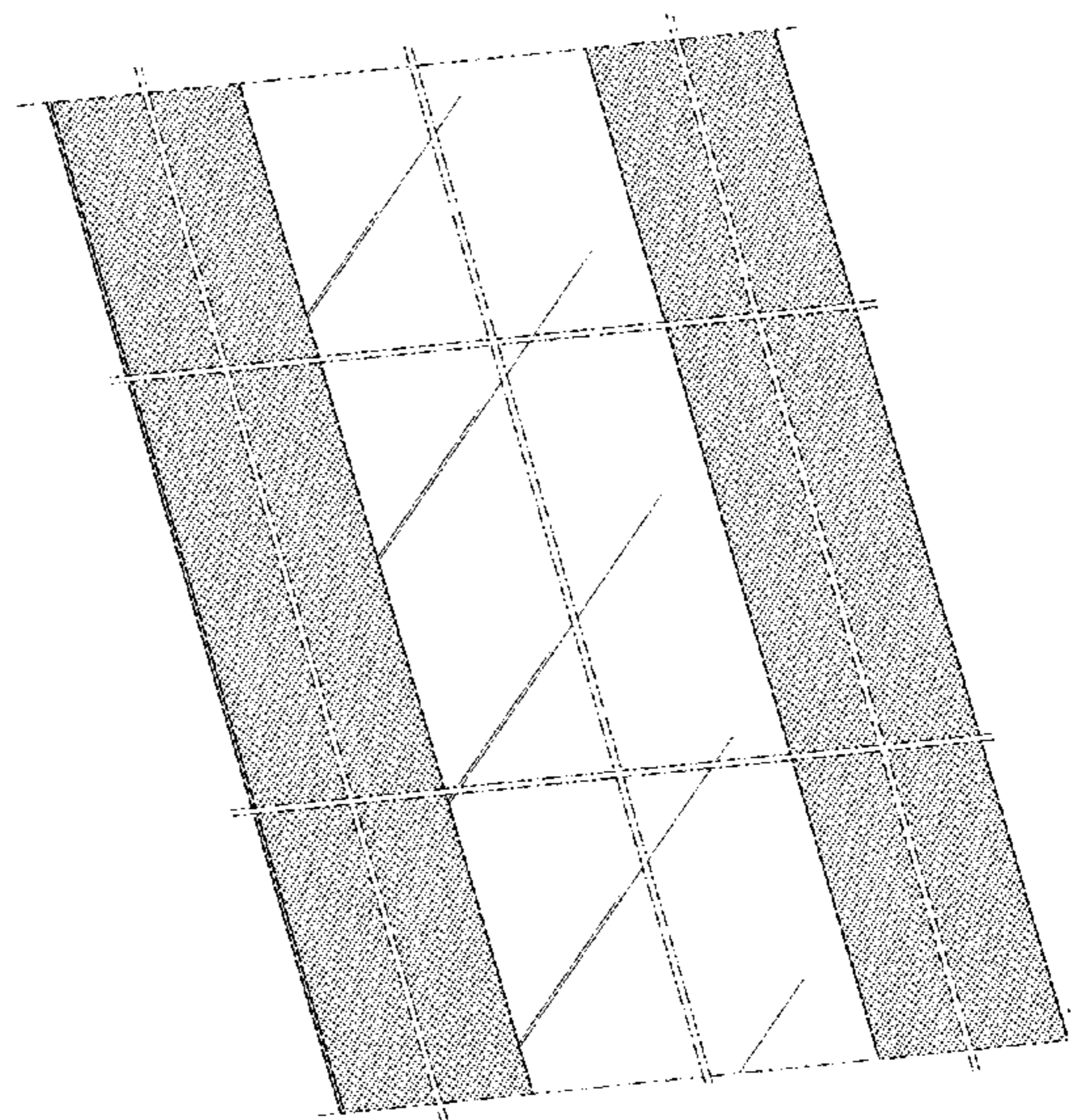
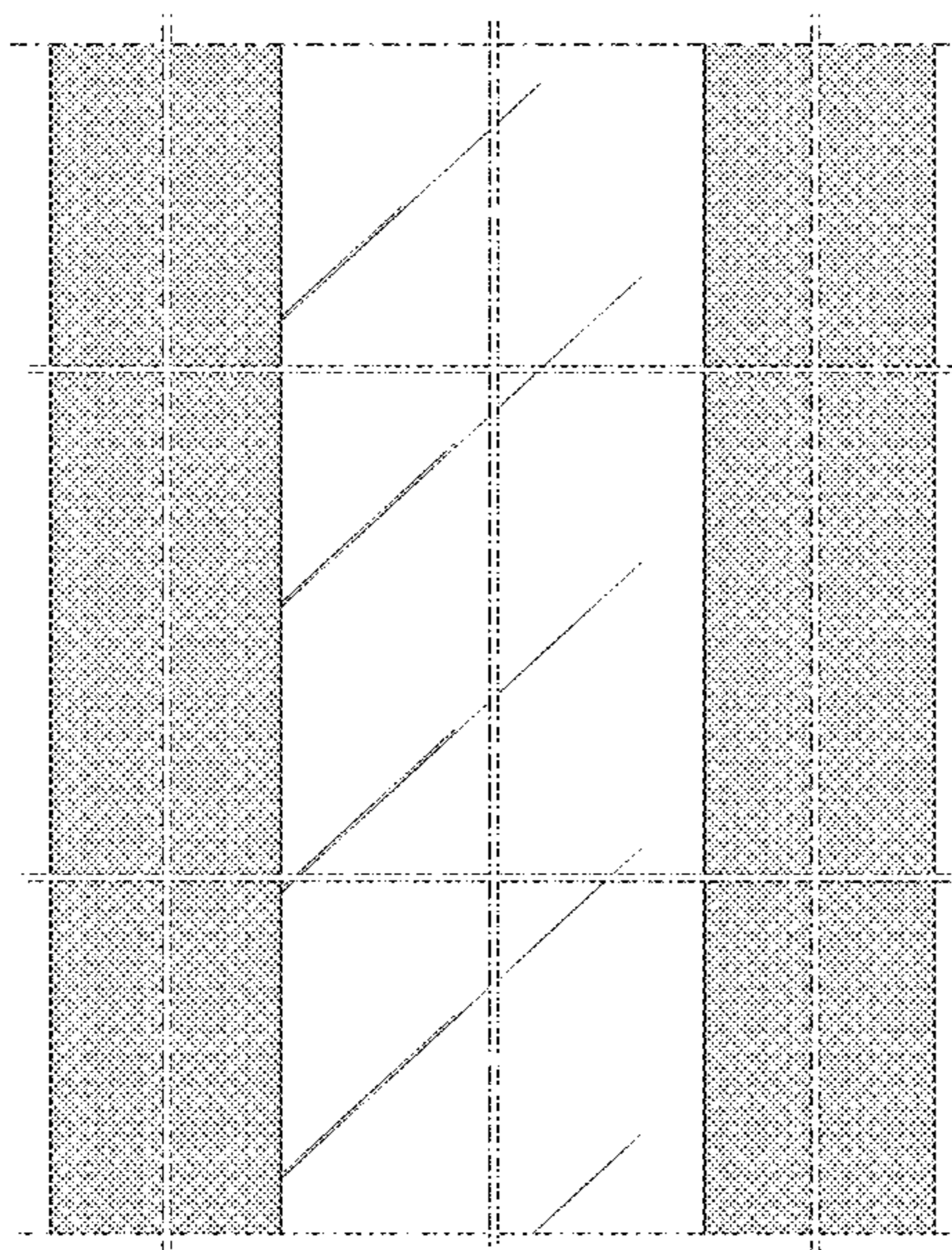
FIG. 2 is a side elevation view thereof, an opposite side view being identical;

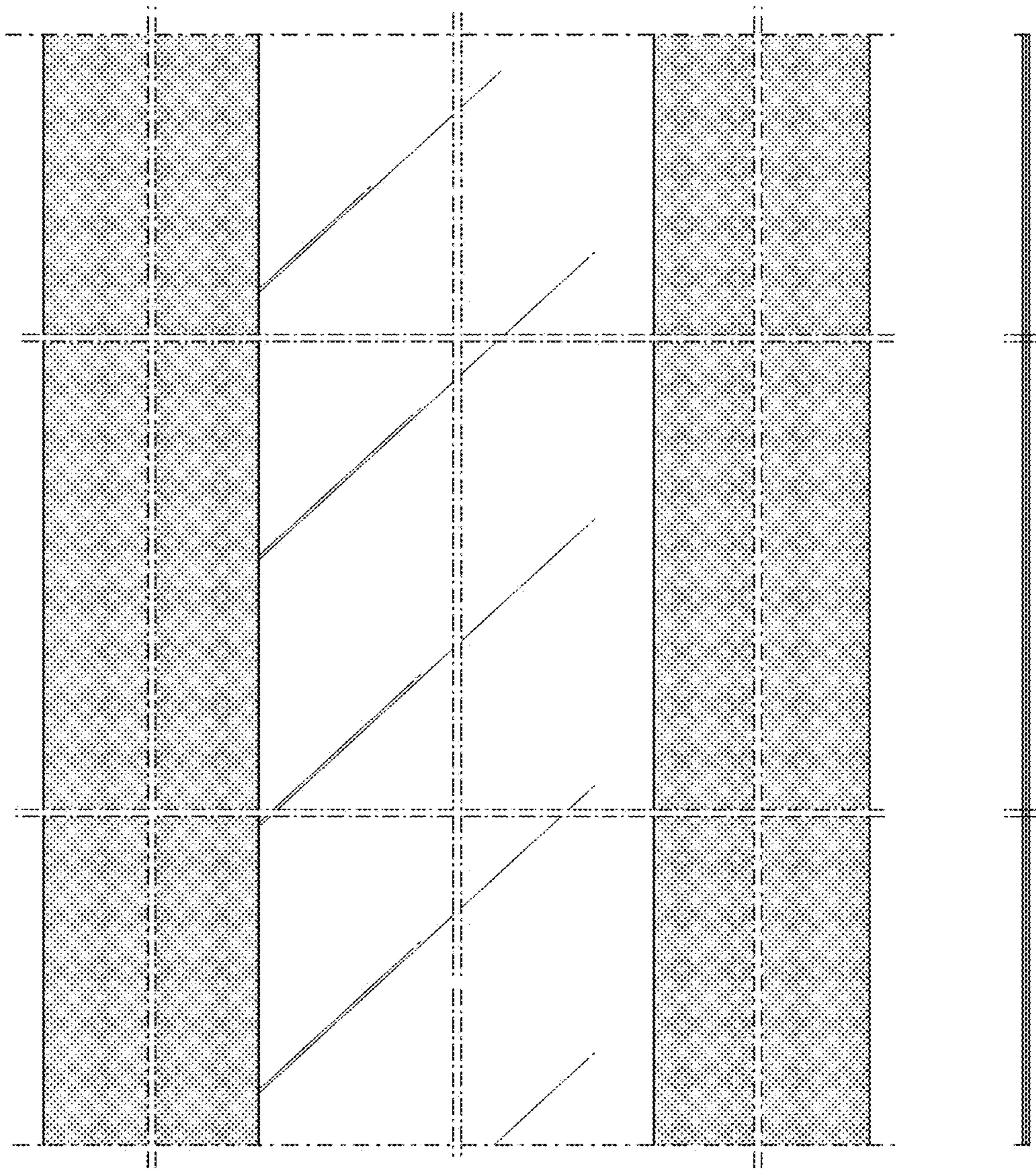

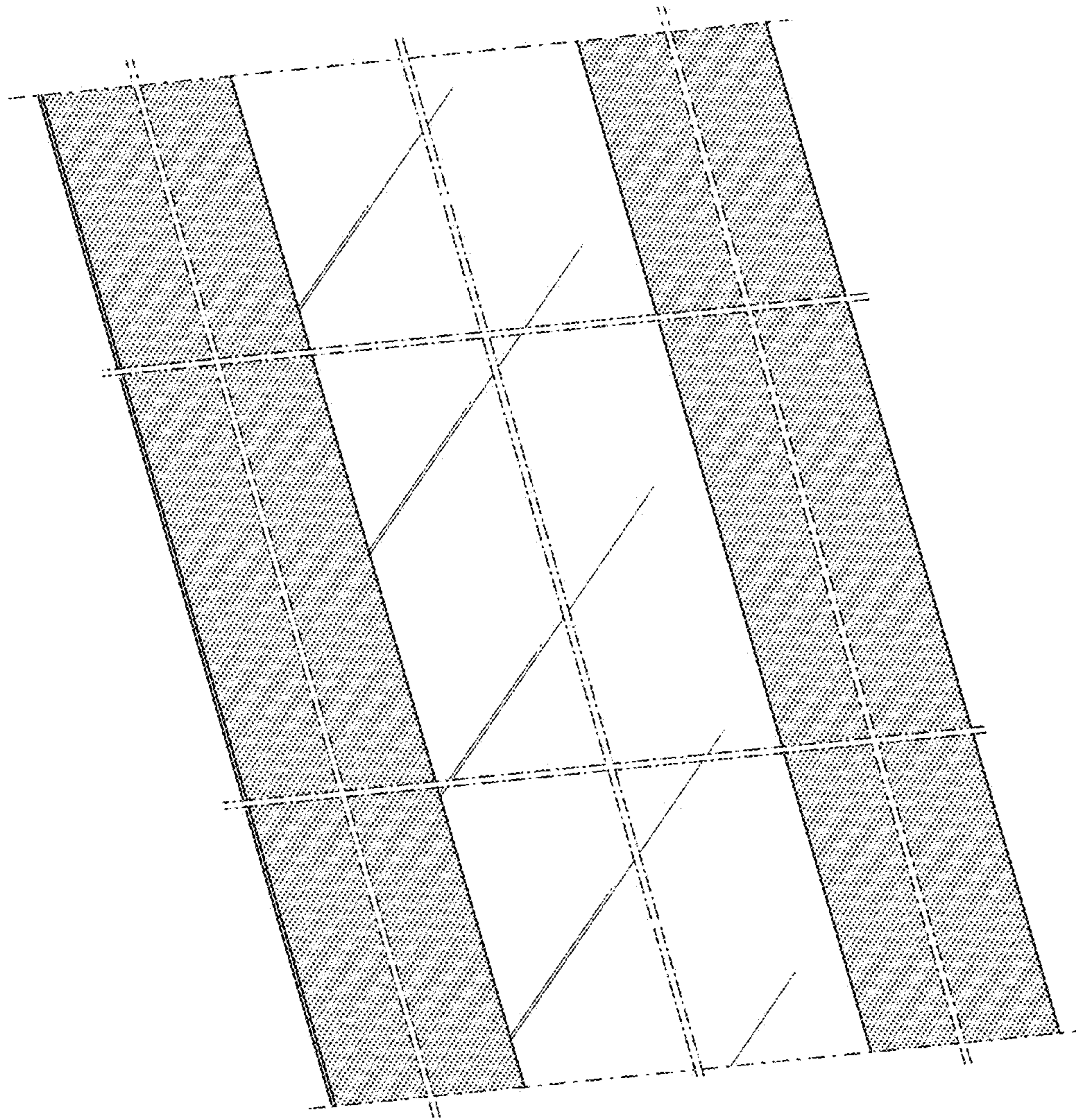

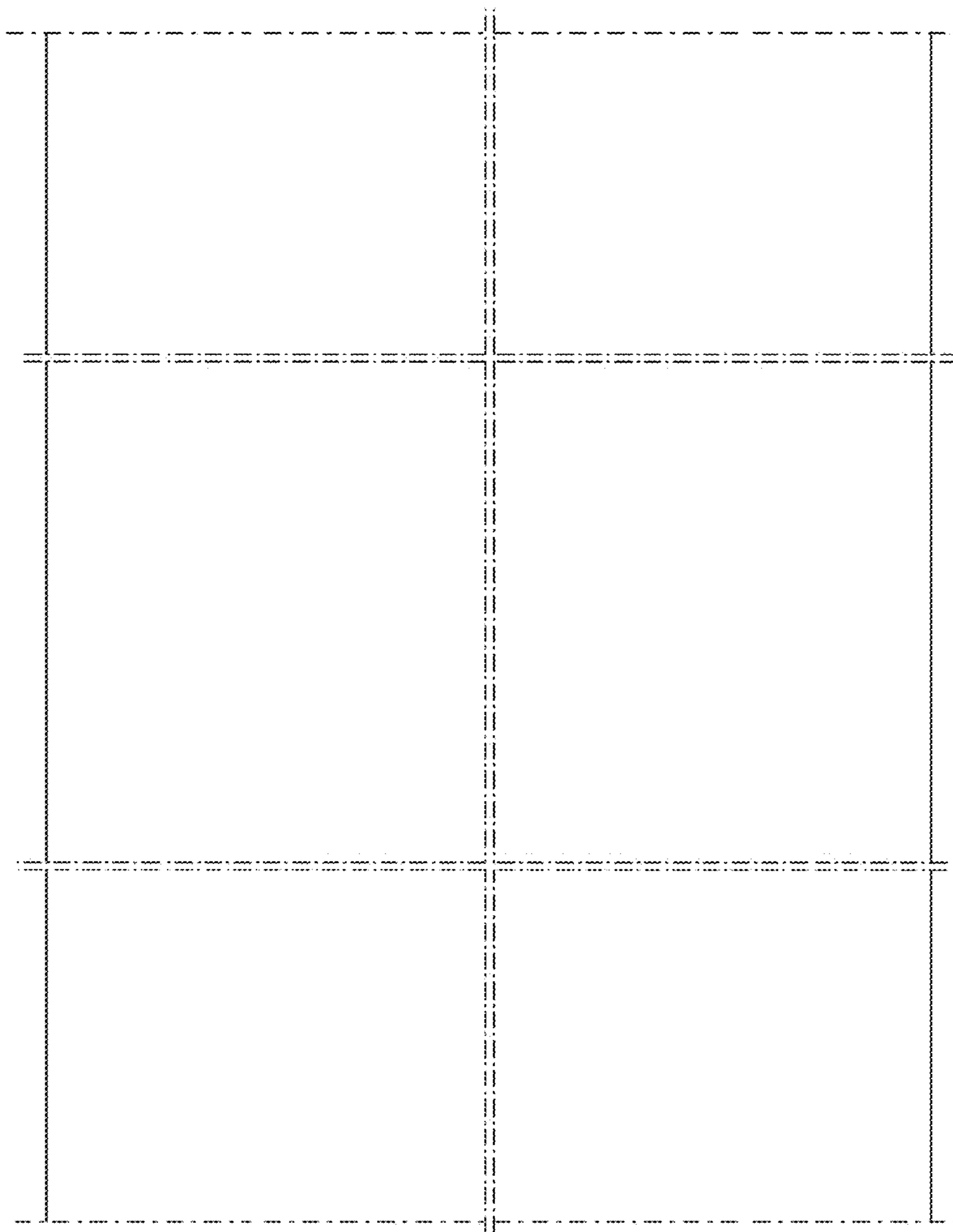
