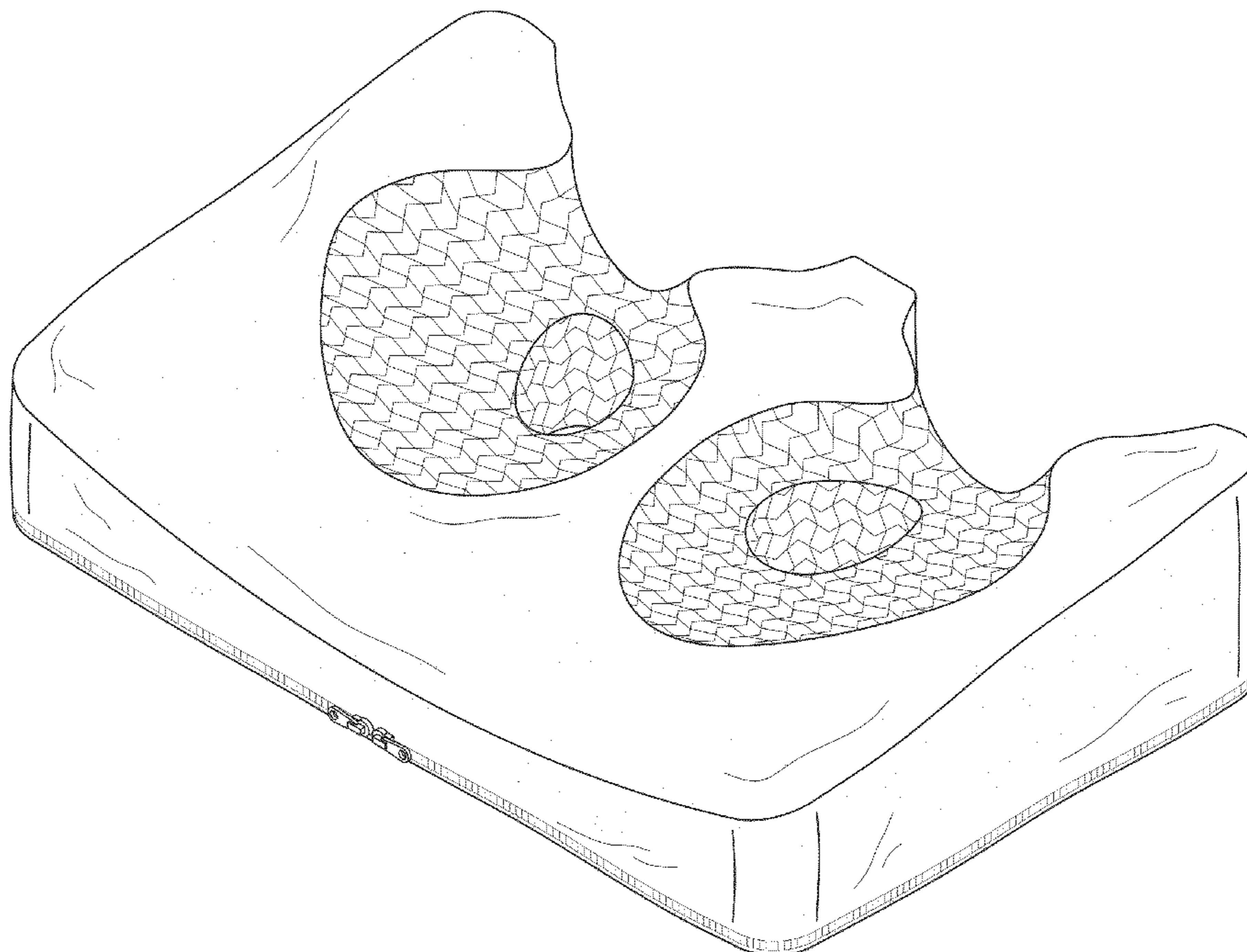
(57) **CLAIM**

I claim the ornamental design for a pillow case, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, rear perspective view of the pillow case.  
FIG. 2 is a bottom, front perspective view thereof.

FIG. 4 is a front side view thereof.

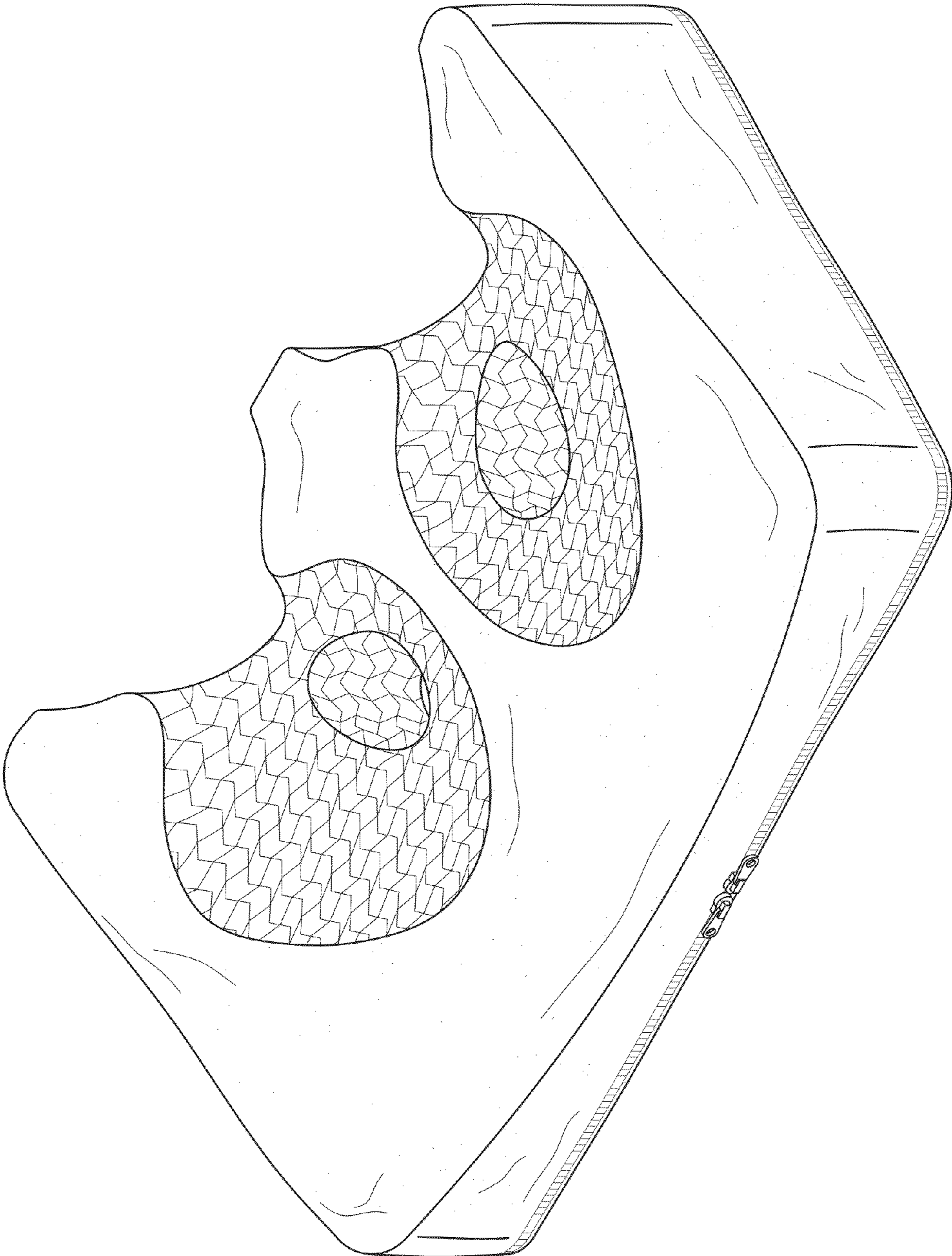

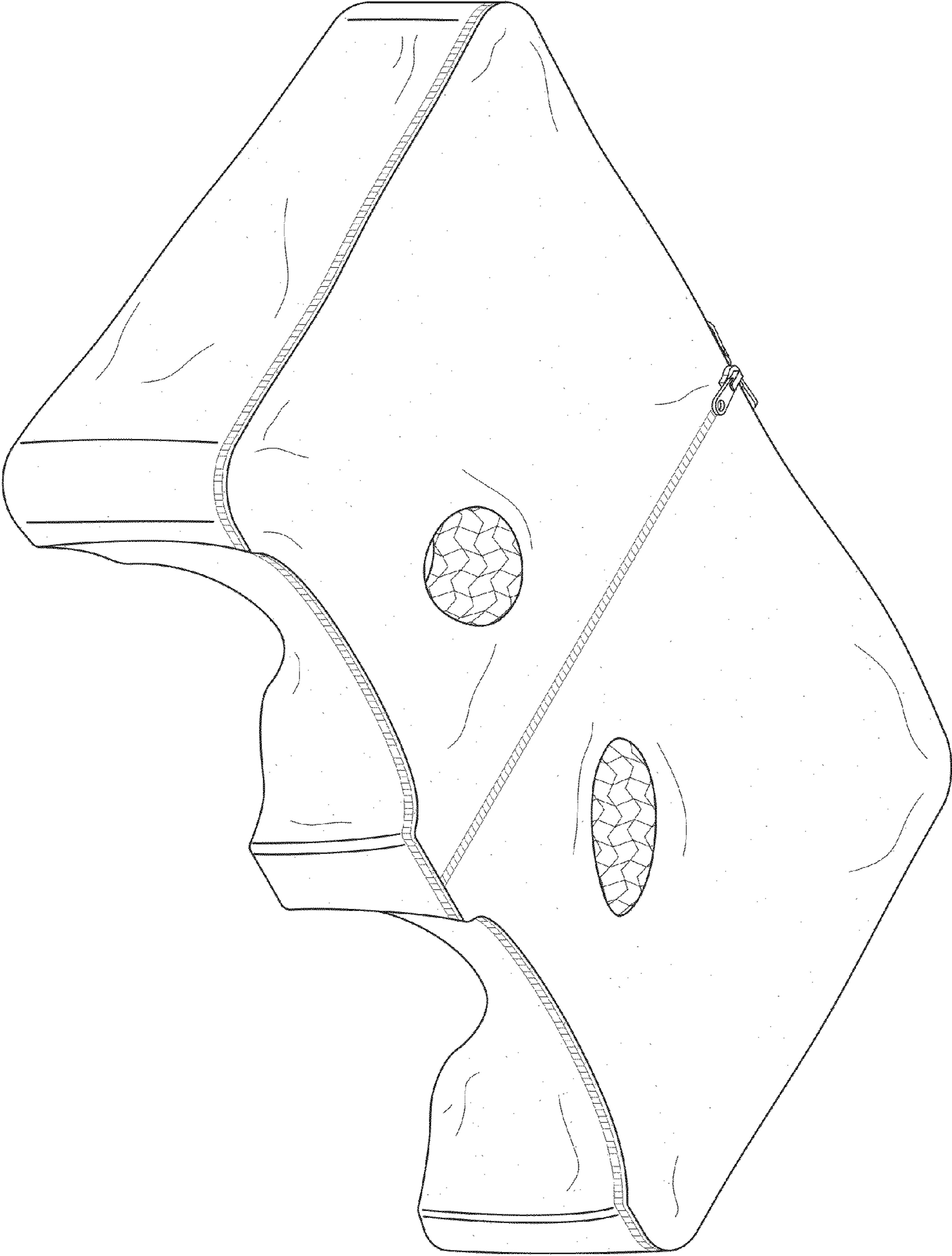

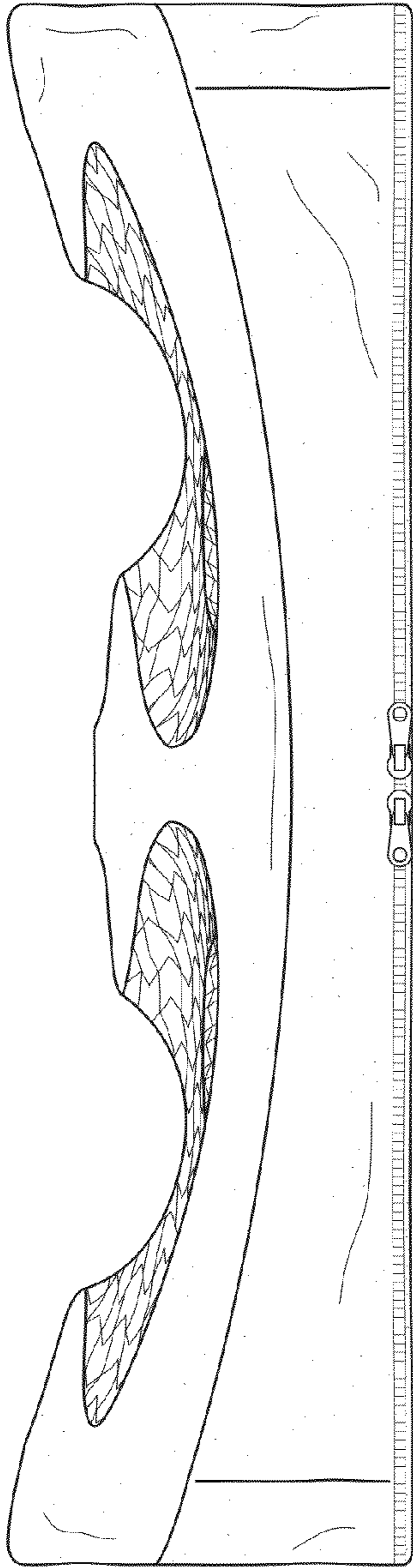

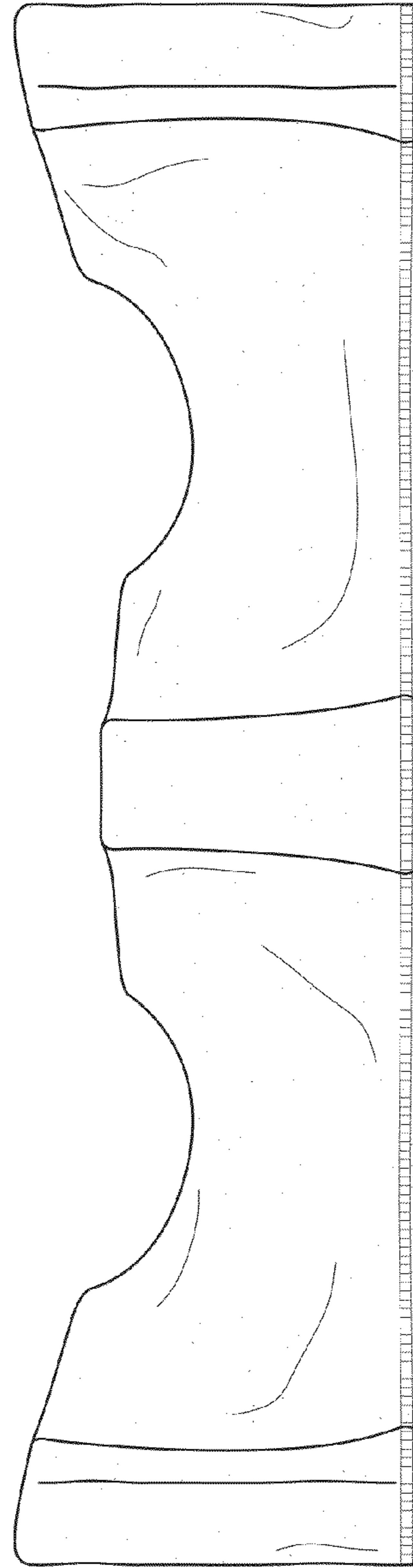

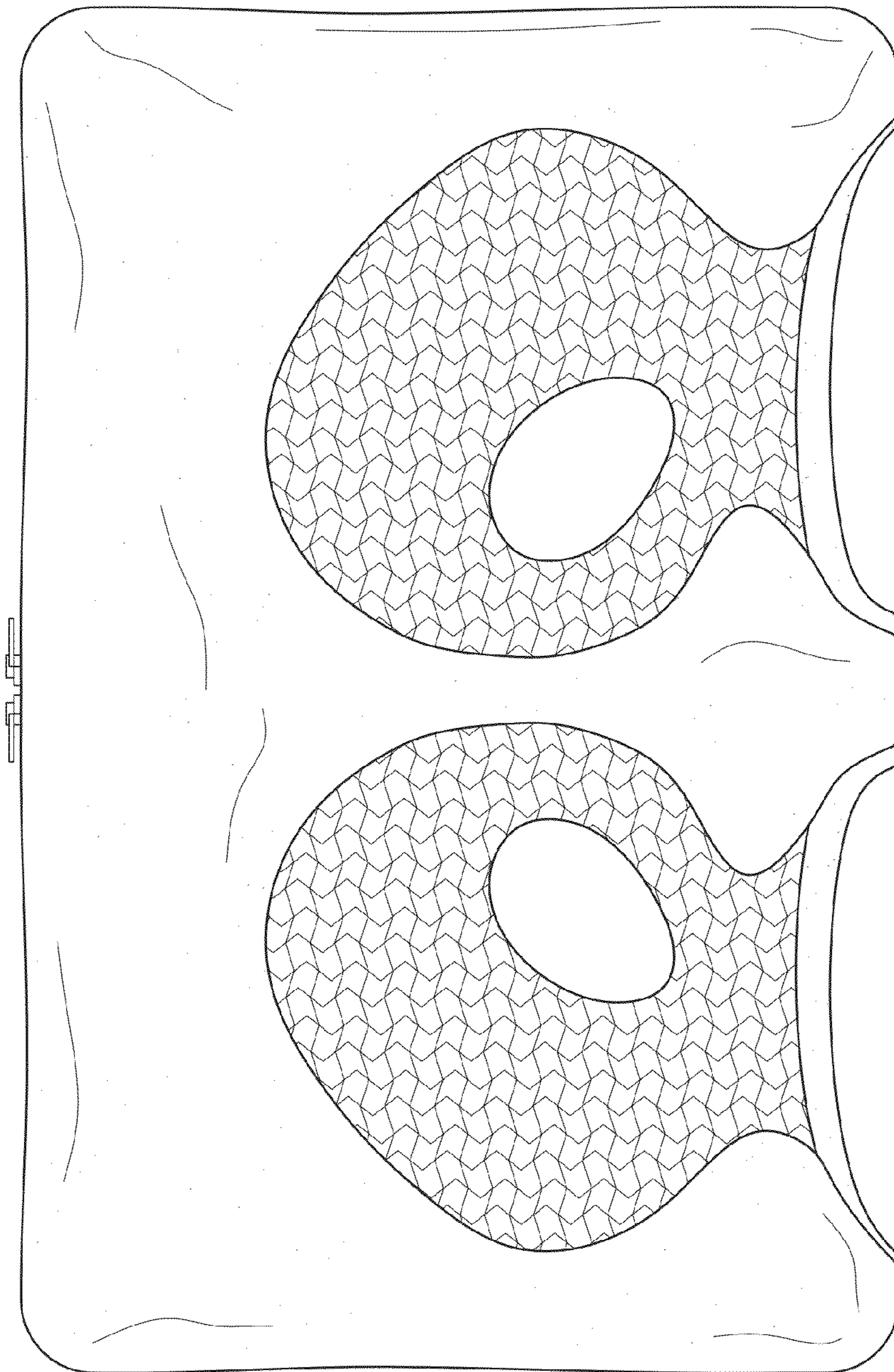

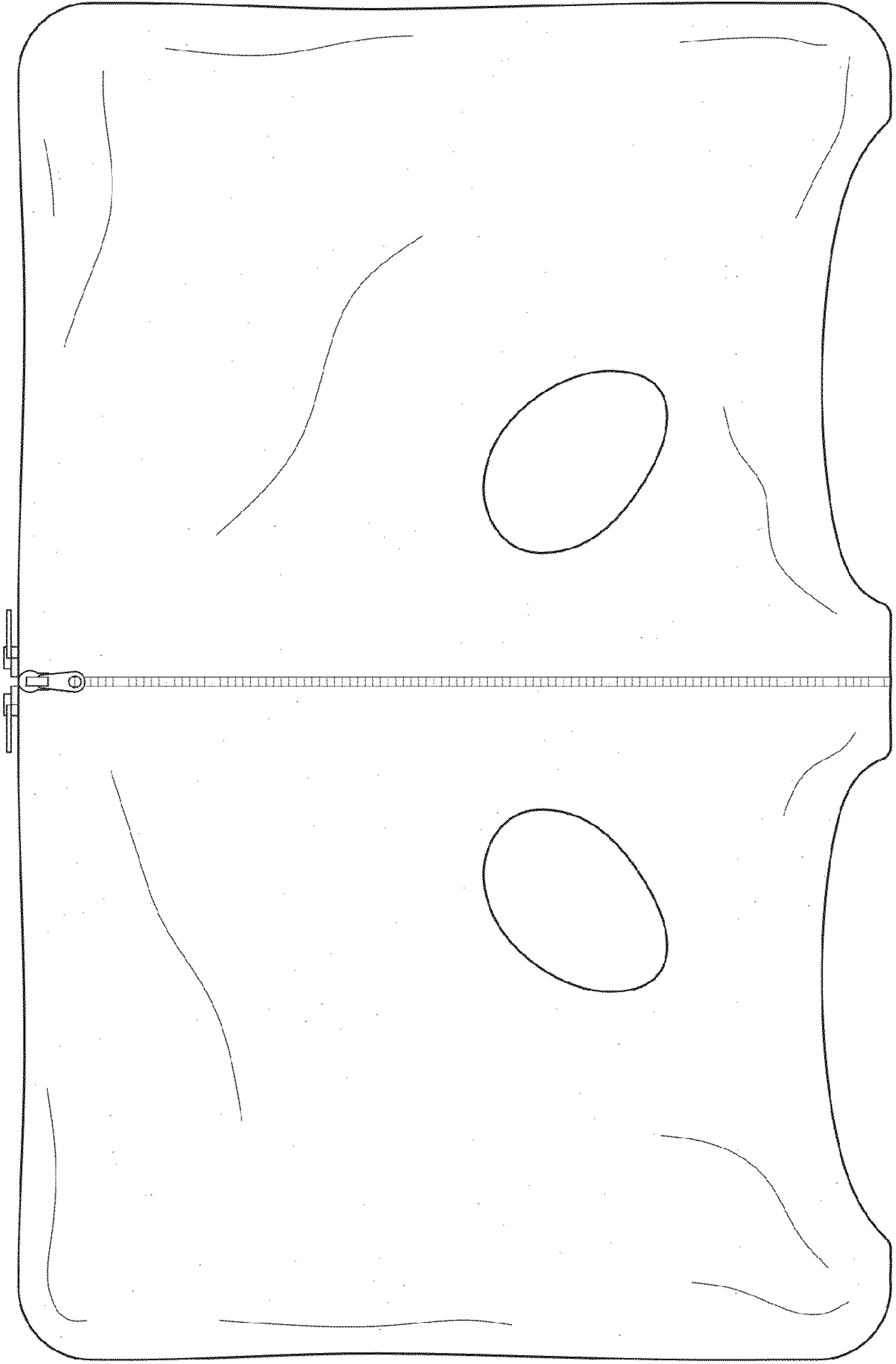

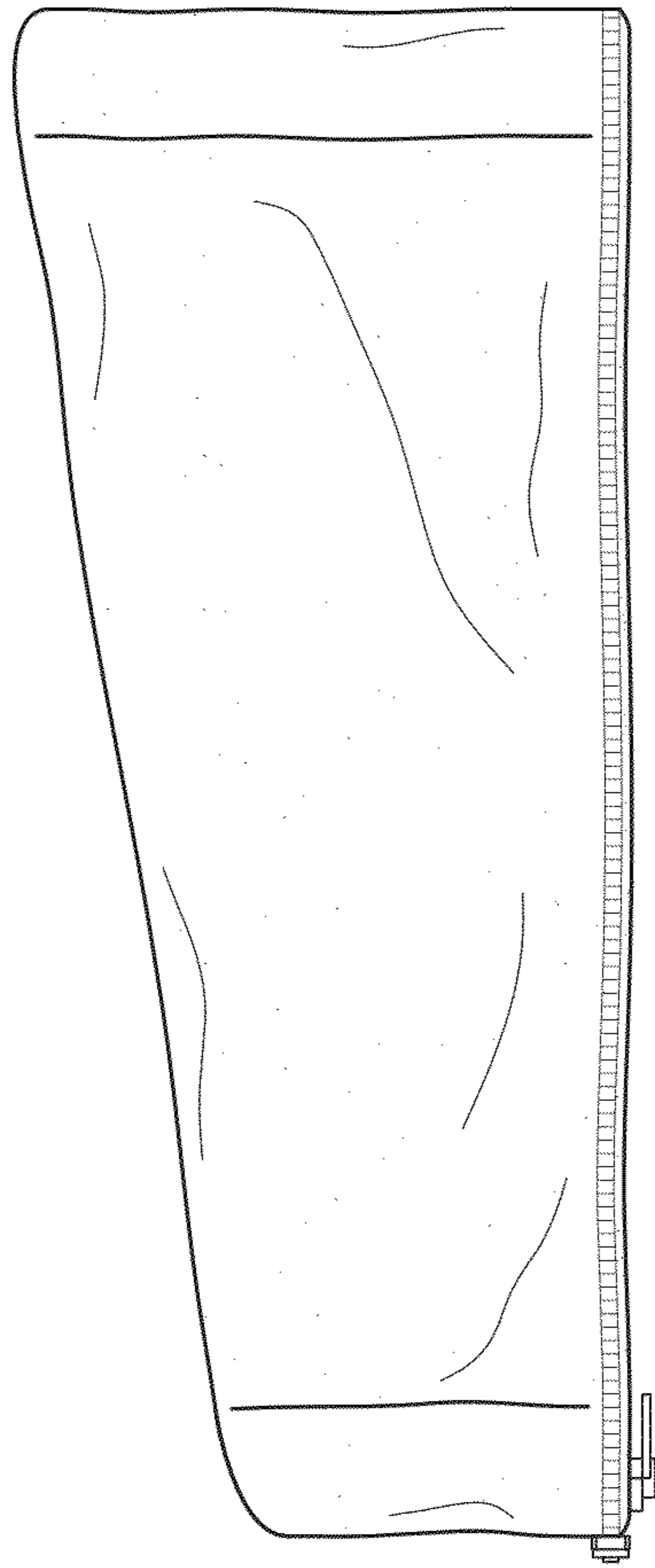
