FIG. 4 is a left-side view of the mini bar shown in FIG. 1;

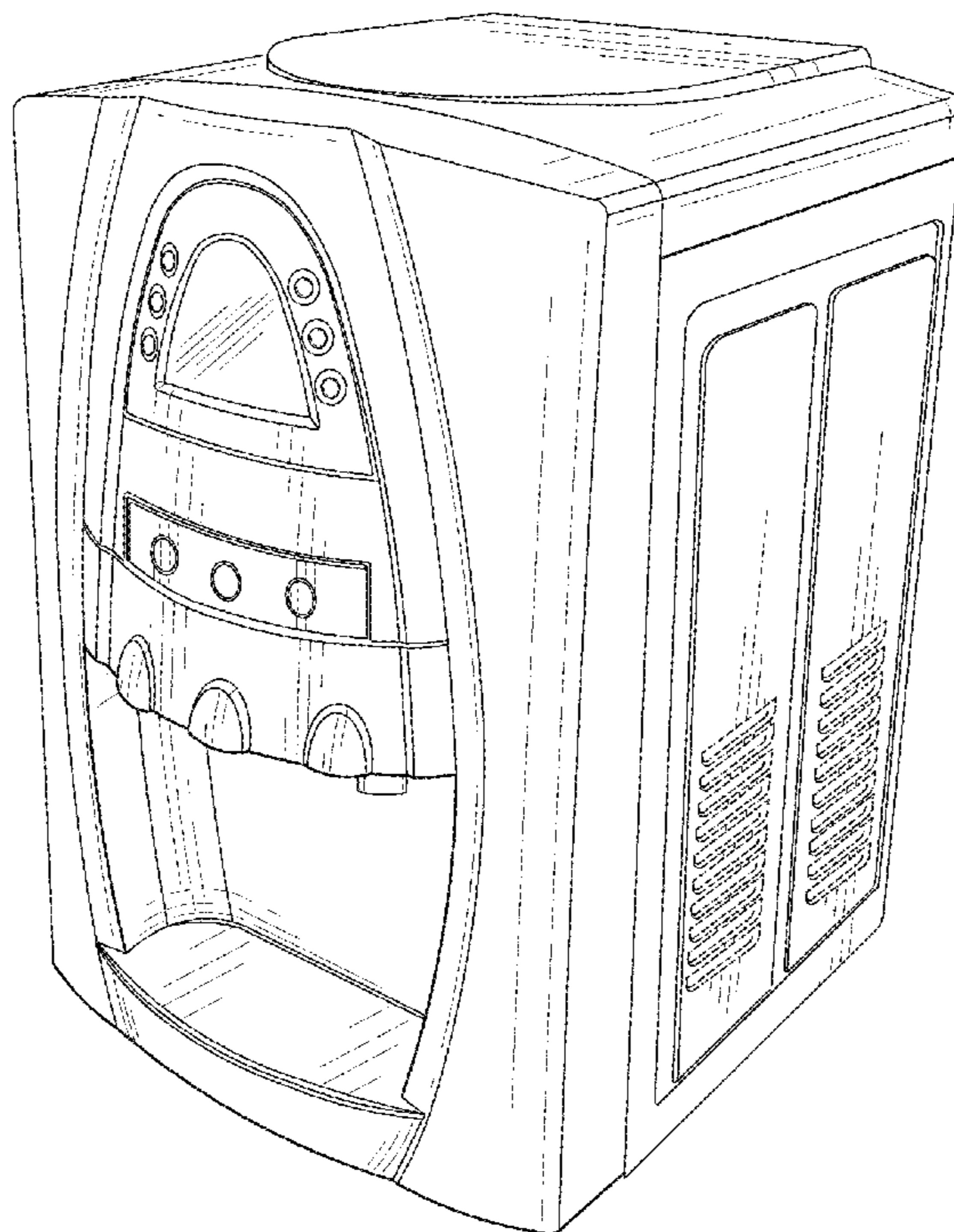
FIG. 5 is a right-side view of the mini bar shown in FIG. 1;

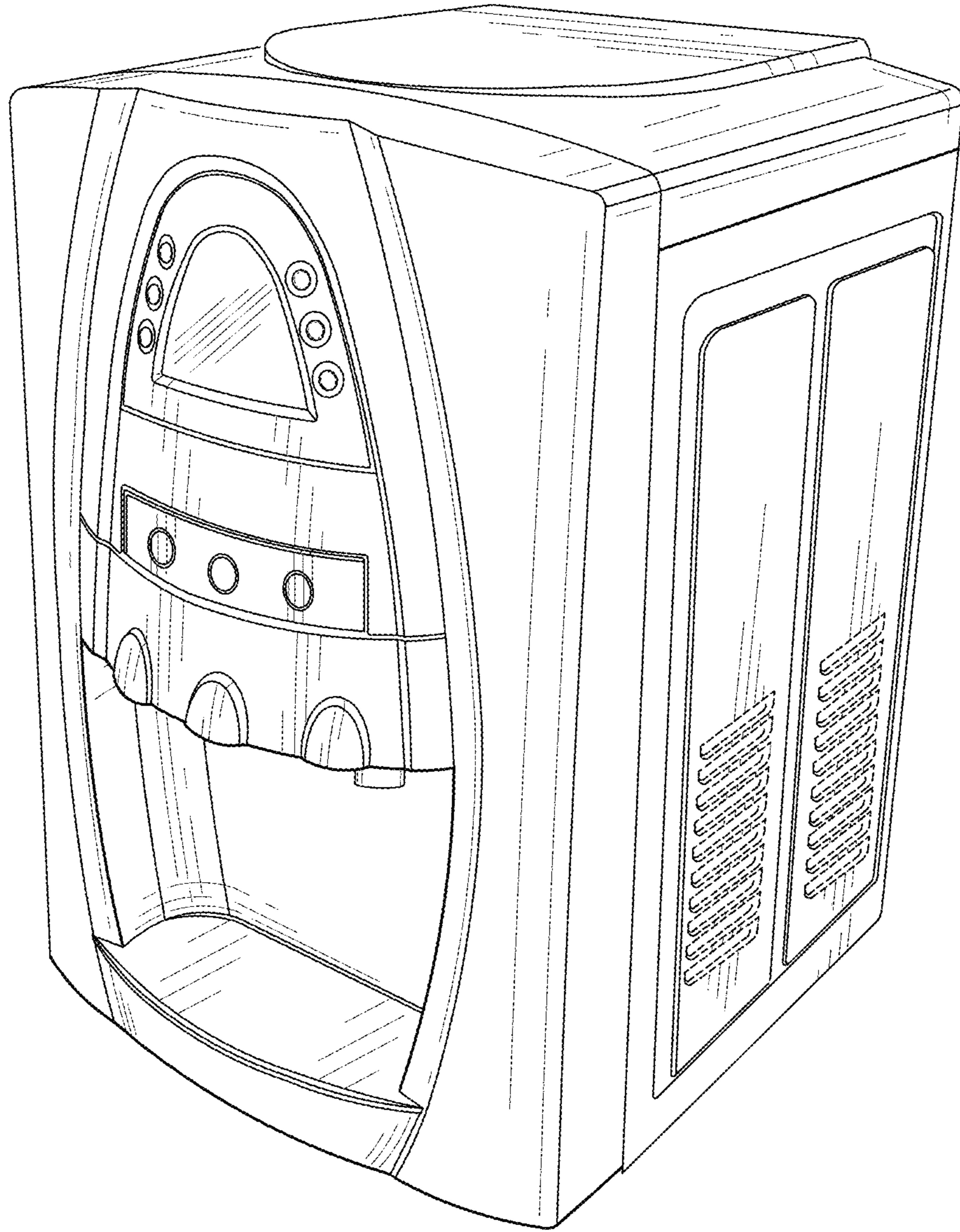

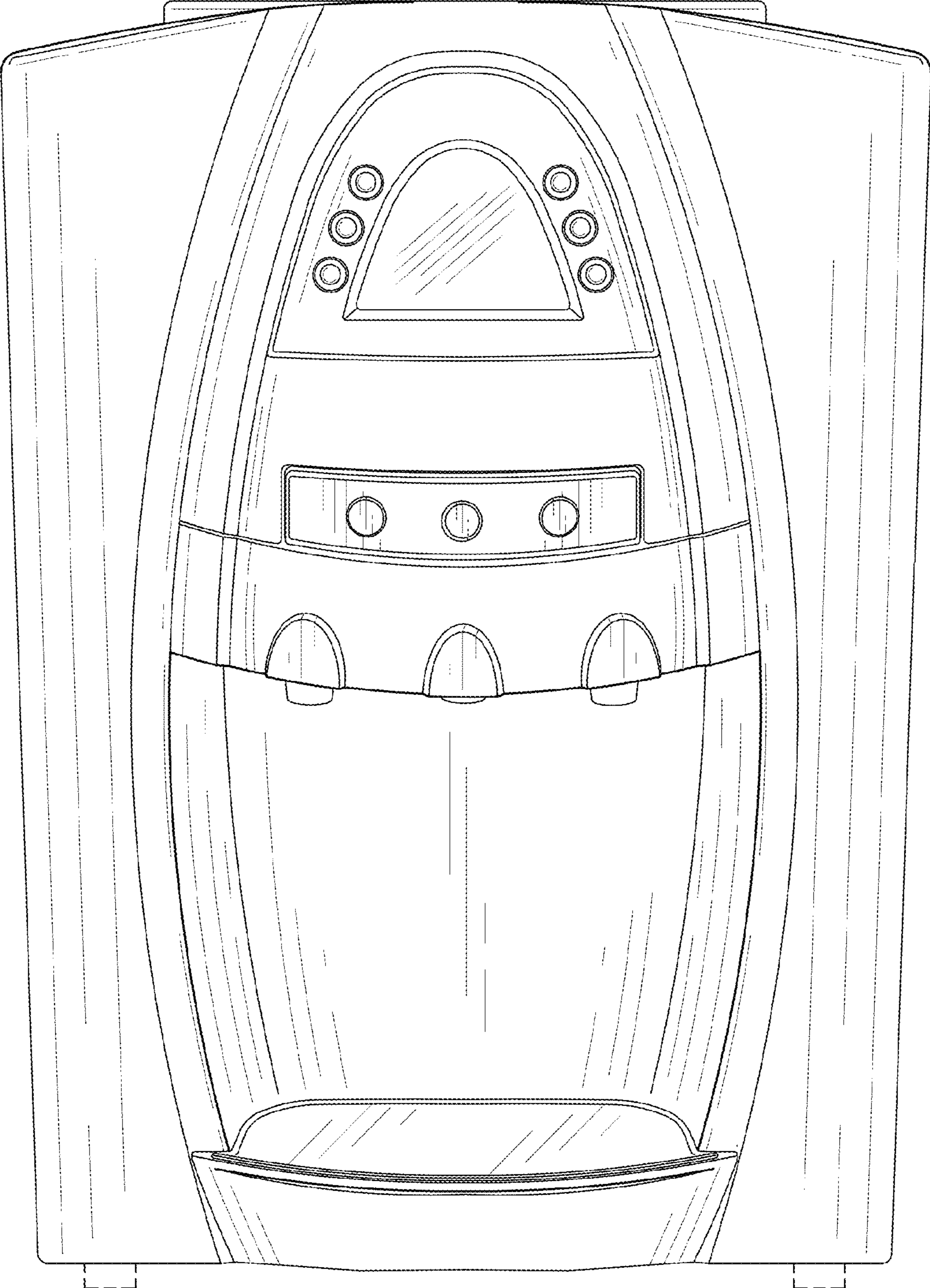

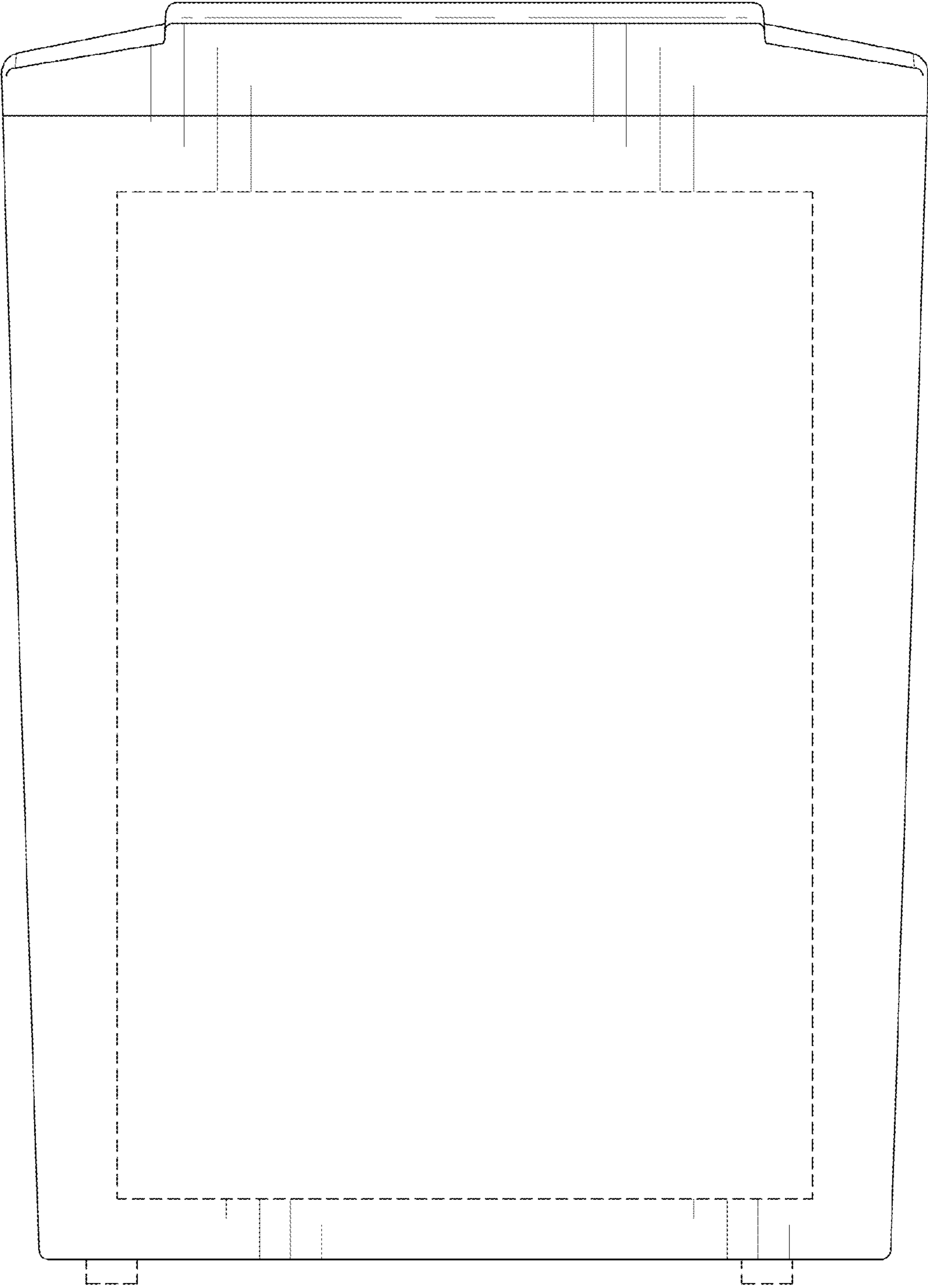

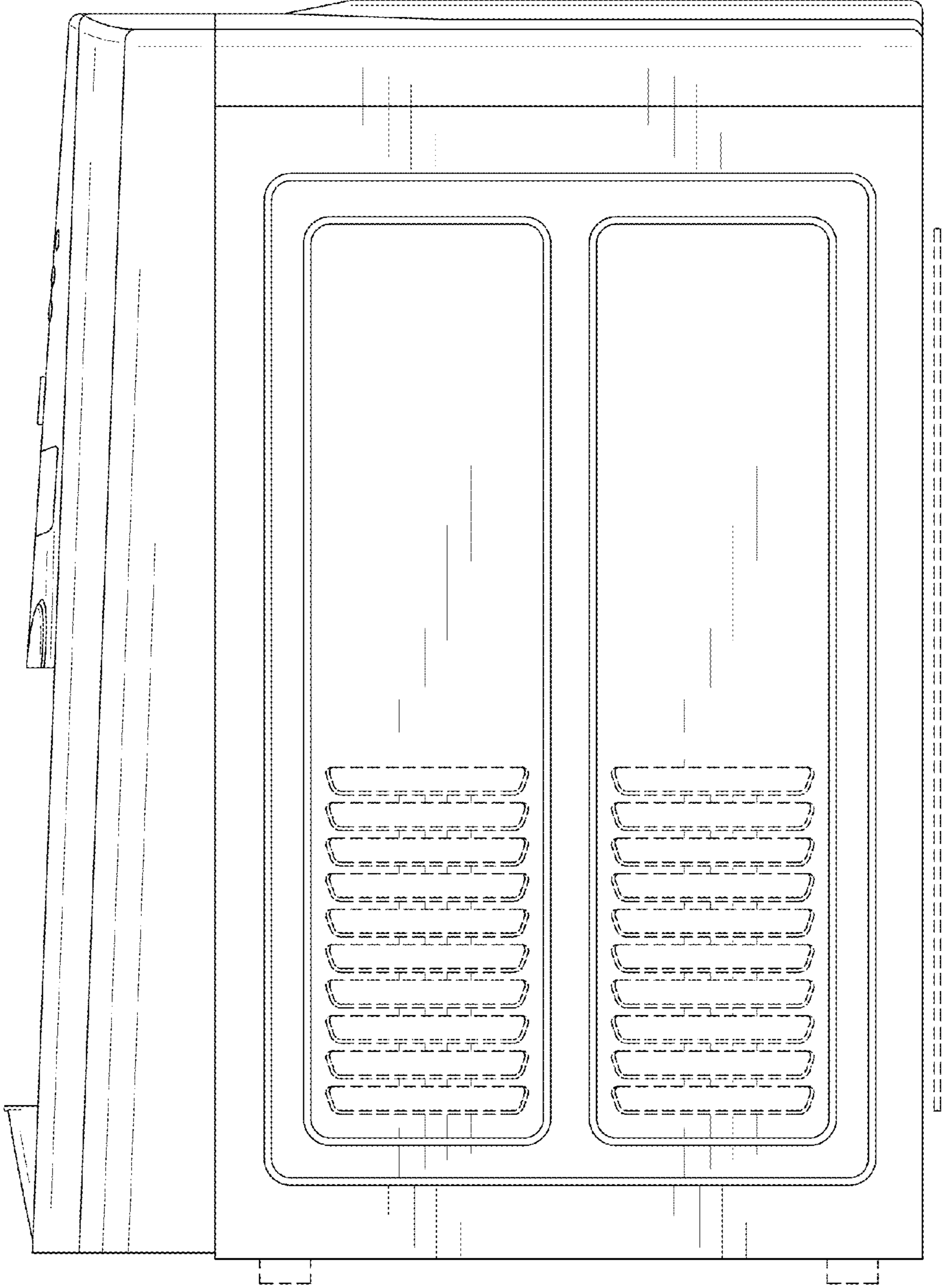

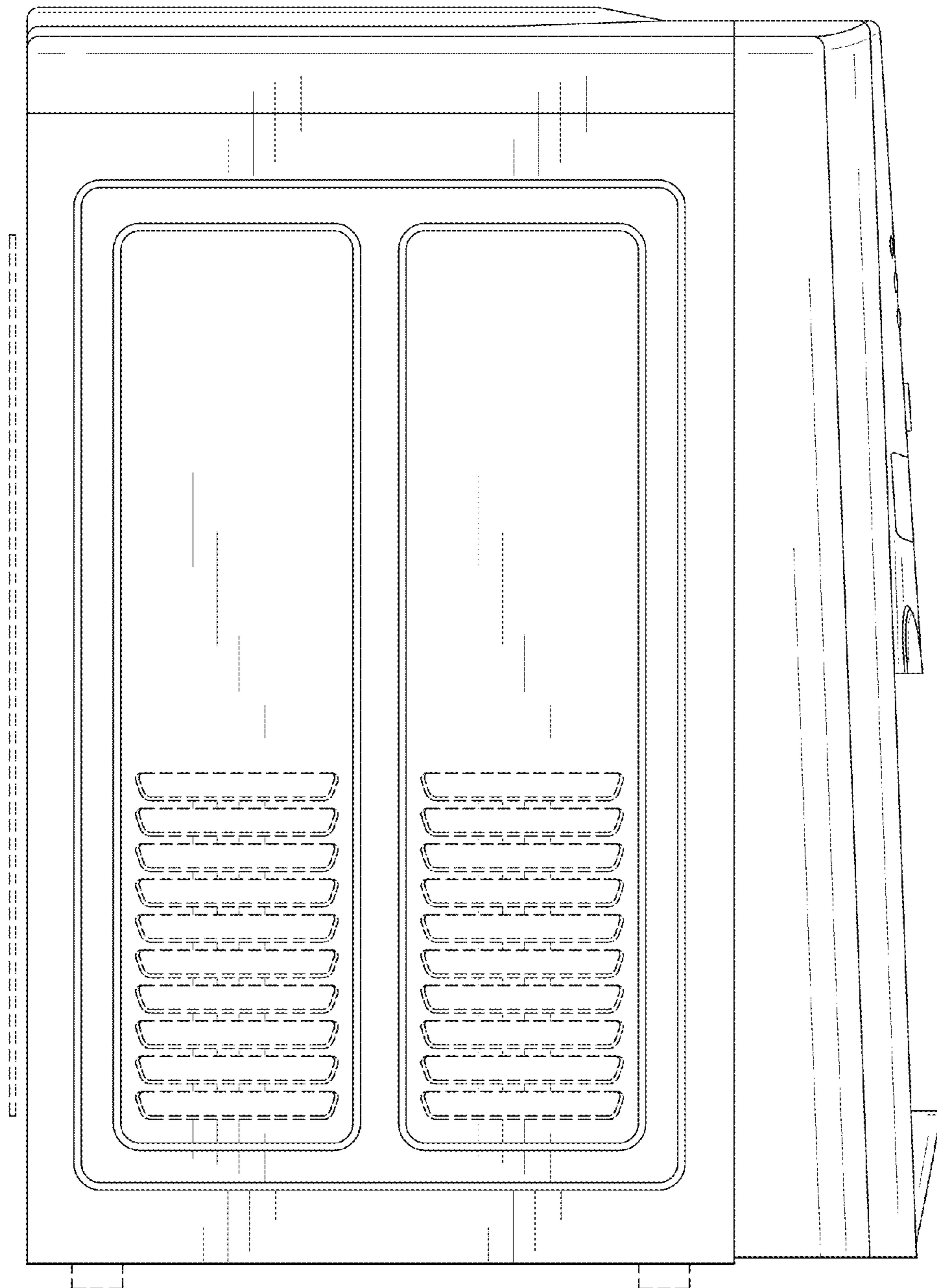

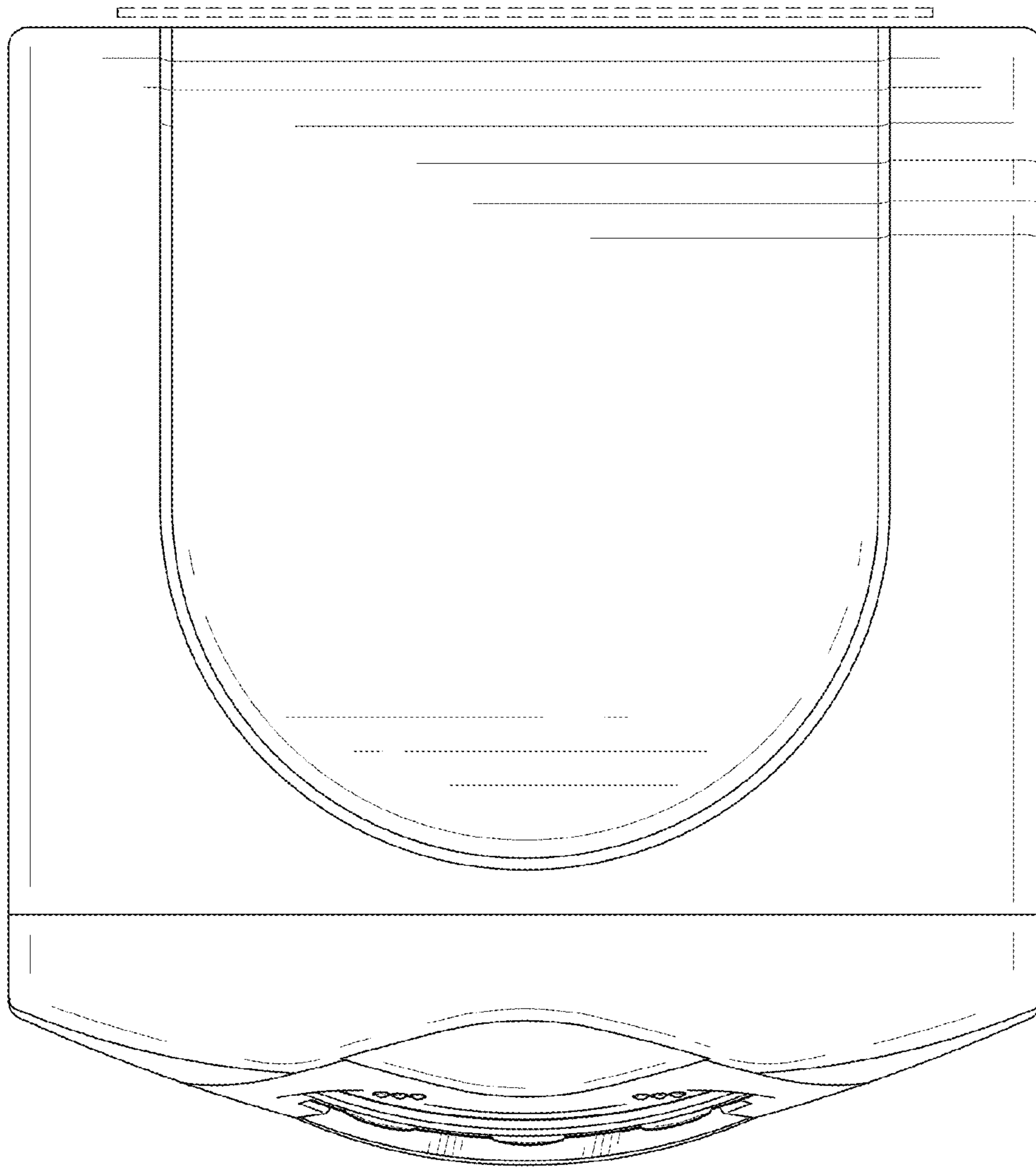

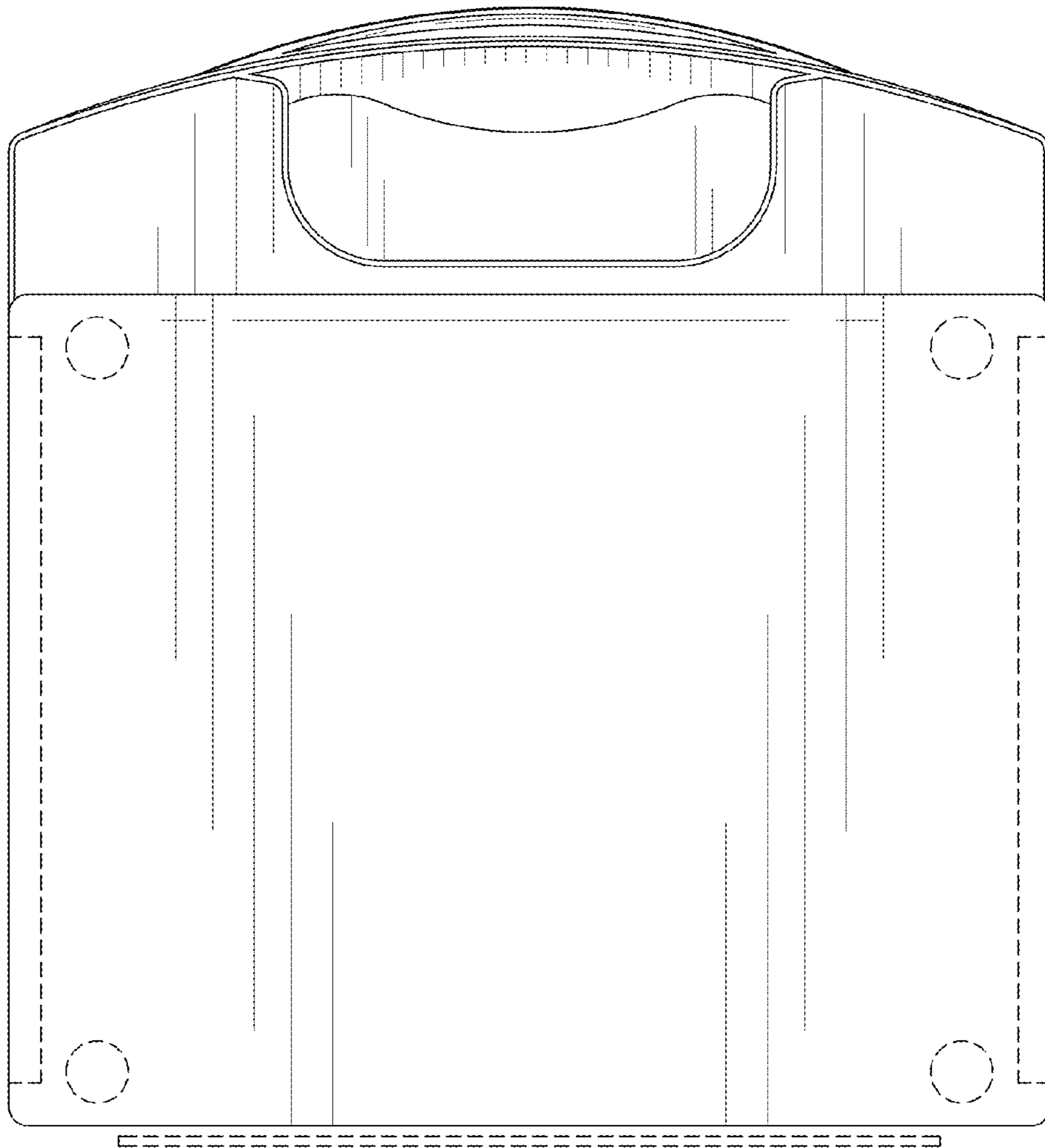
