(57) **CLAIM**

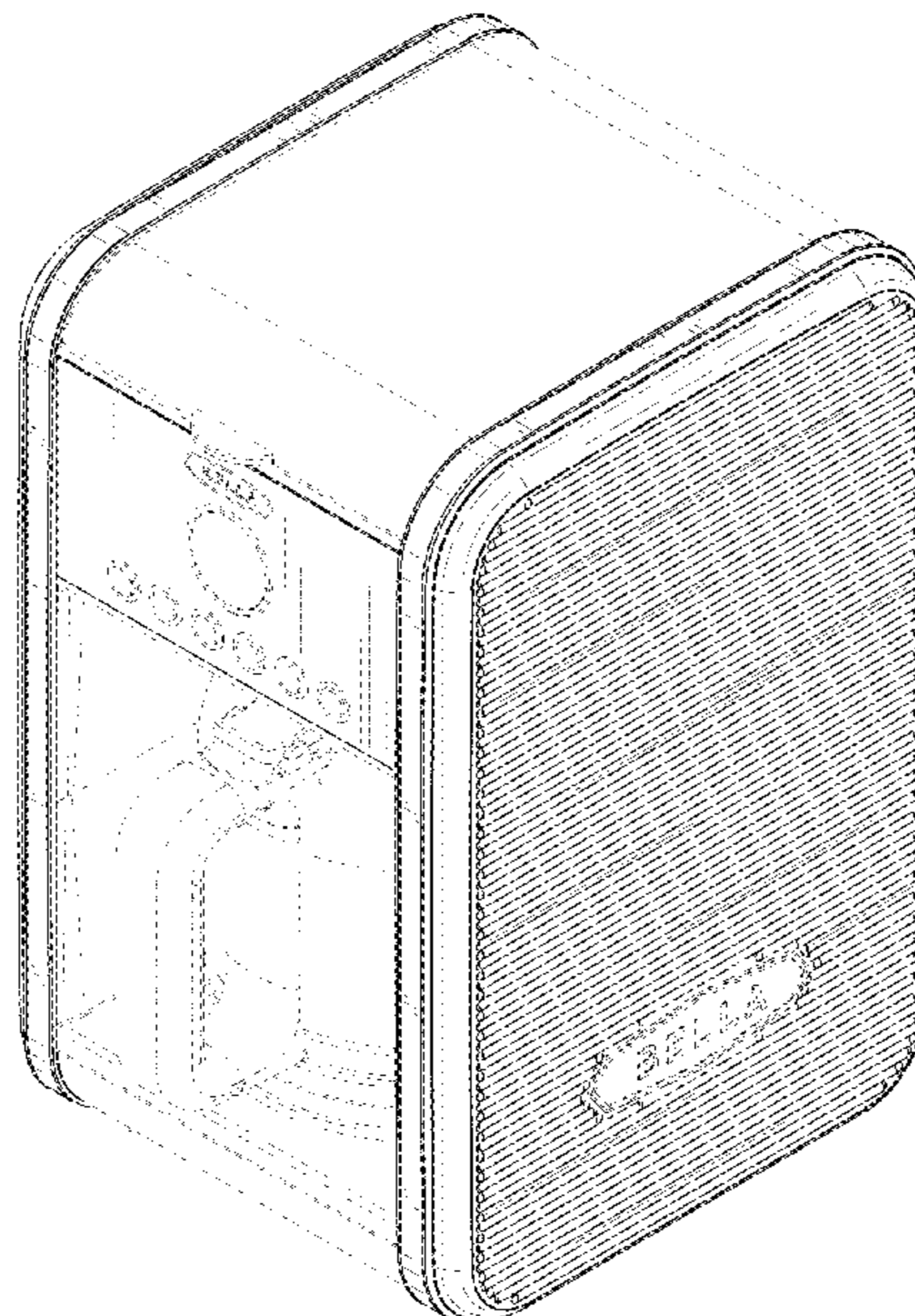
We claim the ornamental design for a coffee maker, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view taken from a top, front, right side of a first embodiment of the coffee maker; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a perspective view taken from a top, front, right side of a second embodiment of the coffee maker; FIG. 9 is a front elevation view thereof; FIG. 10 is a rear elevation view thereof; FIG. 11 is a left side elevation view thereof; FIG. 12 is a right side elevation view thereof; FIG. 13 is a top plan view thereof; and, FIG. 14 is a bottom plan view thereof.

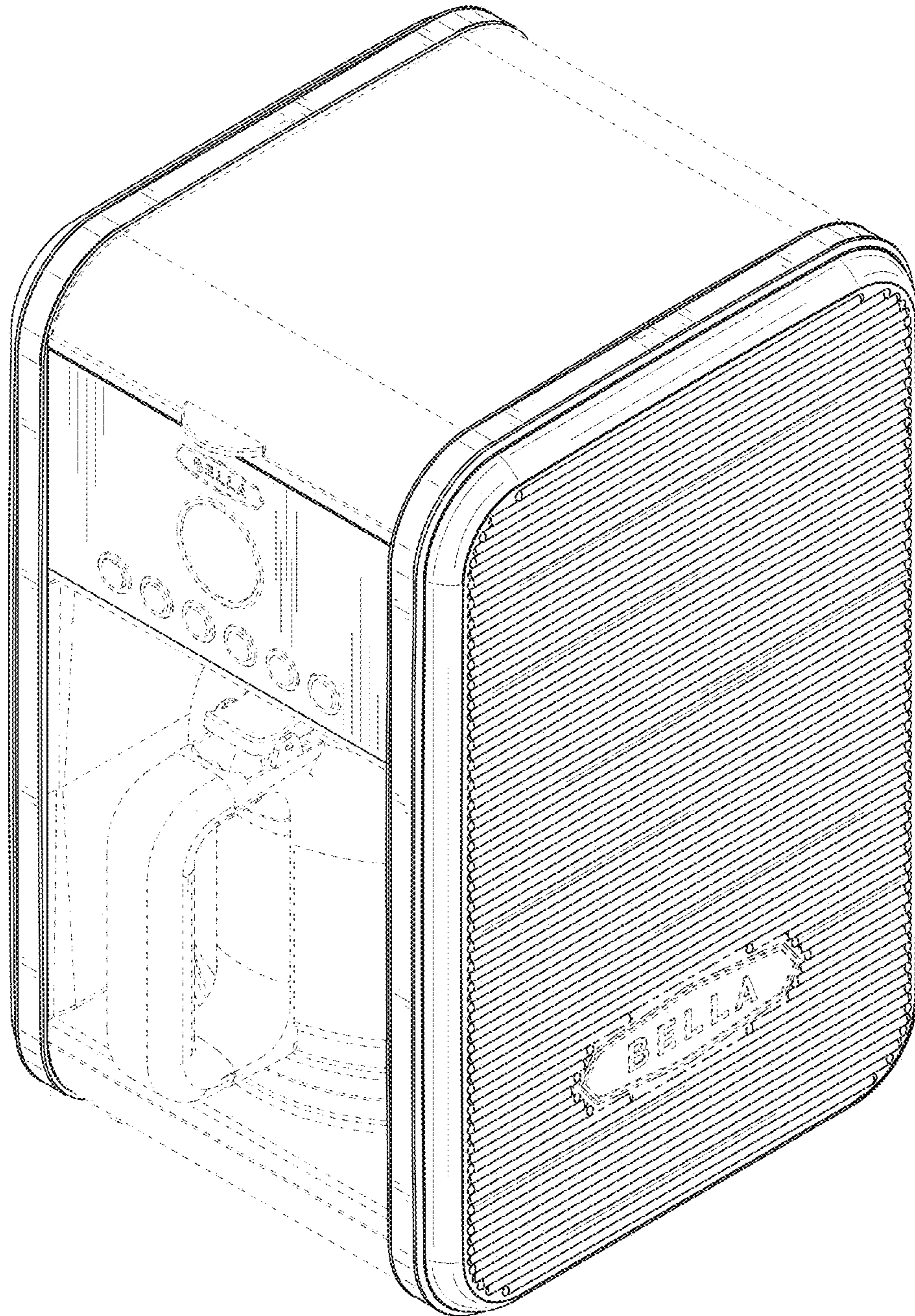

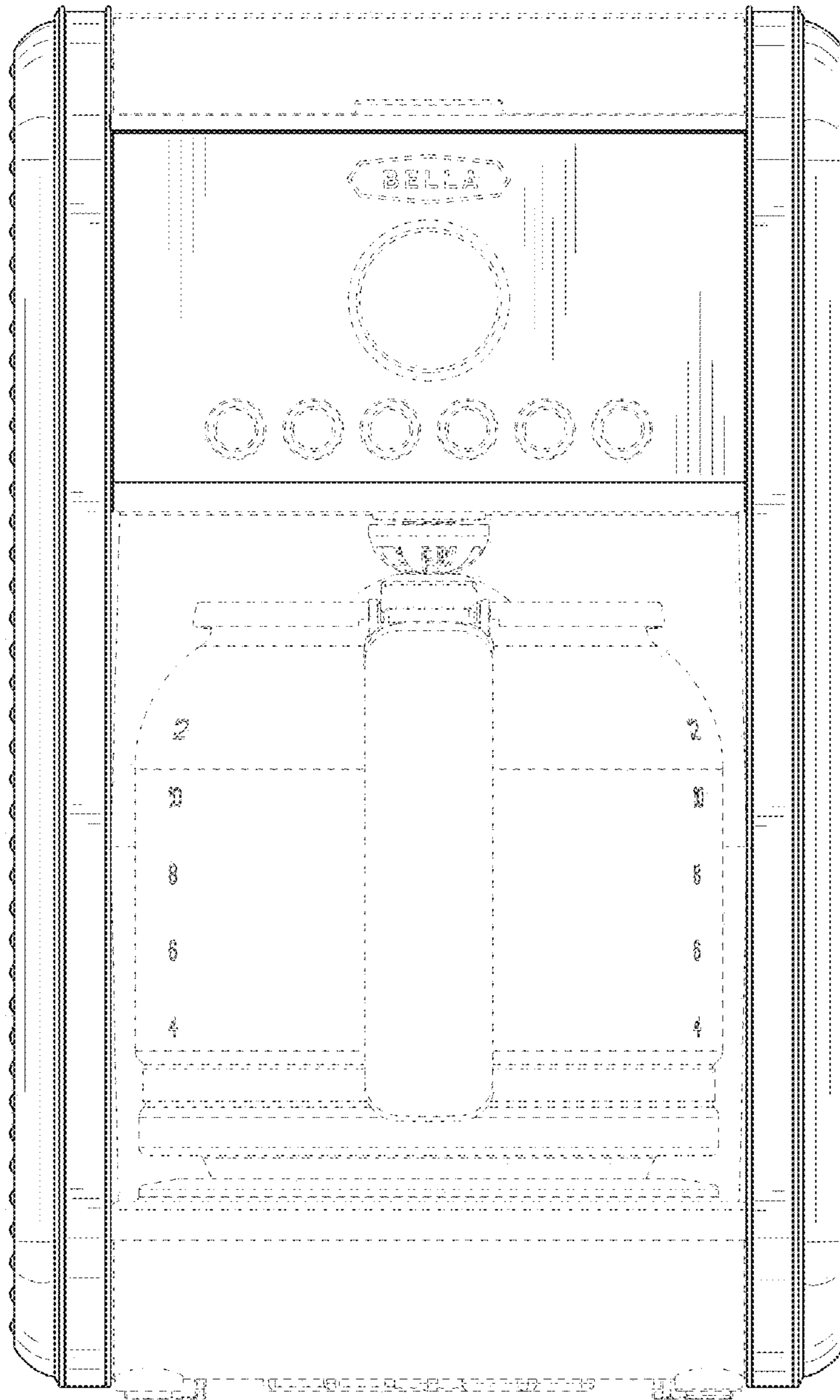

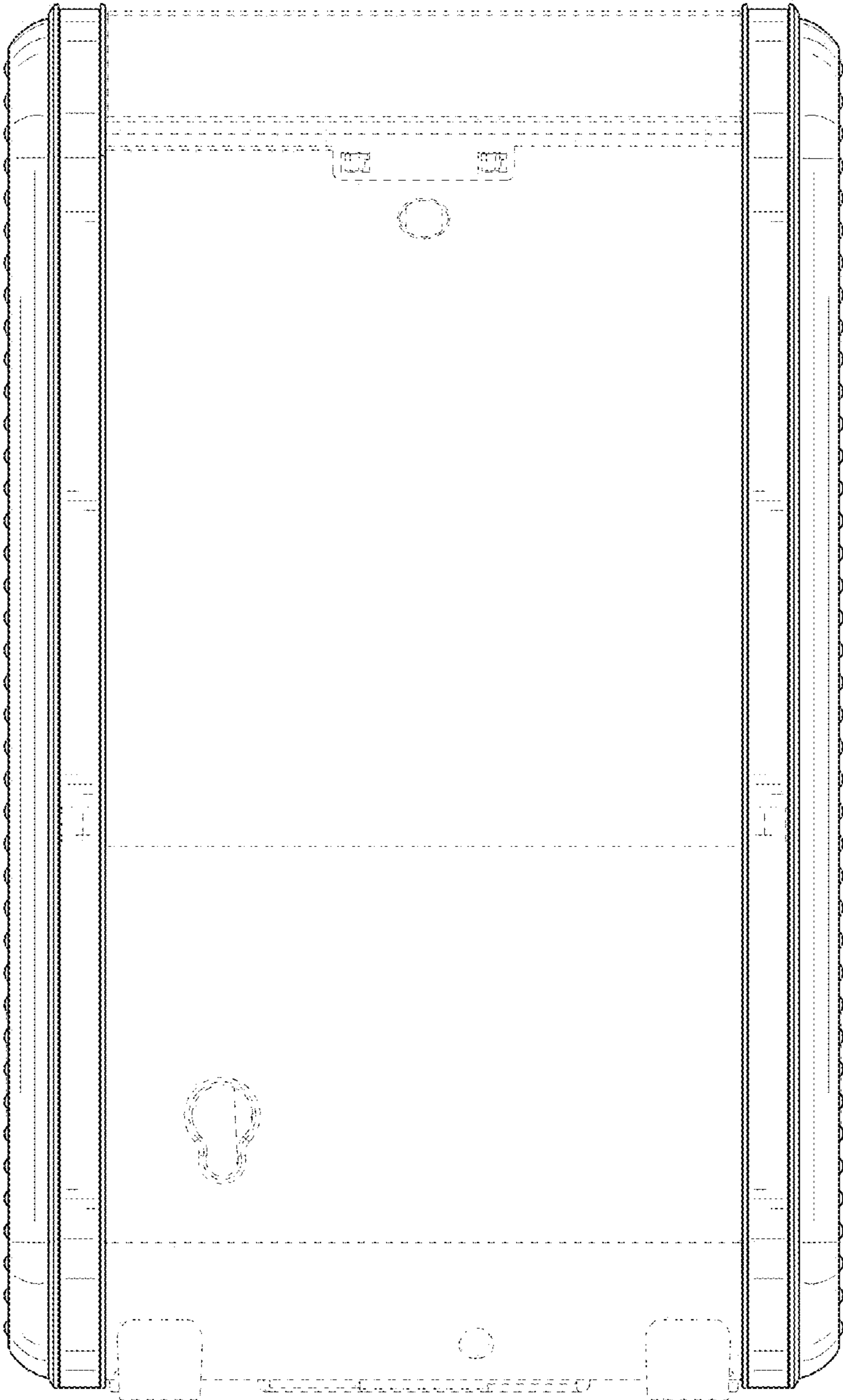

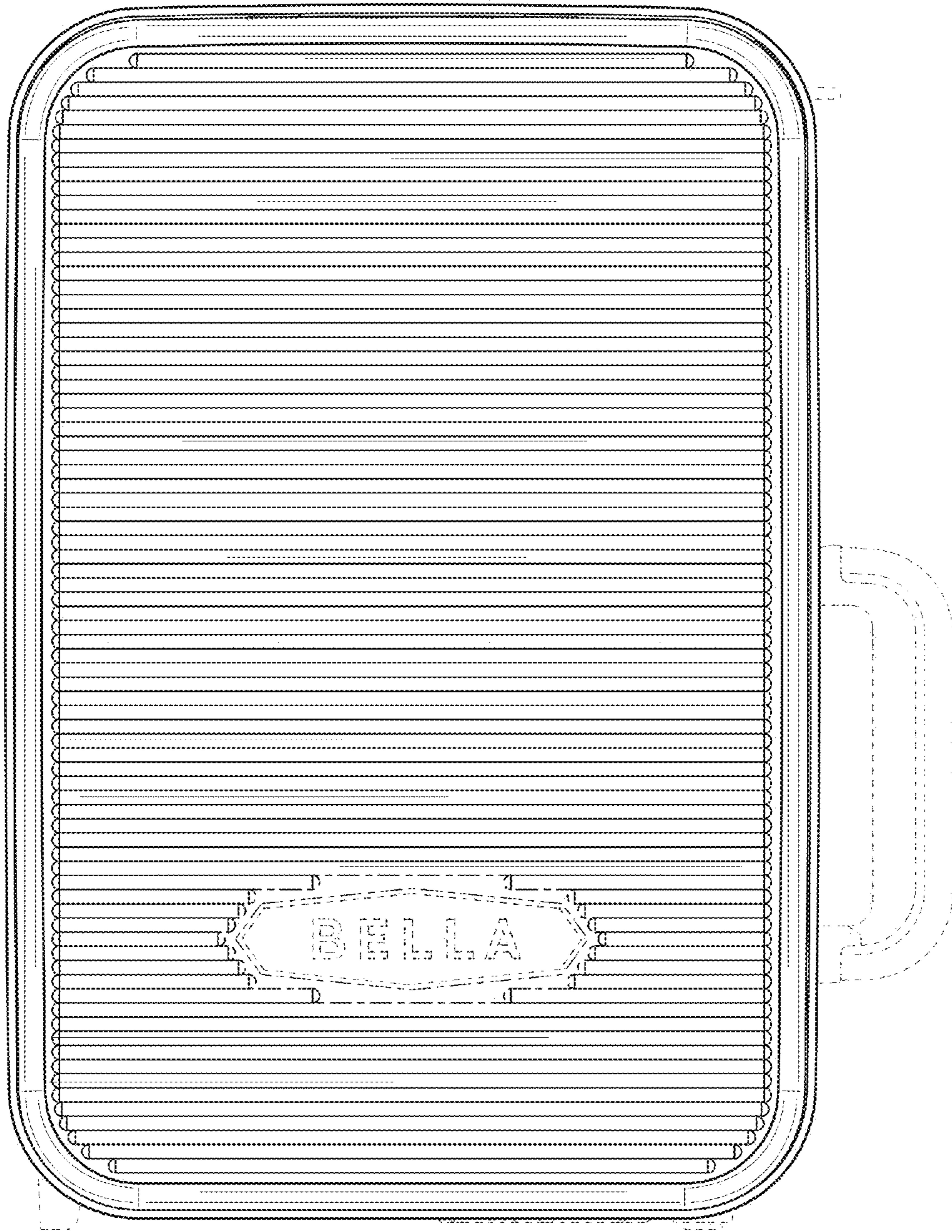

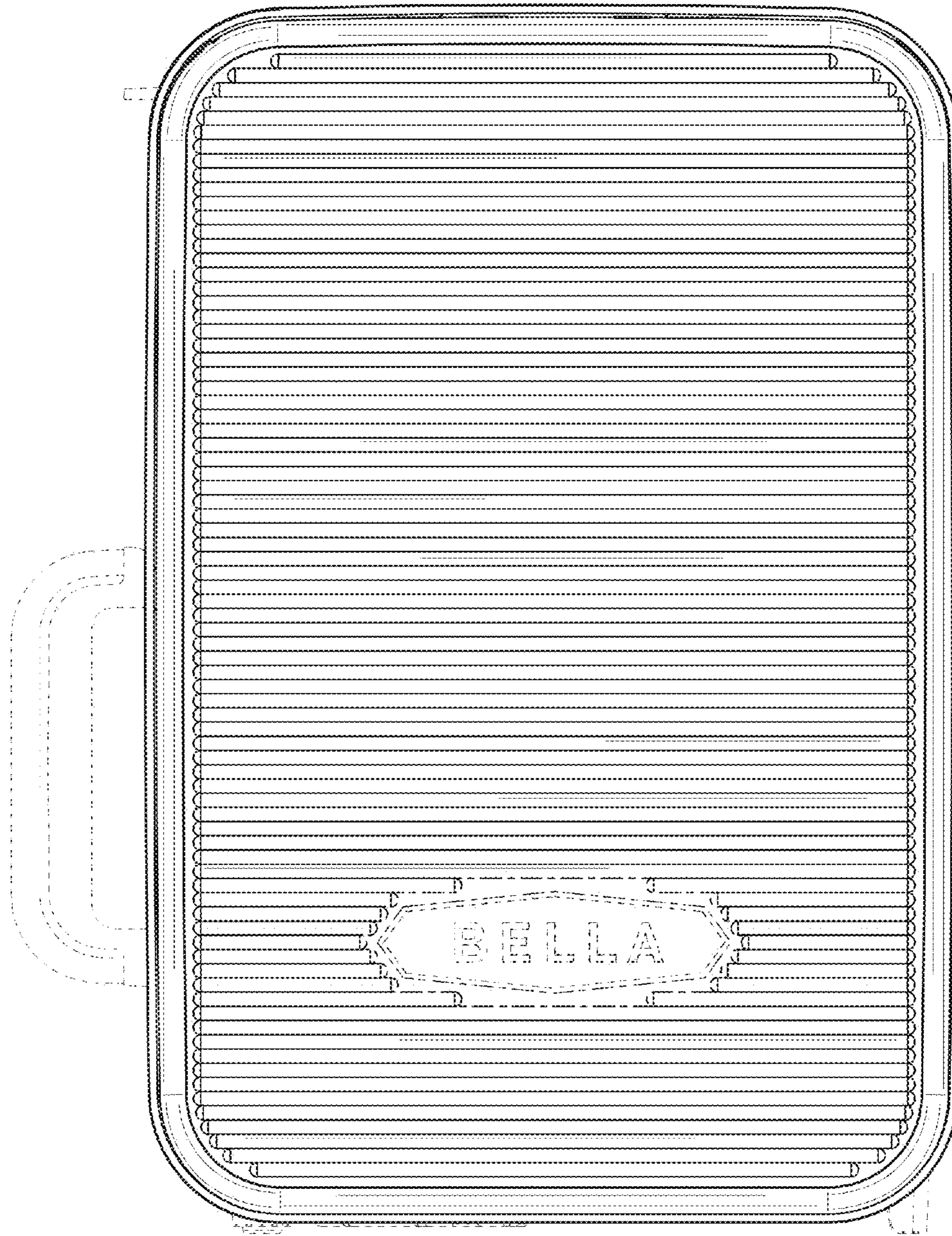

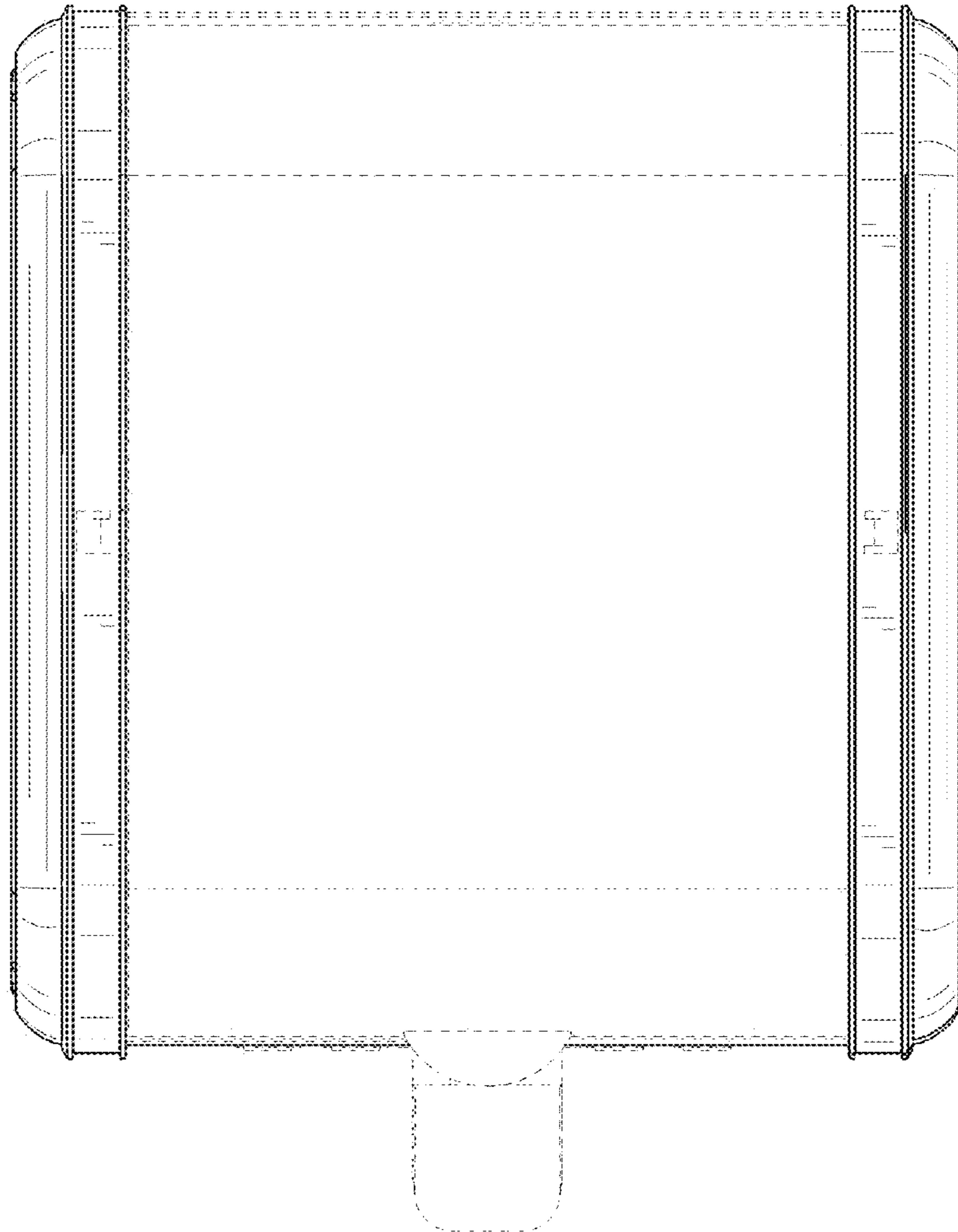

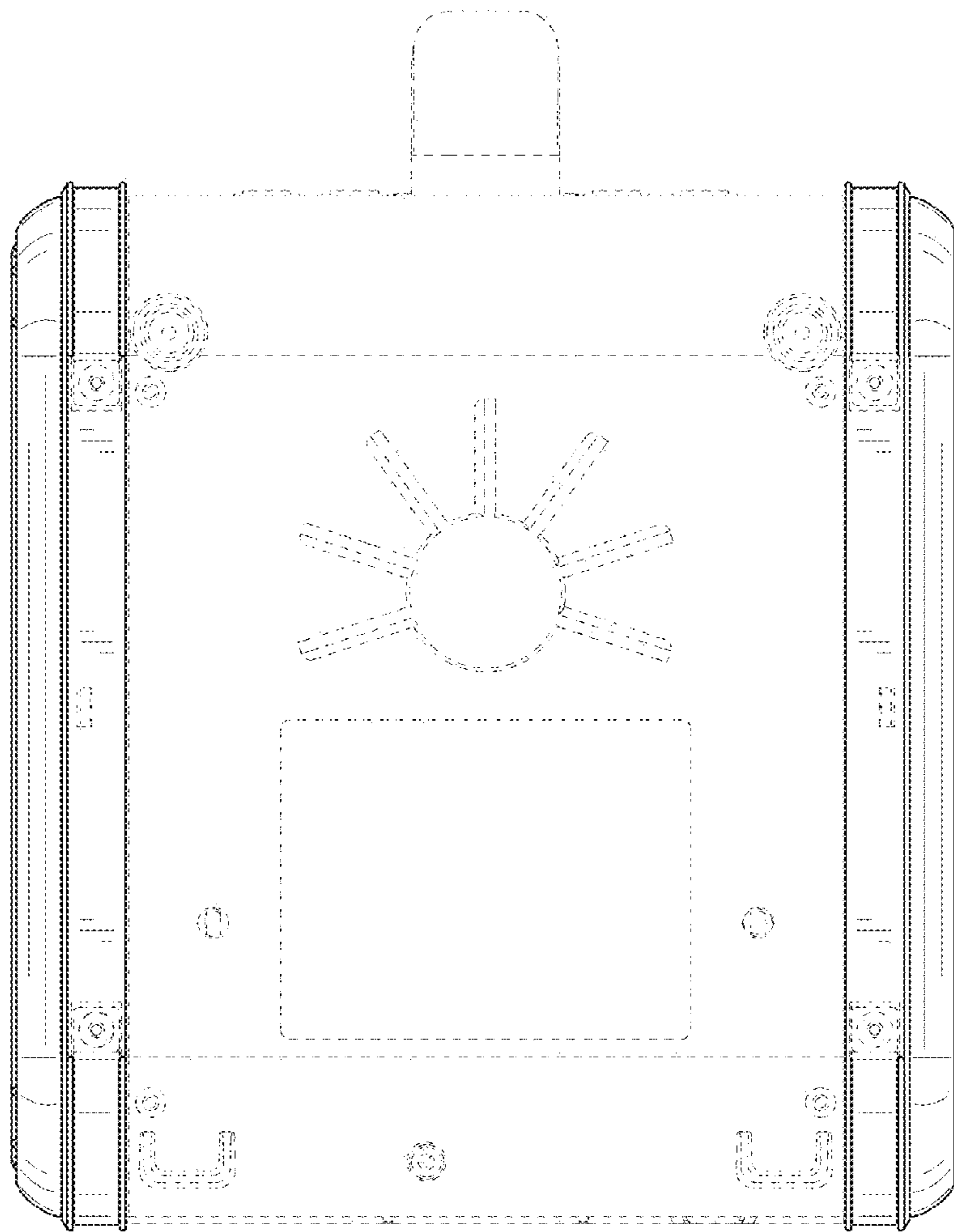

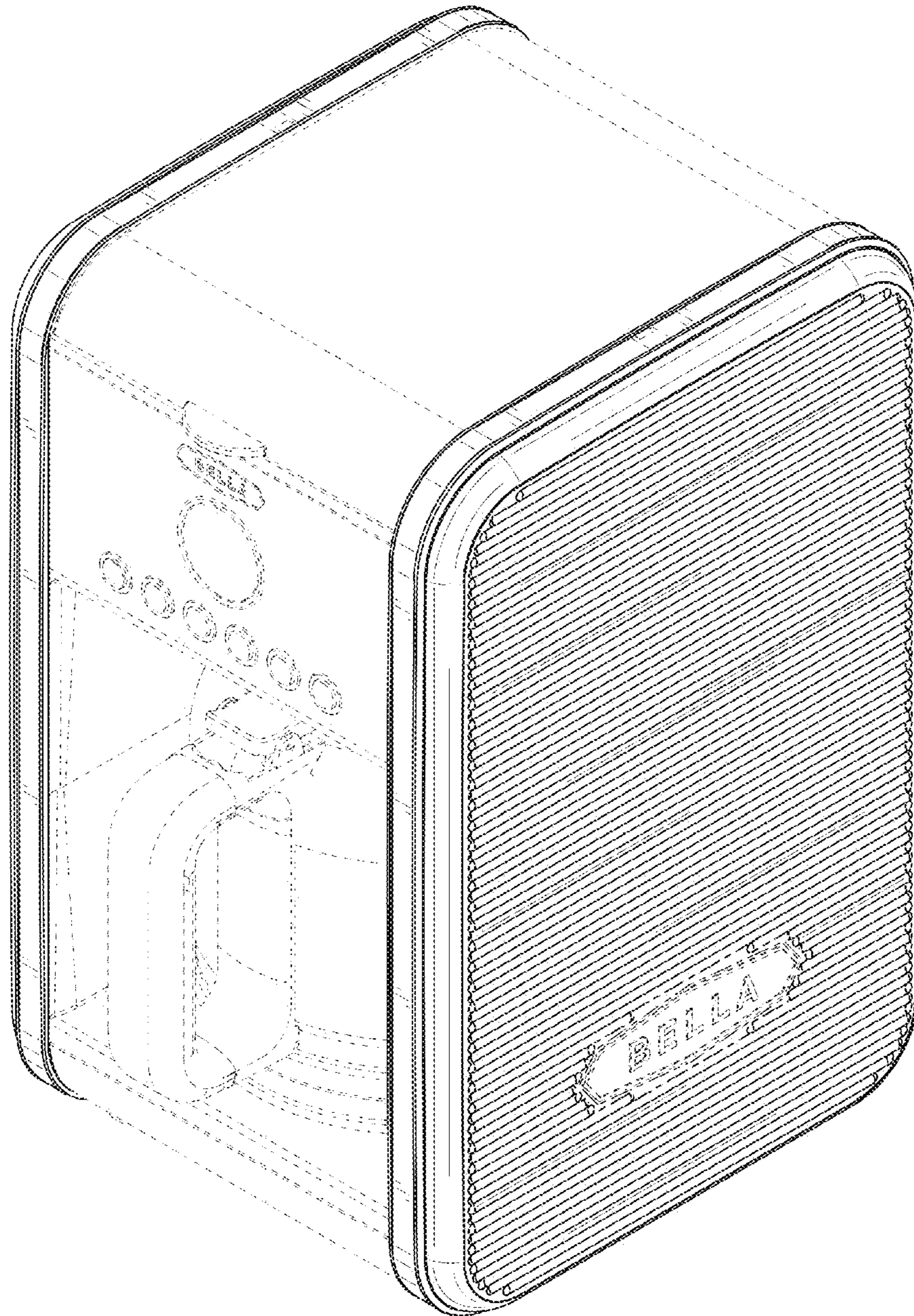

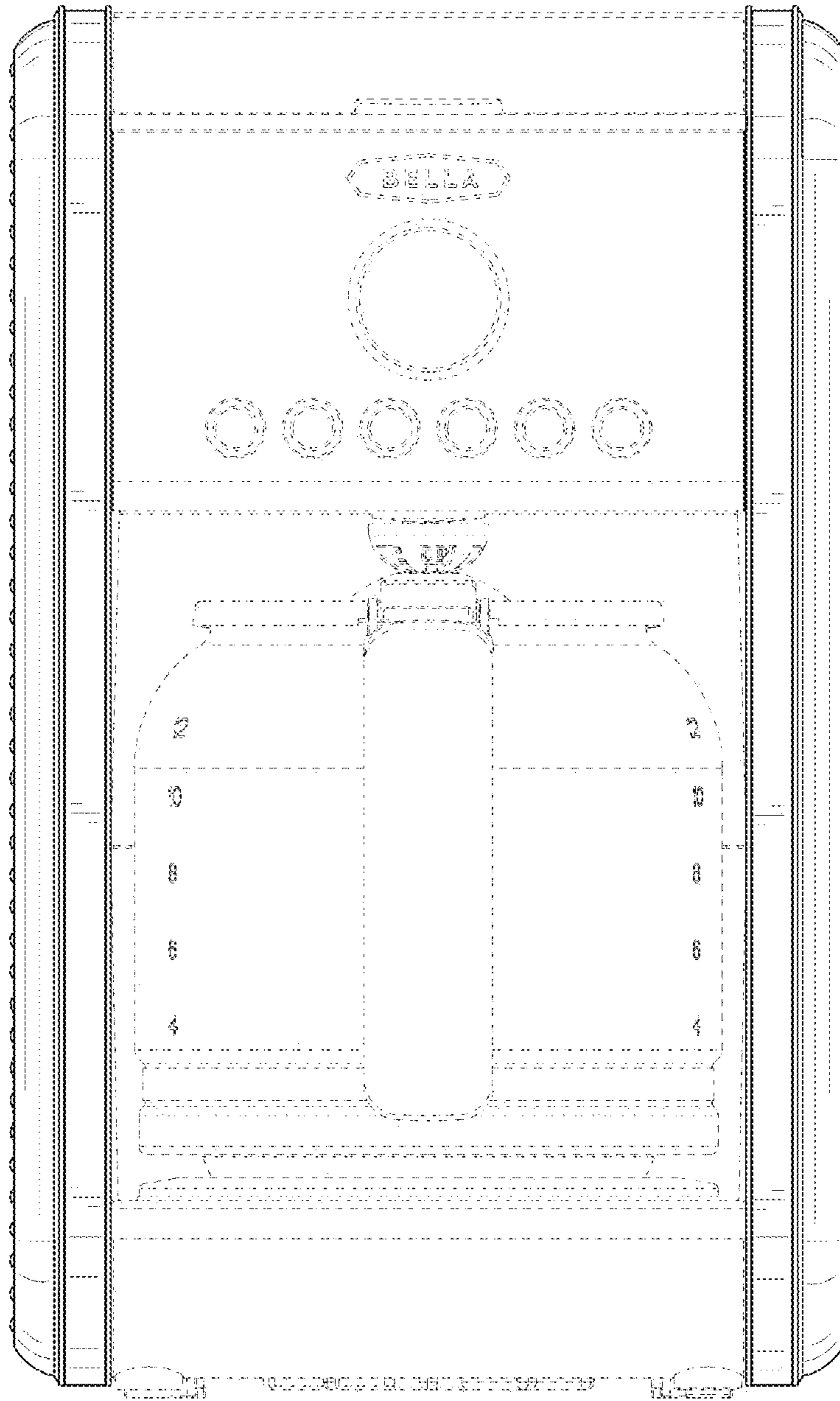

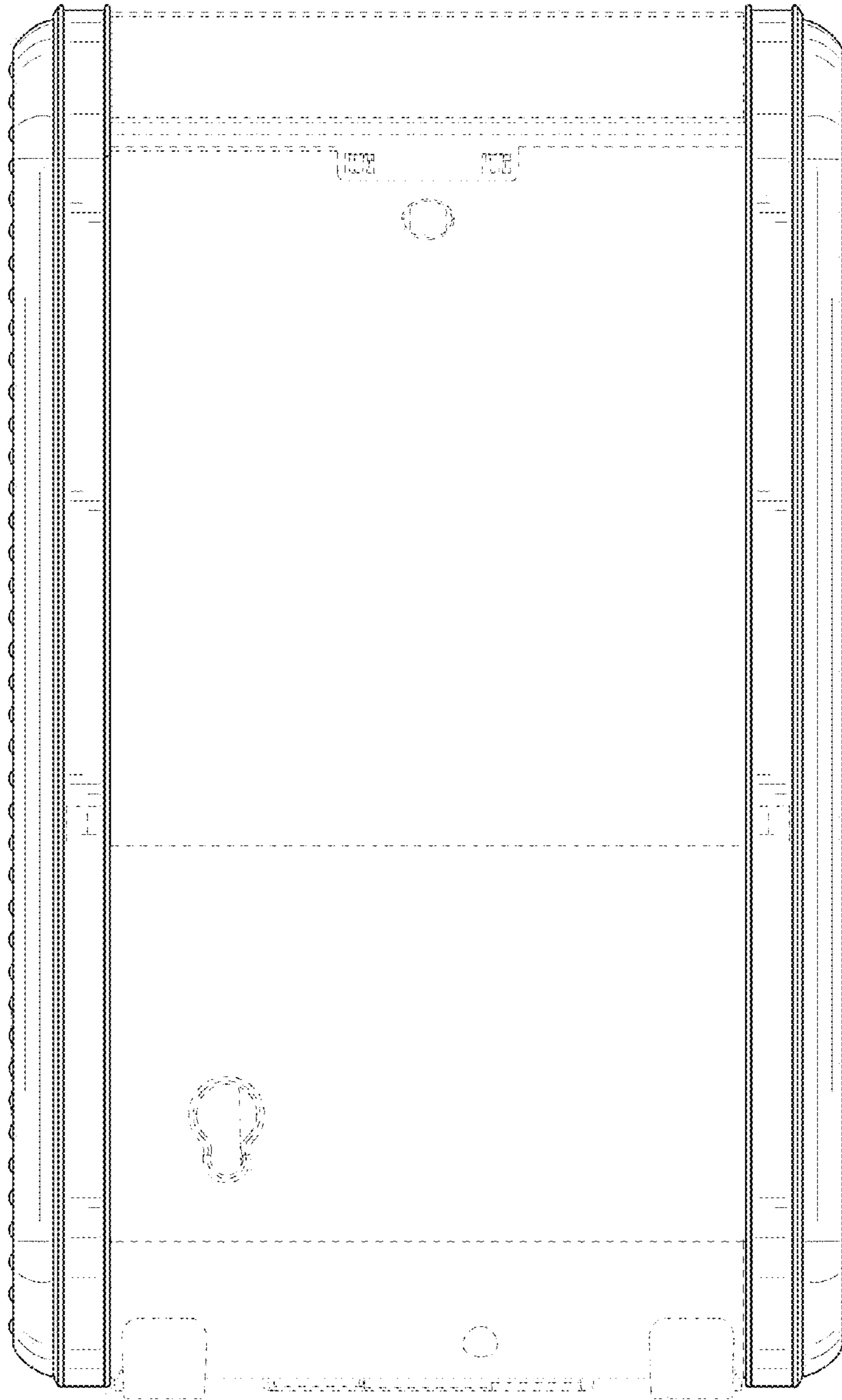

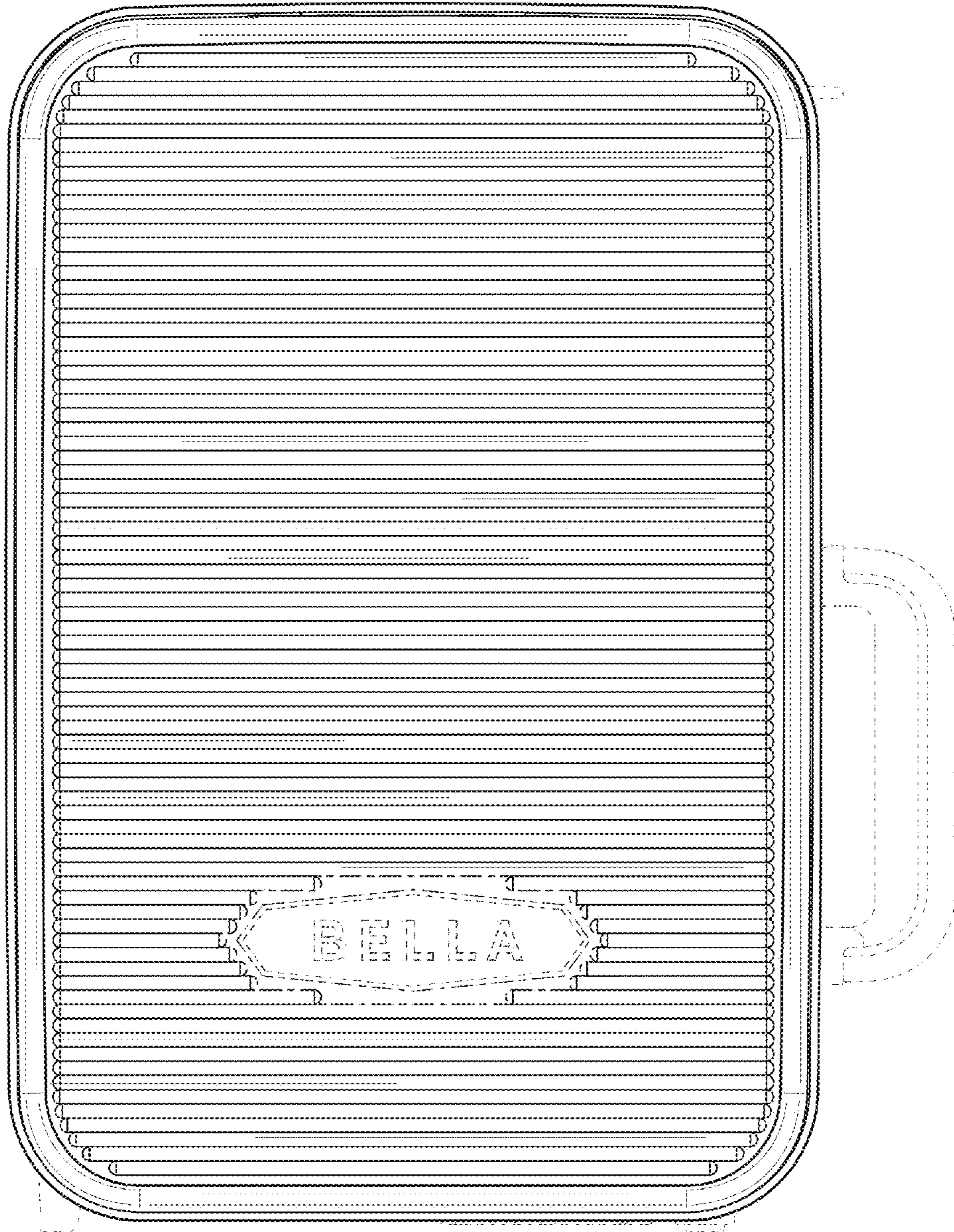

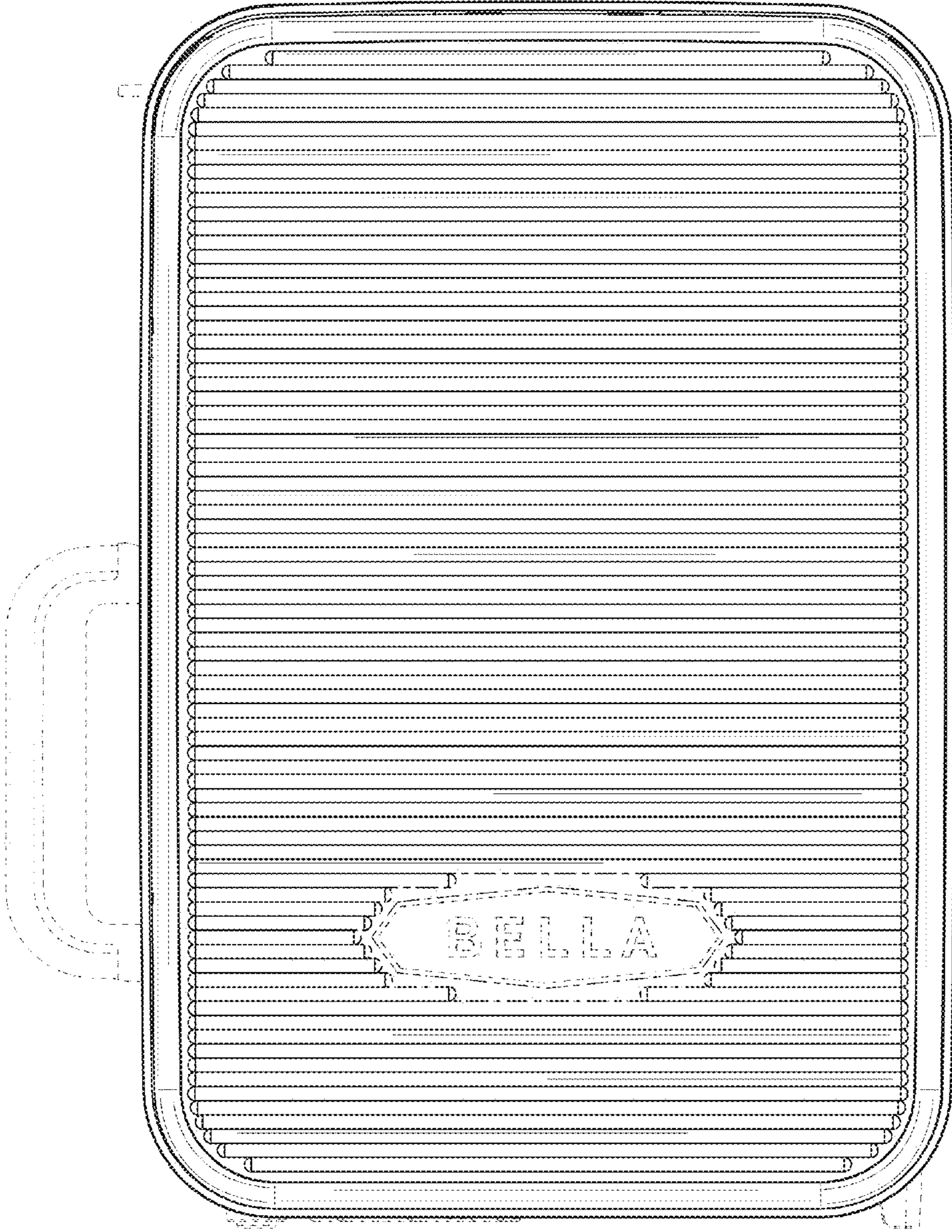

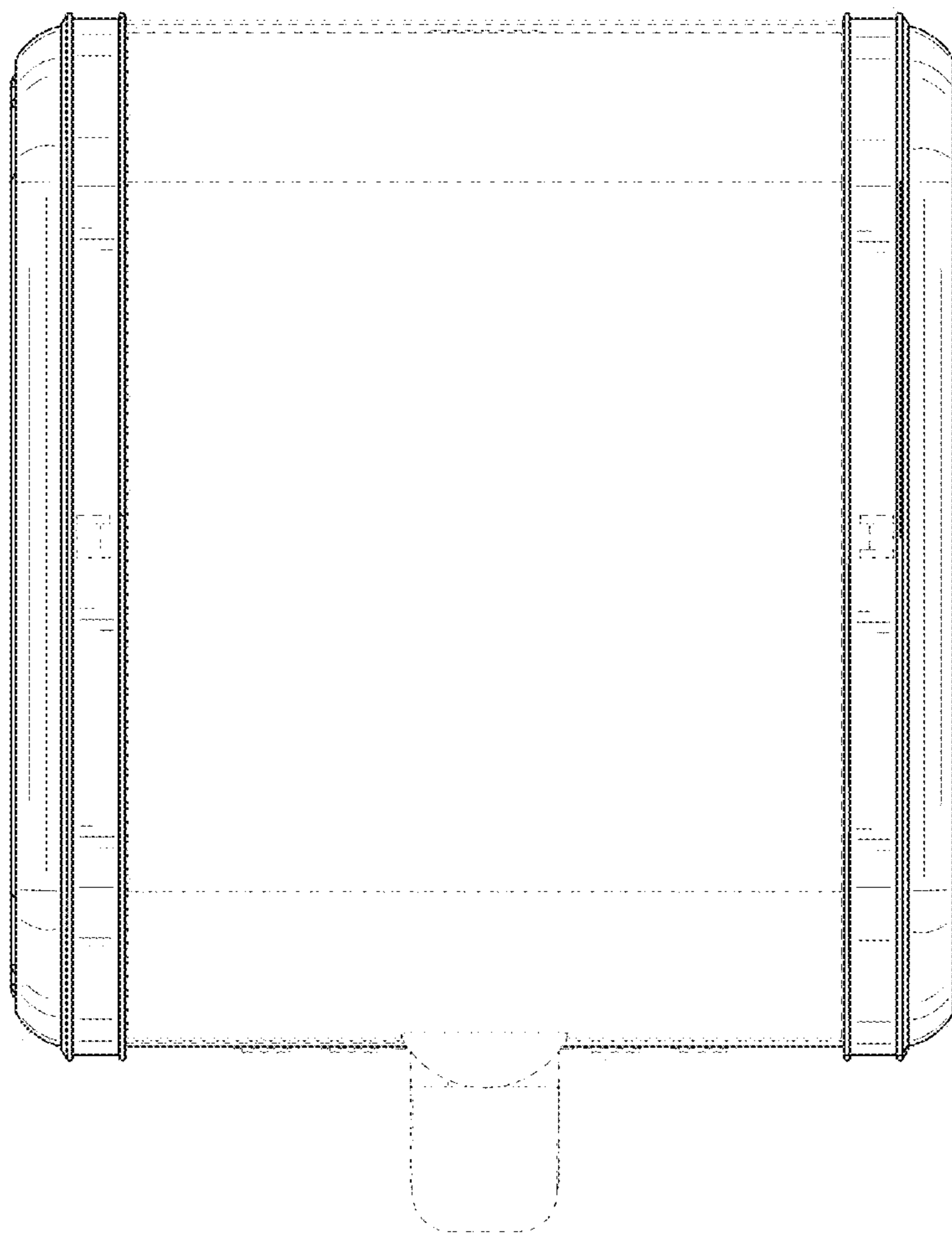

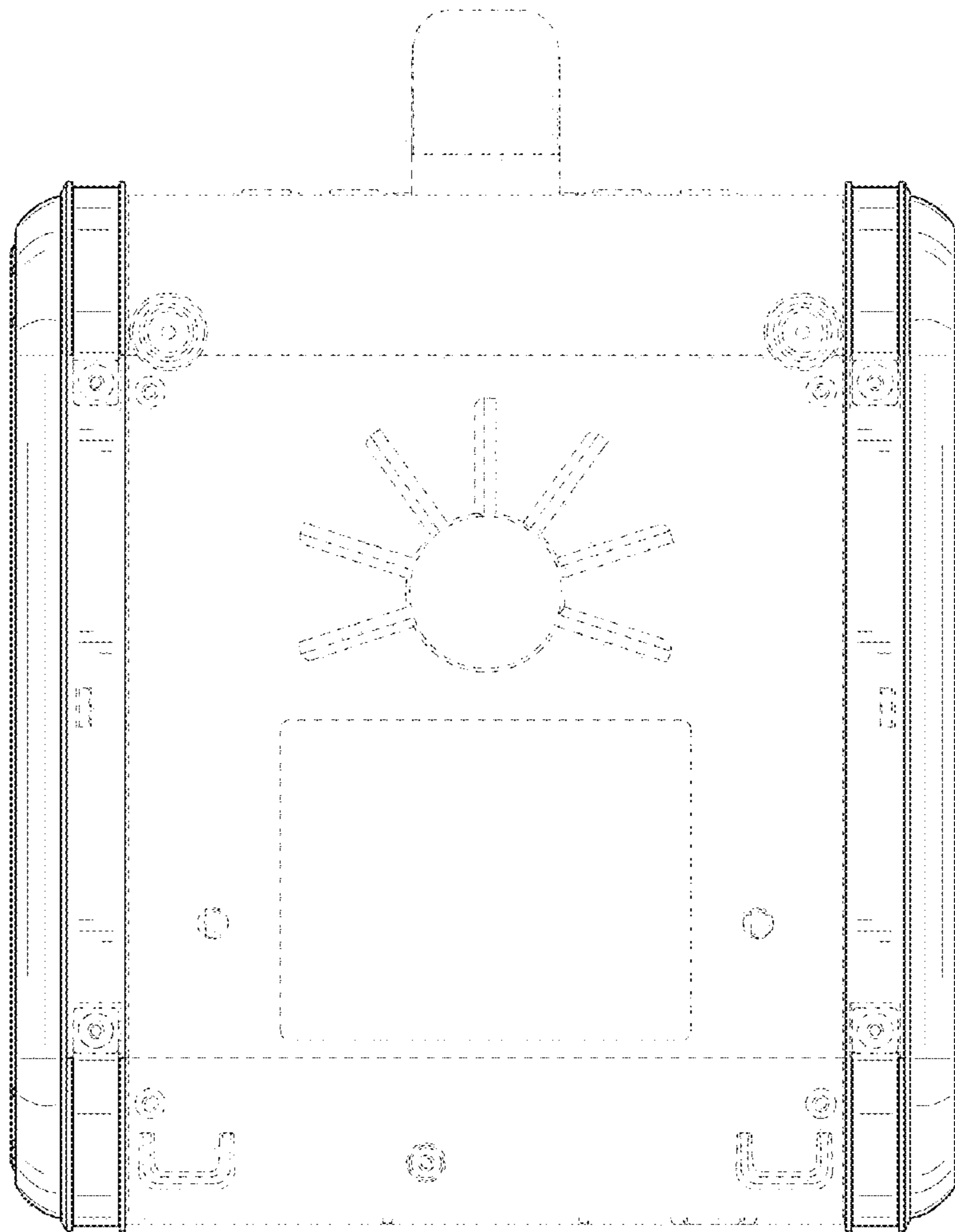
