(57) **CLAIM**

The ornamental design for a handle of a pair of gardening shears, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a handle of a pair of gardening shears showing my design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left side elevational view thereof, with the broken lines shown in FIG. 4 for illustrative purposes only and form no part of the claimed design;

FIG. 5 is a right side elevational view thereof;

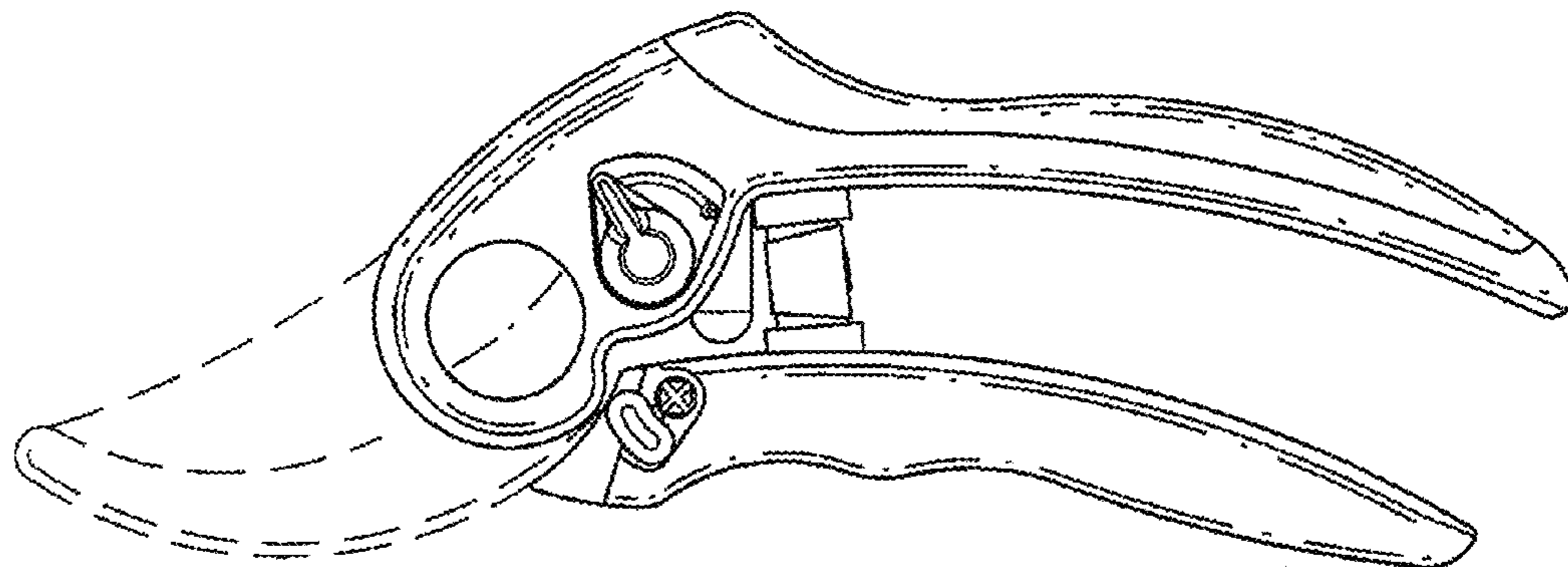
FIG. 6 is a top plan view thereof;

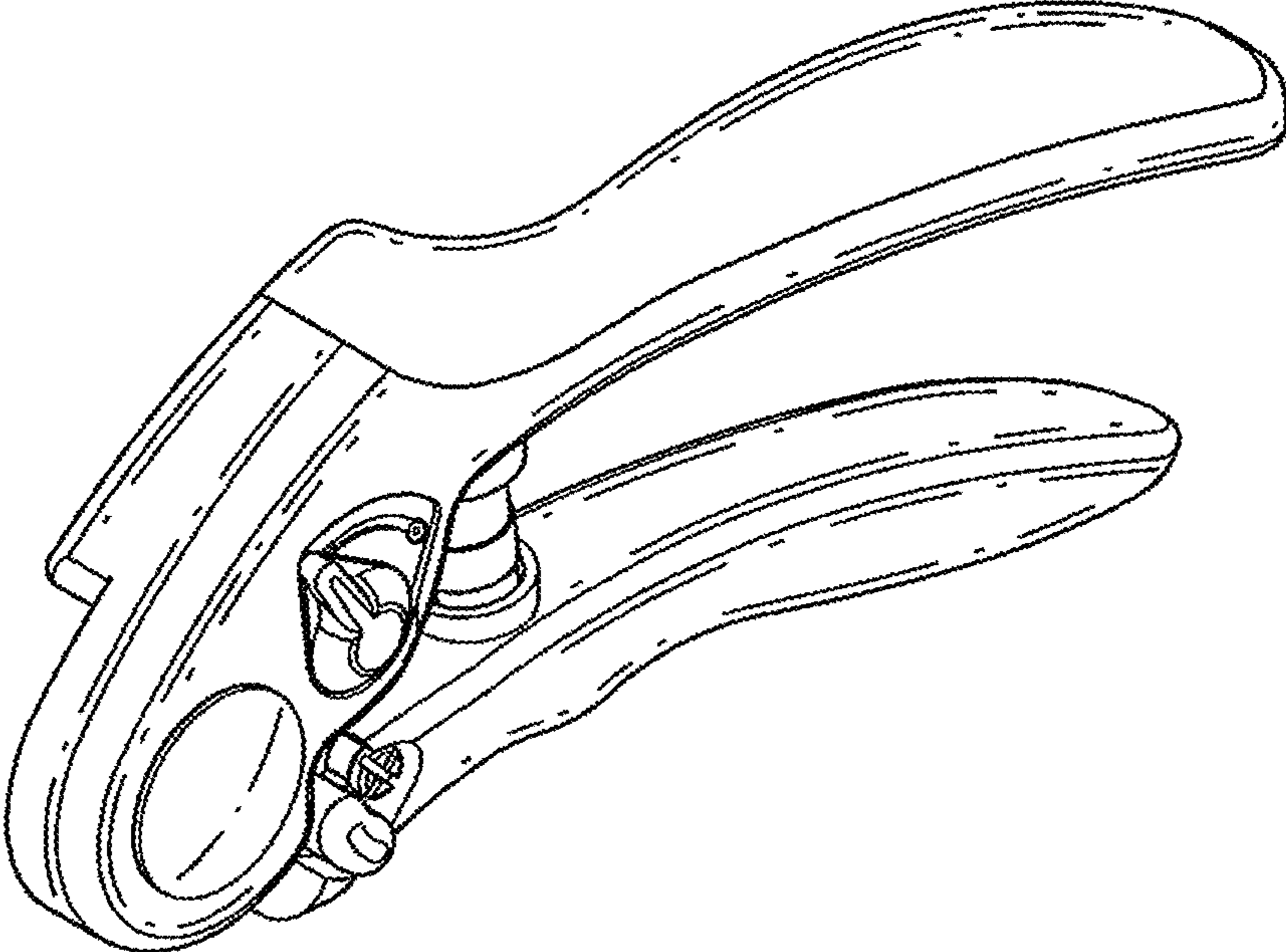

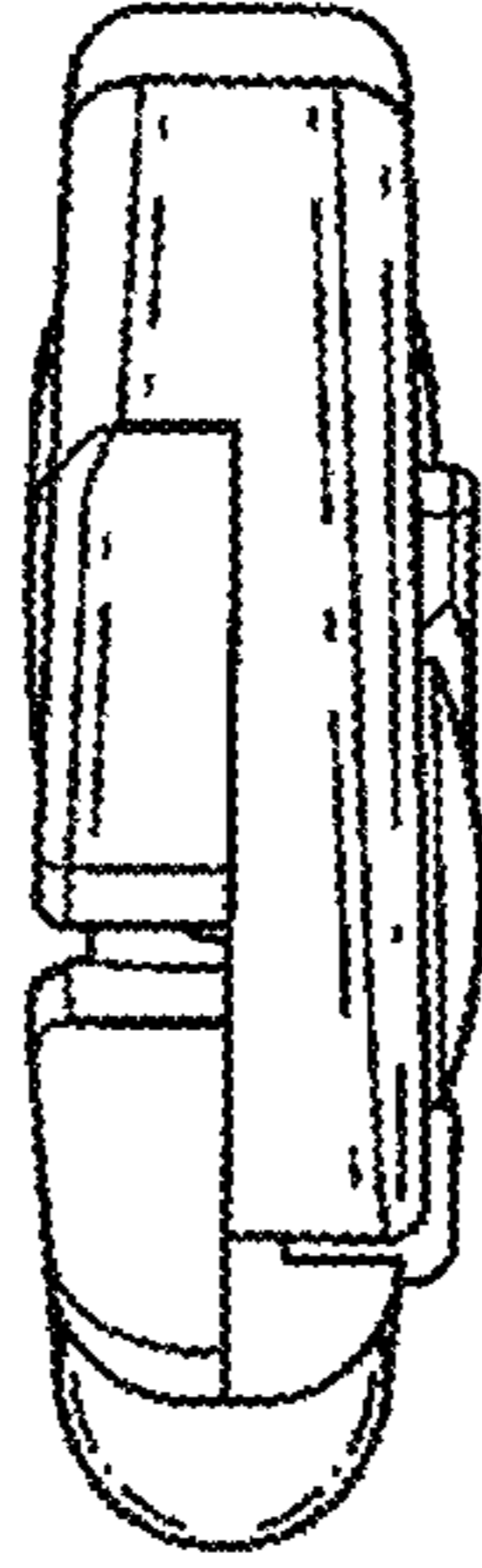

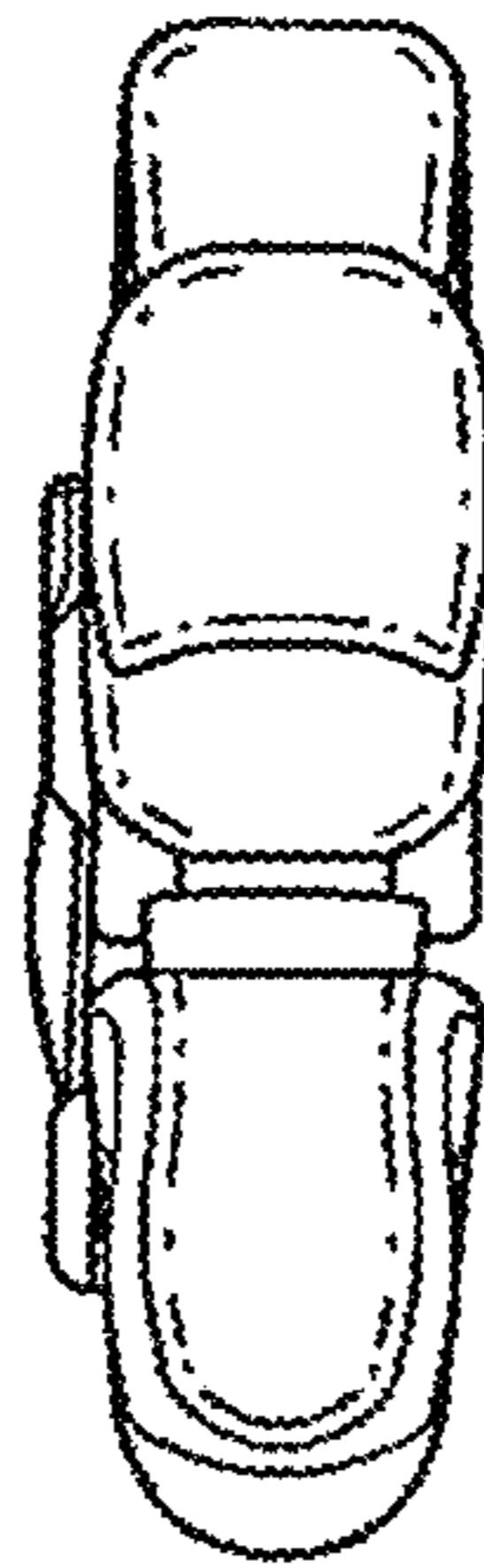

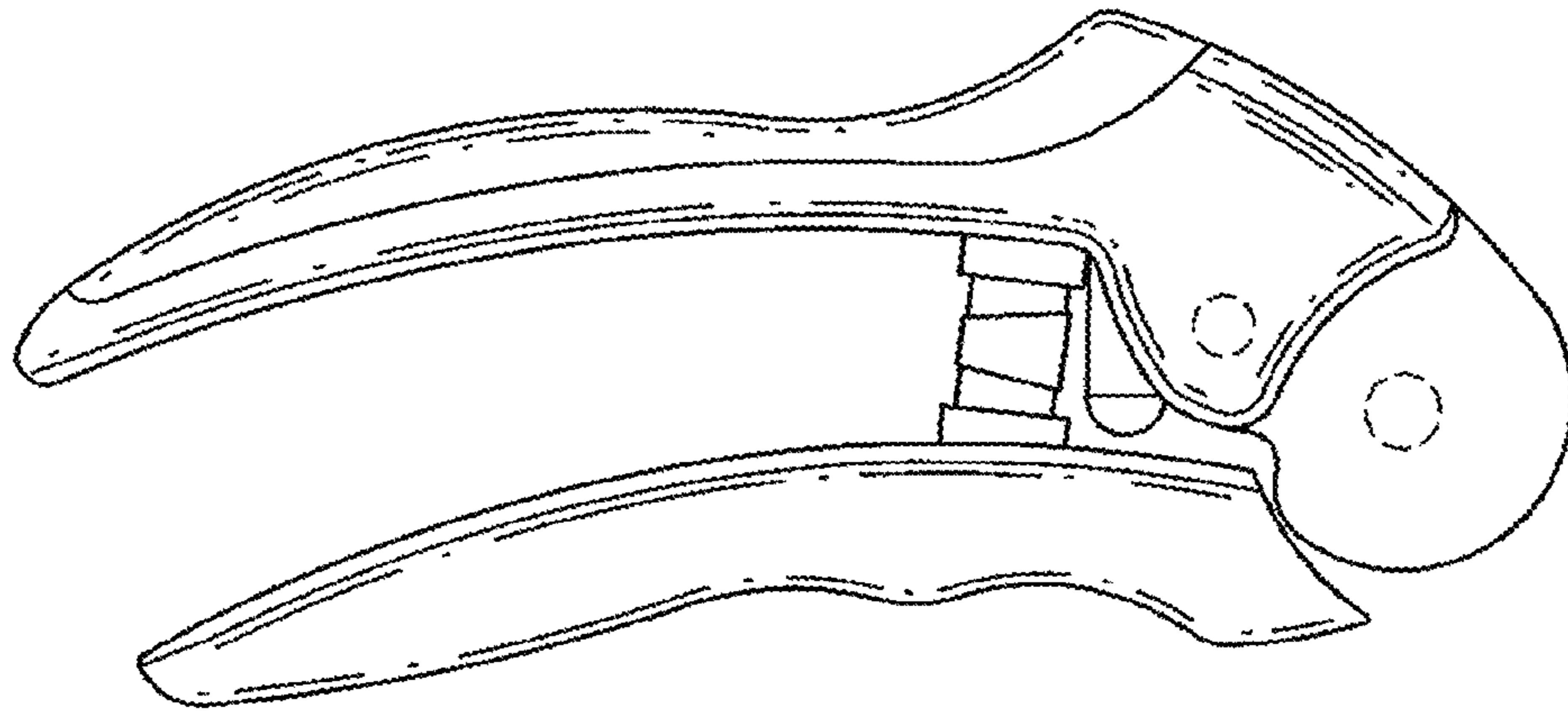

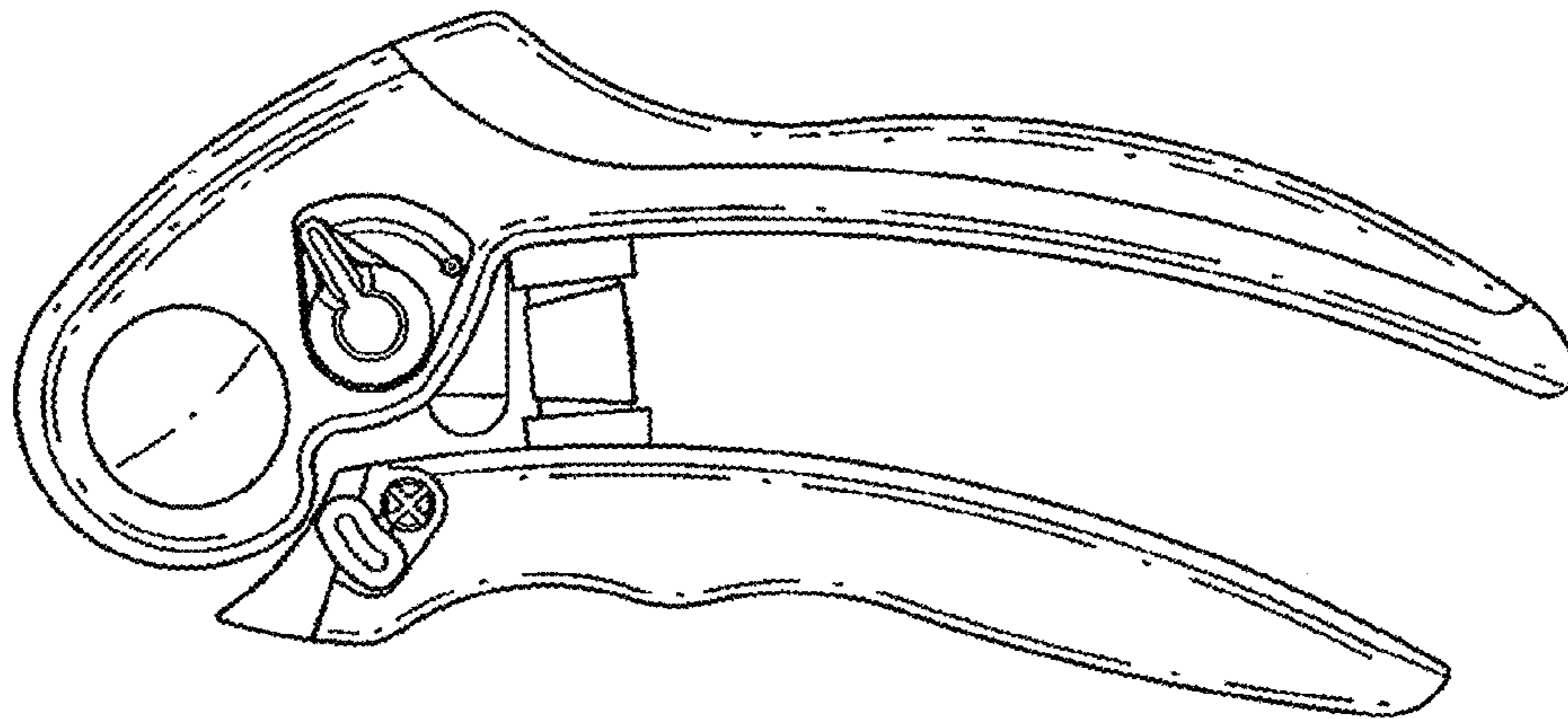

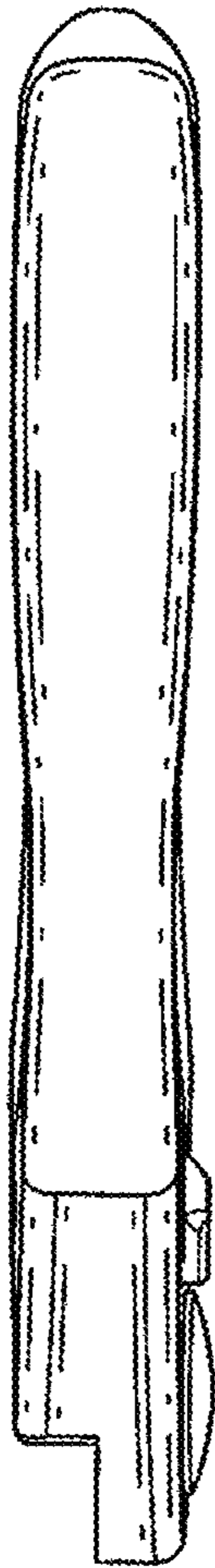

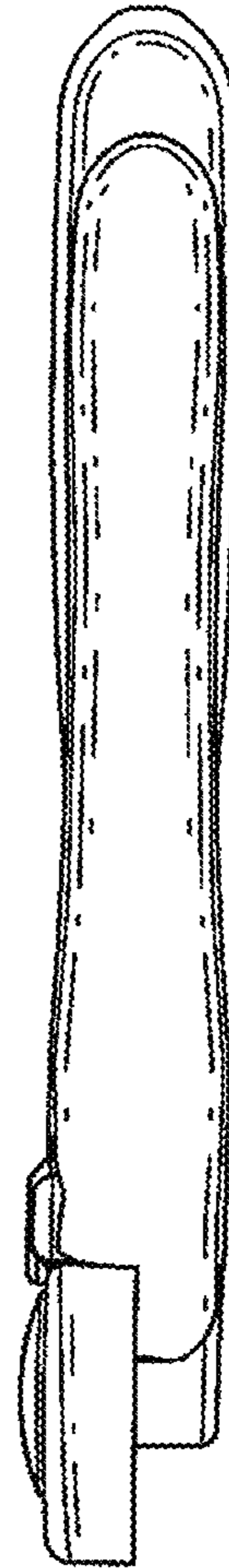

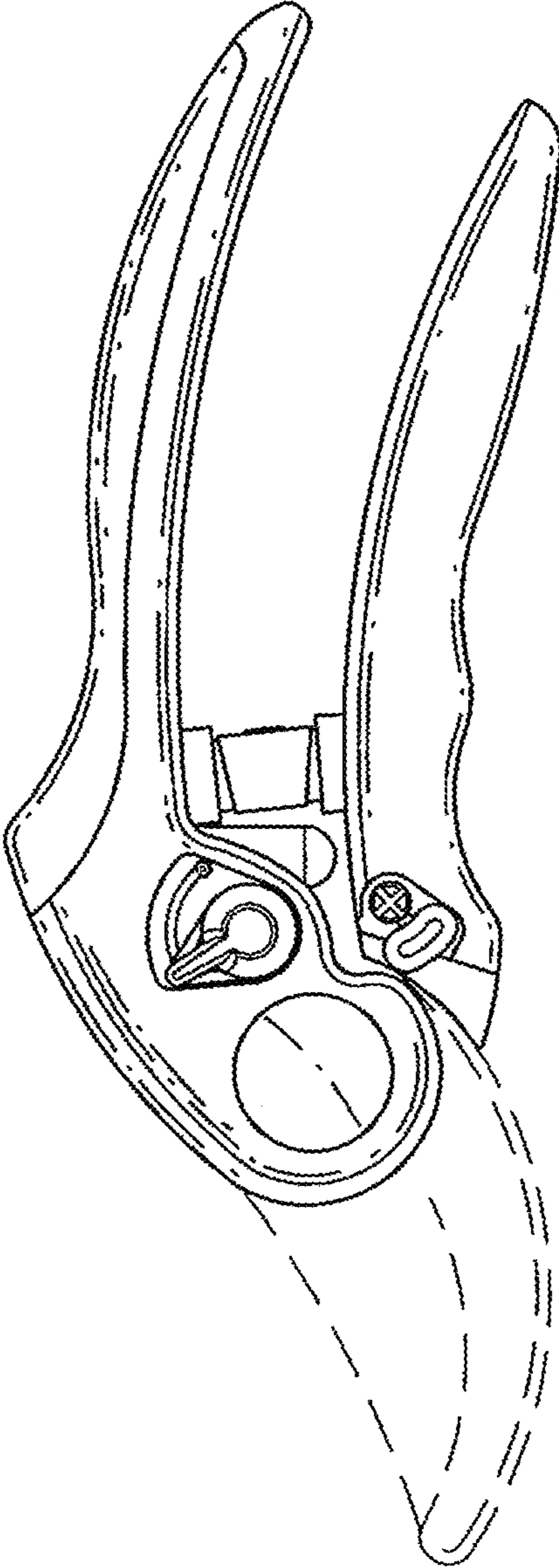
