(57) **CLAIM**

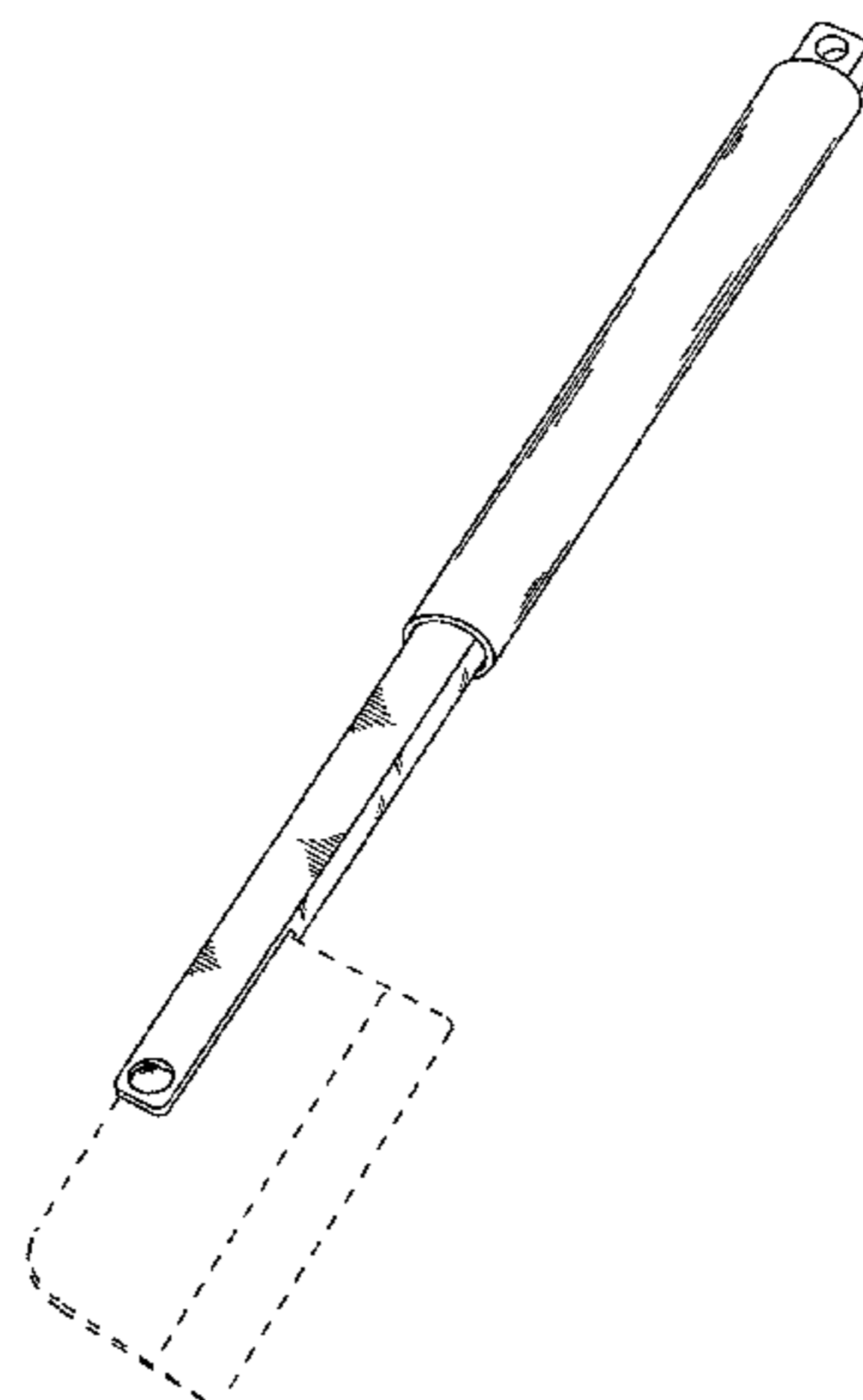
The ornamental design for a handle for applicator, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing my new design;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a right side view thereof;
 FIG. 4 is a bottom plan view thereof;
 FIG. 5 is a side view thereof;
 FIG. 6 is a front view thereof;
 FIG. 7 is a rear view thereof;
 FIG. 8 is a top plan thereof, in the environment of a bucket;
 FIG. 9 is a second perspective view thereof, wherein the broken line showing of the applicator is in an alternate position;
 FIG. 10 is a top plan view thereof;
 FIG. 11 is a right side view with the left side view being a mirror image thereof;
 FIG. 12 is a bottom plan view thereof;
 FIG. 13 is a front view thereof;
 FIG. 14 is a rear view thereof; and,
 FIG. 15 is a top plan view thereof, in the environment of a bucket.

The broken line showing of the applicator in FIGS. 1 through 15 and the bucket in FIGS. 8 and 15 are provided for purposes of environment and form no part of the claimed design.

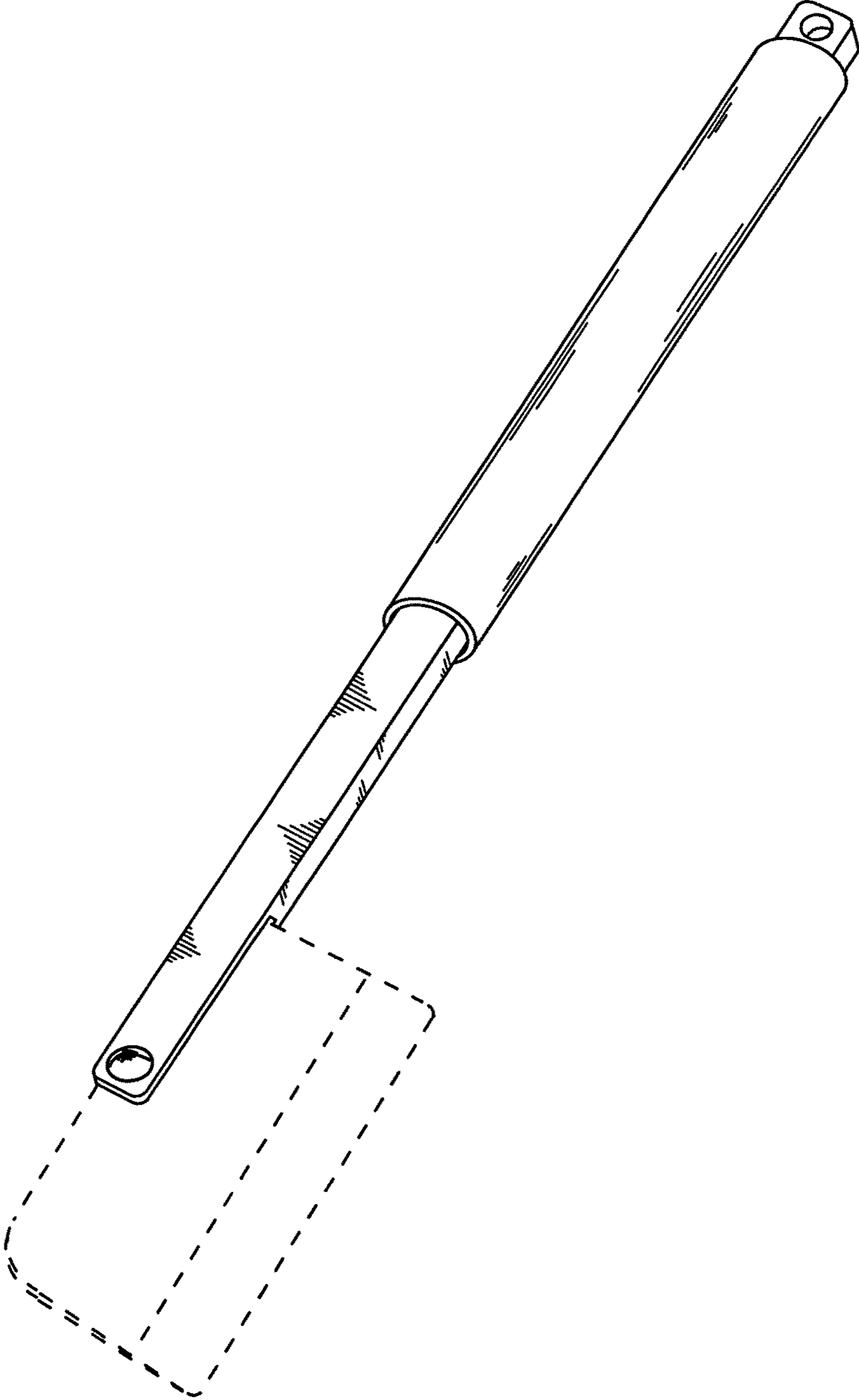

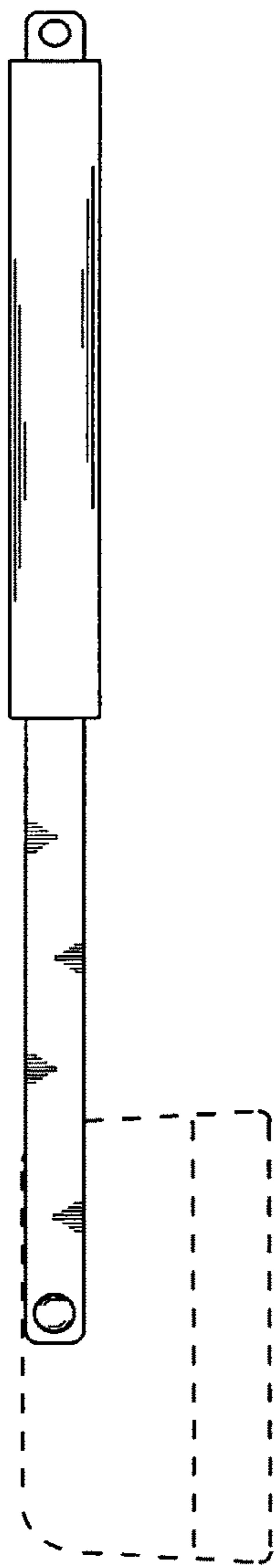

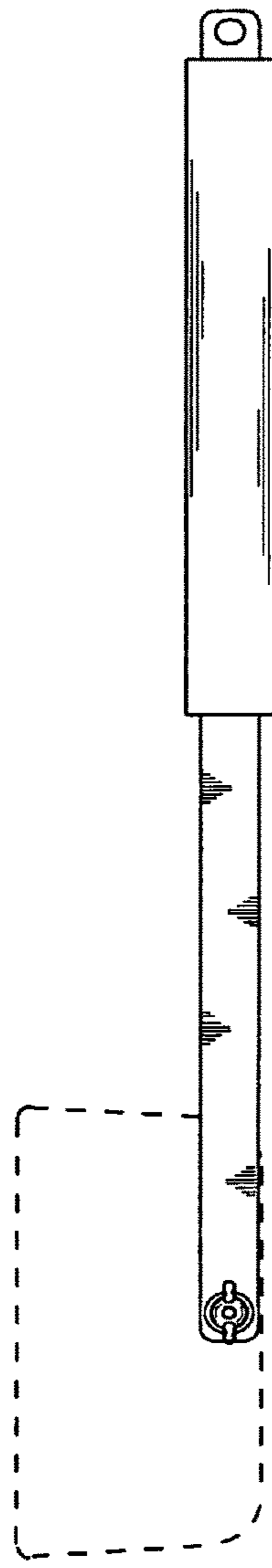

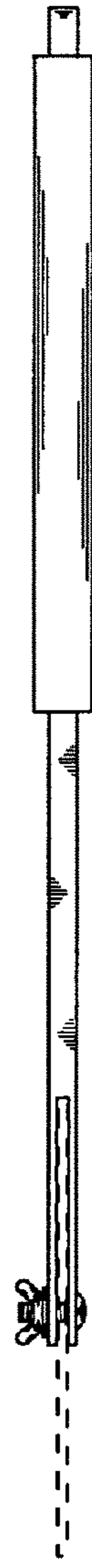

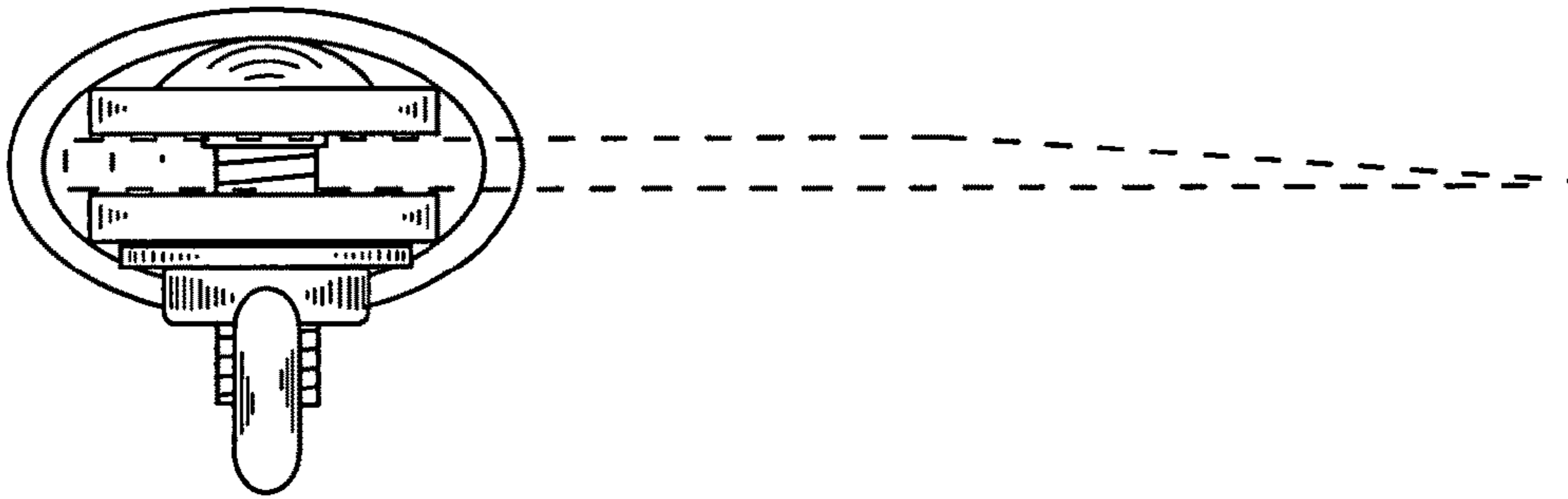

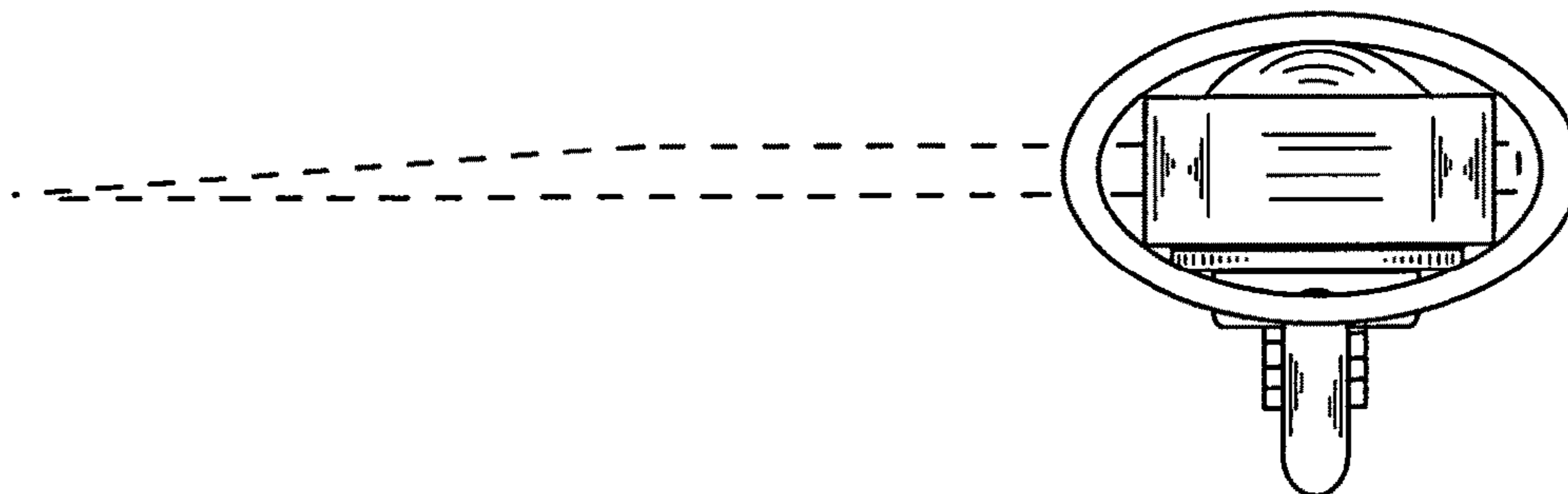

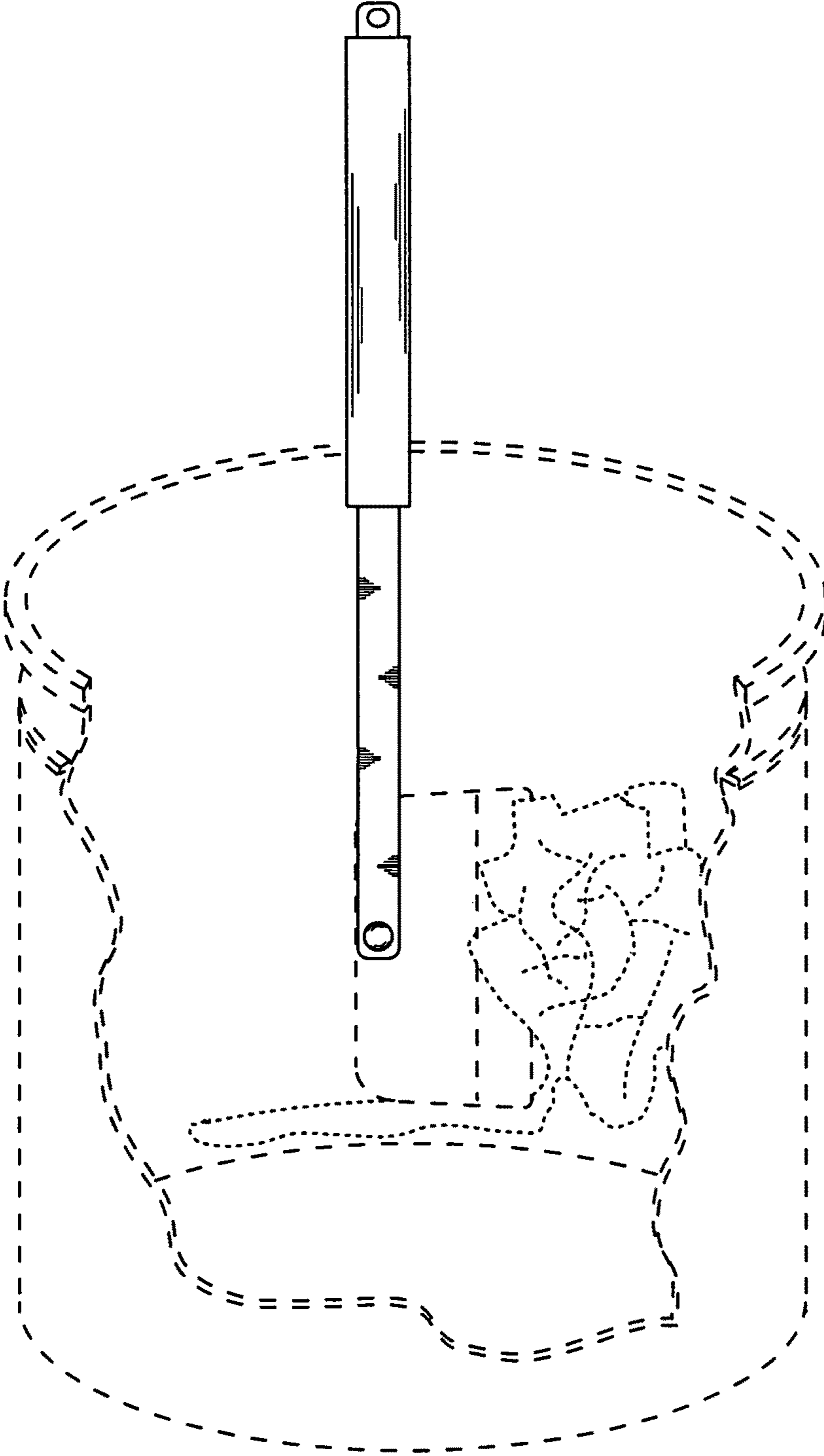

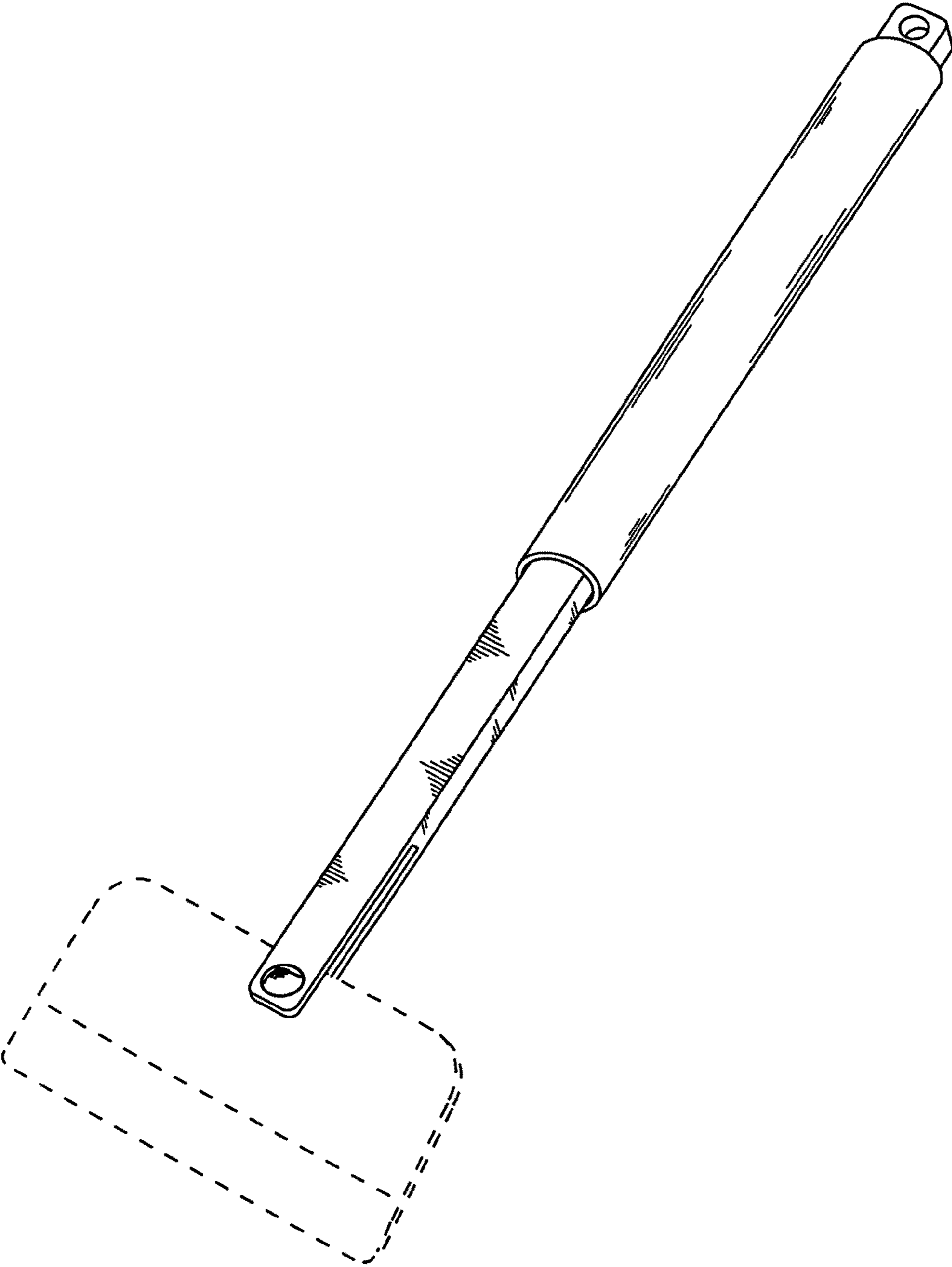

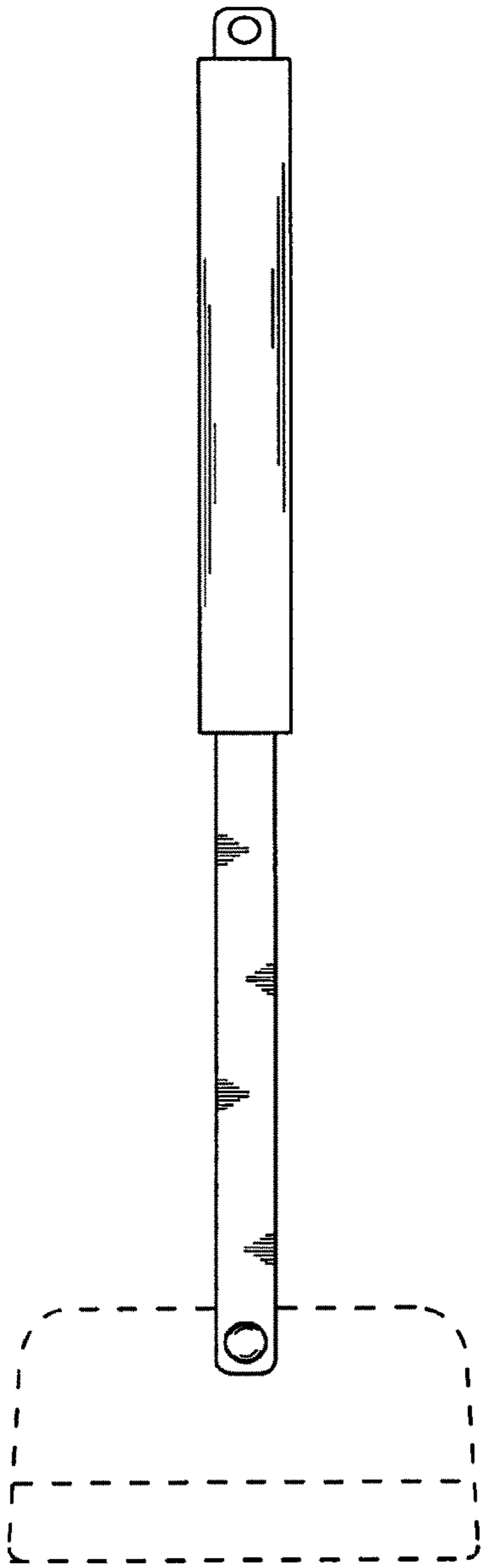

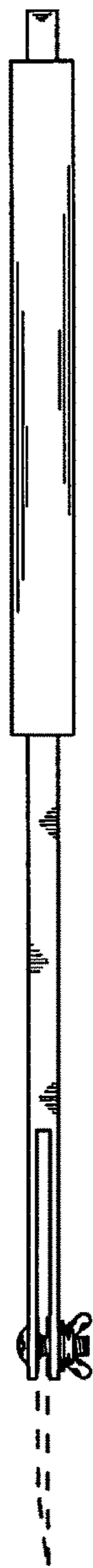

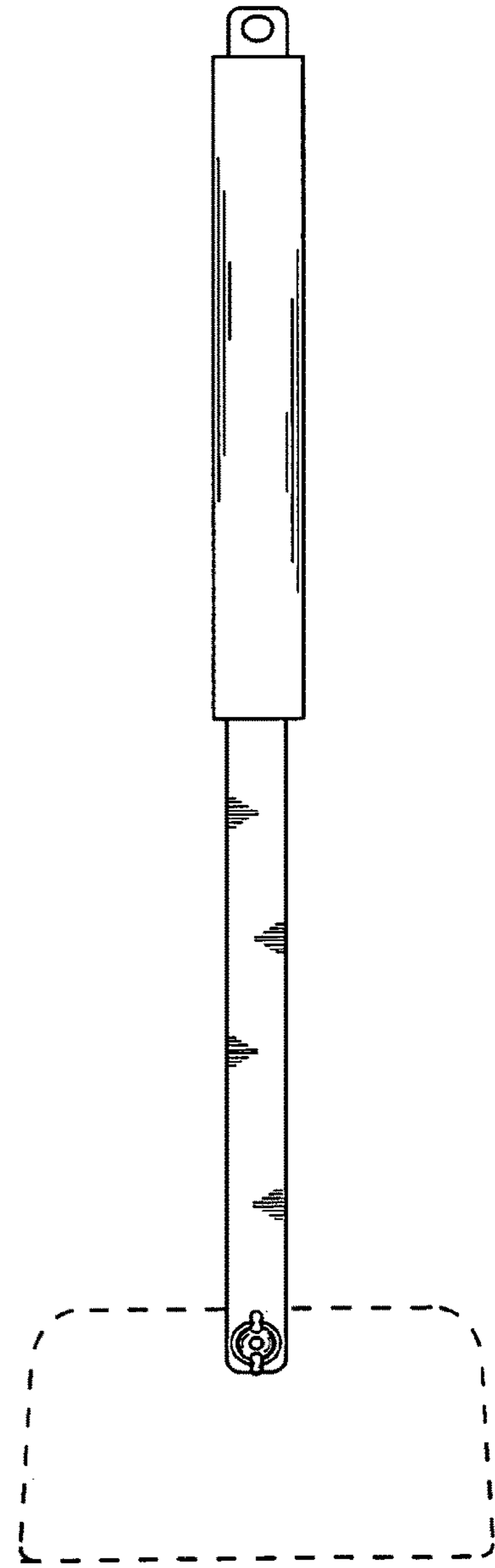

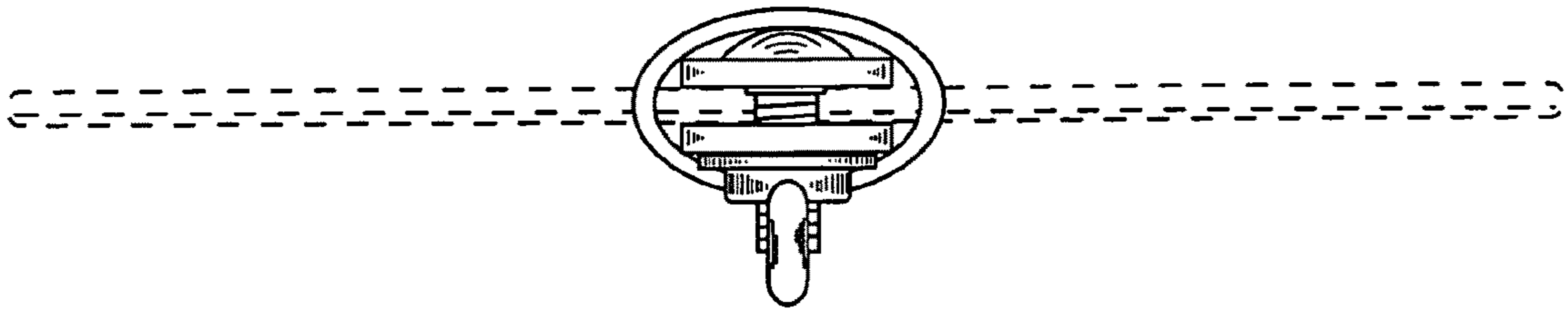

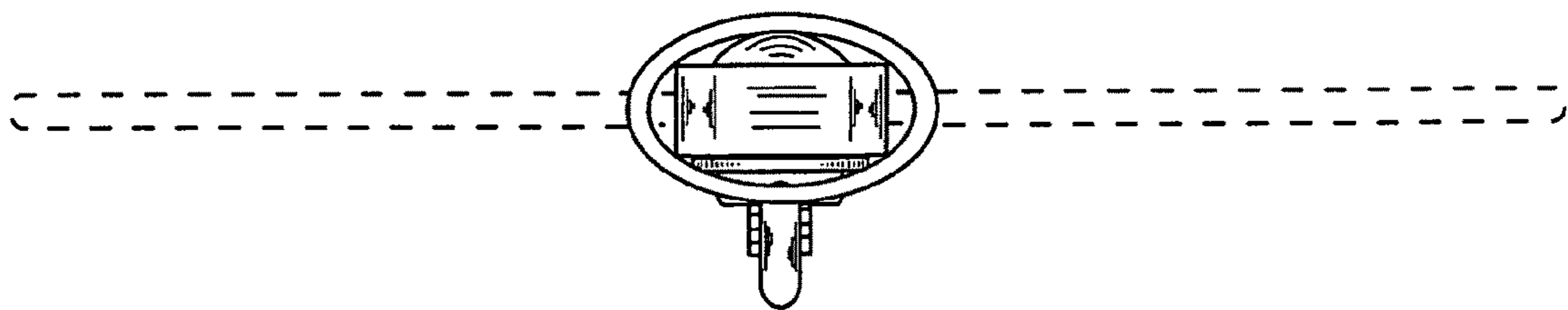

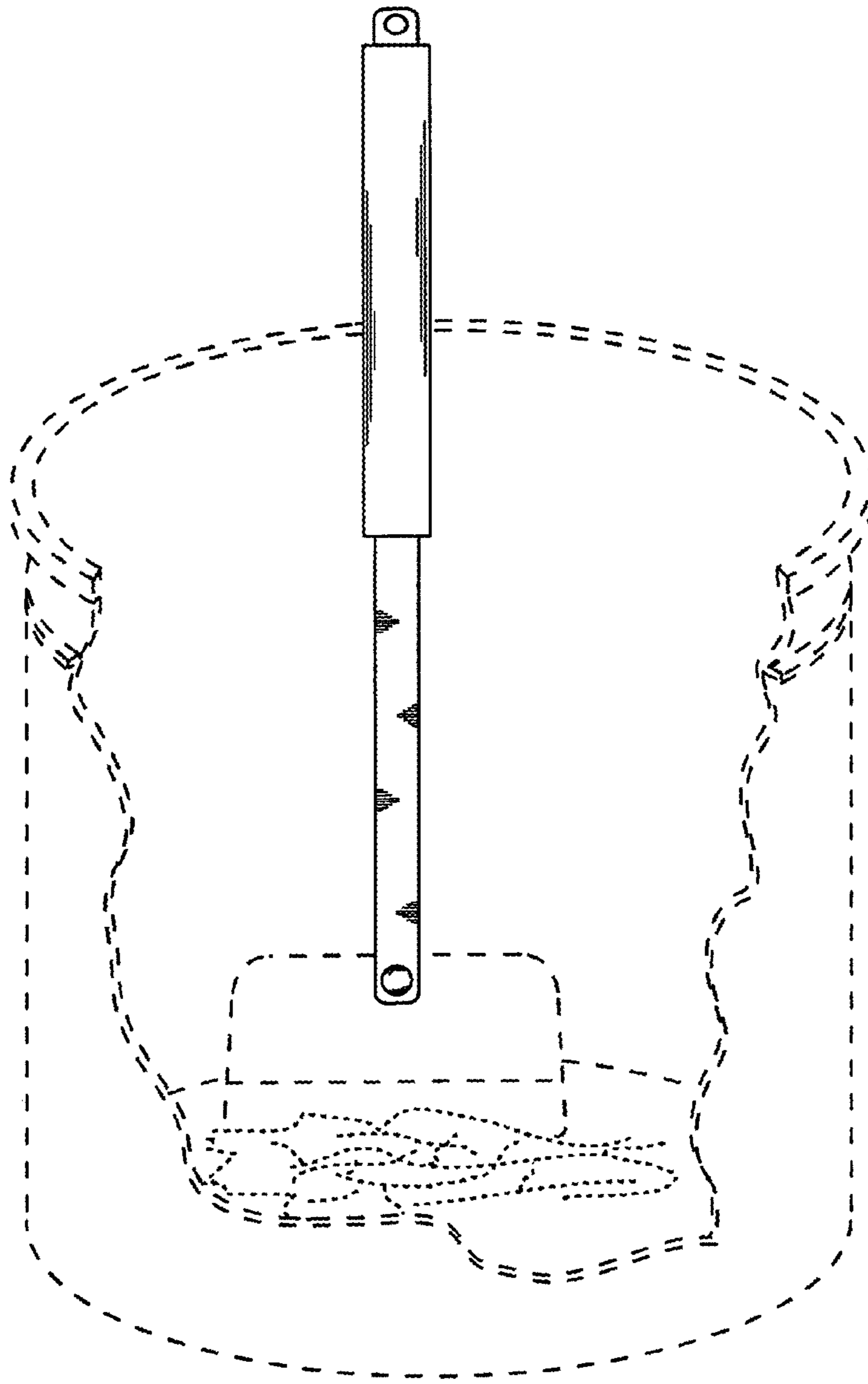
