DESCRIPTION

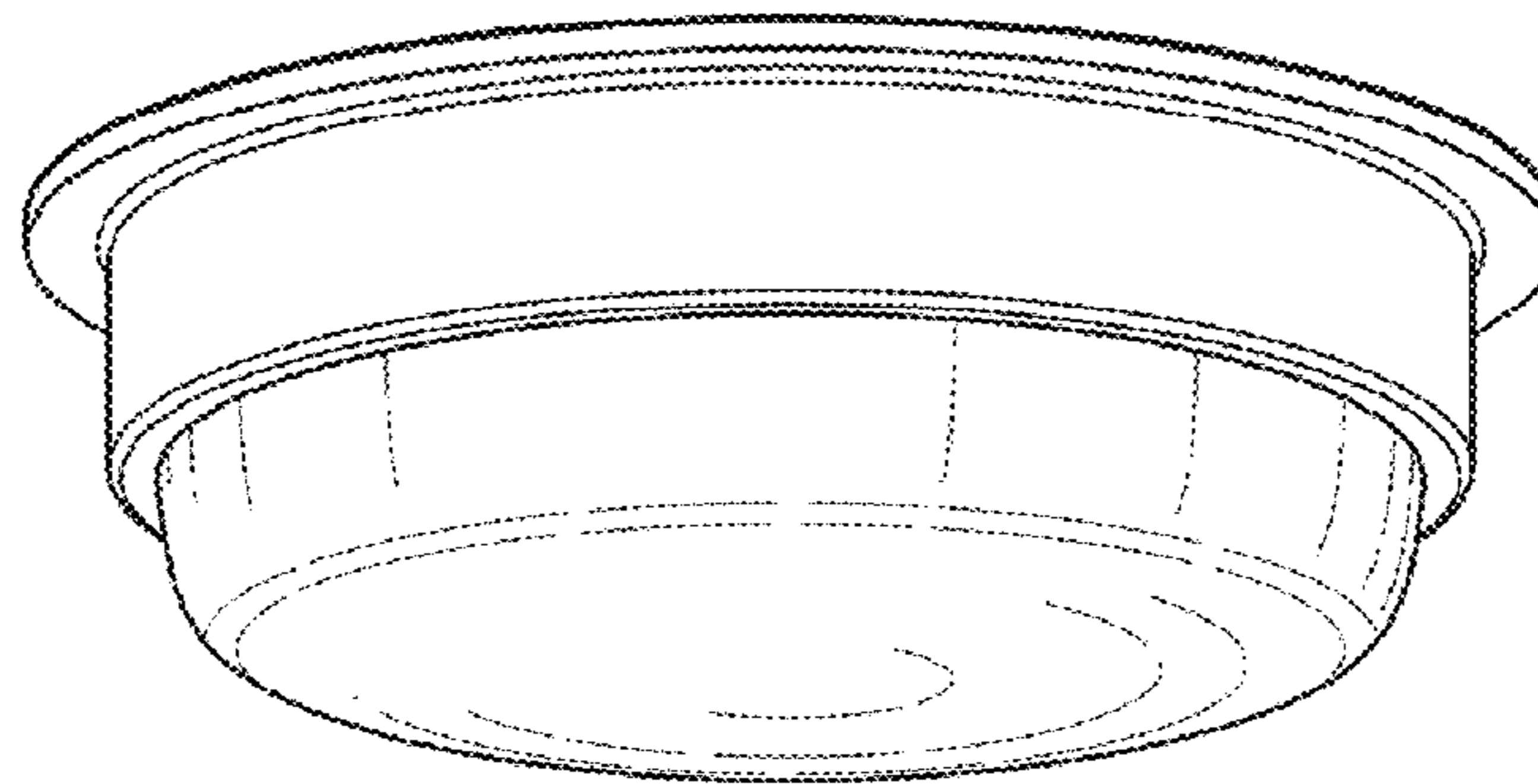
FIG. 1 is a bottom perspective view of a capsule for making

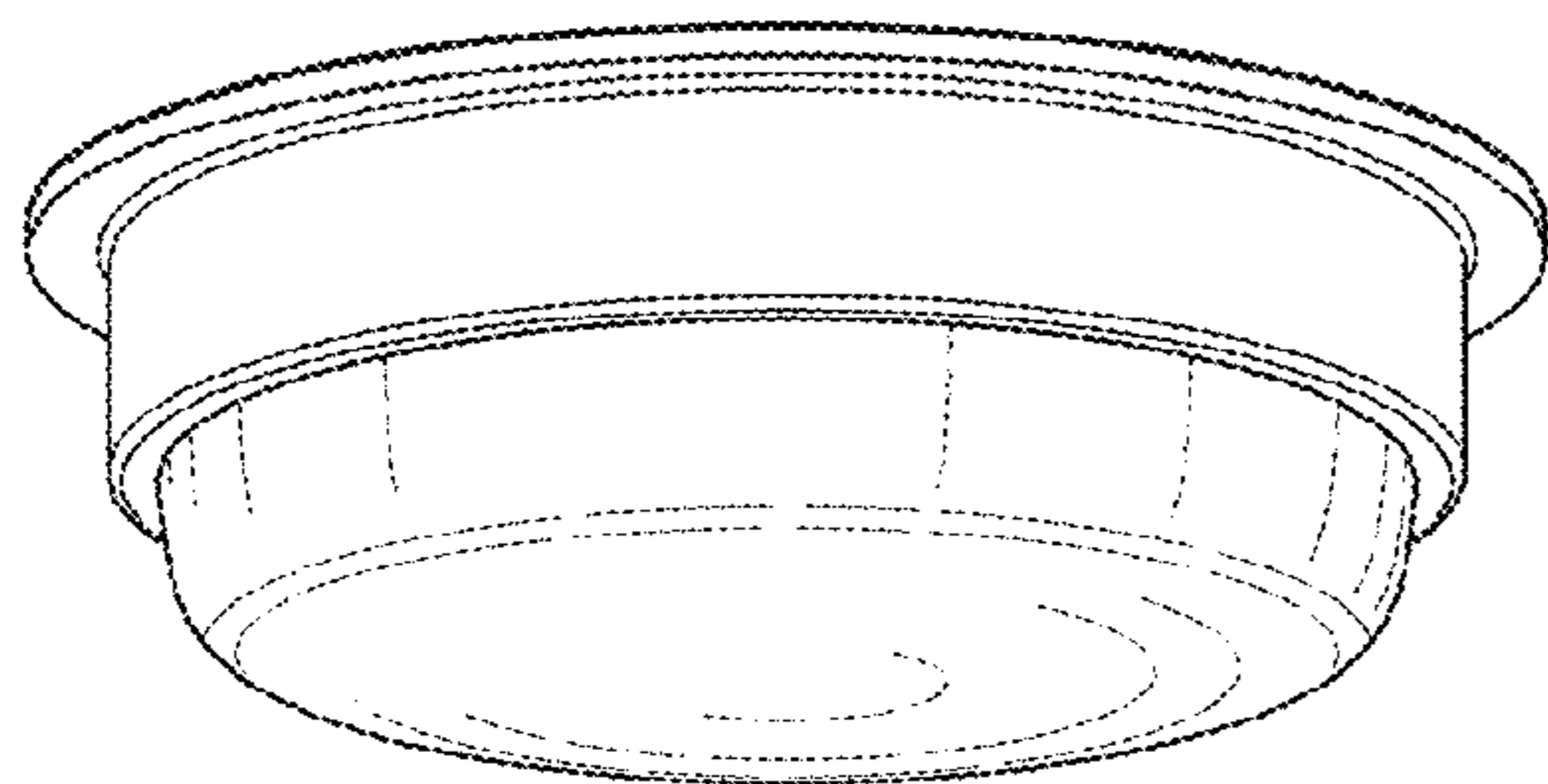

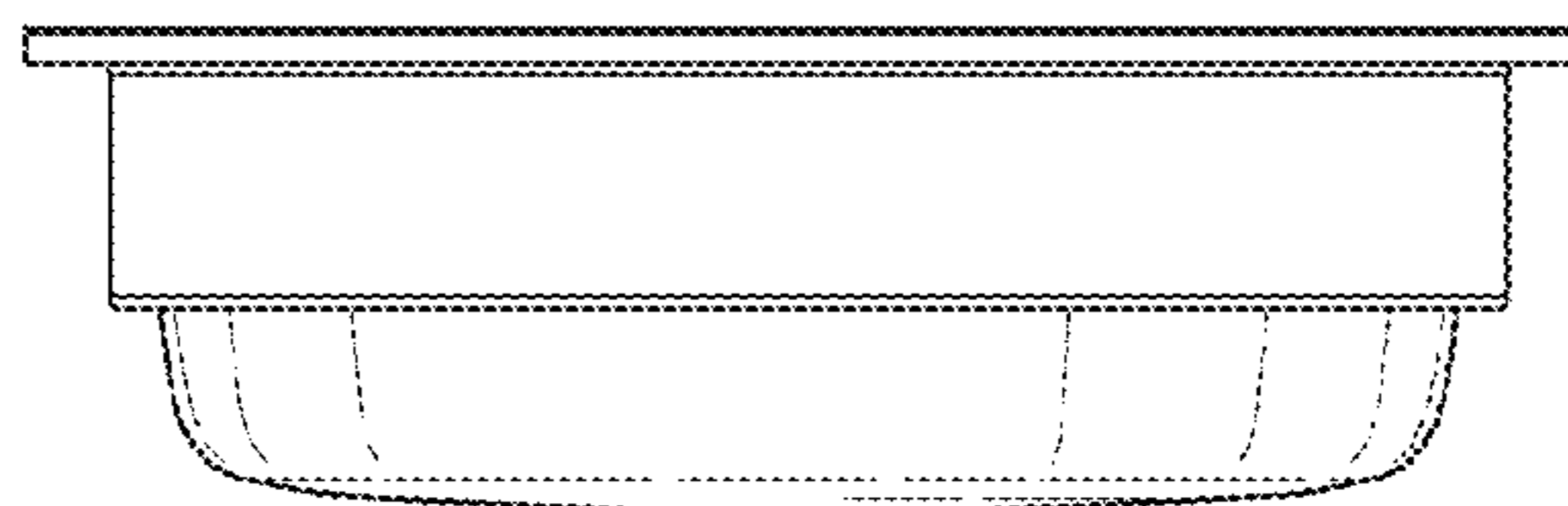

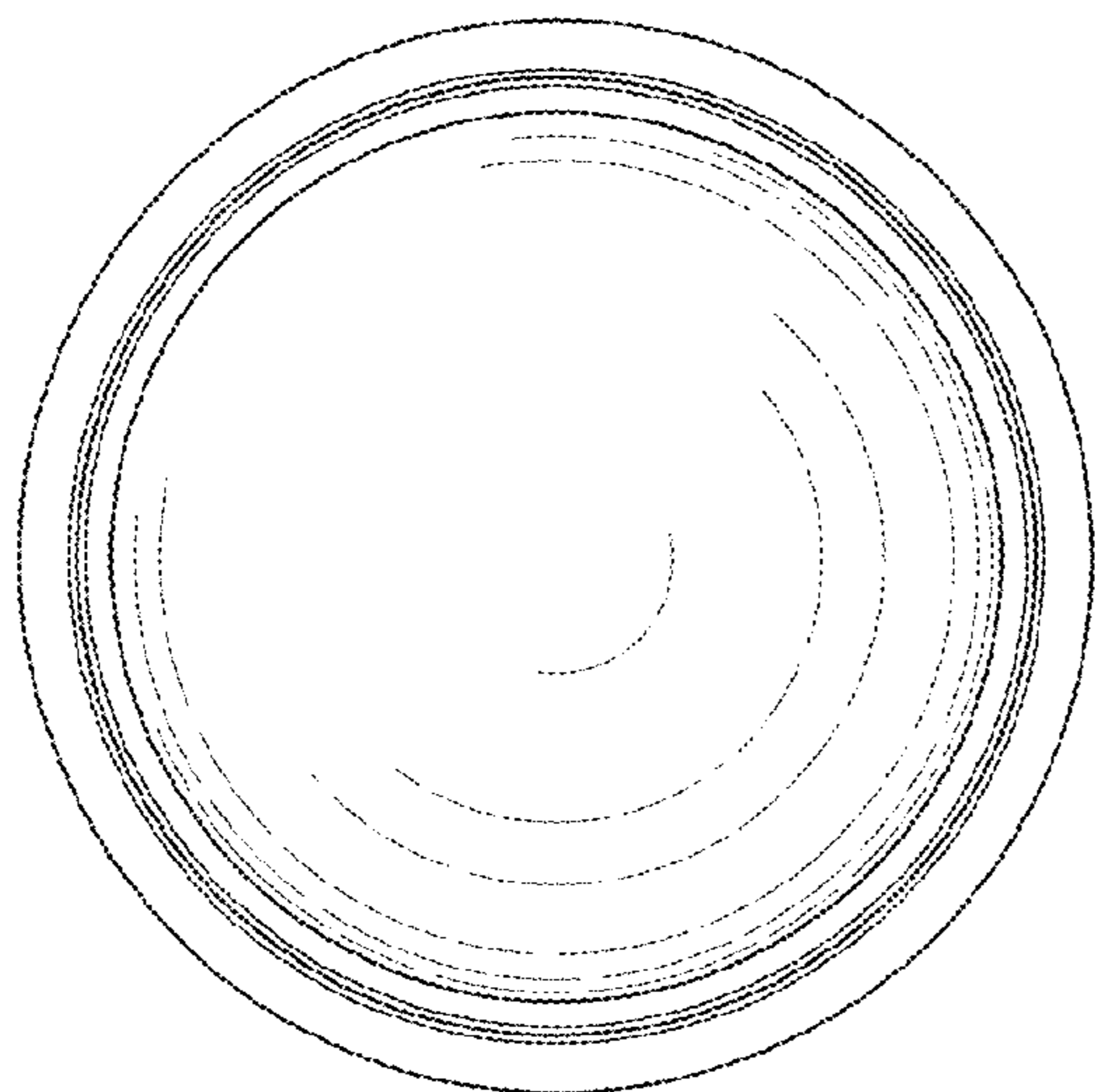
