**DESCRIPTION**

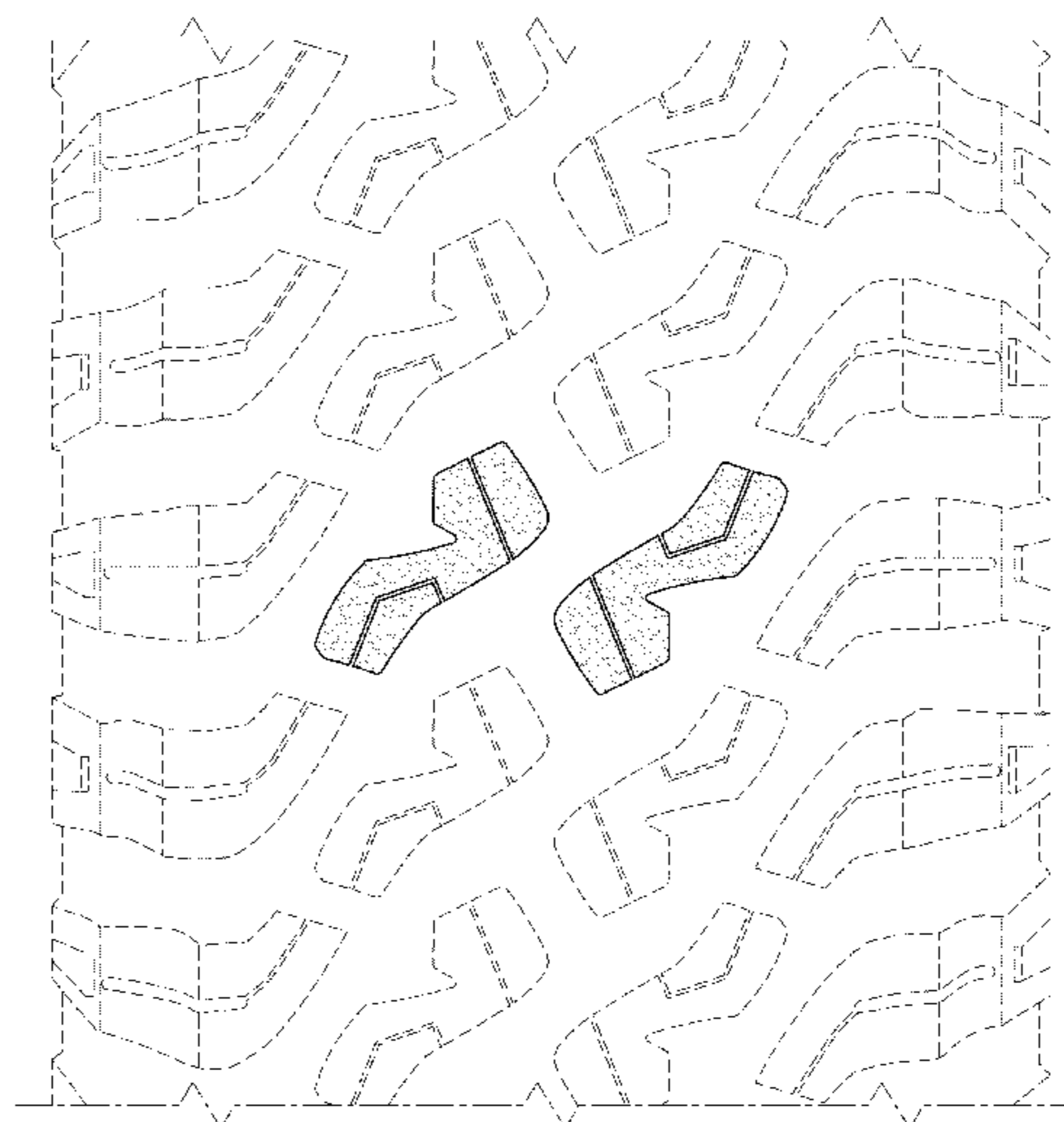
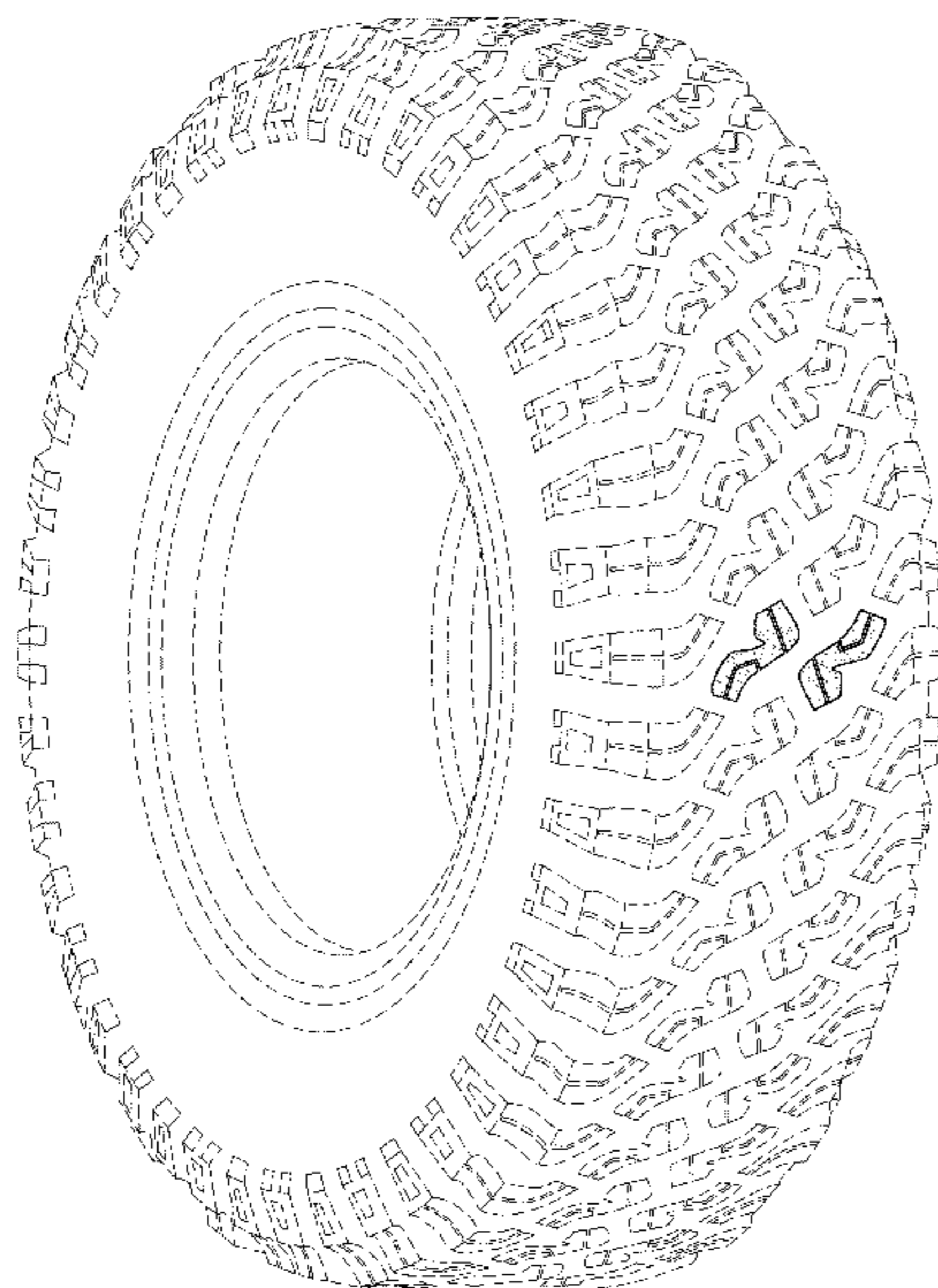
FIG. 1 is a front, left perspective view of a tire for automobile showing my new design;

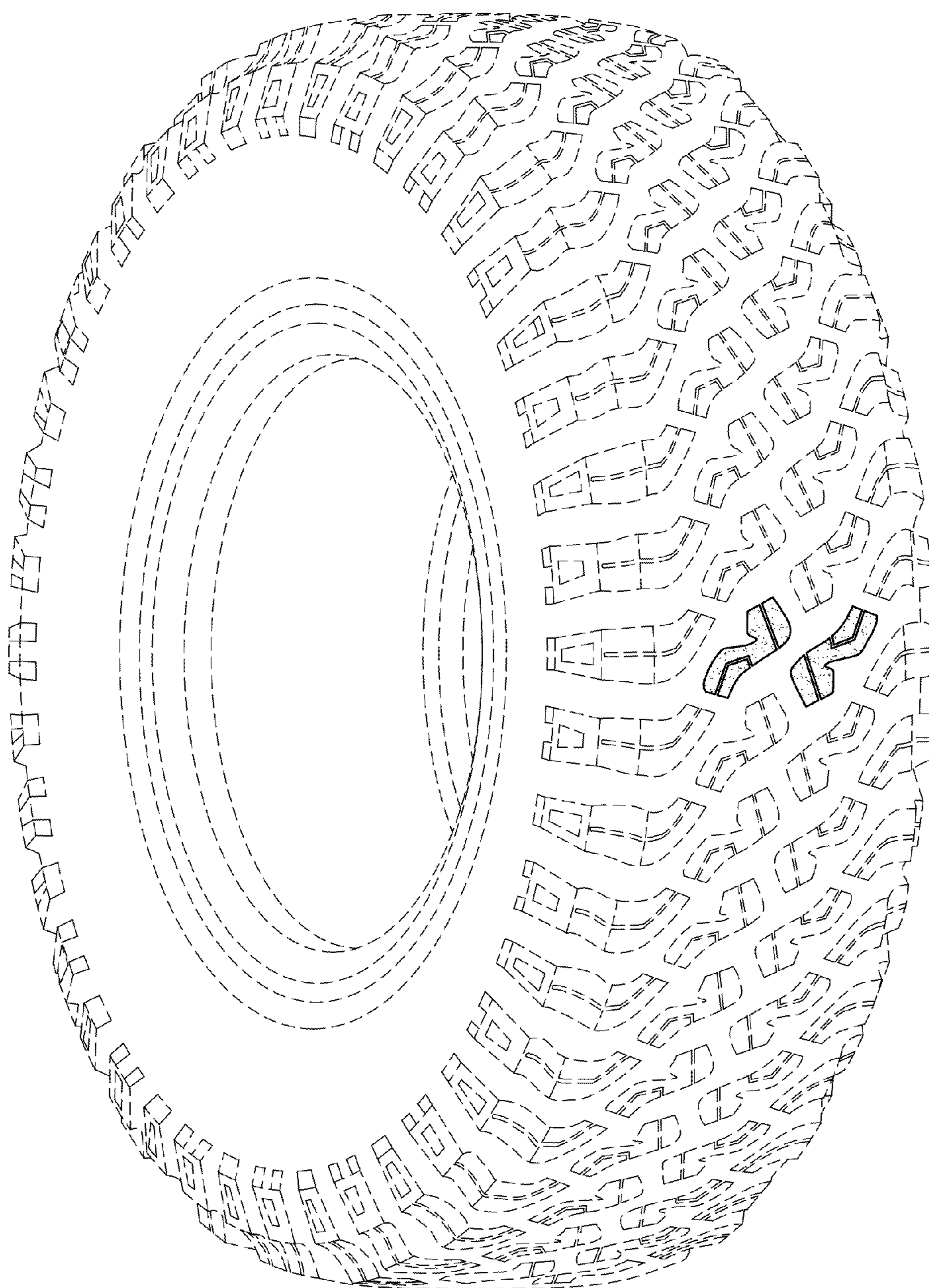

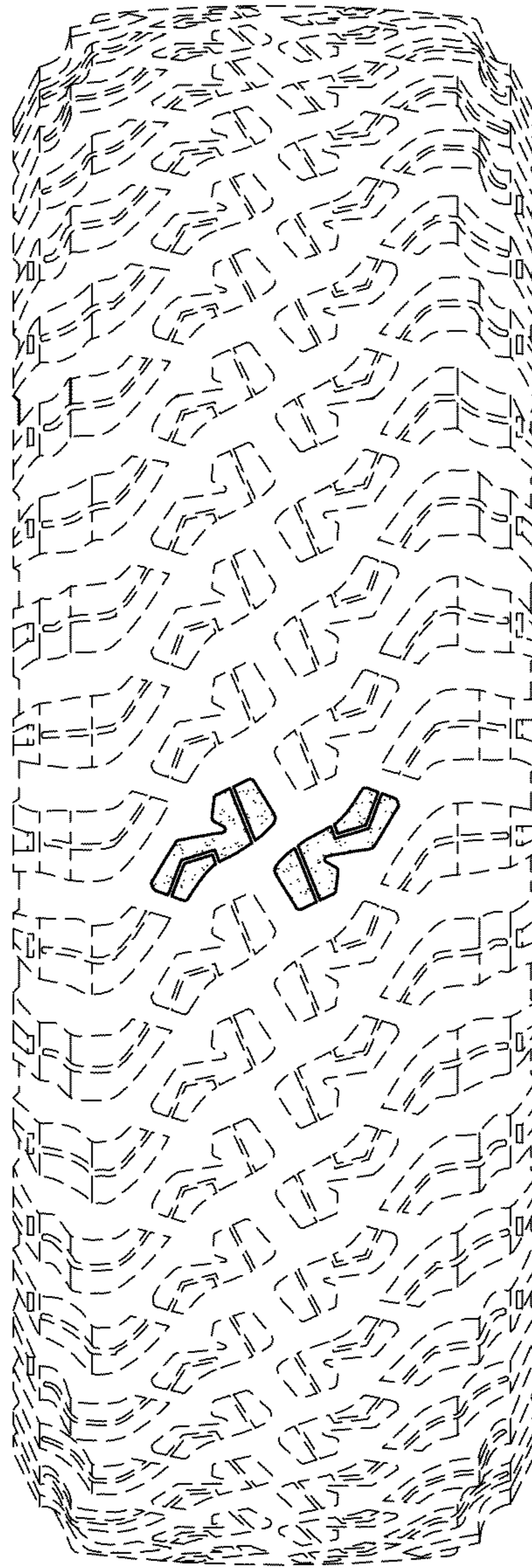

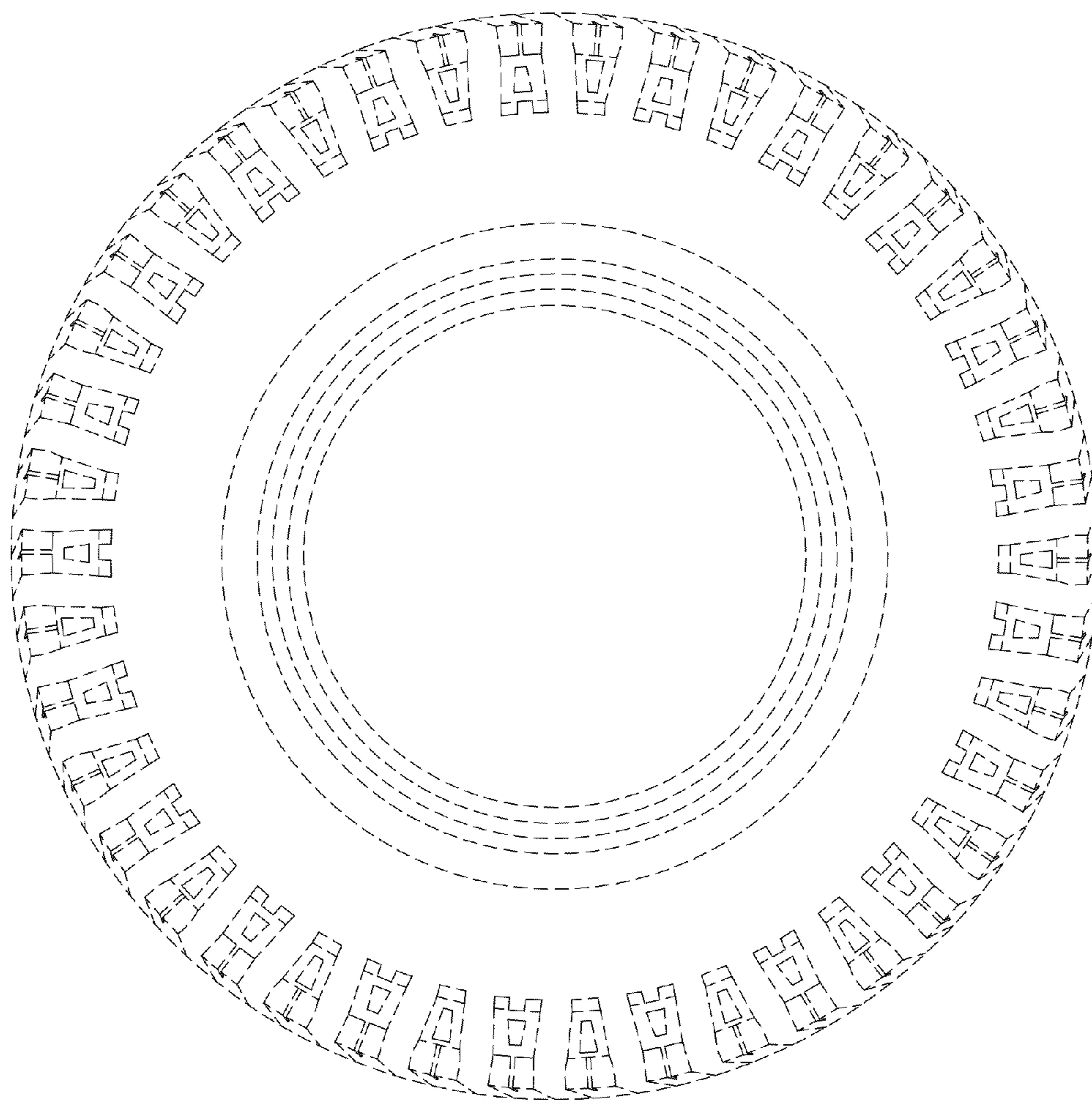

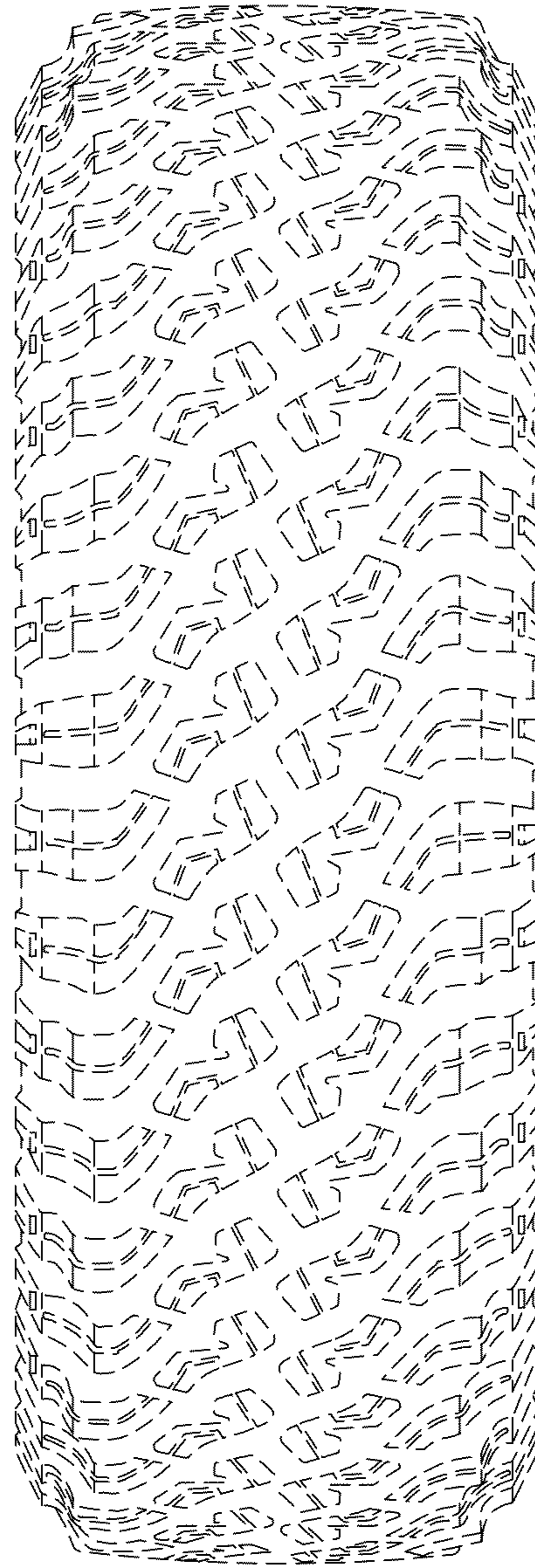

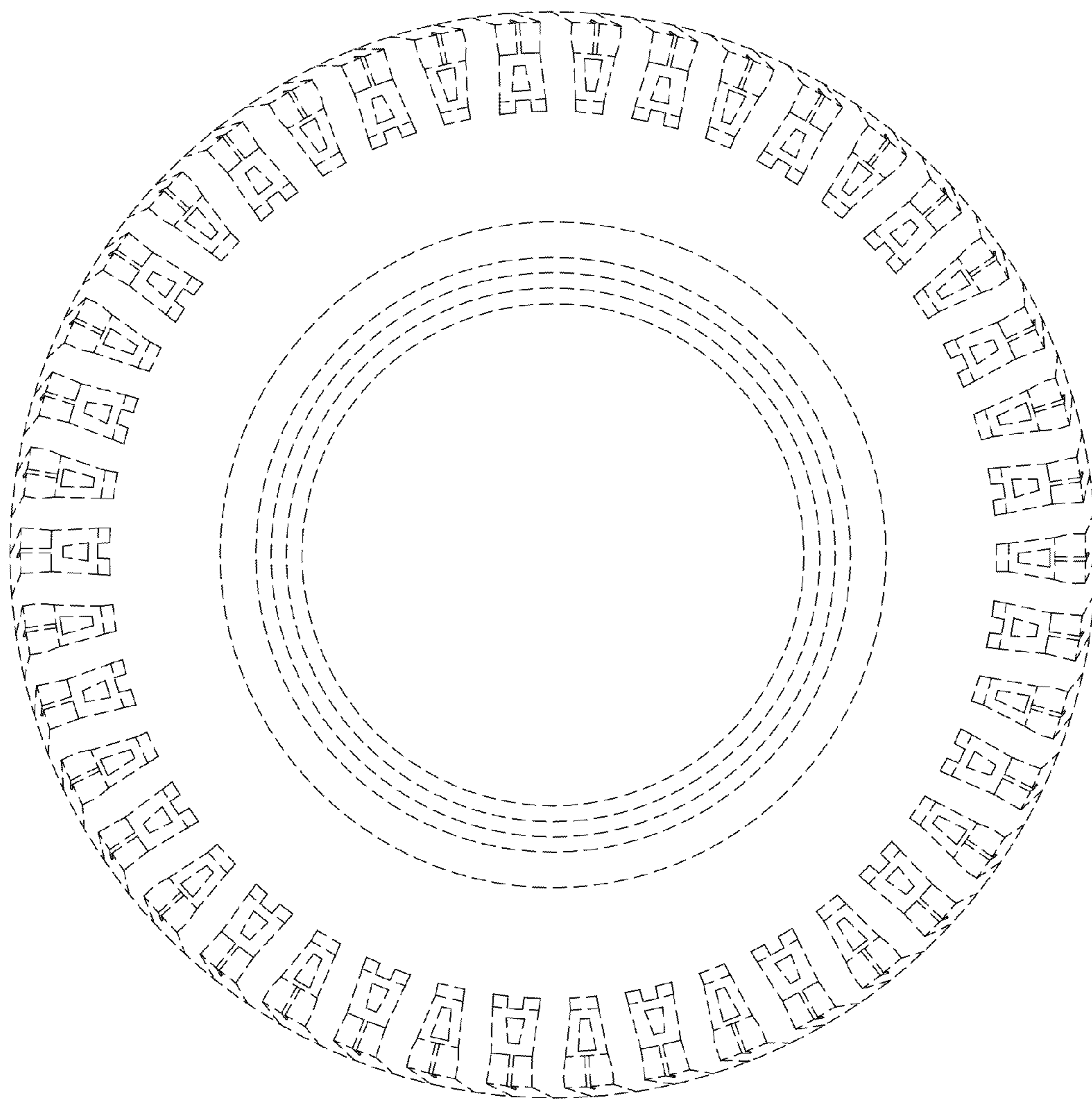

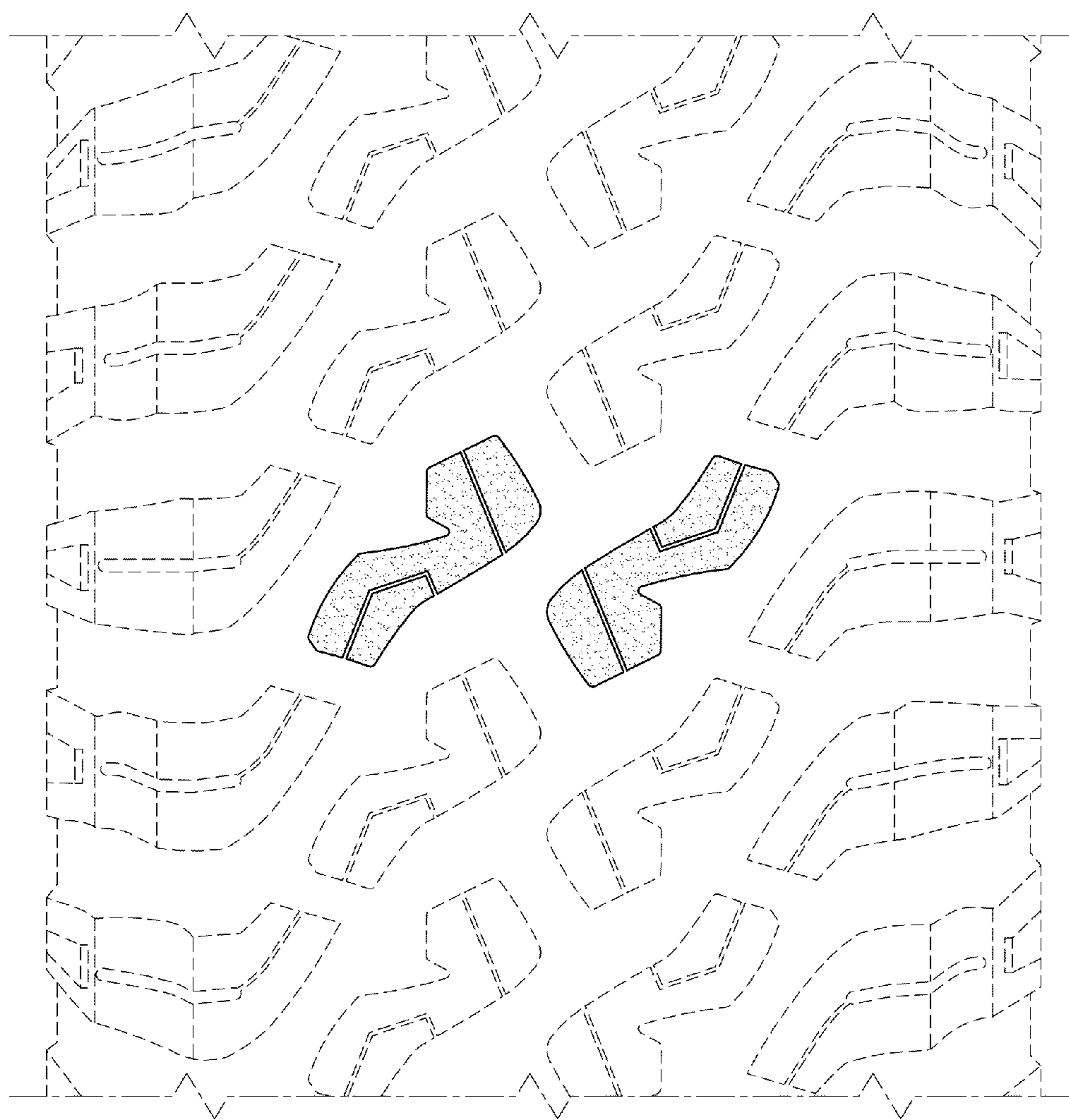
