The broken lines defining the peripheral boundary, sidewall and inner bead are for the purpose of illustrating environment that forms no part of the claimed design.

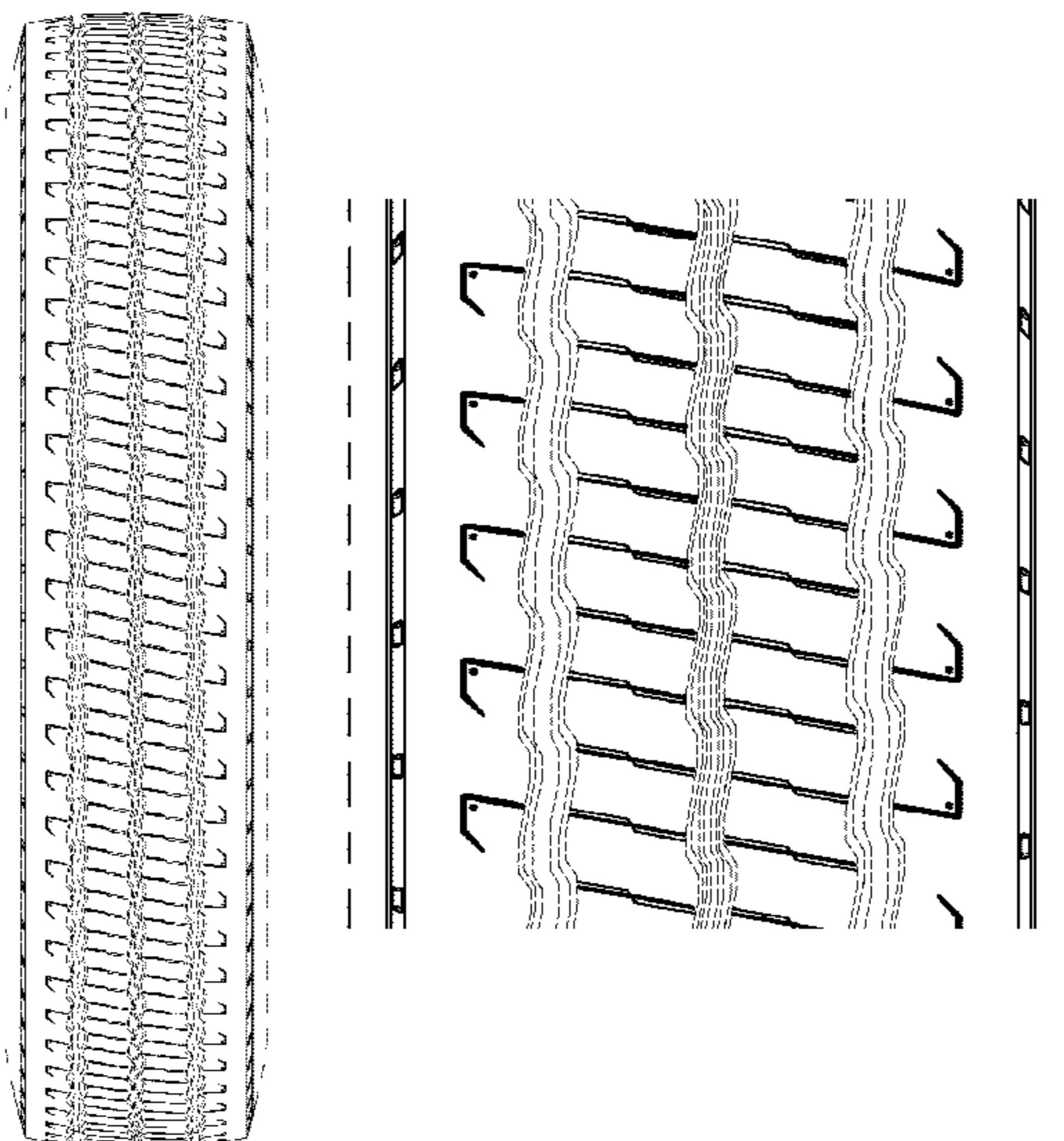

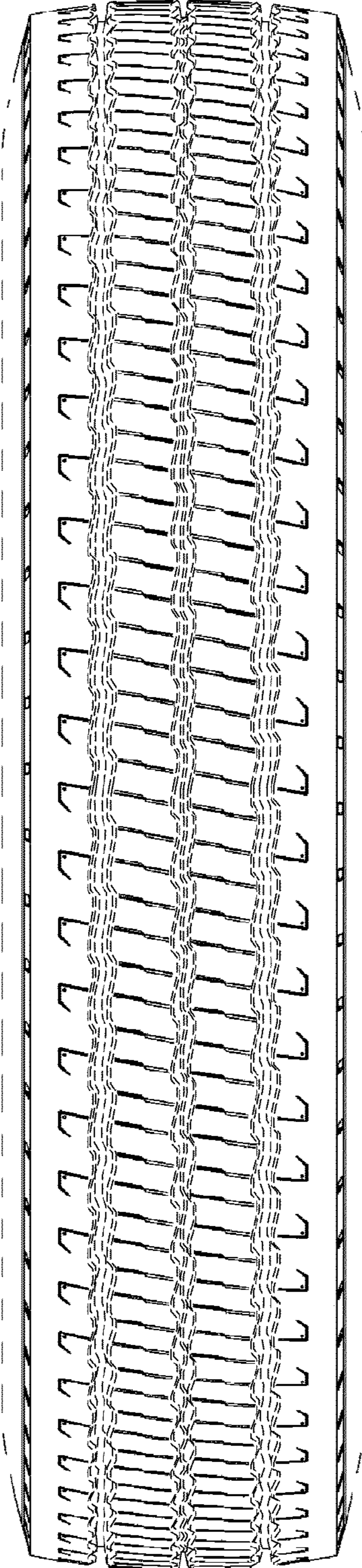

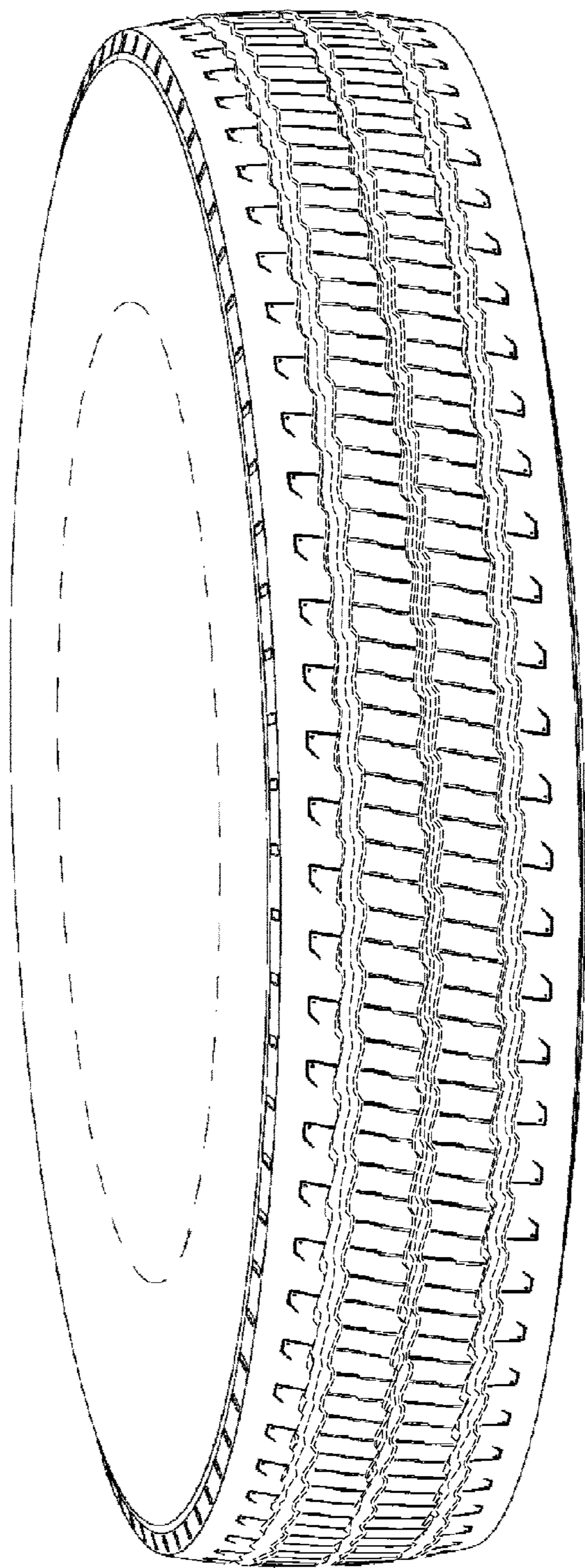

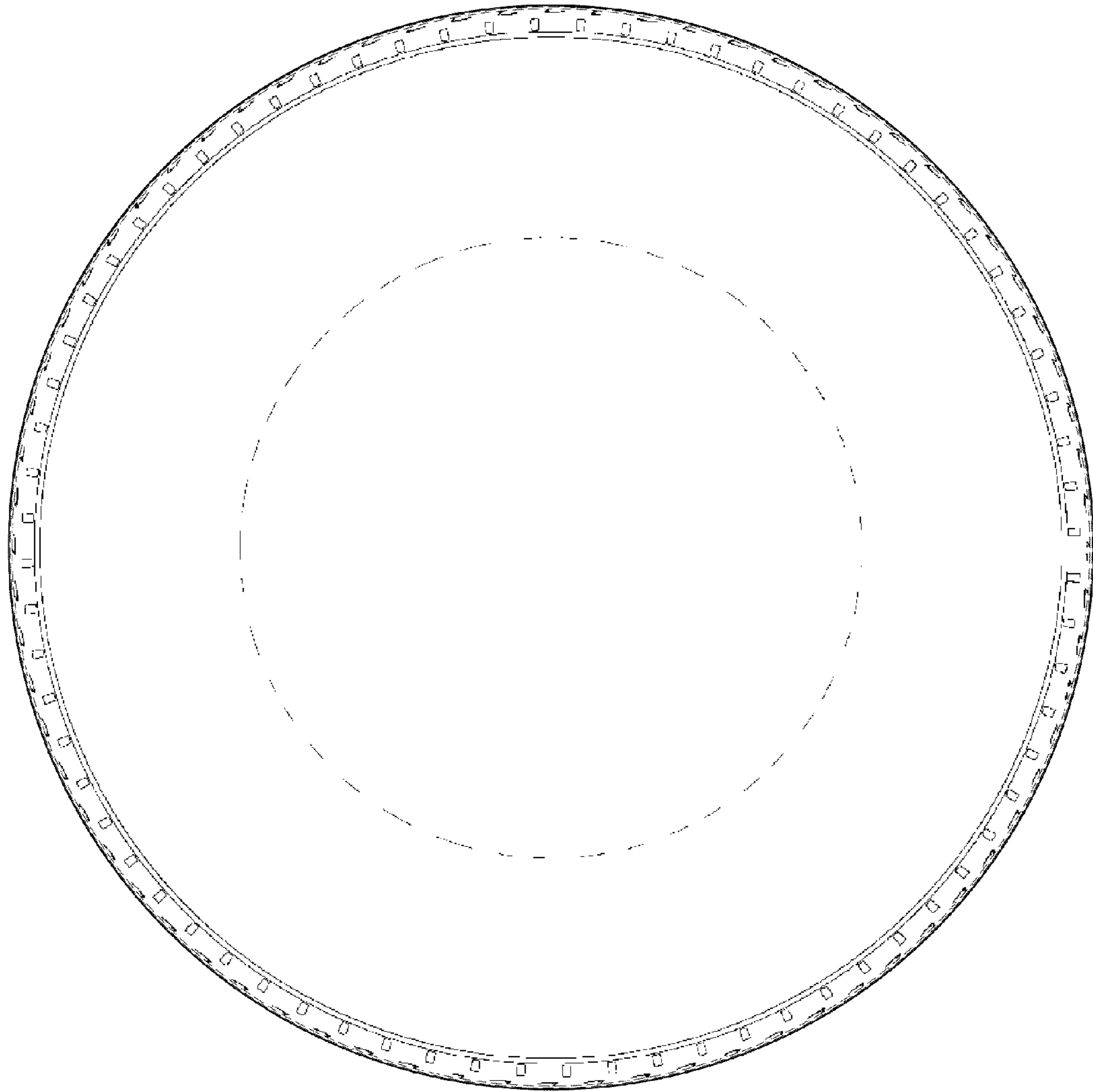

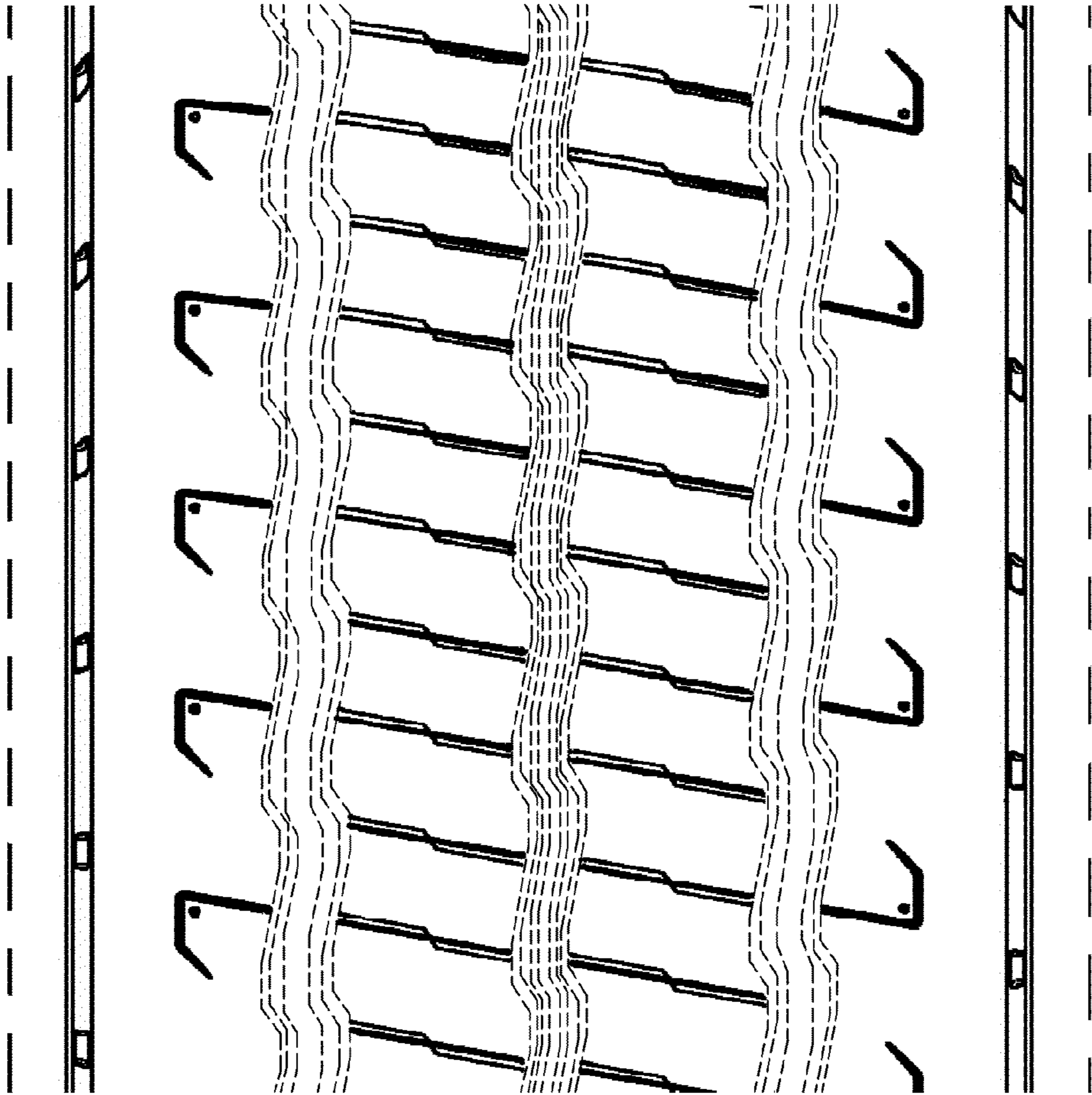
