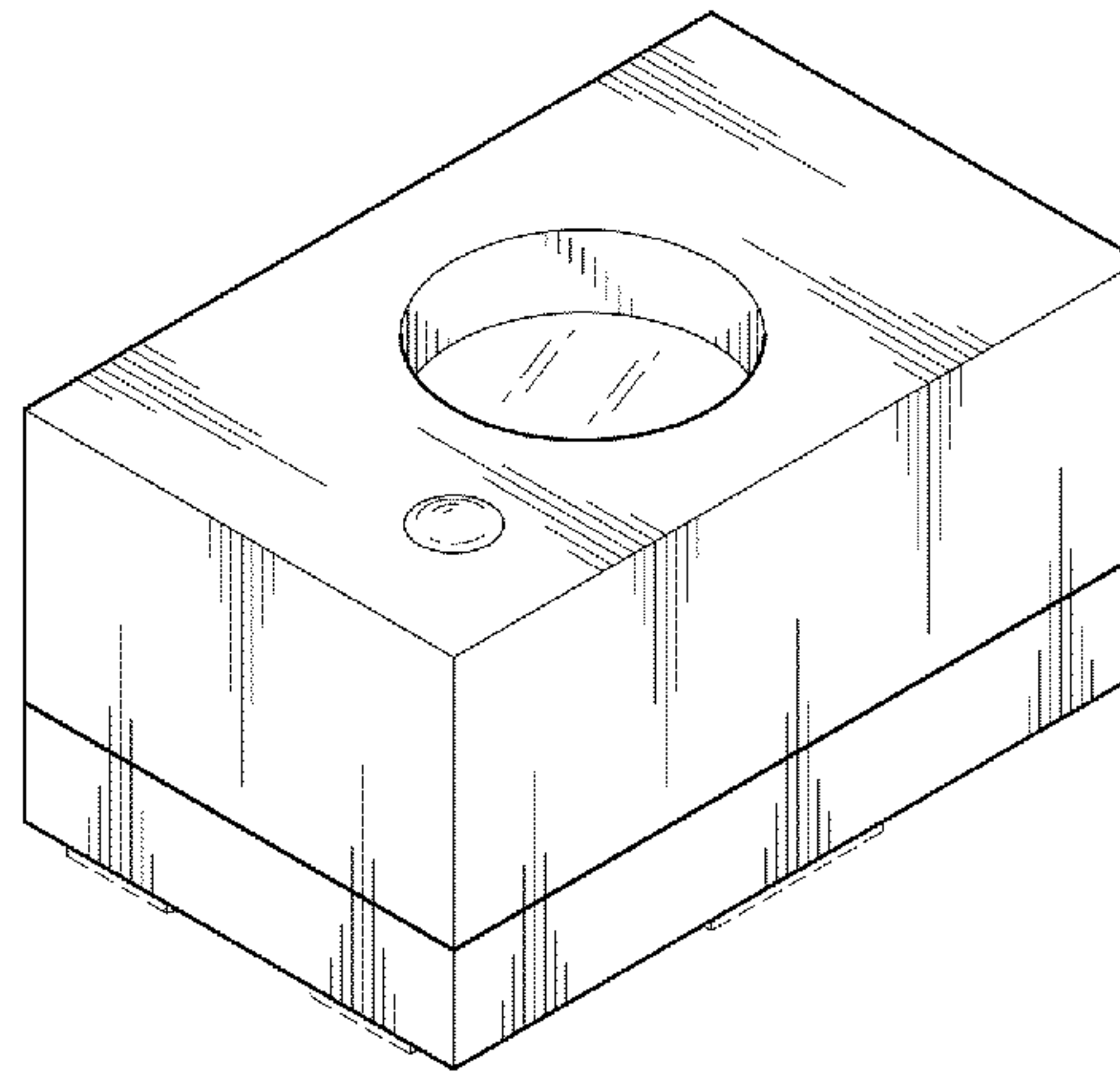
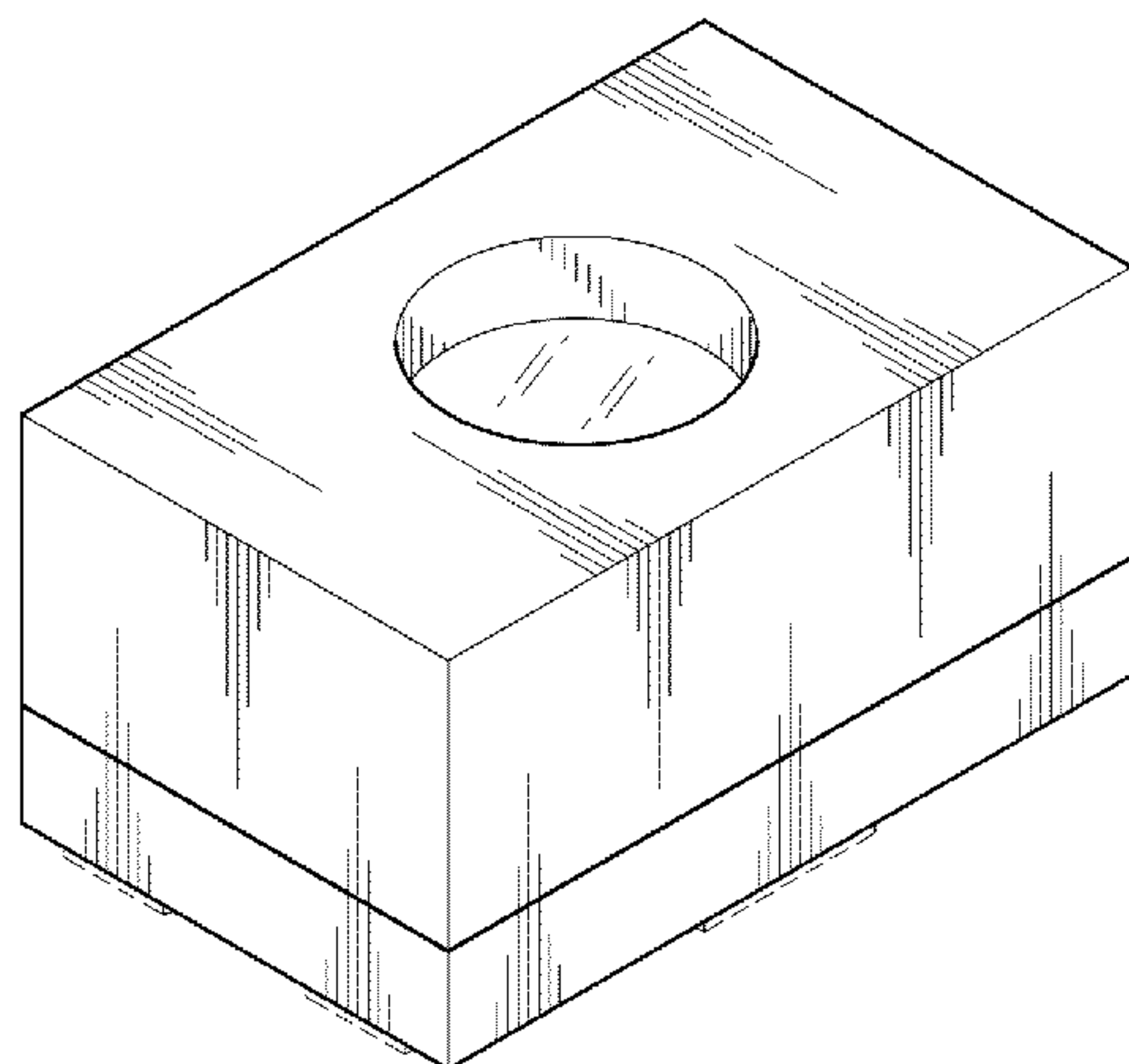
The ornamental design for a “light emitting diode,” as shown

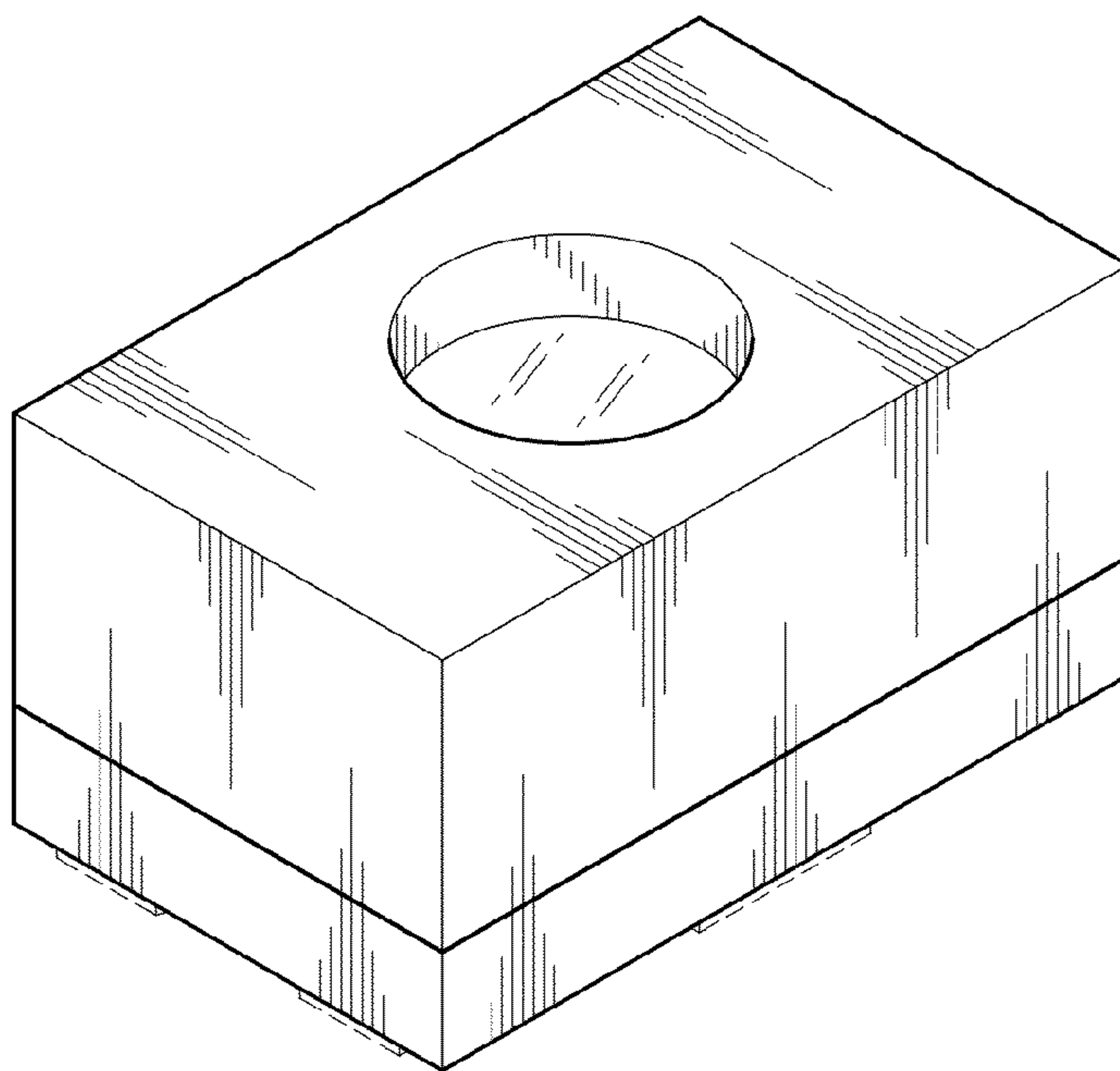

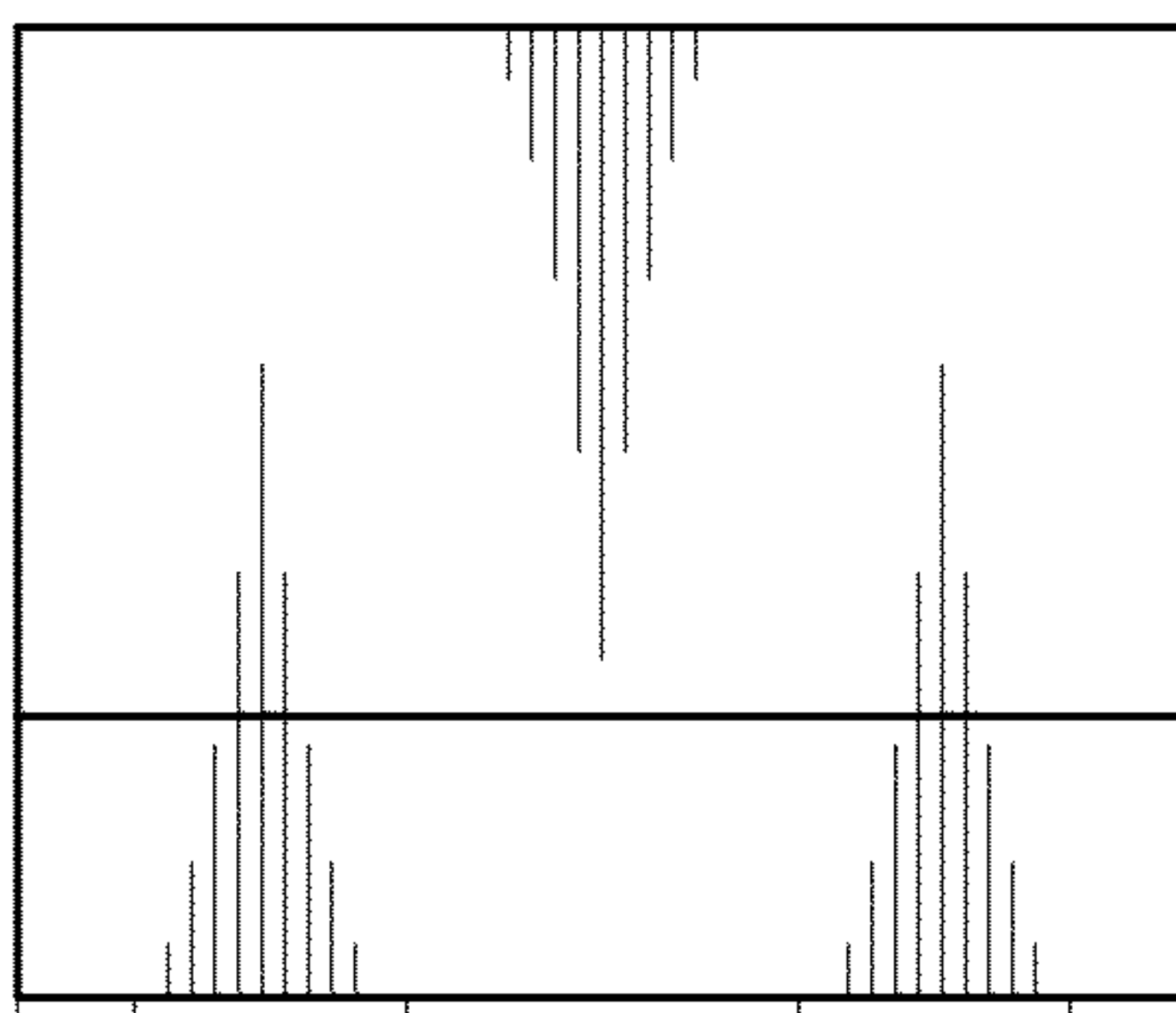

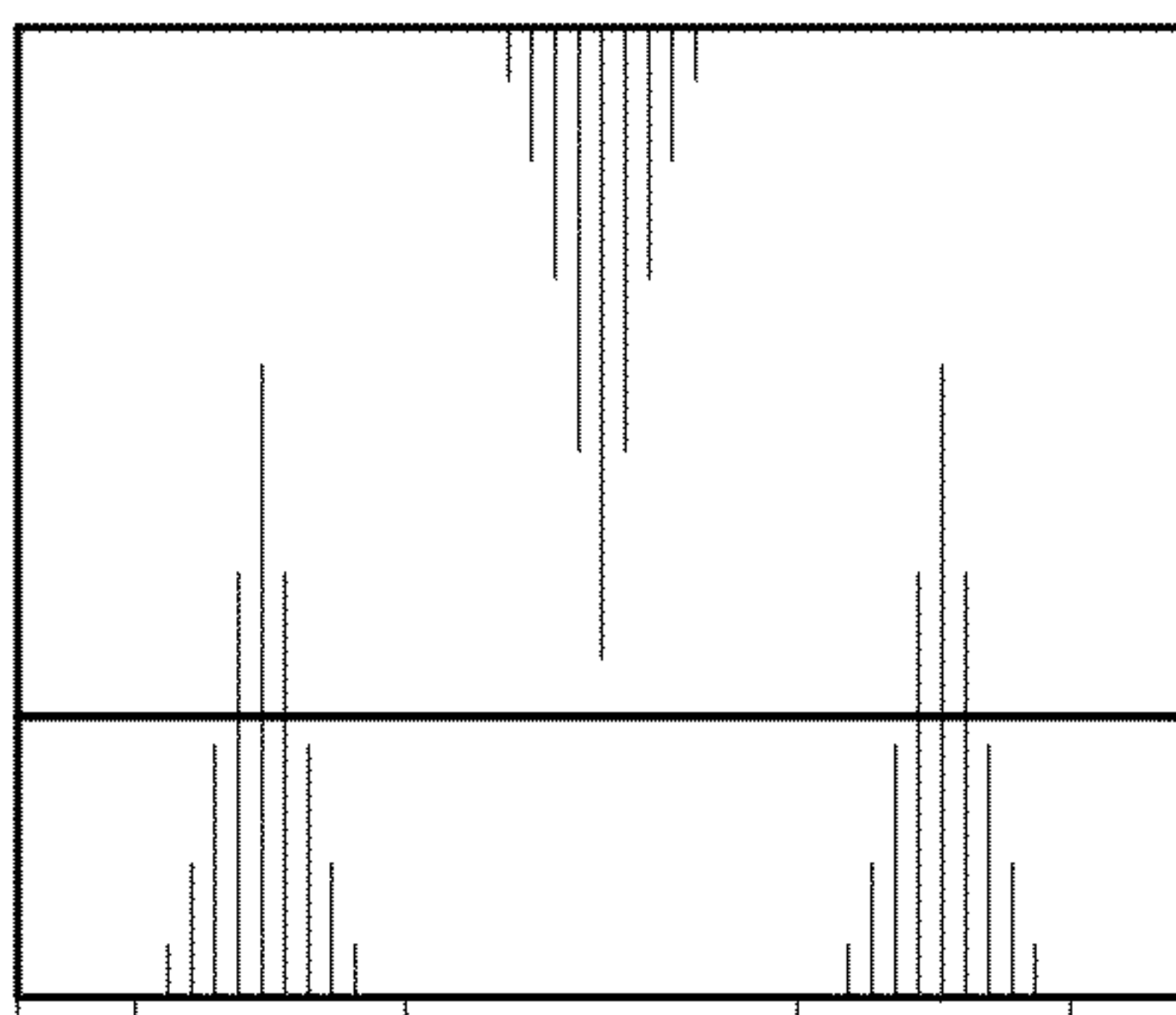

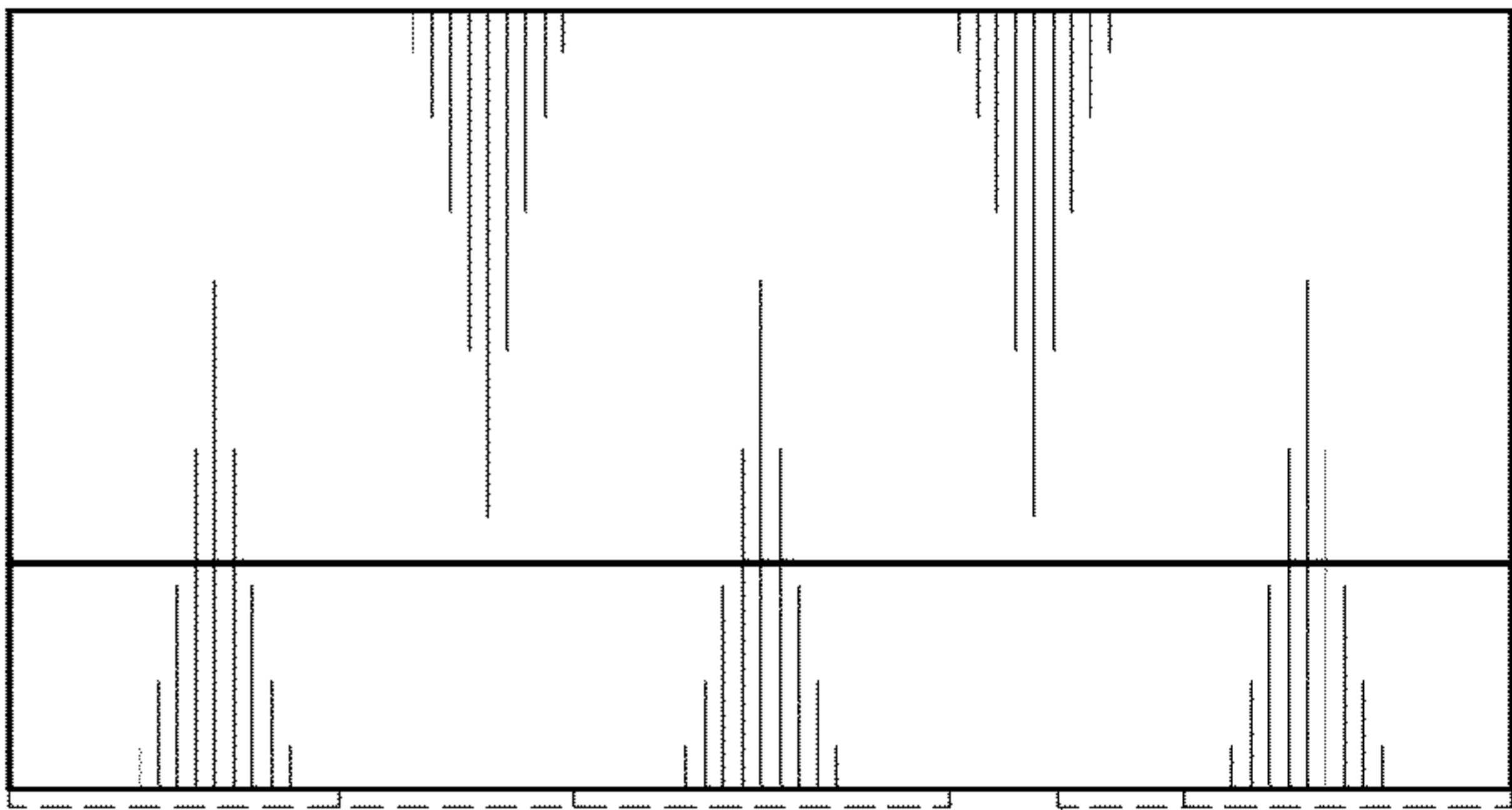

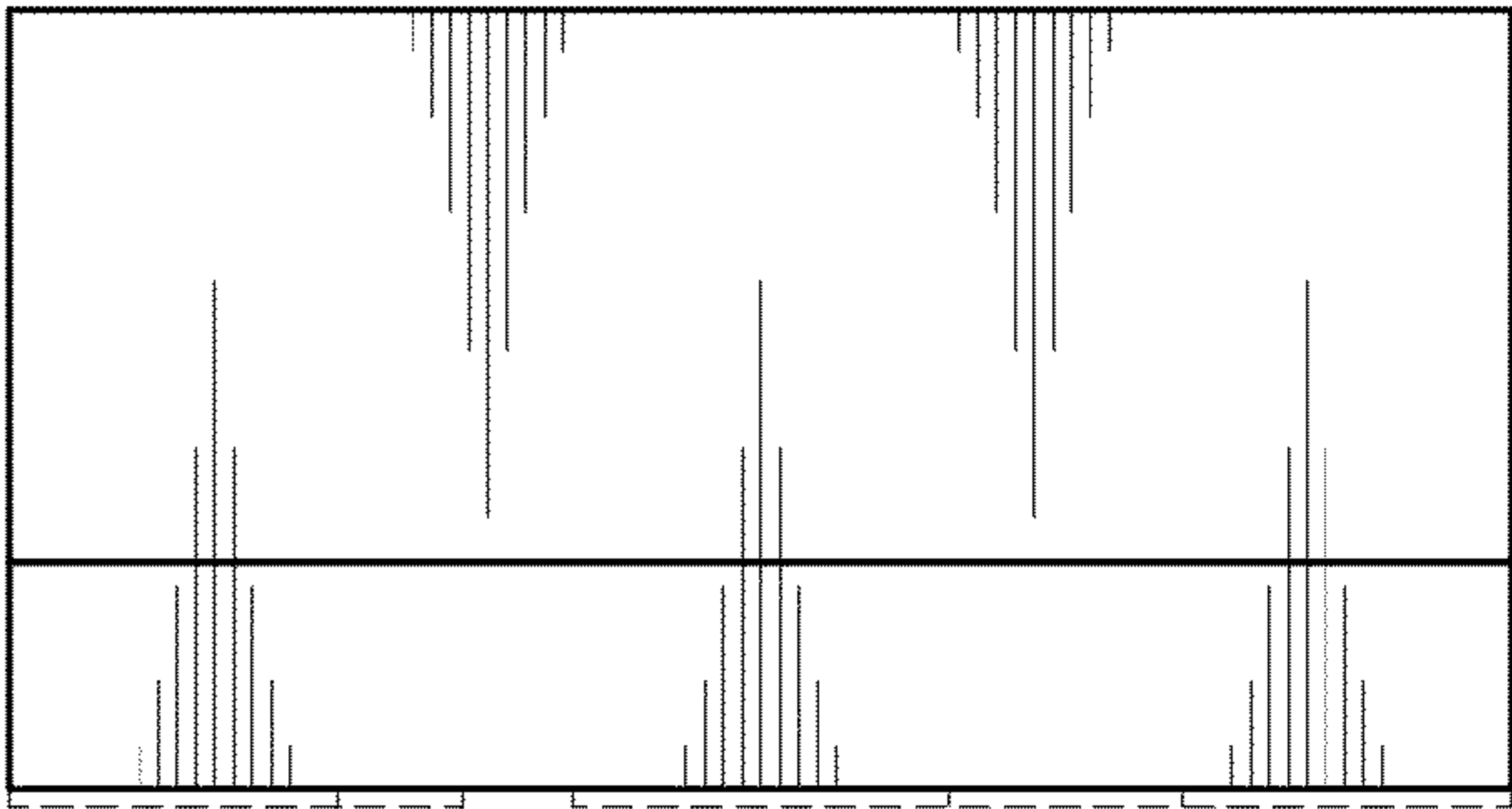

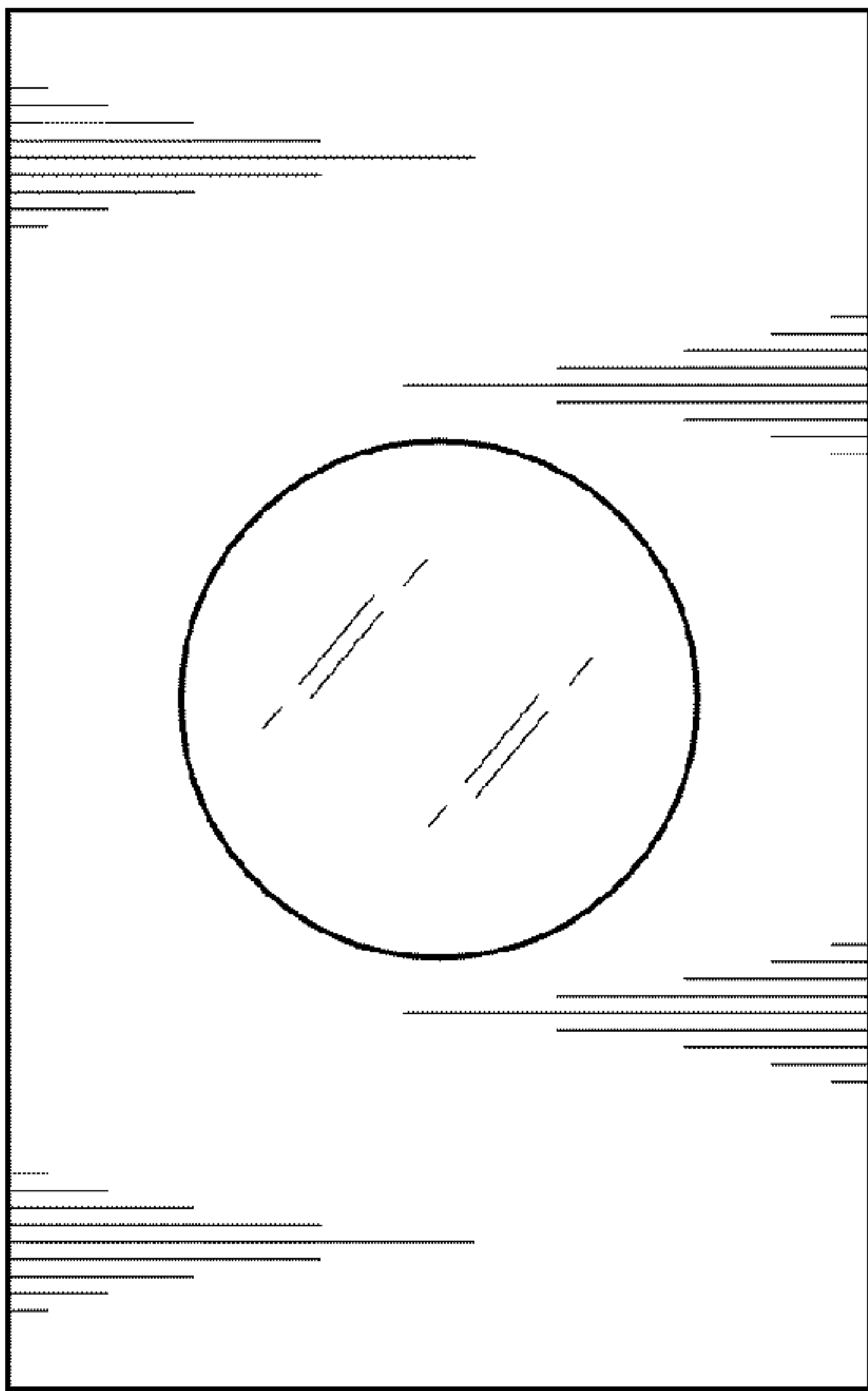

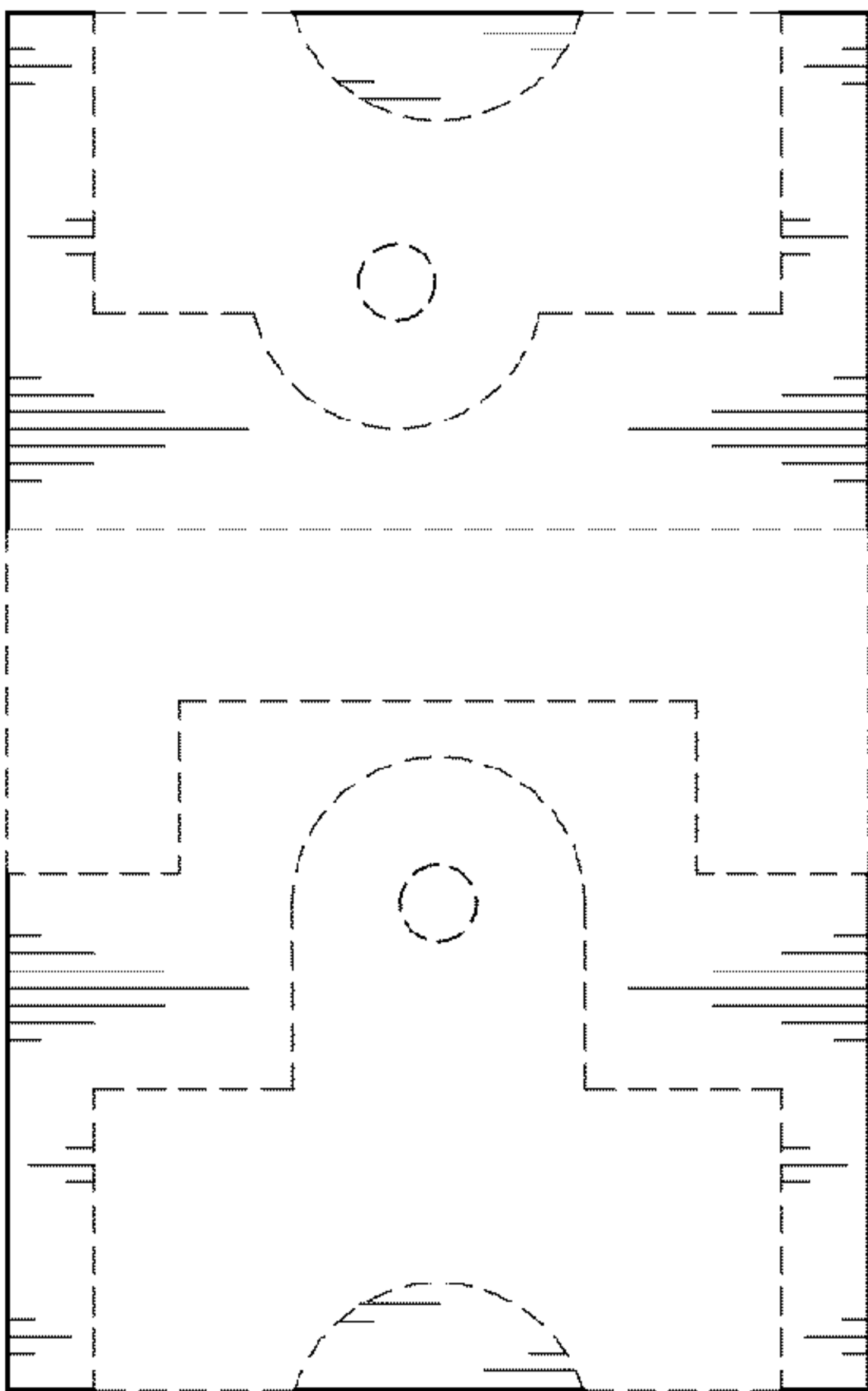

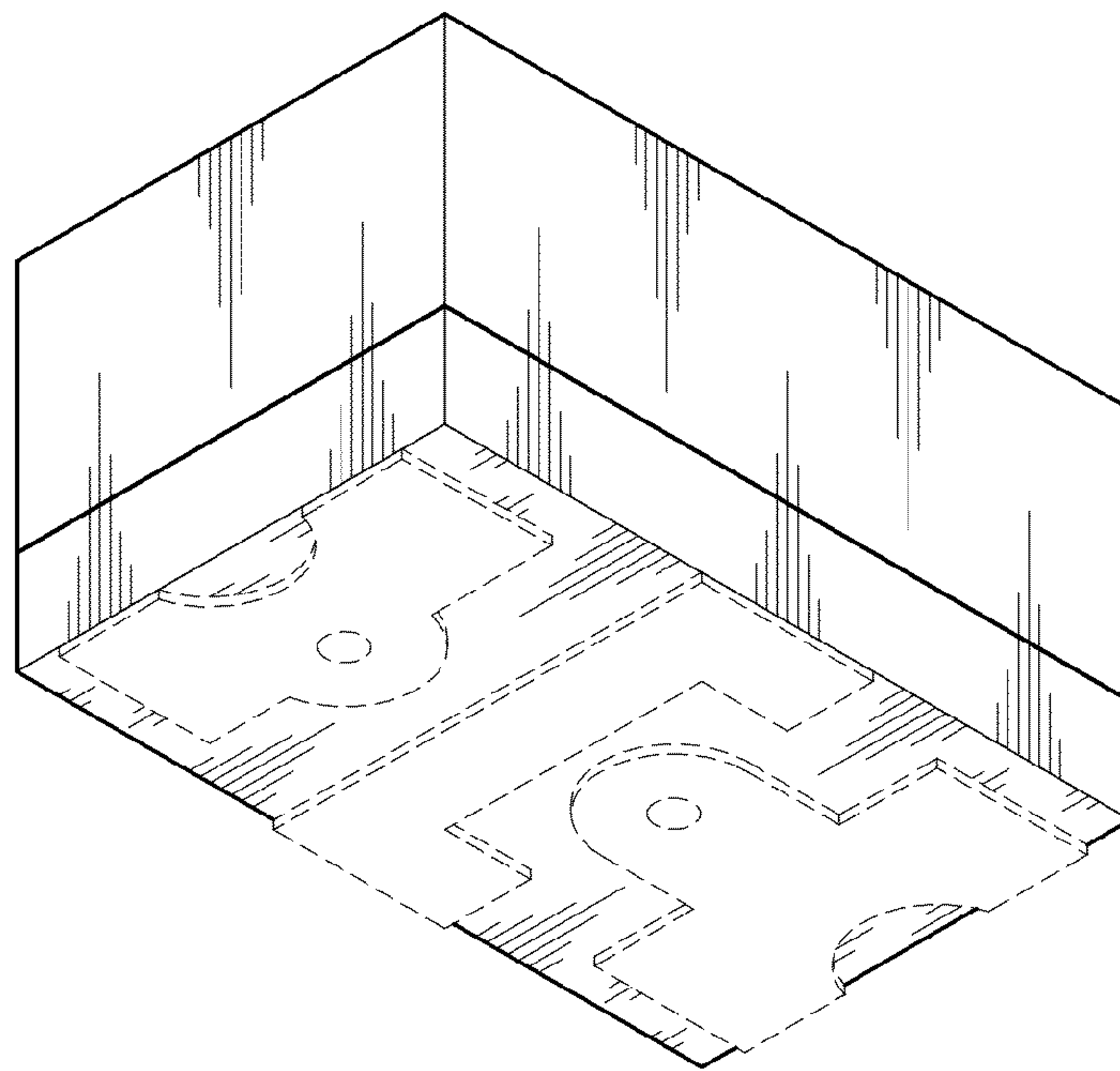

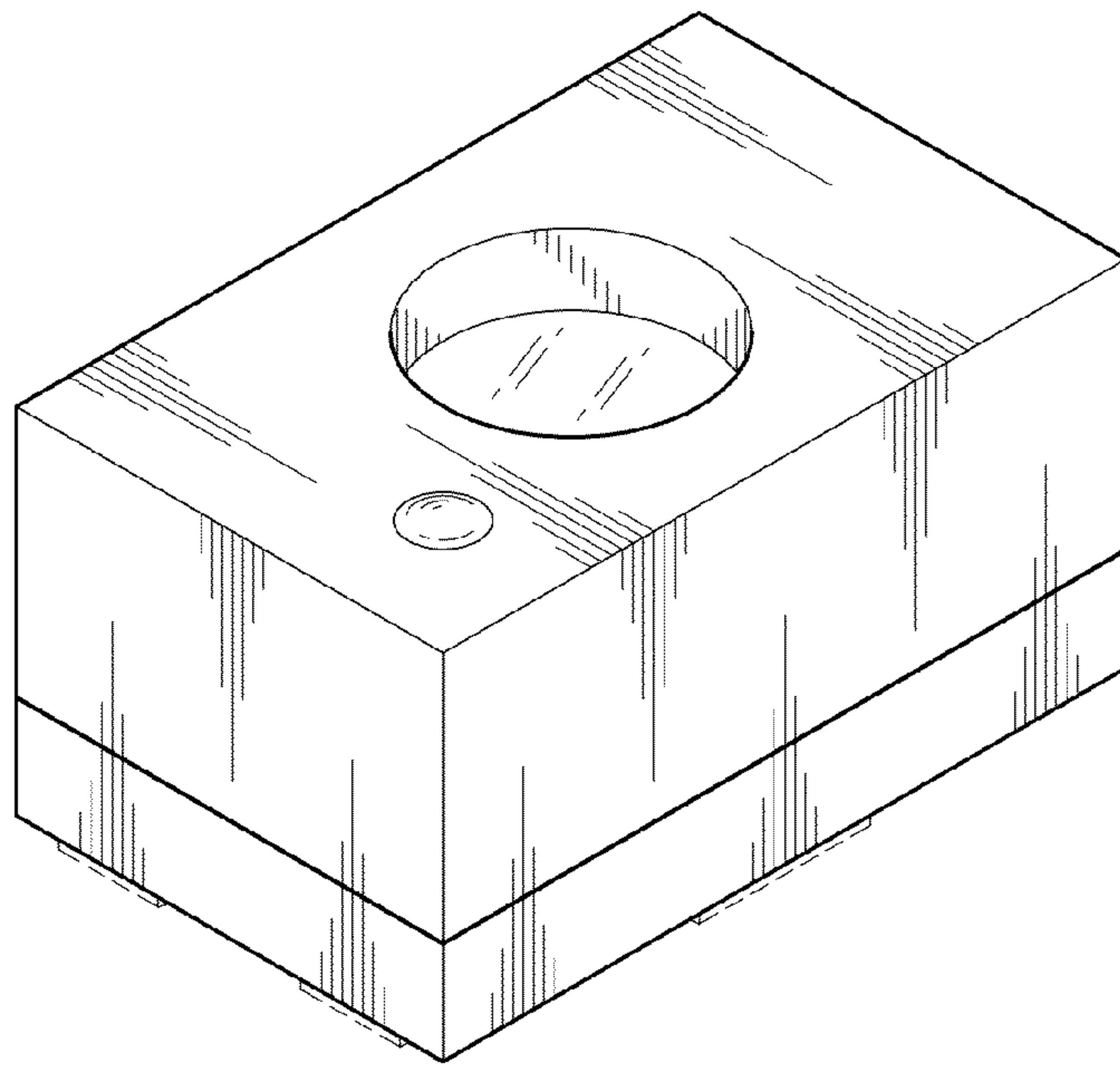

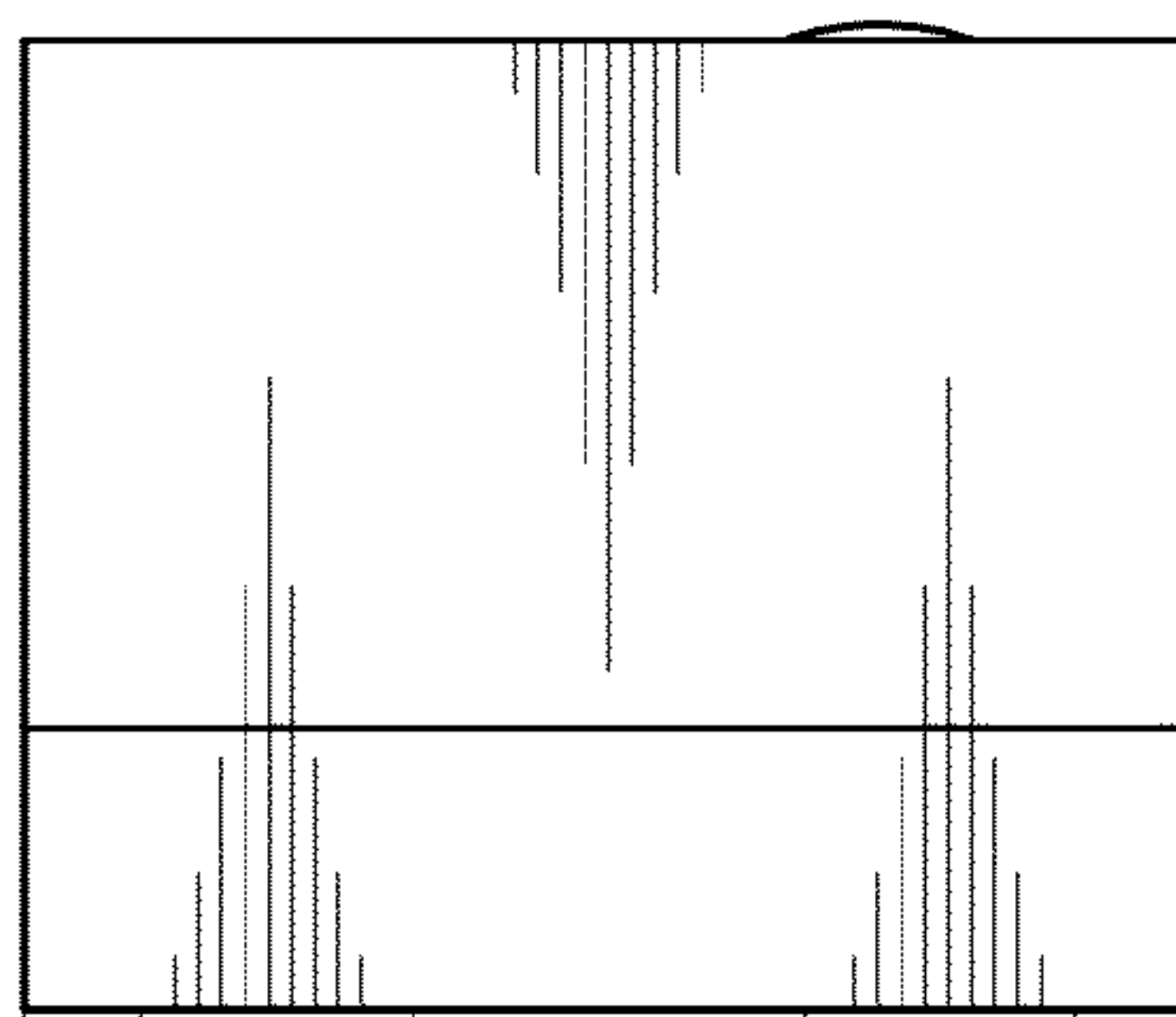

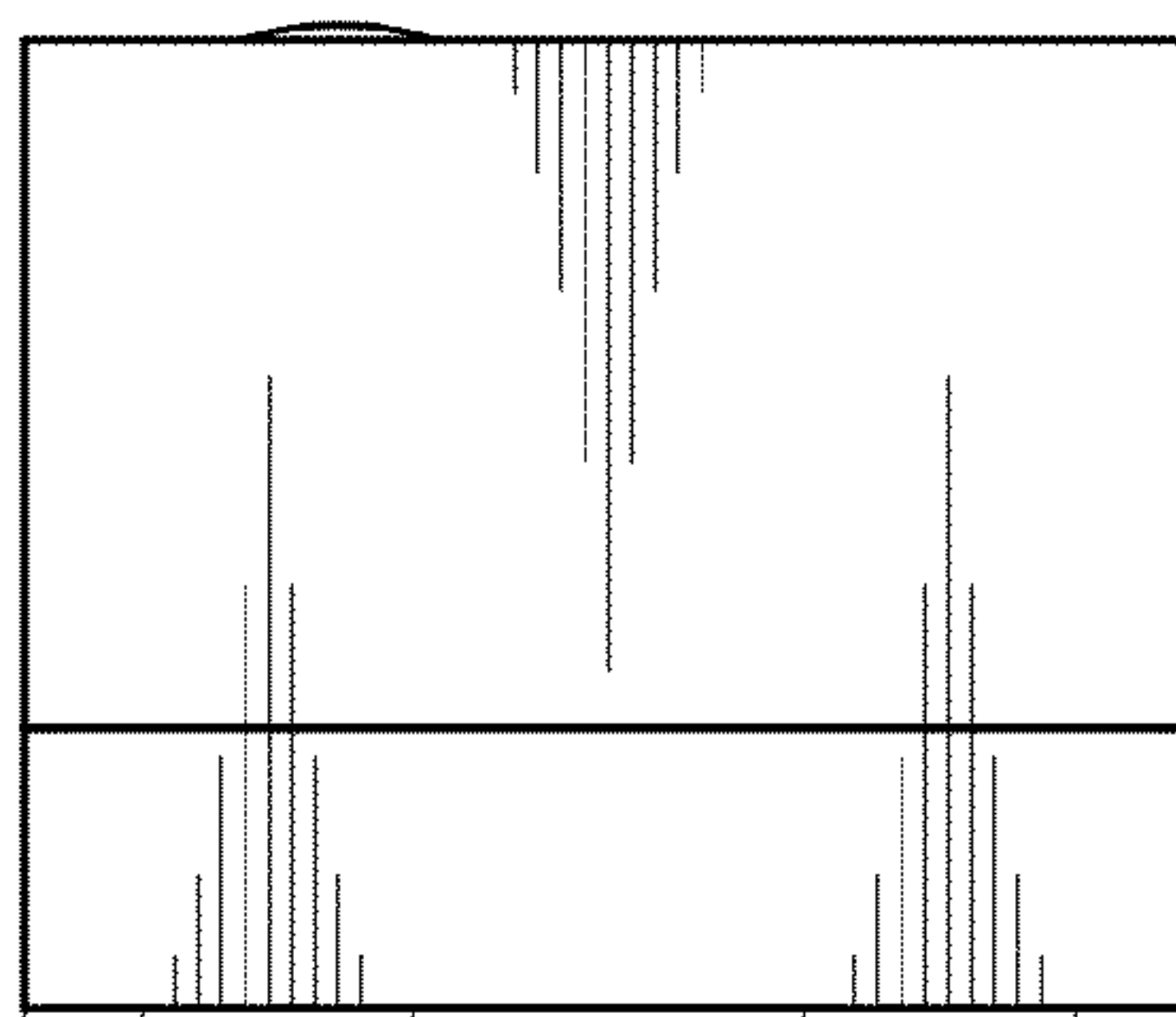

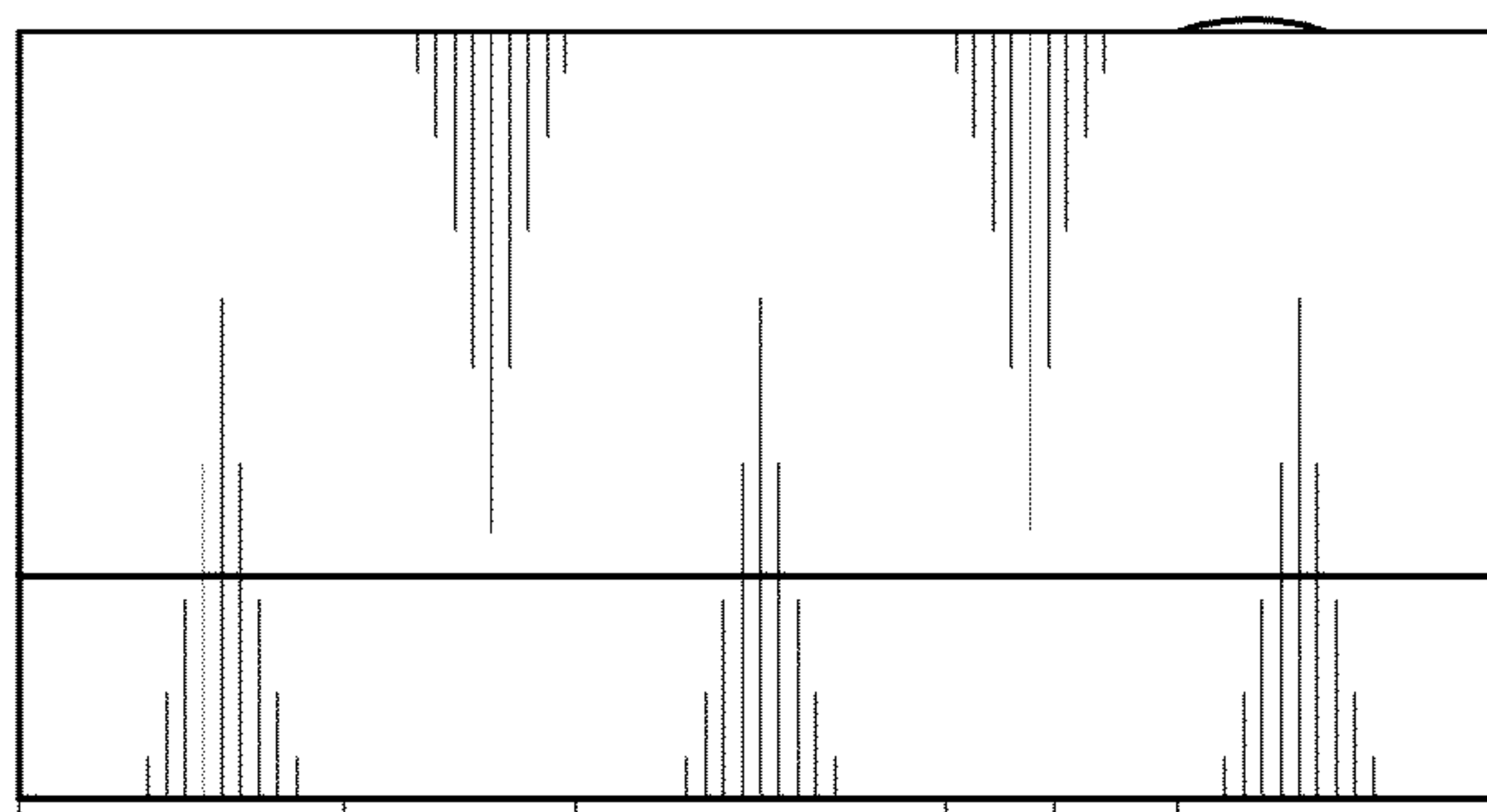

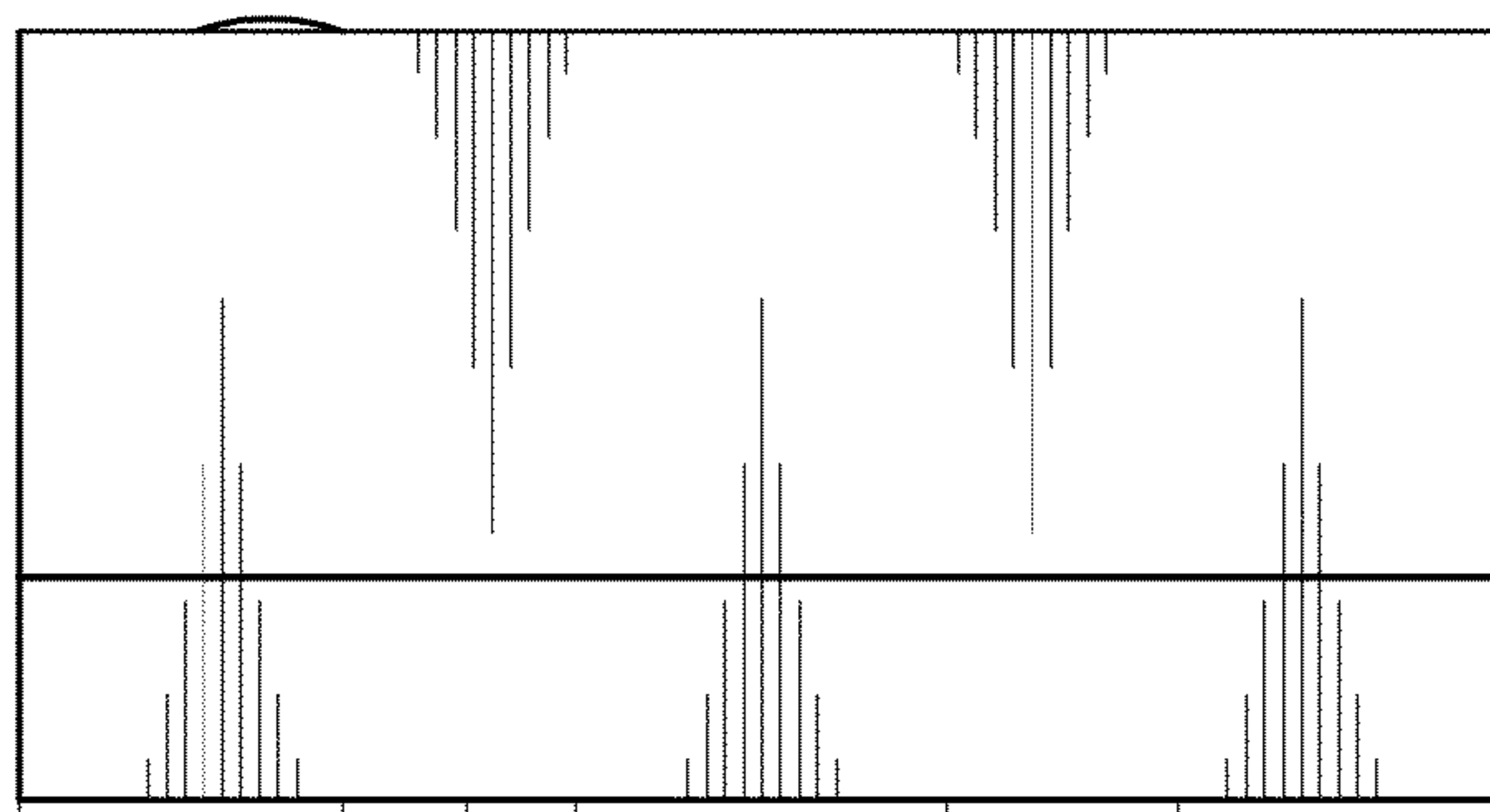

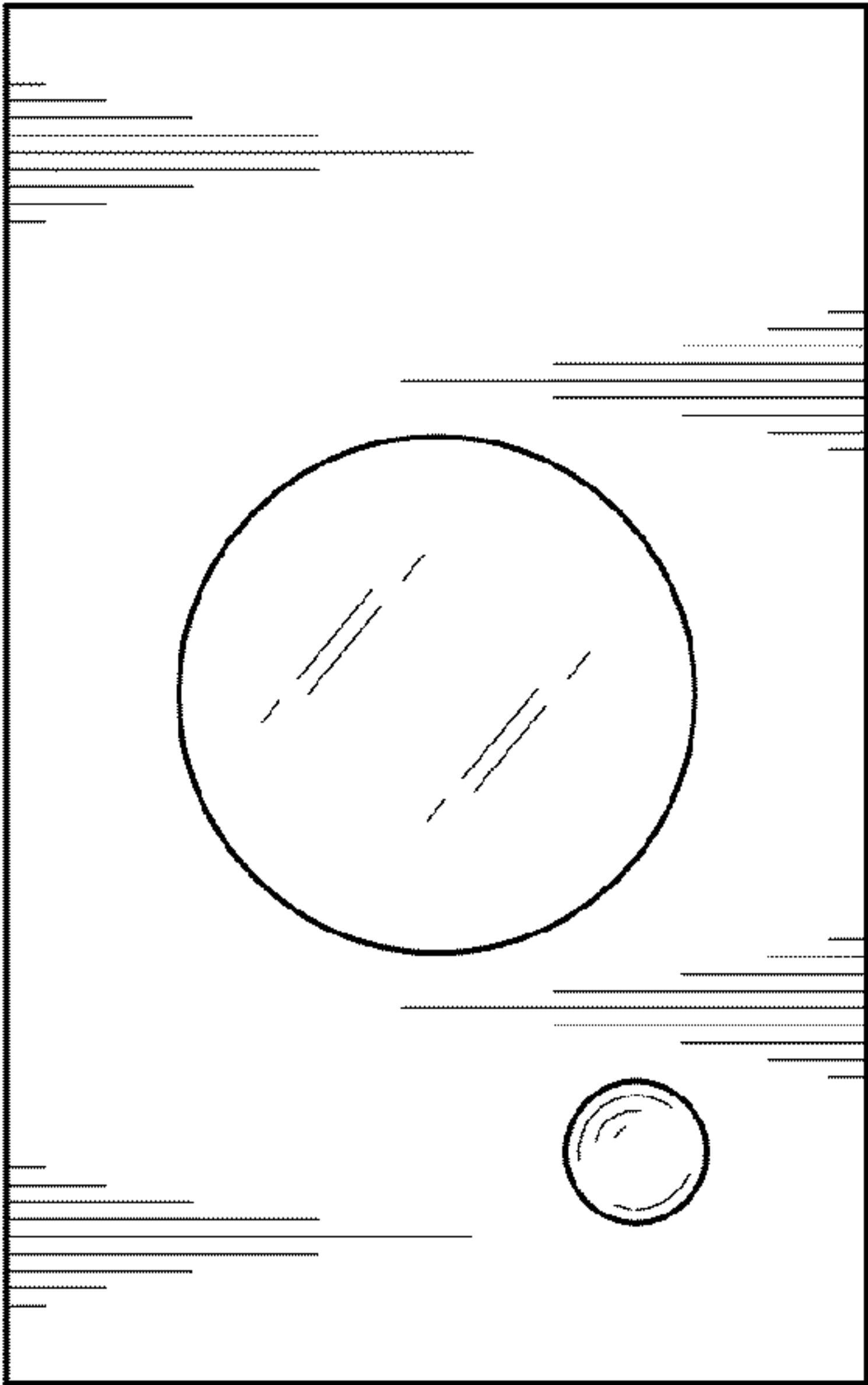

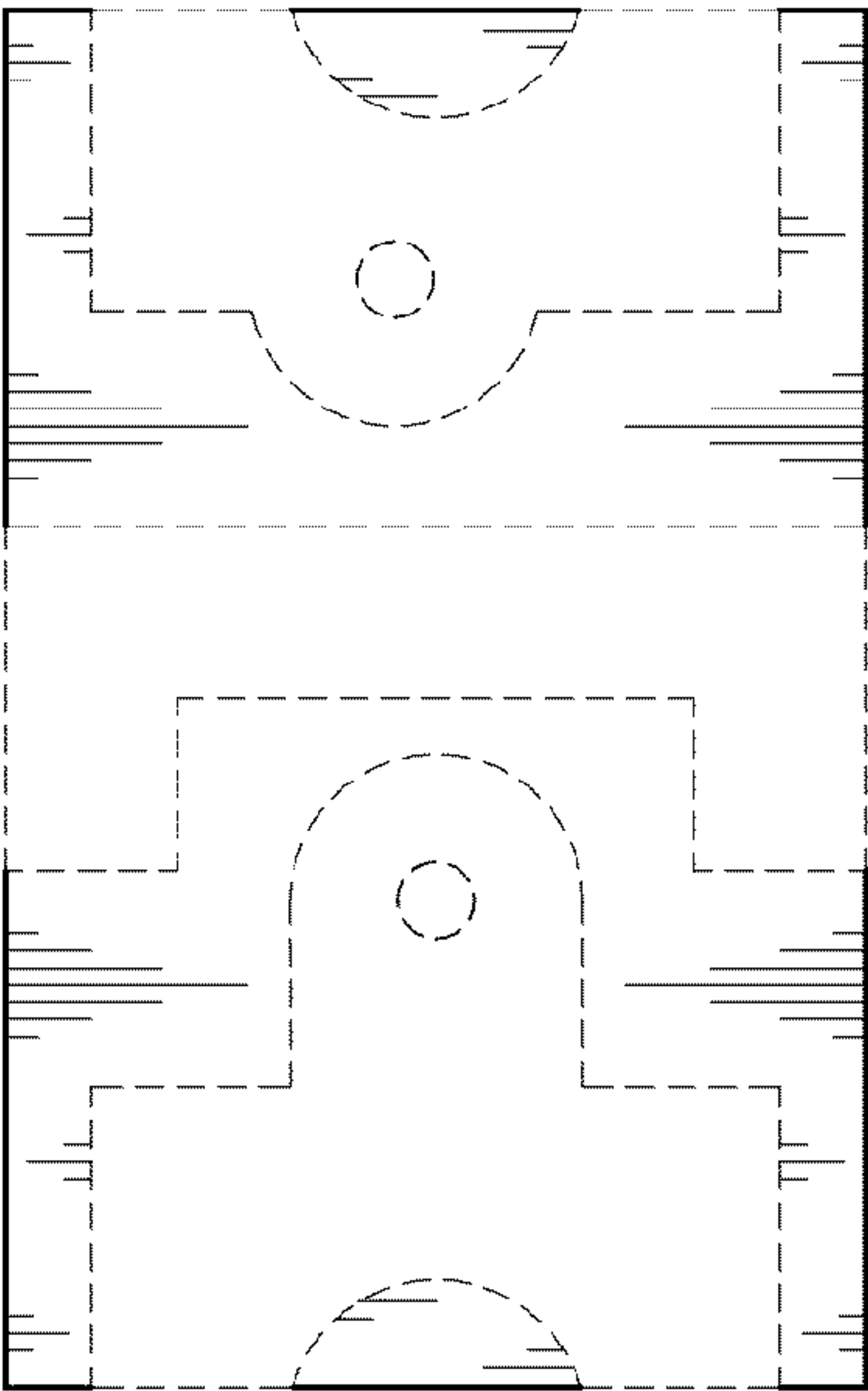

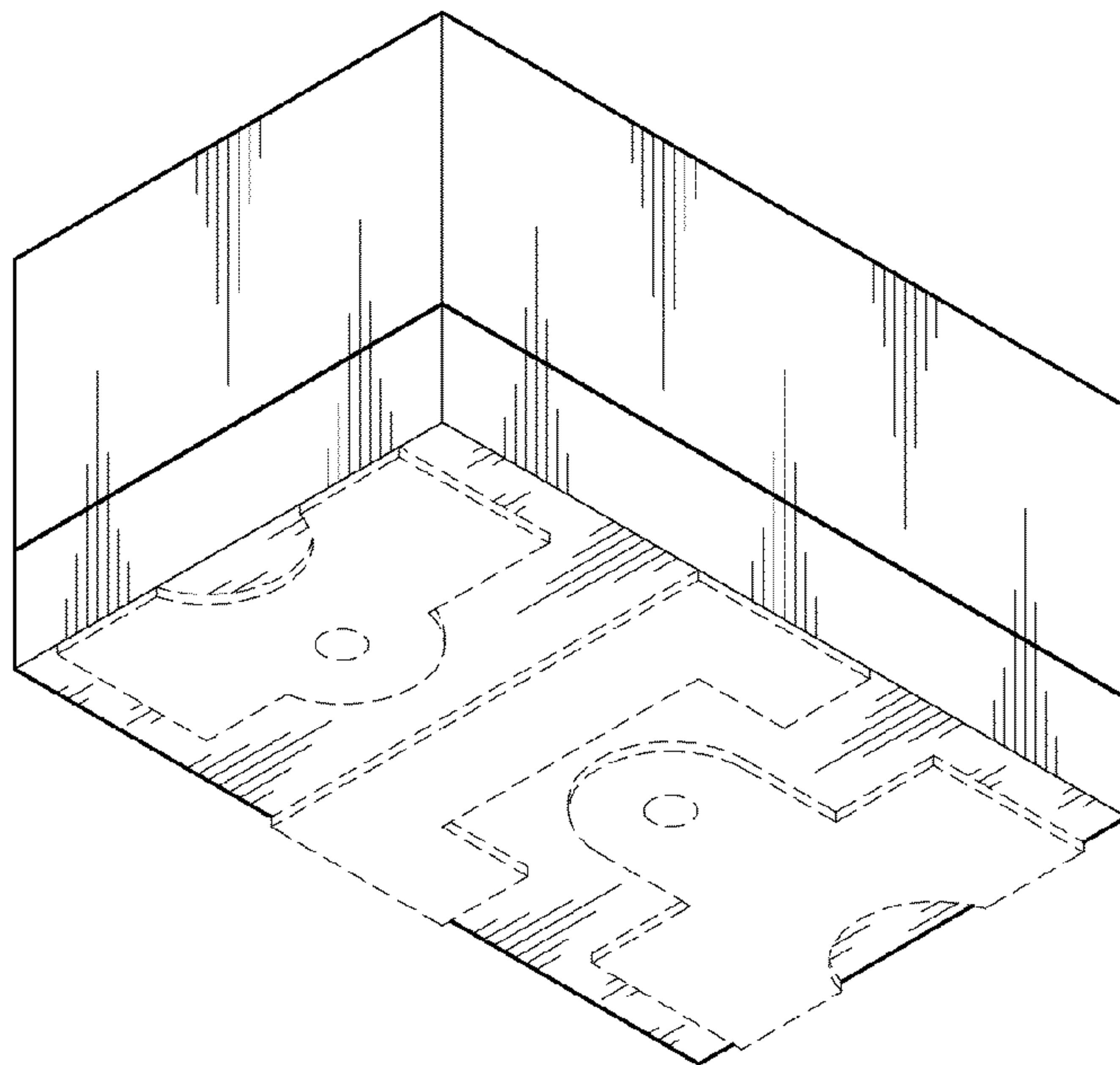

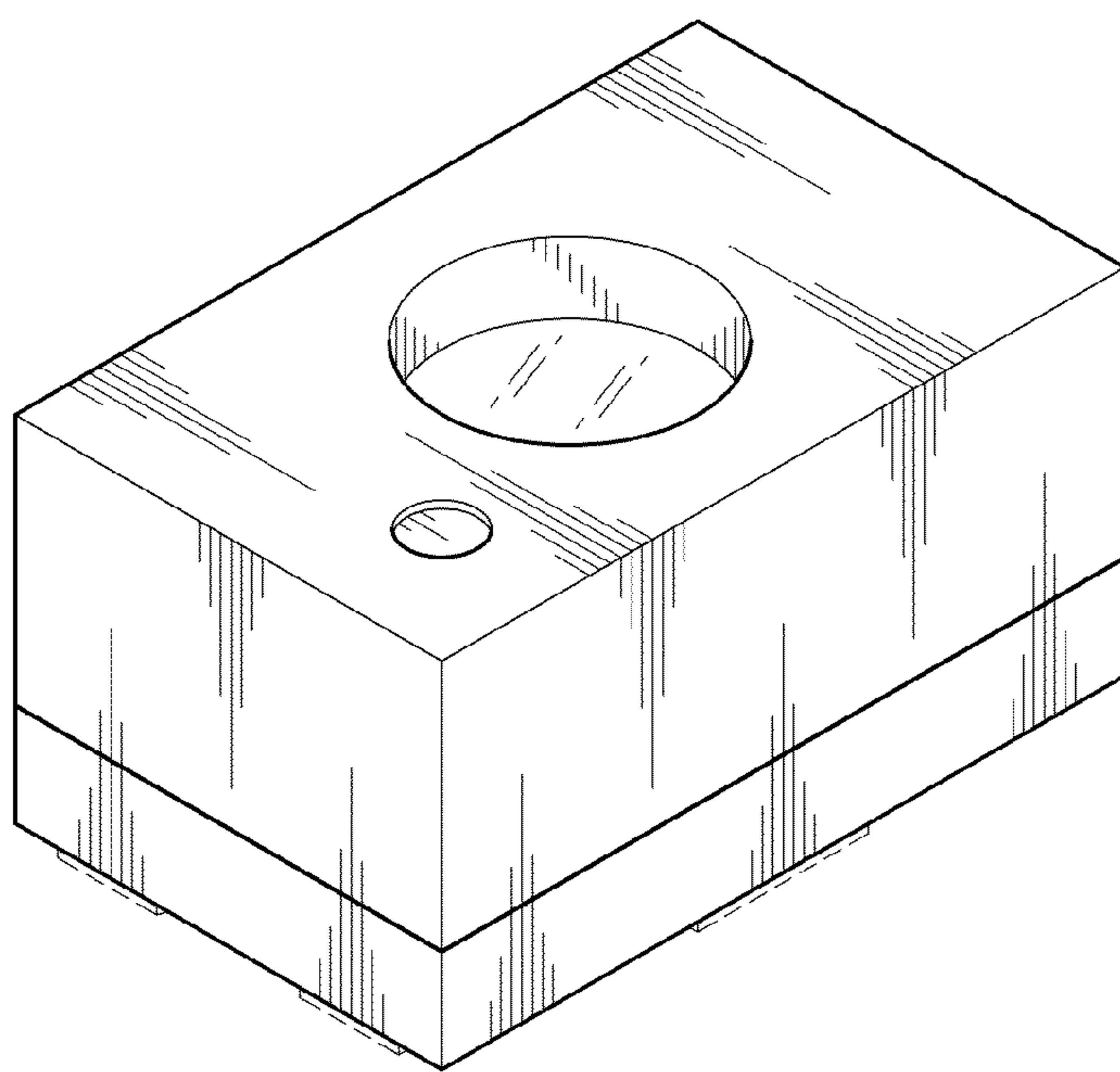

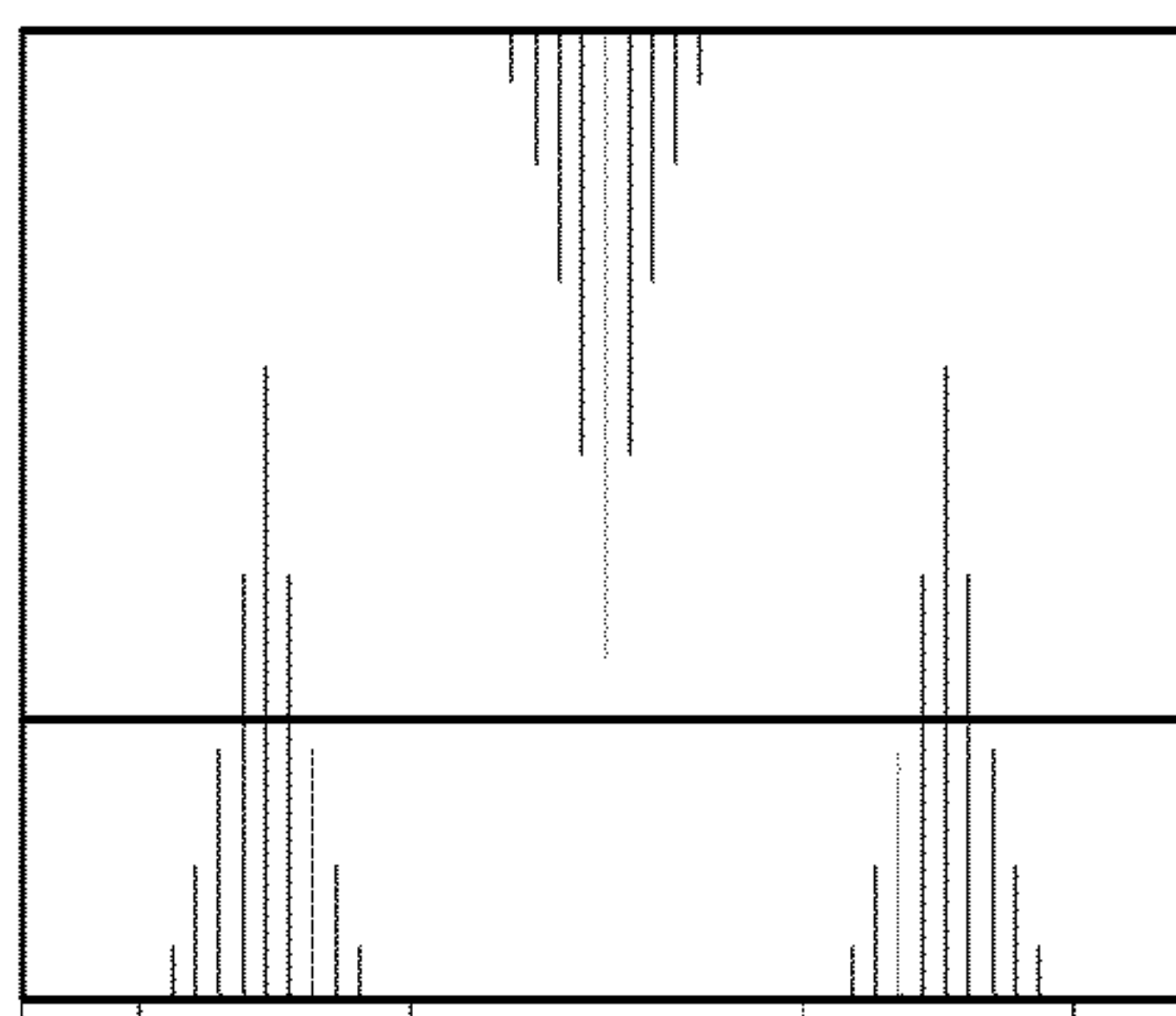

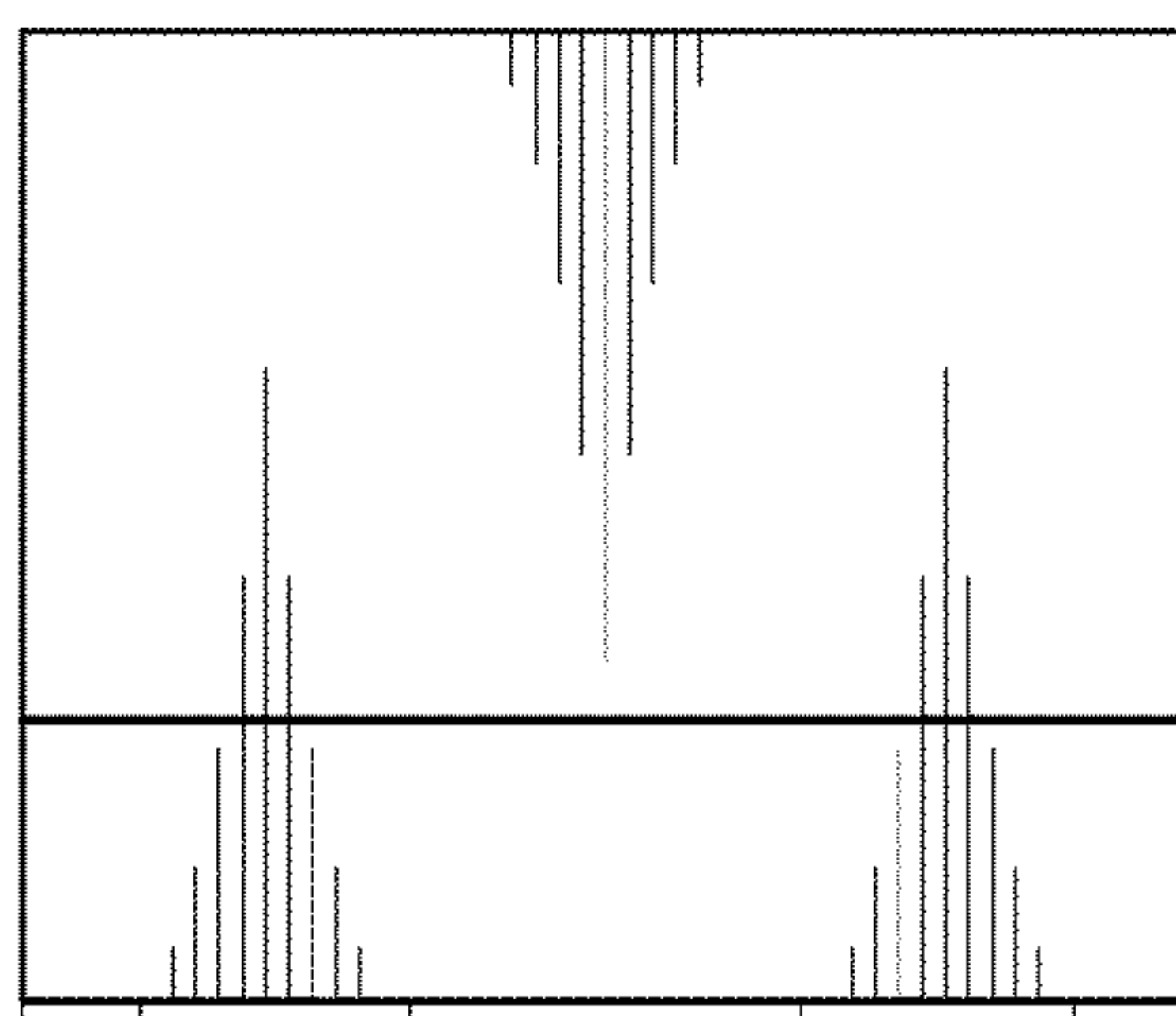

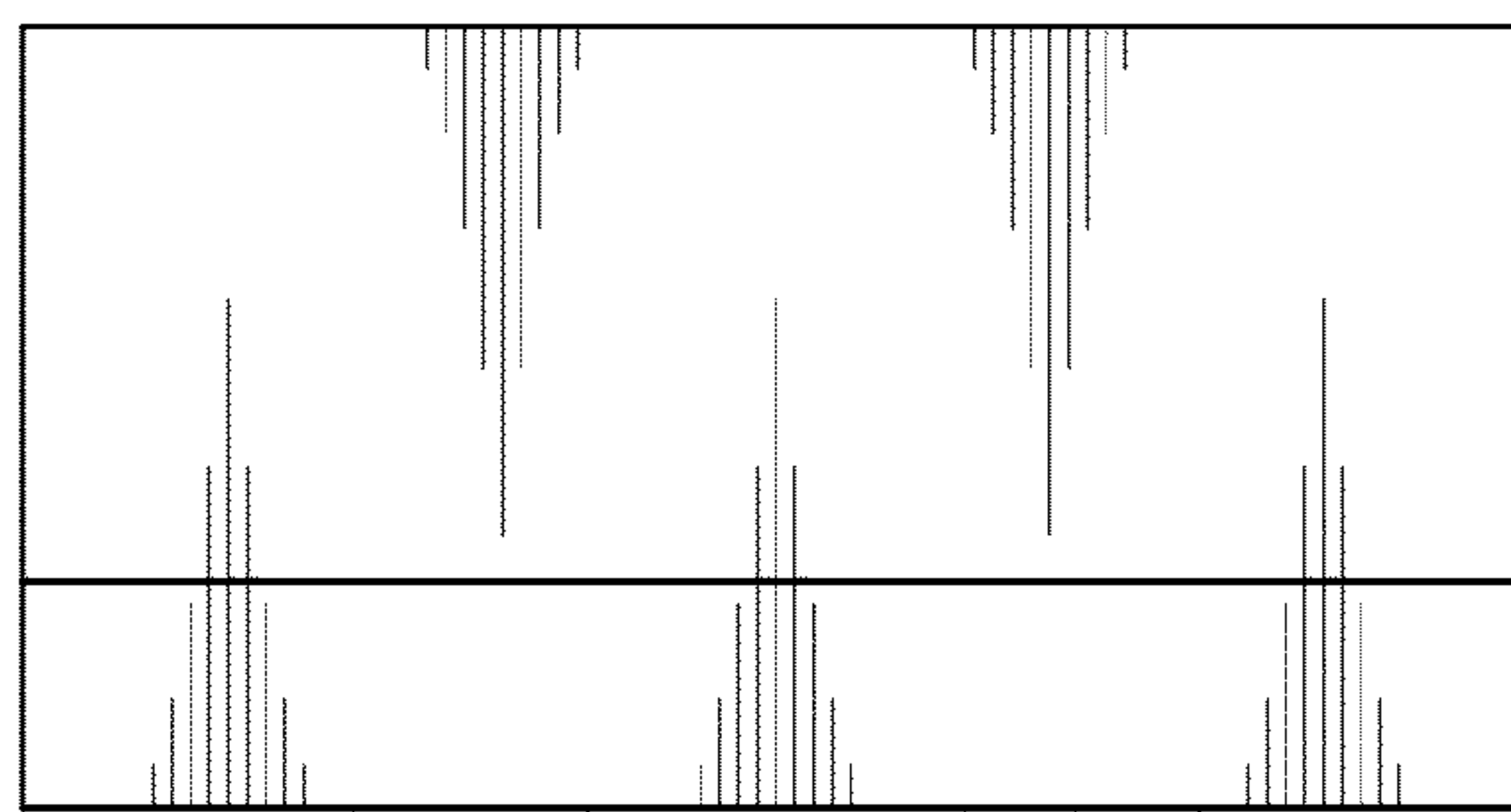

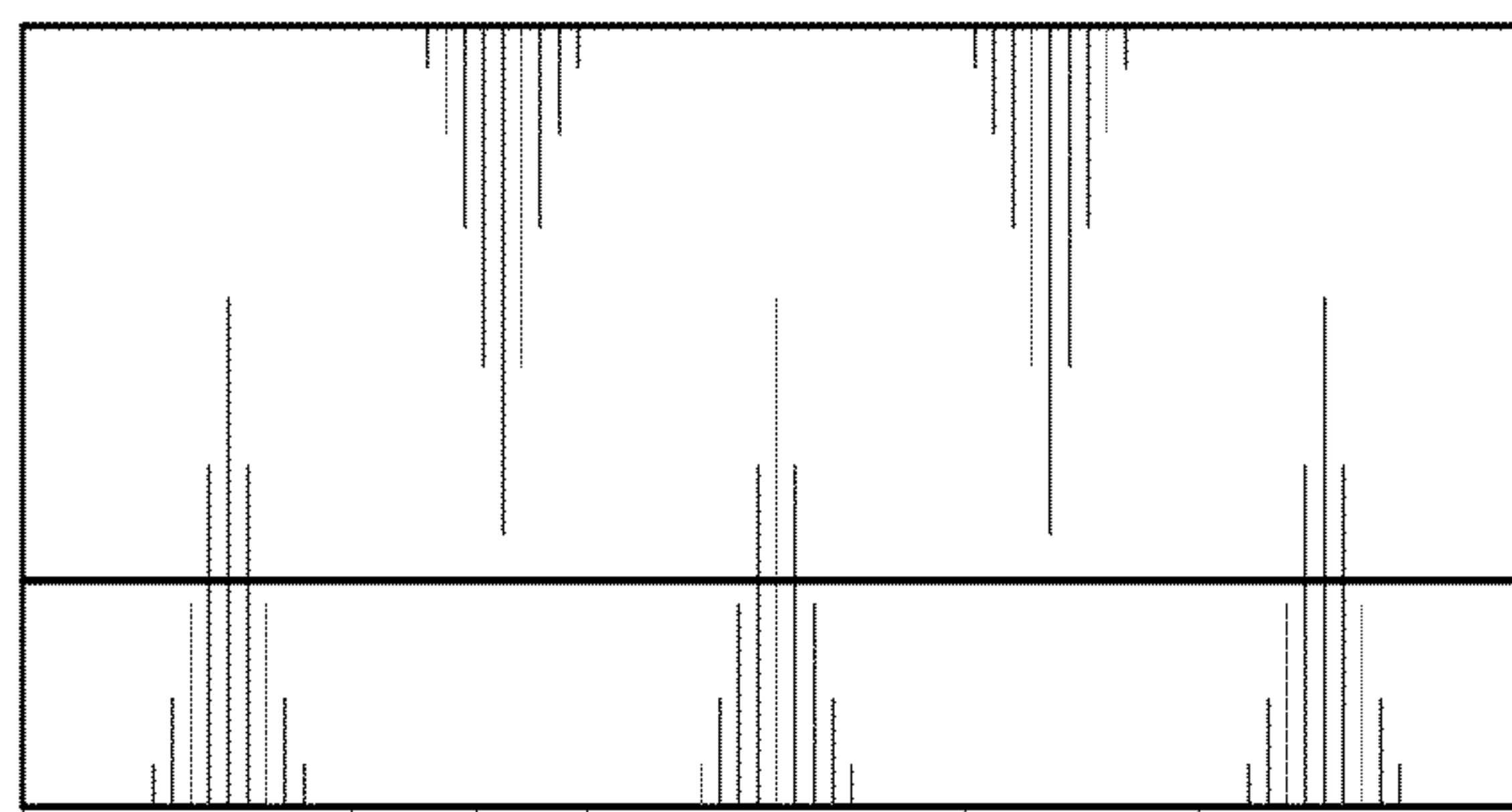

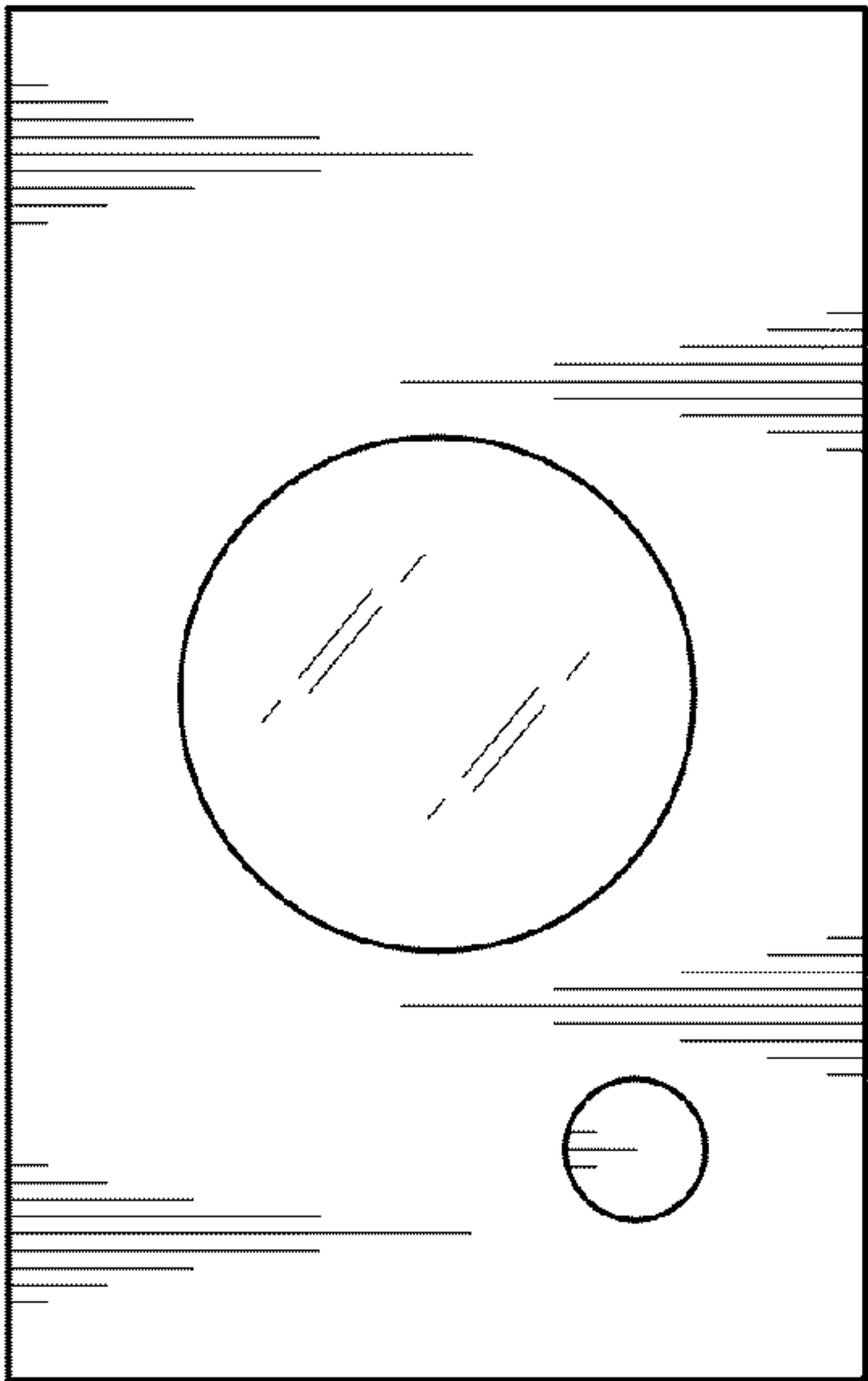

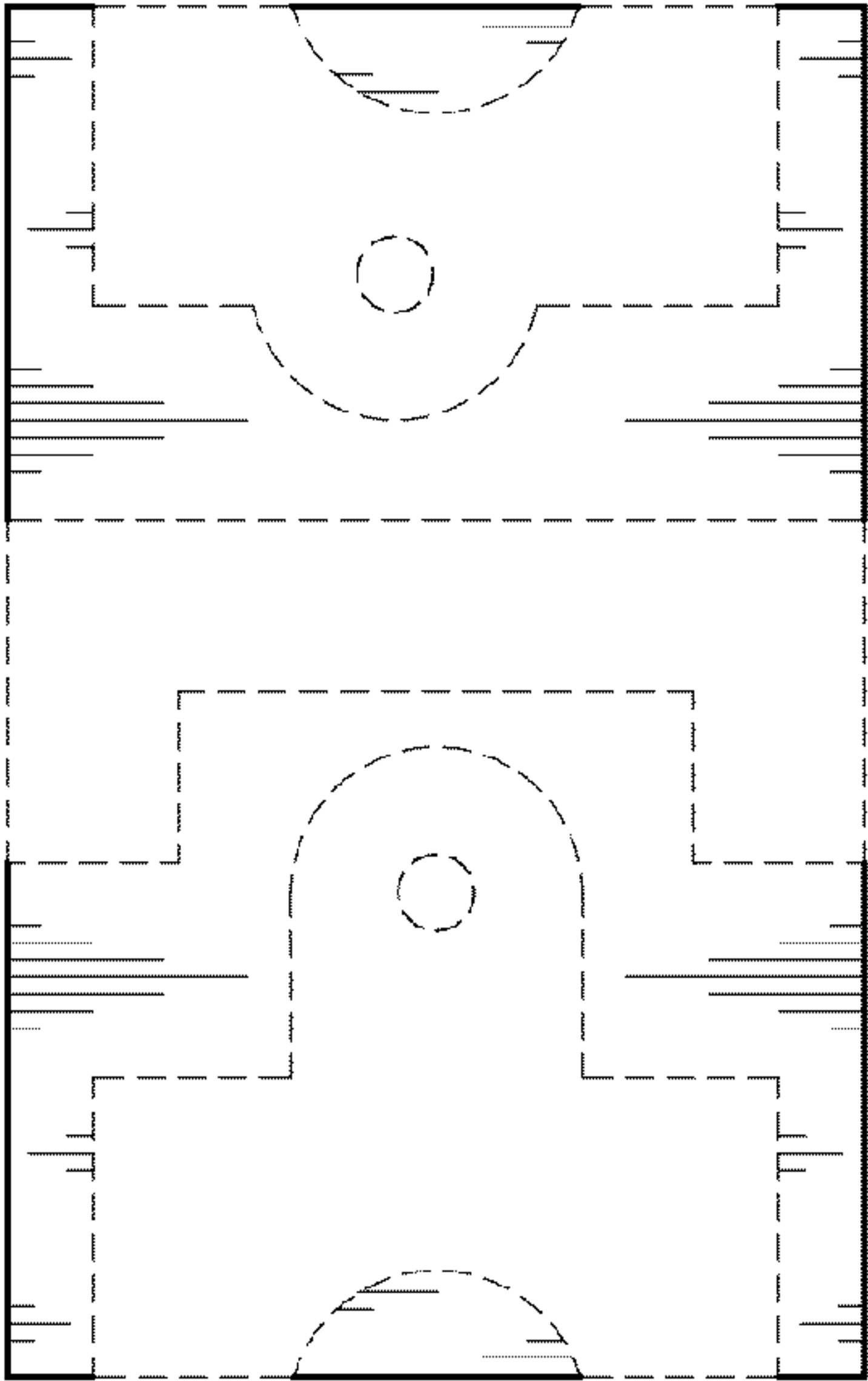

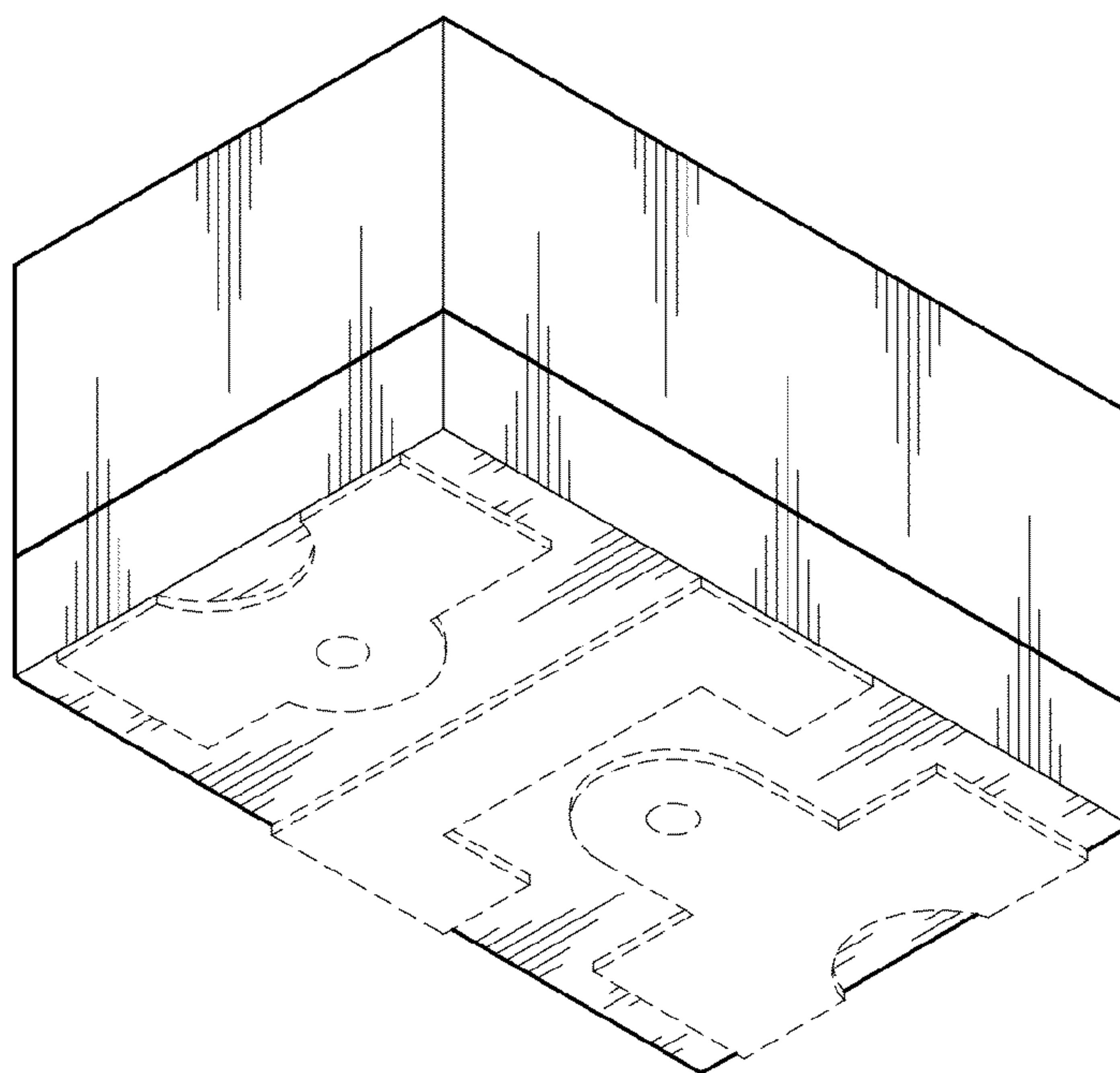
