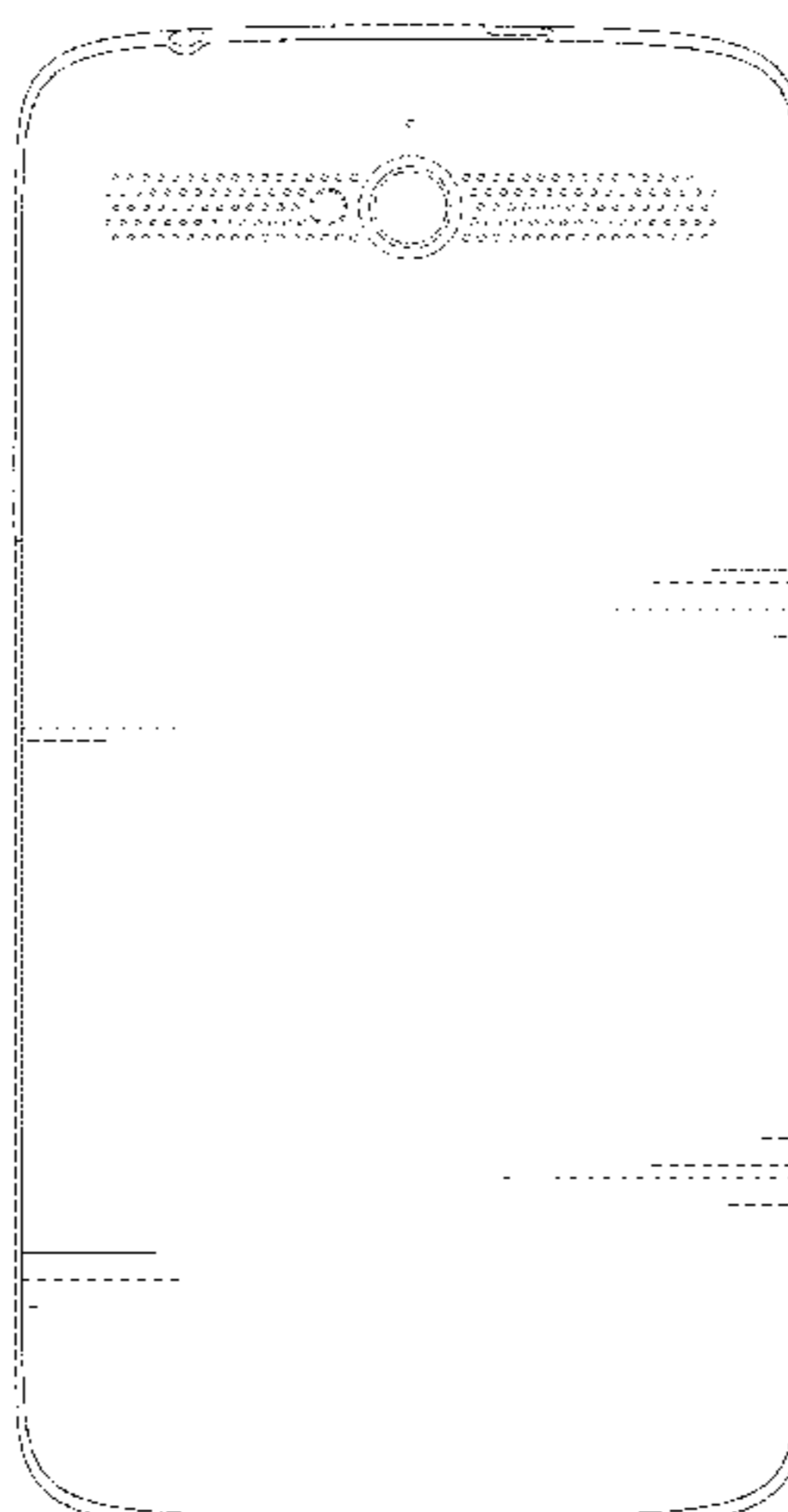
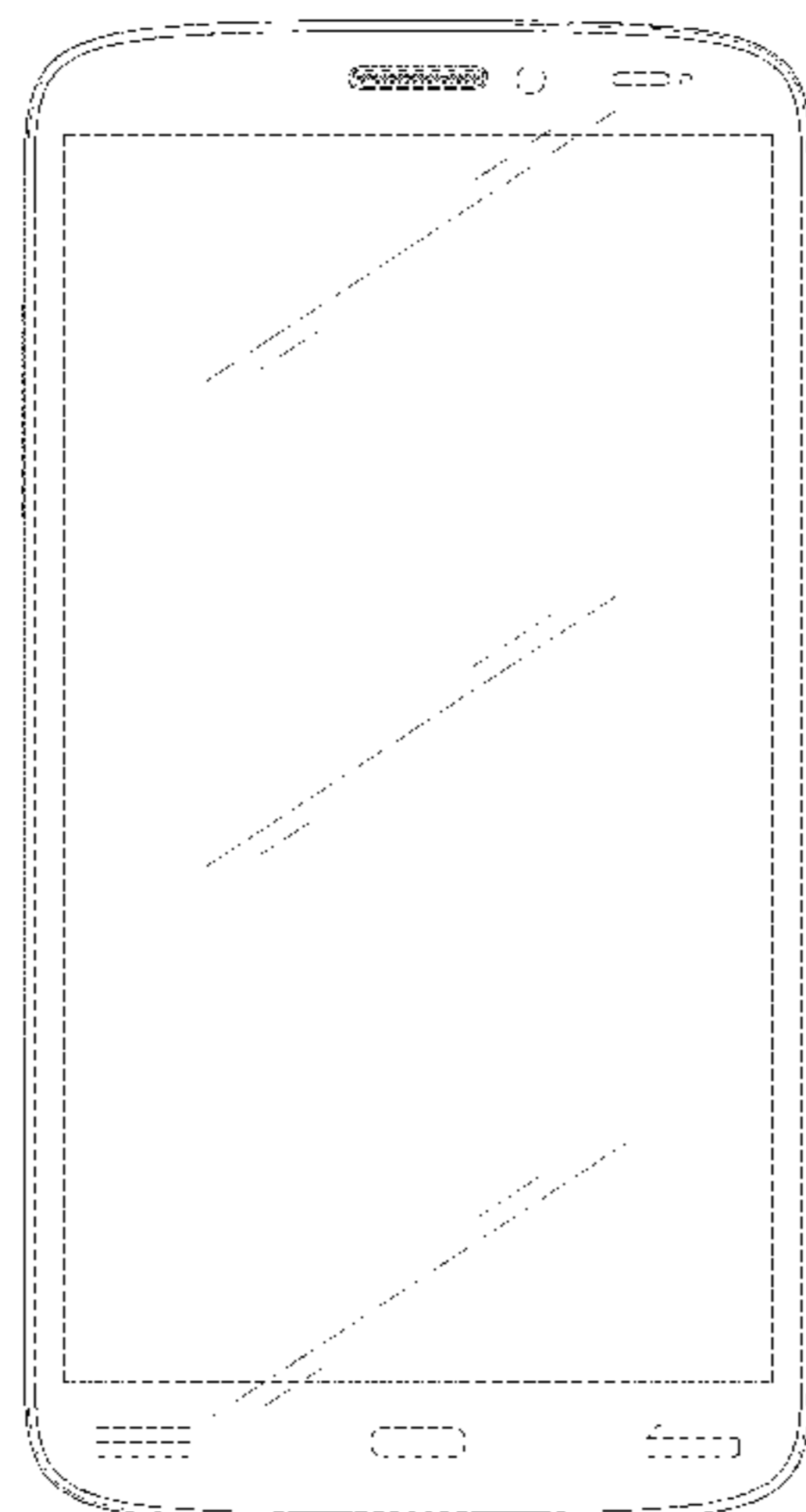
The ornamental design for a mobile phone, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a mobile phone showing our new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.

The broken lines shown in the figures that are immediately adjacent to the shaded areas and define unshaded regions represent the bounds of the claim. All other broken lines, including the features within broken line boundaries and the broken lines on the front surface to the right of the speaker, the display rectangle, and the icons at either side of the home button on the front, are directed to environment. The broken lines form no part of the claimed design.

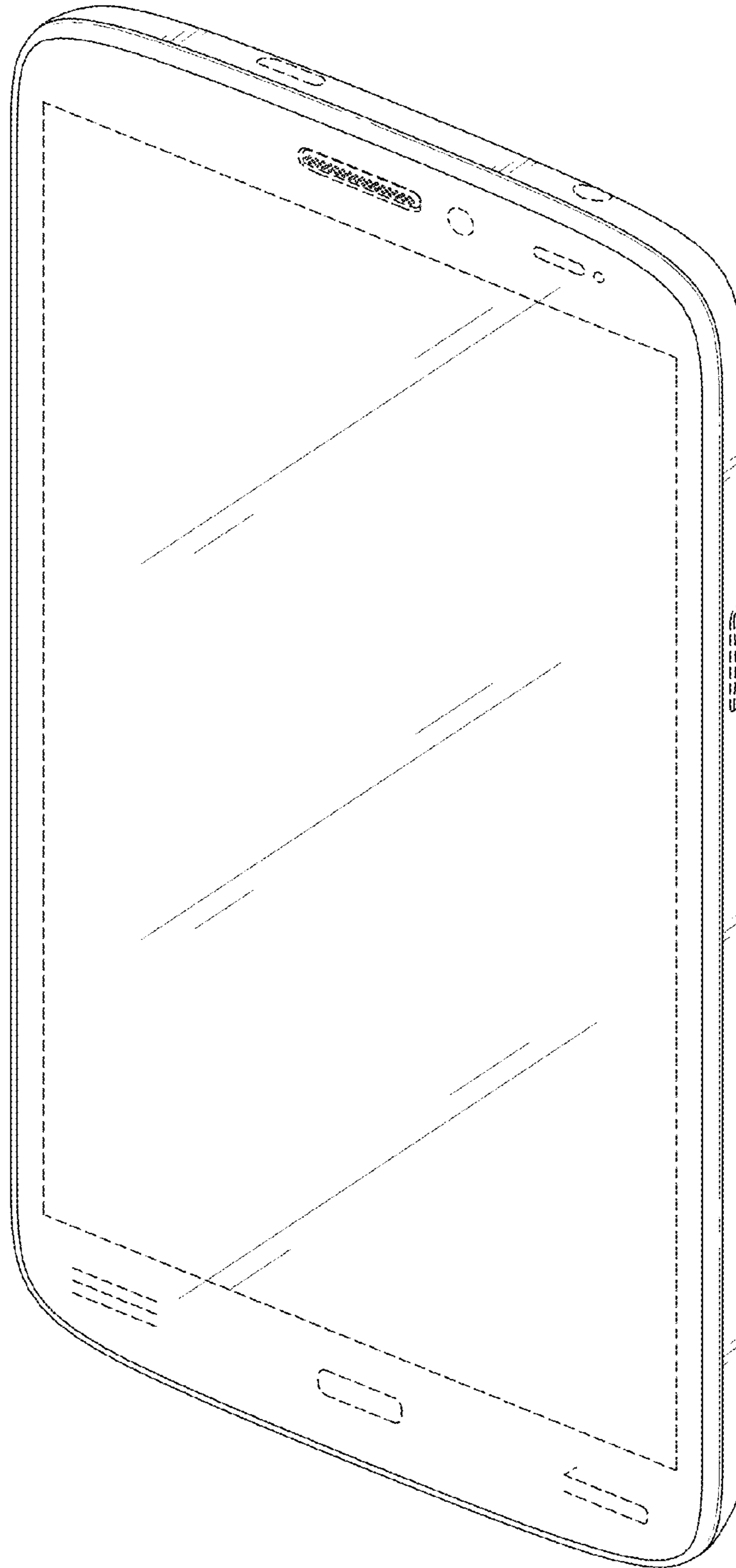

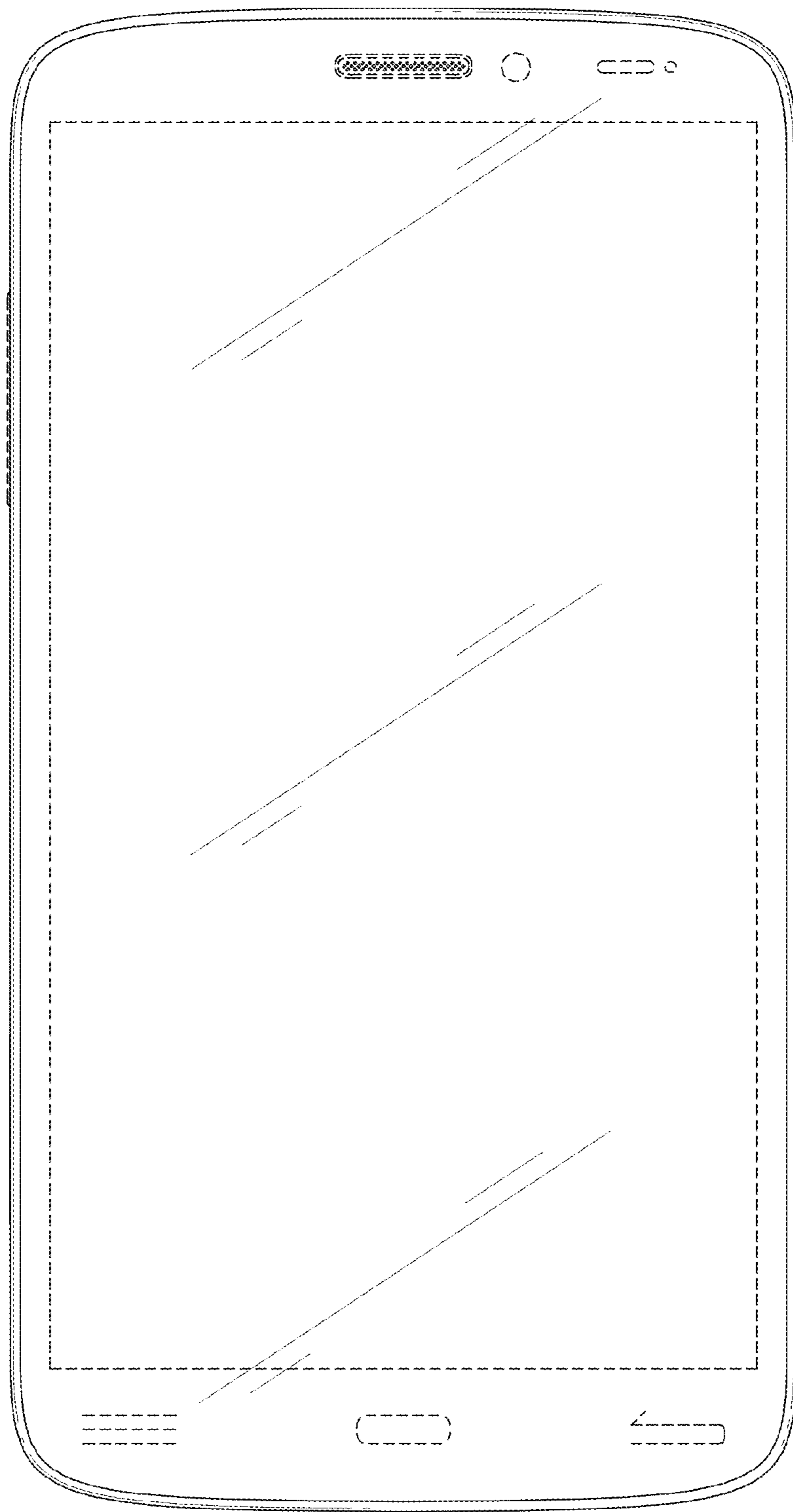

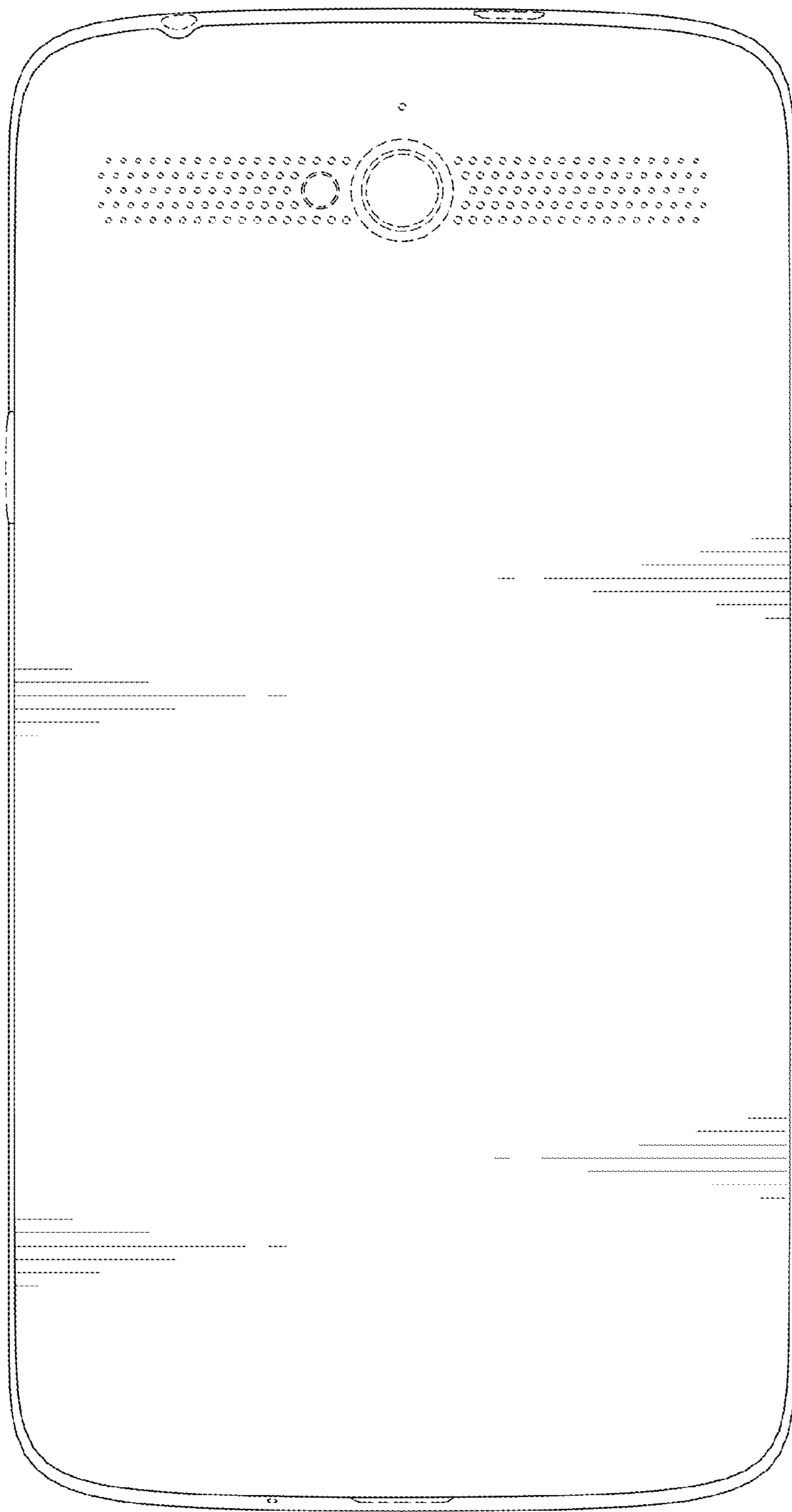

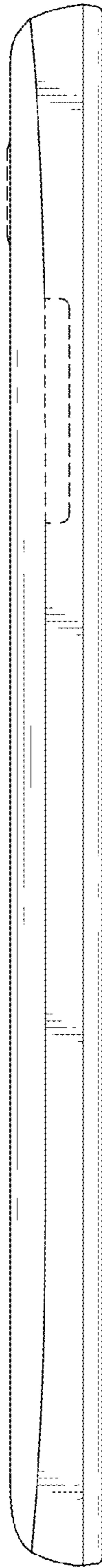

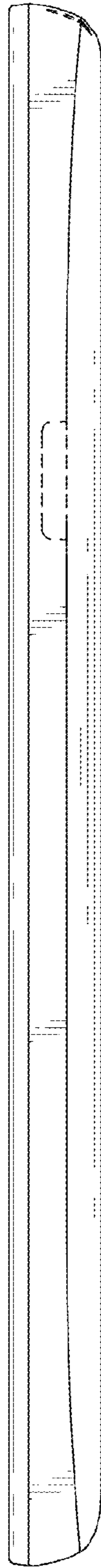

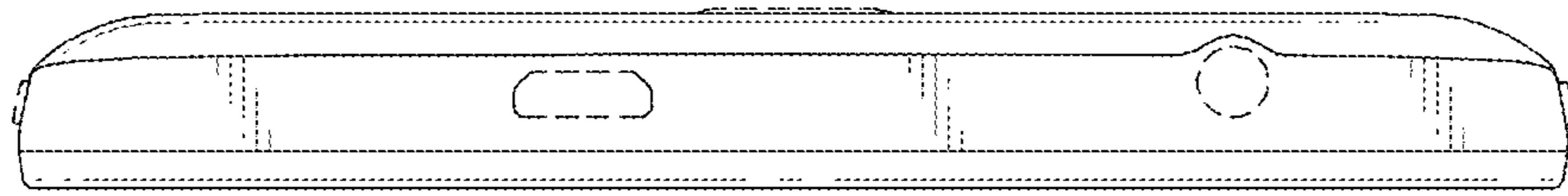

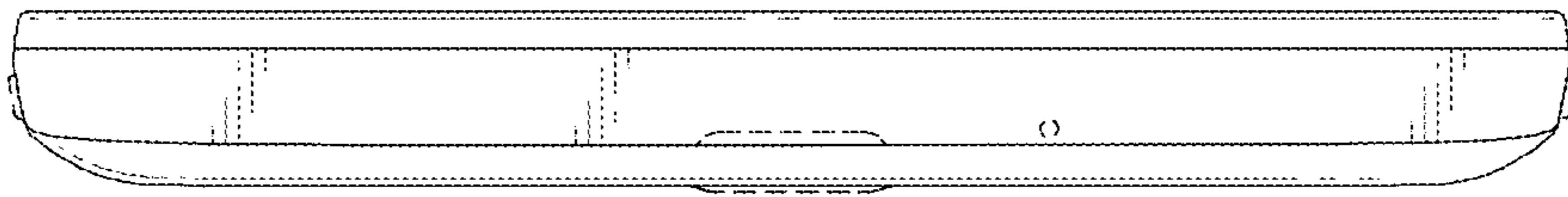
