FIG. 3 illustrates a back view of a radio.

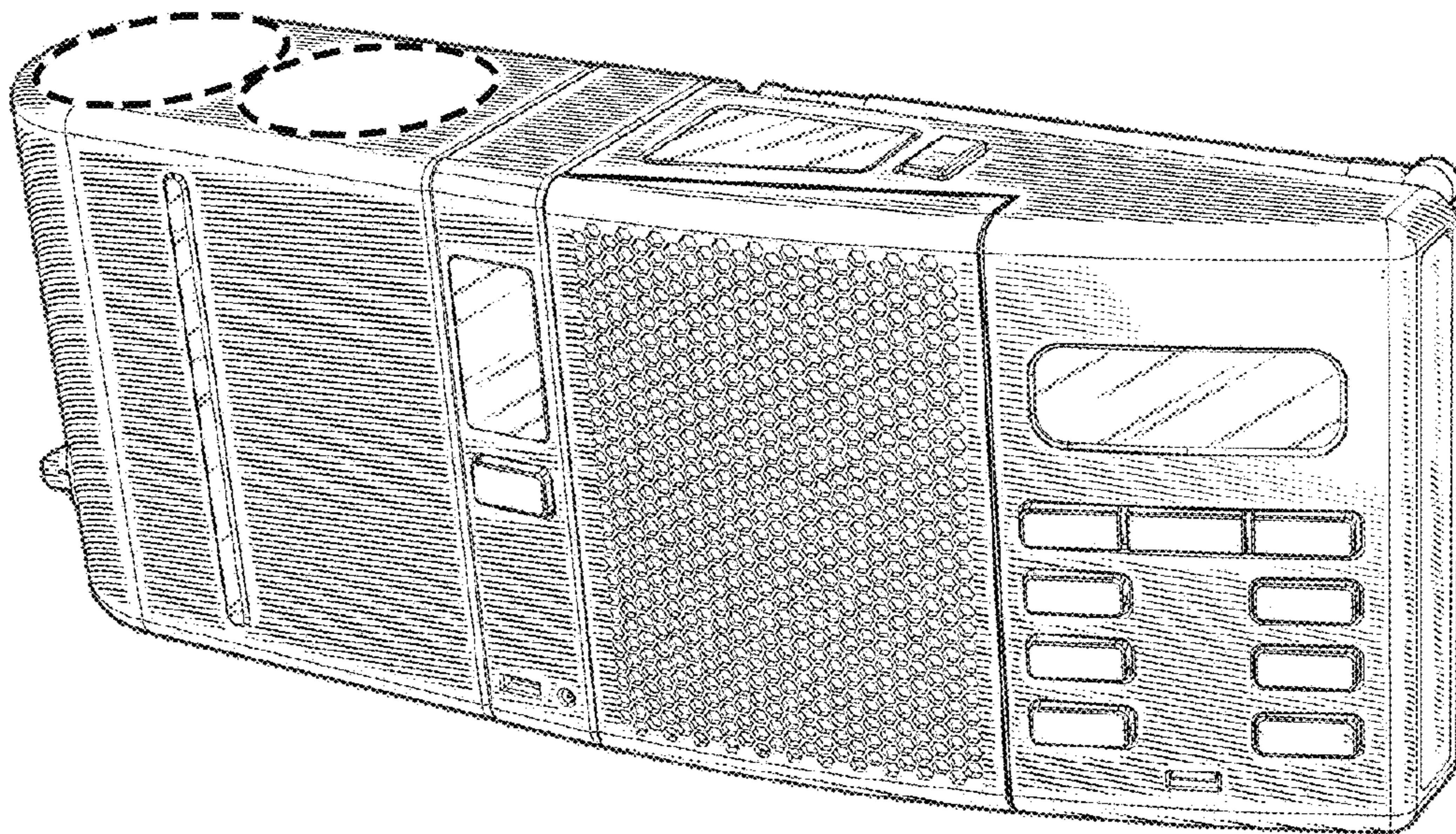
FIG. 4 illustrates a side view of a radio.

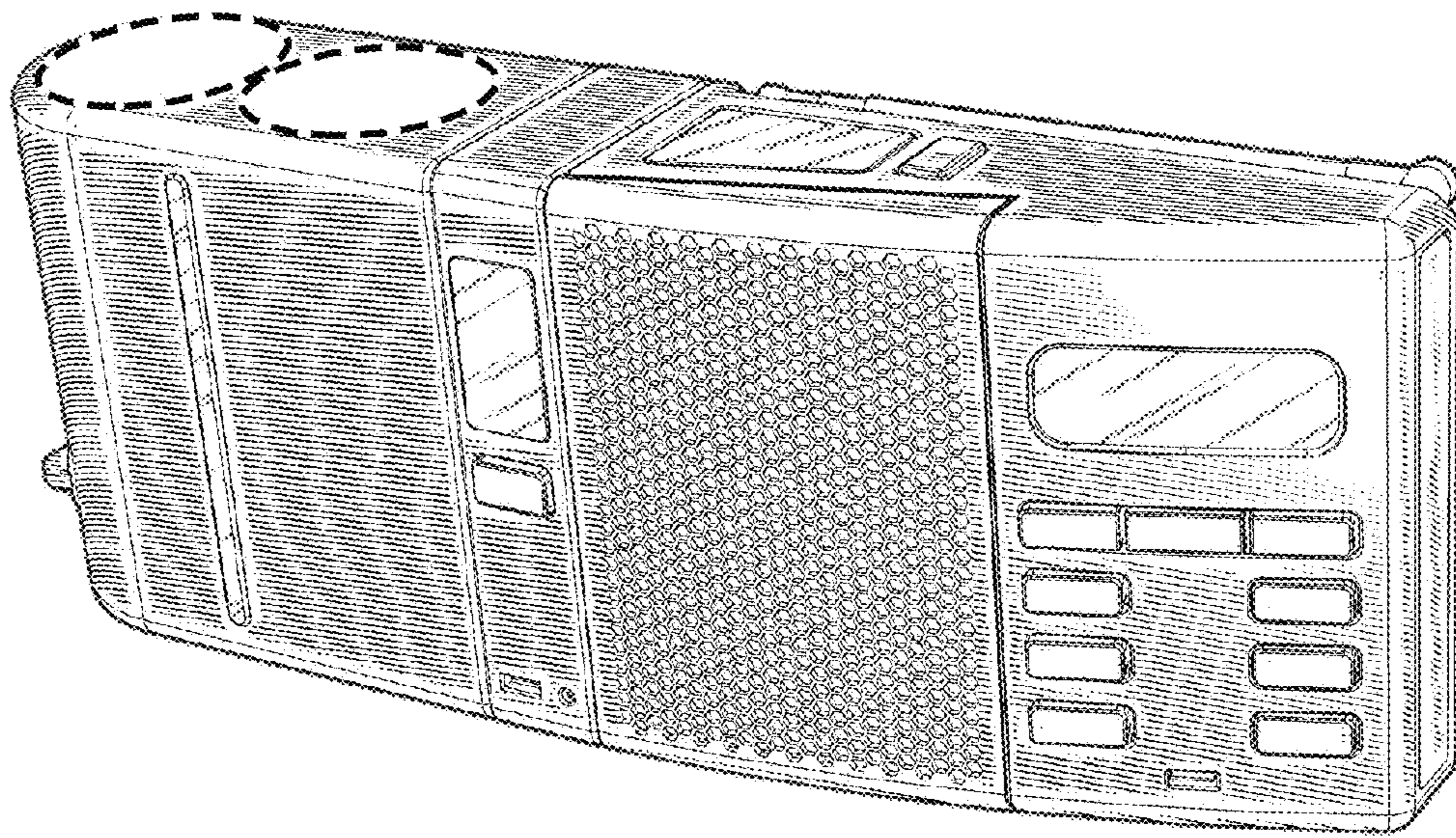

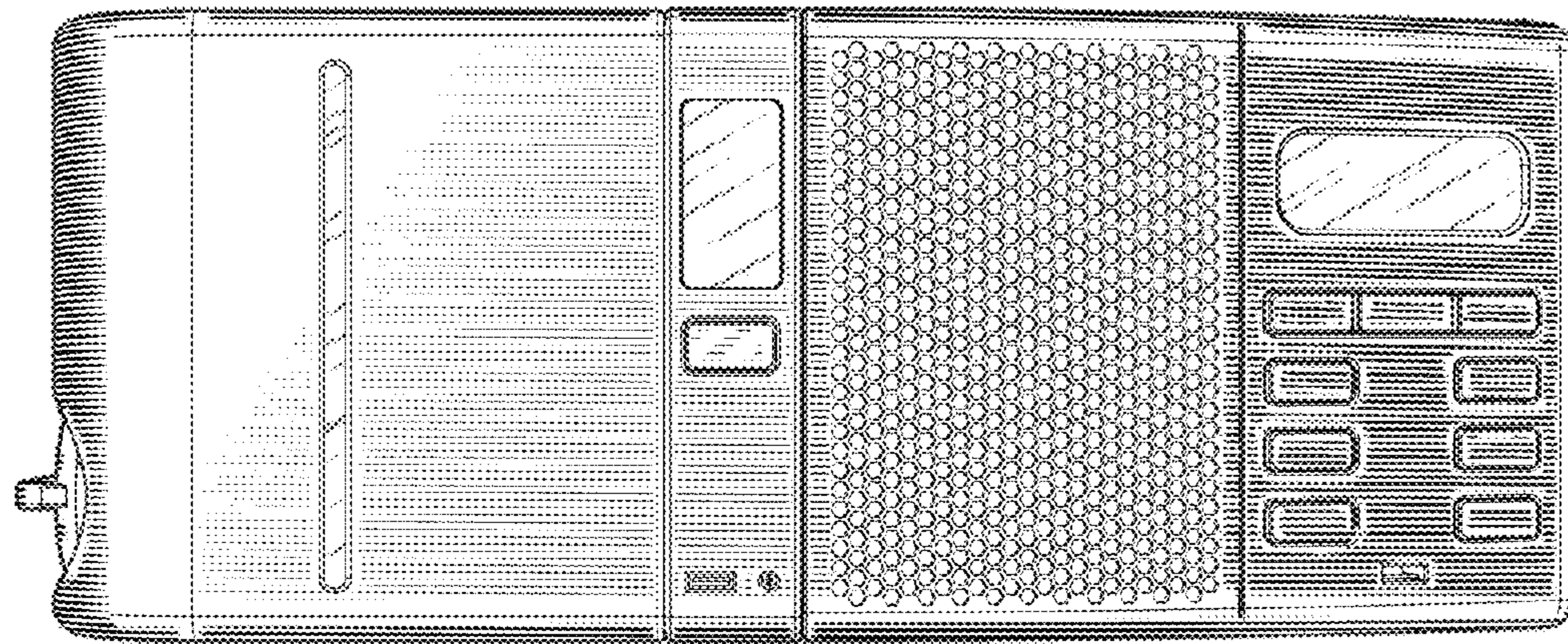

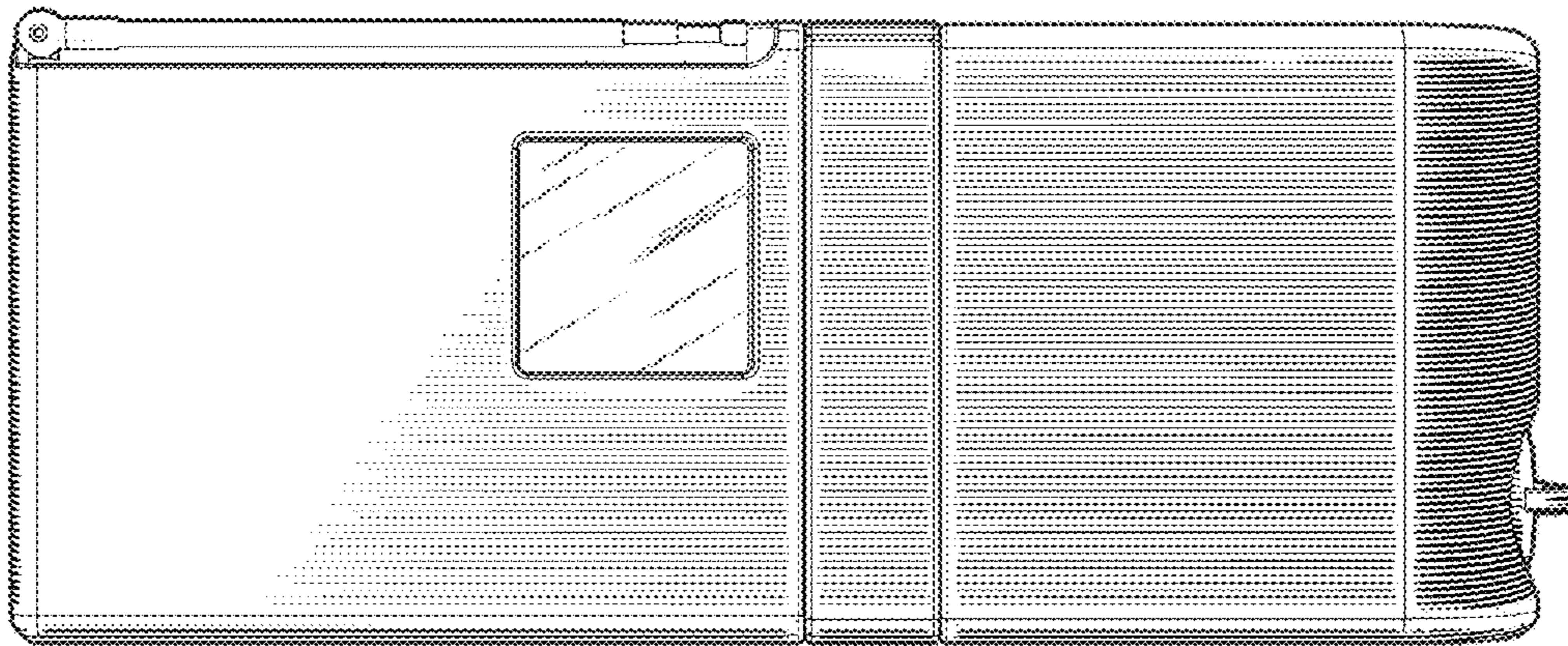

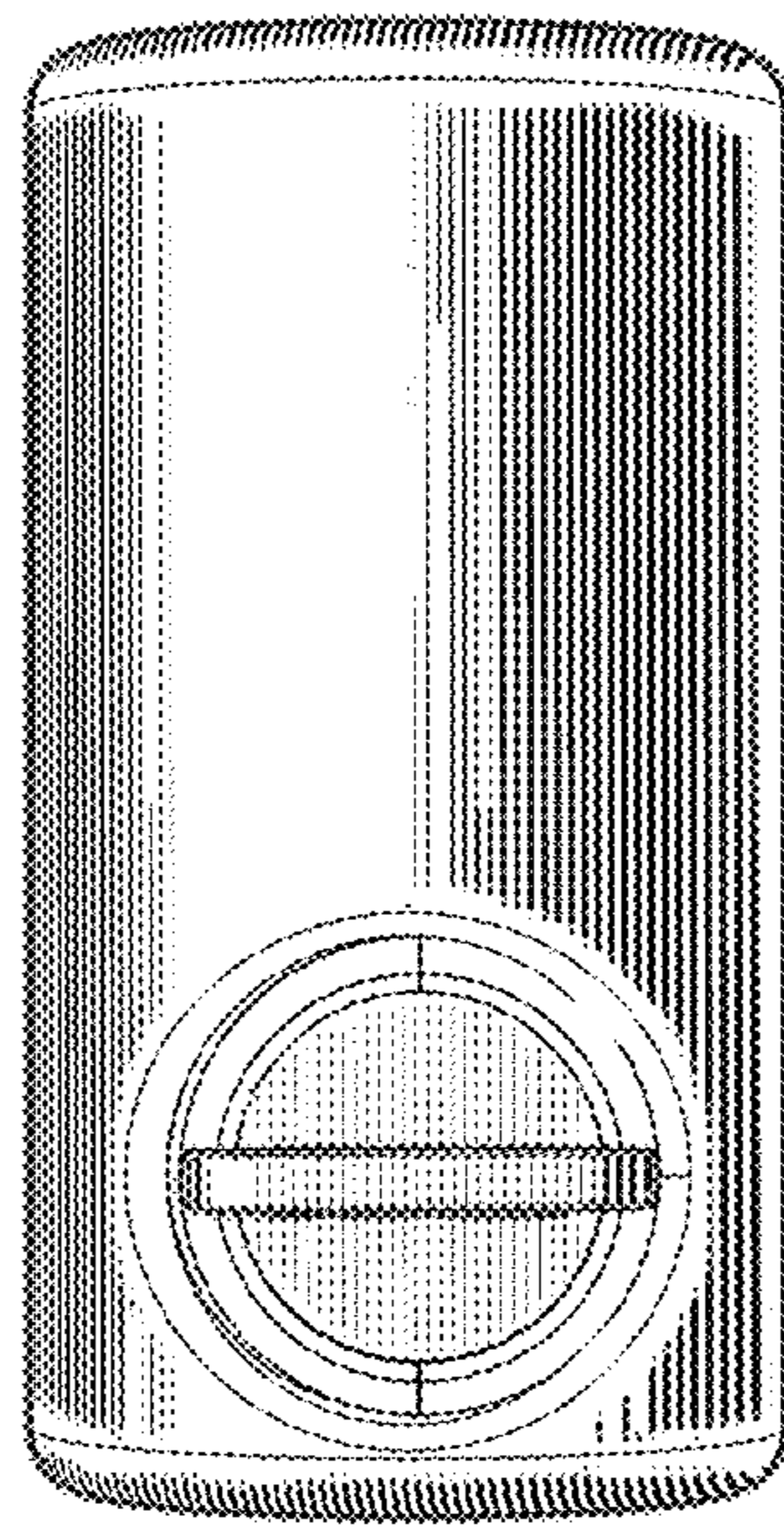

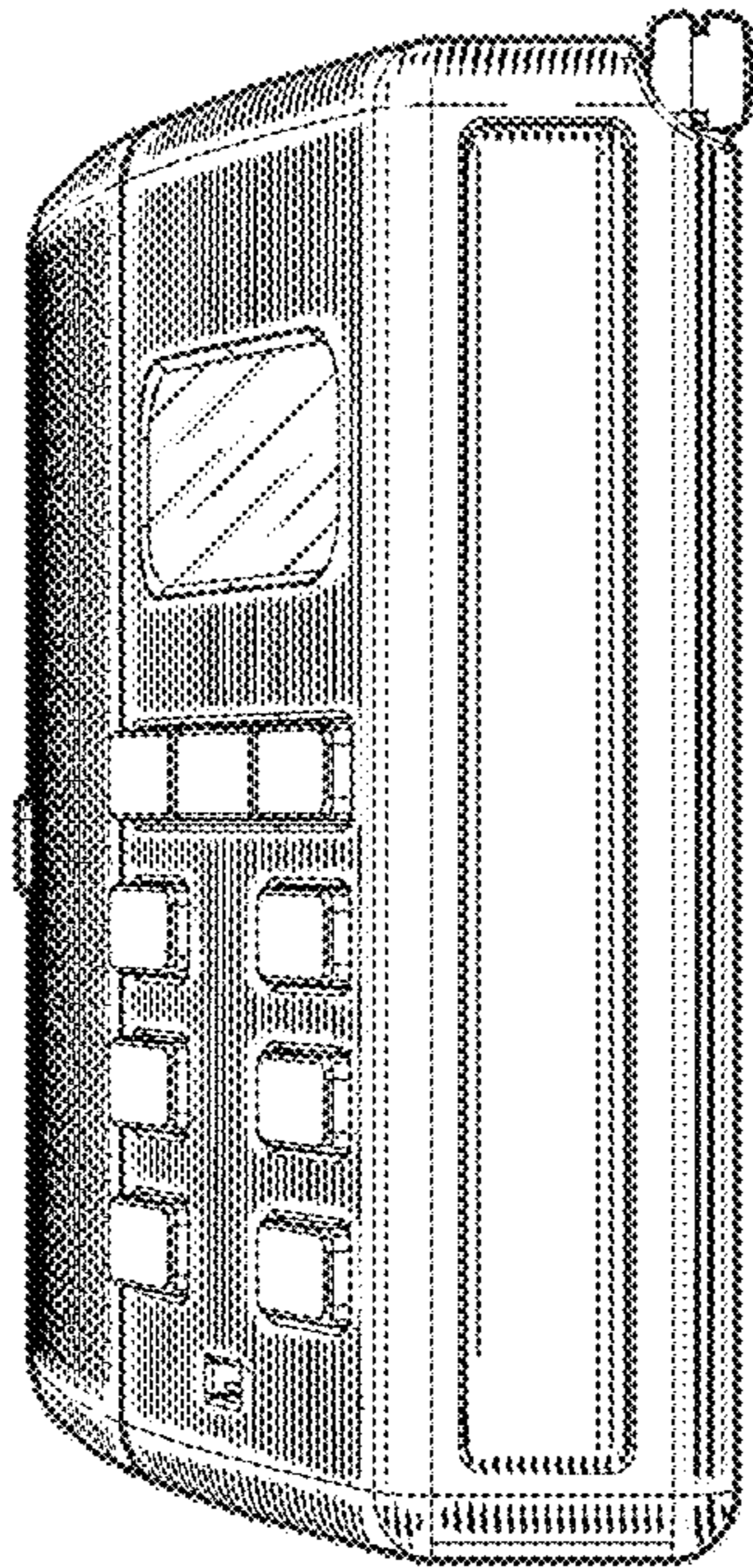

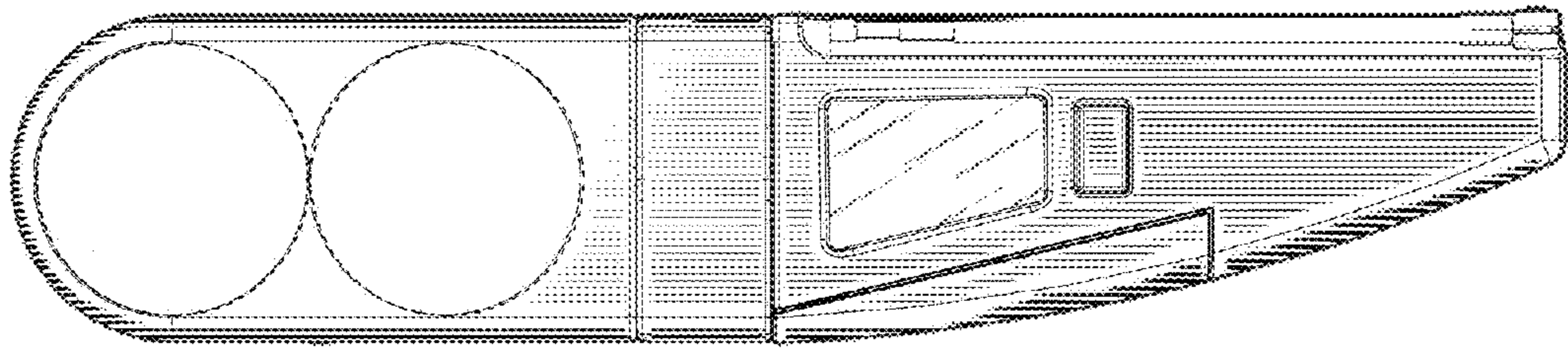

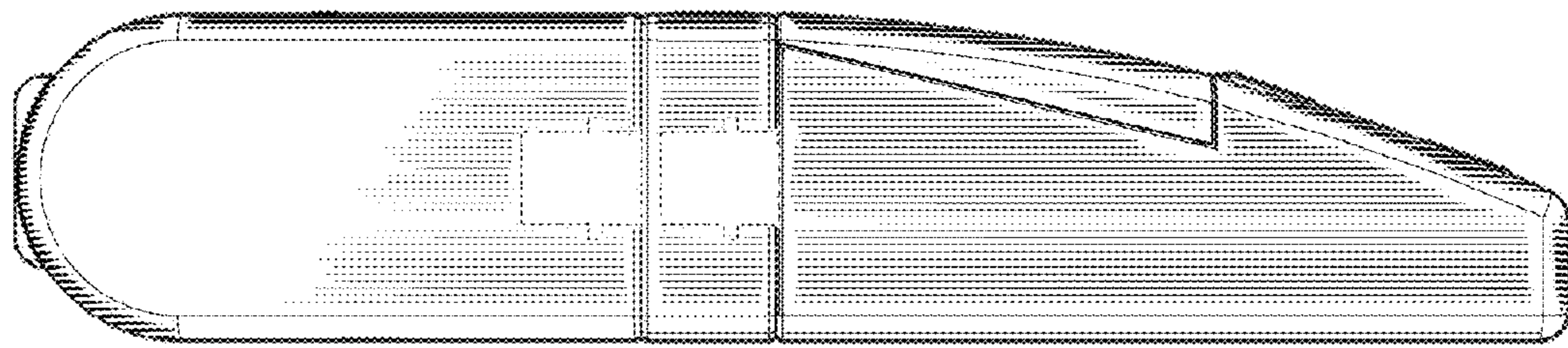
