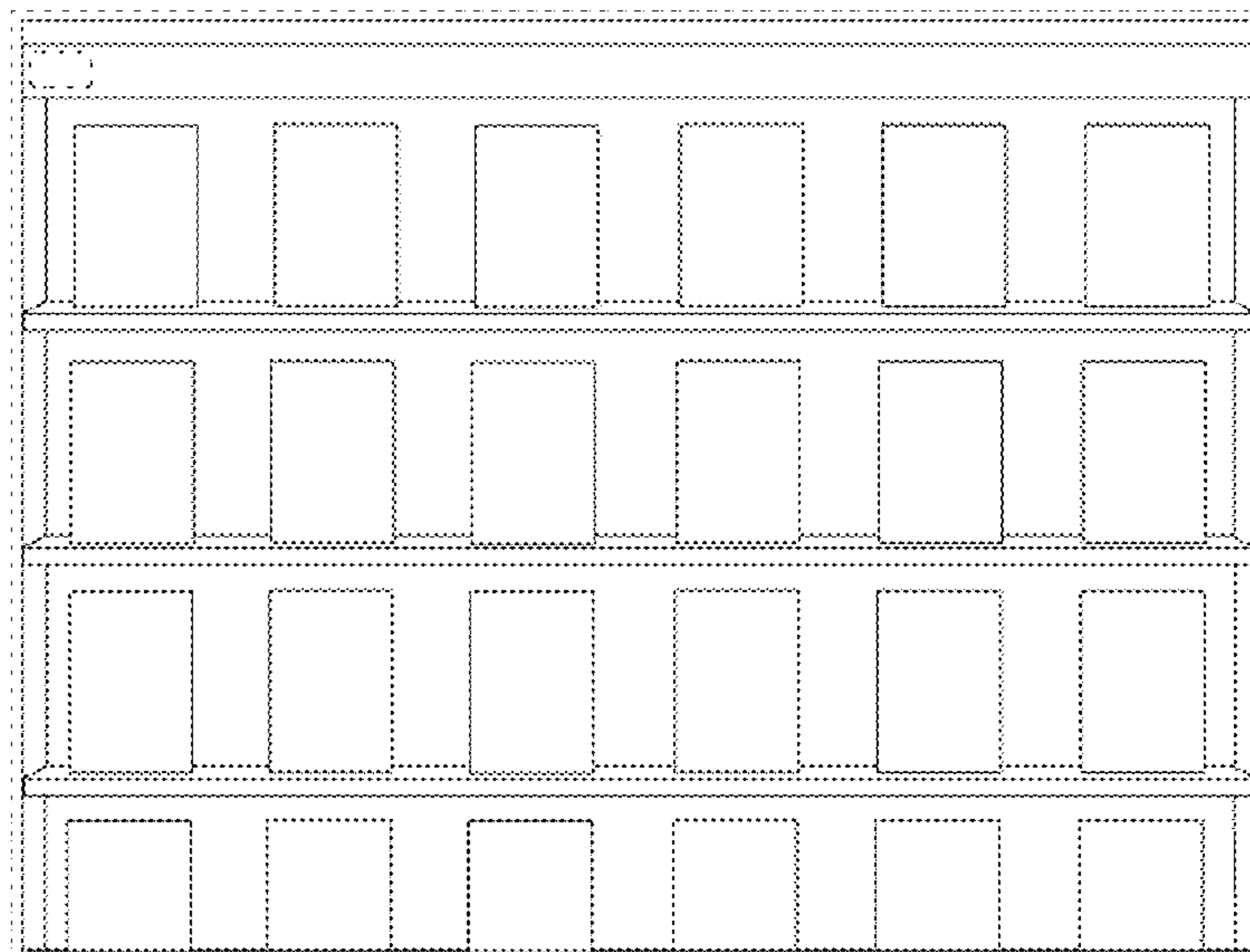
(57) **CLAIM**

The ornamental design for a display screen or portion thereof with graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display screen or portion thereof with graphical user interface showing our new design; and, FIG. 2 is a front view of a second embodiment thereof. The outermost broken lines in the Figures show a display screen or portion thereof, and form no part of the claimed design. The other broken lines within the Figures show portions of the graphical user interface that form no part of the claimed design.

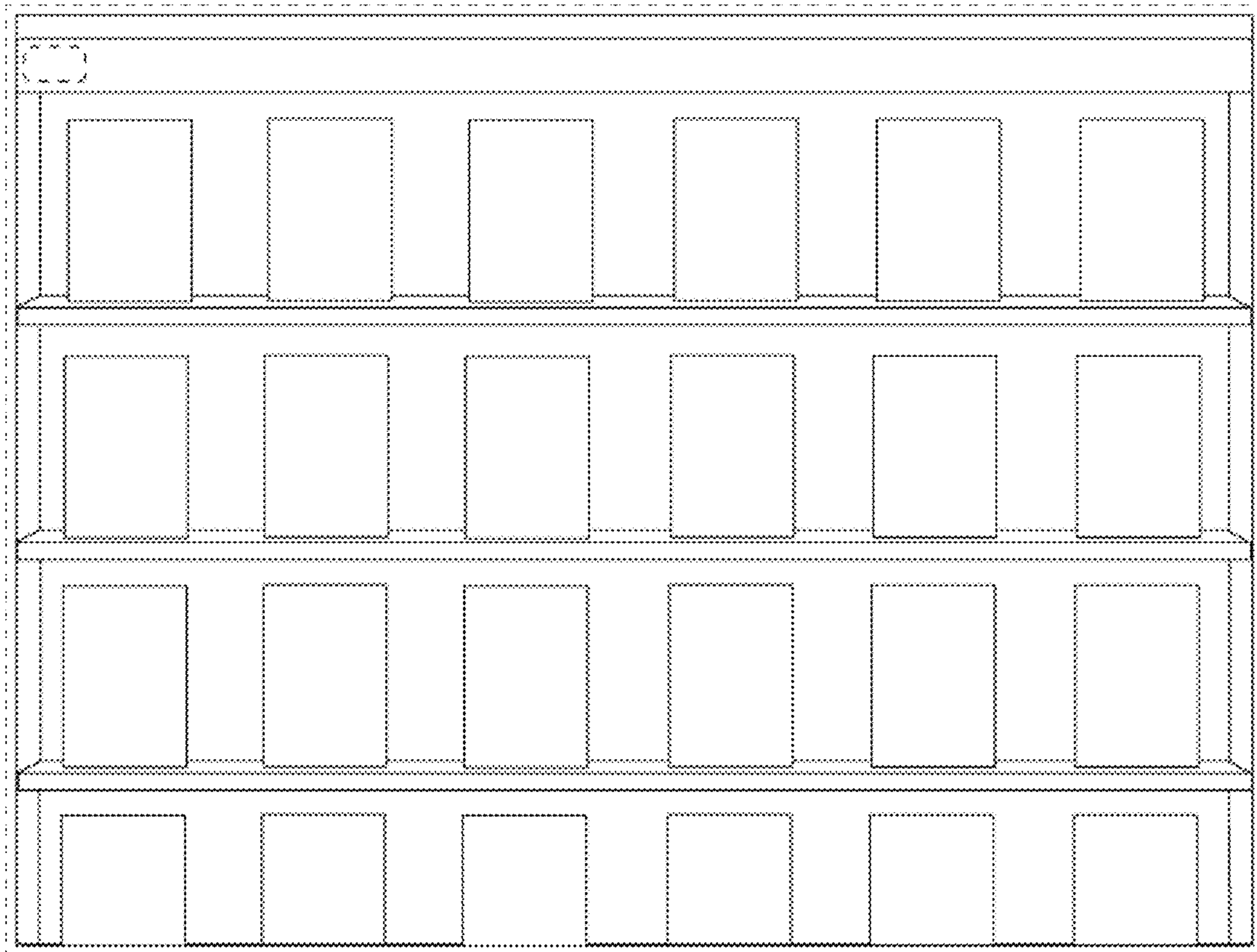

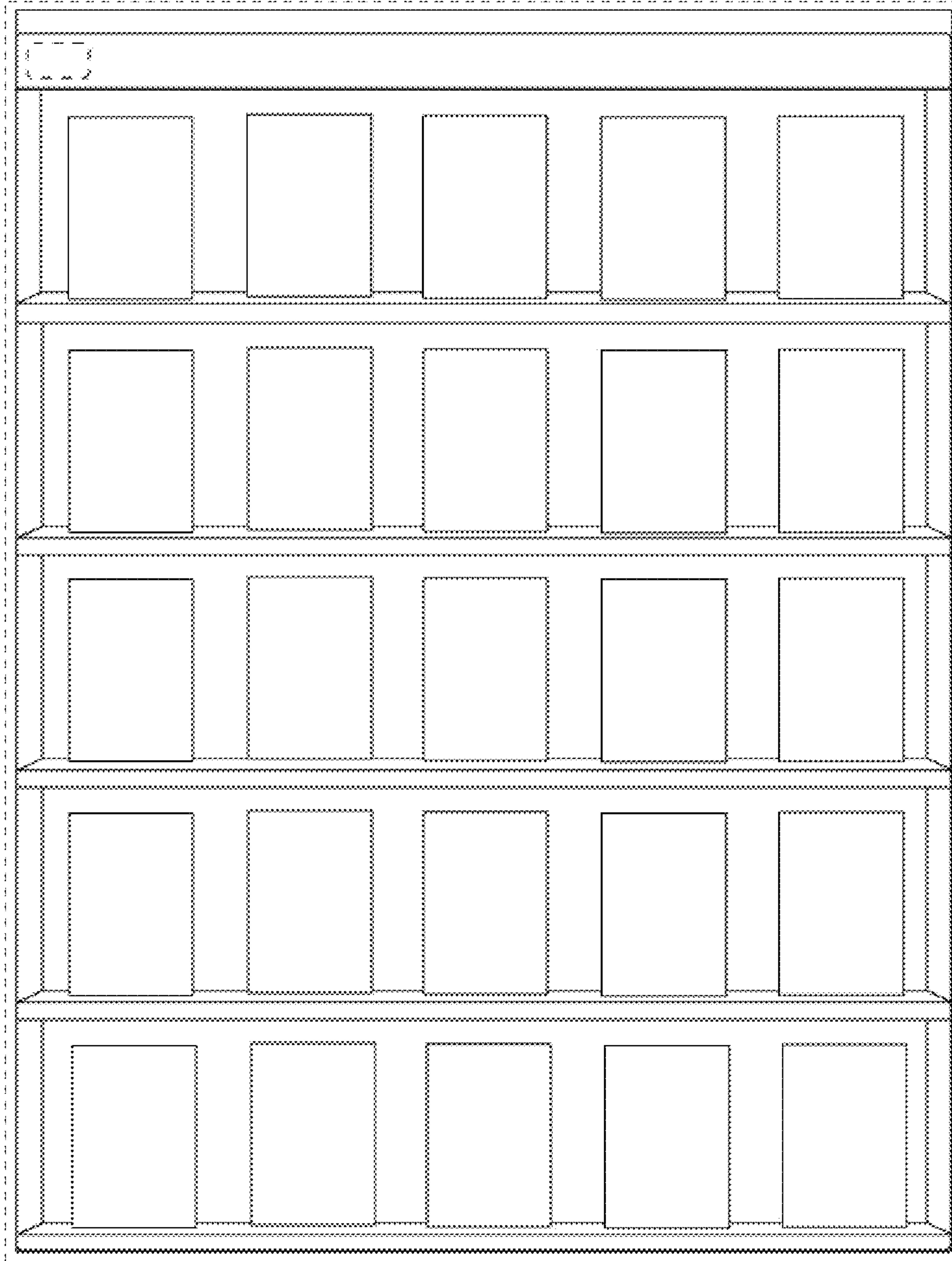
