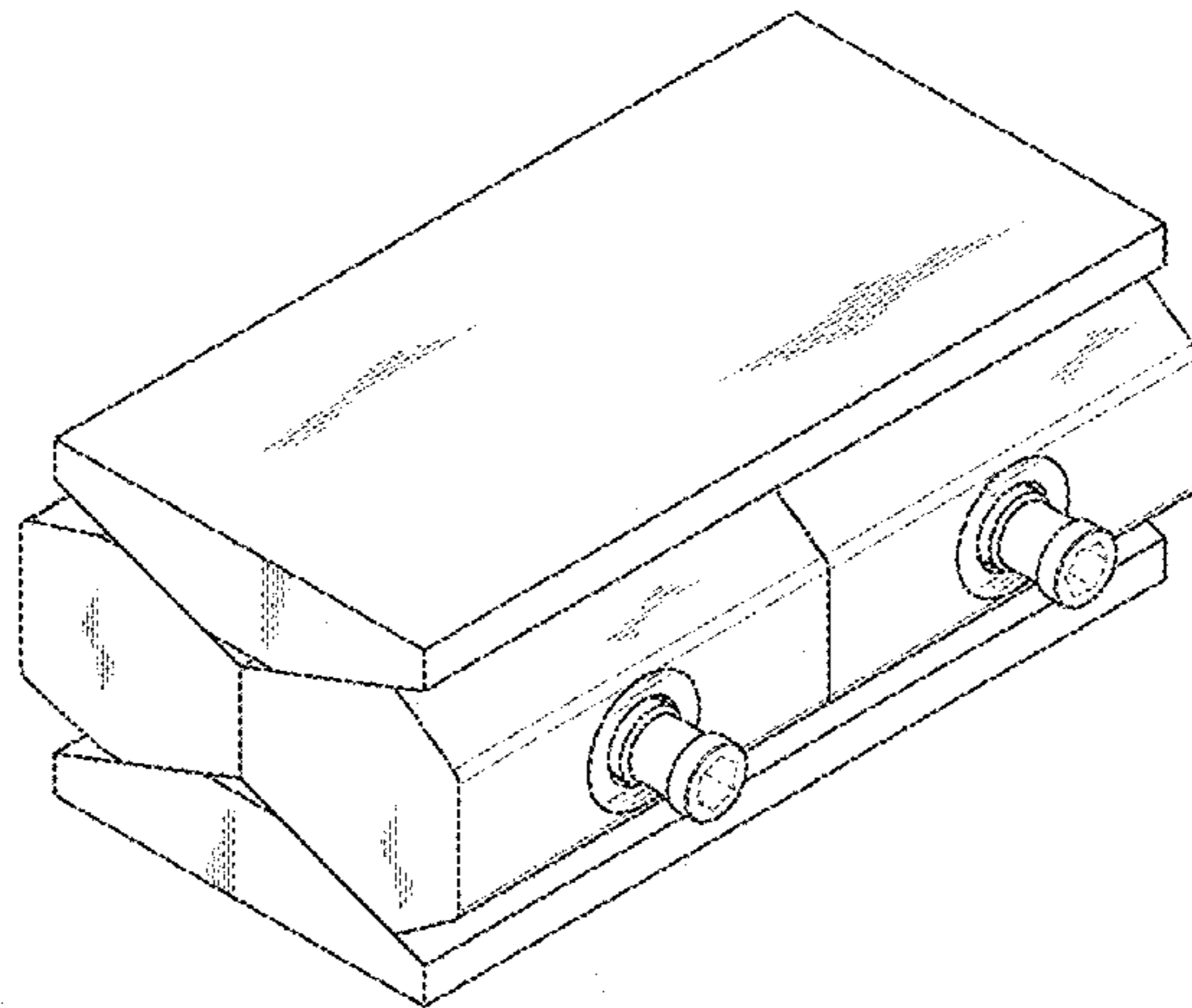
(57) **CLAIM**

The ornamental design for a pressure sealing means for cable transit, as shown and described.

DESCRIPTION

FIG. 1 is a first perspective view of the pressure sealing means for cable transit;

 FIG. 3 is a front view of the pressure sealing means for cable transit;

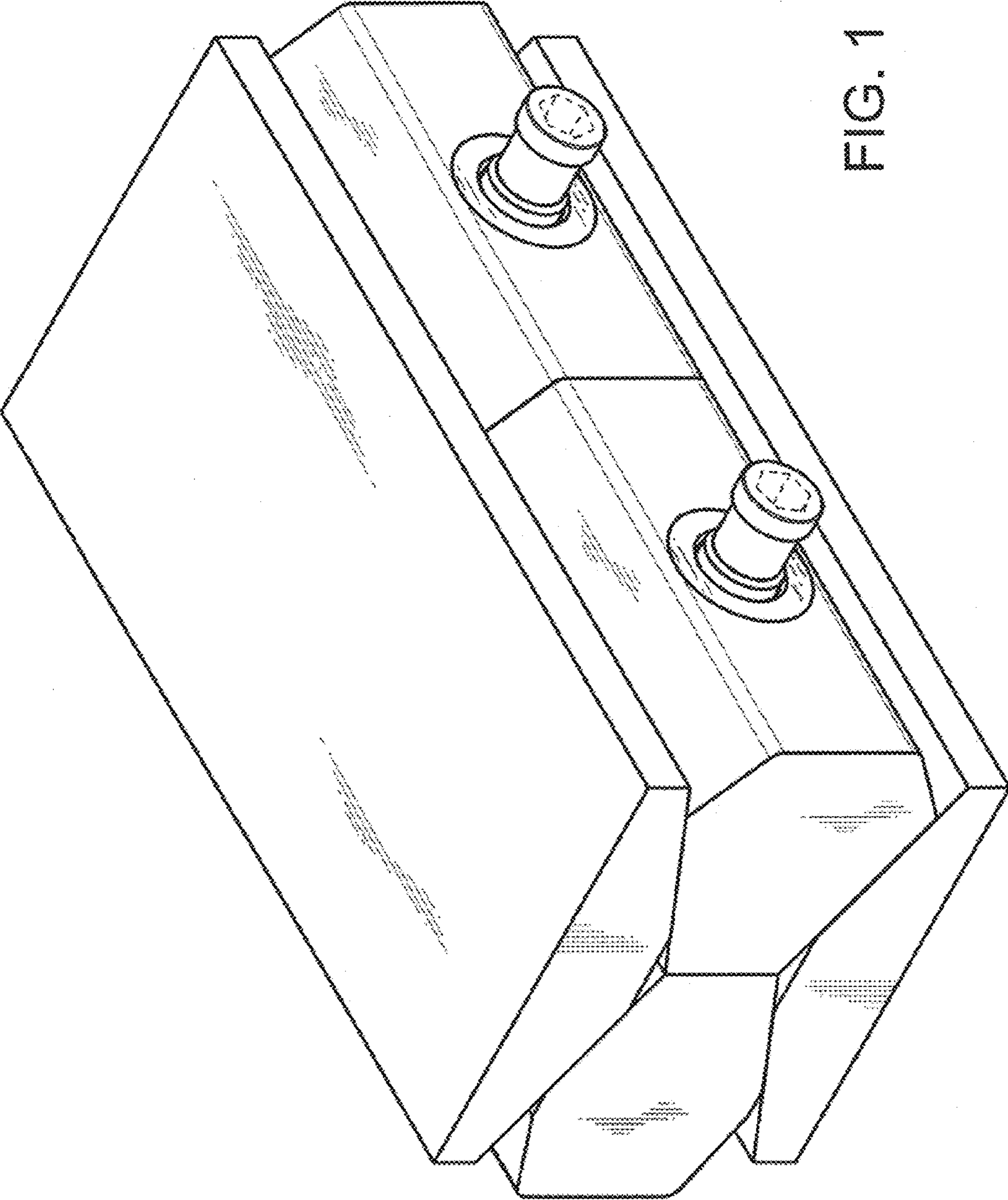

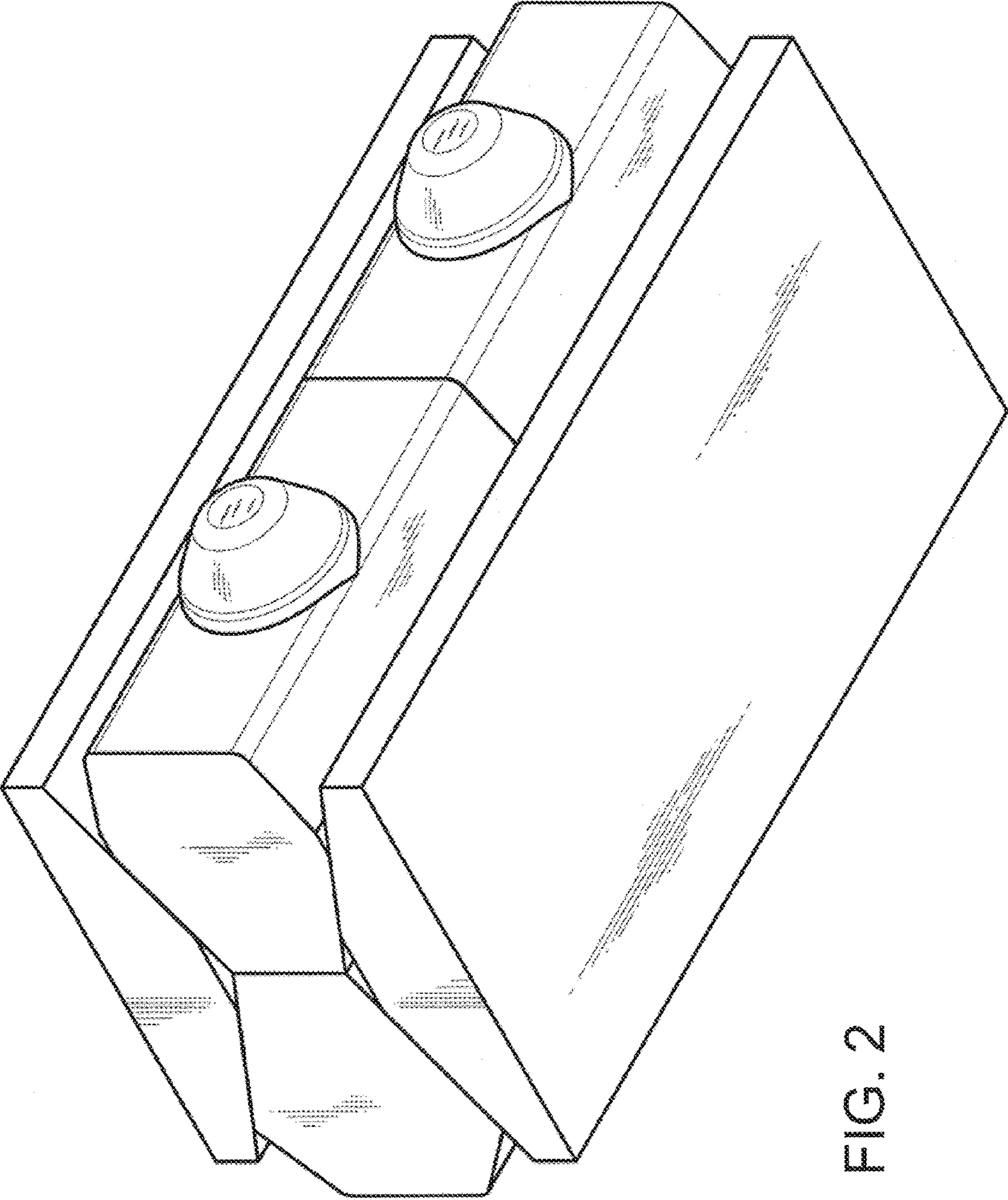

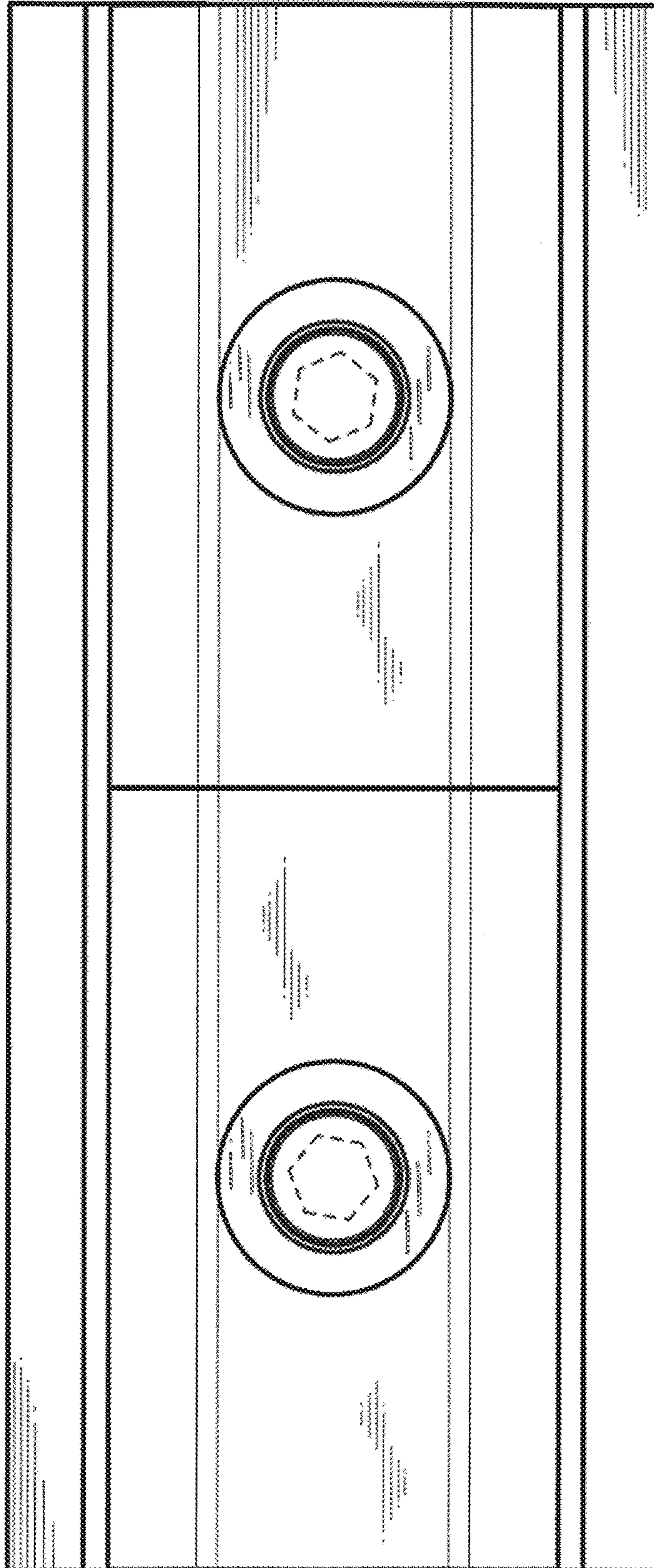

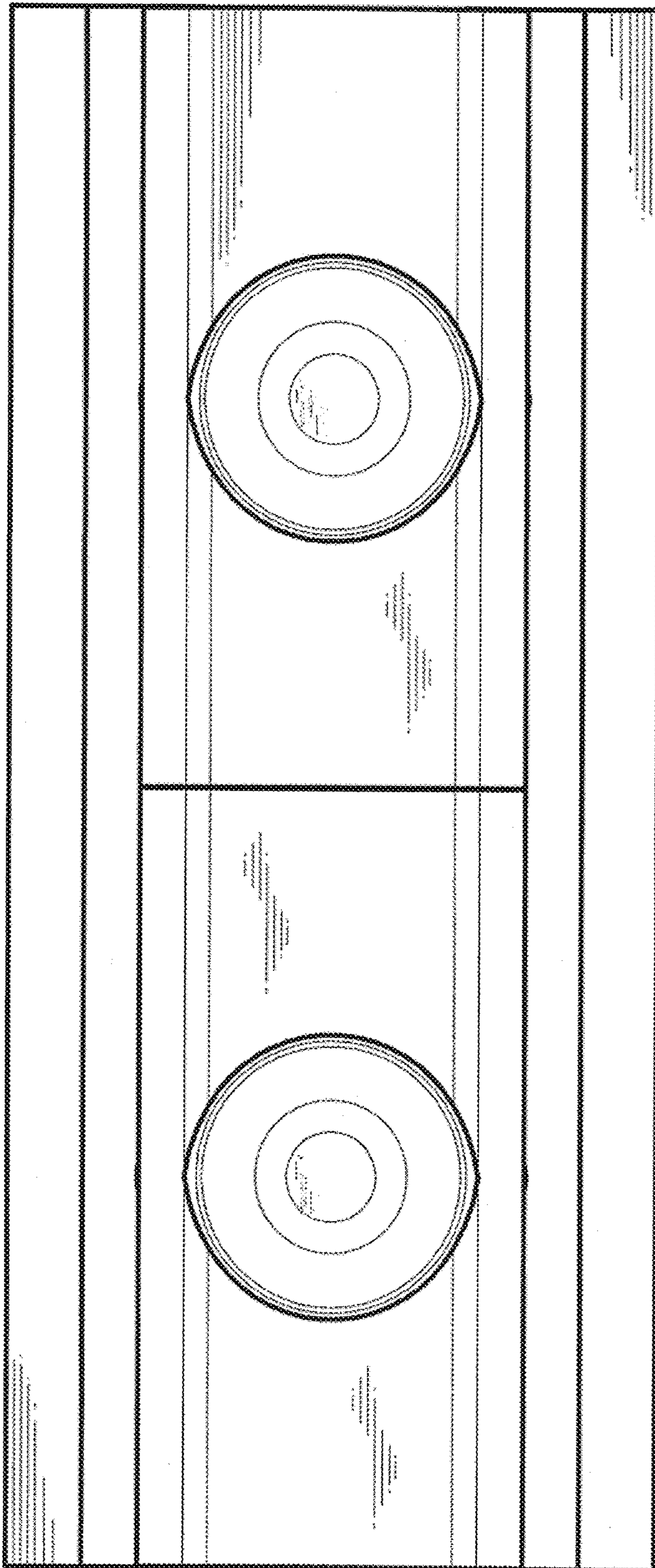

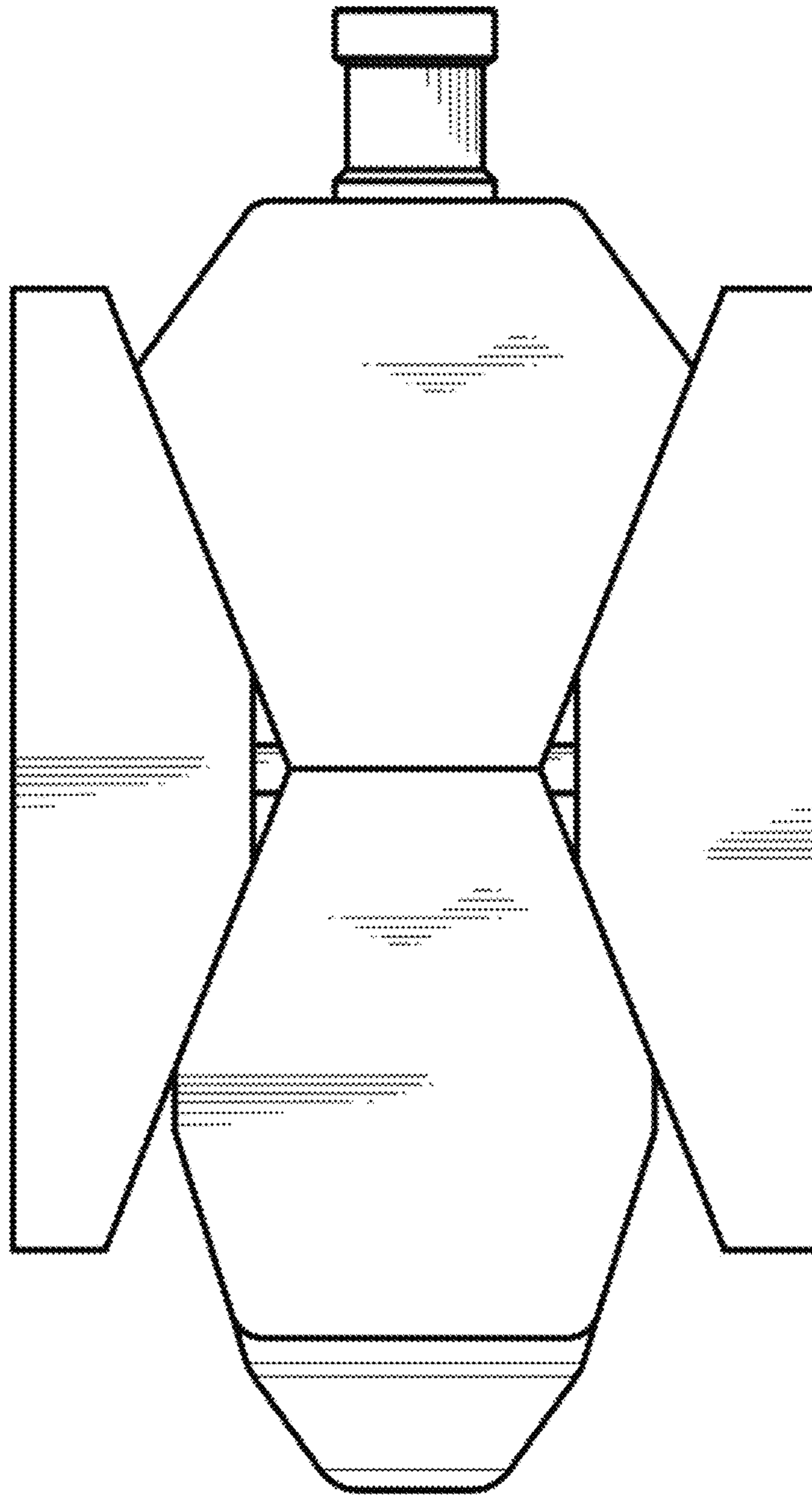
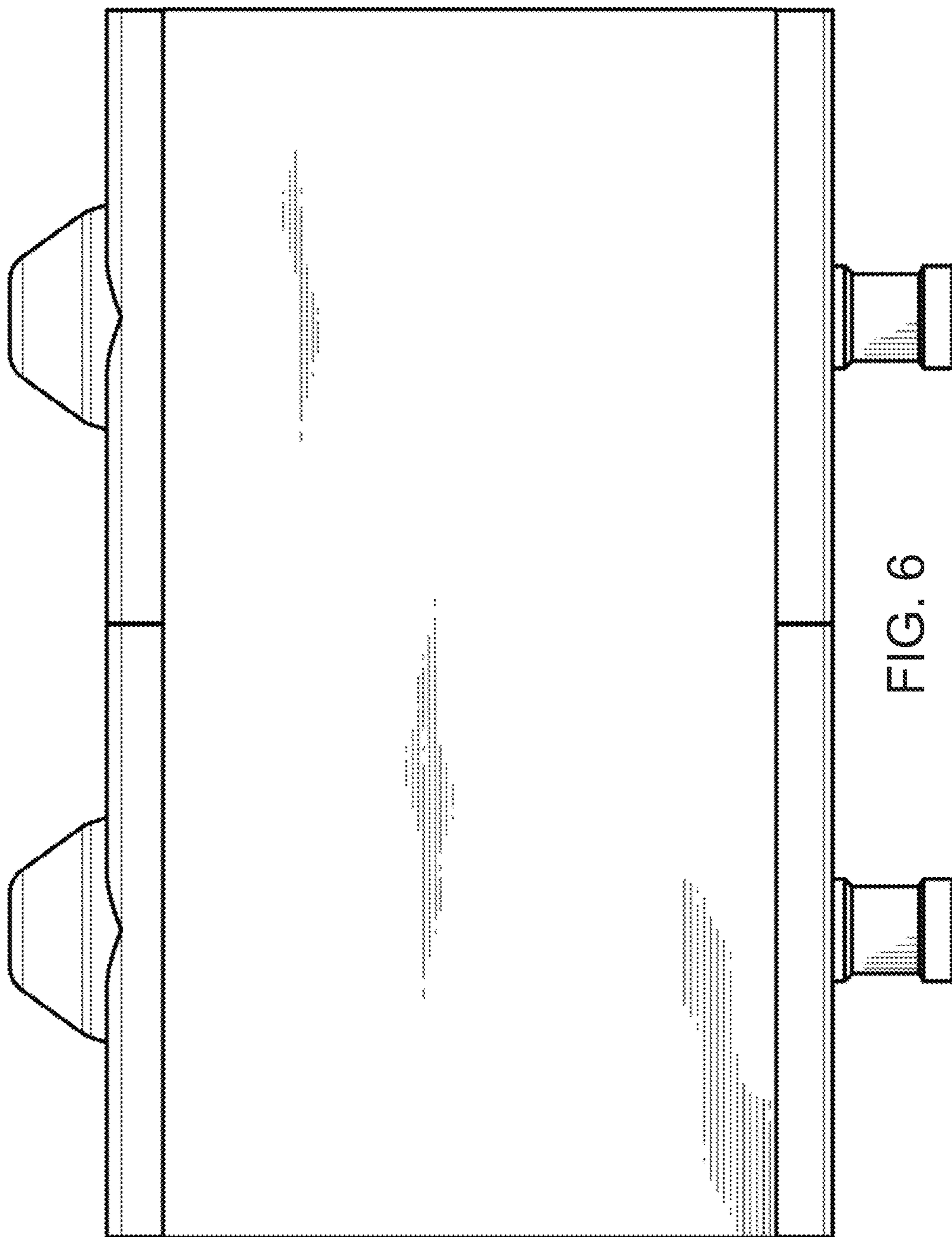

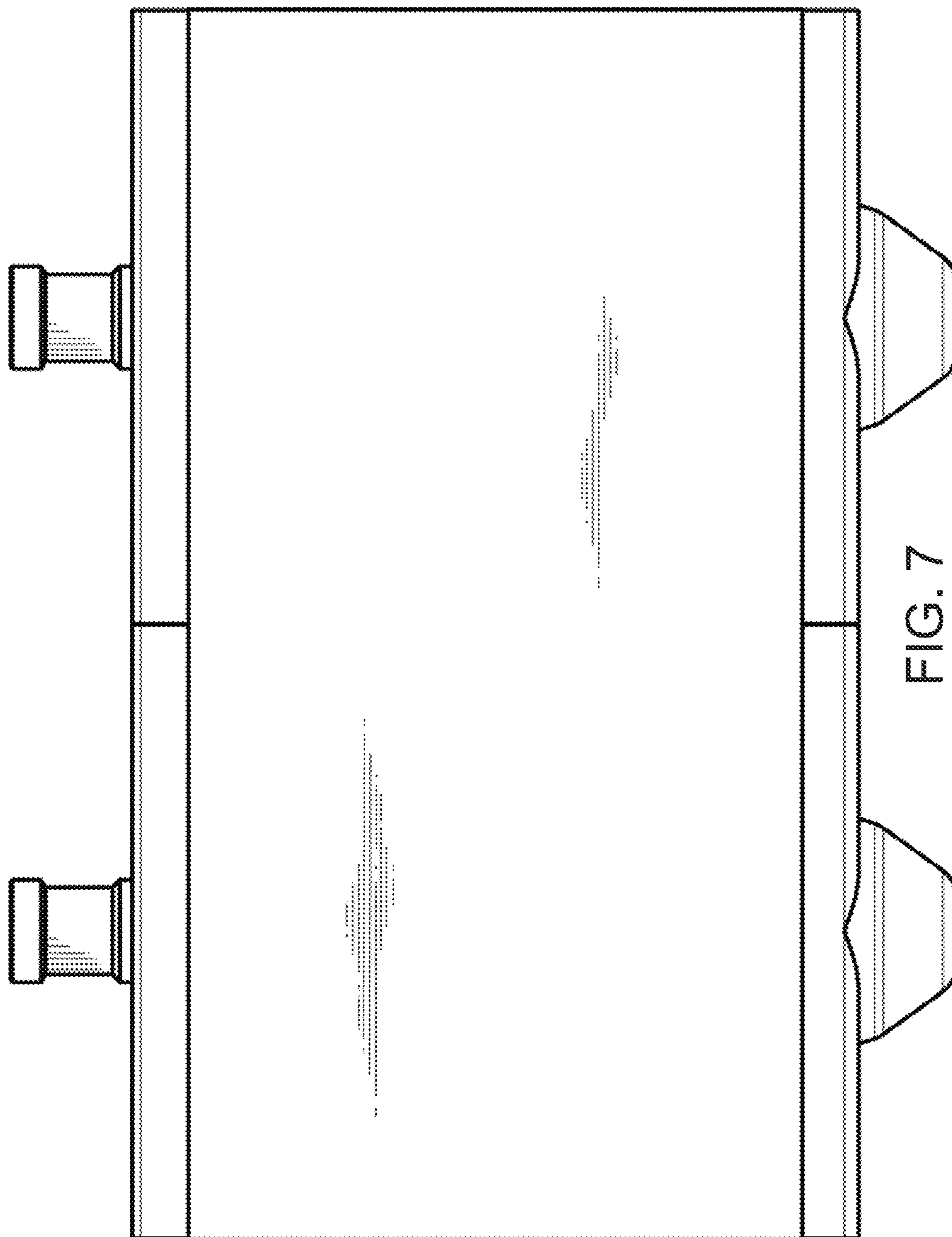
