DESCRIPTION

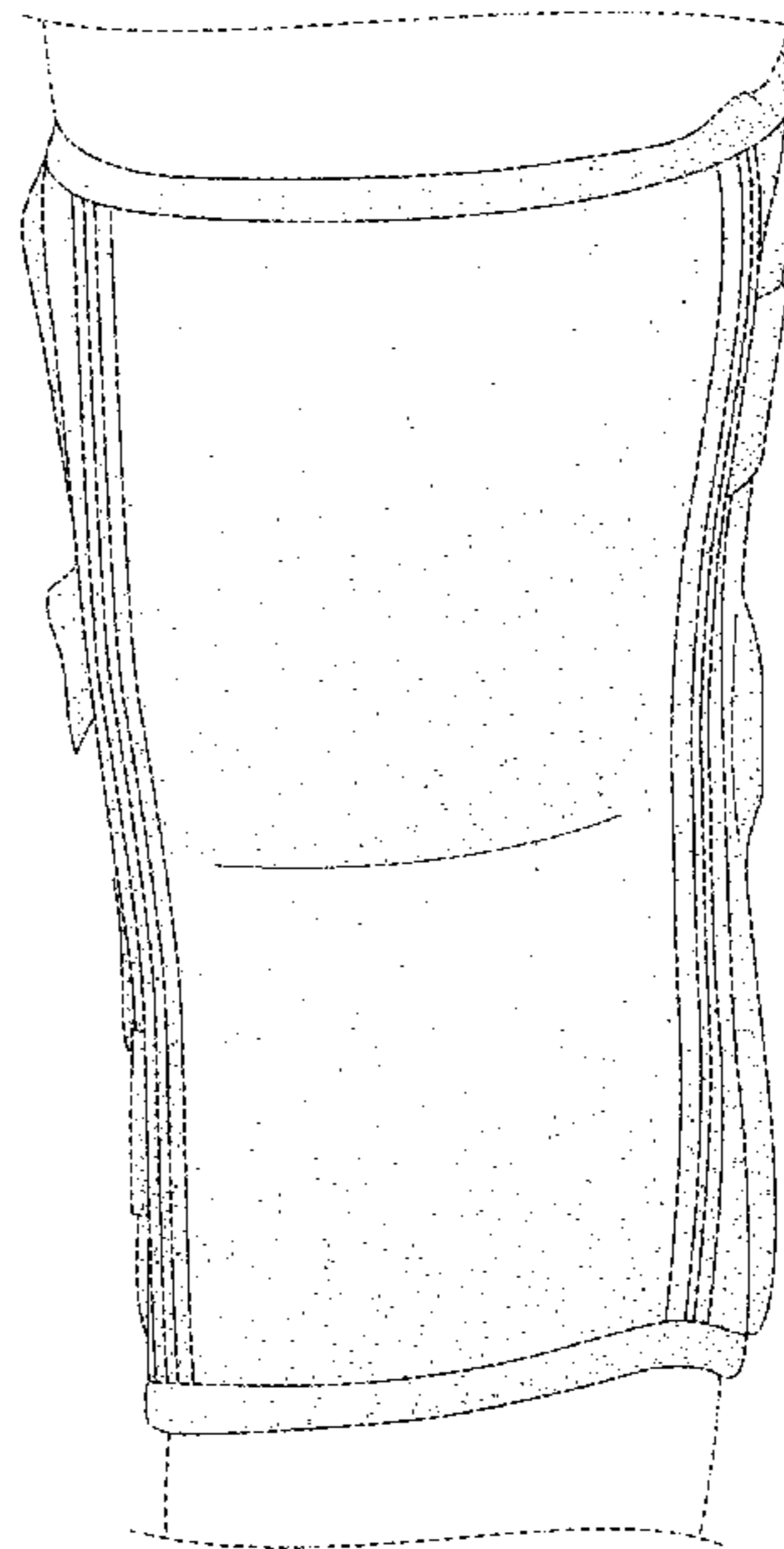
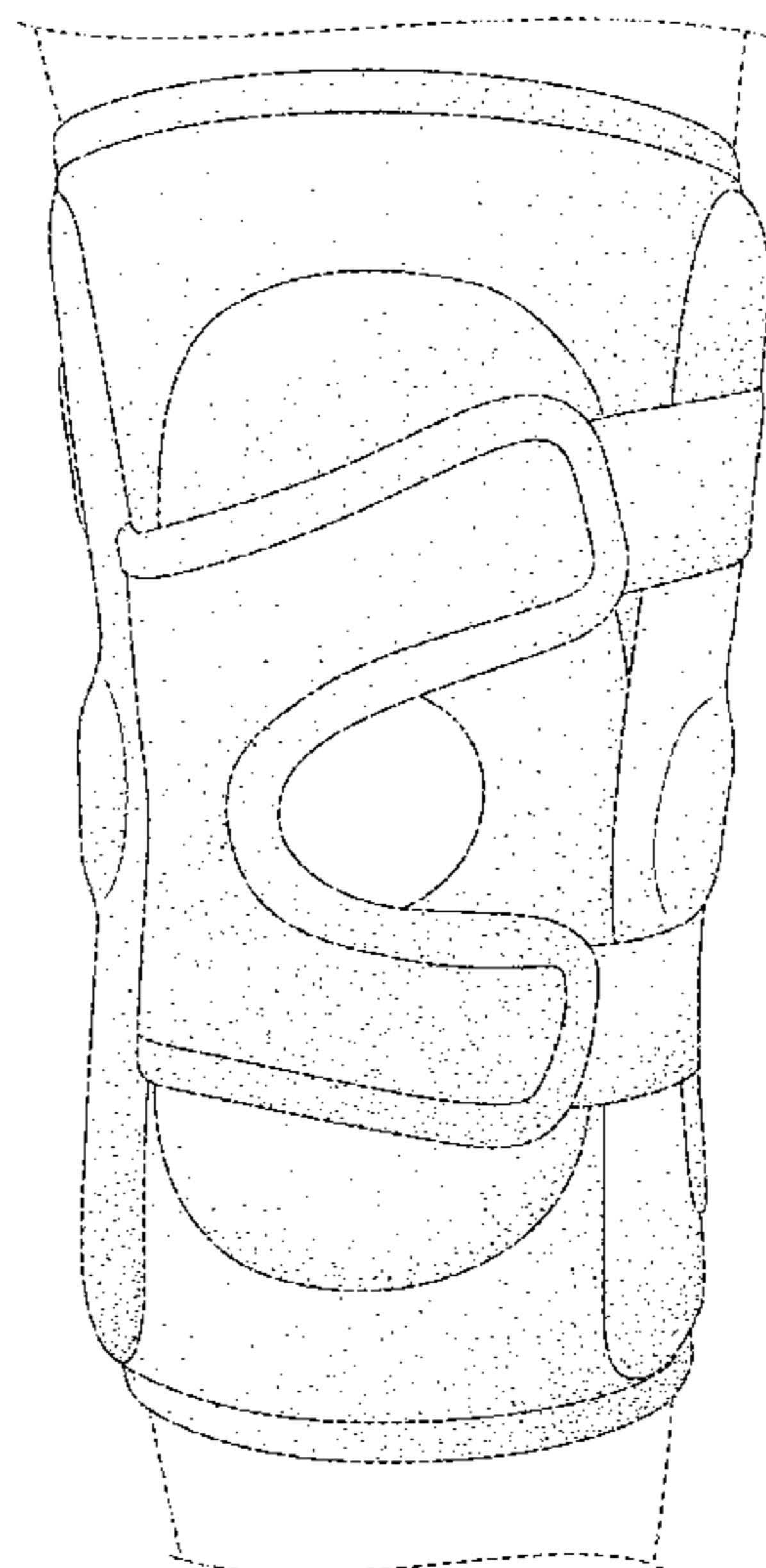

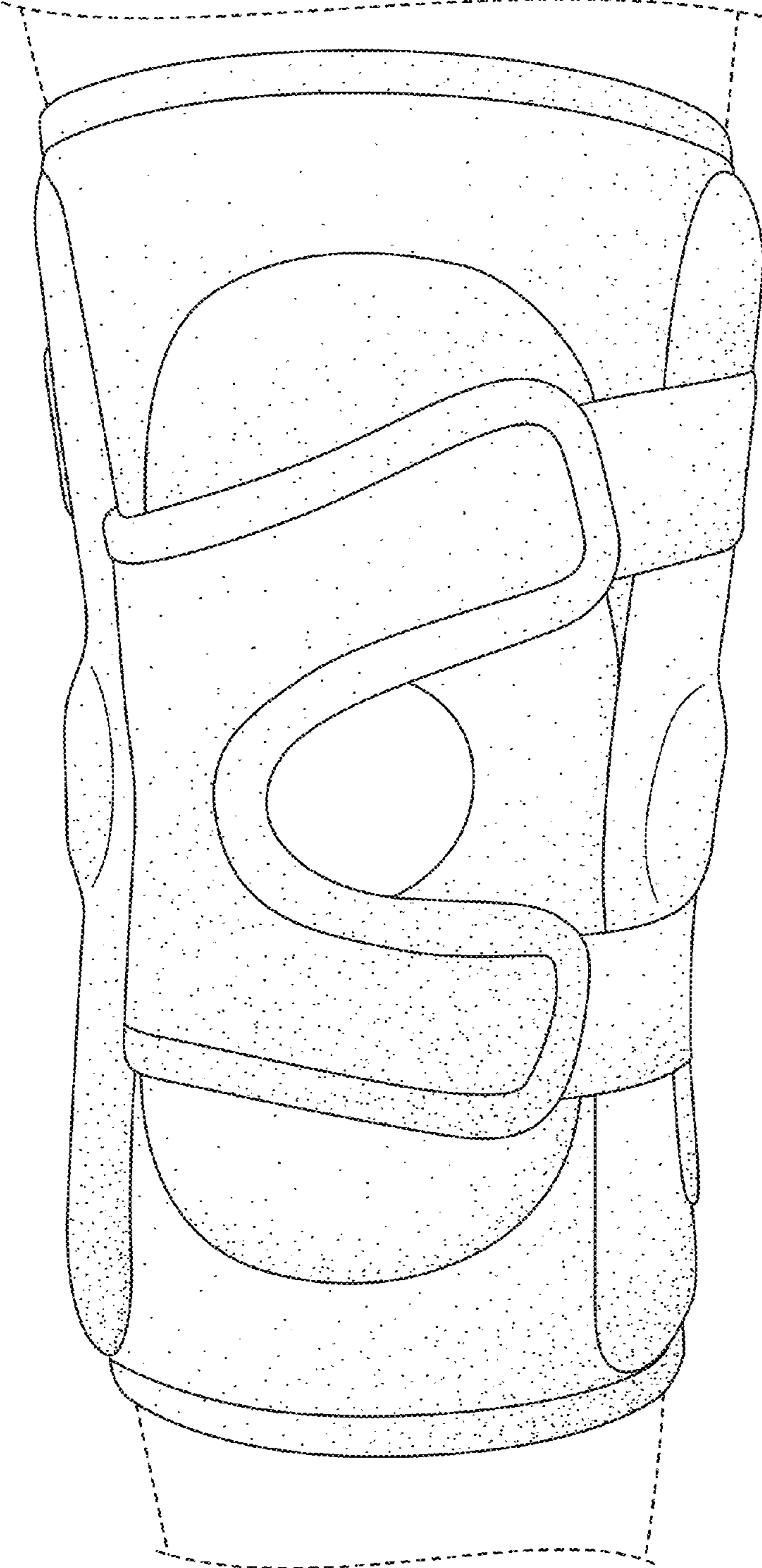

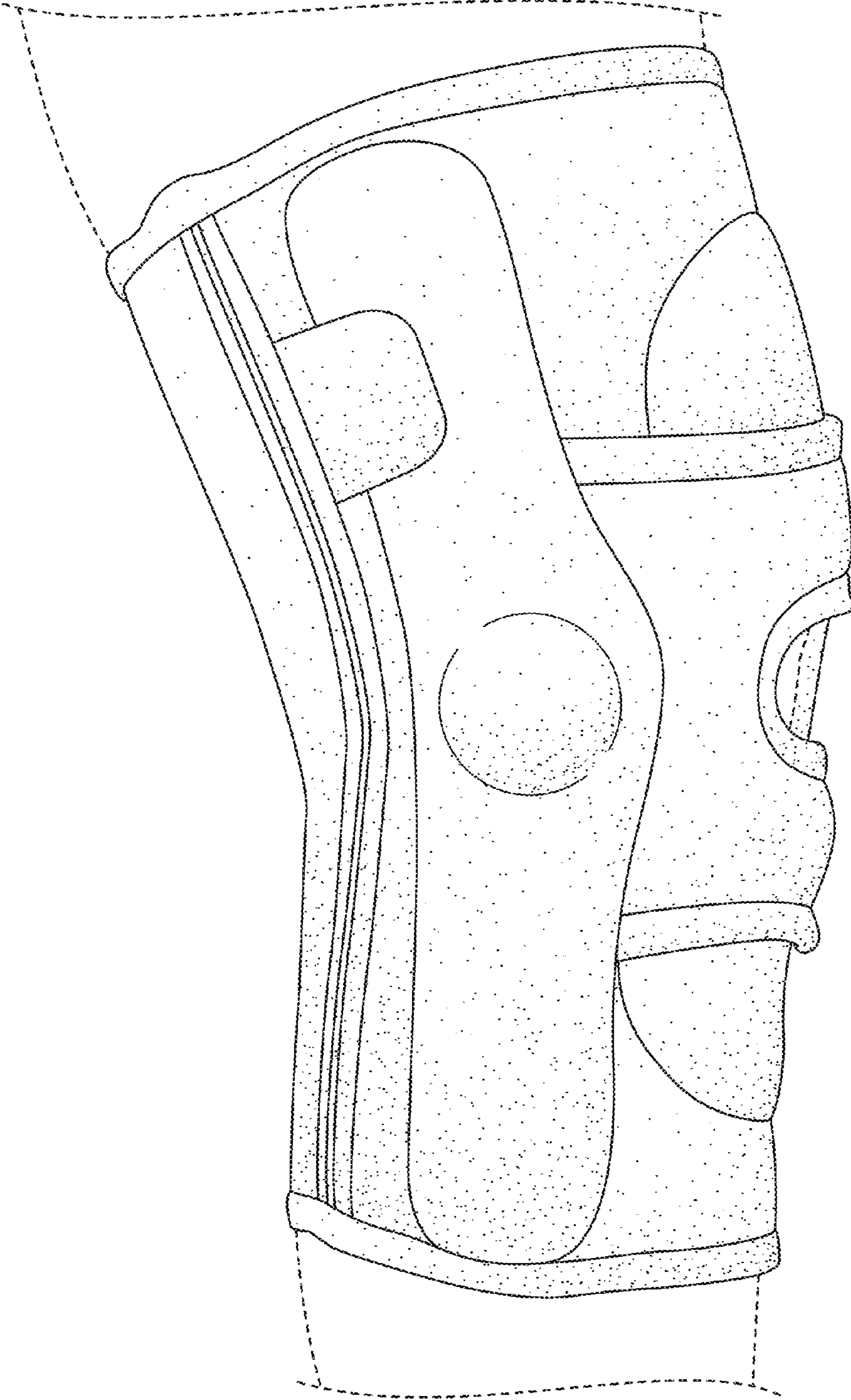

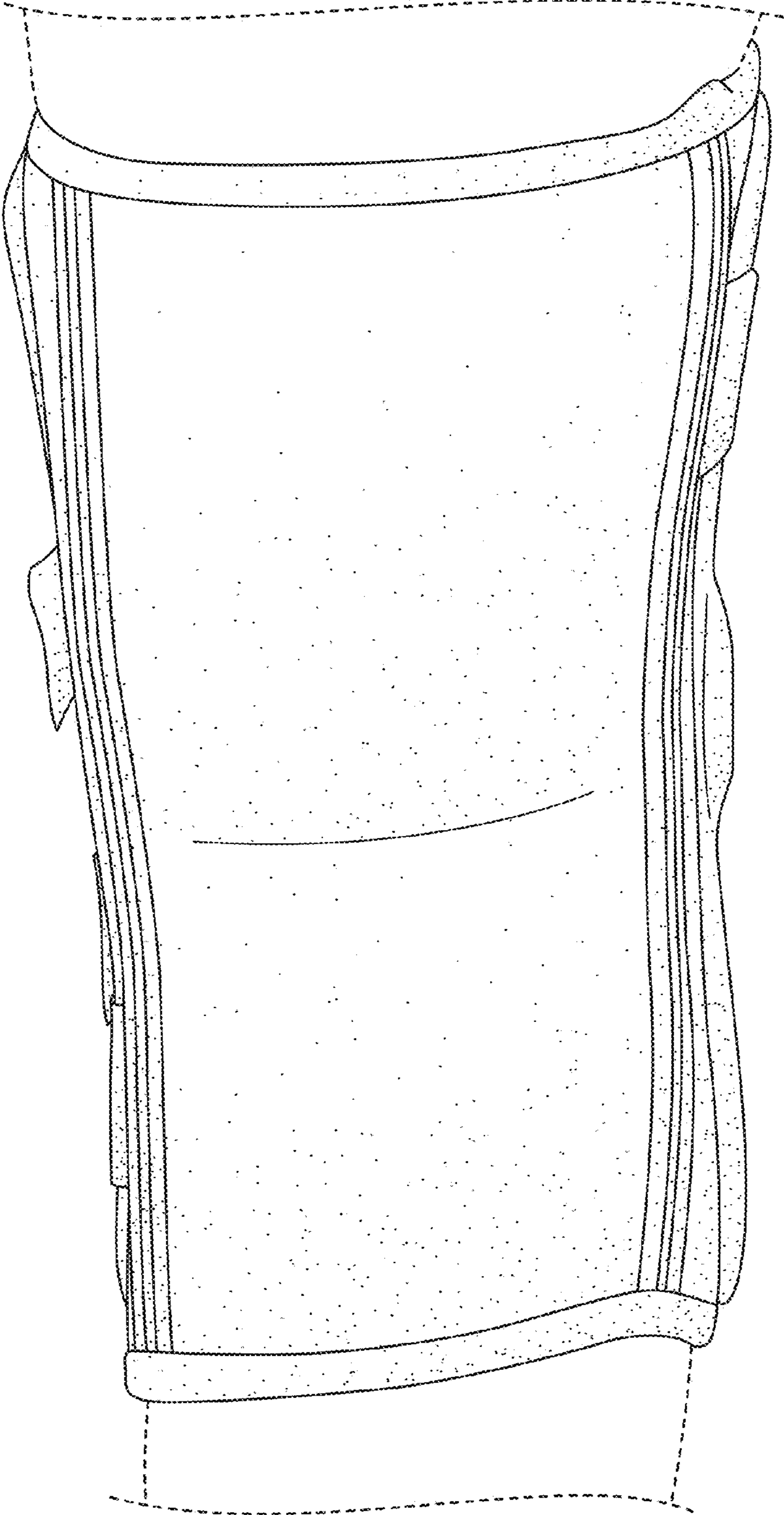

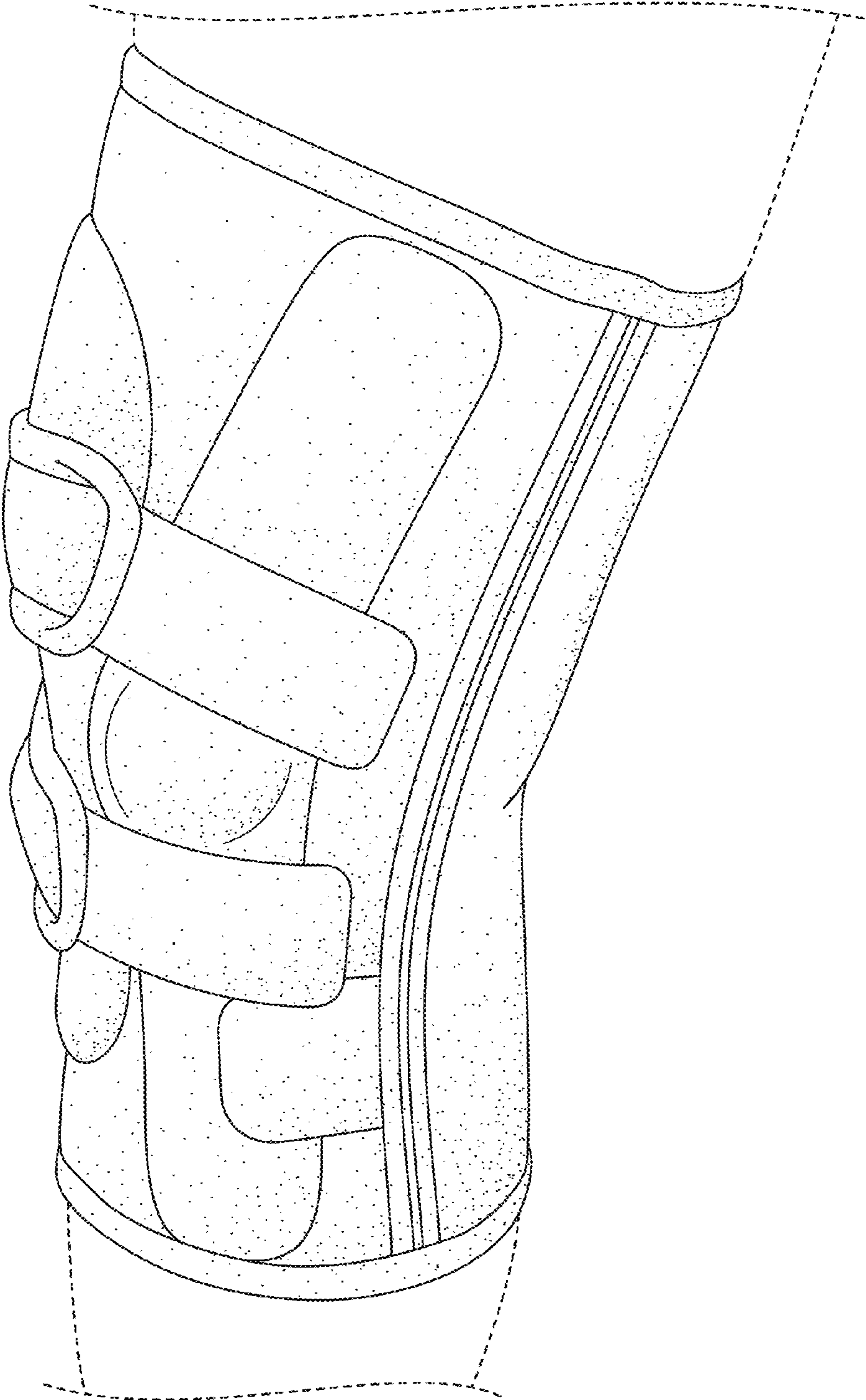

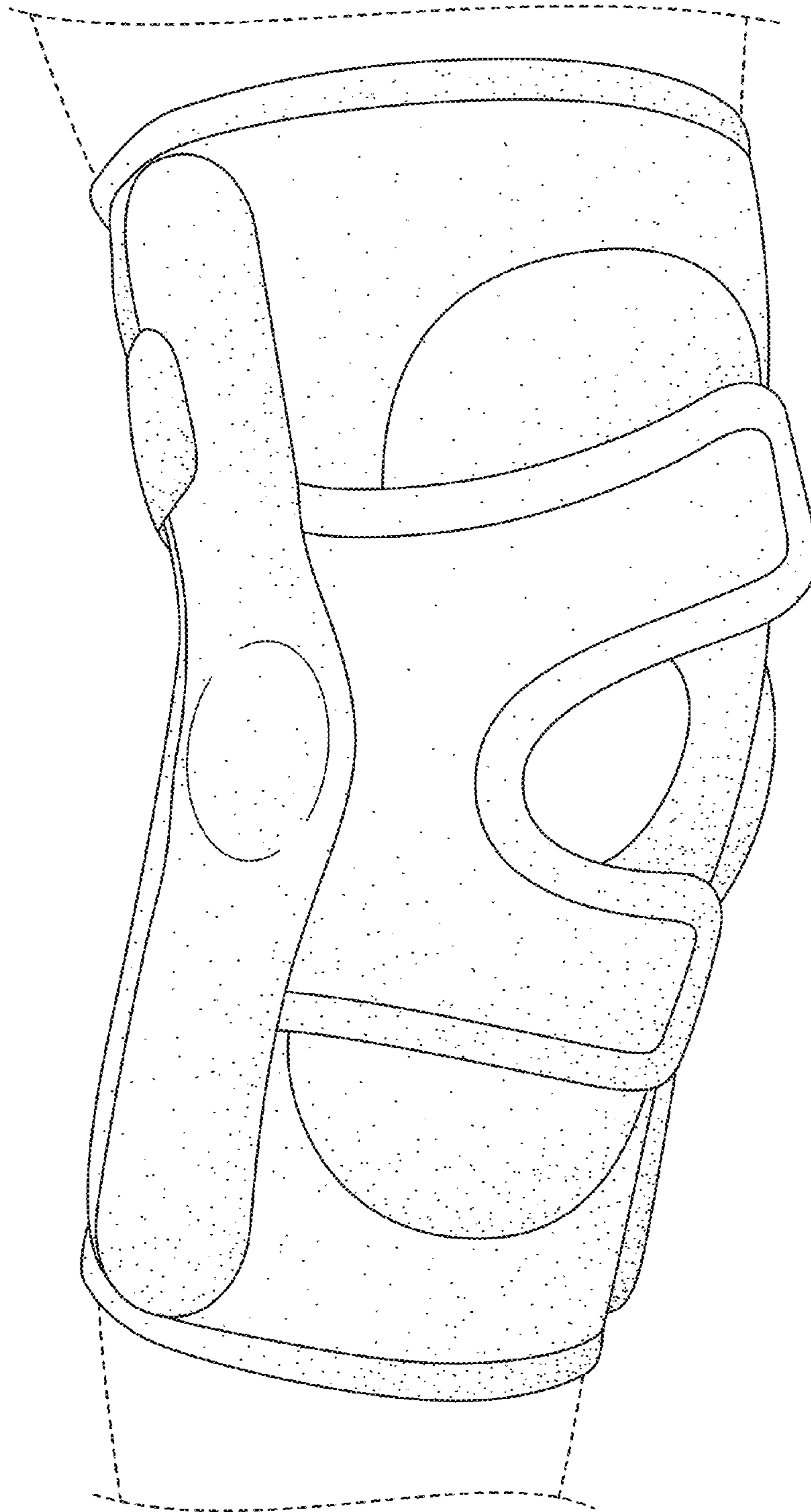
