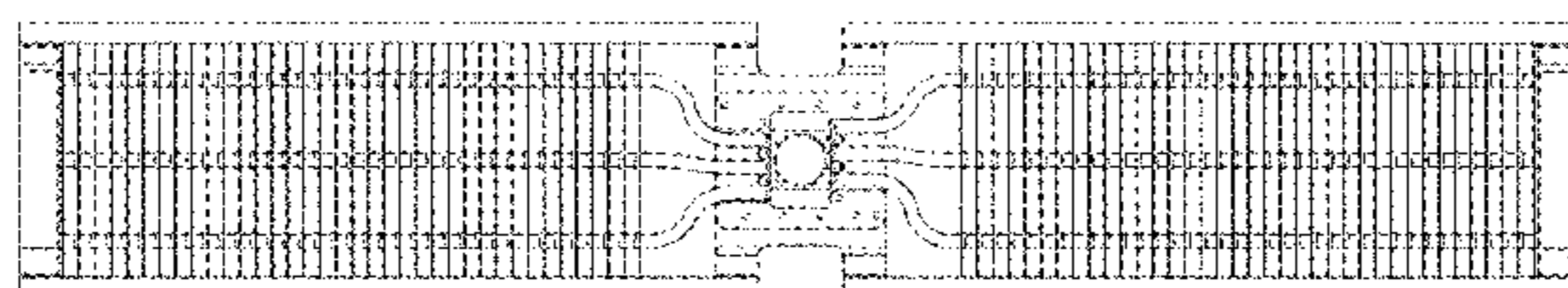
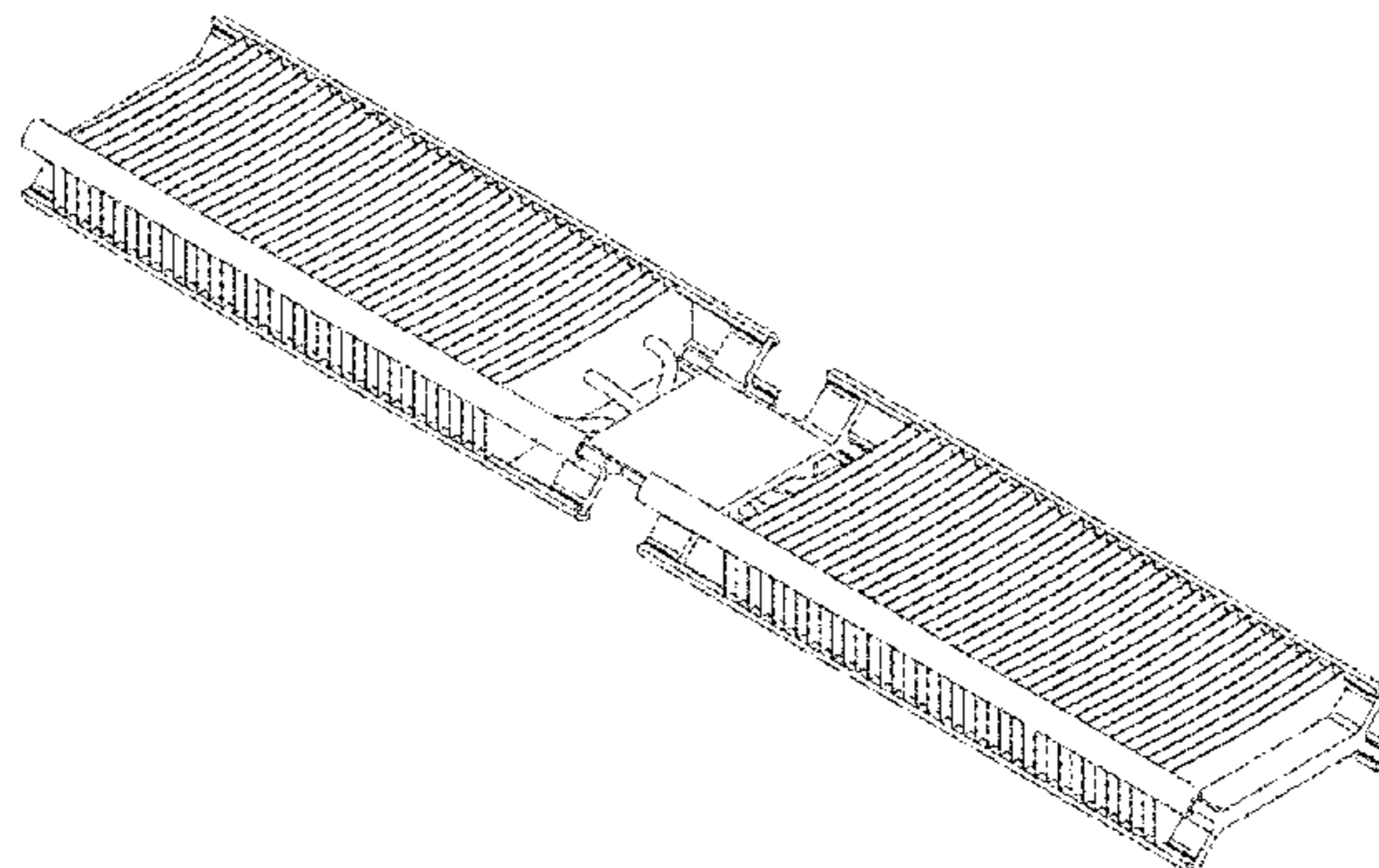
FIG. 1 is a perspective view of the light fixture showing our new design;

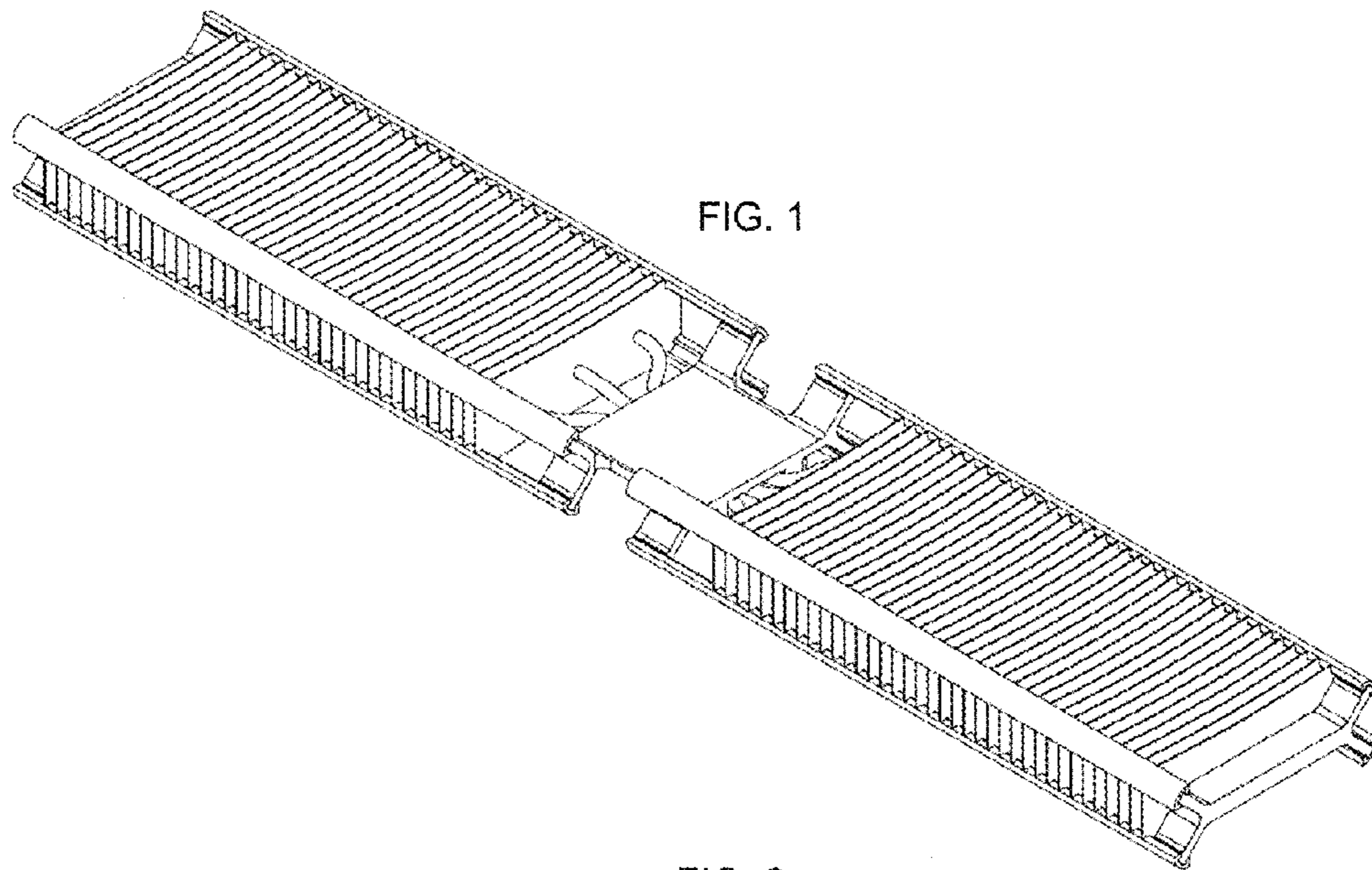

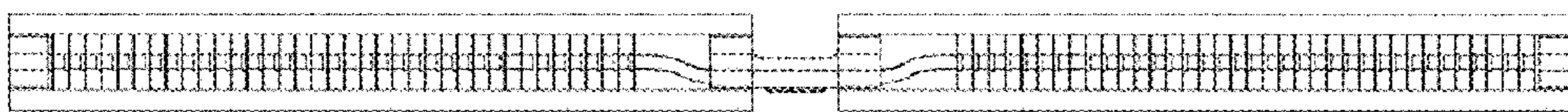

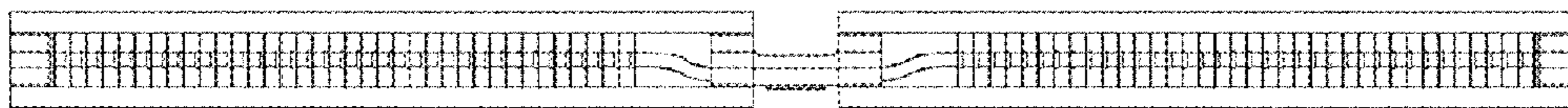

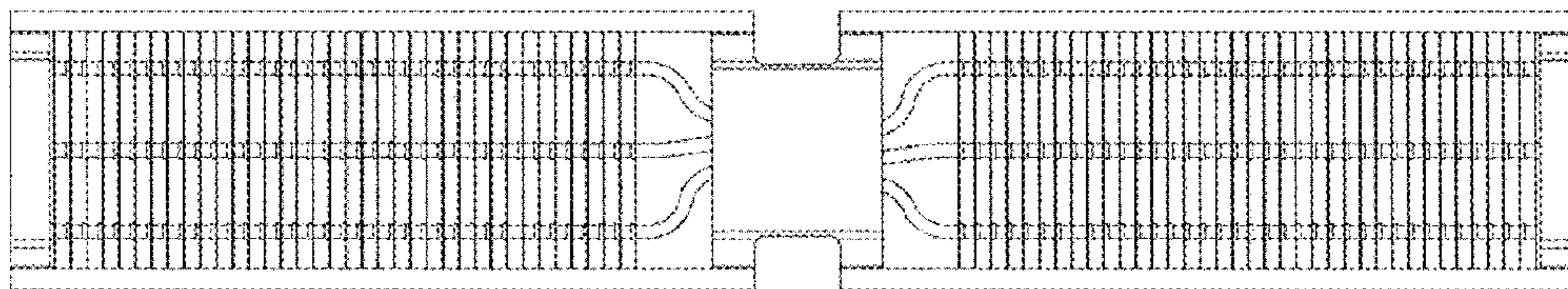

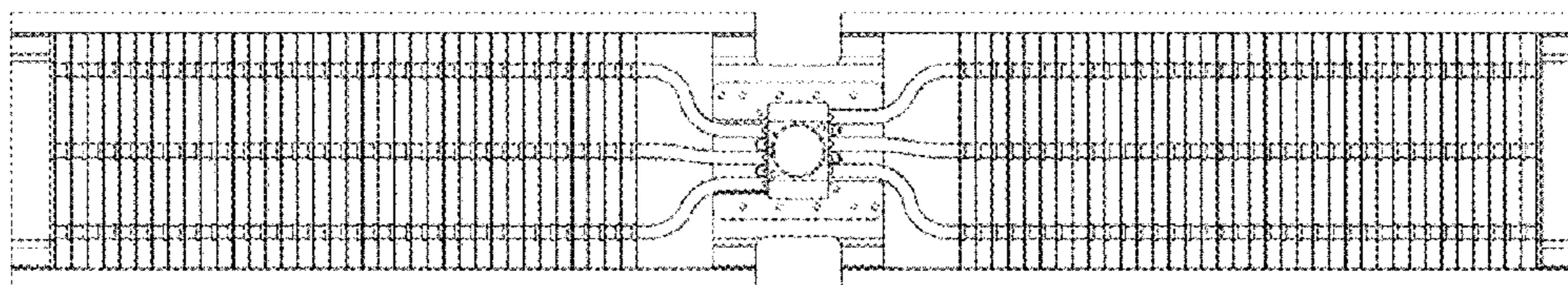
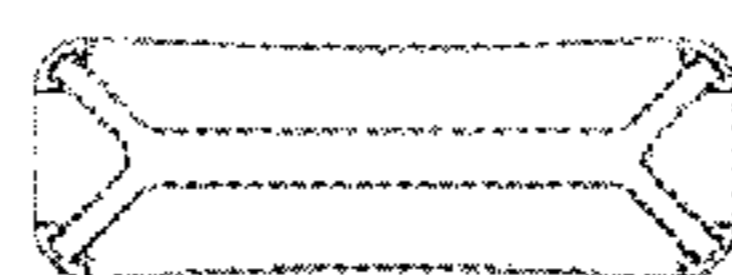
