(57) **CLAIM**

I claim the ornamental design for an outer shell of a helmet for a hockey or lacrosse player, as shown and described.

DESCRIPTION

FIG. 1 is a front side perspective view of an outer shell of a helmet for a hockey or lacrosse player according to the present design;

FIG. 2 is a rear side perspective view thereof;

FIG. 3 is a left side elevational view thereof;

FIG. 4 is a front elevational view thereof;

FIG. 5 is a rear elevational view thereof; and,

FIG. 6 is a top plan view thereof.

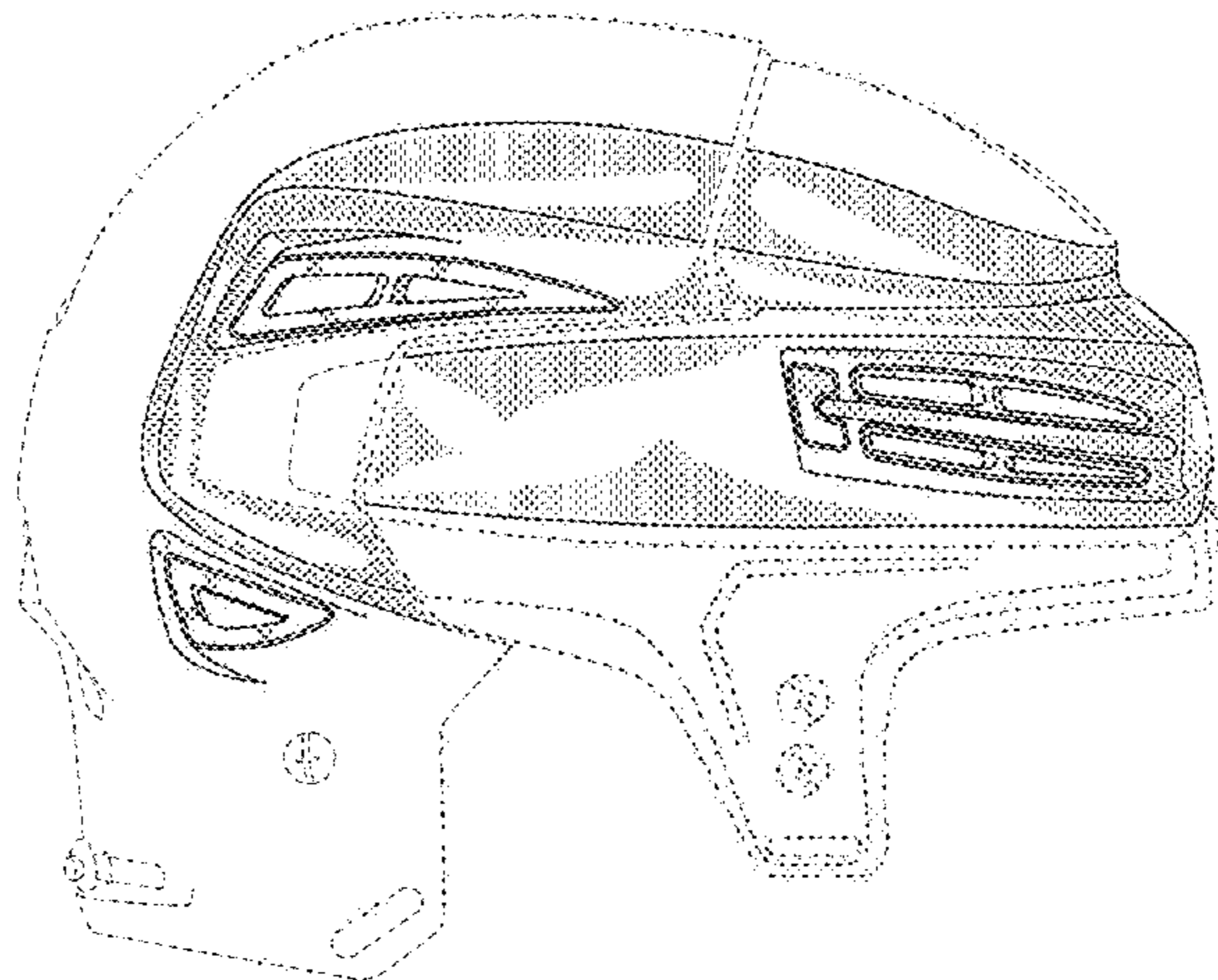
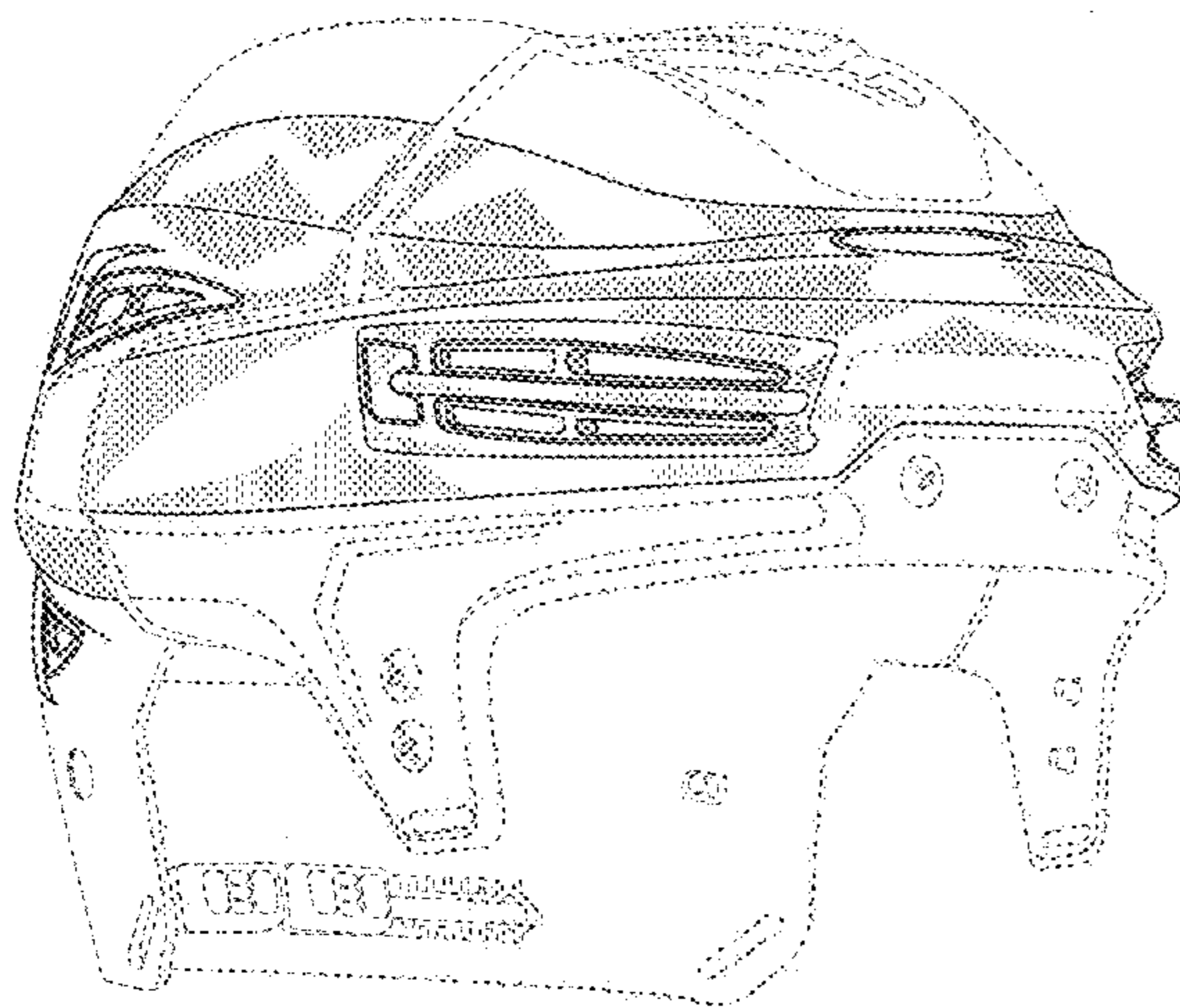
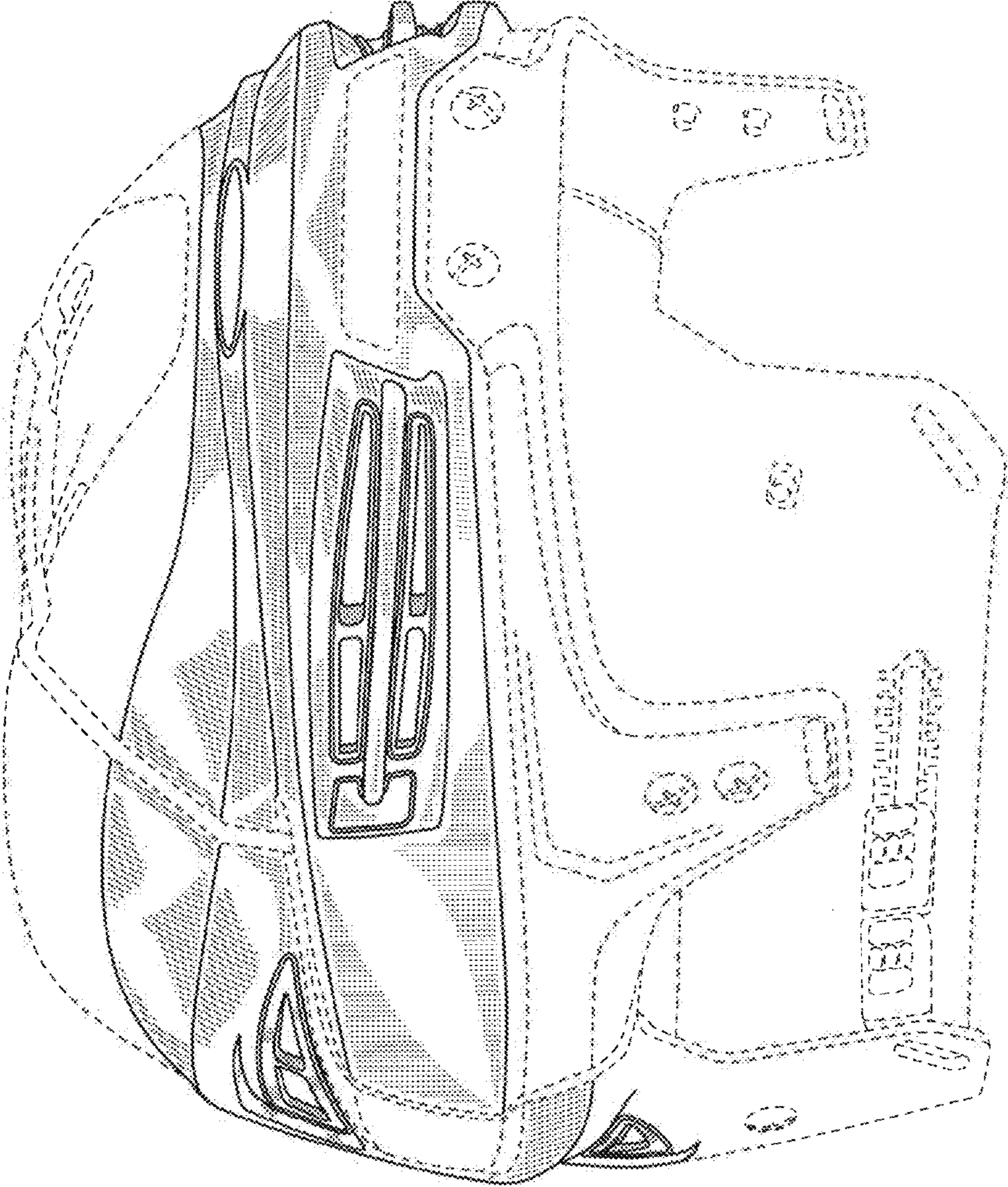

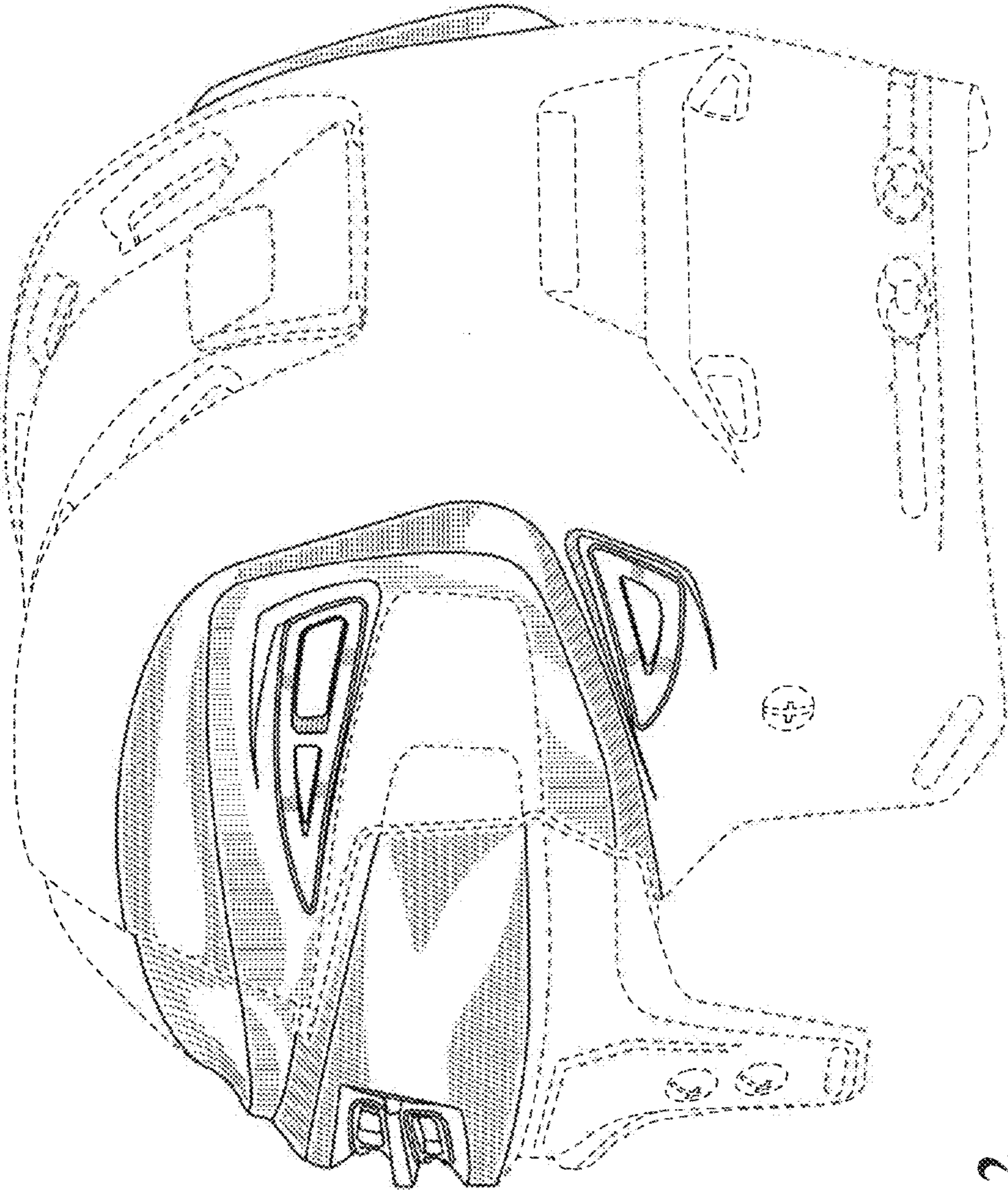

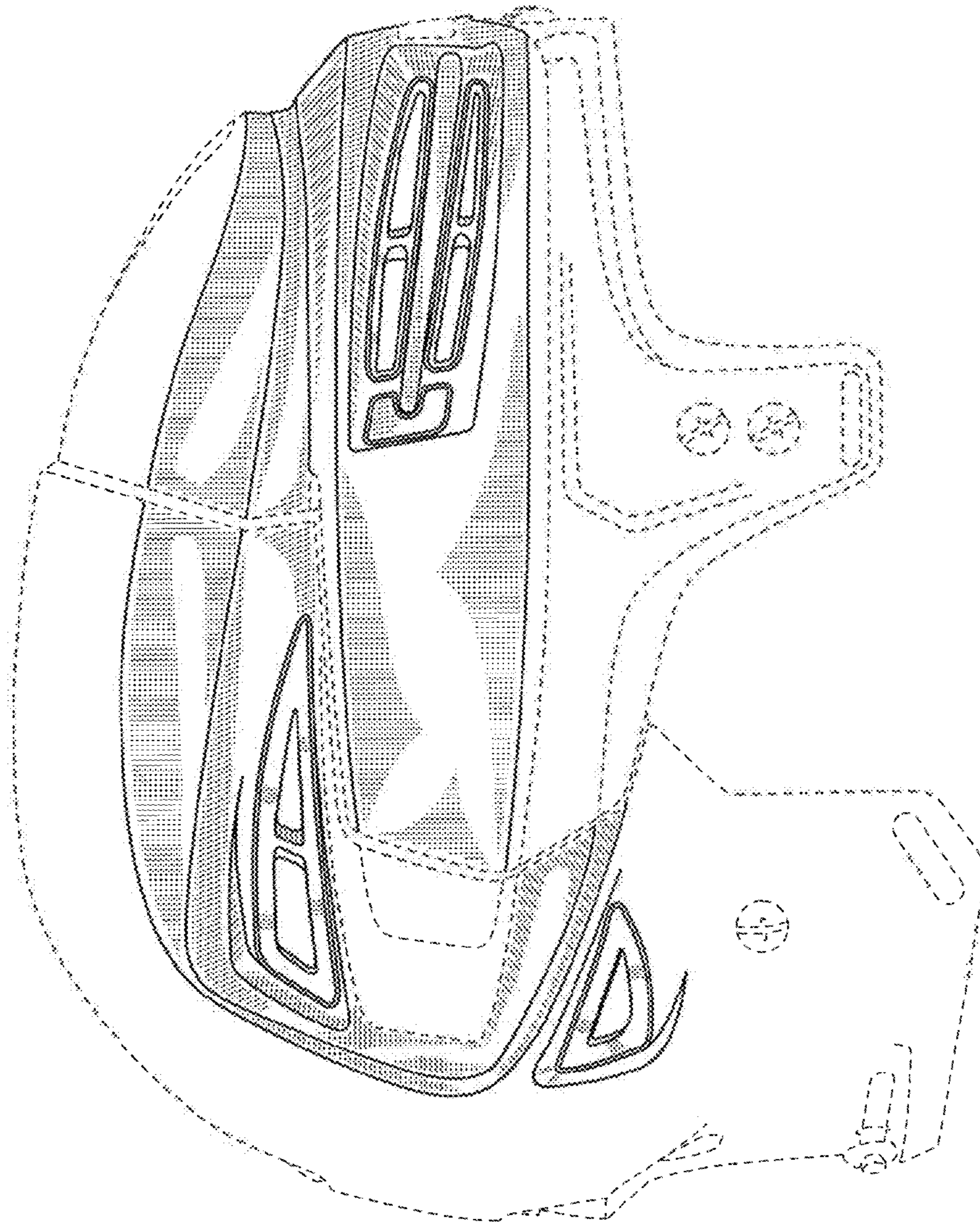

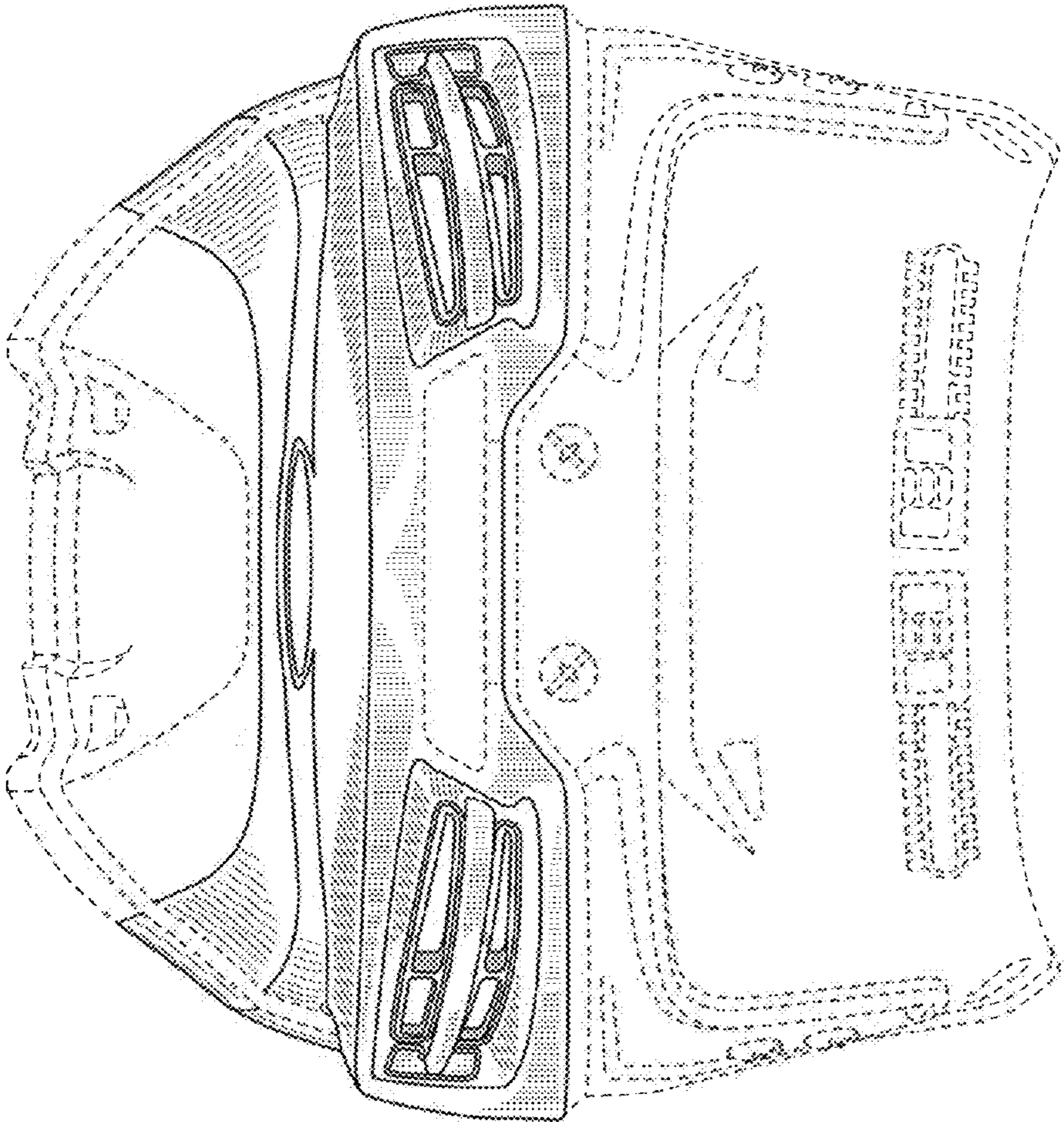

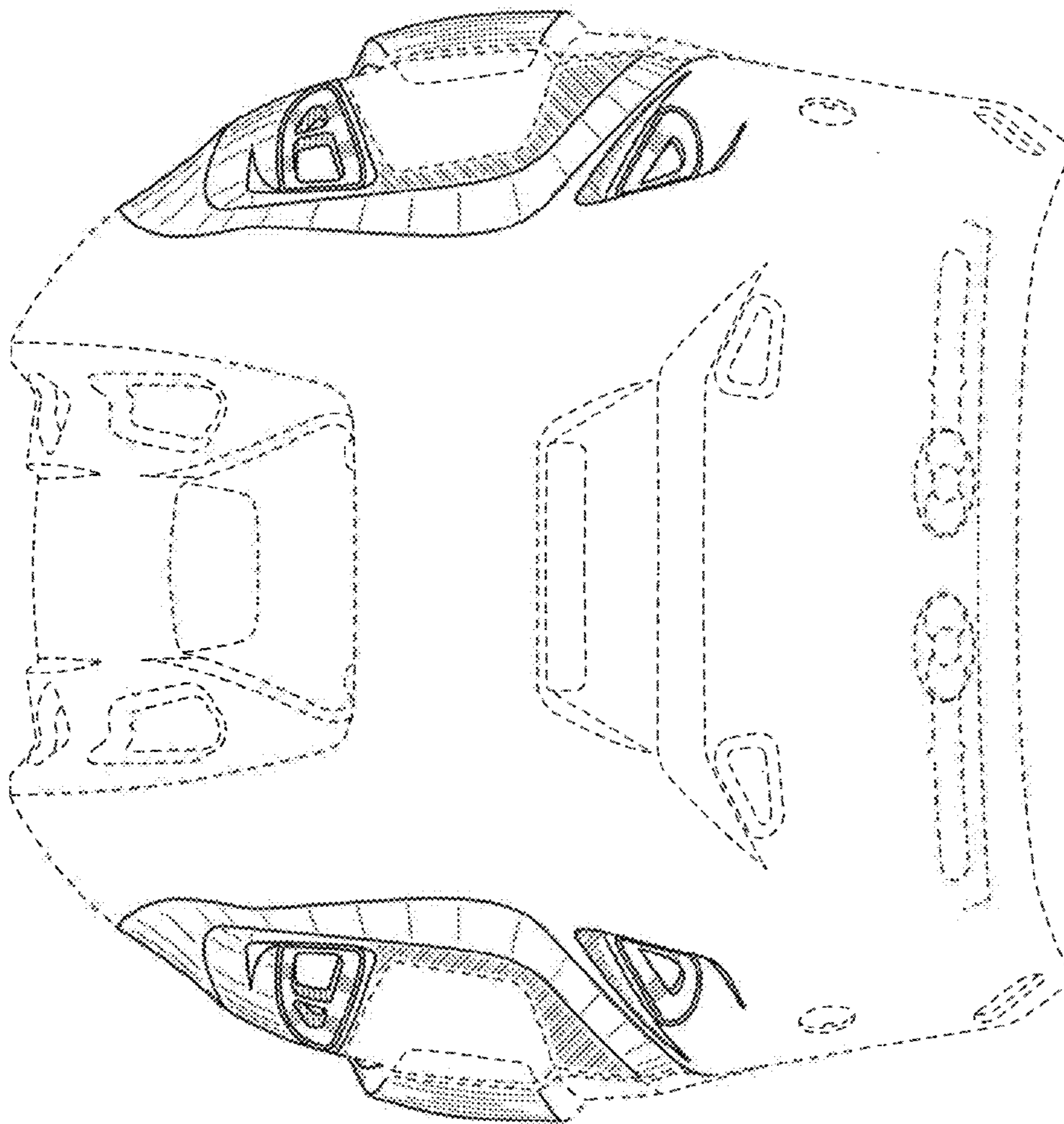

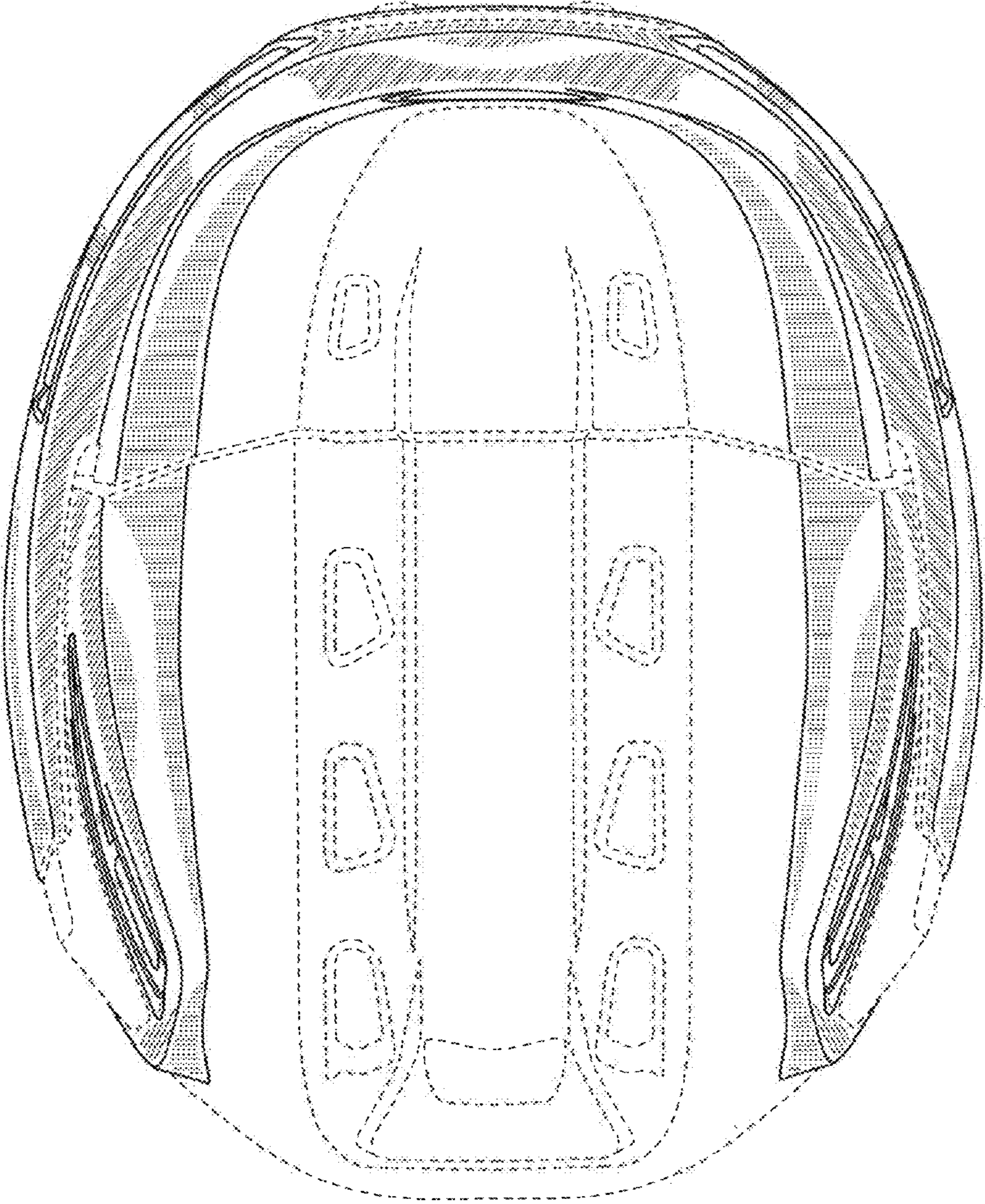
