**DESCRIPTION**

FIG. 6 is a bottom view thereof;

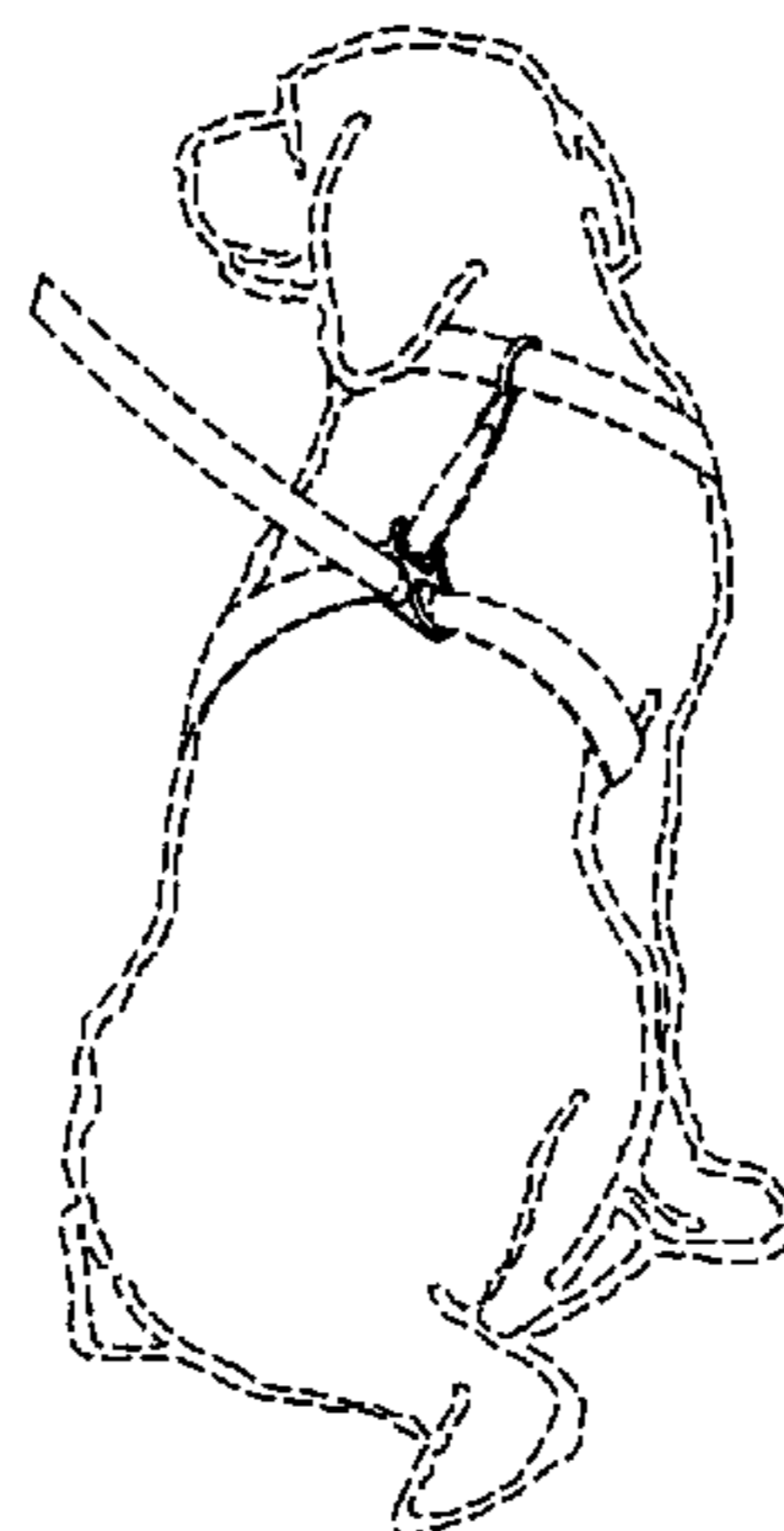
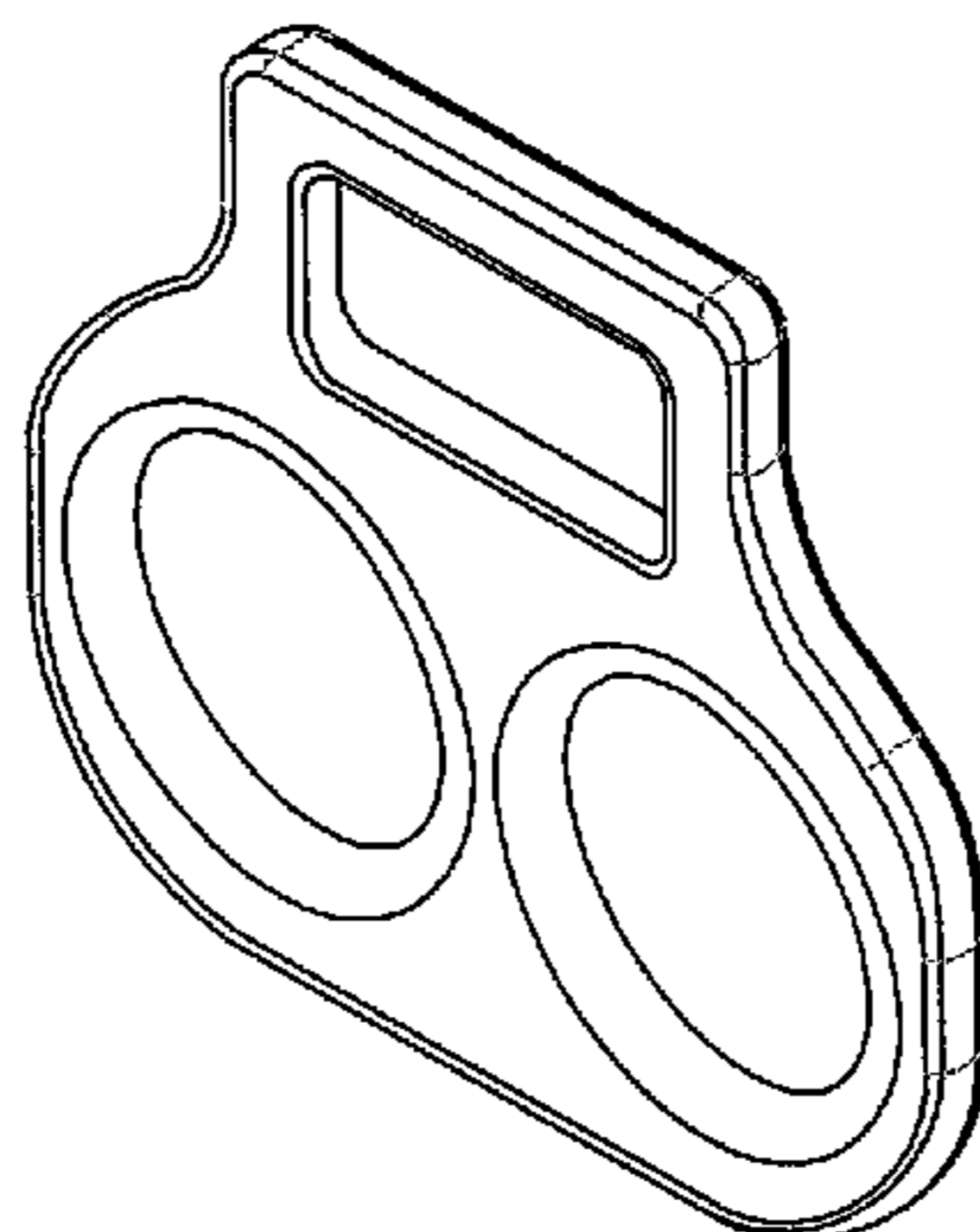
FIG. 7 is a perspective view thereof, shown in a condition of use;

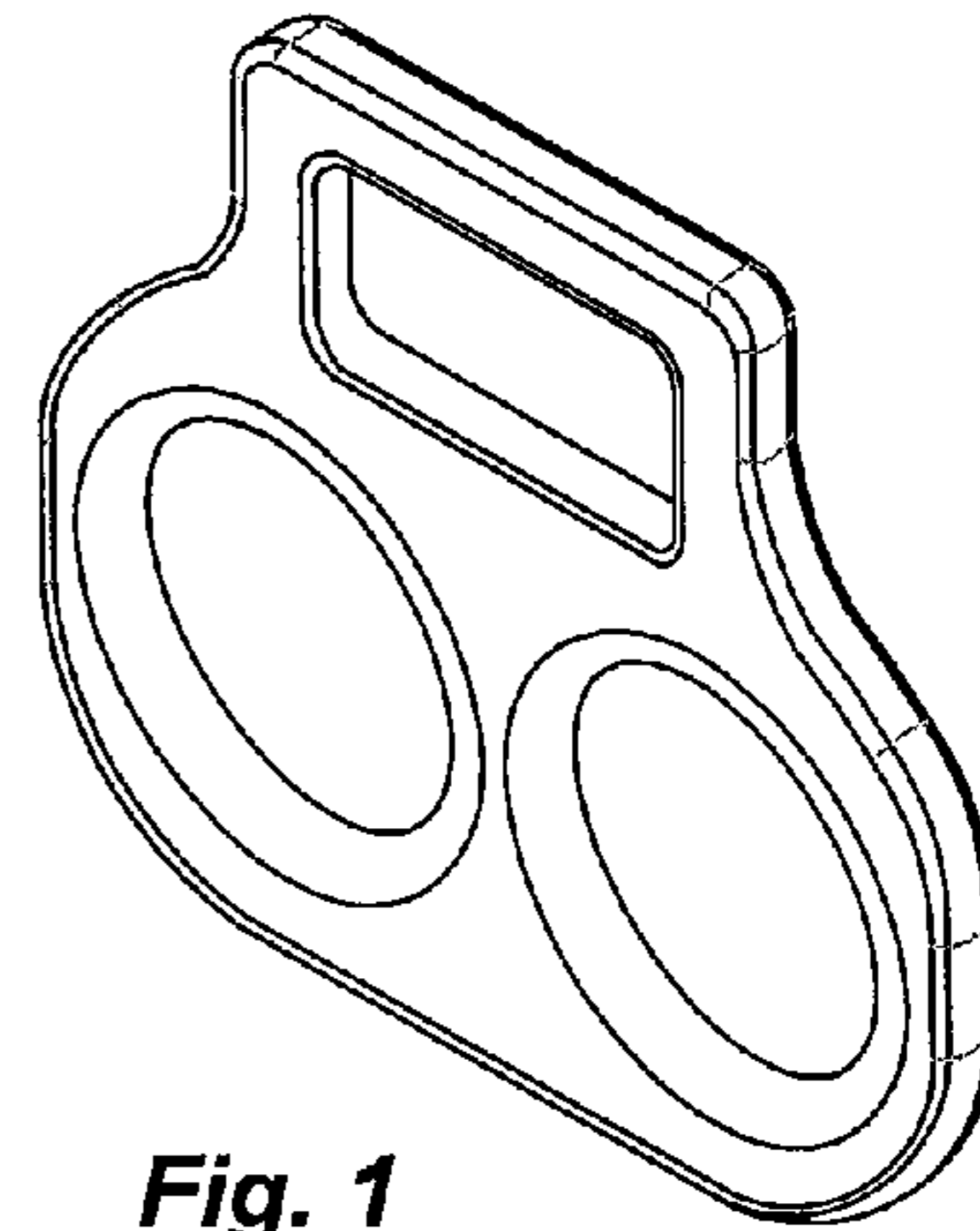
FIG. 8 is a perspective view thereof, shown in a second condition of use; and,

FIG. 9 is a perspective view thereof, illustrated with a collar and a further extension and shown in a third condition of use.

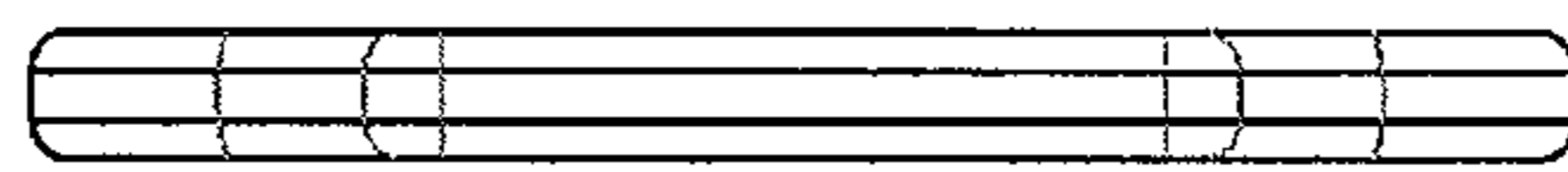
The portions of the dog harness illustrated in broken lines form no part of the claimed subject matter.

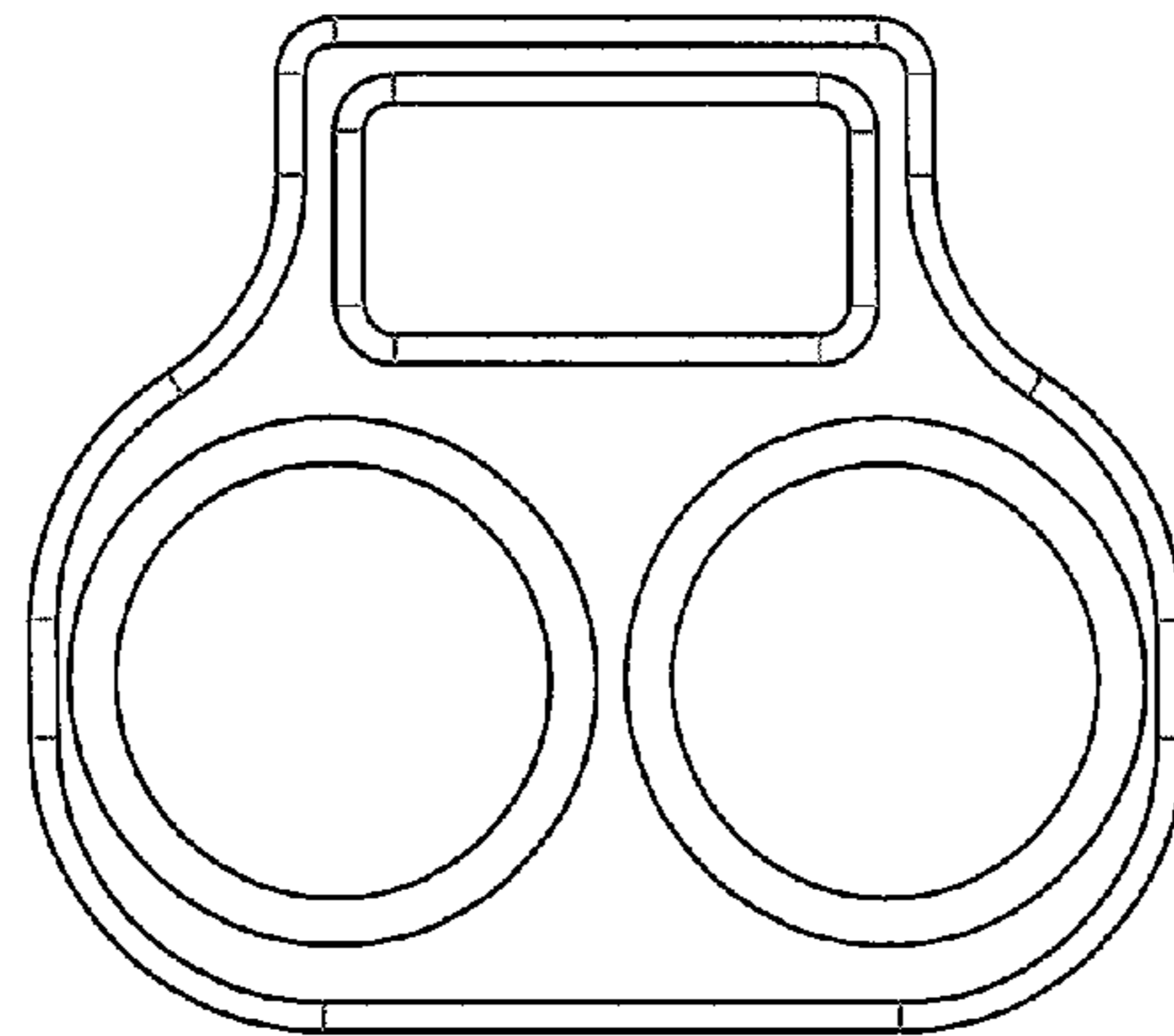

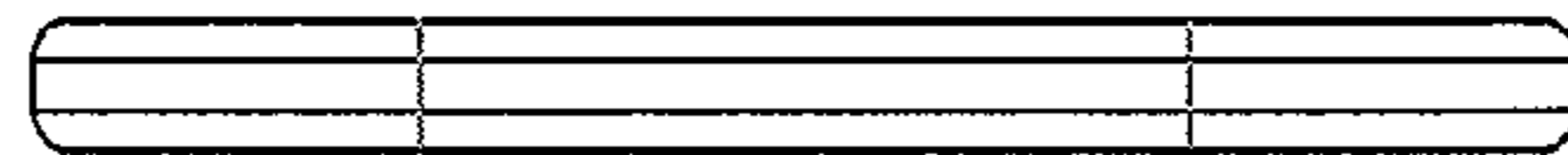

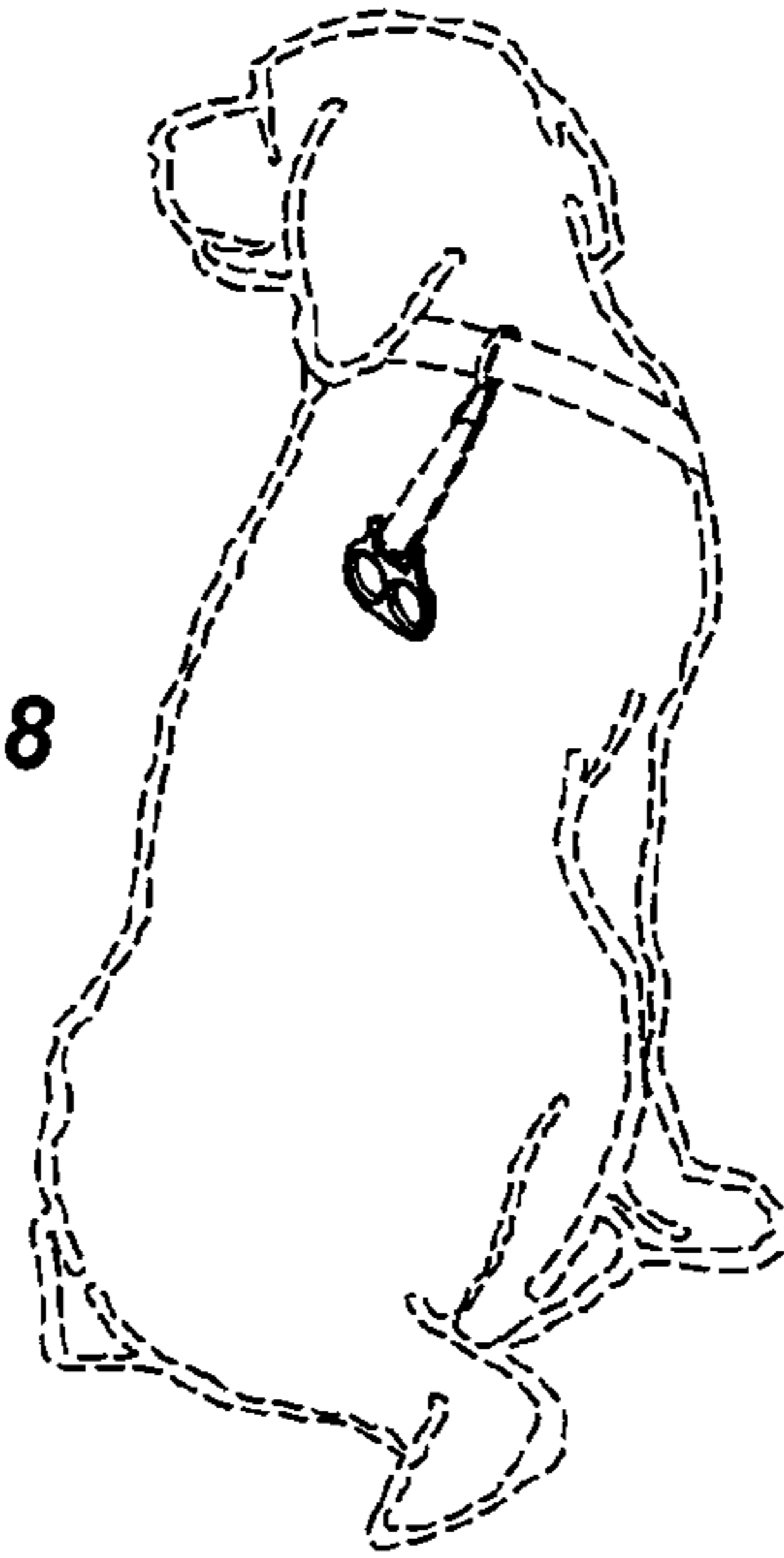

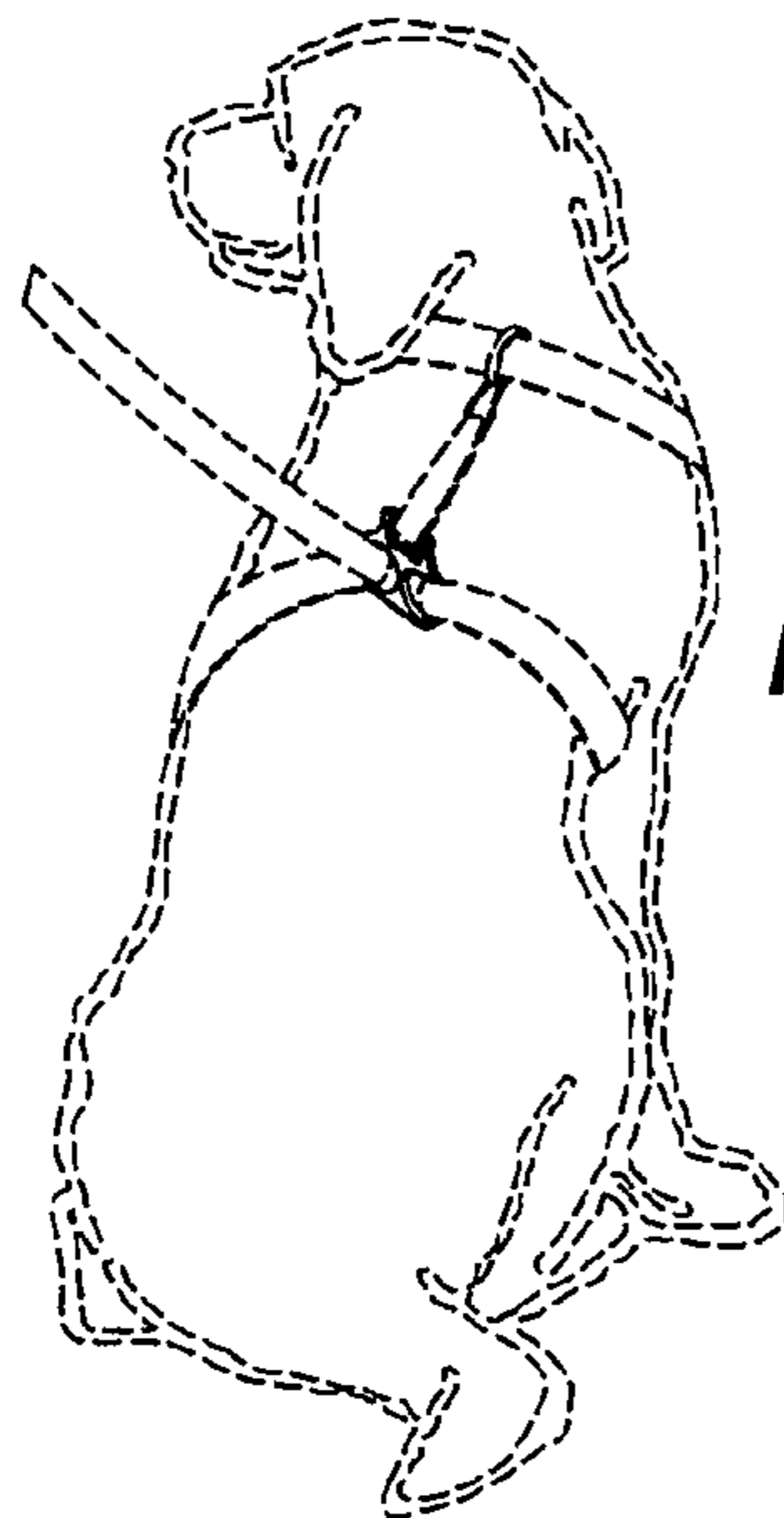
