**DESCRIPTION**

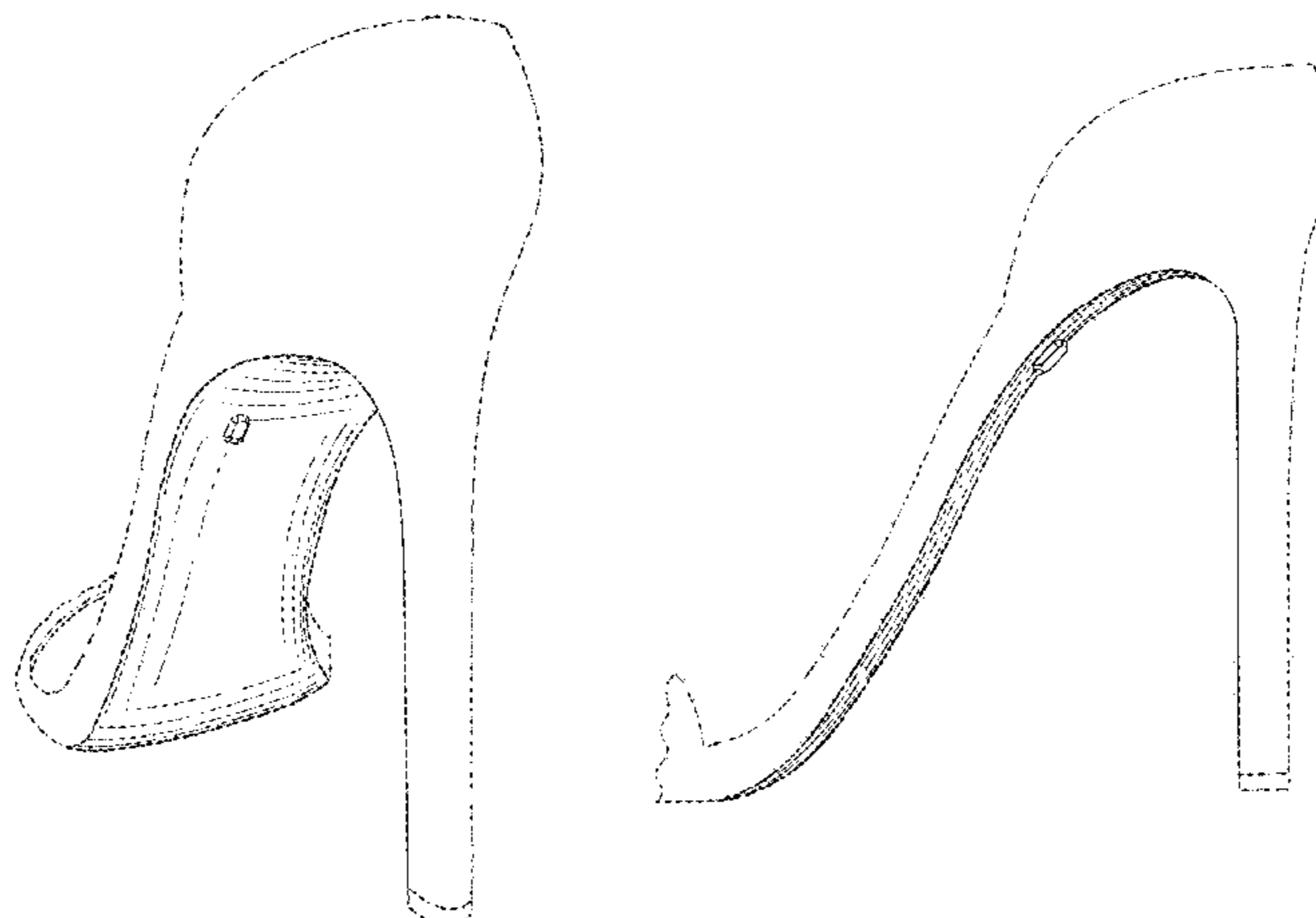
FIGS. 1-4 show an embodiment of a sole of a left woman's shoe showing my design;

 FIG. 2 is a side perspective view of the embodiment thereof taken from the outside and below the center line;  
 FIG. 3 is a rear plan view of the embodiment thereof;  
 FIG. 4 is a bottom plan view of the embodiment thereof;  
 FIGS. 5-8 show an embodiment of a sole of a right woman's shoe showing my design;  
 FIG. 5 is an outside rear perspective view of the embodiment of the sole of a woman's shoe;  
 FIG. 6 is a side perspective view of the embodiment thereof taken from the outside and below the center line;  
 FIG. 7 is a rear plan view of the embodiment thereof; and,  
 FIG. 8 is a bottom plan view of the embodiment thereof.

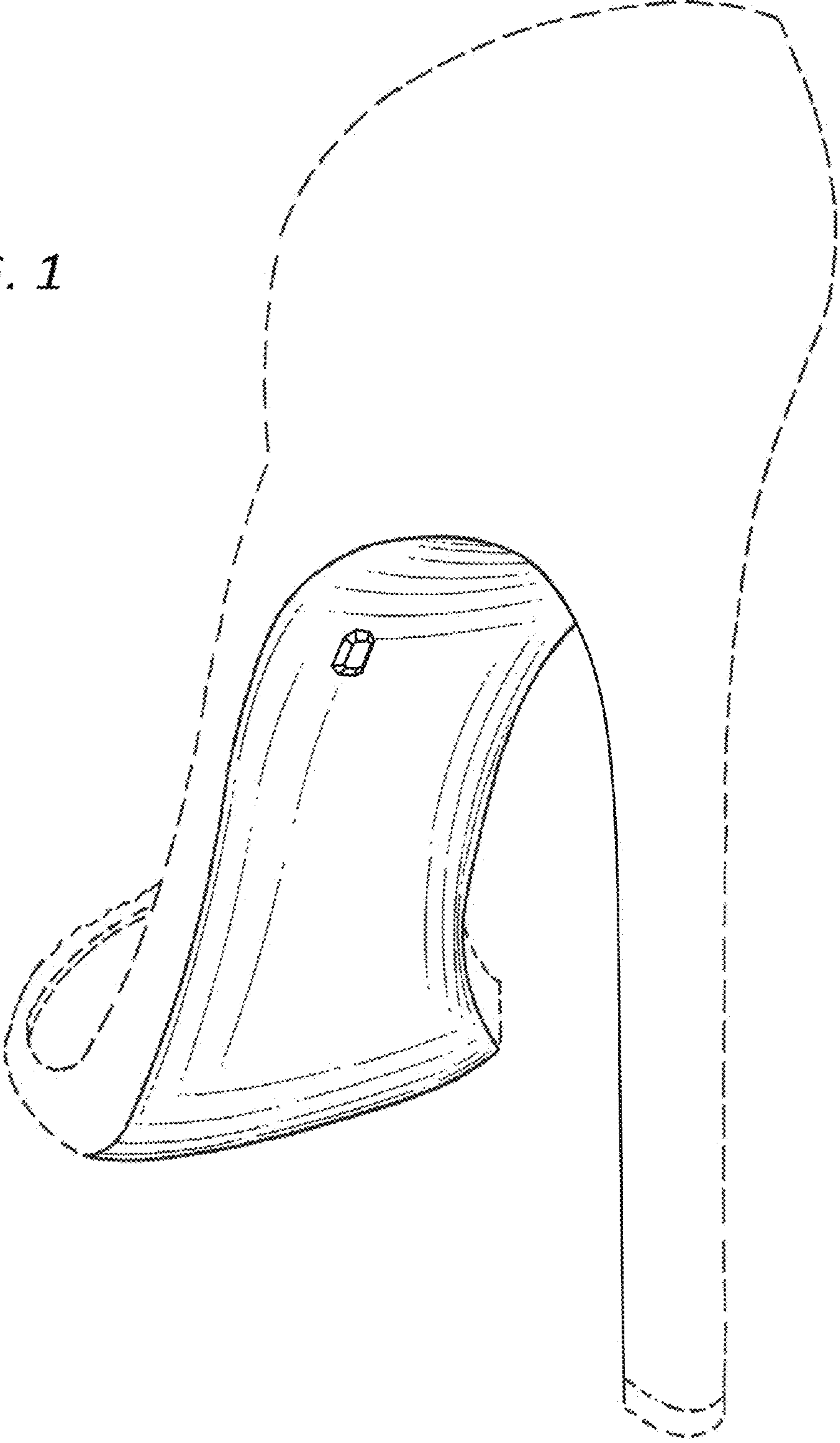
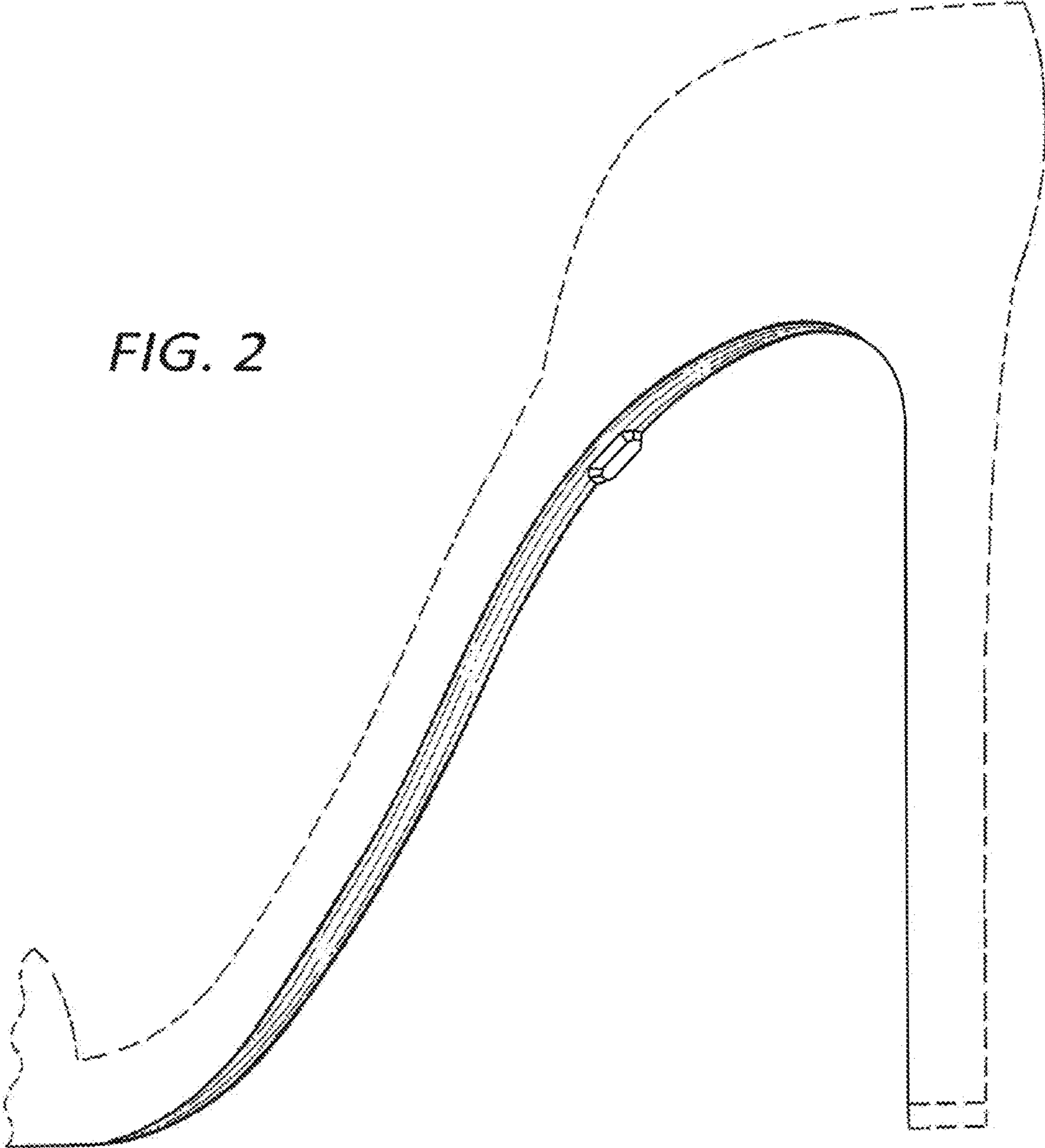

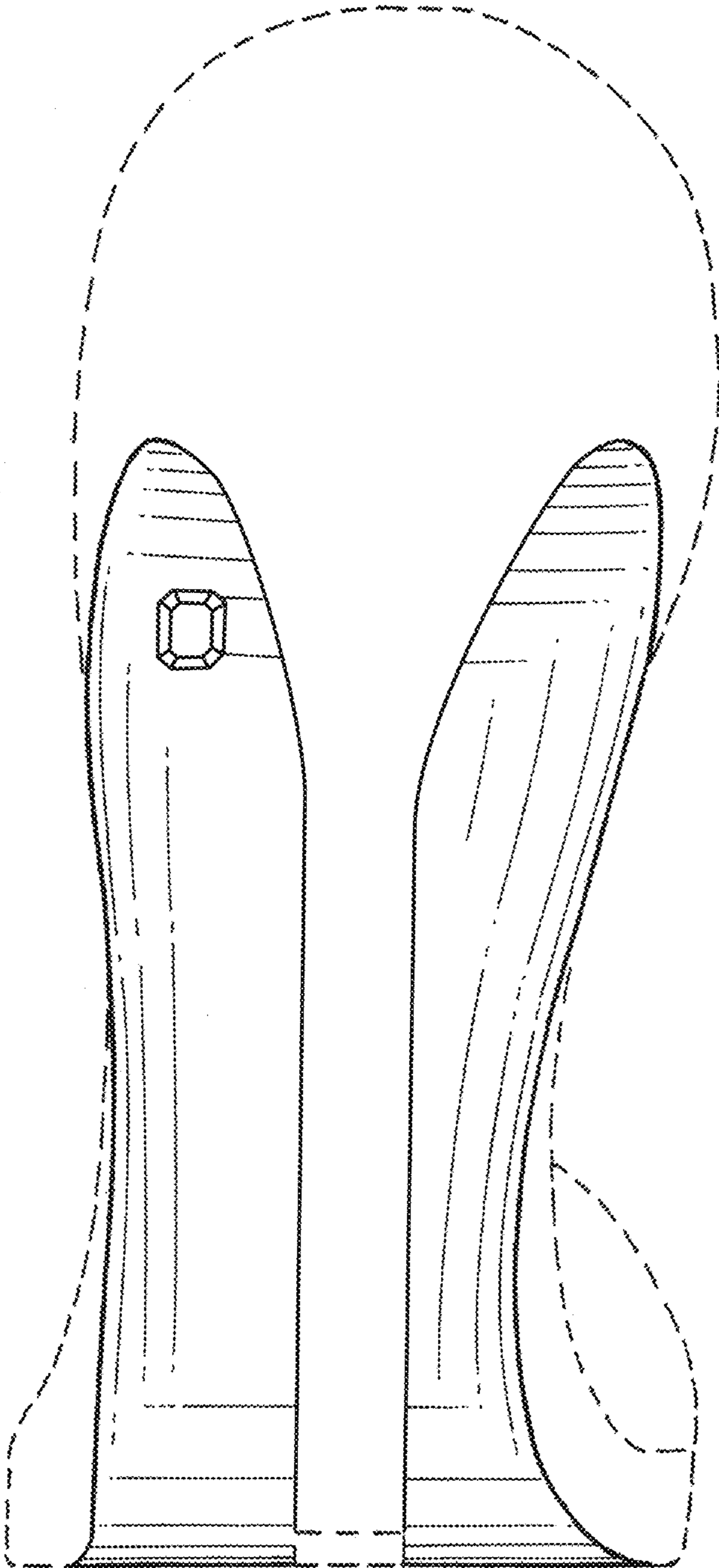

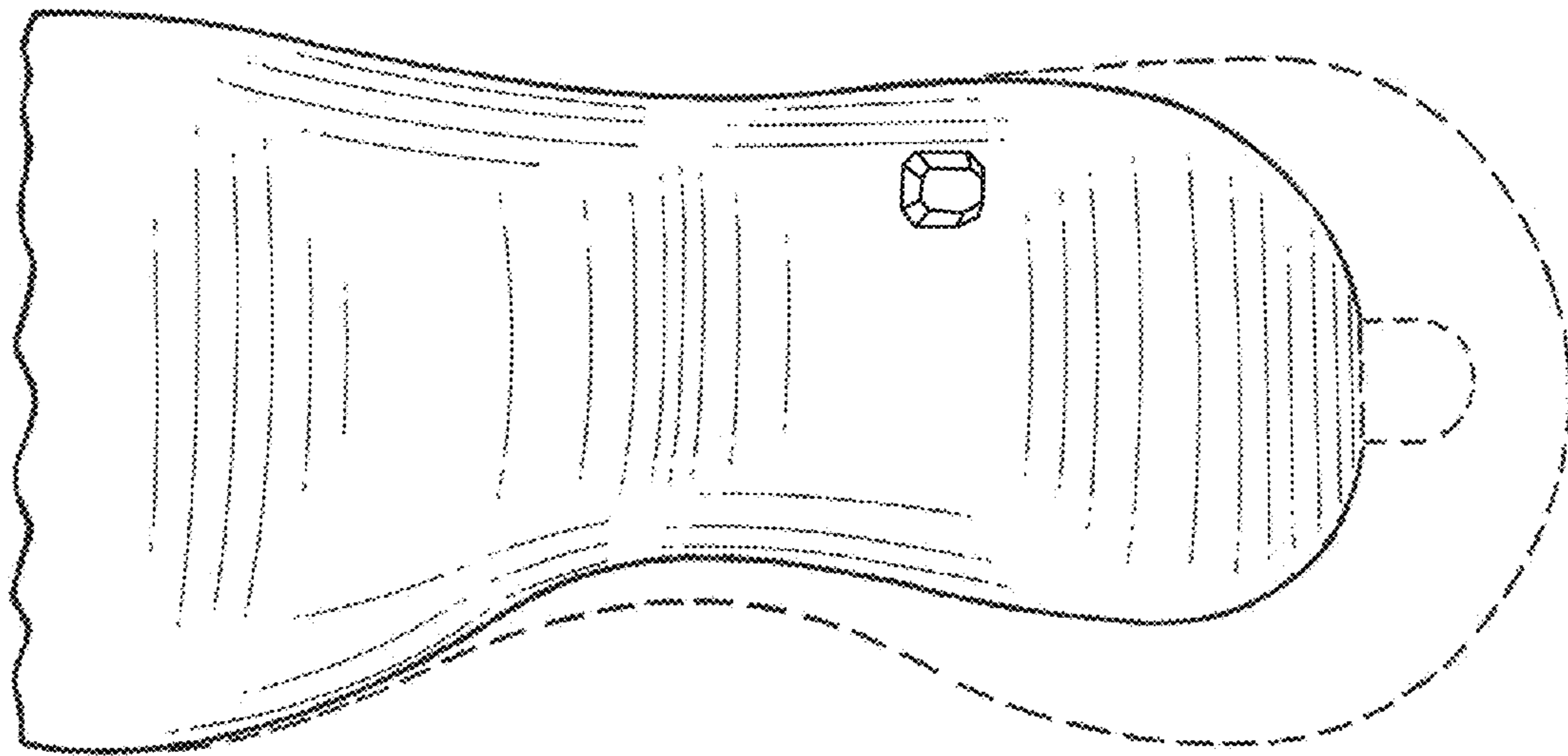

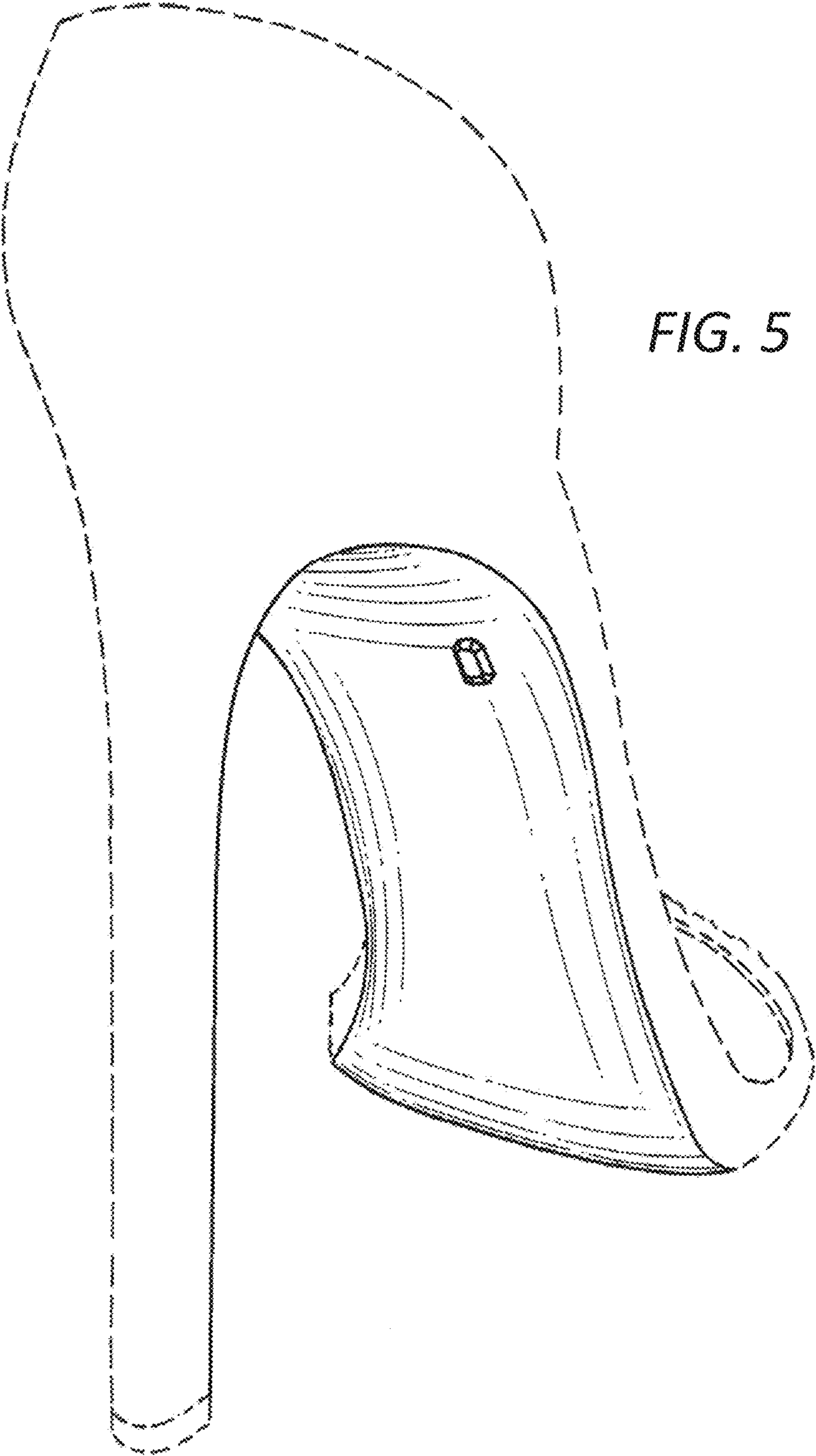

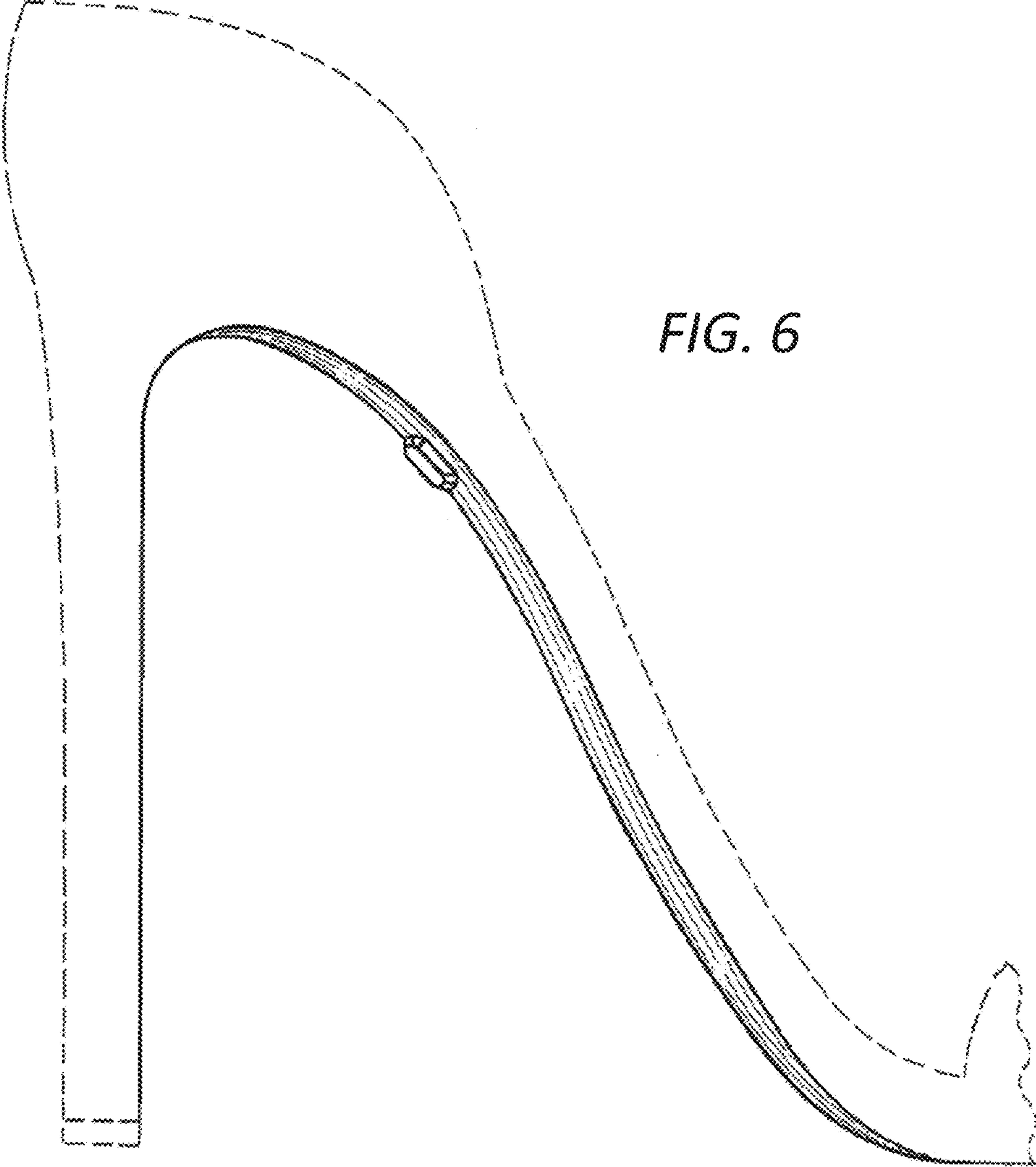
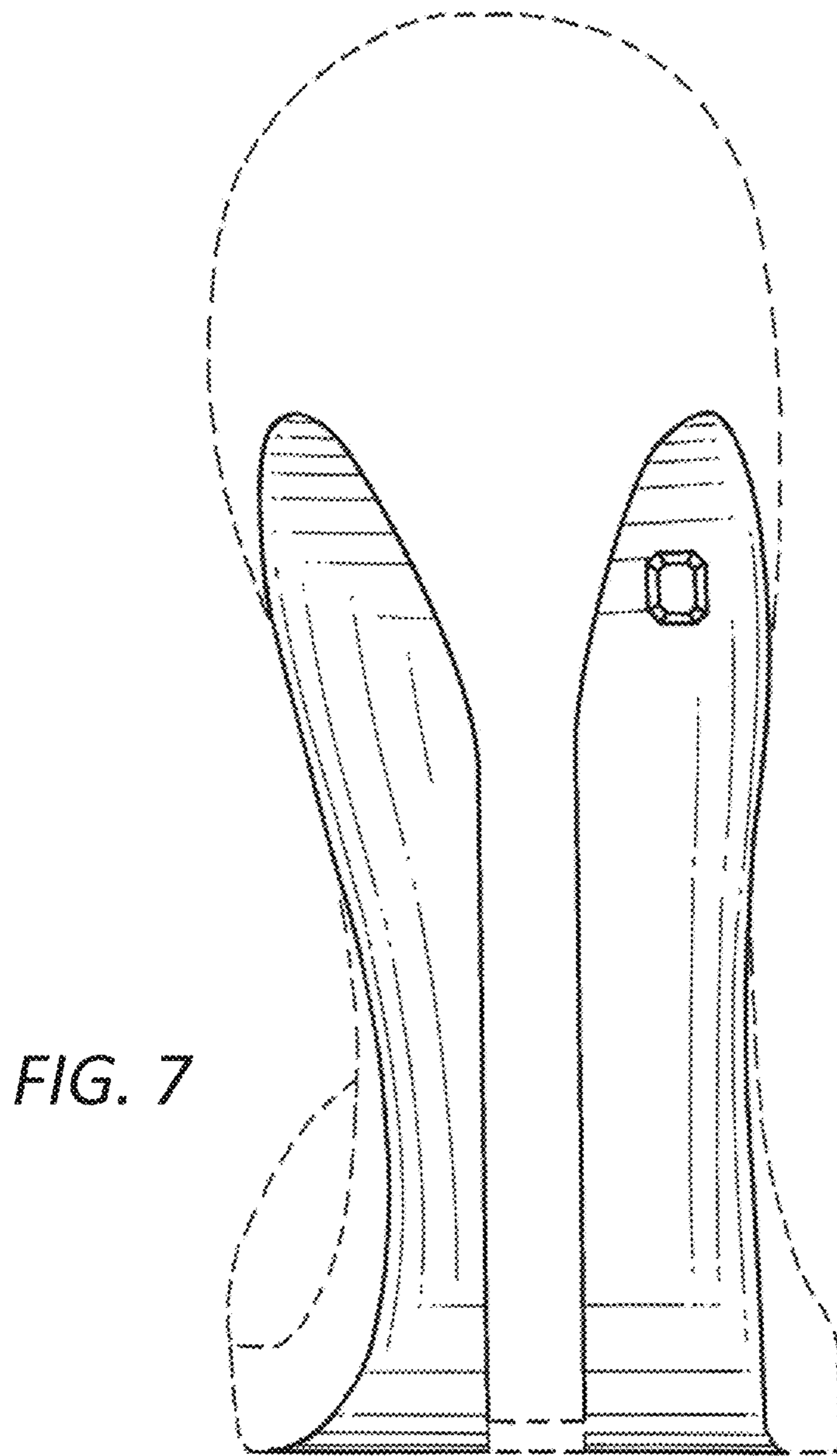

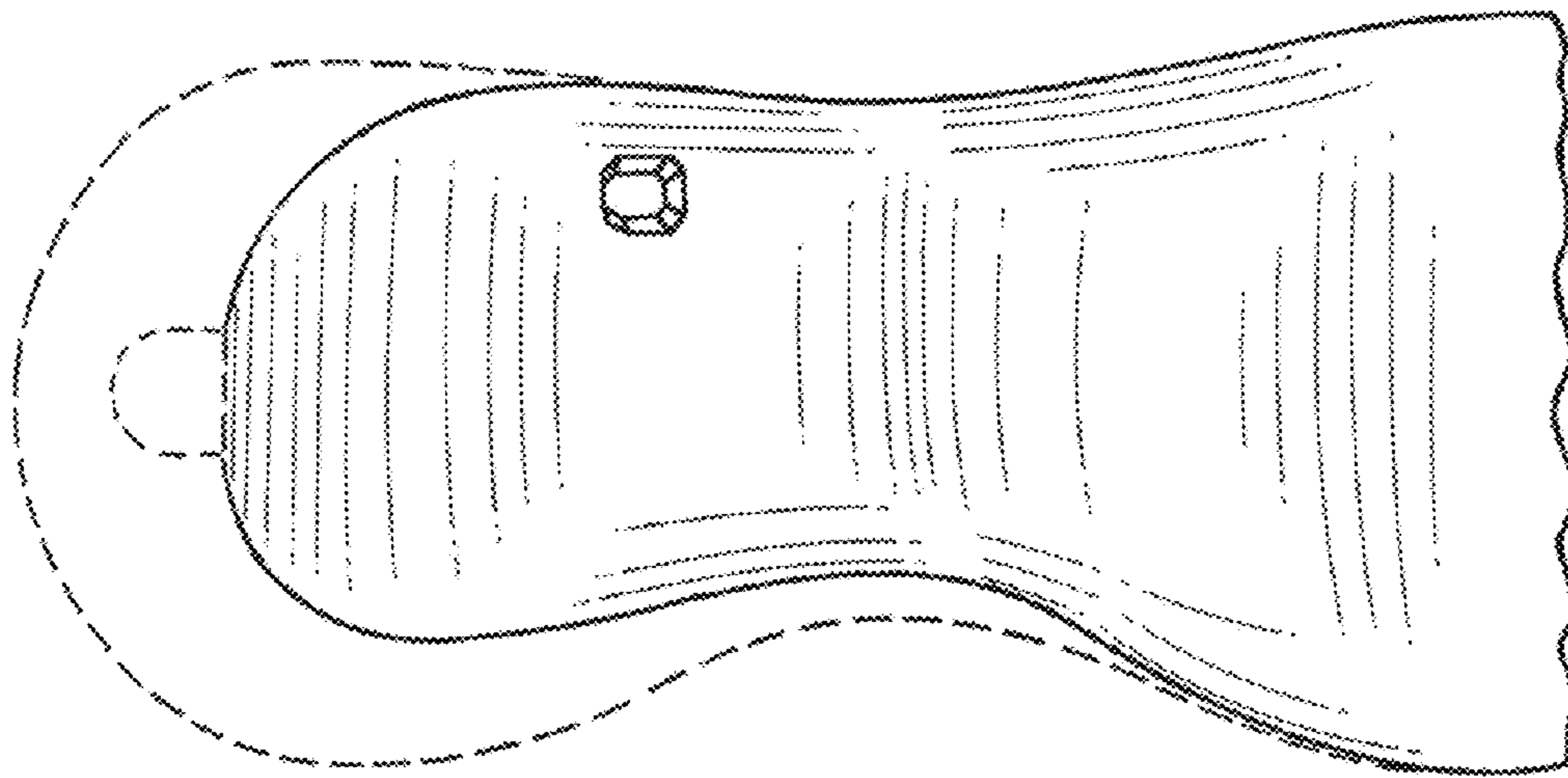
