(57) **CLAIM**

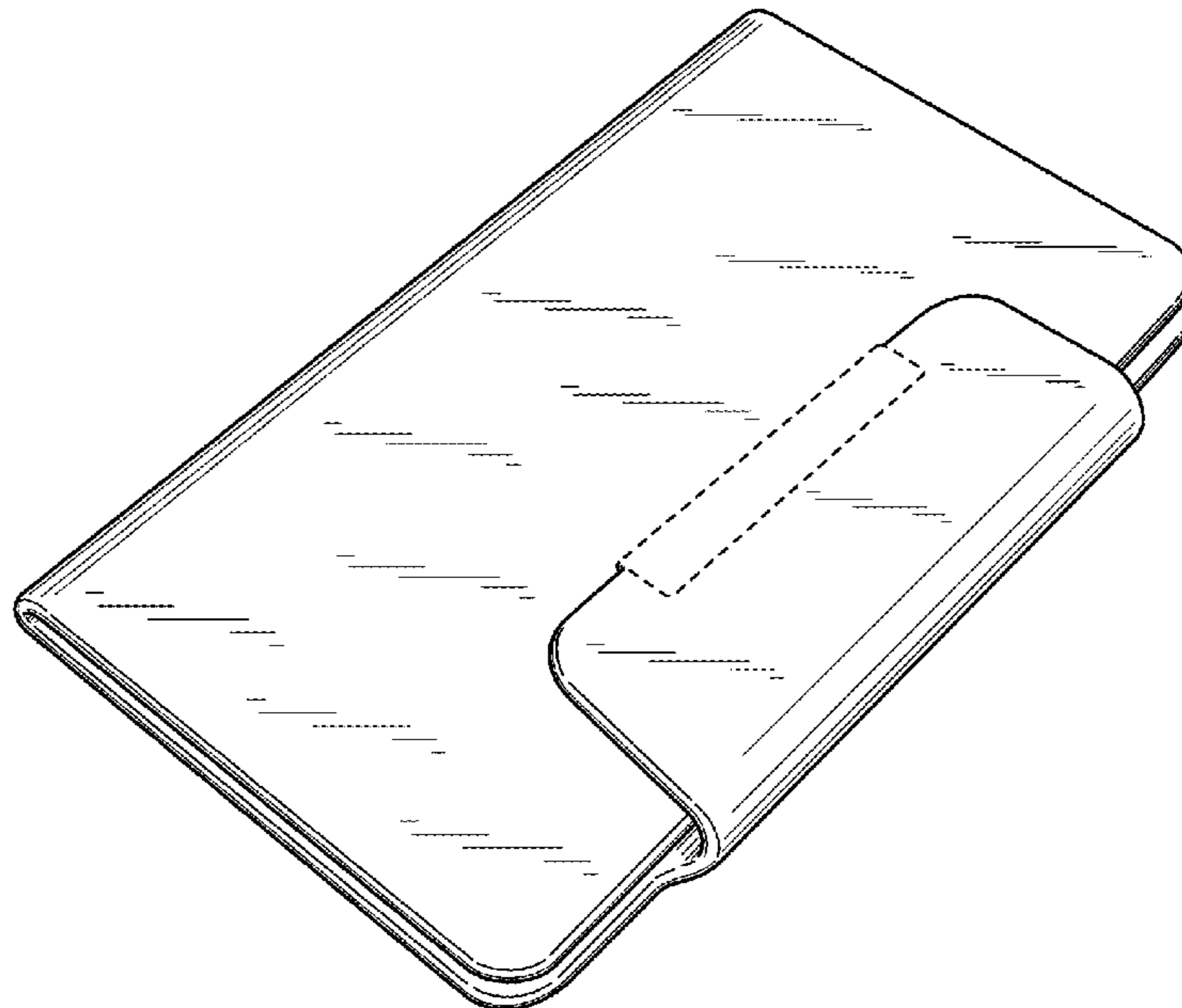
The ornamental design for a wallet, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a wallet showing our new design;

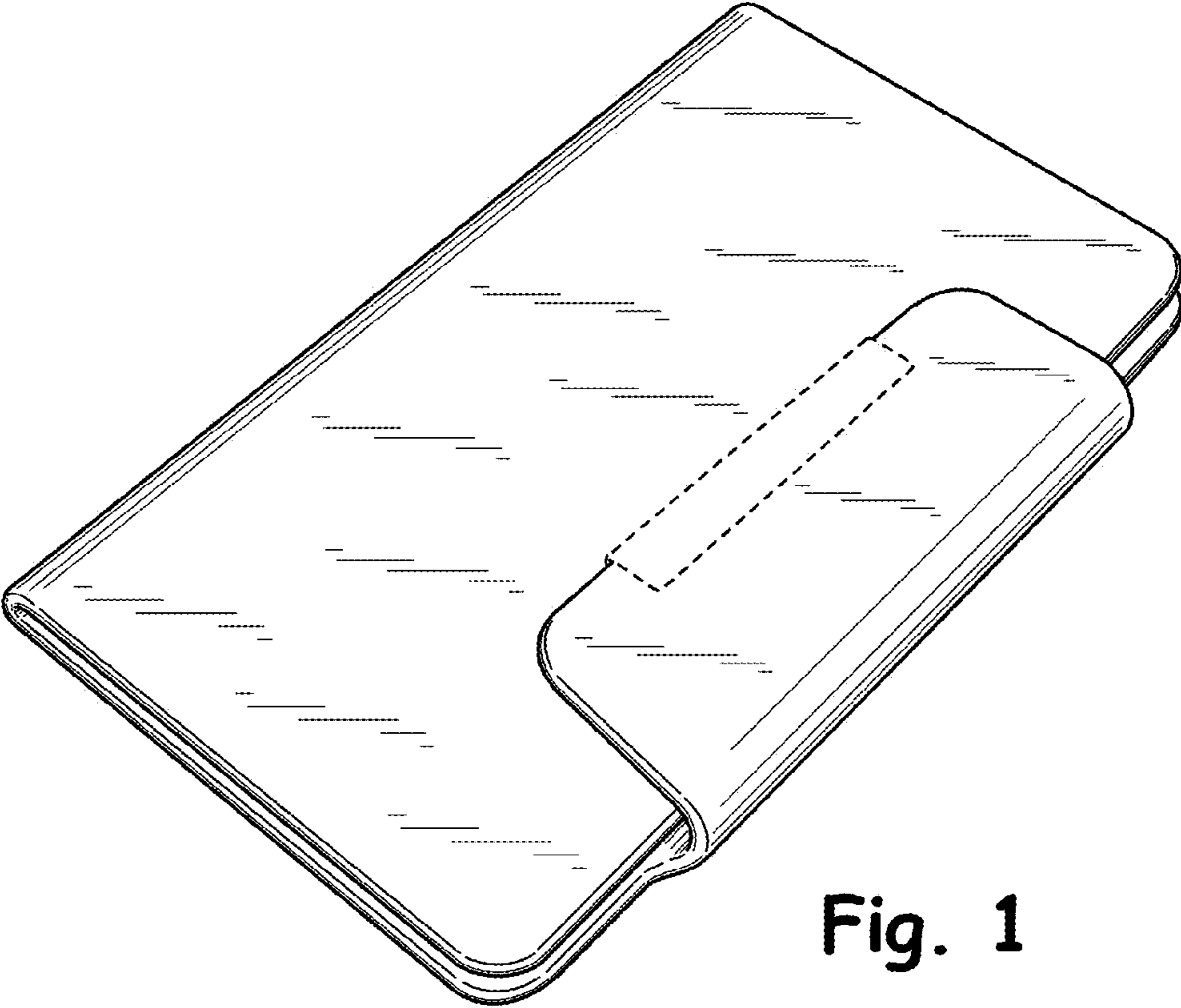

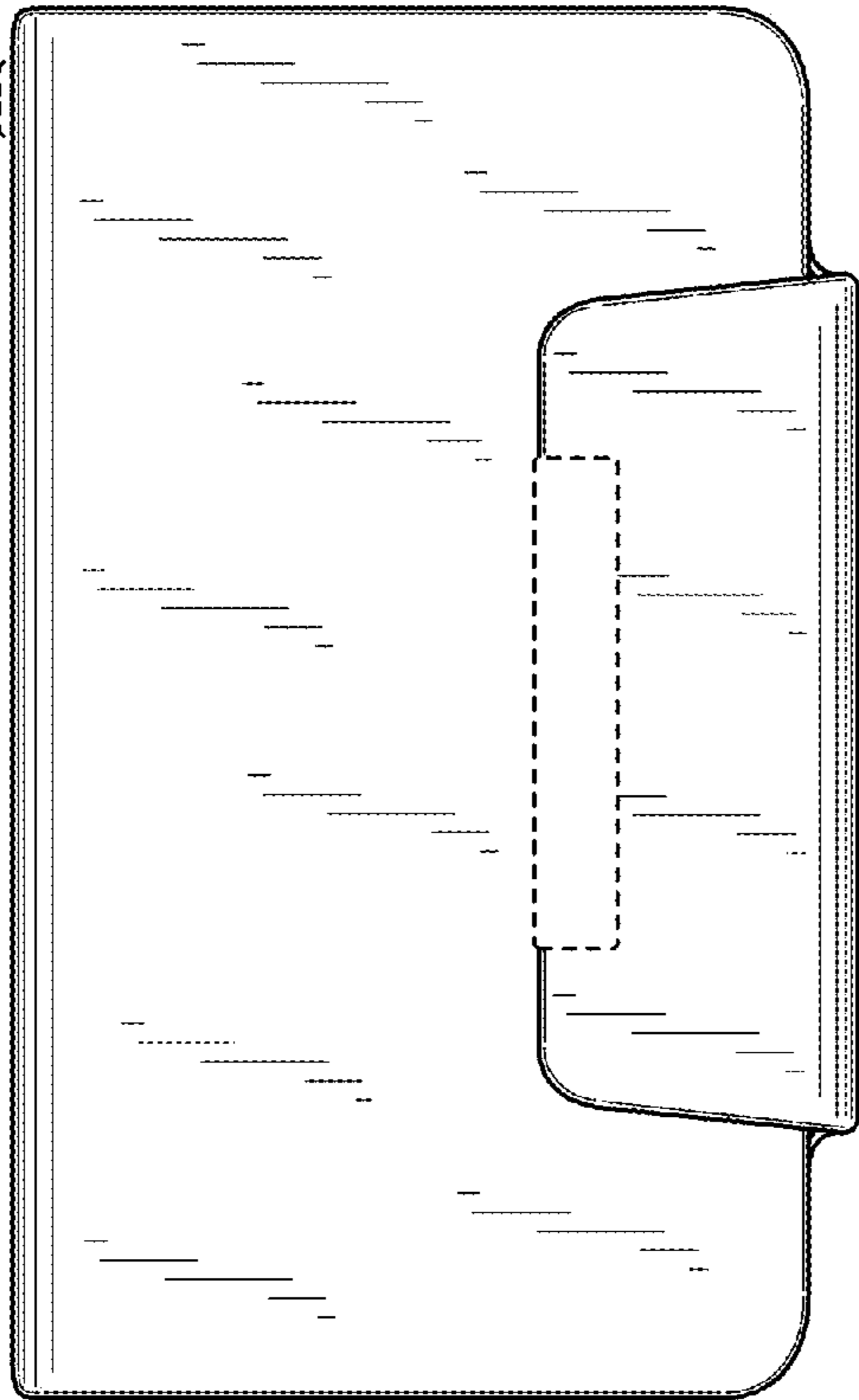

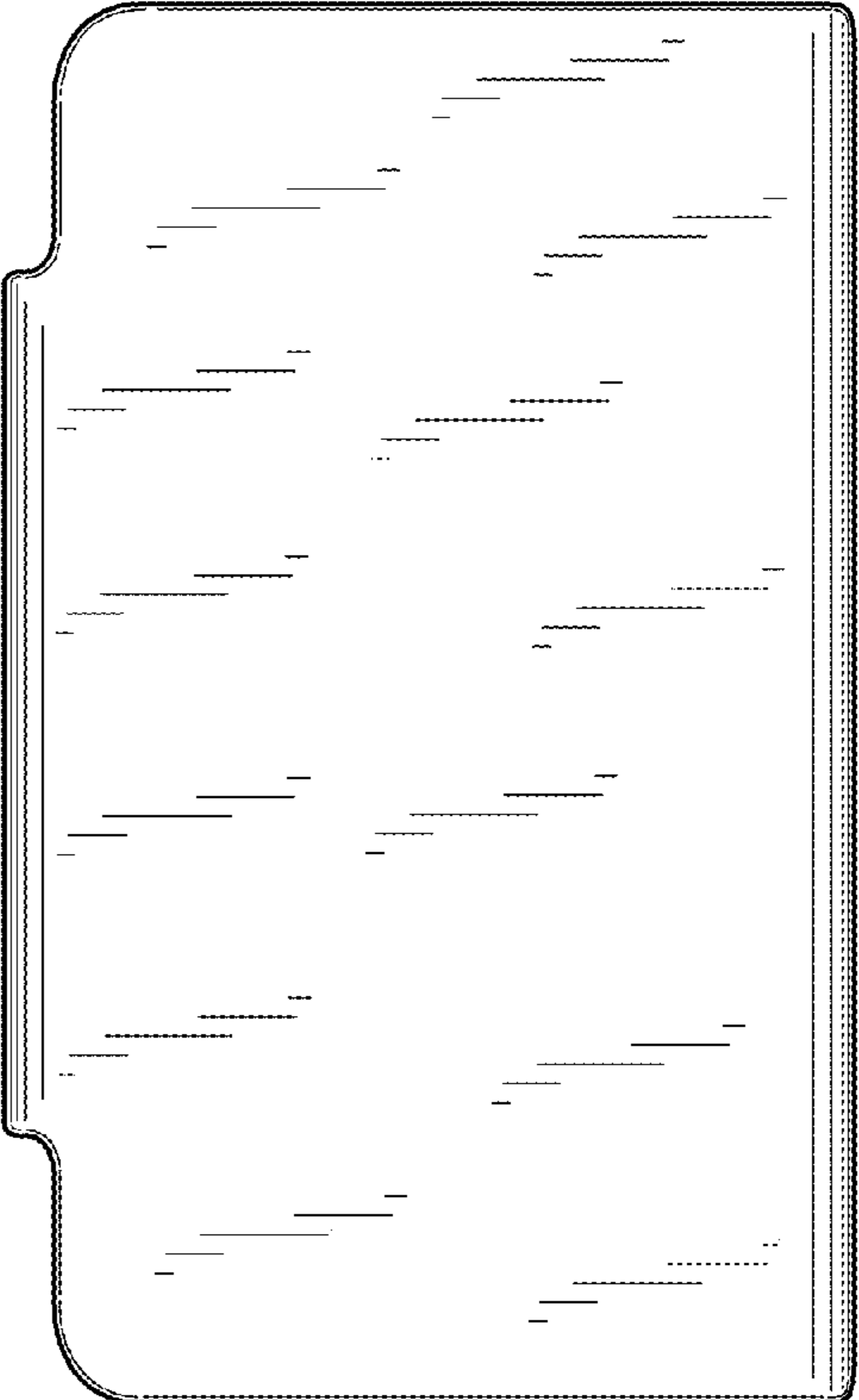

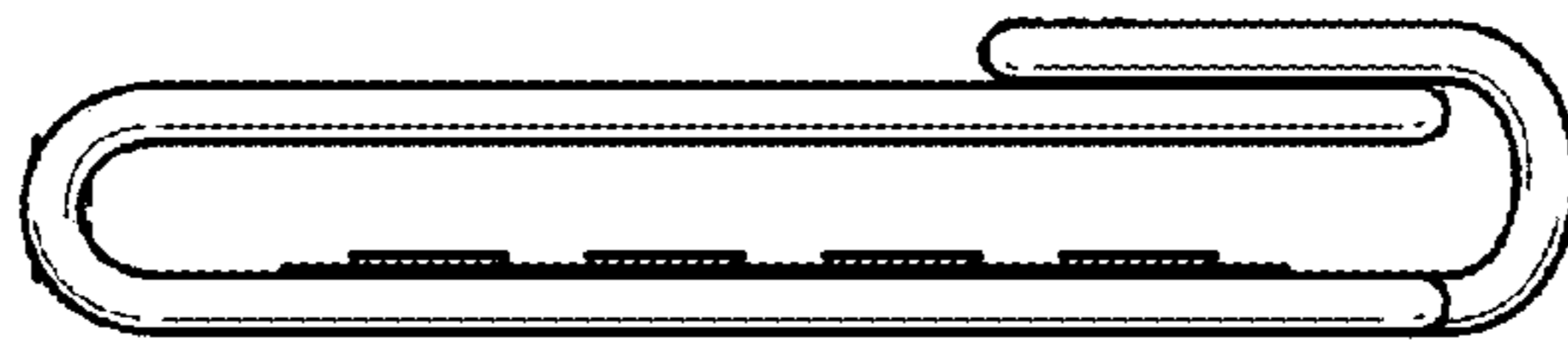

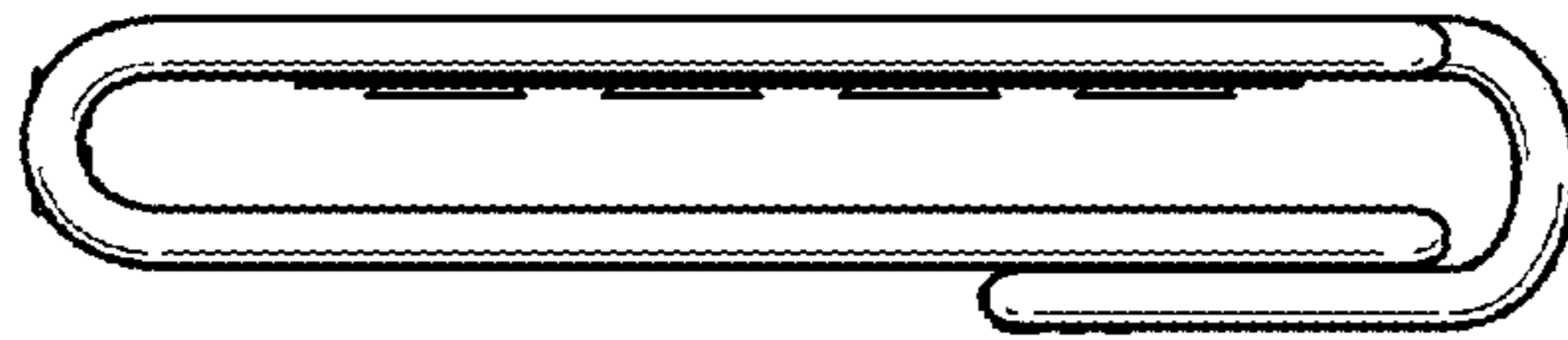

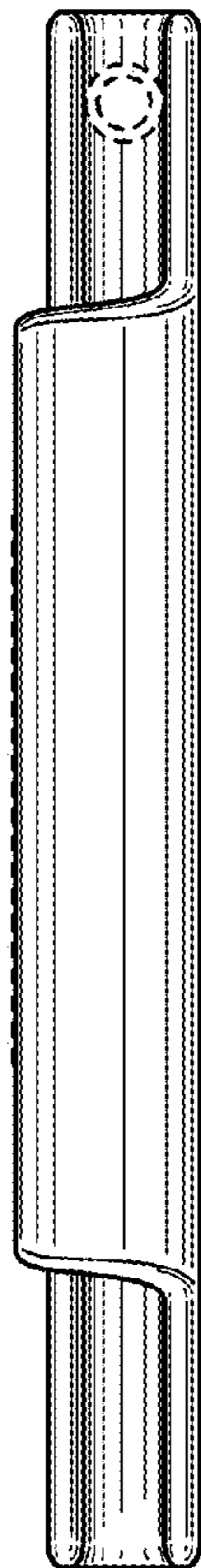

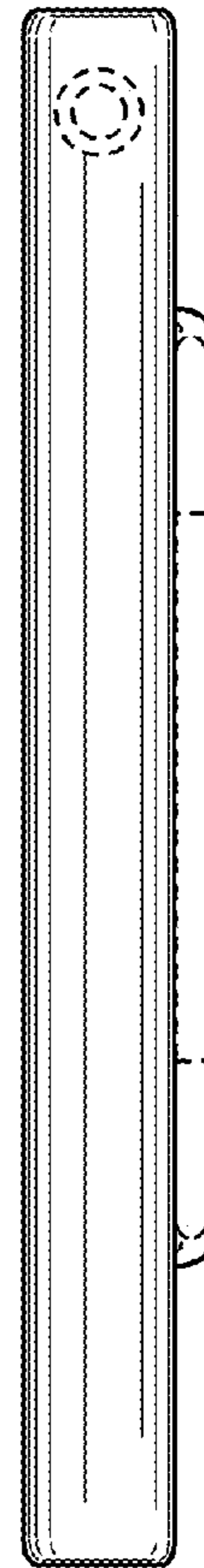

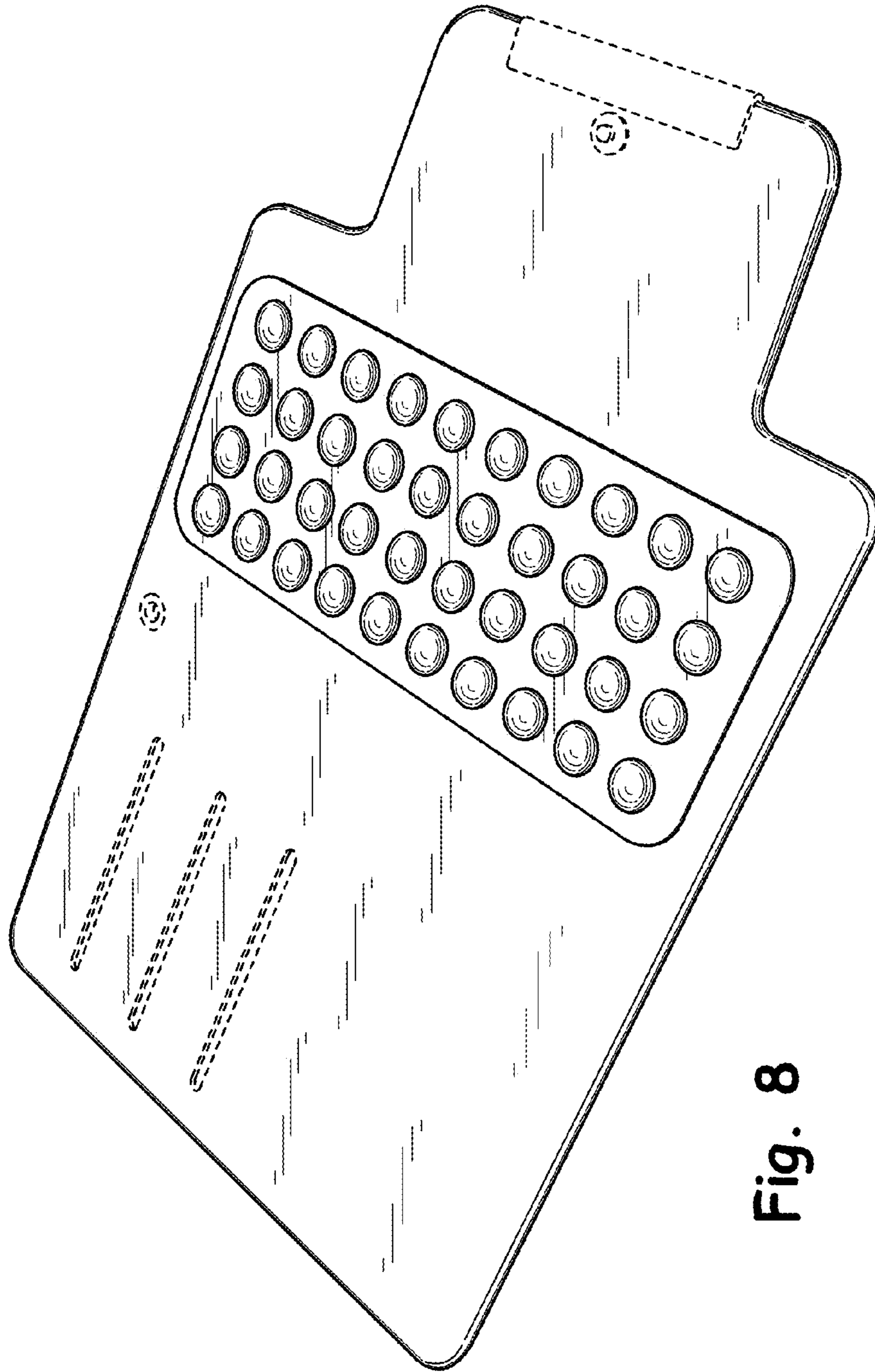

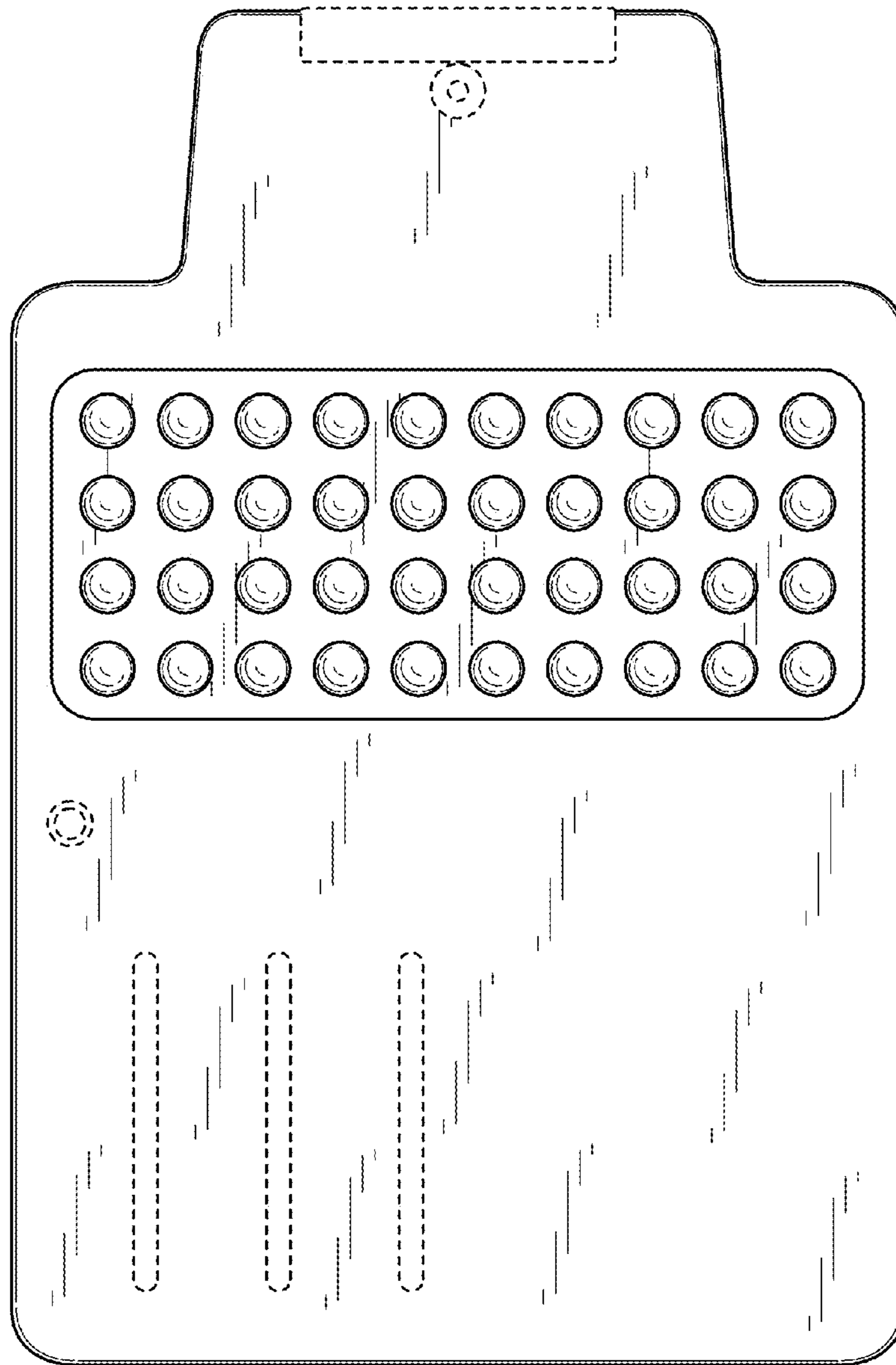

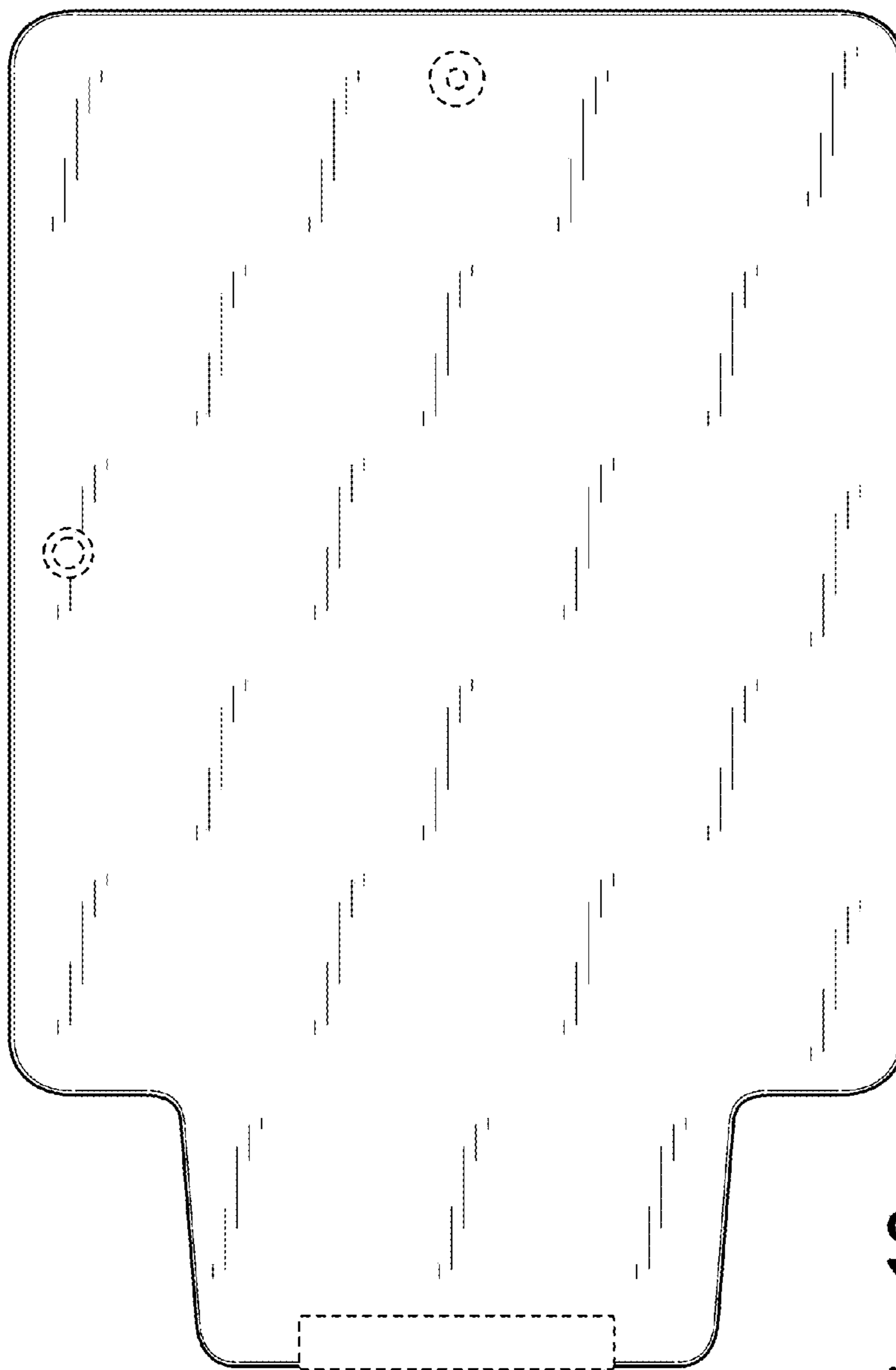
