(57) **CLAIM**

The ornamental design for a storage container with handle, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, top, and left side perspective view of a storage container with handle according to the present invention.

FIG. 2 is a rear elevational view of the storage container with handle of FIG. 1.

FIG. 3 is a right side elevational view of the storage container with handle of FIG. 1.

FIG. 4 is a top plan view of the storage container with handle of FIG. 1.

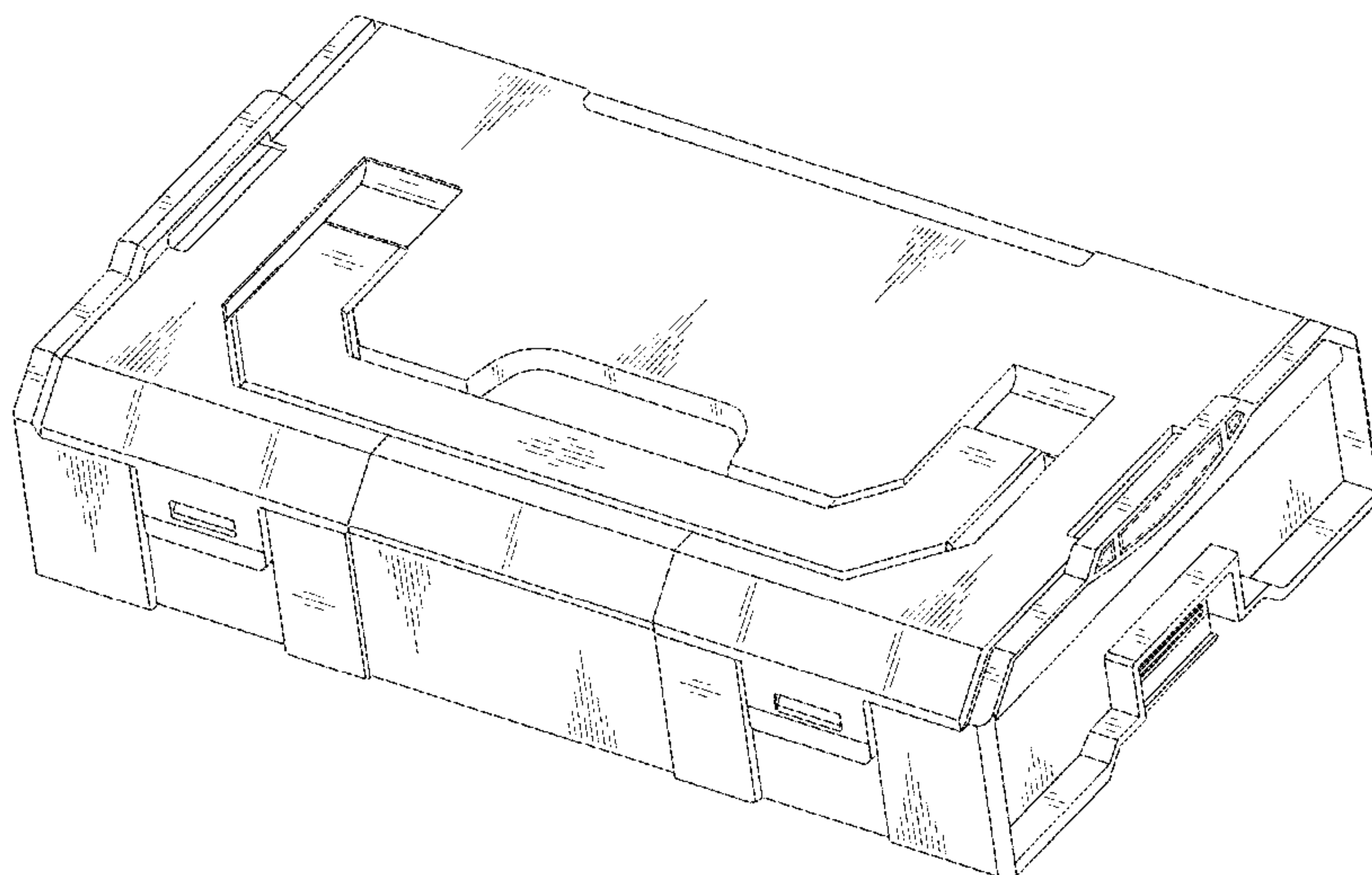
FIG. 5 is a left side elevational view of the storage container with handle of FIG. 1.

FIG. 6 is a bottom plan view of the storage container with handle of FIG. 1; and,

FIG. 7 is a front elevational view of the storage container with handle of FIG. 1.

The broken lines immediately adjacent the solid contour lines in FIGS. 1, 3, and 5 represent the bounds of the claim. The remaining broken lines illustrate portions of the storage container with handle. None of the broken lines forms part of the claimed design.

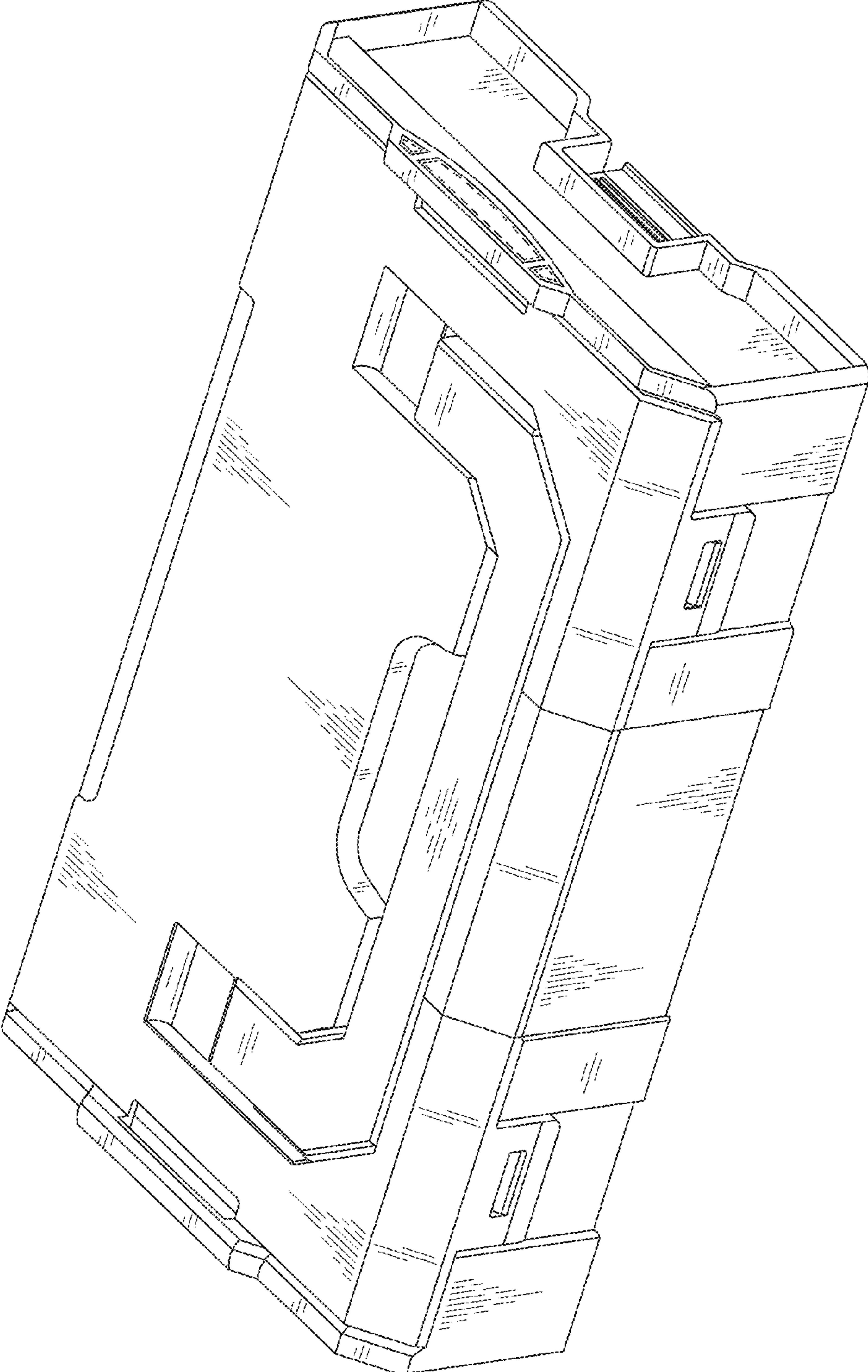

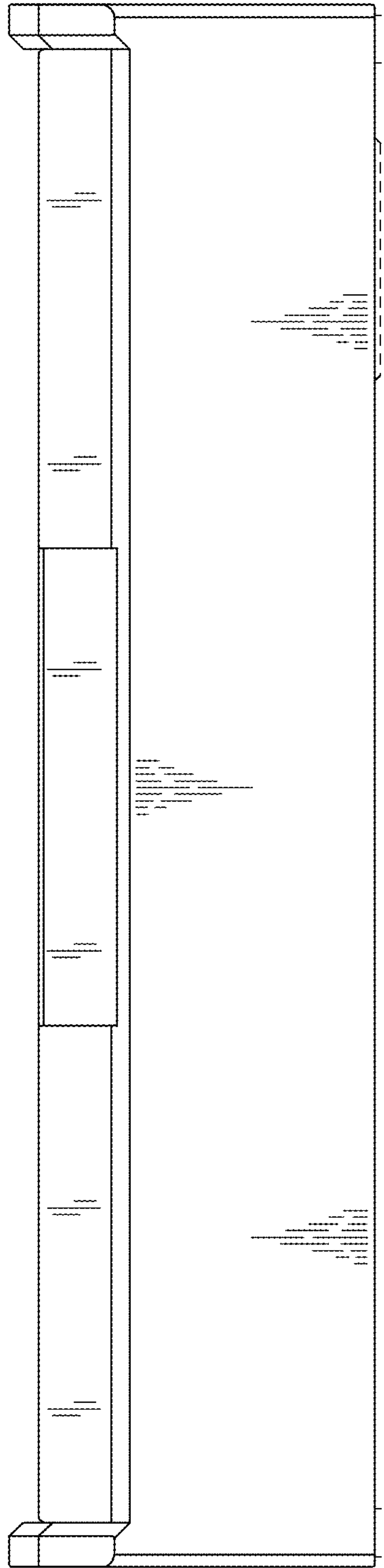

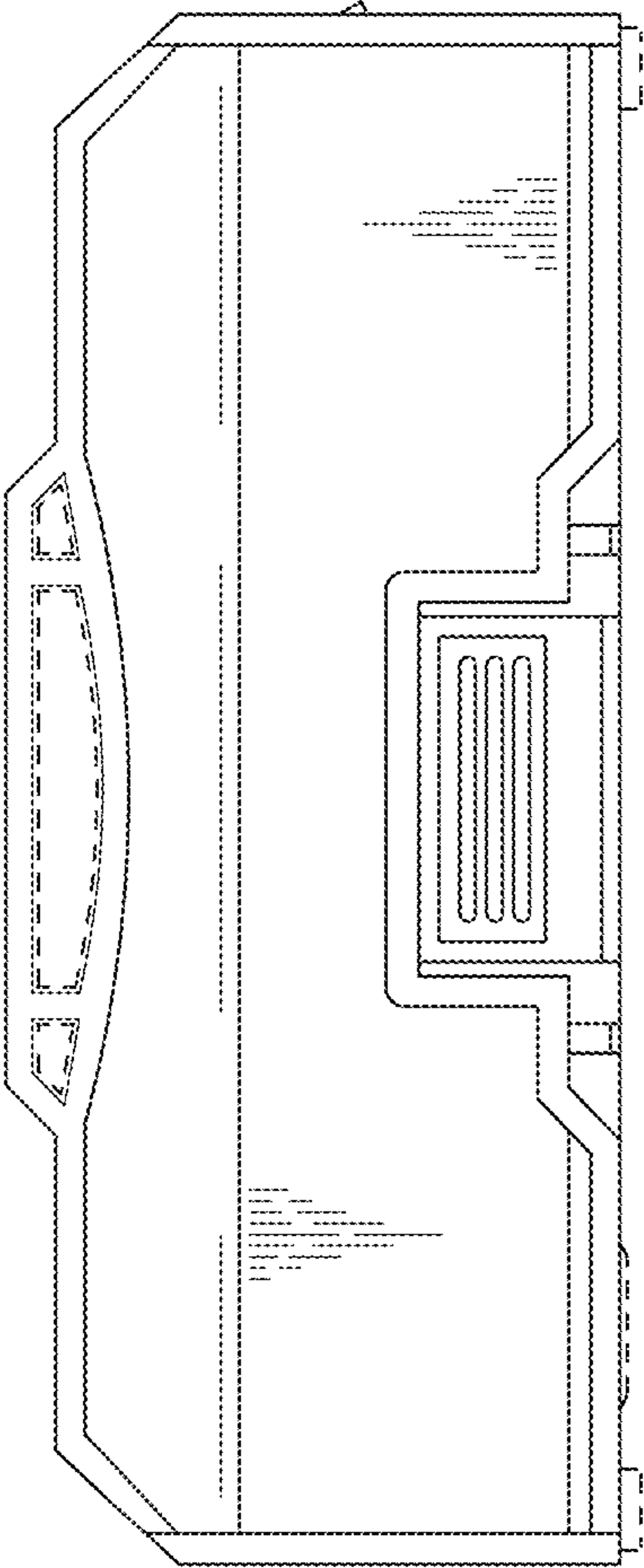

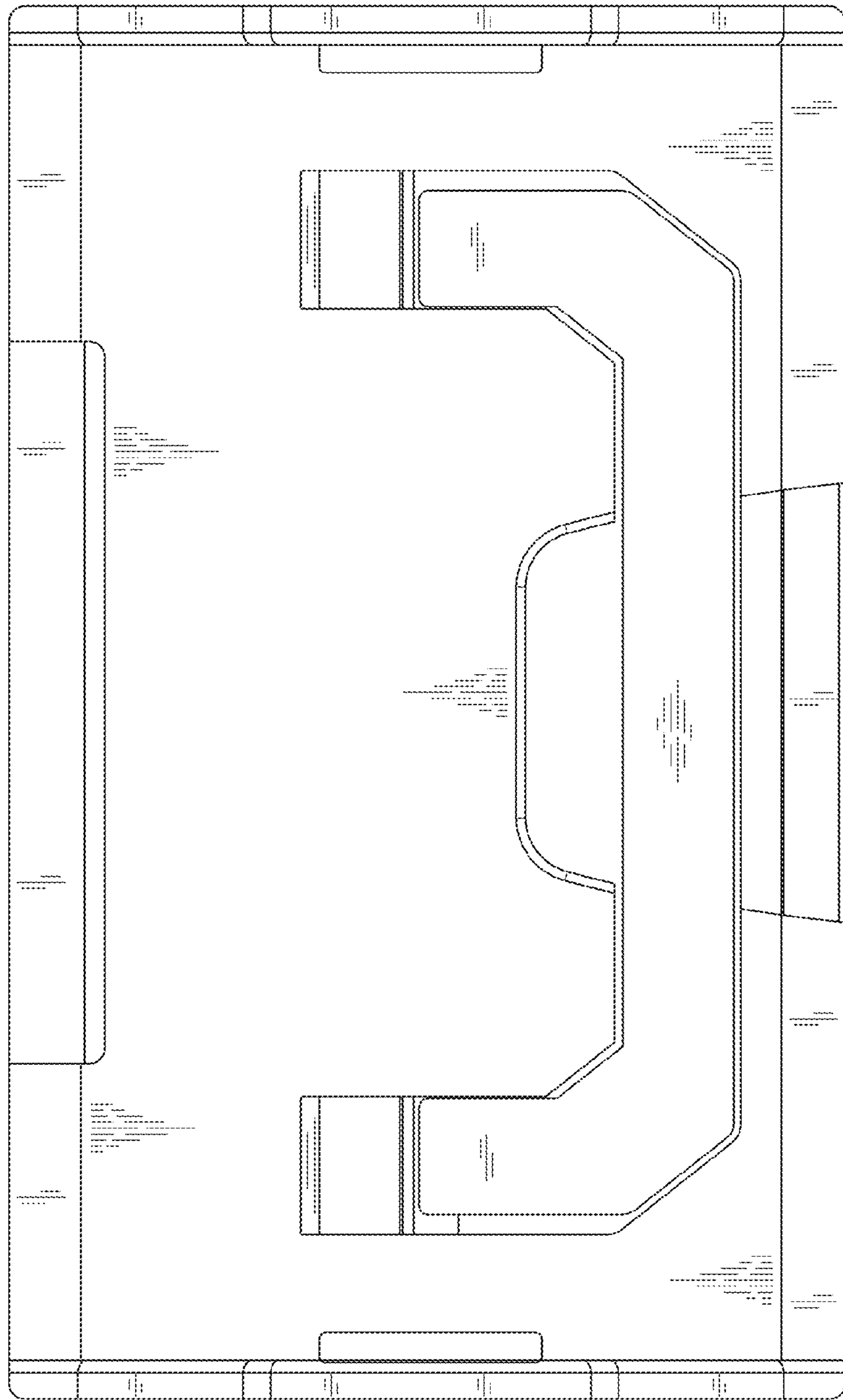

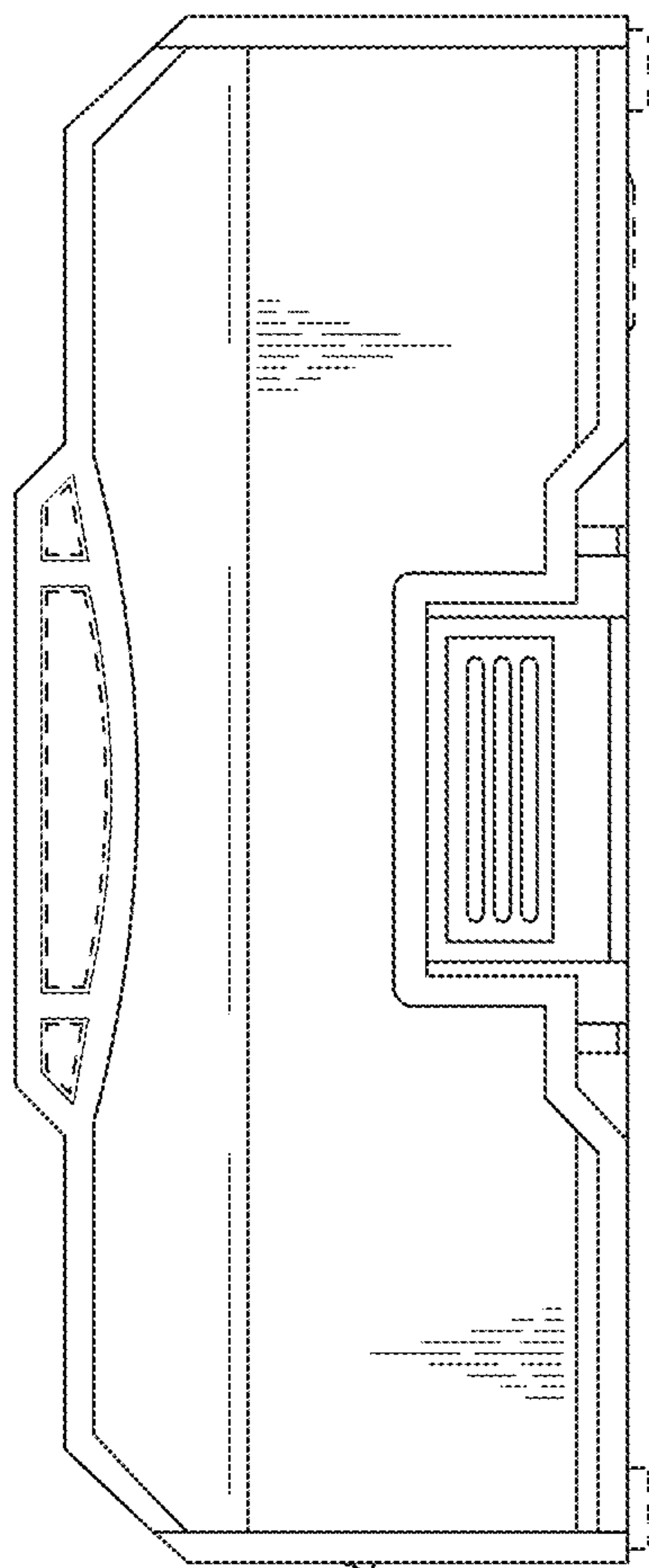

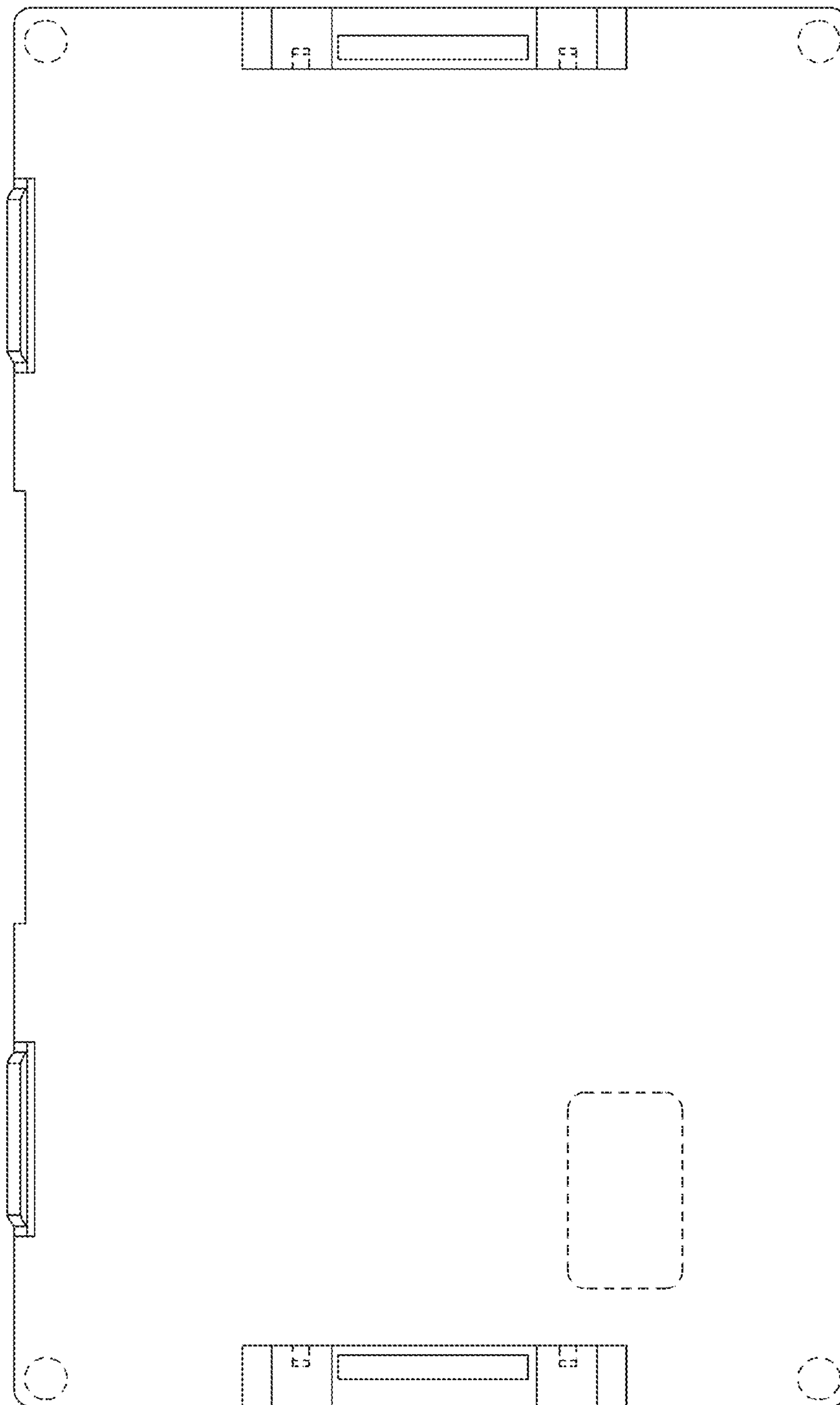

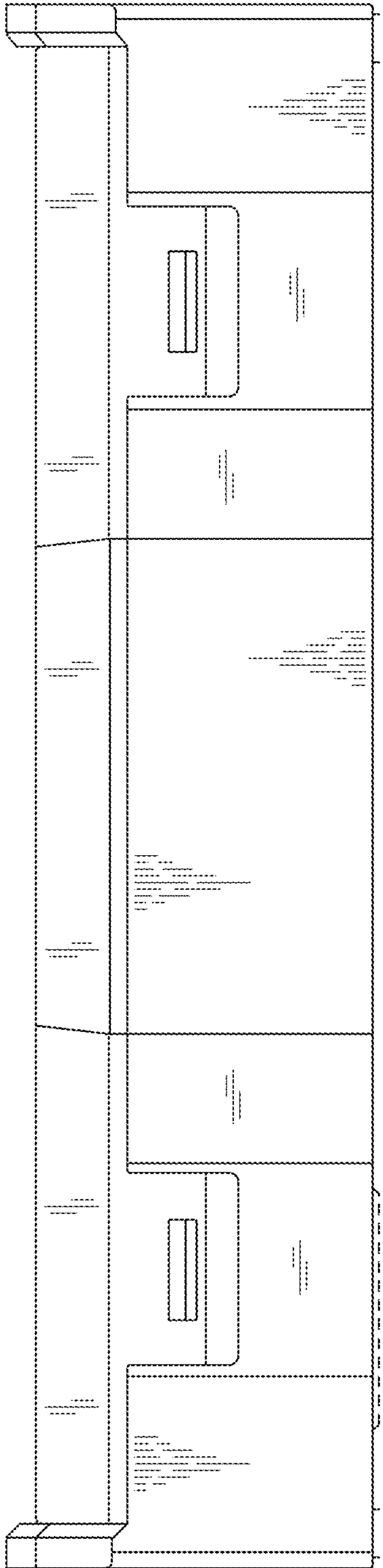
