(57) **CLAIM**

The ornamental design for a multiform chair, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of the multiform chair with two portions of the chair shown in a first deployed relative angular position;

FIG. 2 is a bottom plan view of the multiform chair in the first deployed relative angular position of FIG. 1;

FIG. 3 is a right side elevational view of the multiform chair in the first deployed relative angular position of FIG. 1;

FIG. 4 is a left side elevational view of the multiform chair in the first deployed relative angular position of FIG. 1;

FIG. 5 is a front elevational view of the multiform chair in the first deployed relative angular position of FIG. 1;

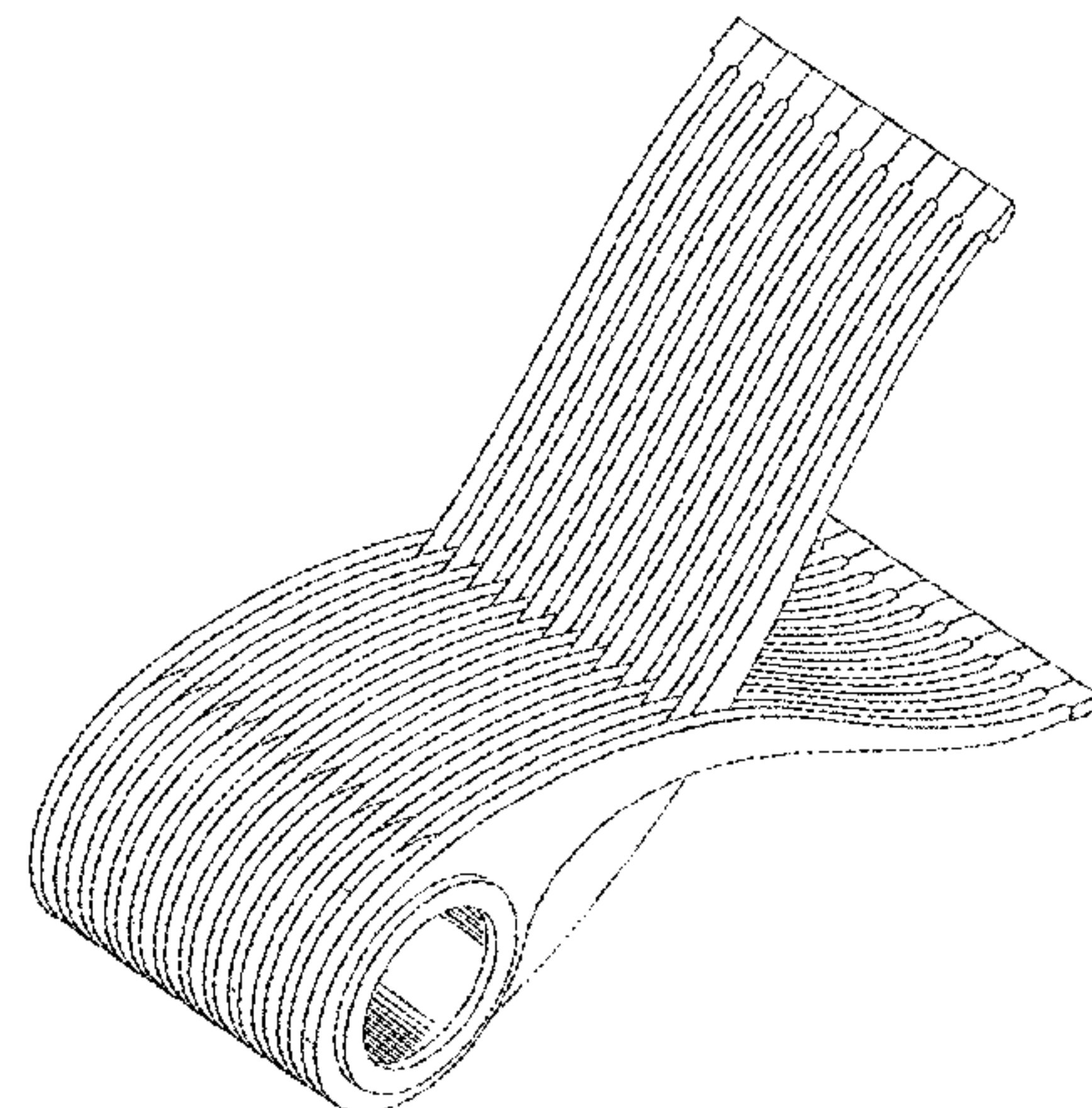
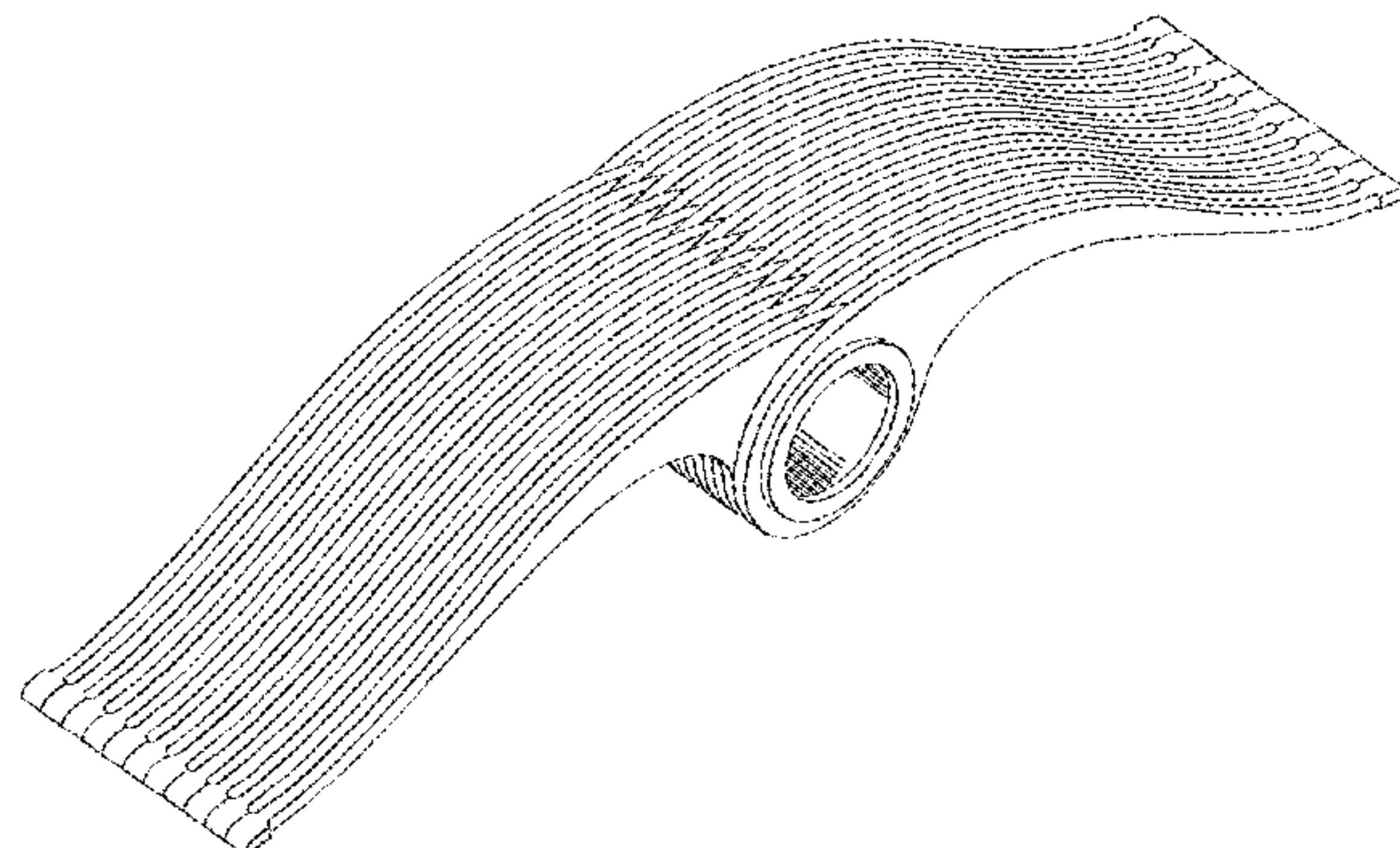


FIG. 6 is a rear elevational view of the multiform chair in the first deployed relative angular position of FIG. 1;

FIG. 7 is a perspective view of the multiform chair in the first deployed relative angular position of FIG. 1;

FIG. 8 is a top plan view of the multiform chair of FIG. 1, with the two portions of the chair shown in a second deployed right-angle relative angular position;

FIG. 9 is a bottom plan view of the multiform chair in the second deployed right-angle relative angular position of FIG. 8;

FIG. 10 is a right side elevational view of the multiform chair in the second deployed right-angle relative angular position of FIG. 8, wherein a left side elevational view is not shown as it is identical to the right side elevational view and pertinent design features can be ascertained from FIG. 4;

FIG. 11 is a front elevational view of the multiform chair in the second deployed right-angle relative angular position of FIG. 8;

FIG. 12 is a rear elevational view of the multiform chair in the second deployed right-angle relative angular position of FIG. 8;

FIG. 13 is a perspective view of the multiform chair in the second deployed right-angle relative angular position of FIG. 8;

FIG. 14 is a top plan view of the multiform chair of FIGS. 1 and 8, with the two portions of the chair shown in a third deployed partly collapsed relative angular position;

FIG. 15 is a bottom plan view of the multiform chair in the third deployed partly collapsed relative angular position of FIG. 14;

FIG. 16 is a right side elevational view of the multiform chair in the third deployed partly collapsed relative angular position of FIG. 14, wherein a left side elevational view is not

shown as it is identical to the right side elevational view and pertinent design features can be ascertained from FIG. 4;

FIG. 17 is a front elevational view of the multiform chair in the third deployed partly collapsed relative angular position of FIG. 14;

FIG. 18 is a rear elevational view of the multiform chair in the third deployed partly collapsed relative angular position of FIG. 14;

FIG. 19 is a perspective view of the multiform chair in the third deployed partly collapsed relative angular position of FIG. 14;

FIG. 20 is a top plan view of the multiform chair of FIGS. 1, 8, and 14, with the two portions of the chair shown in a fourth deployed partly collapsed relative angular position;

FIG. 21 is a bottom plan view of the multiform chair in the fourth deployed partly collapsed relative angular position of FIG. 20;

FIG. 22 is a right side elevational view of the multiform chair in the fourth deployed partly collapsed relative angular position of FIG. 20, wherein a left side elevational view is not shown as it is identical to the right side elevational view and pertinent design features can be ascertained from FIG. 4;

FIG. 23 is a front elevational view of the multiform chair in the fourth deployed partly collapsed relative angular position of FIG. 20;

FIG. 24 is a rear elevational view of the multiform chair in the fourth deployed partly collapsed relative angular position of FIG. 20; and,

FIG. 25 is a perspective view of the multiform chair in the fourth deployed partly collapsed relative angular position of FIG. 20.

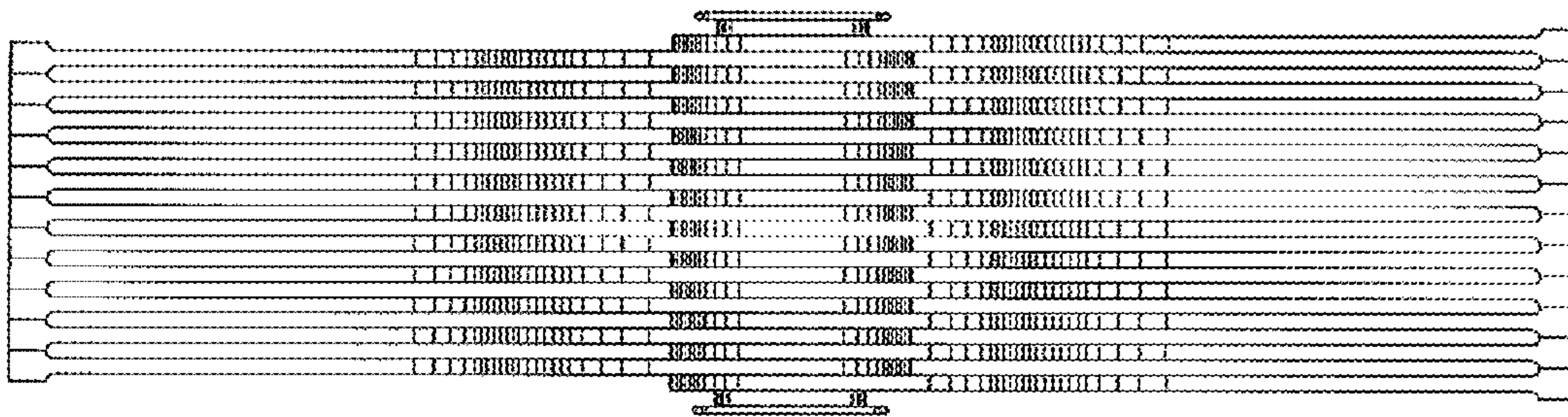

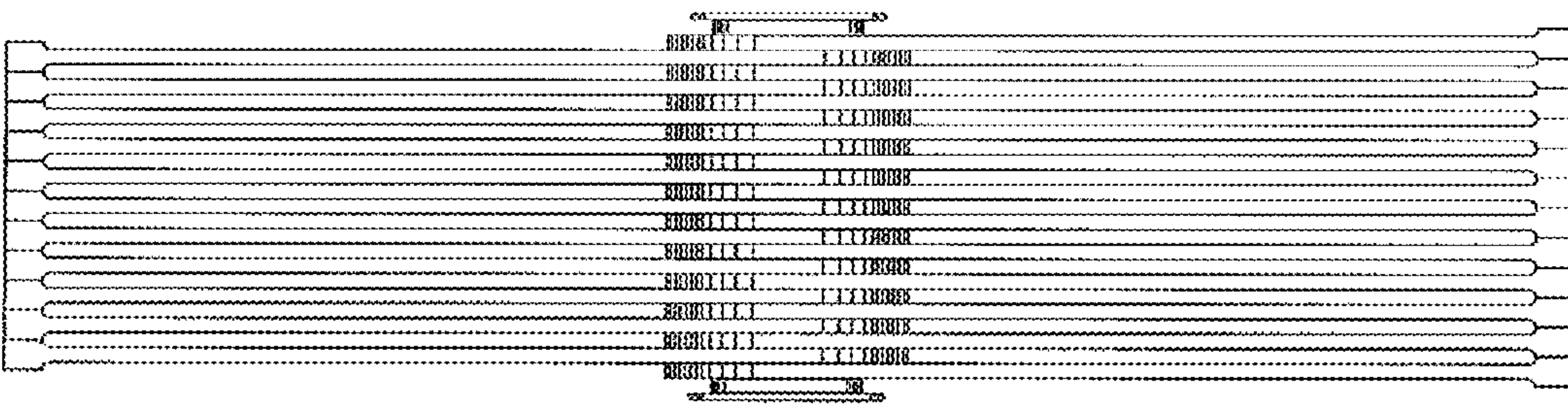

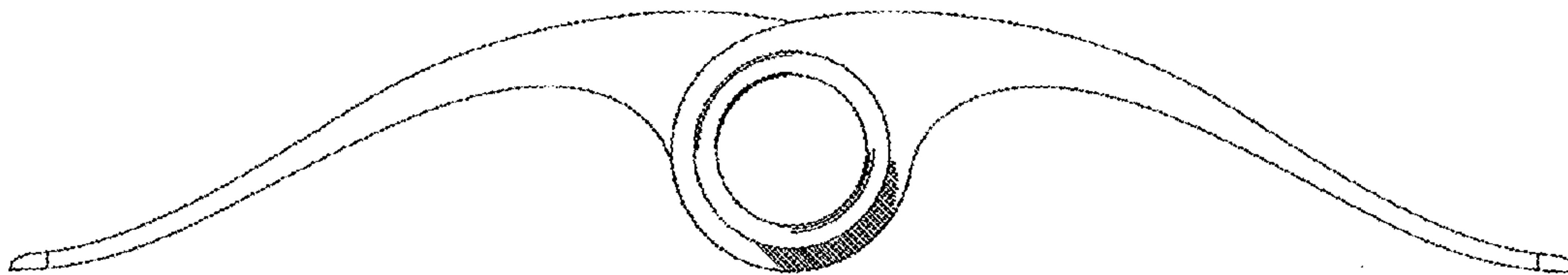

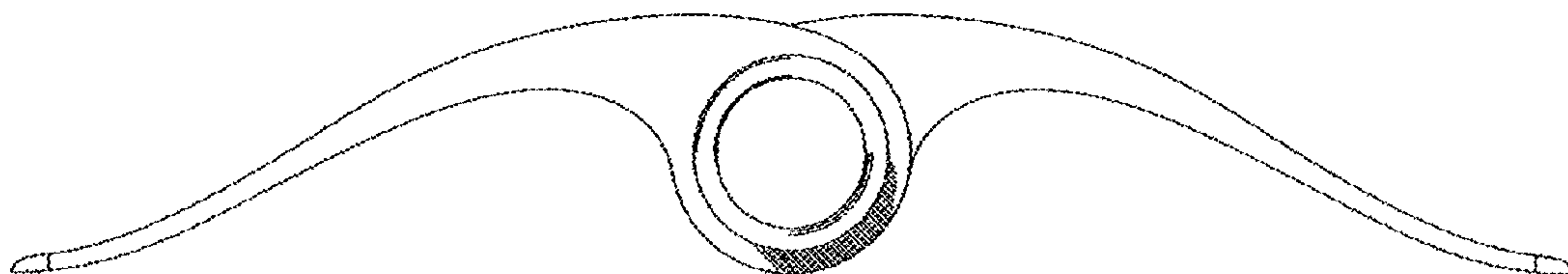

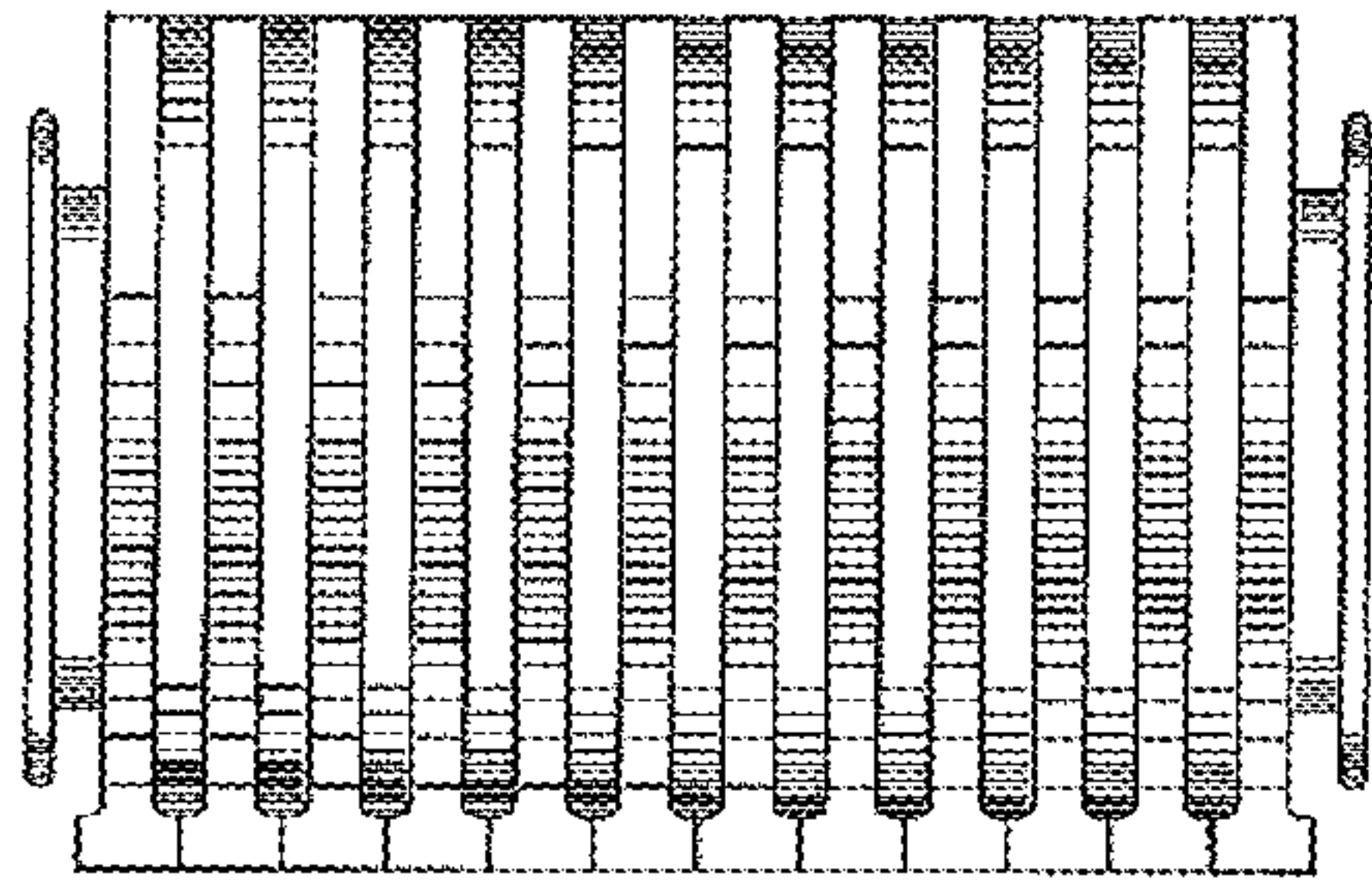

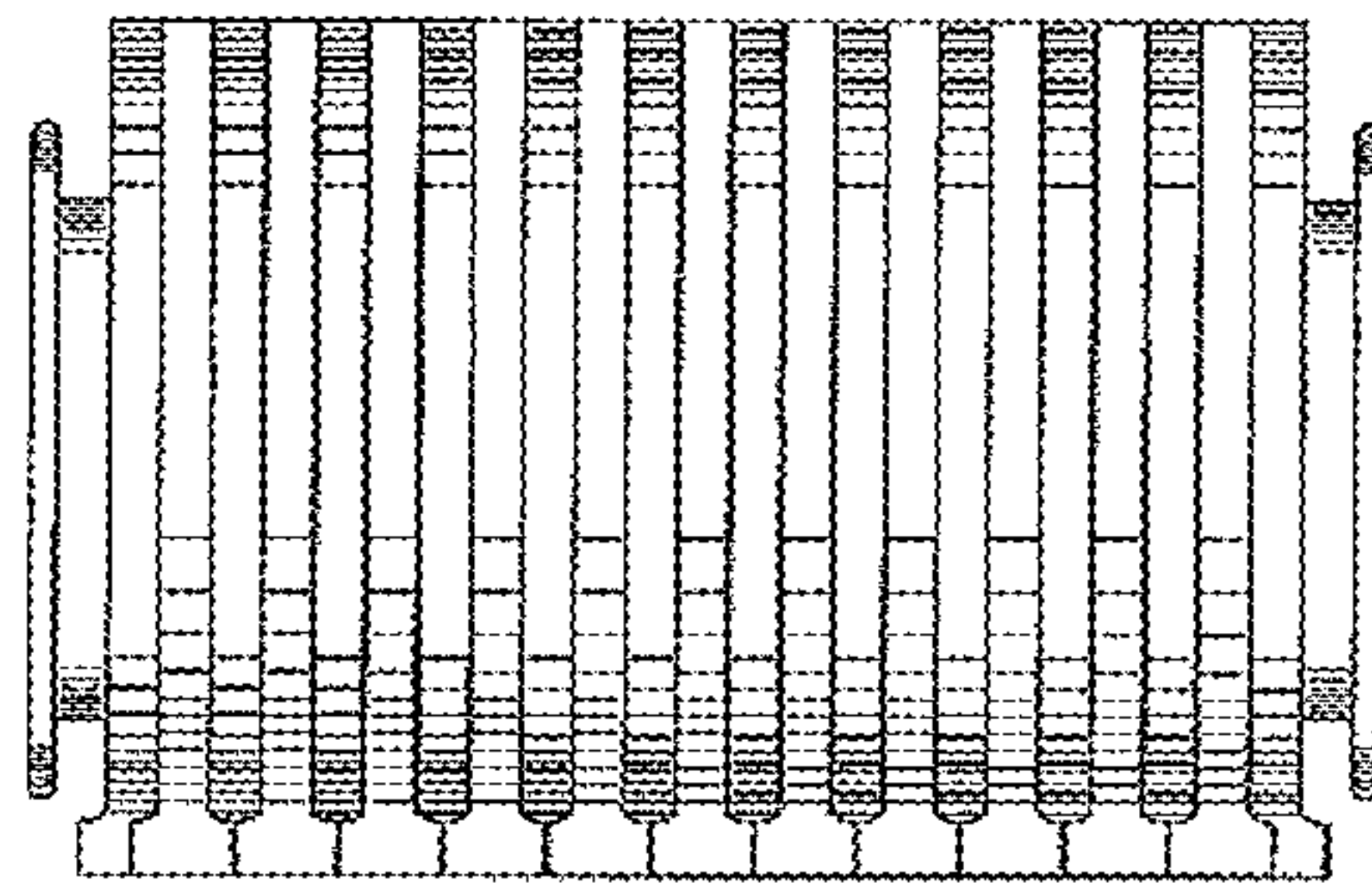

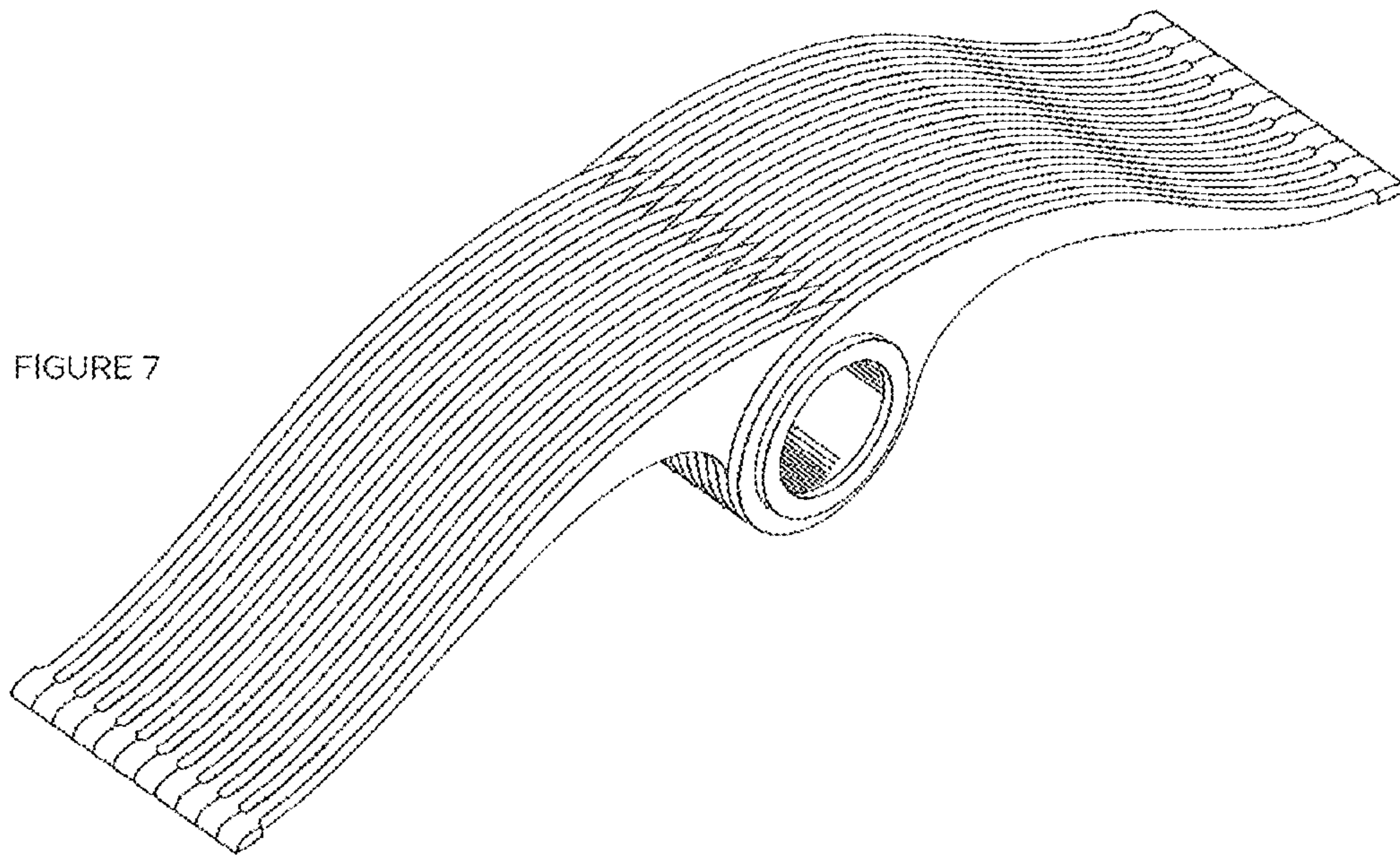

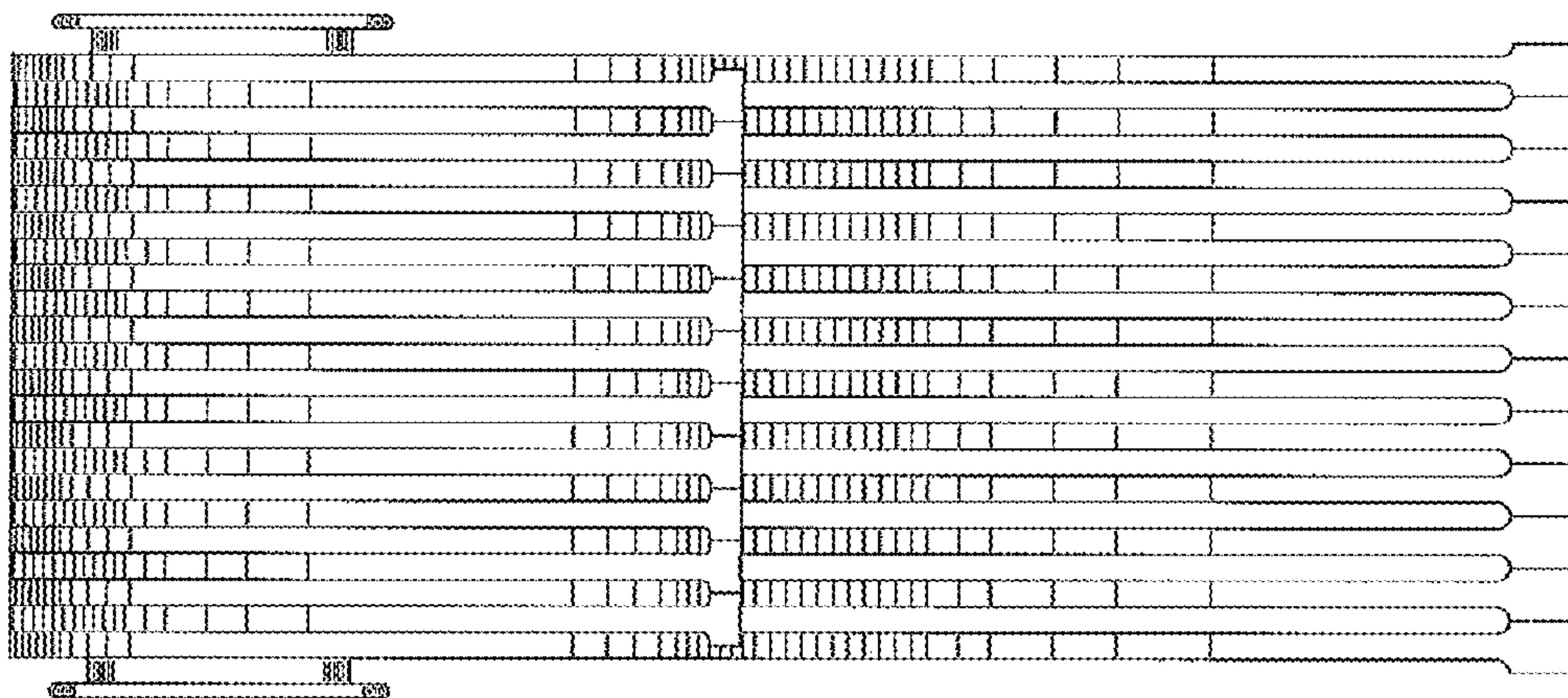

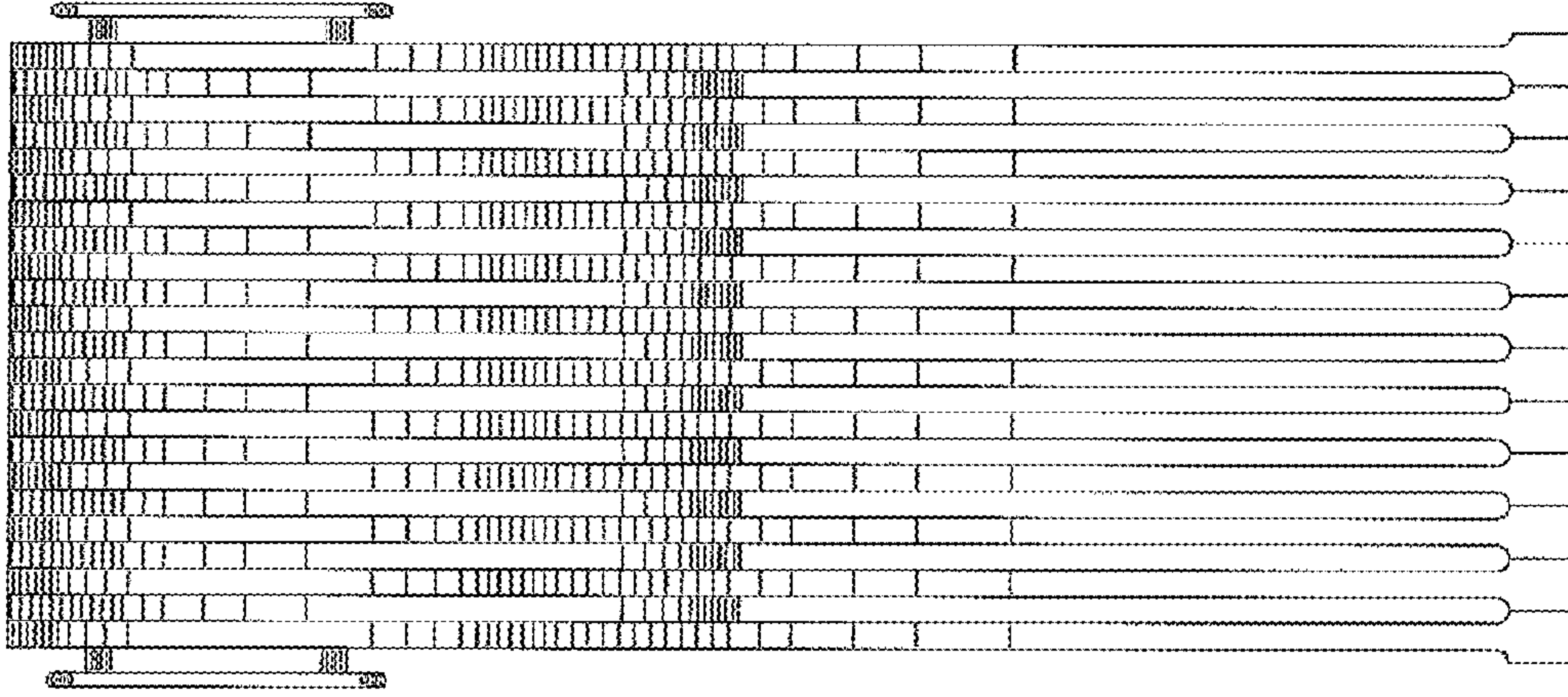

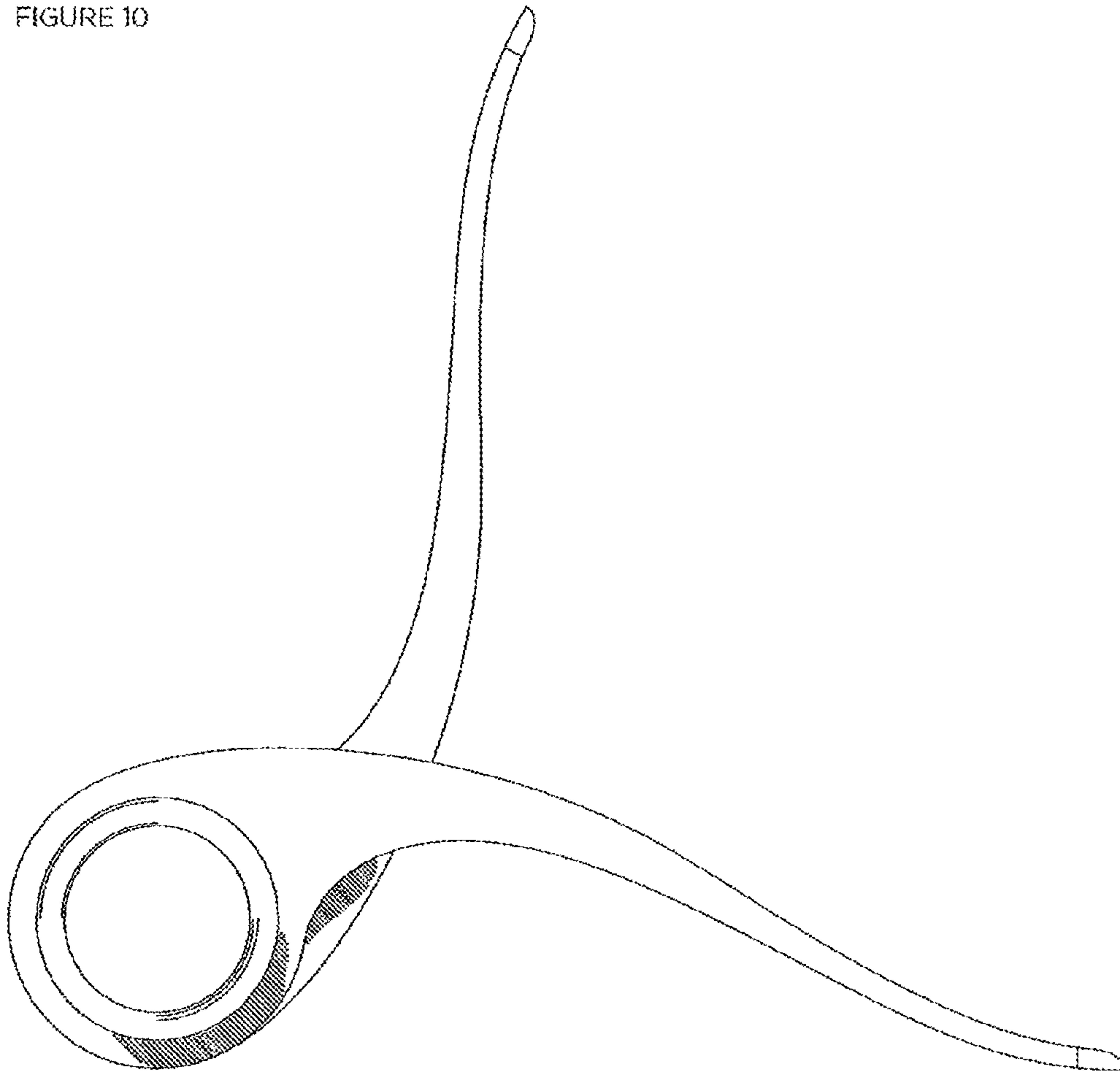

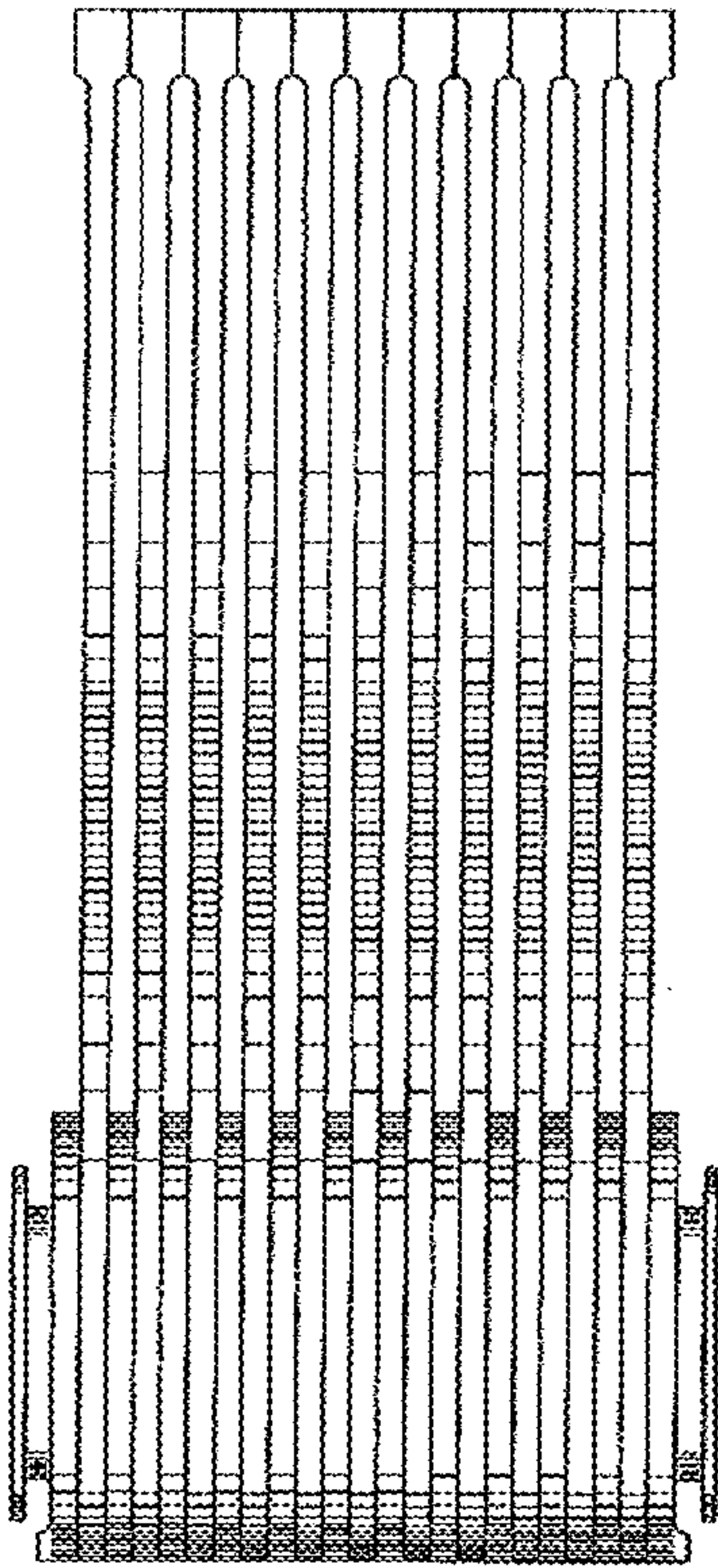

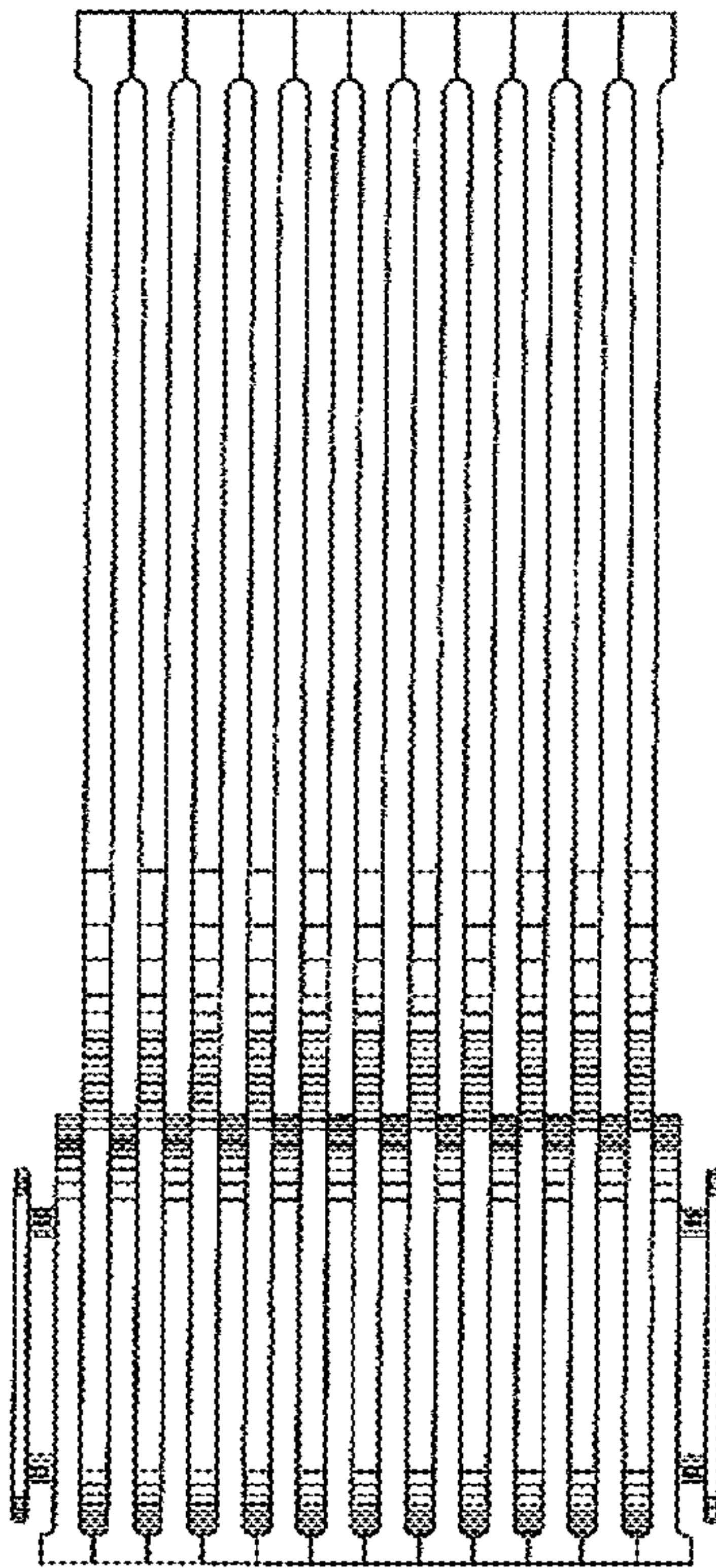

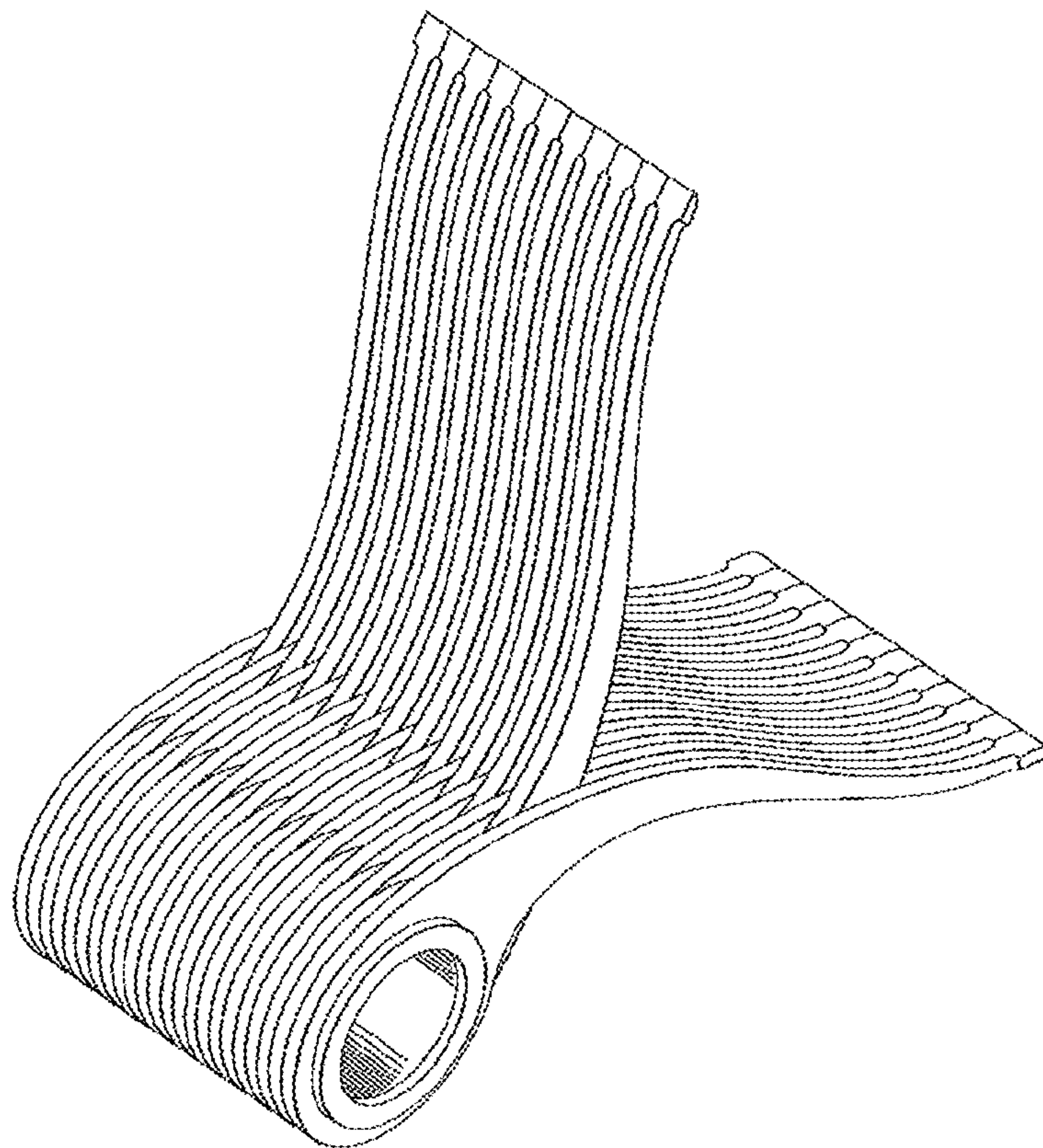

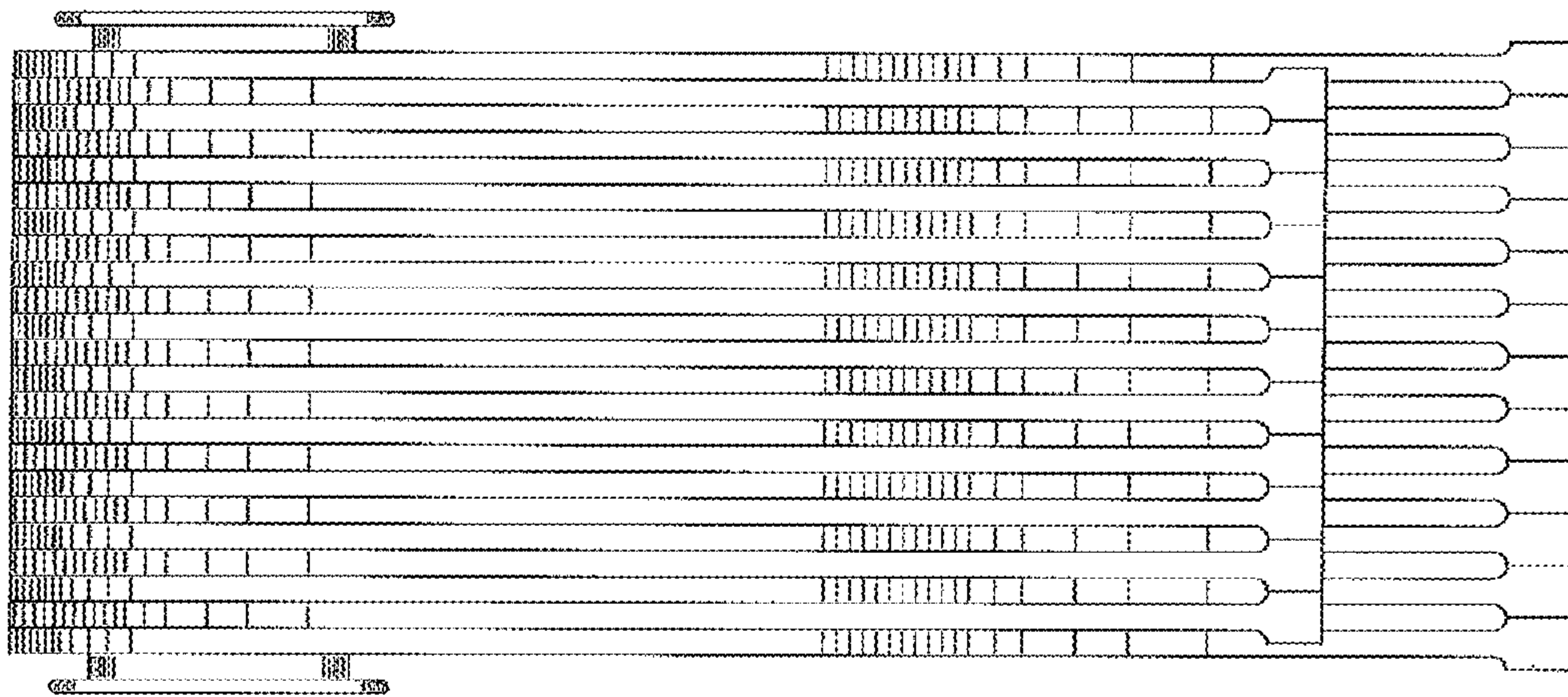

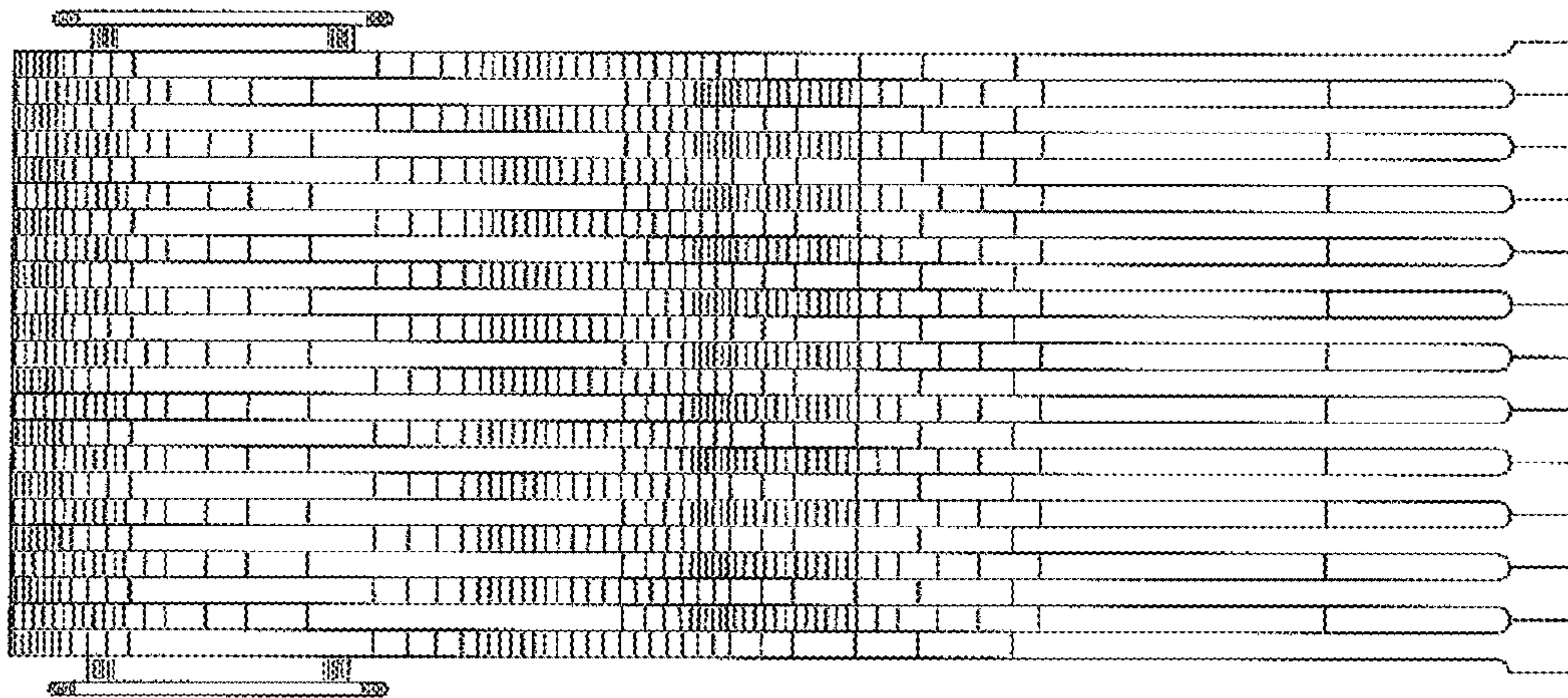

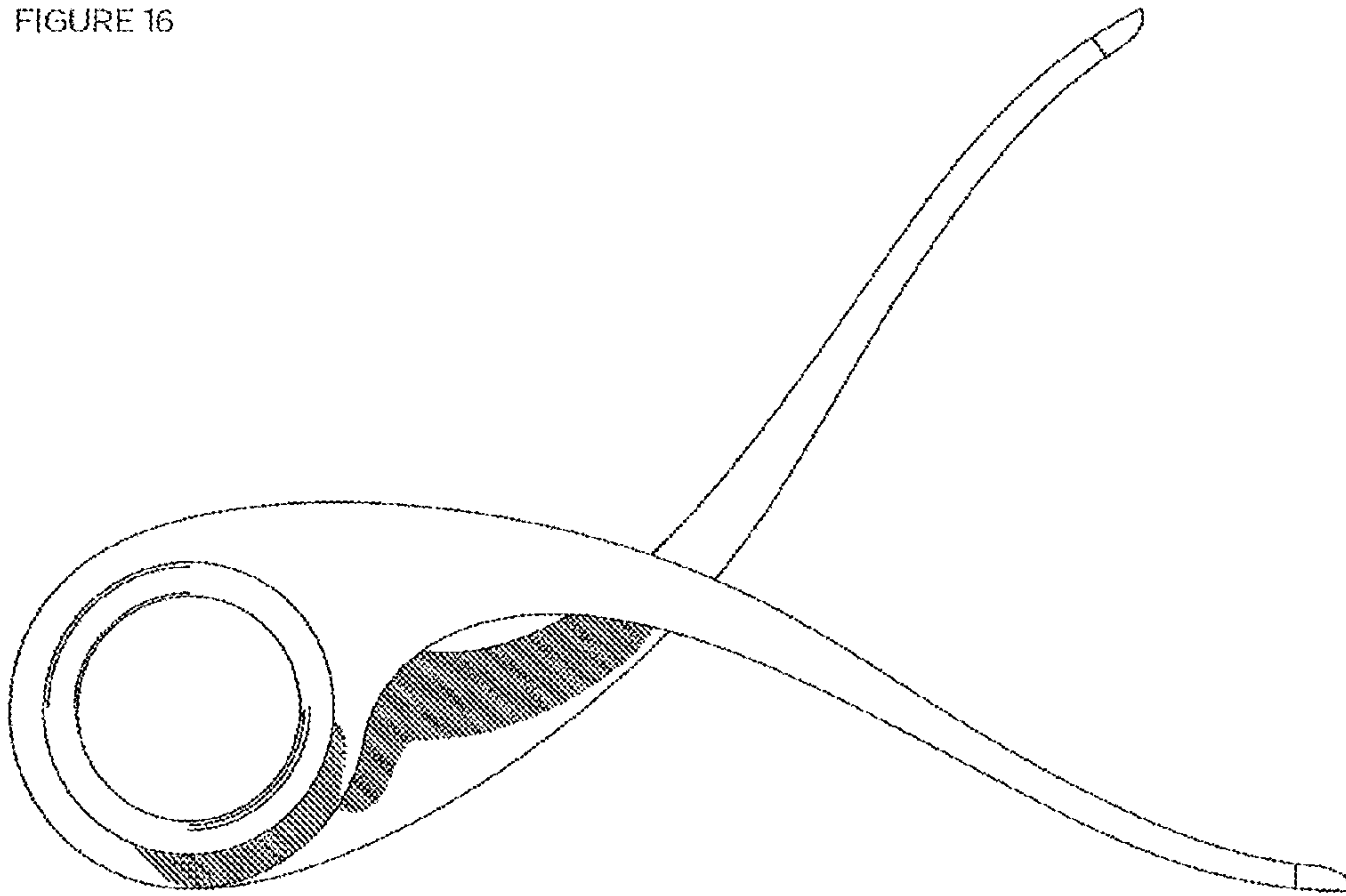

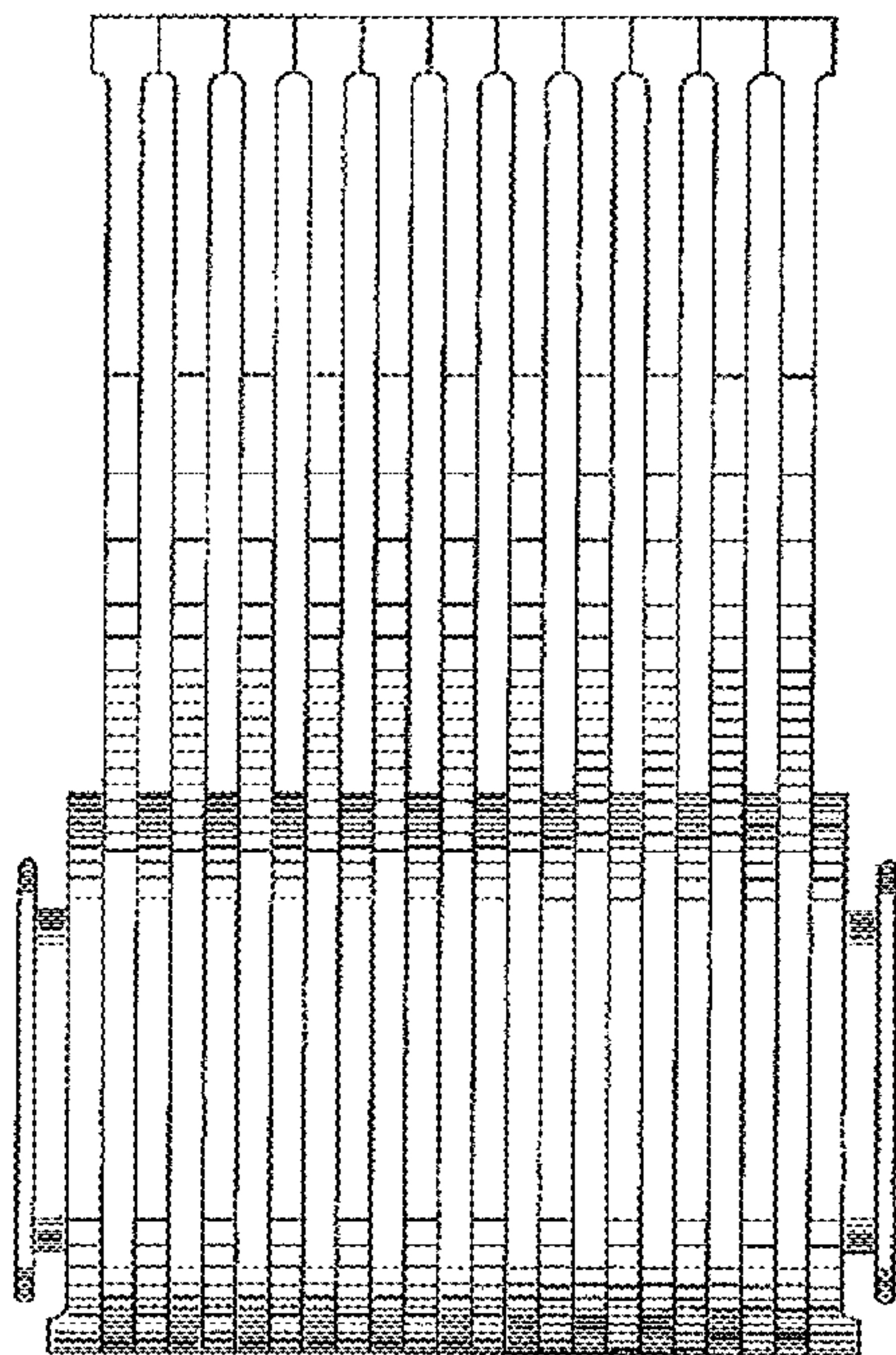

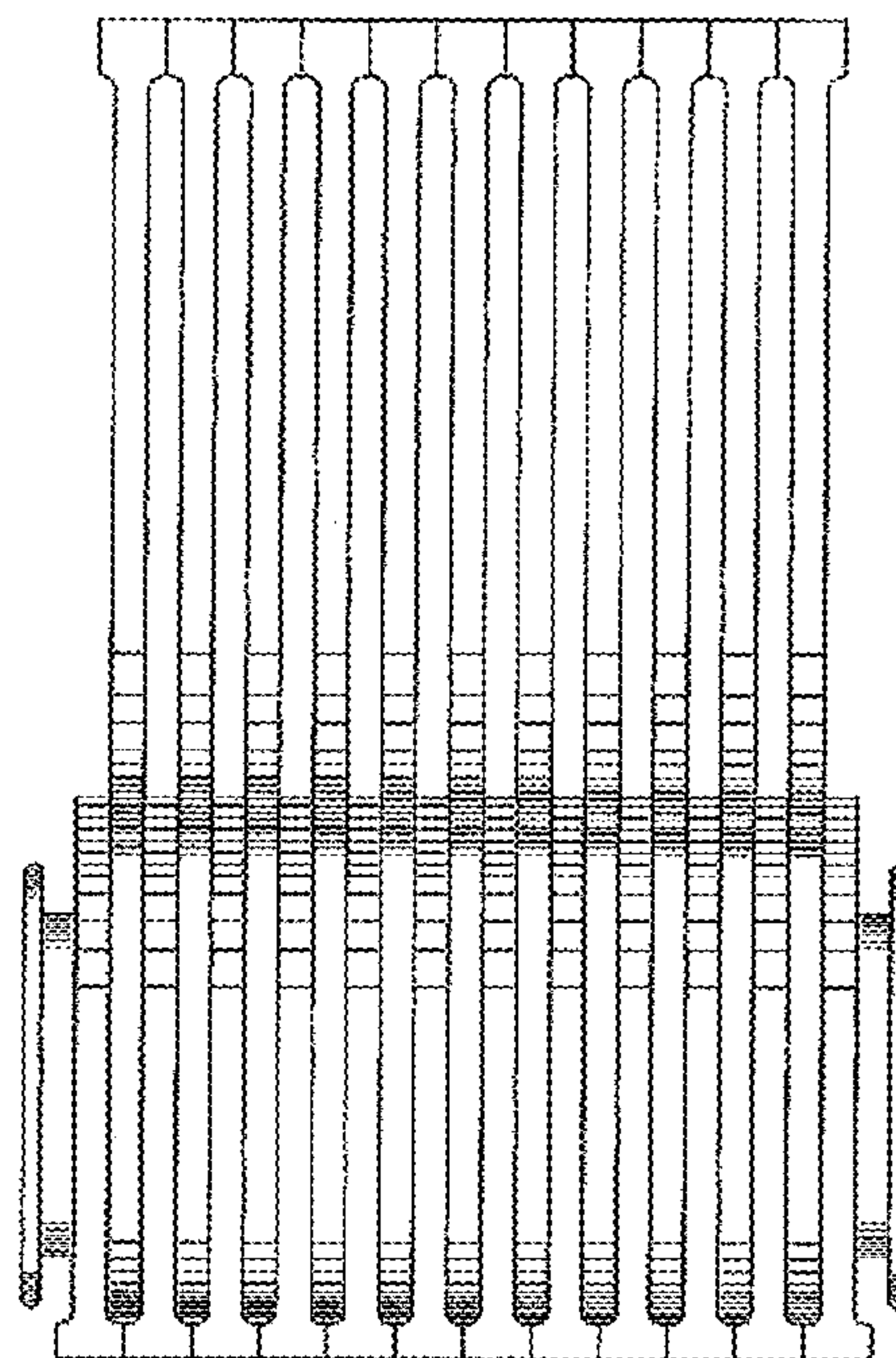

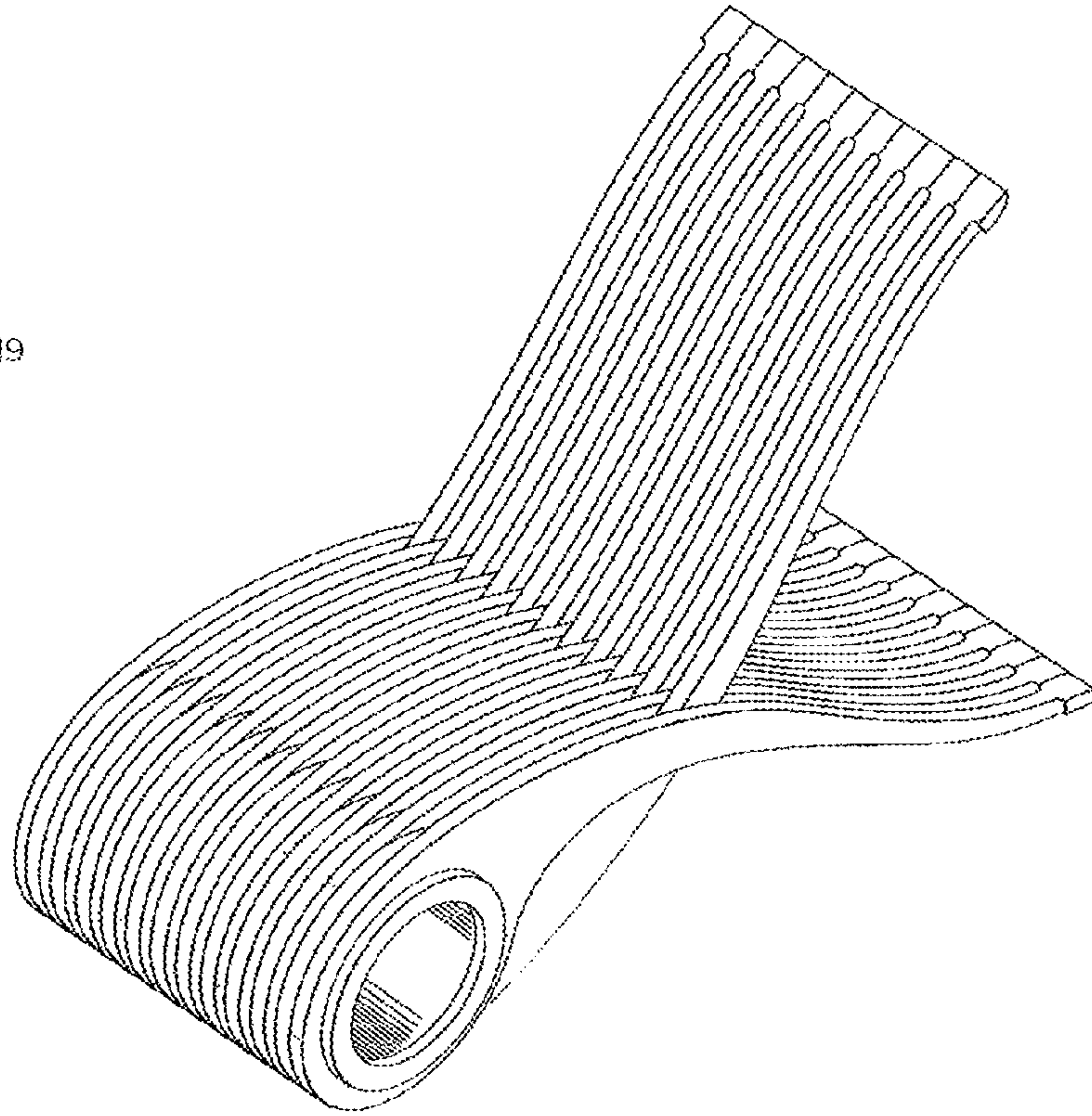

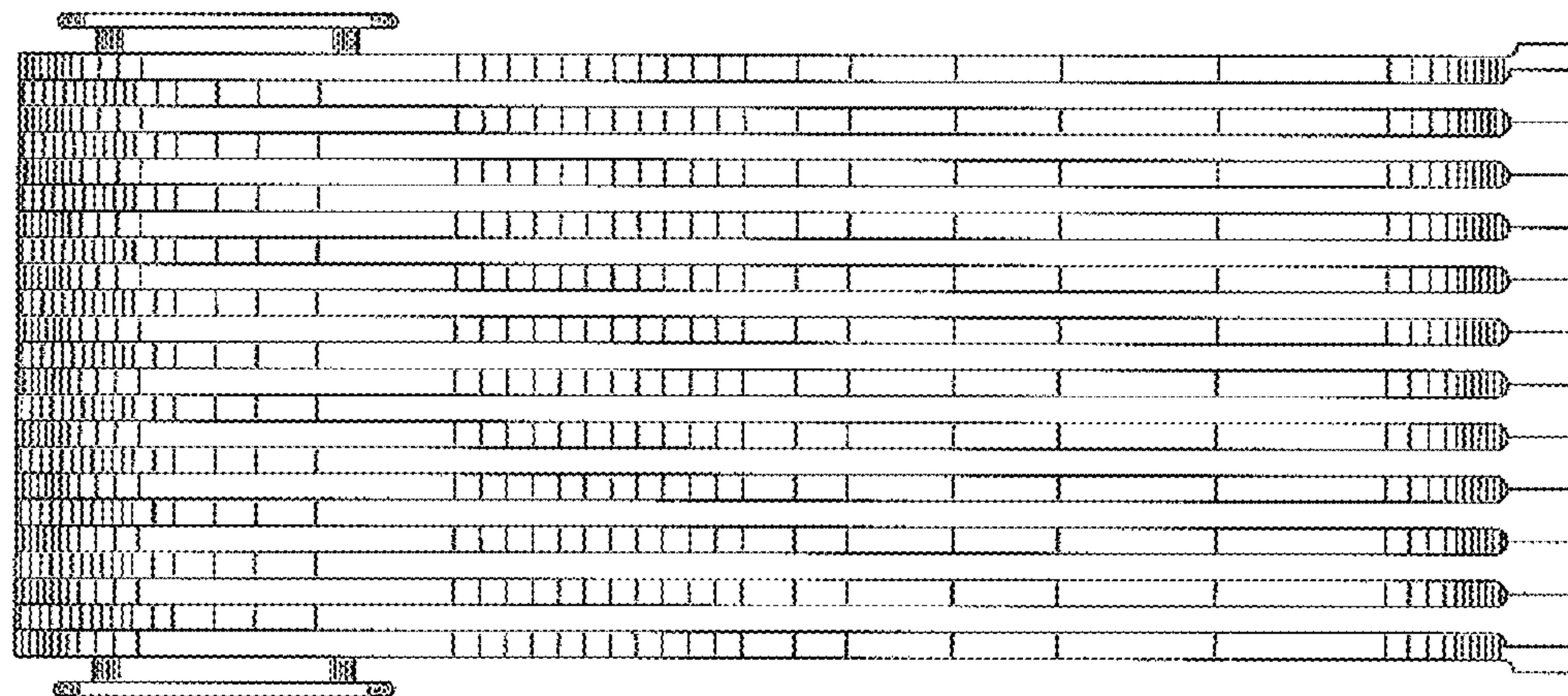

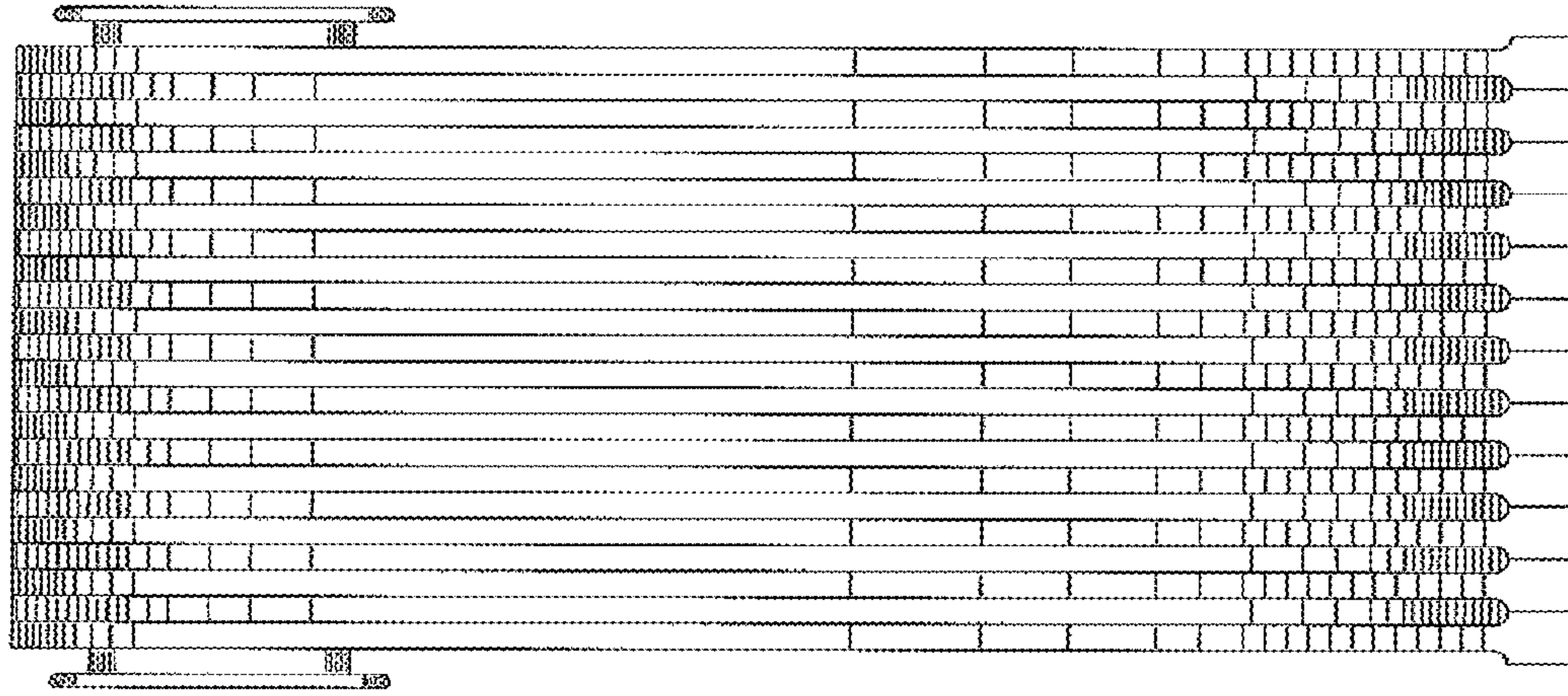

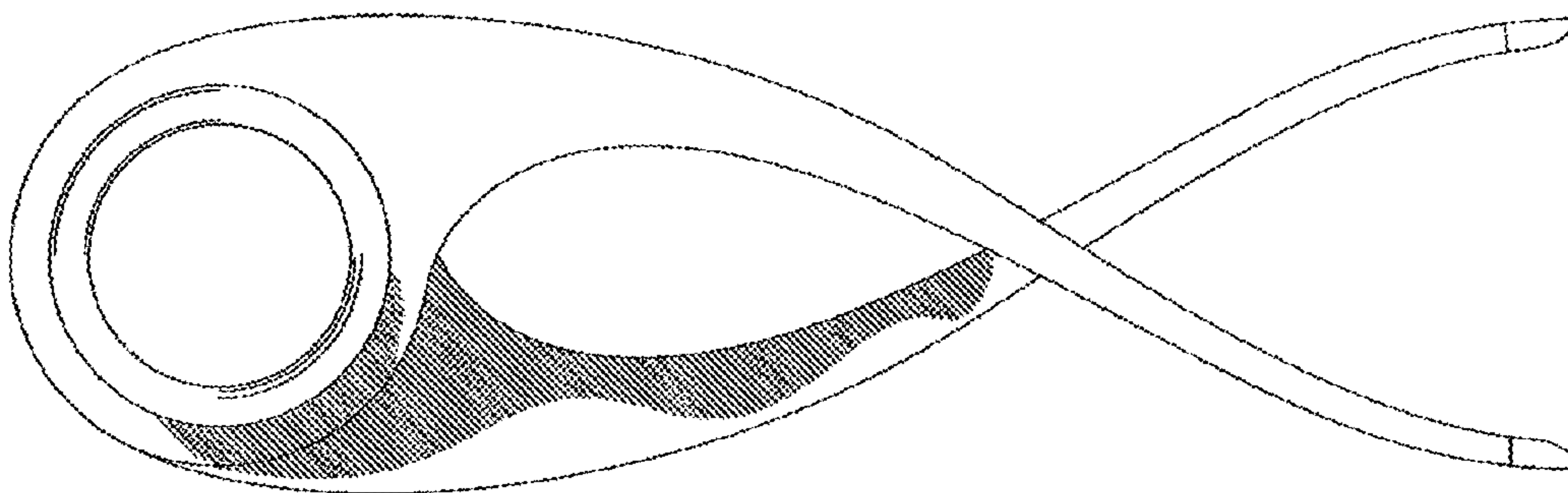

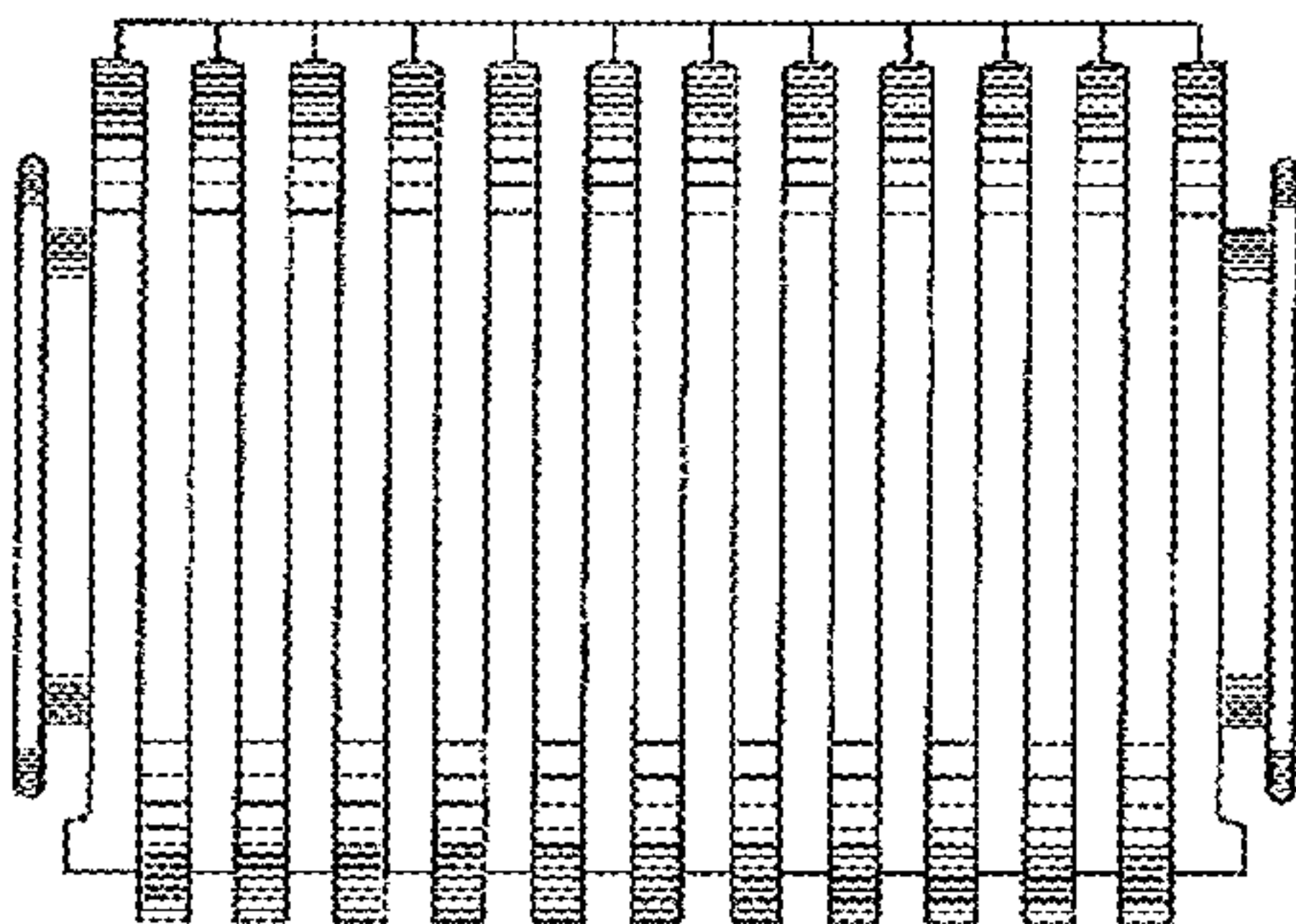

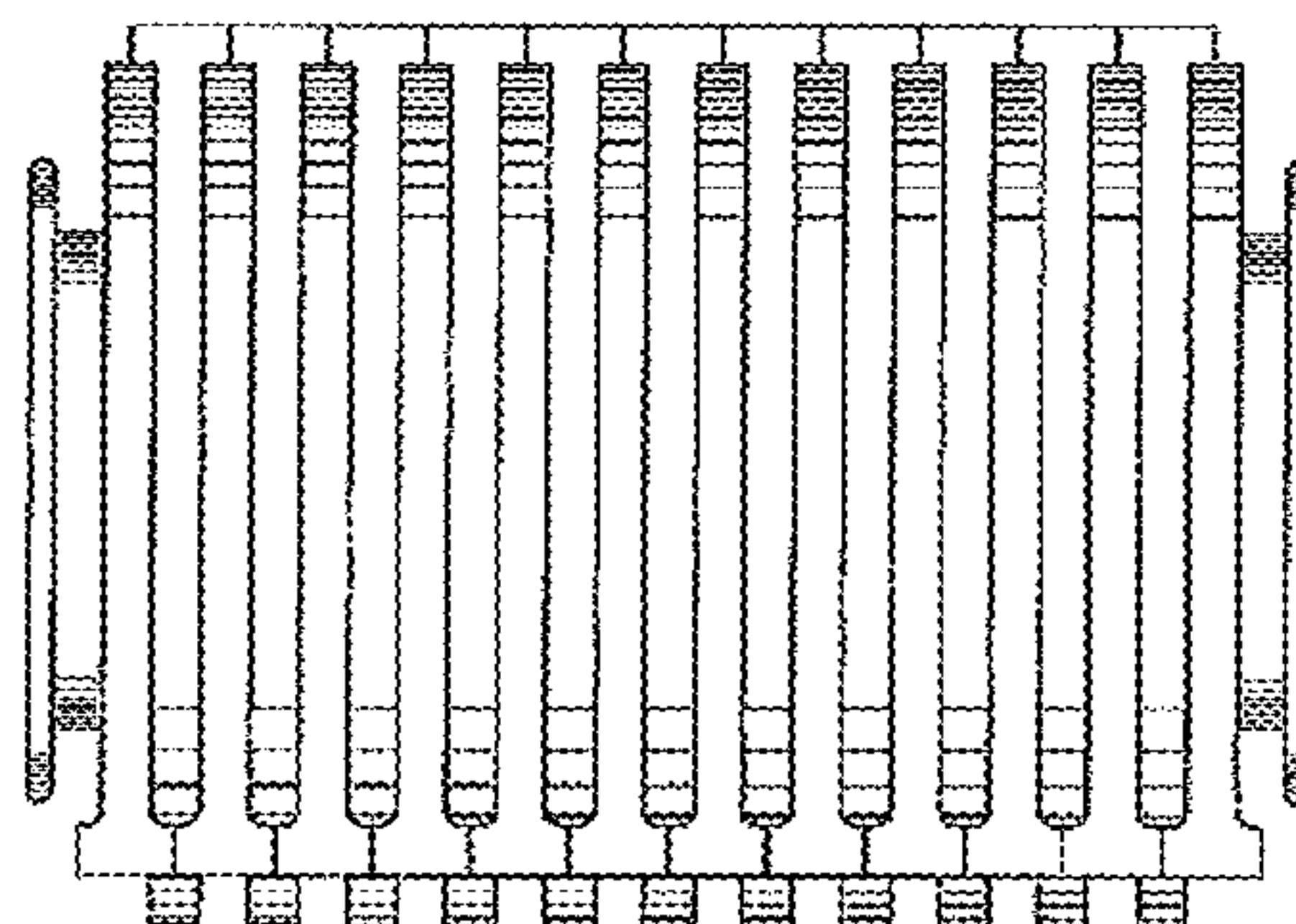
