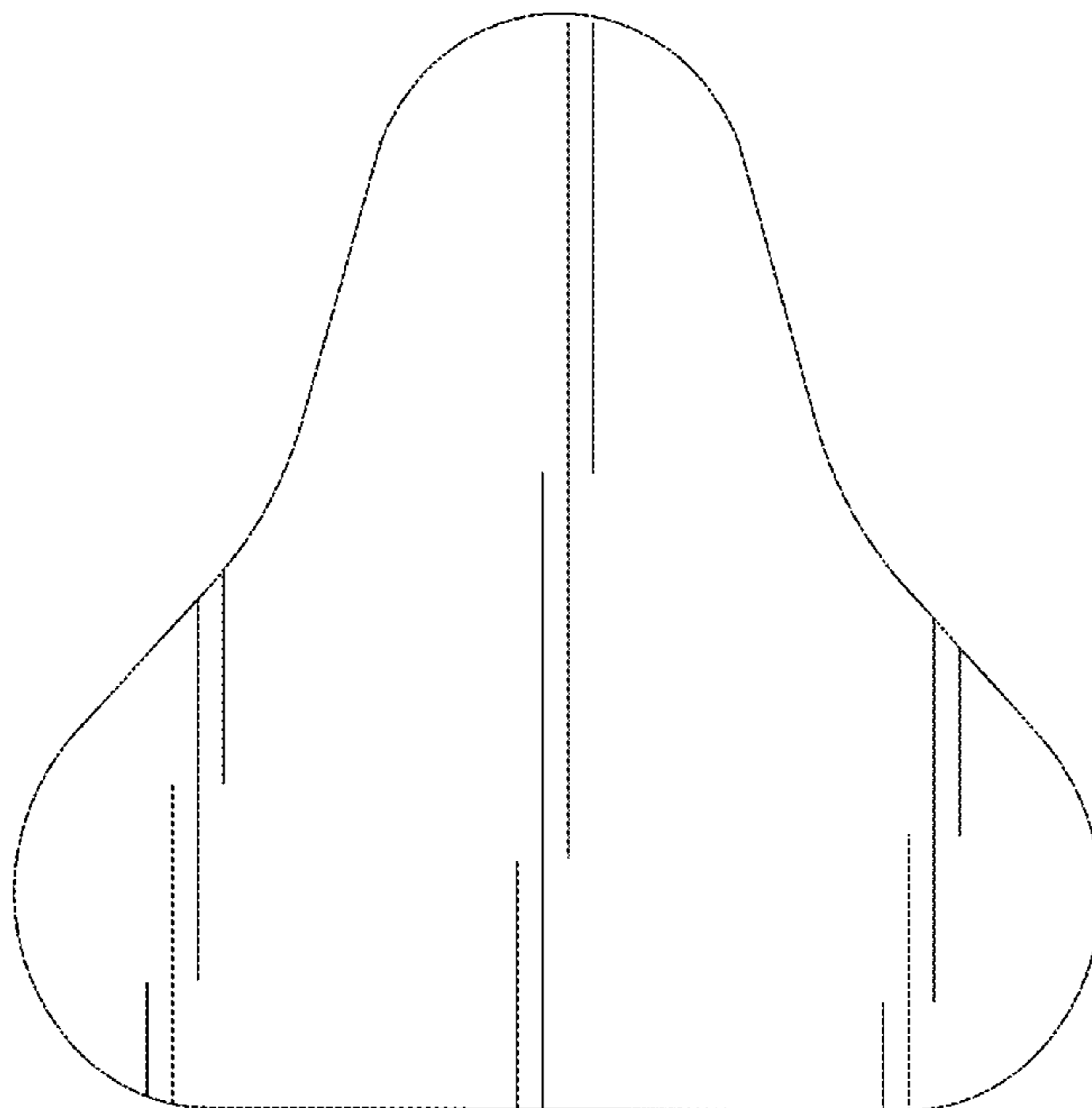

**DESCRIPTION**

FIG. 1 is a front perspective view of a toe protective padding; FIG. 2 is a front view thereof; FIG. 3 is a rear view of thereof; FIG. 4 is a left-hand side view thereof, wherein a right-hand side view is a mirror image of the left-hand side view; and, FIG. 5 is a top view thereof, wherein a bottom view is a mirror image of the top view.

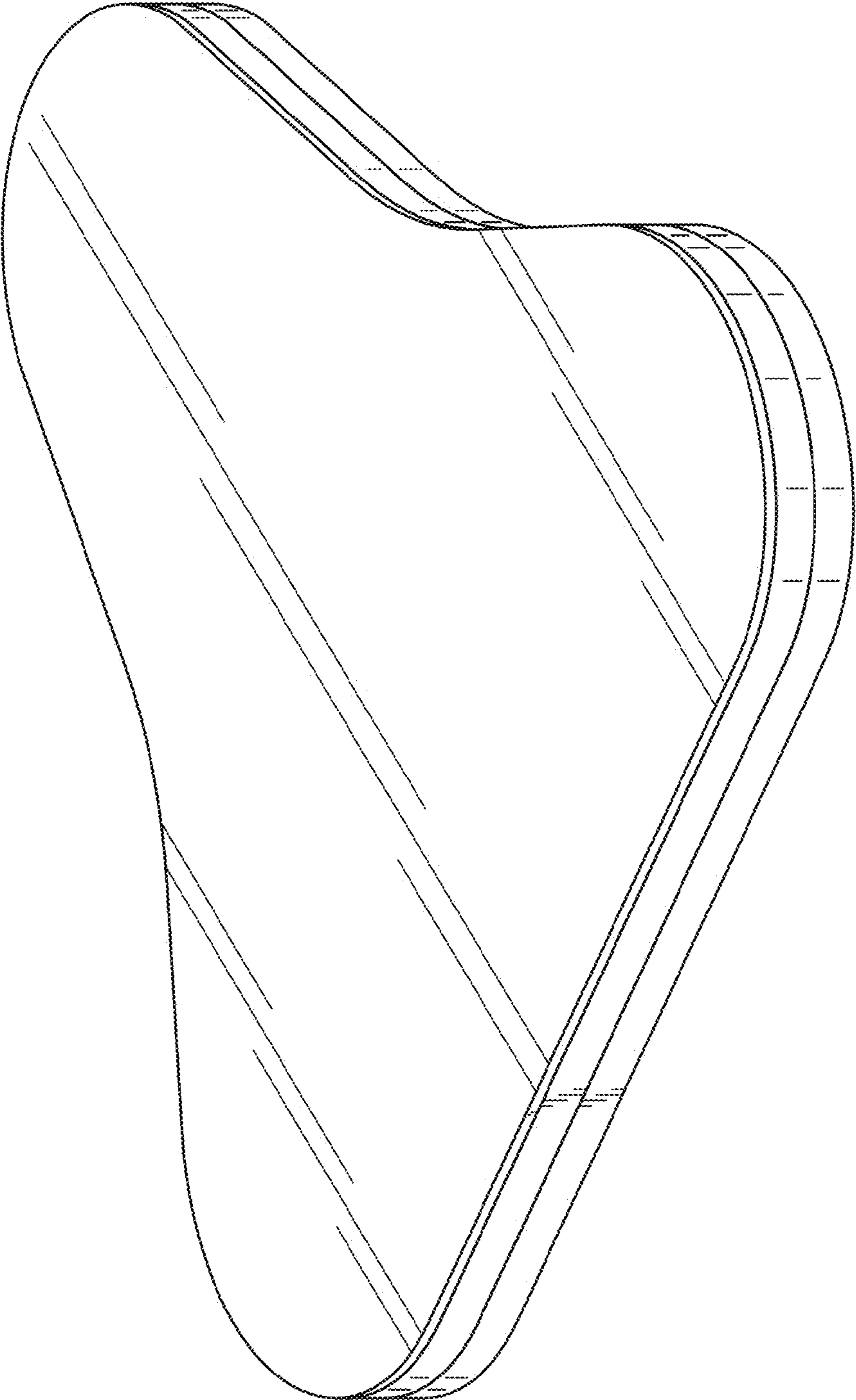

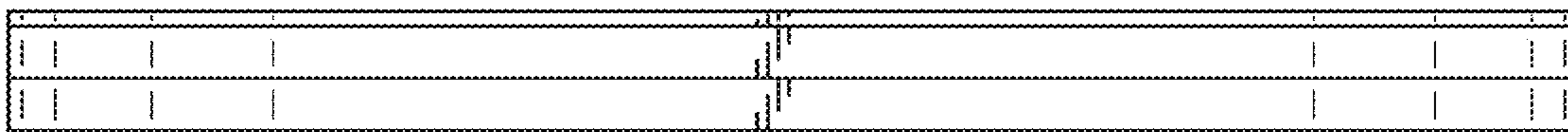

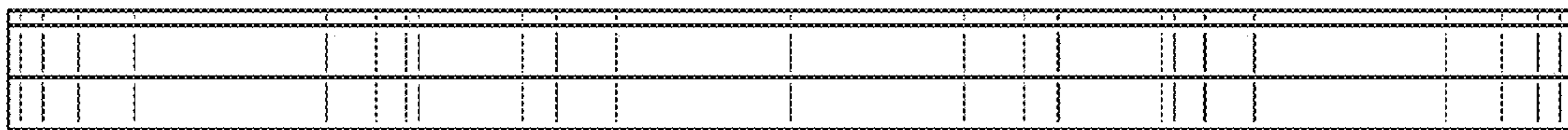

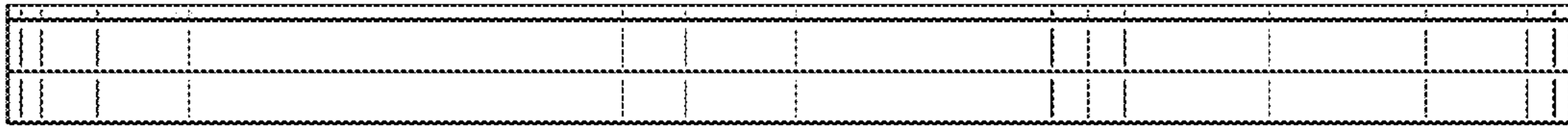

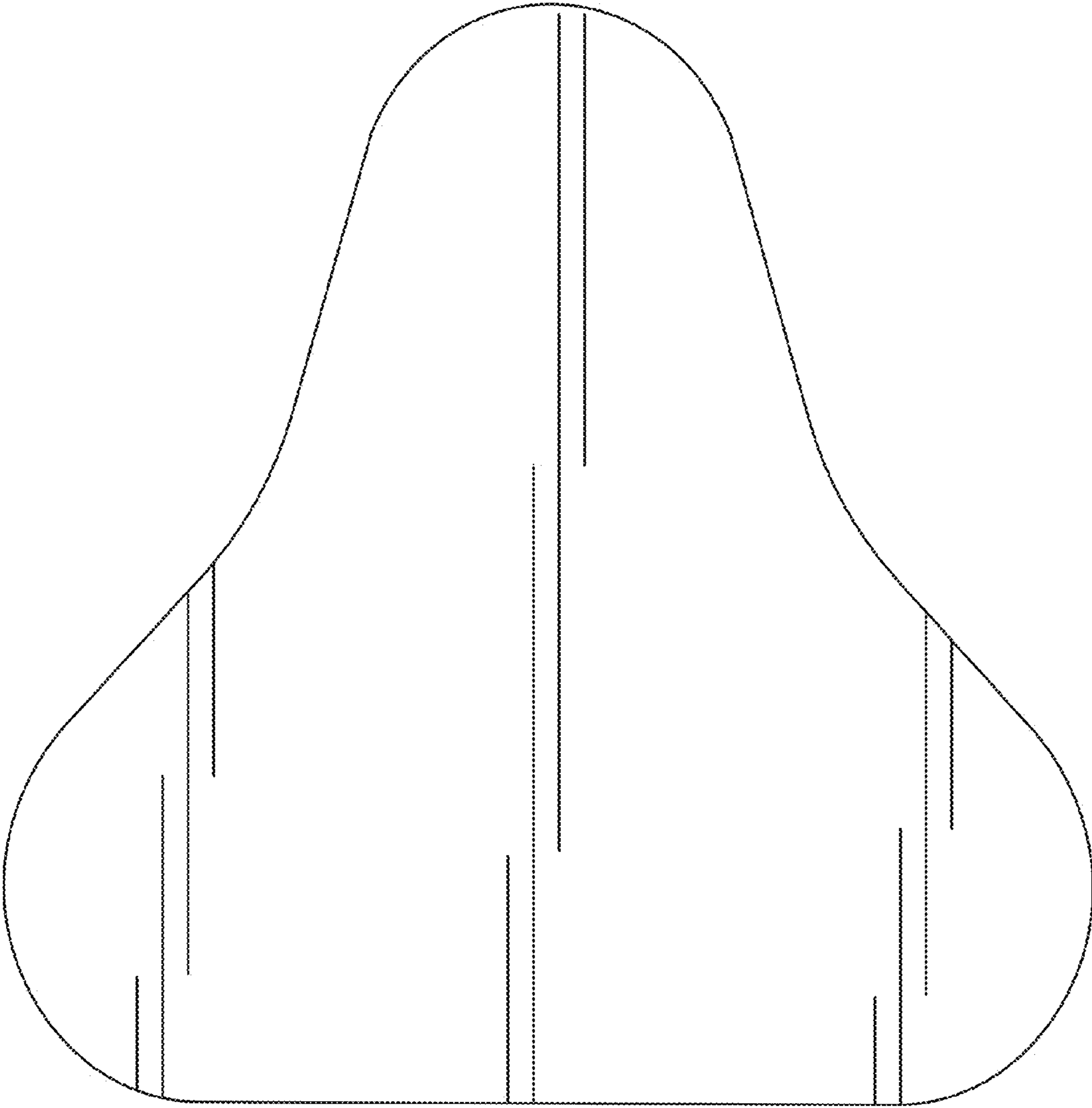
