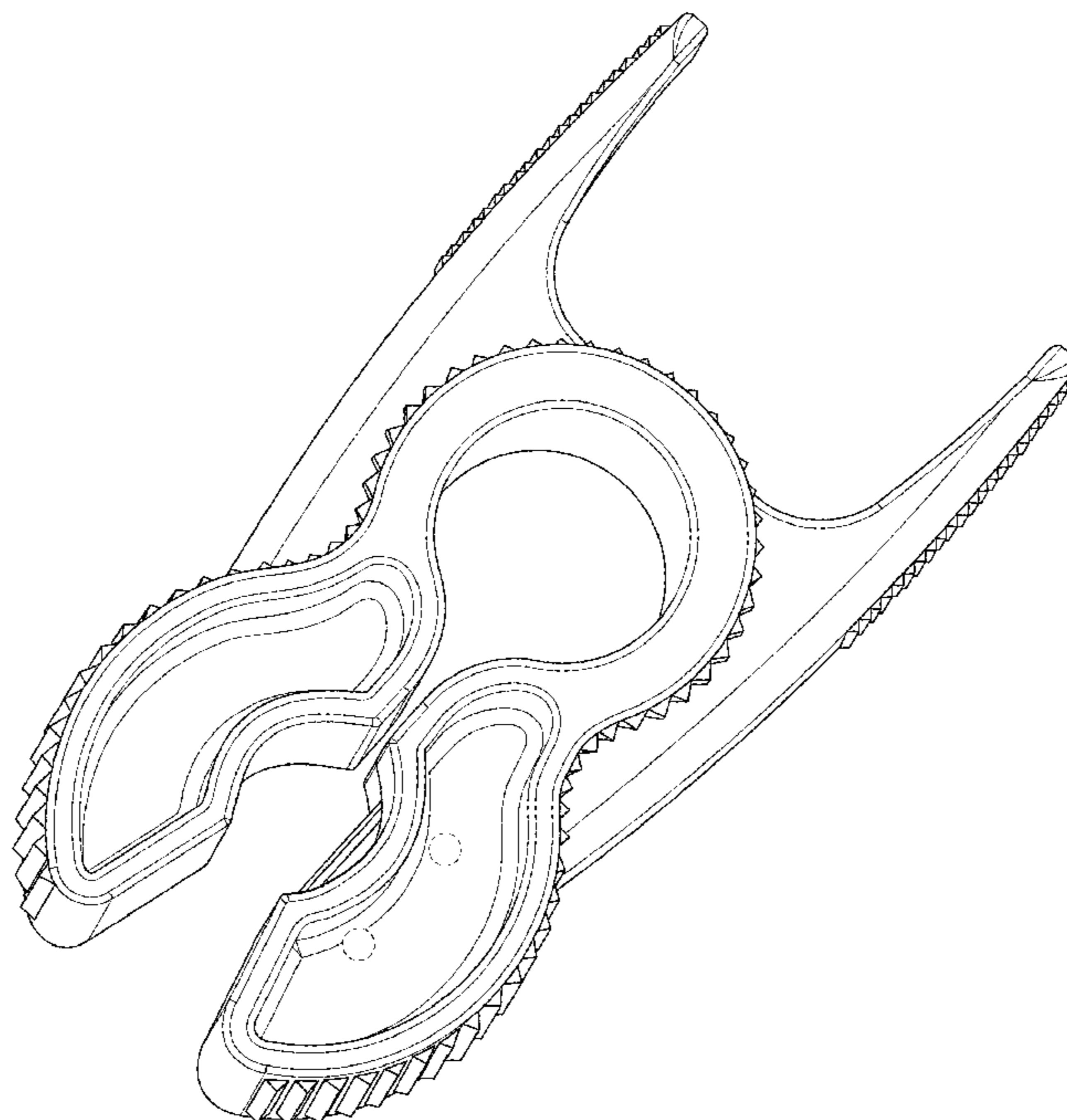
(57) **CLAIM**

We claim, the ornamental design for a cutting tool, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an embodiment of the invention;  
FIG. 2 is a top view of the embodiment of FIG. 1, the bottom view being a mirror image thereof;  
FIG. 3 is a first end view of the embodiment of FIG. 1;  
FIG. 4 is a second end view of the embodiment of FIG. 1; and,  
FIG. 5 is a first side view of the embodiment of FIG. 1, the opposing side being a mirror image thereof.  
The broken lines in FIG. 1 and FIG. 2 illustrate portions of the cutting tool which form no part of the claimed design.

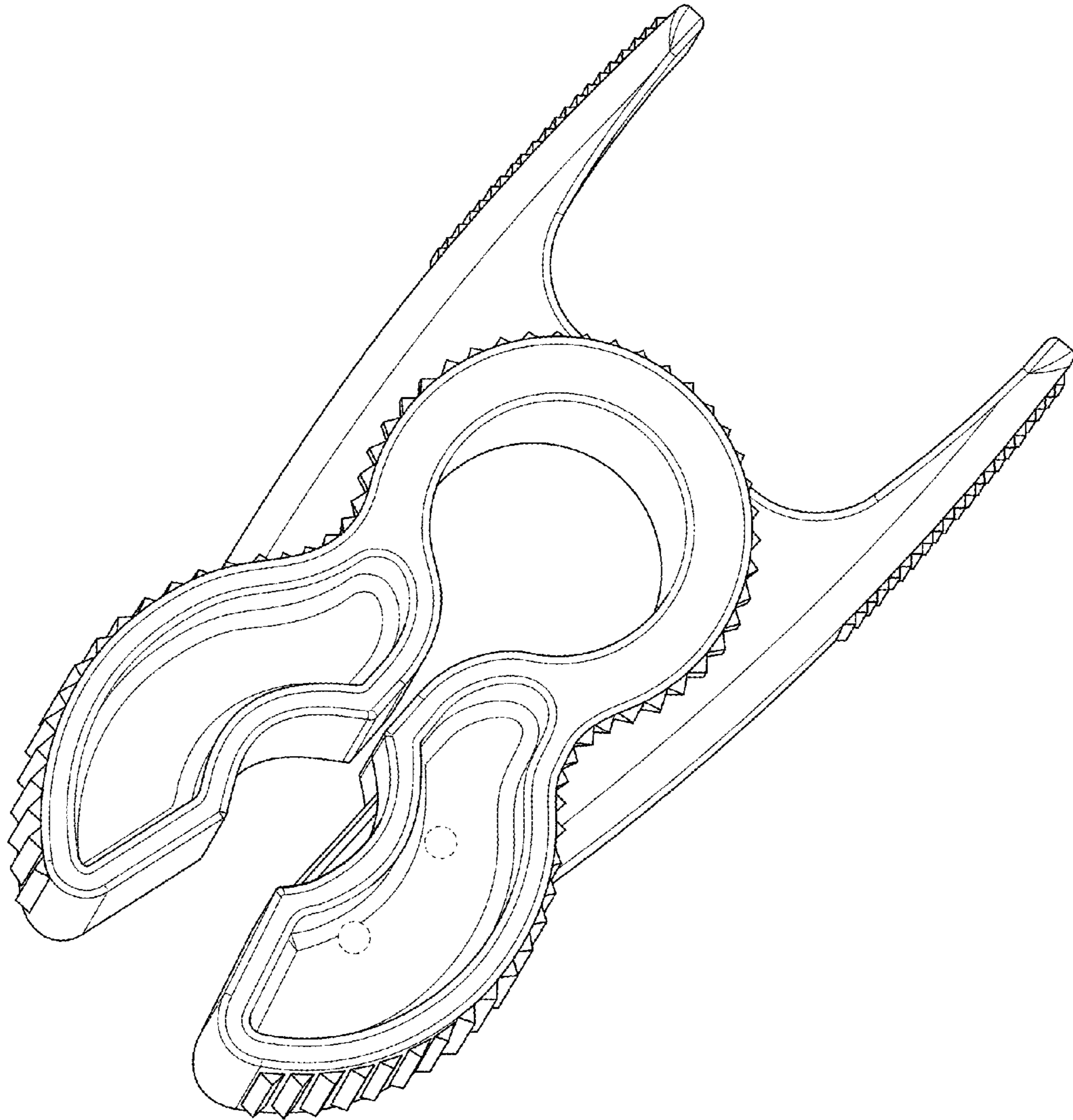

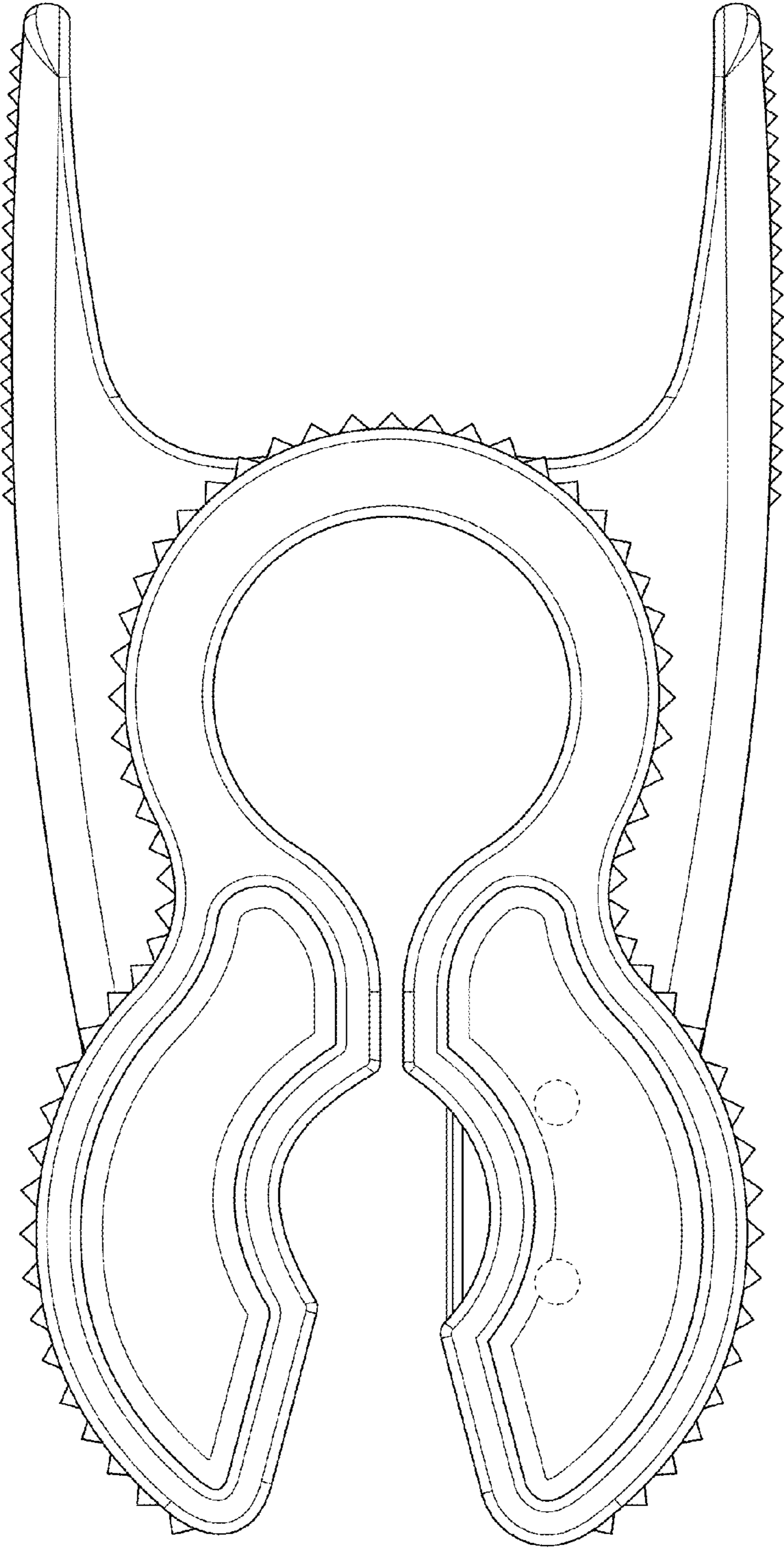

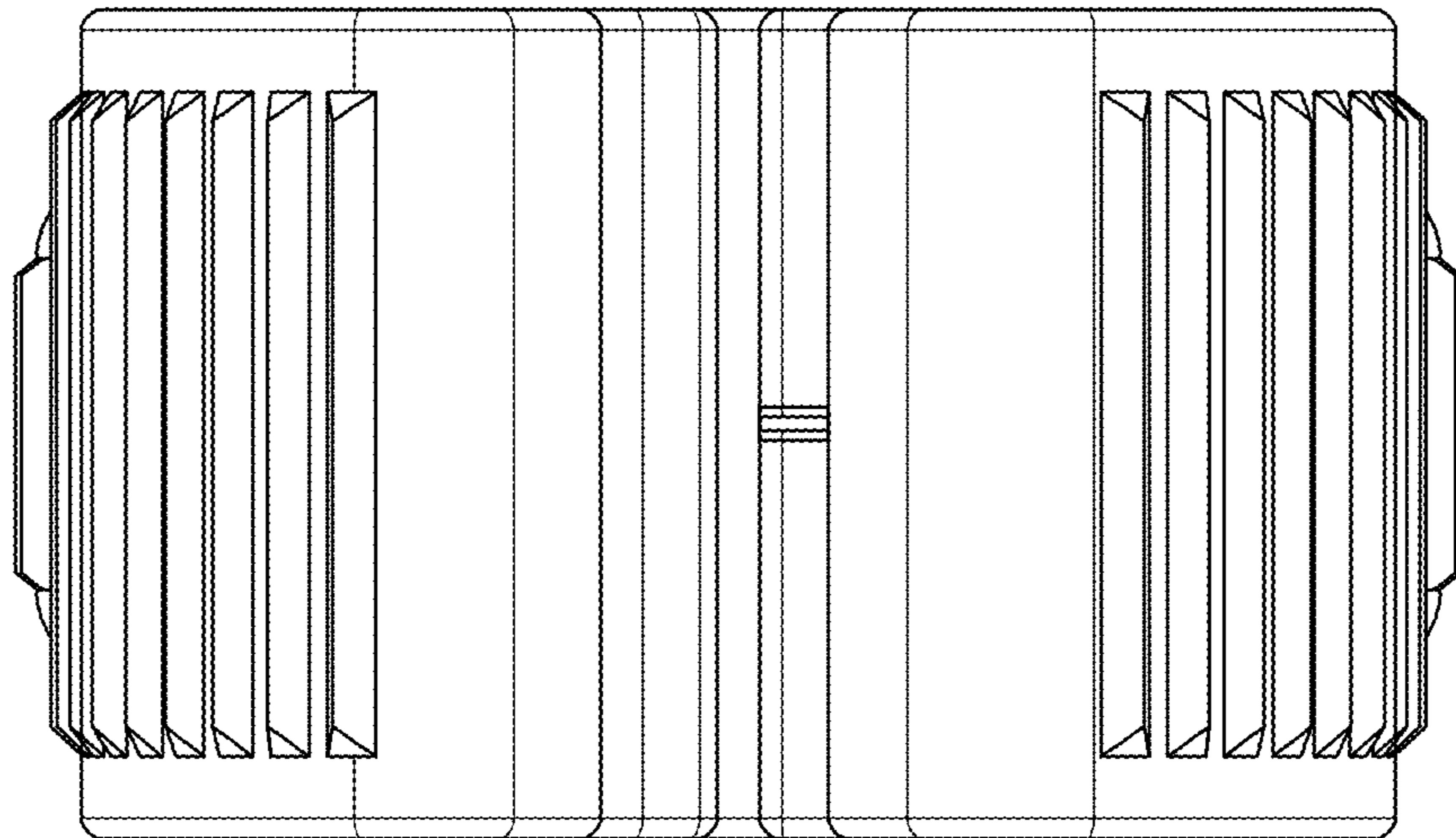

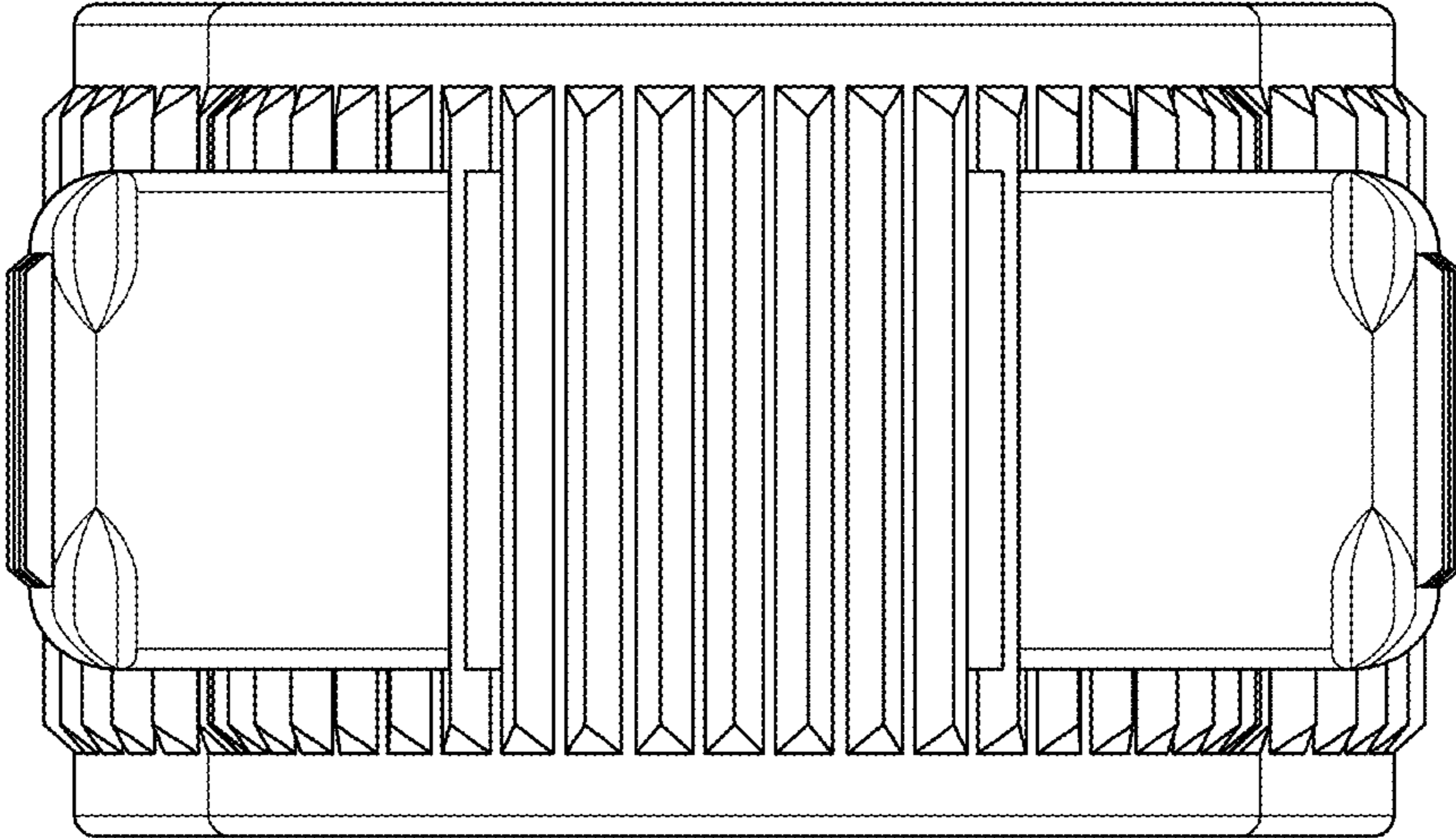

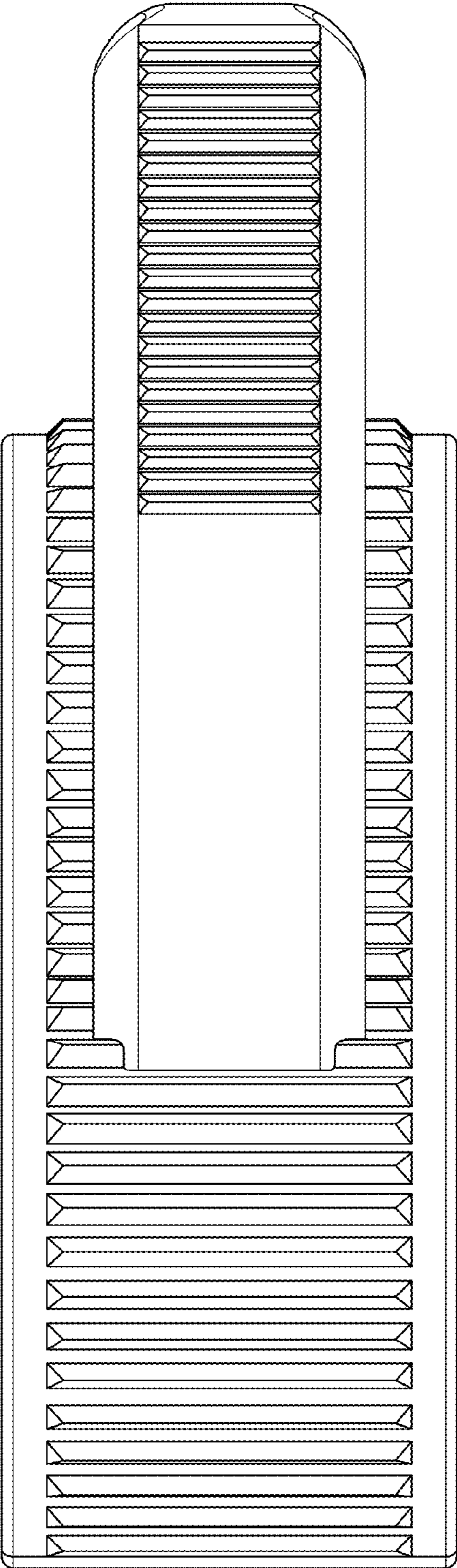
