The ornamental design for a mechanical connector, as shown and described.

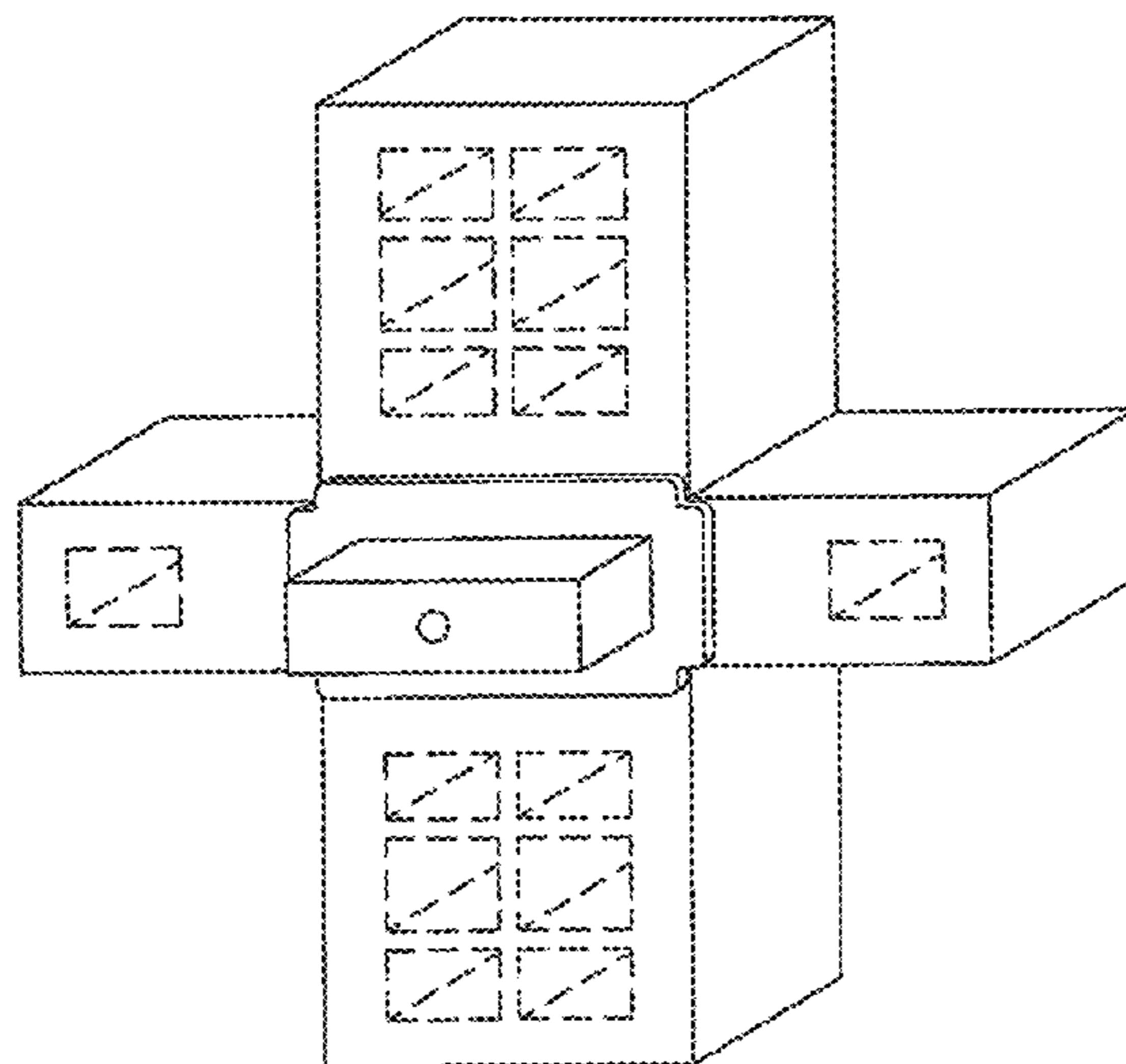
DESCRIPTION

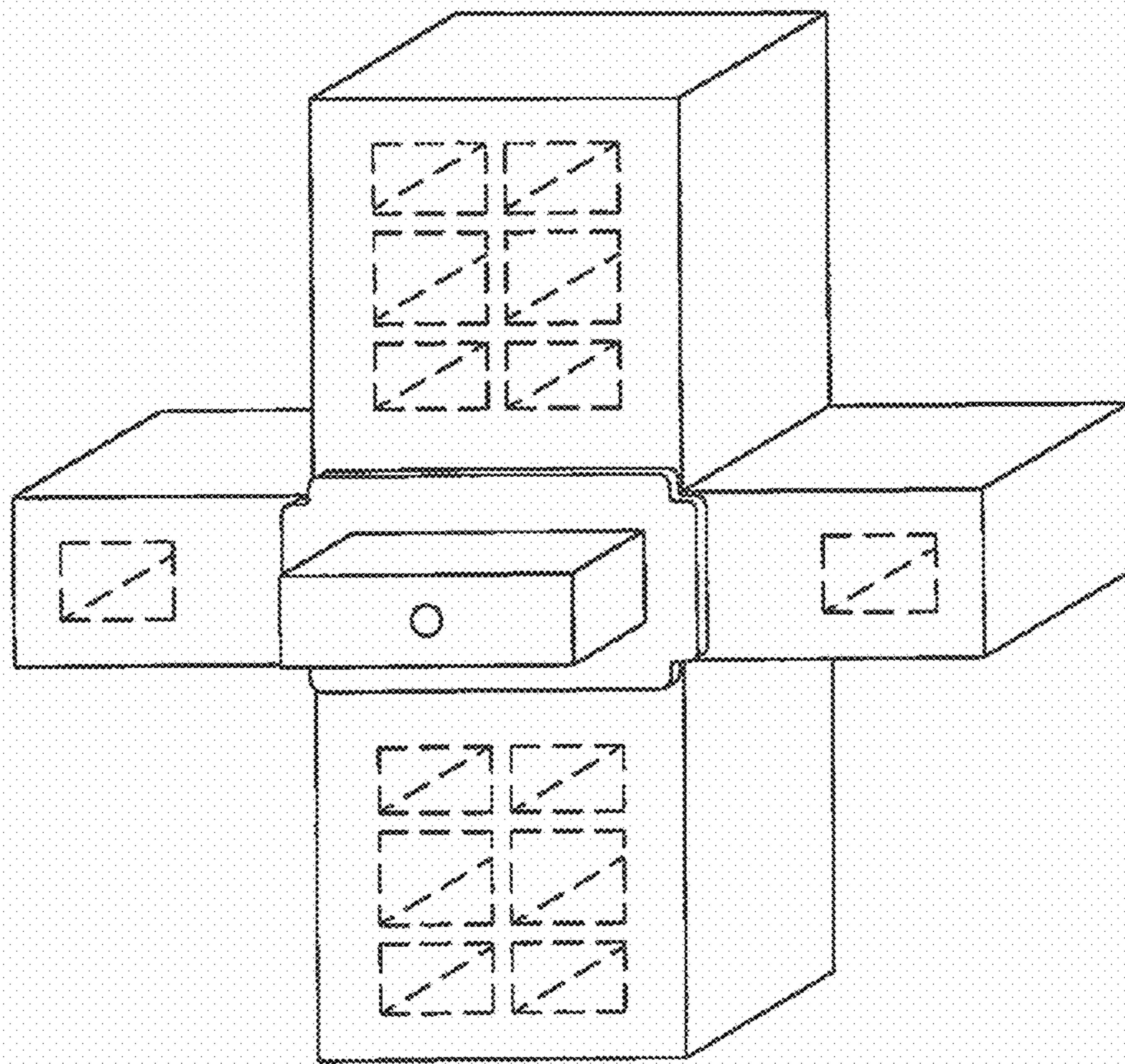

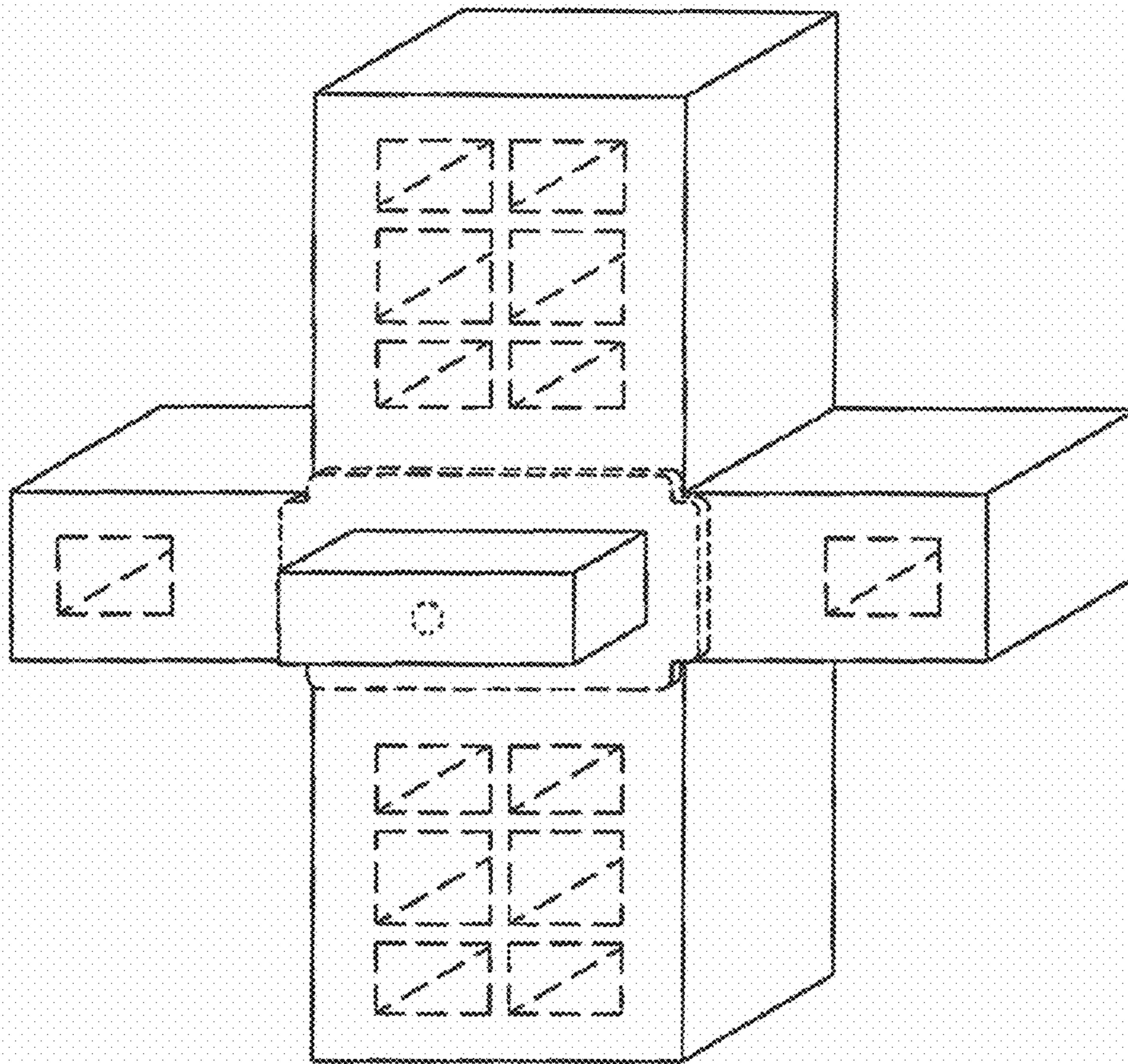

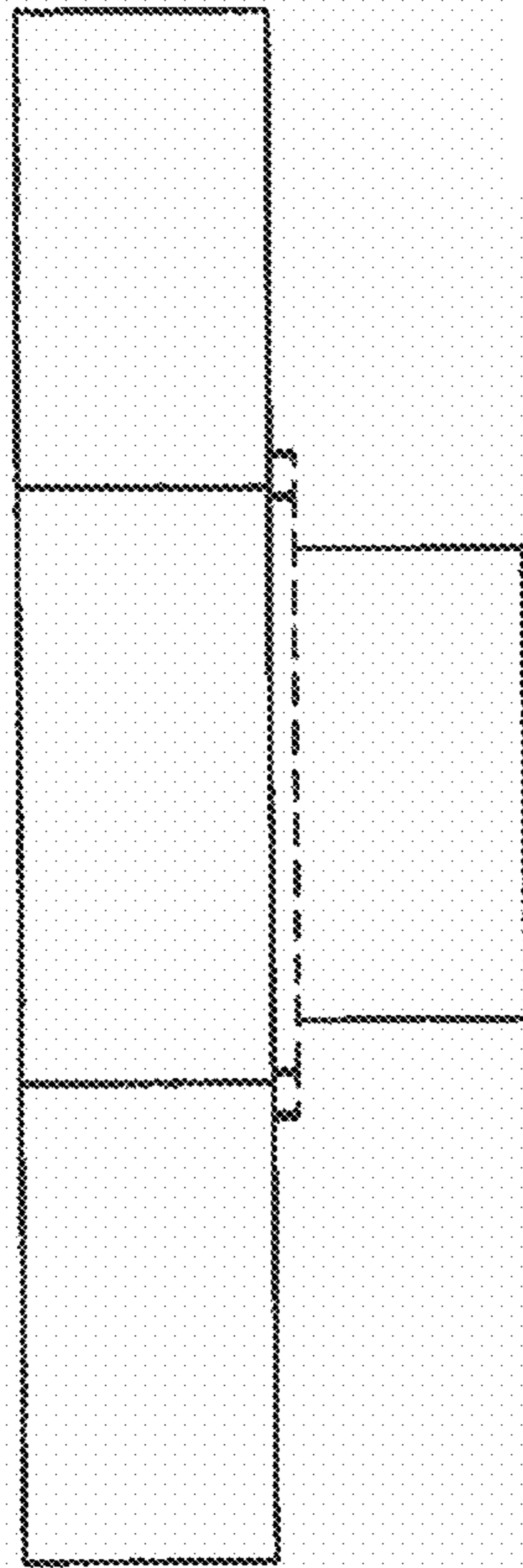

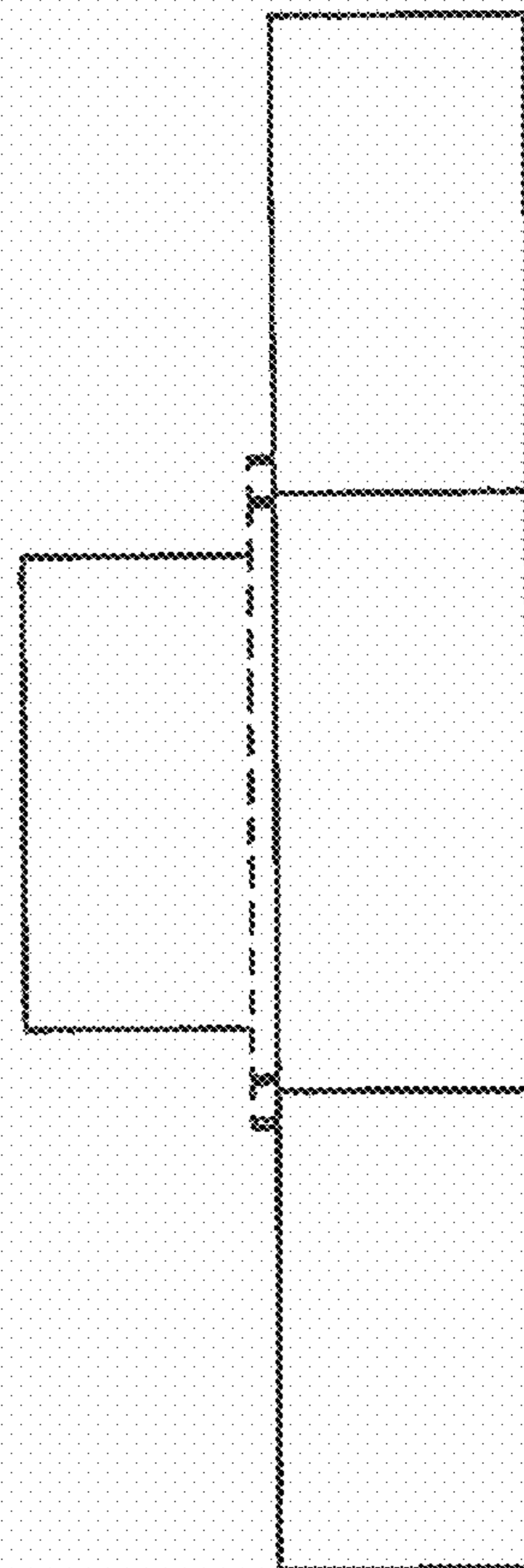

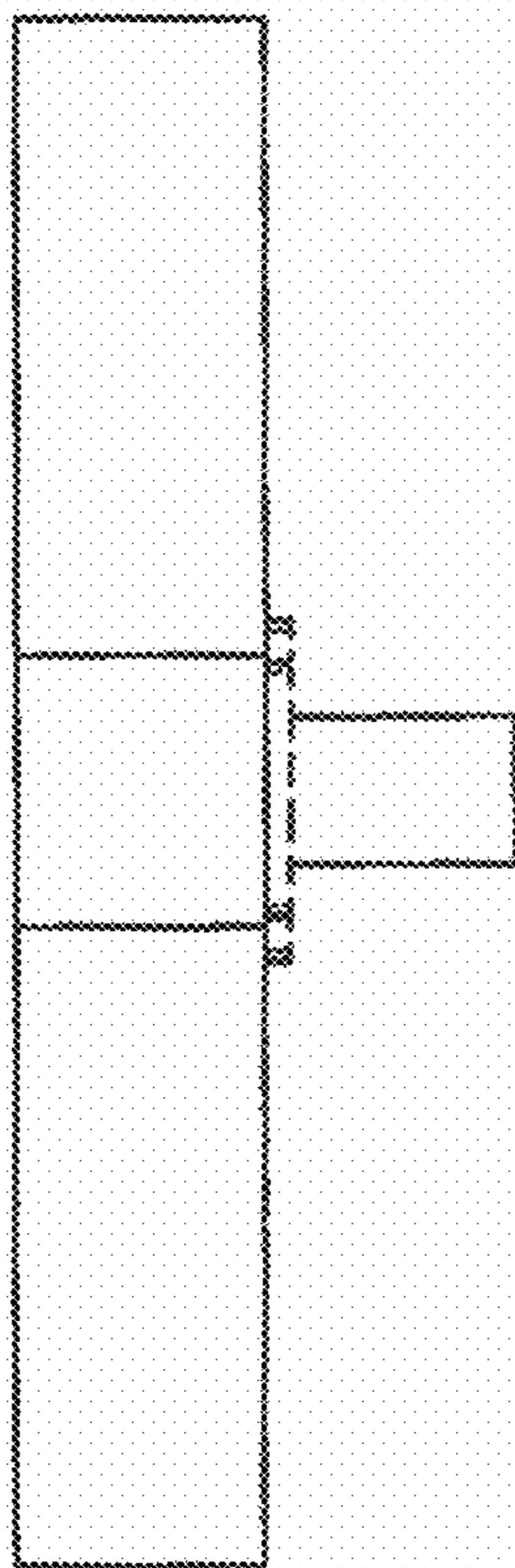
