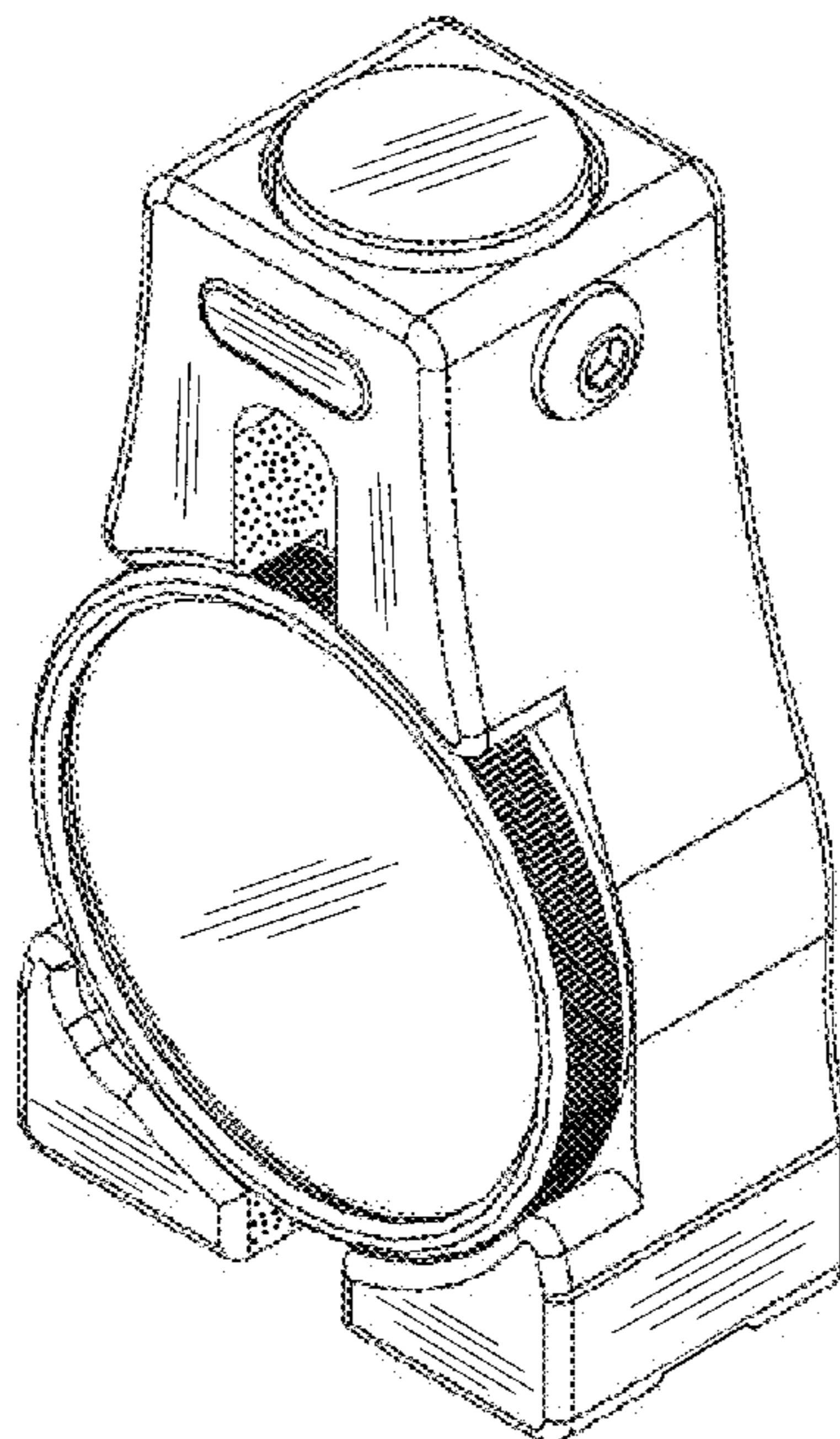
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front right perspective view of a pro touch off gauge showing my new design;

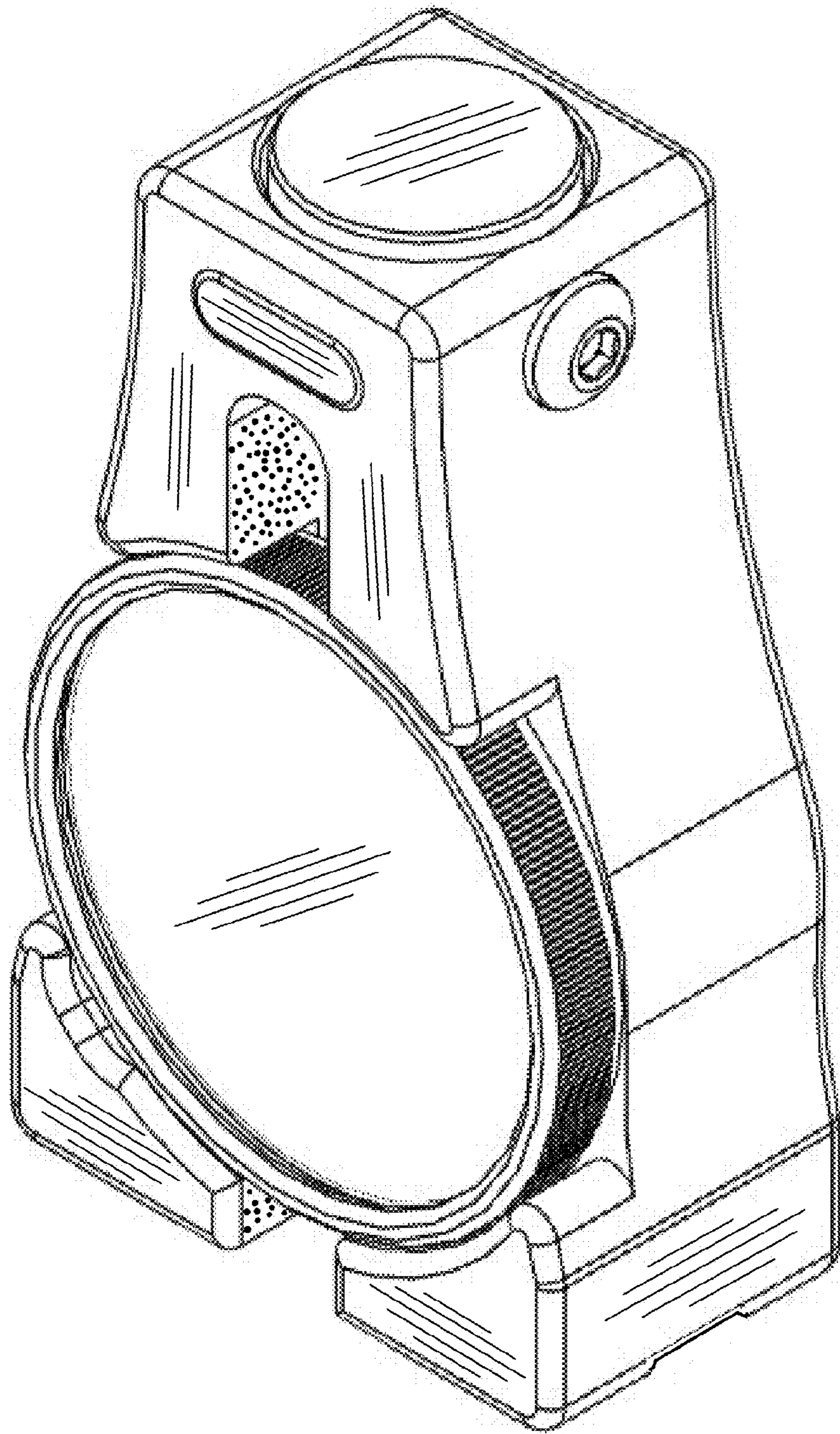

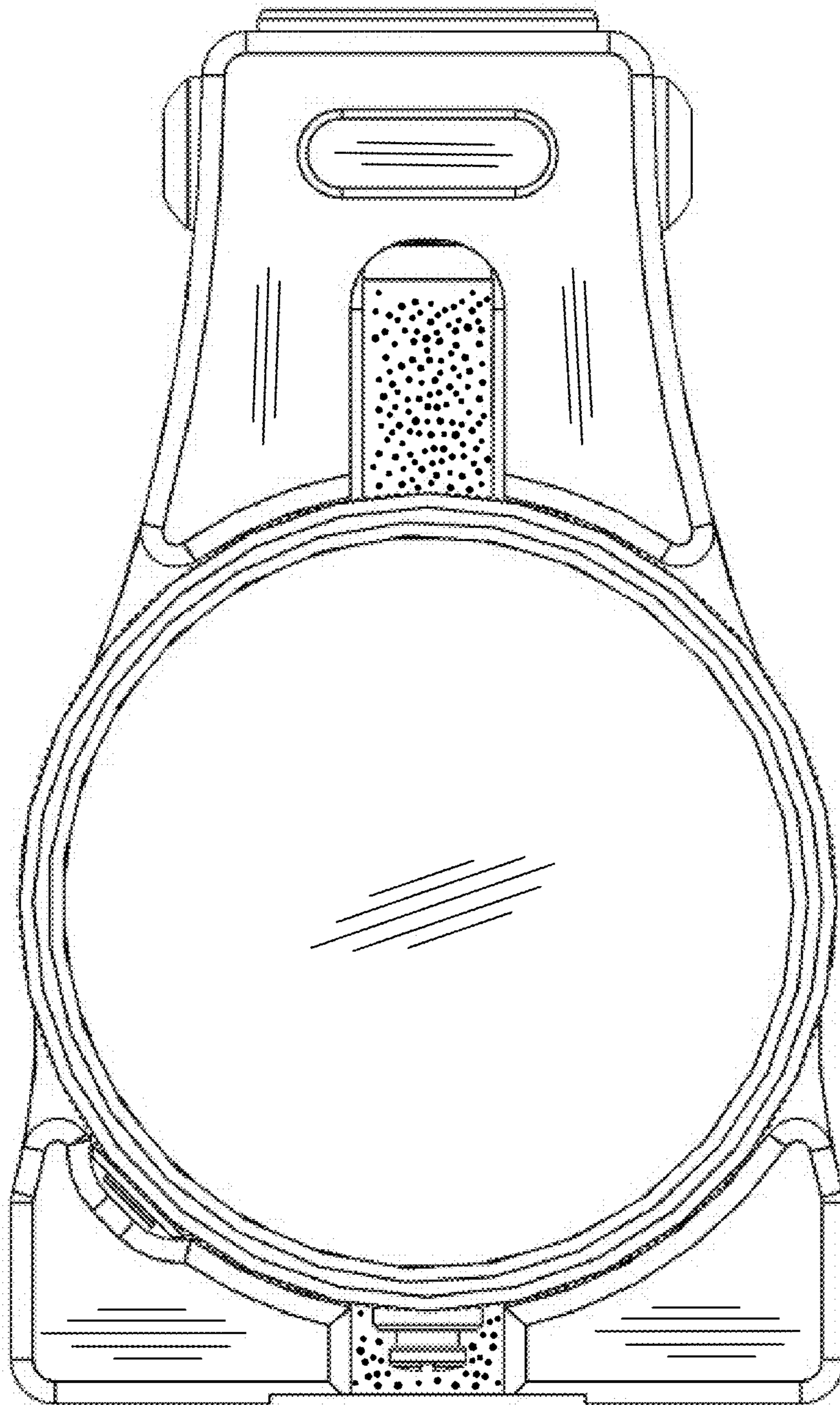

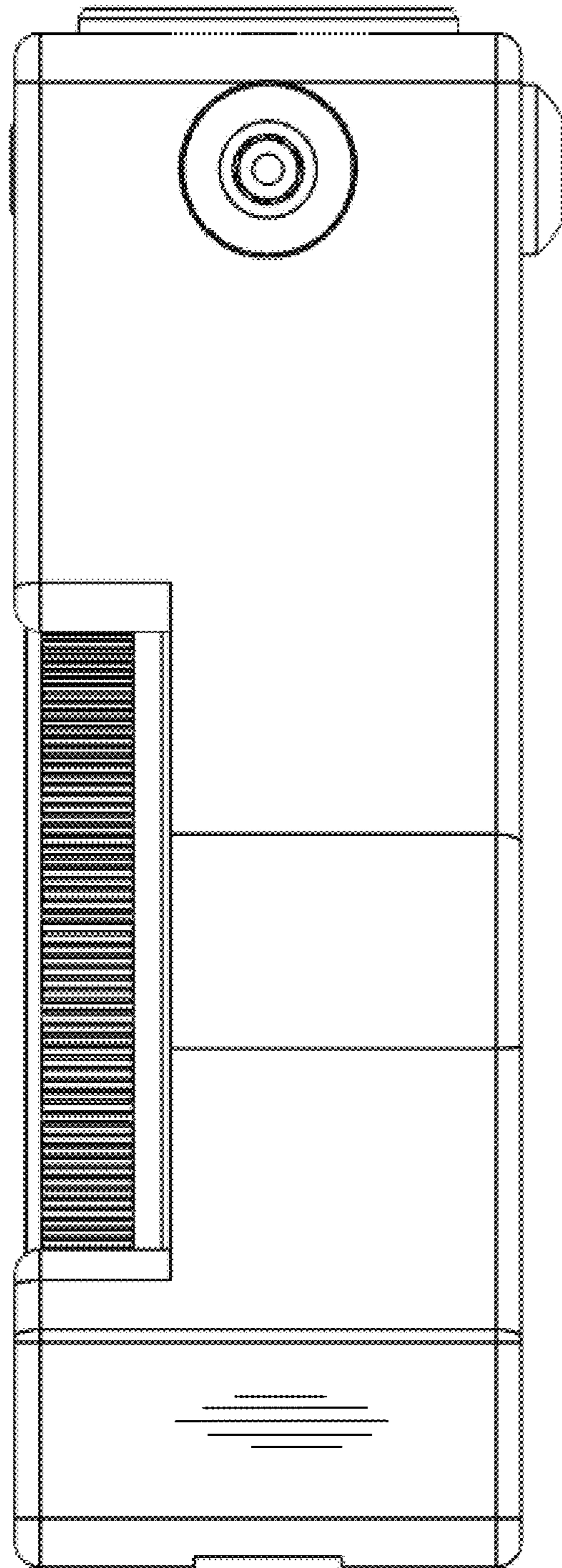

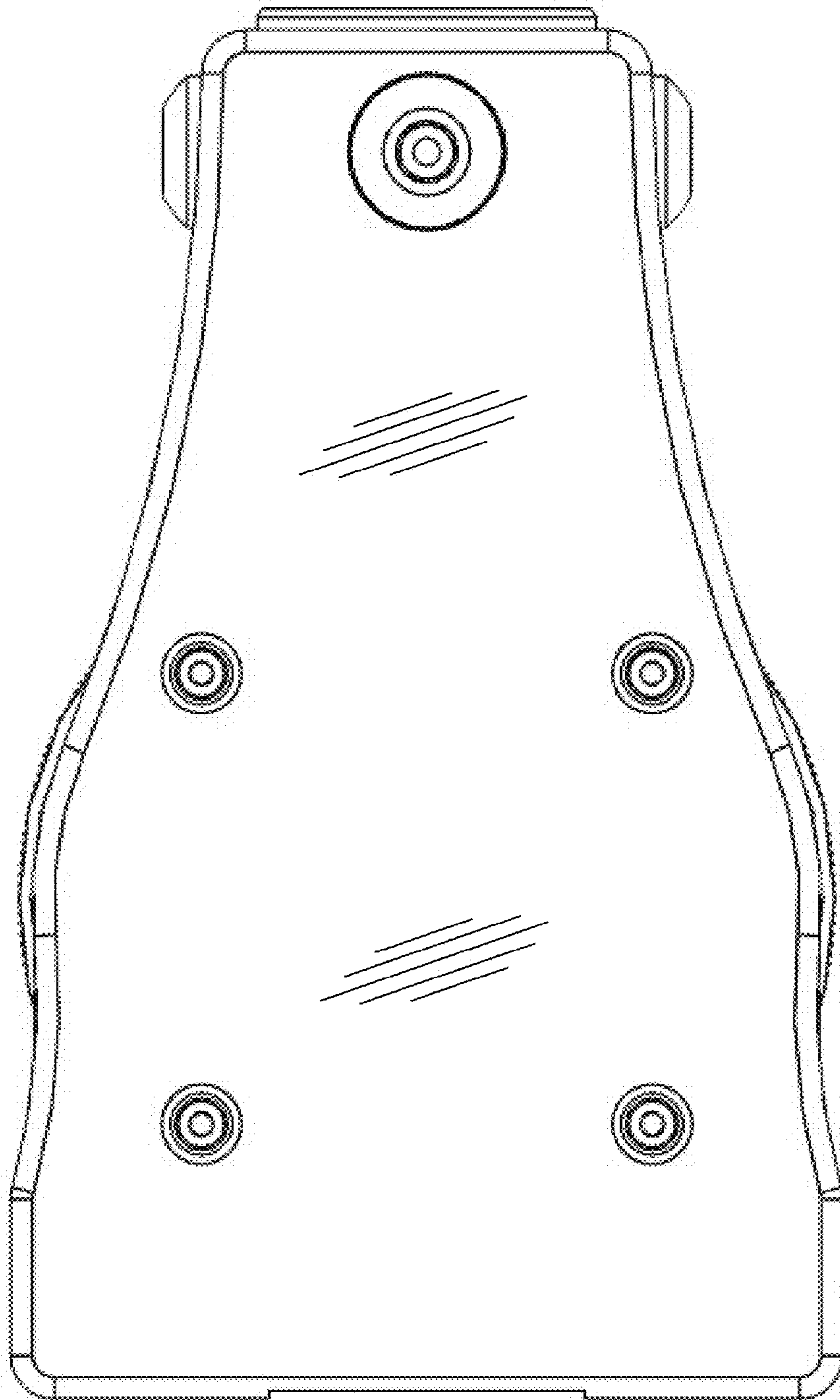

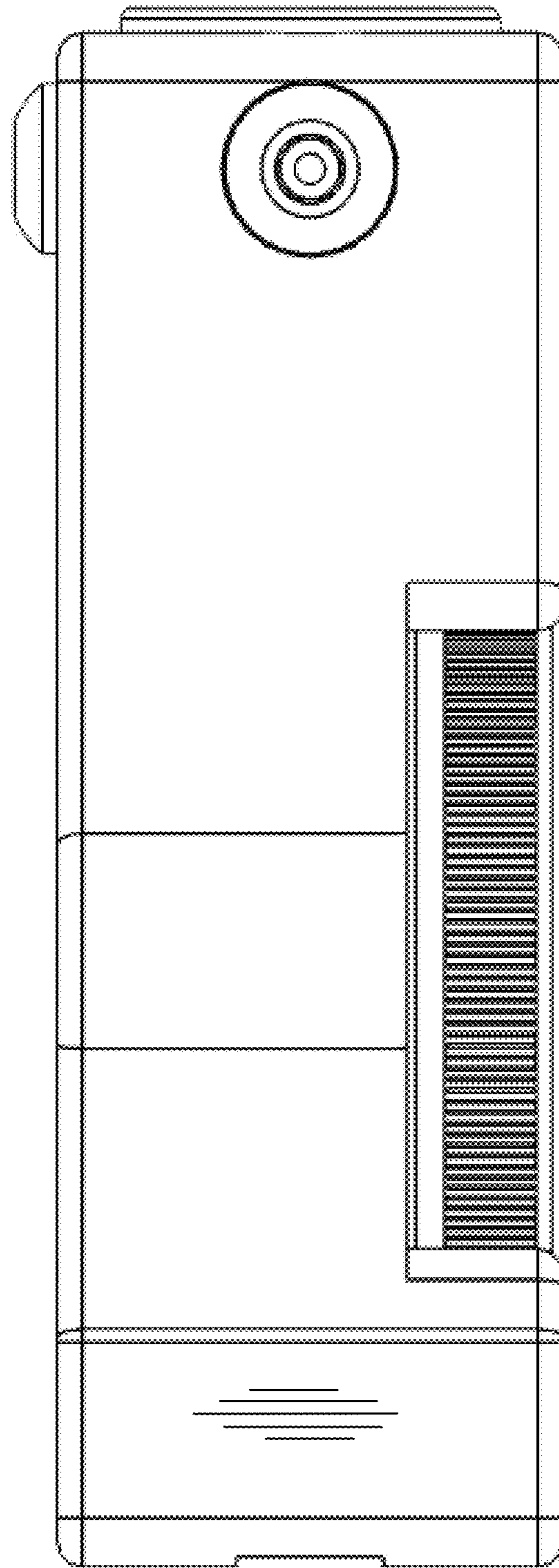

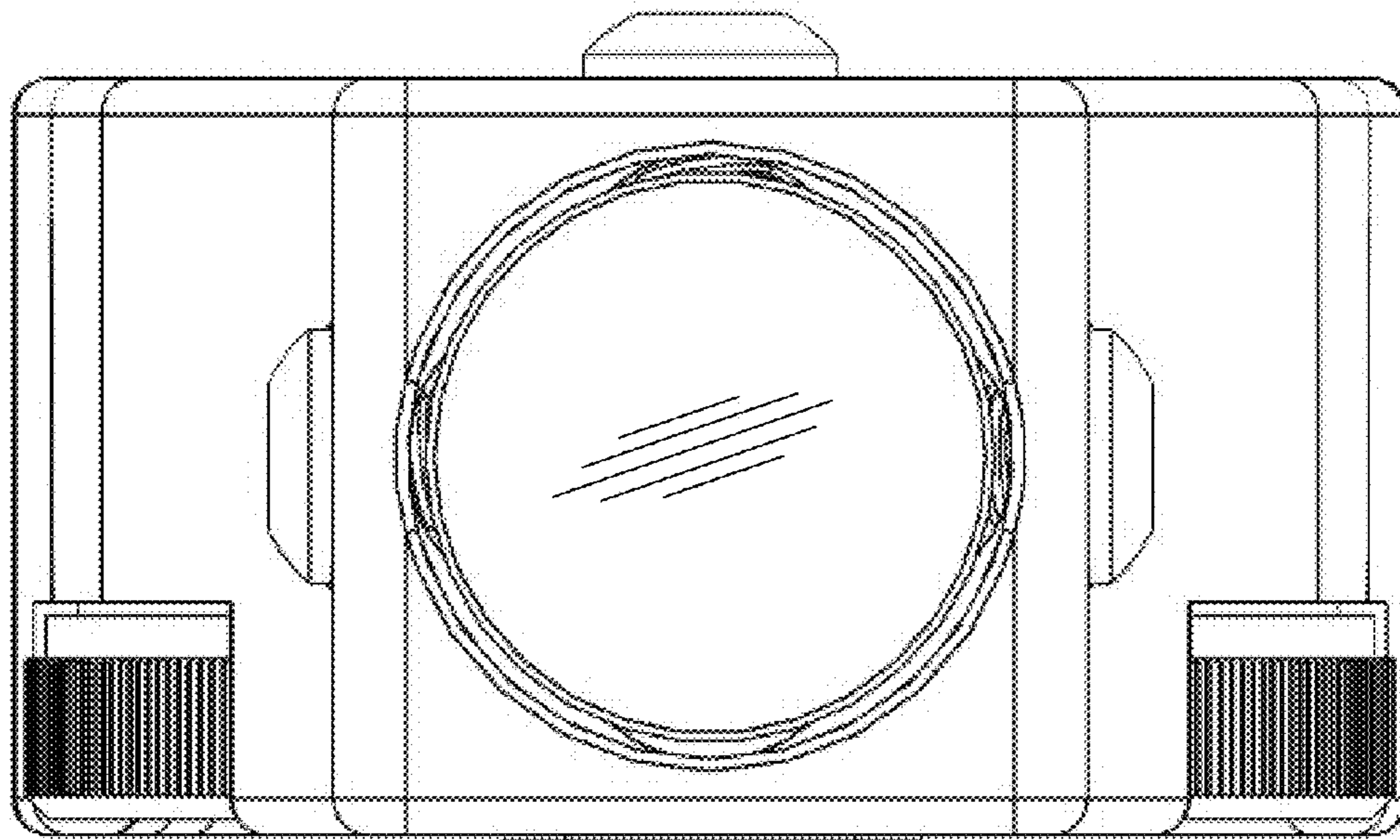

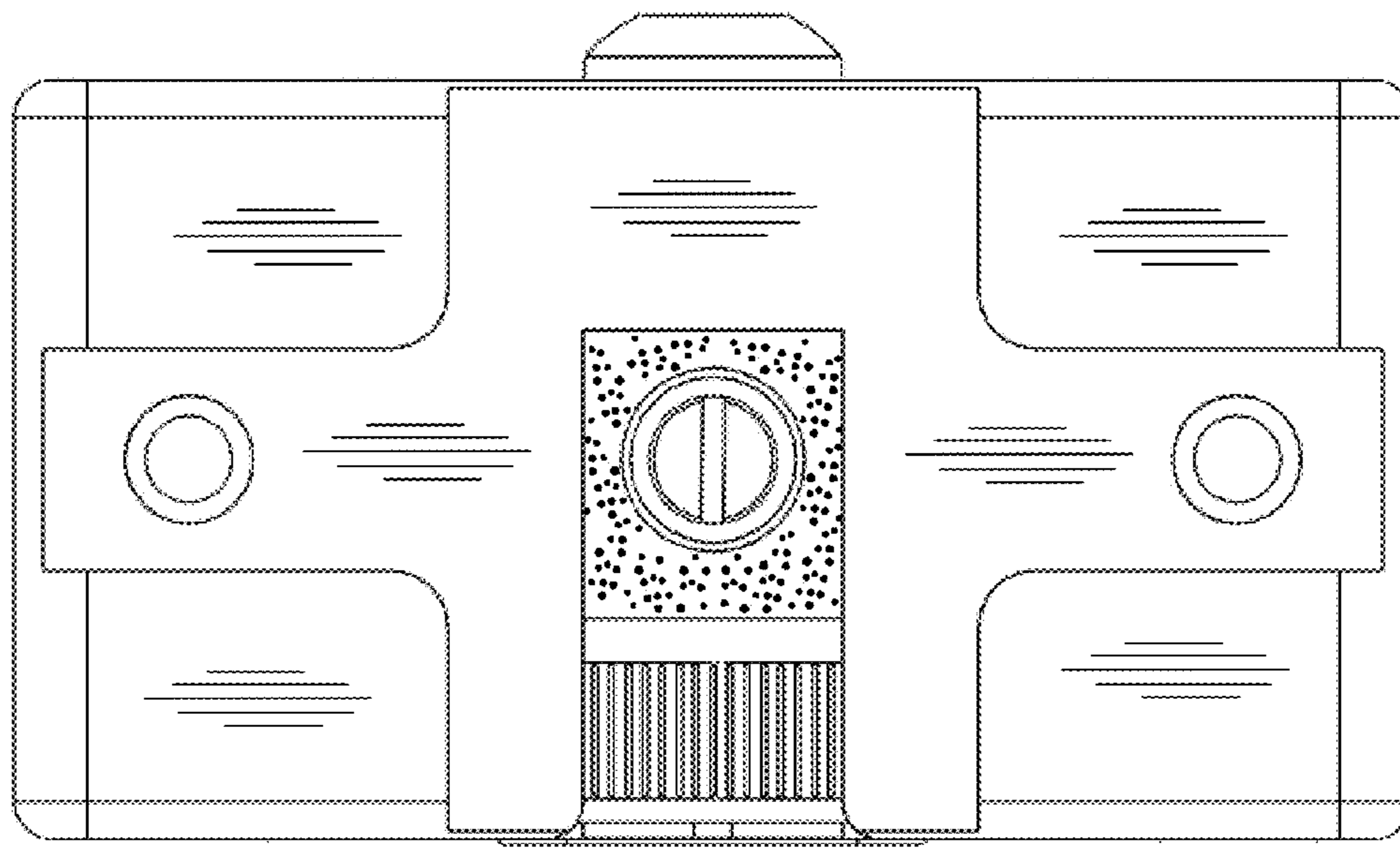

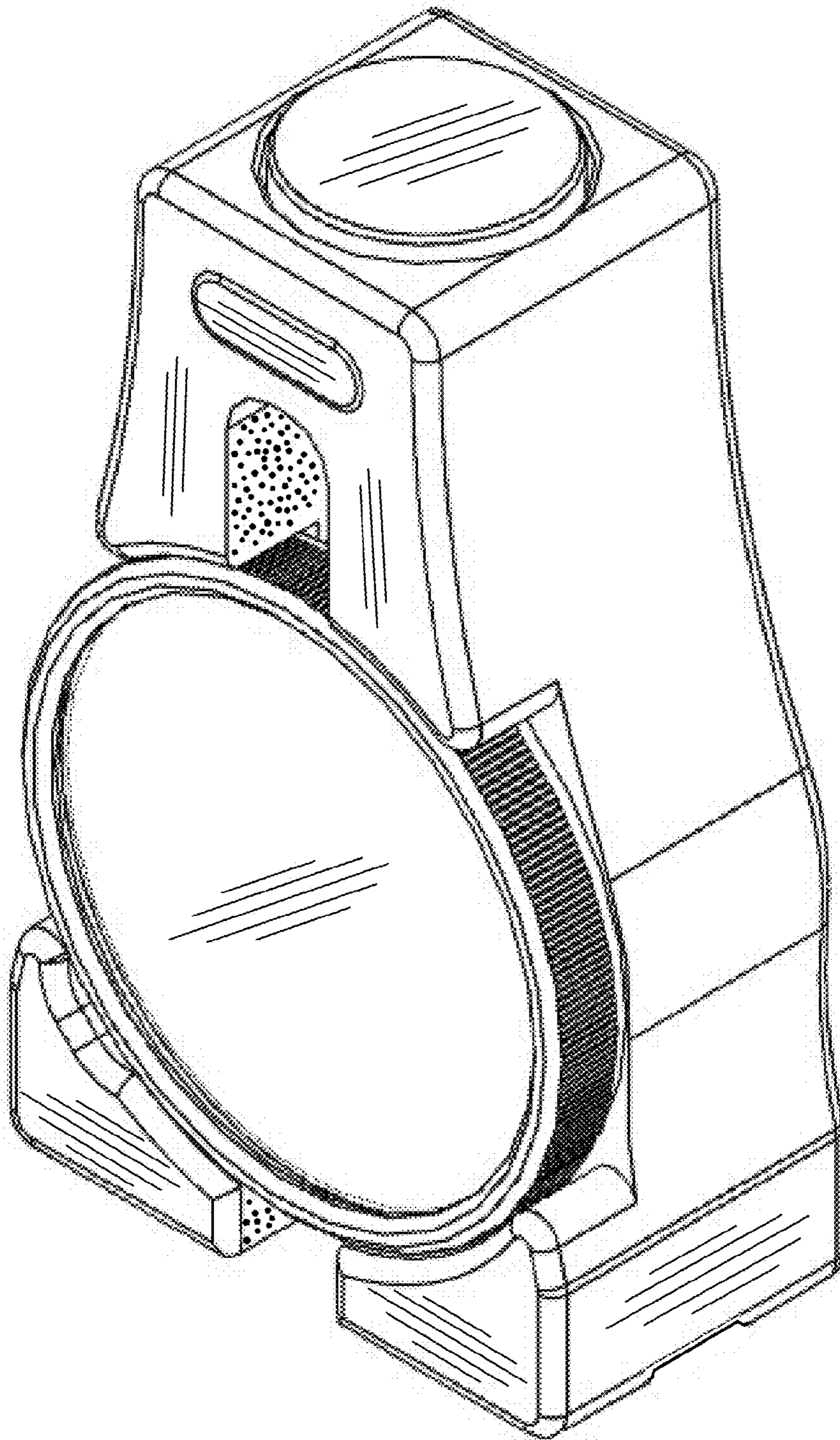

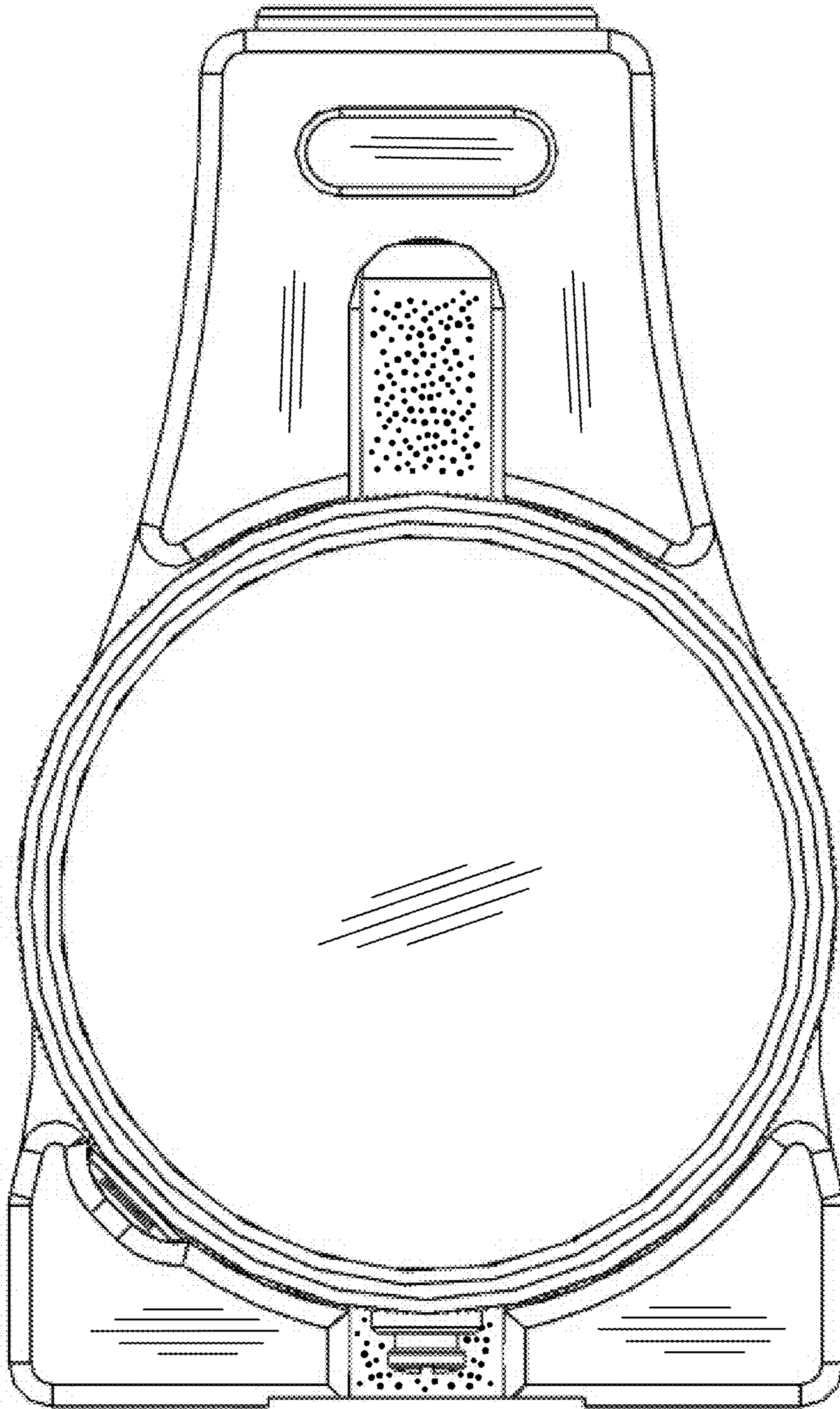

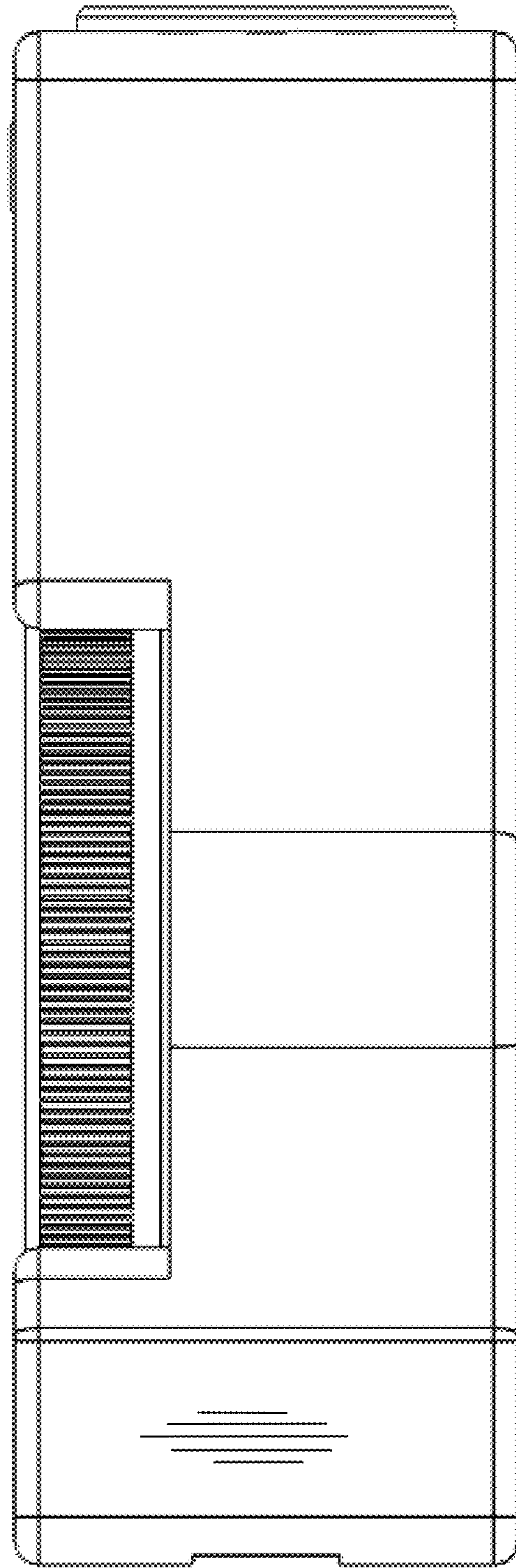

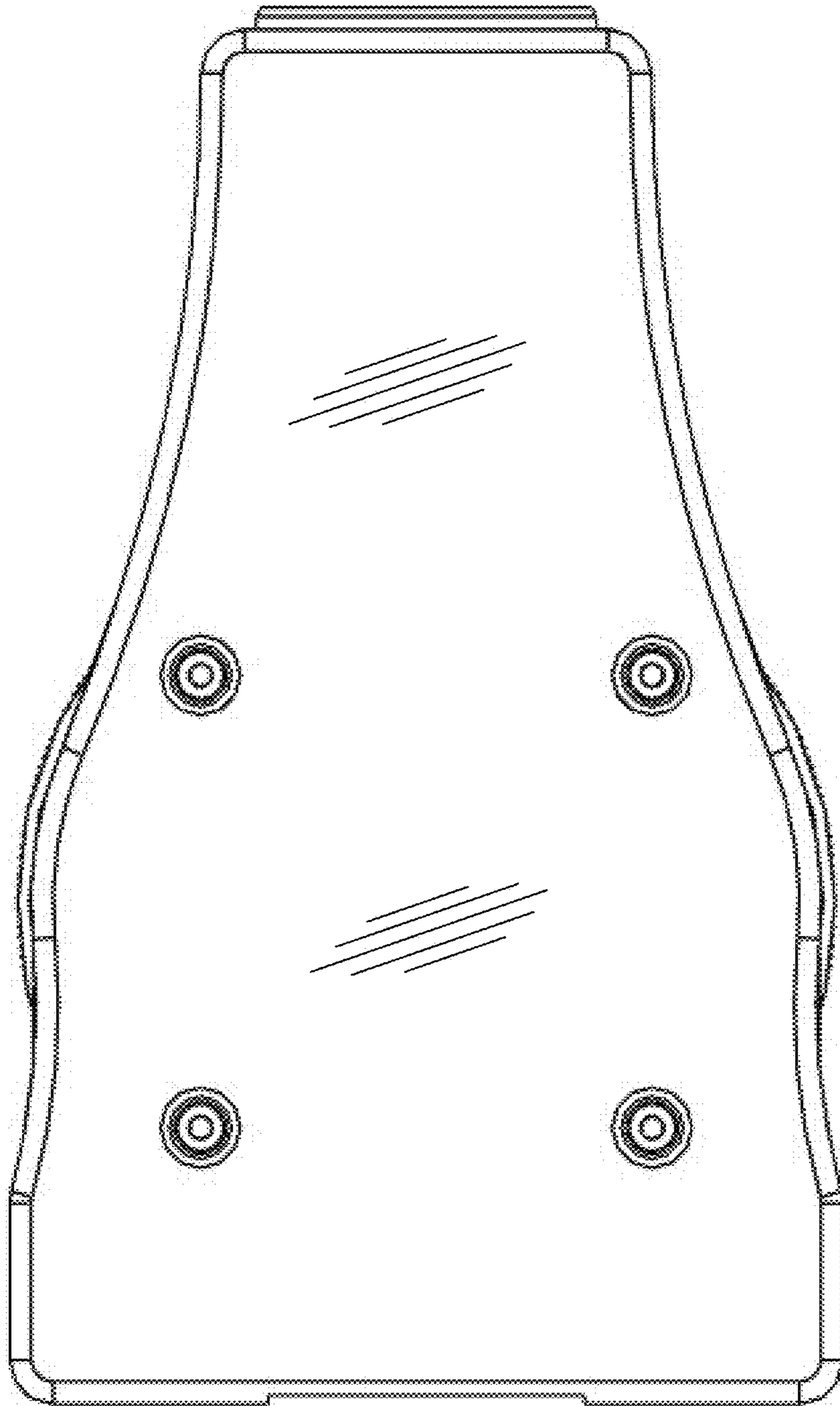

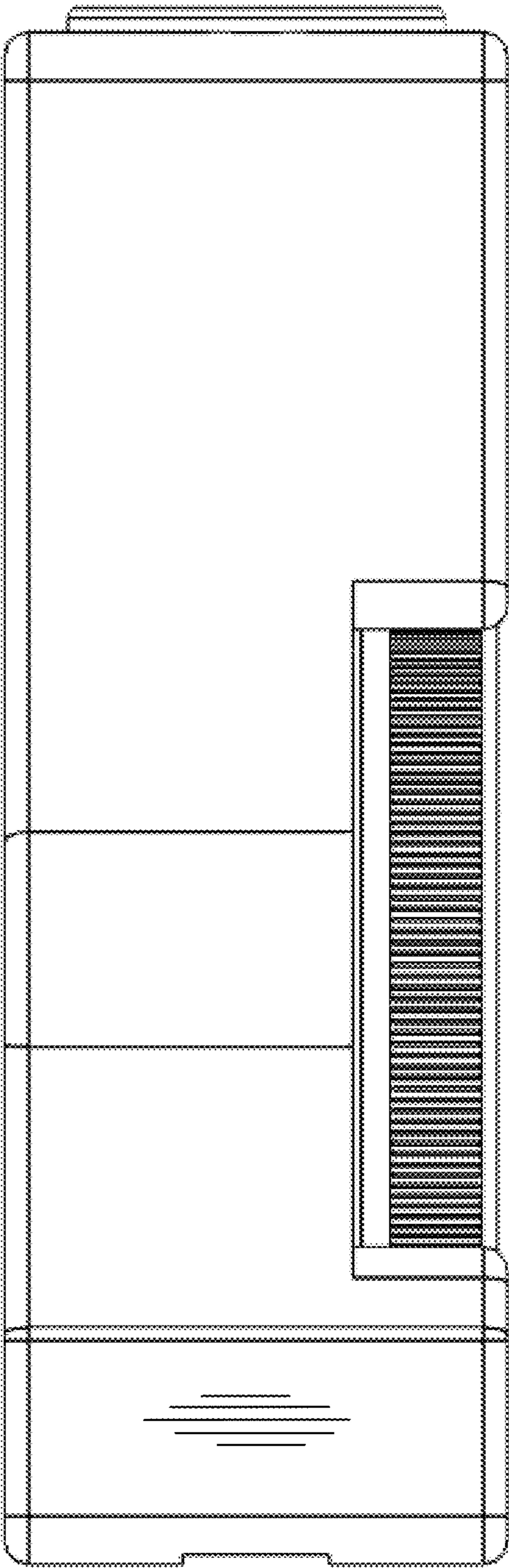

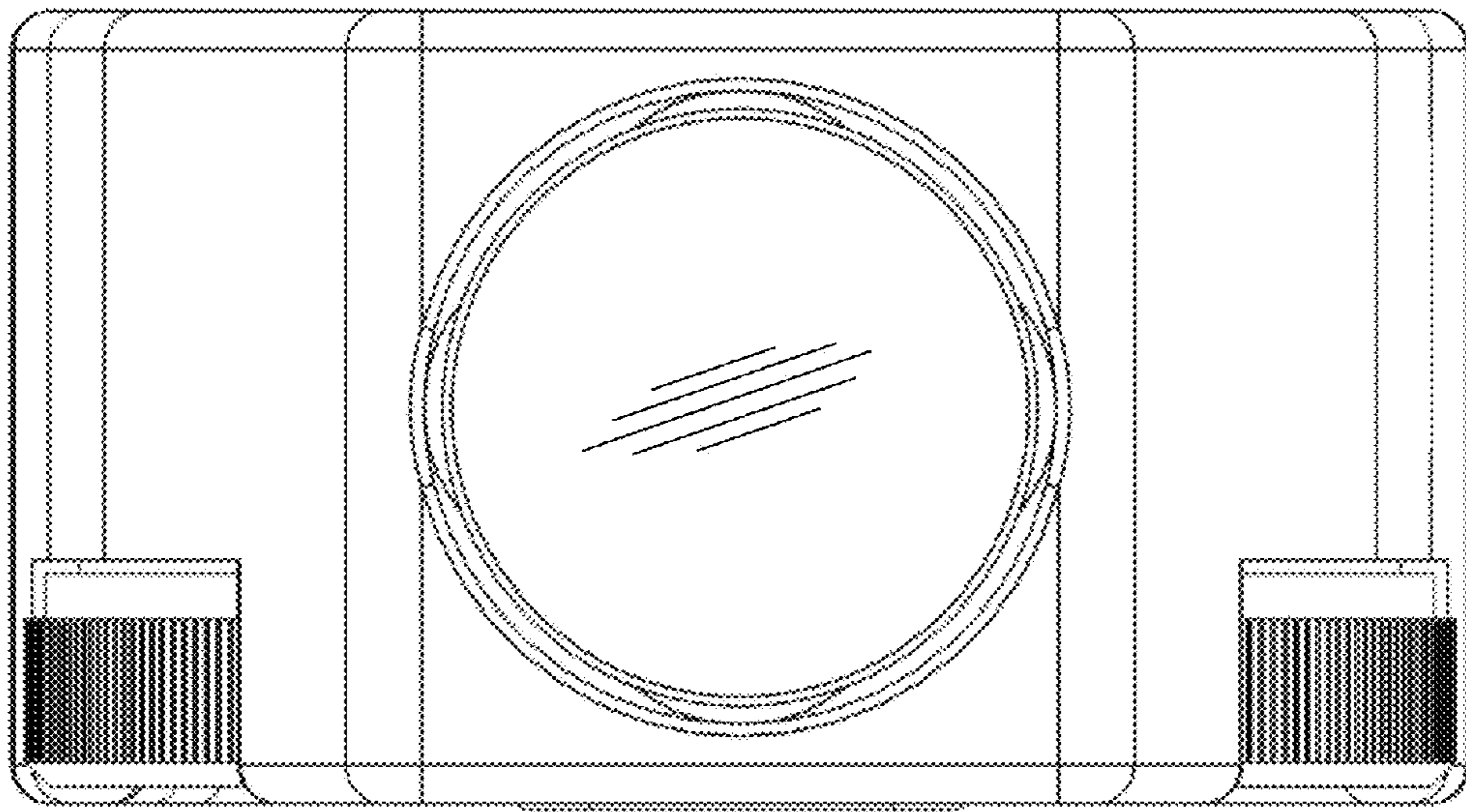

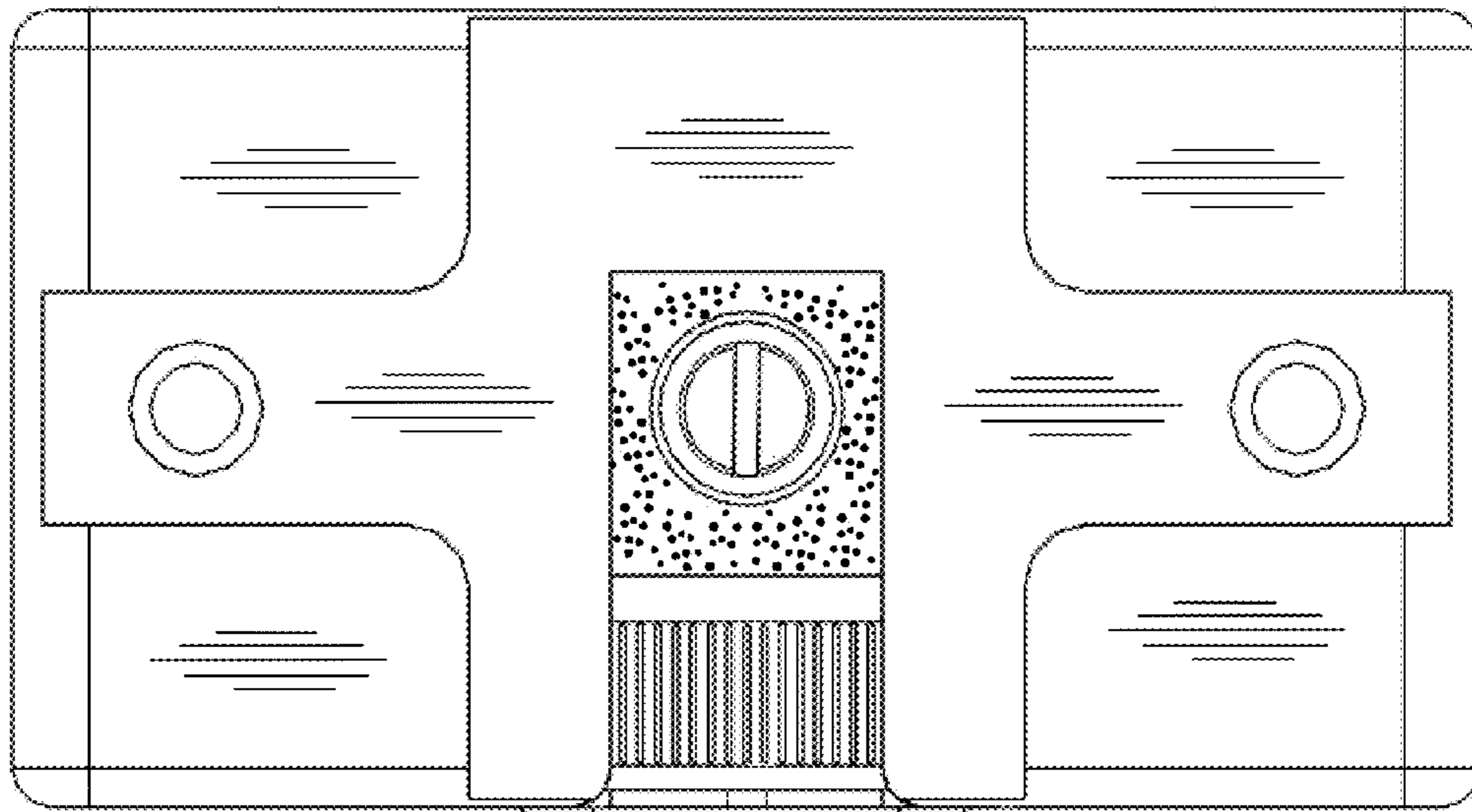
