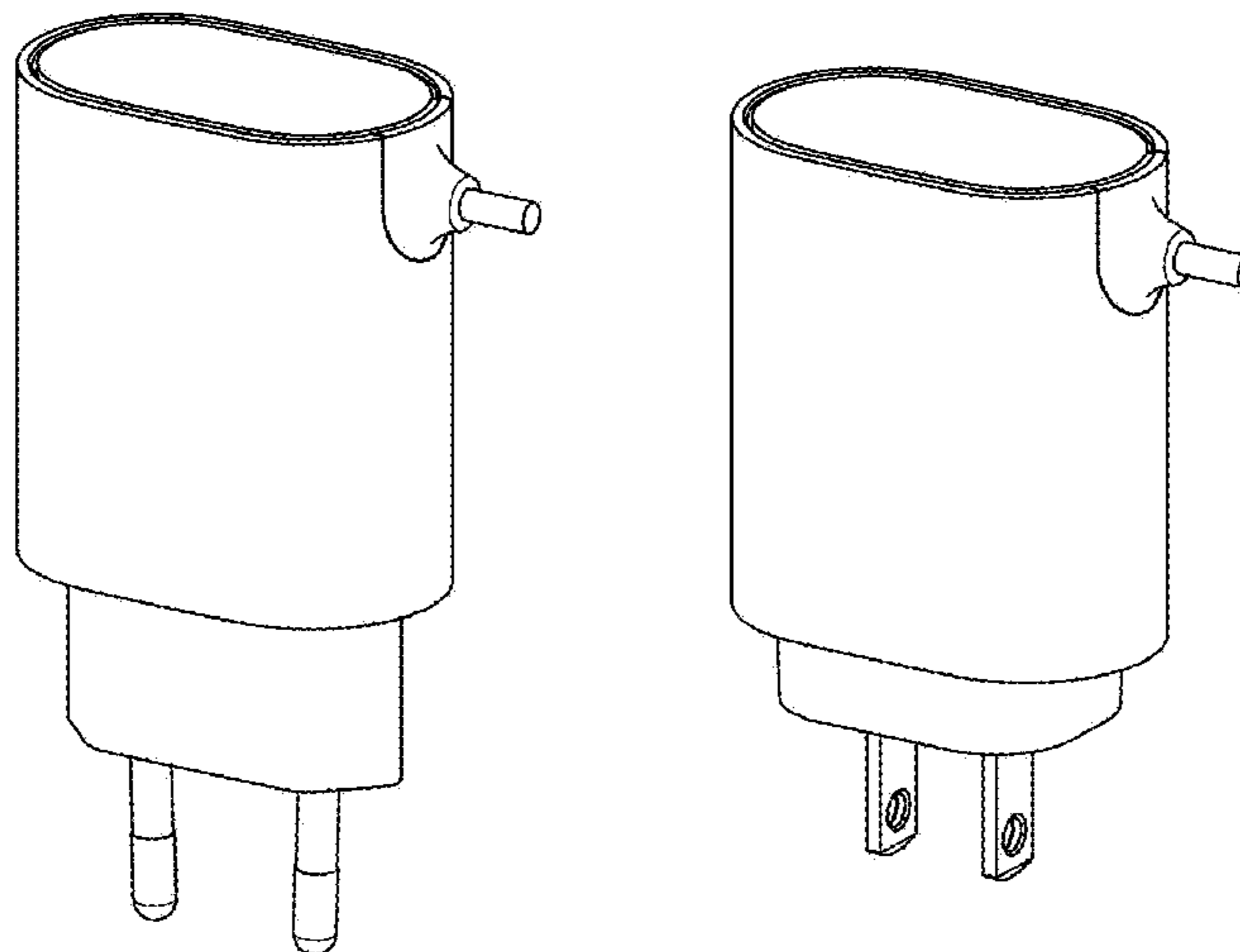

The ornamental design for an electrical plug, as shown and described.

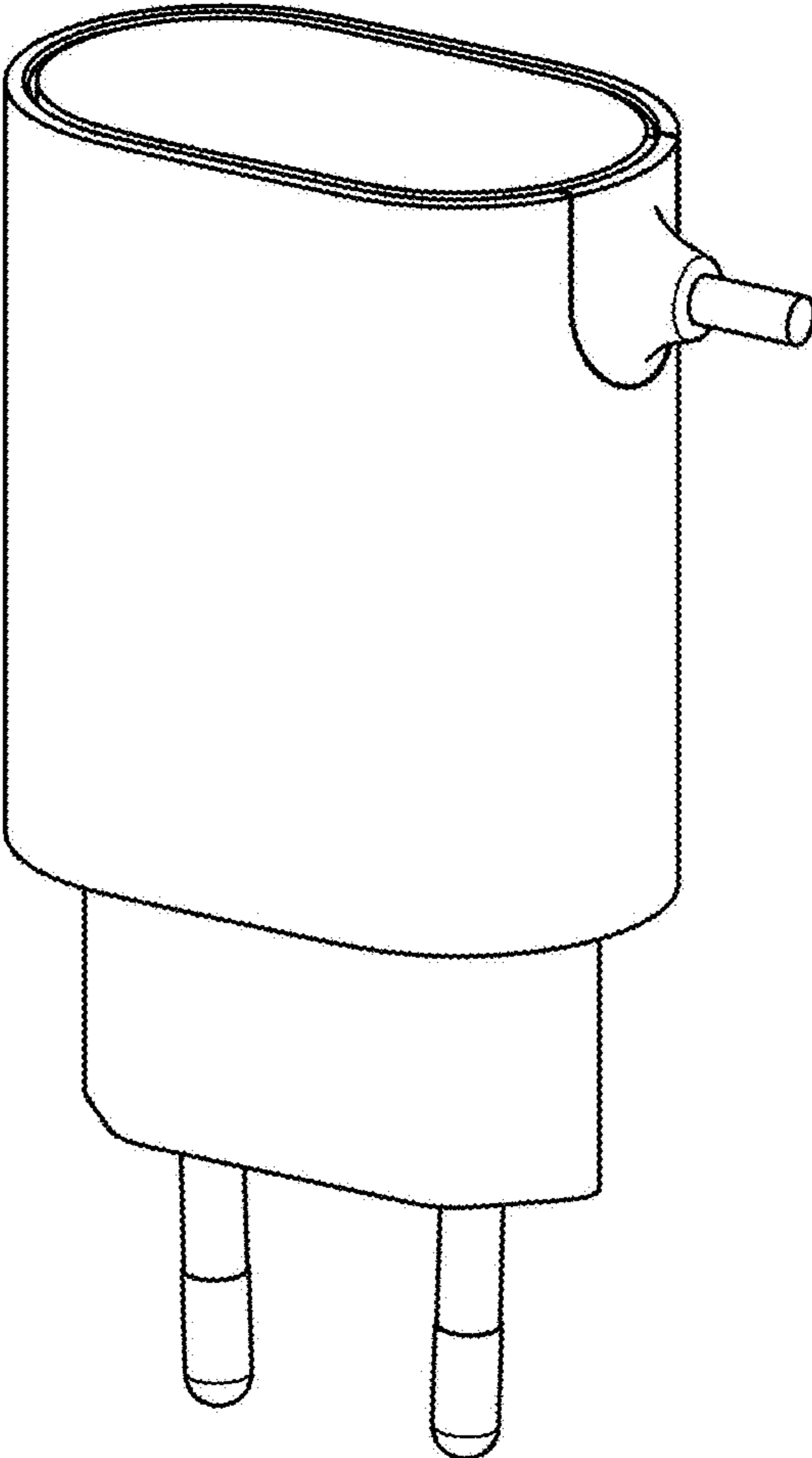

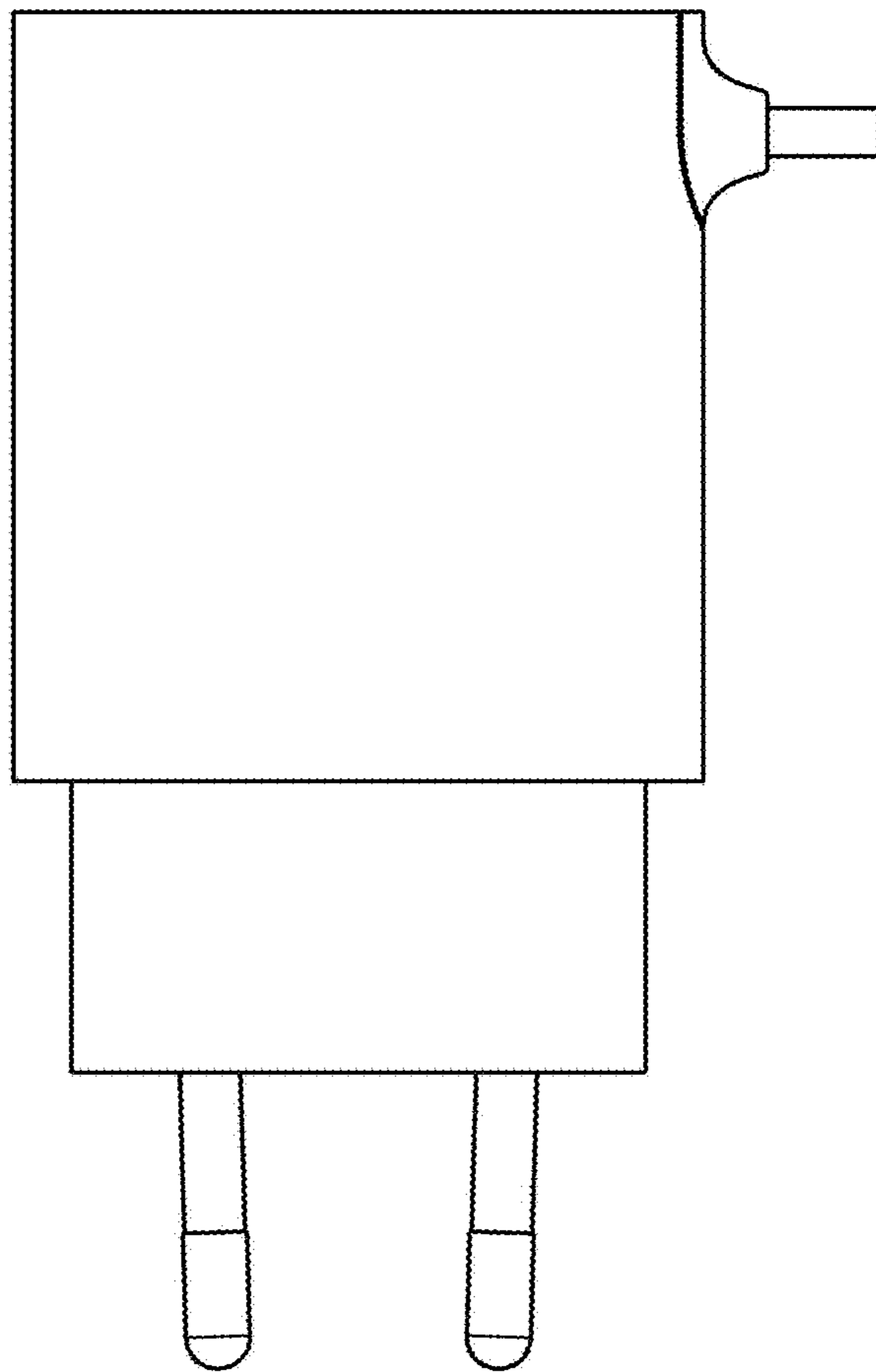

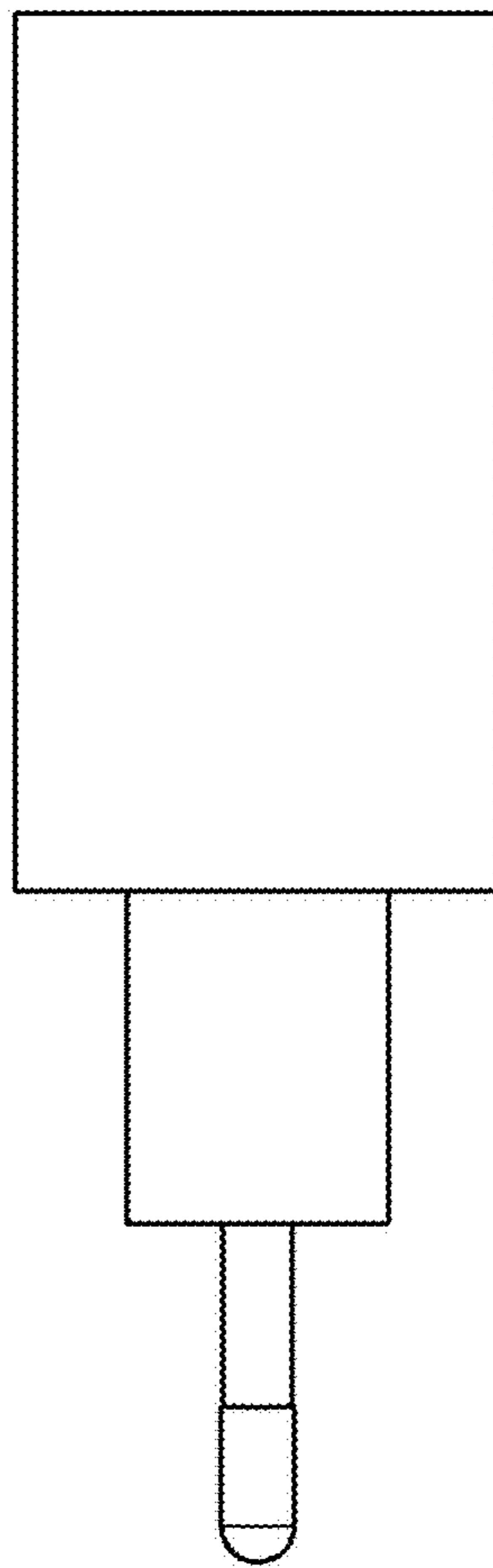

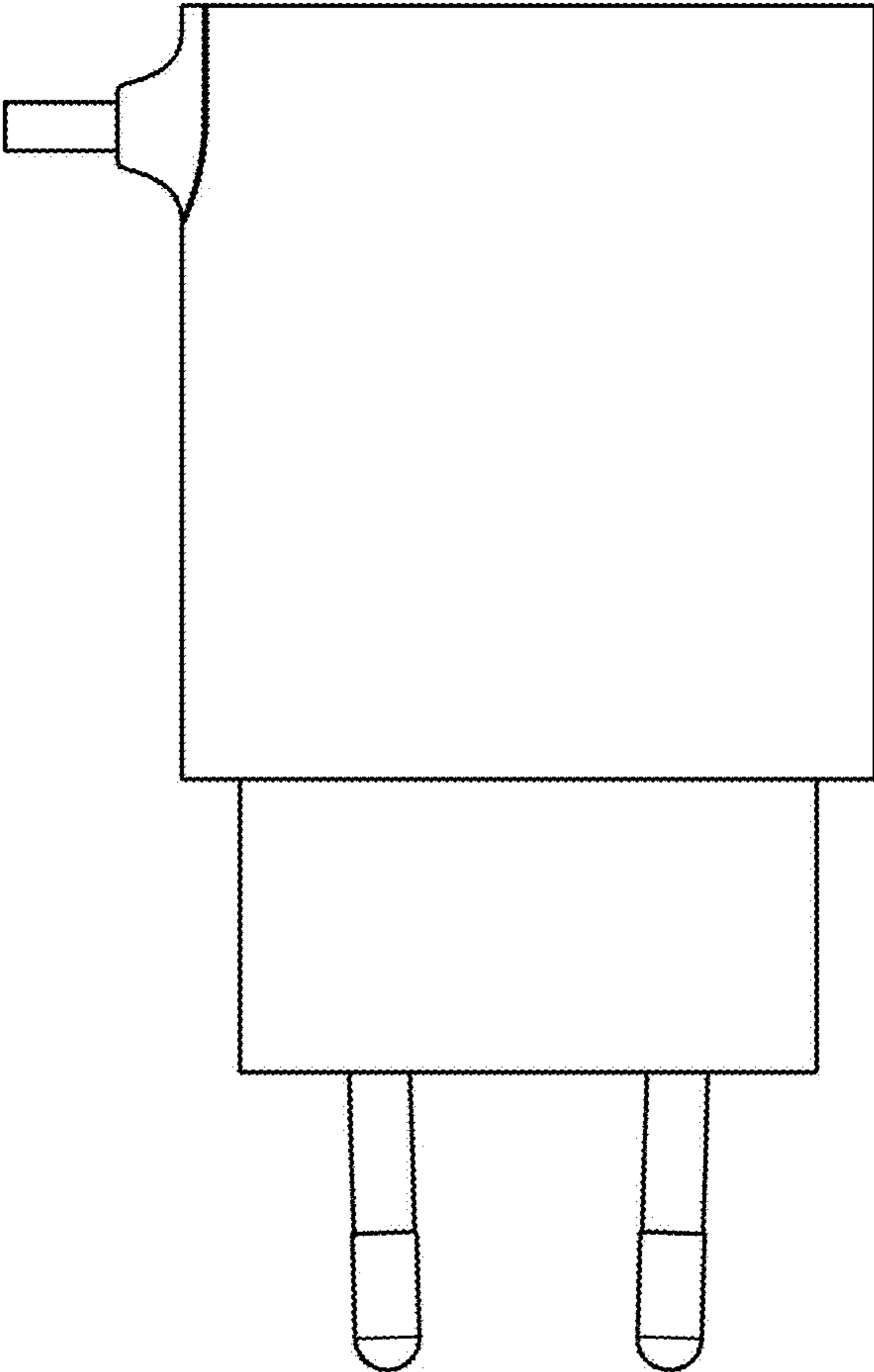

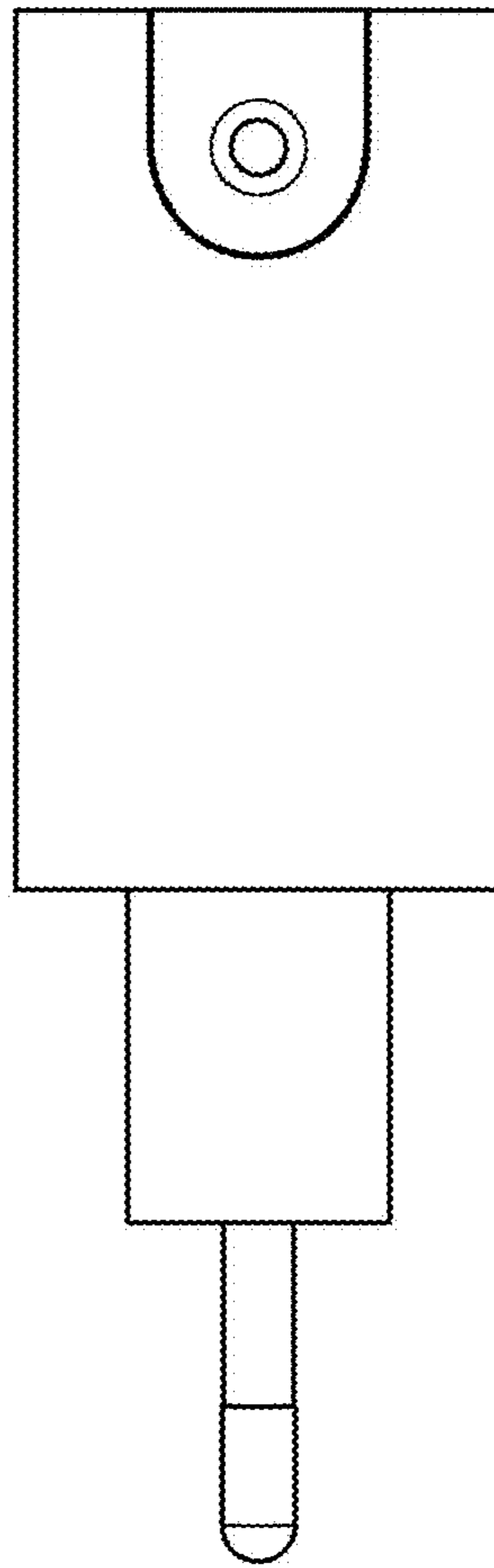

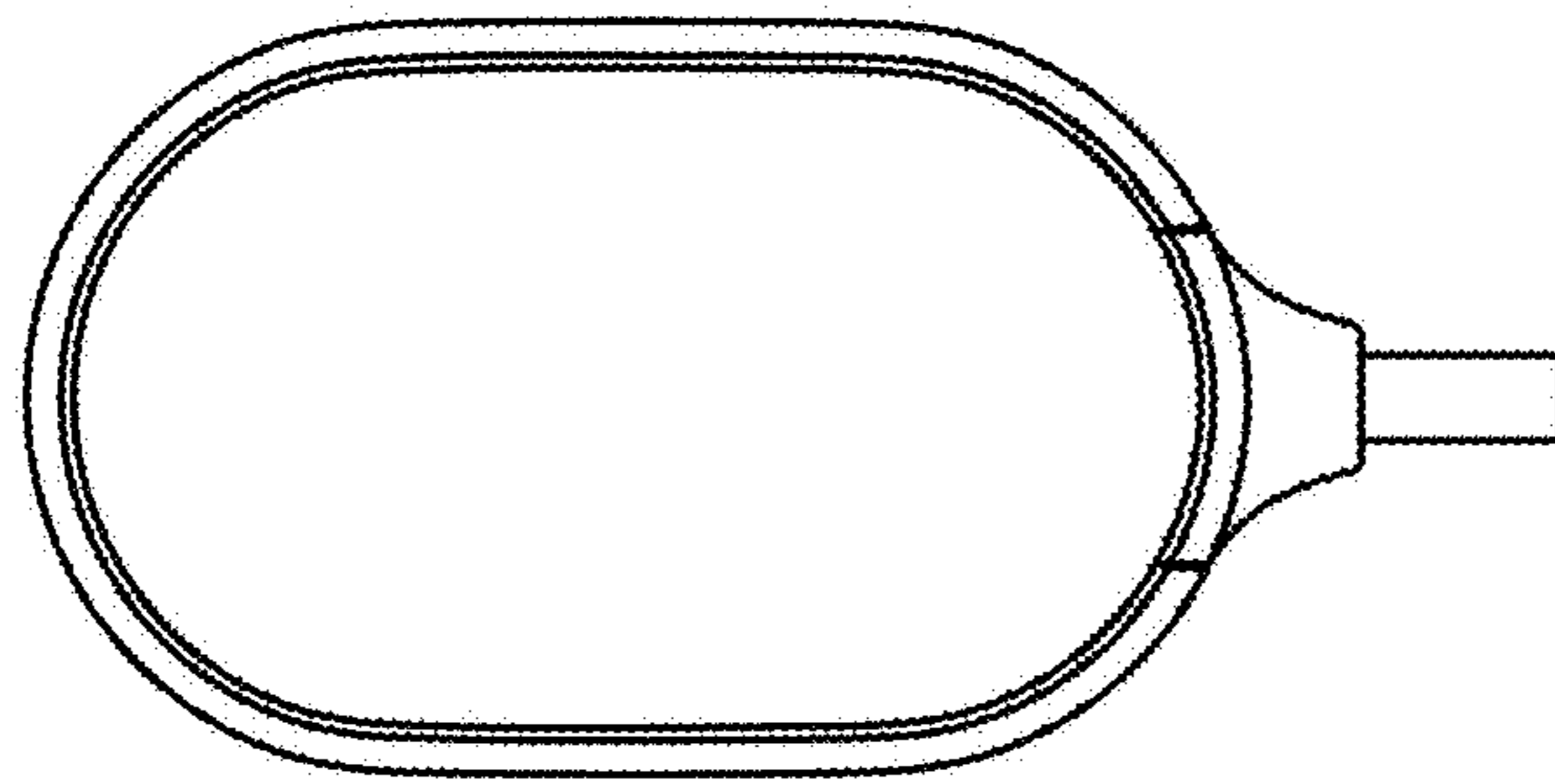

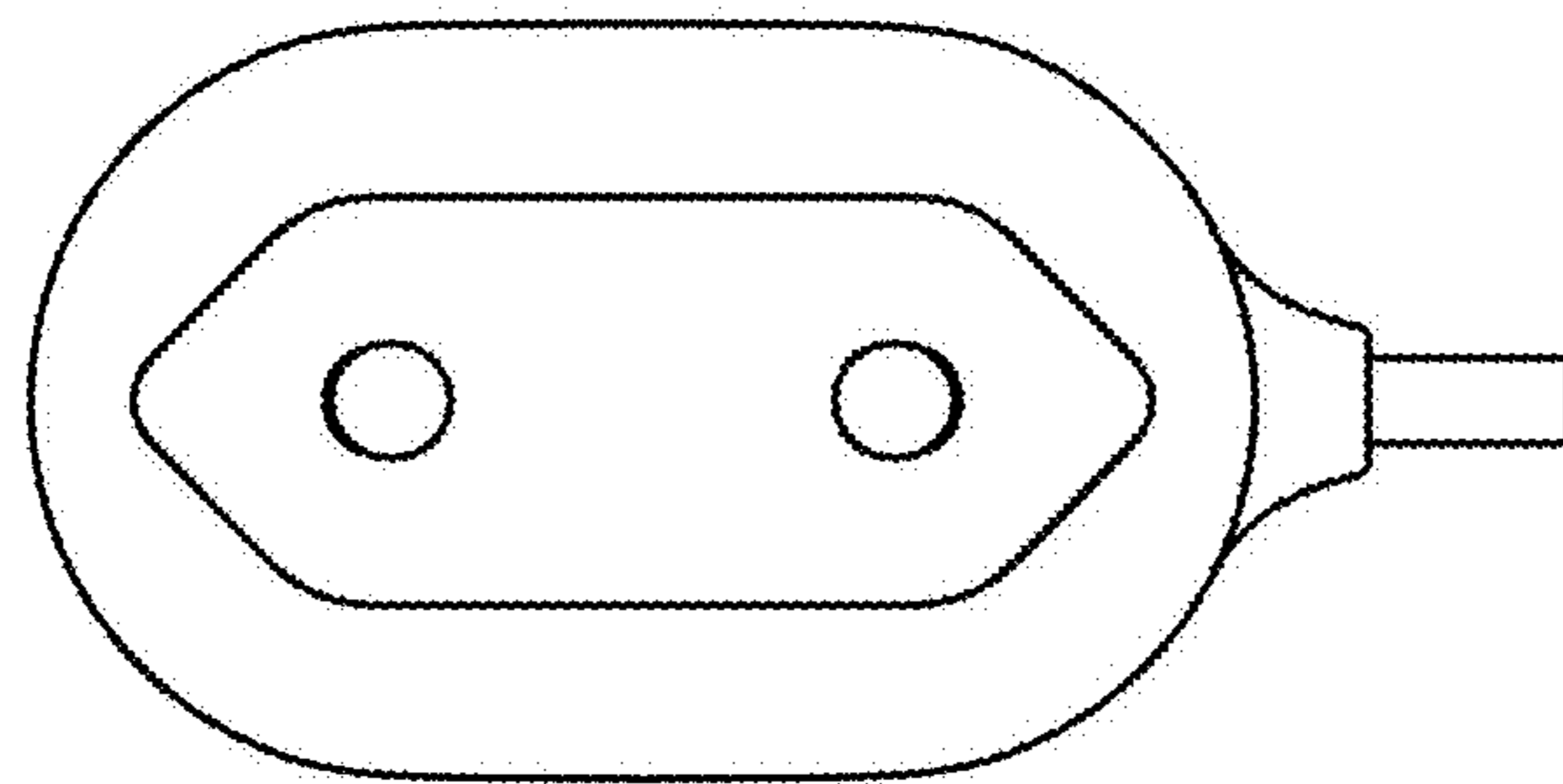

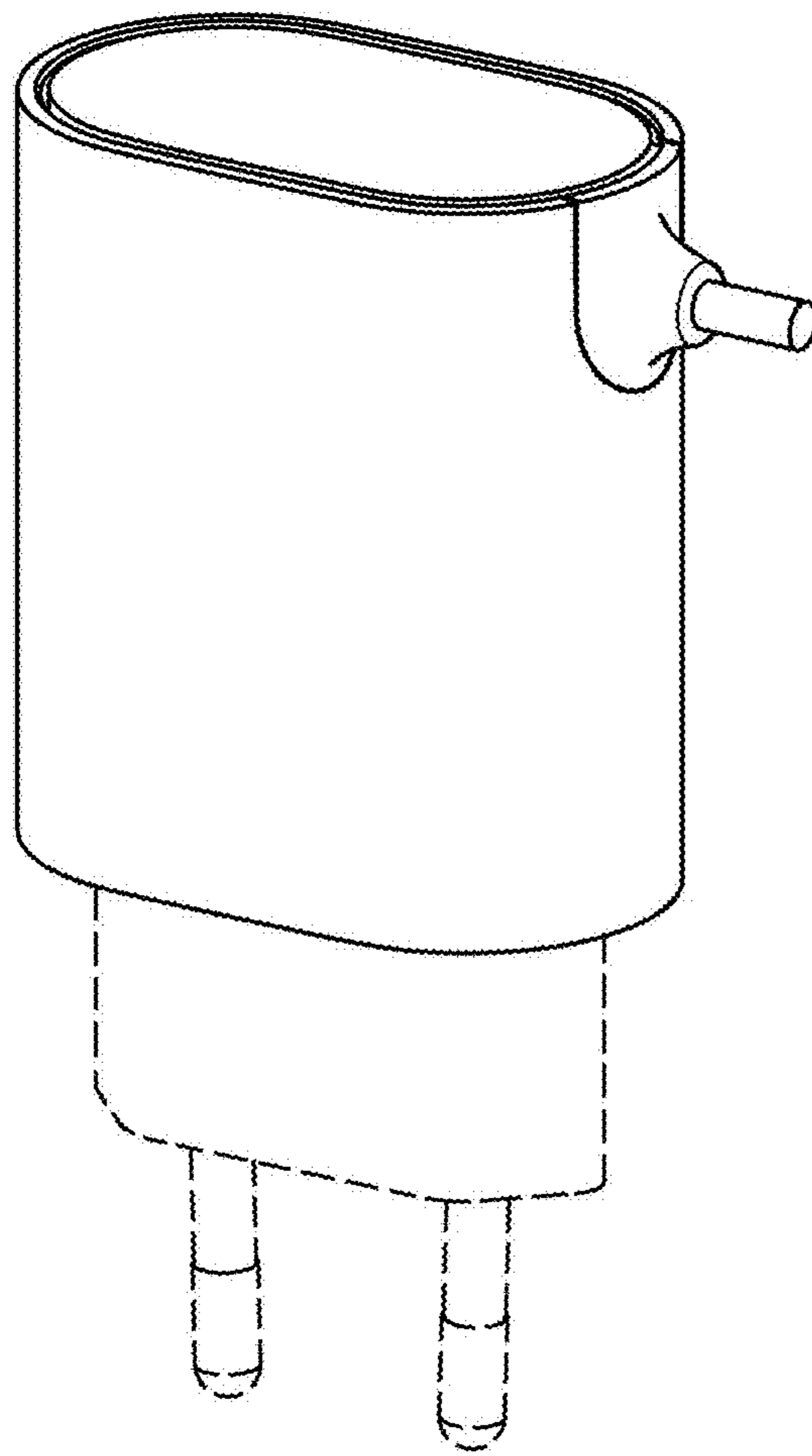

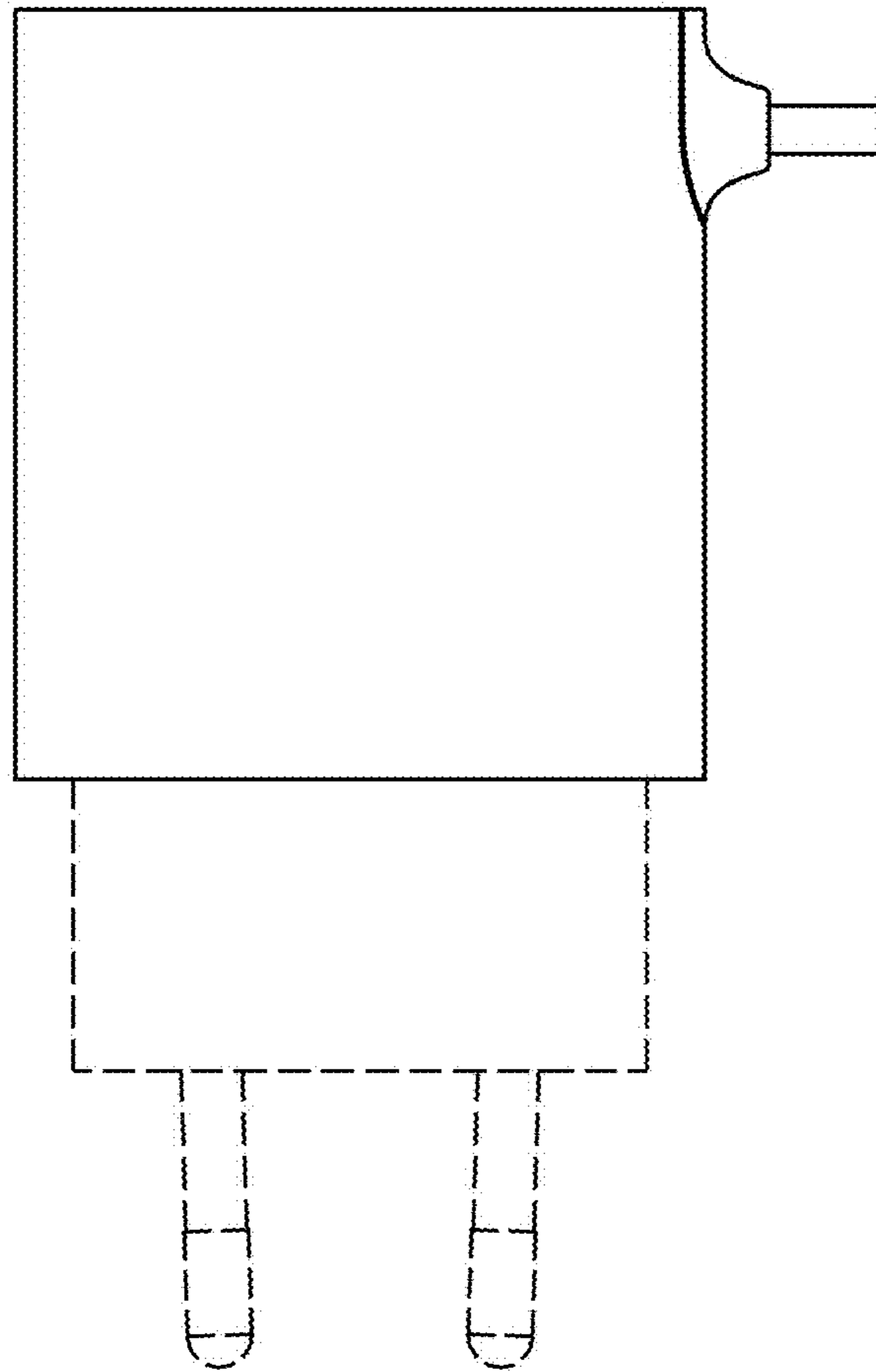

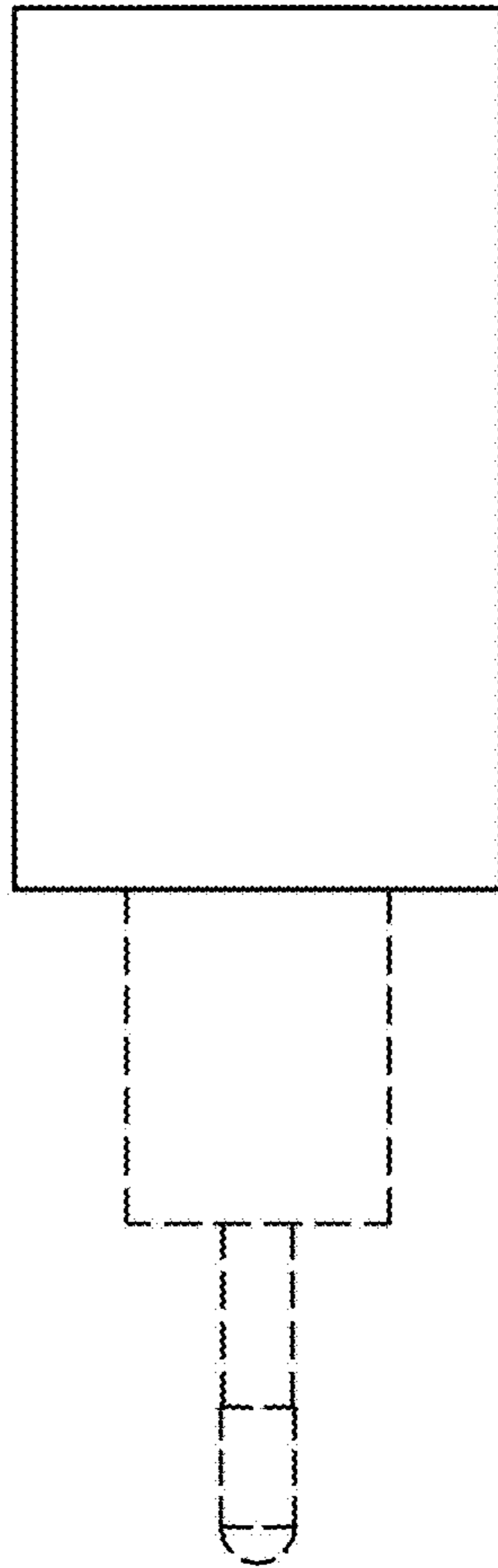

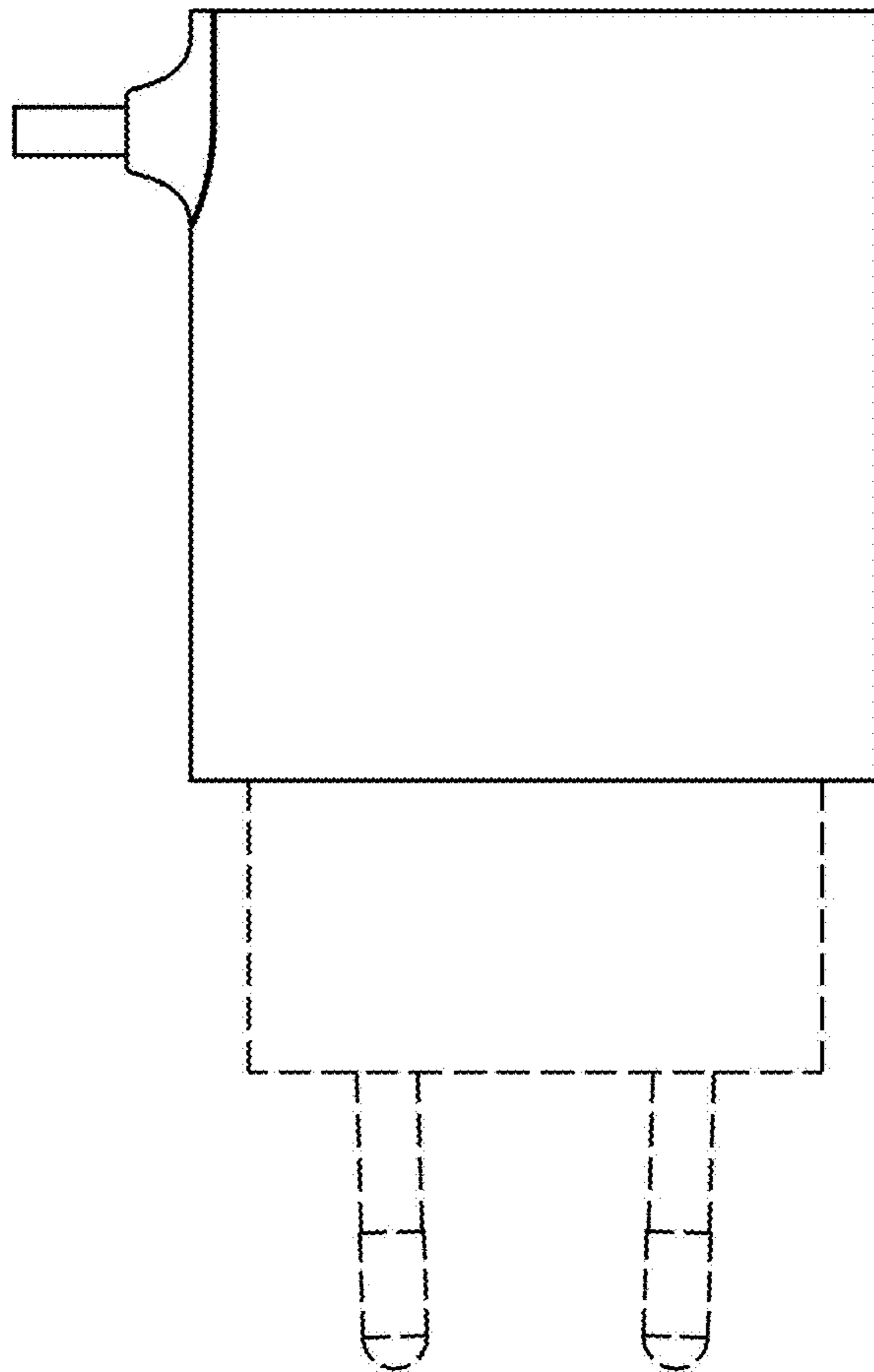

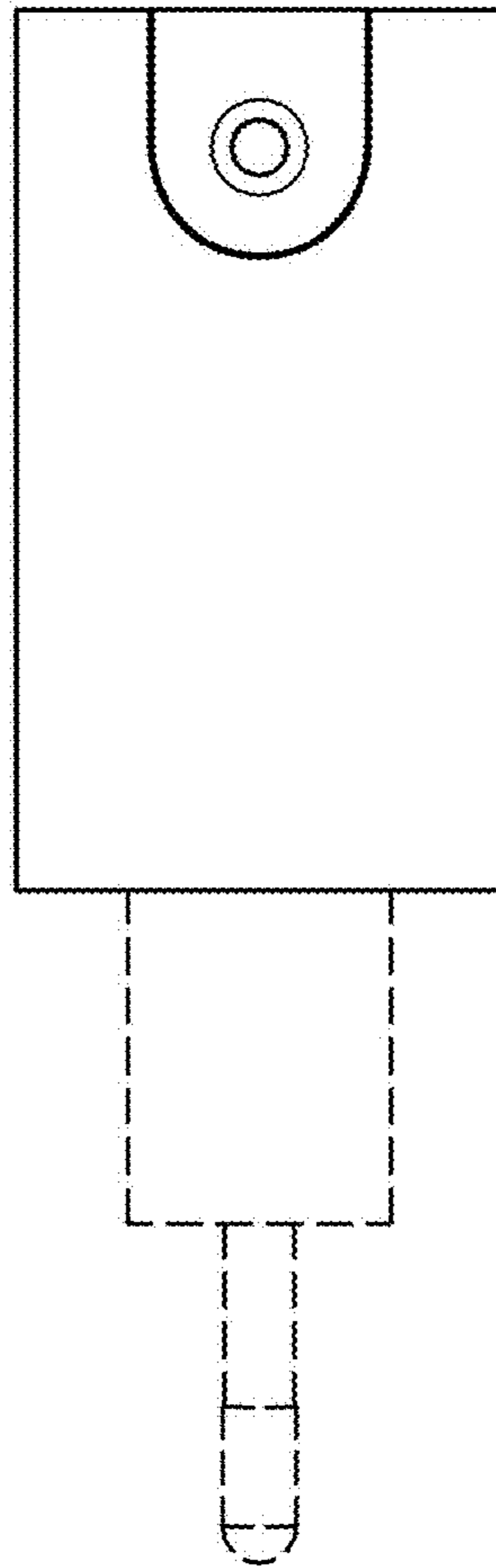

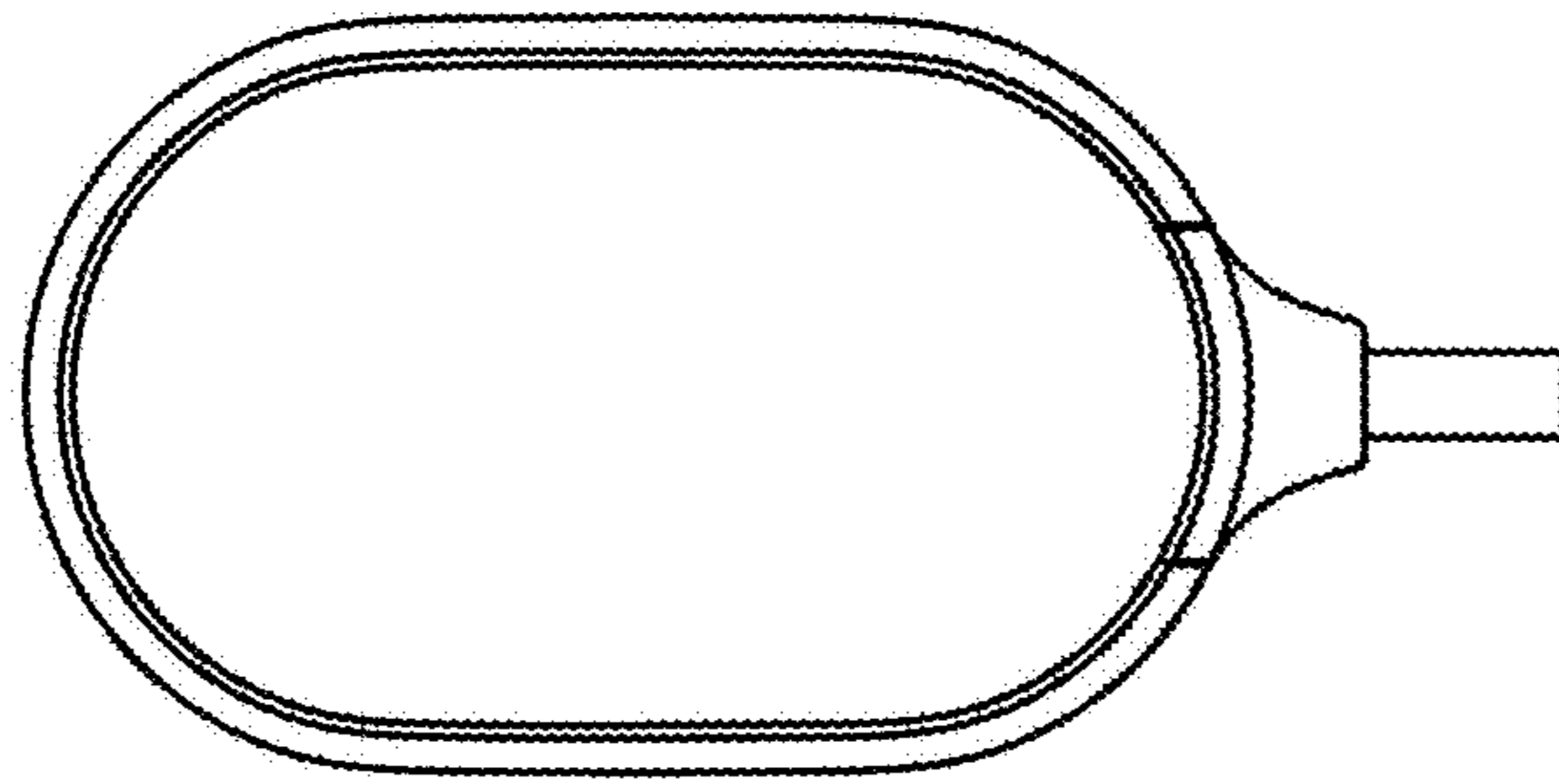

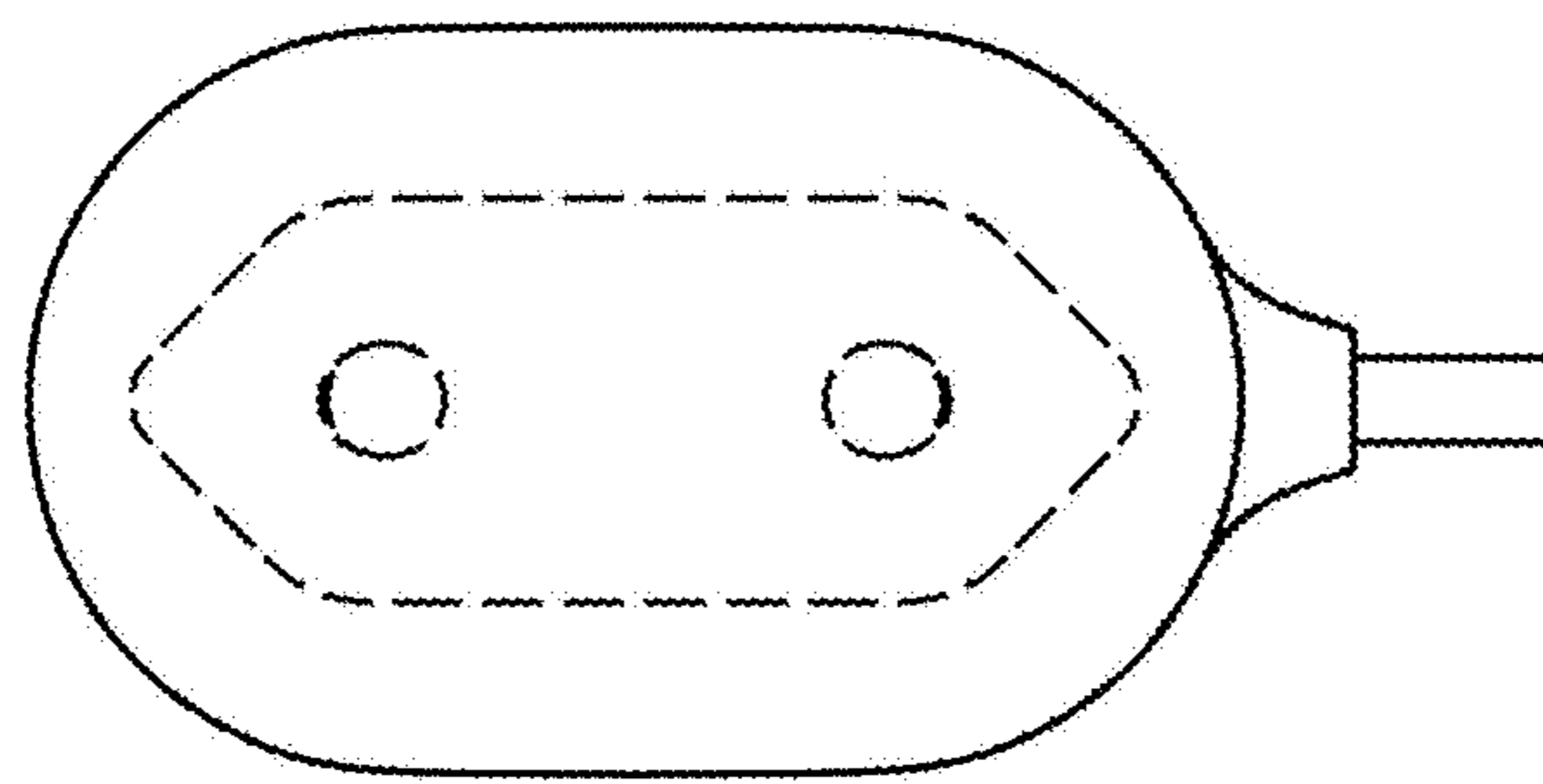

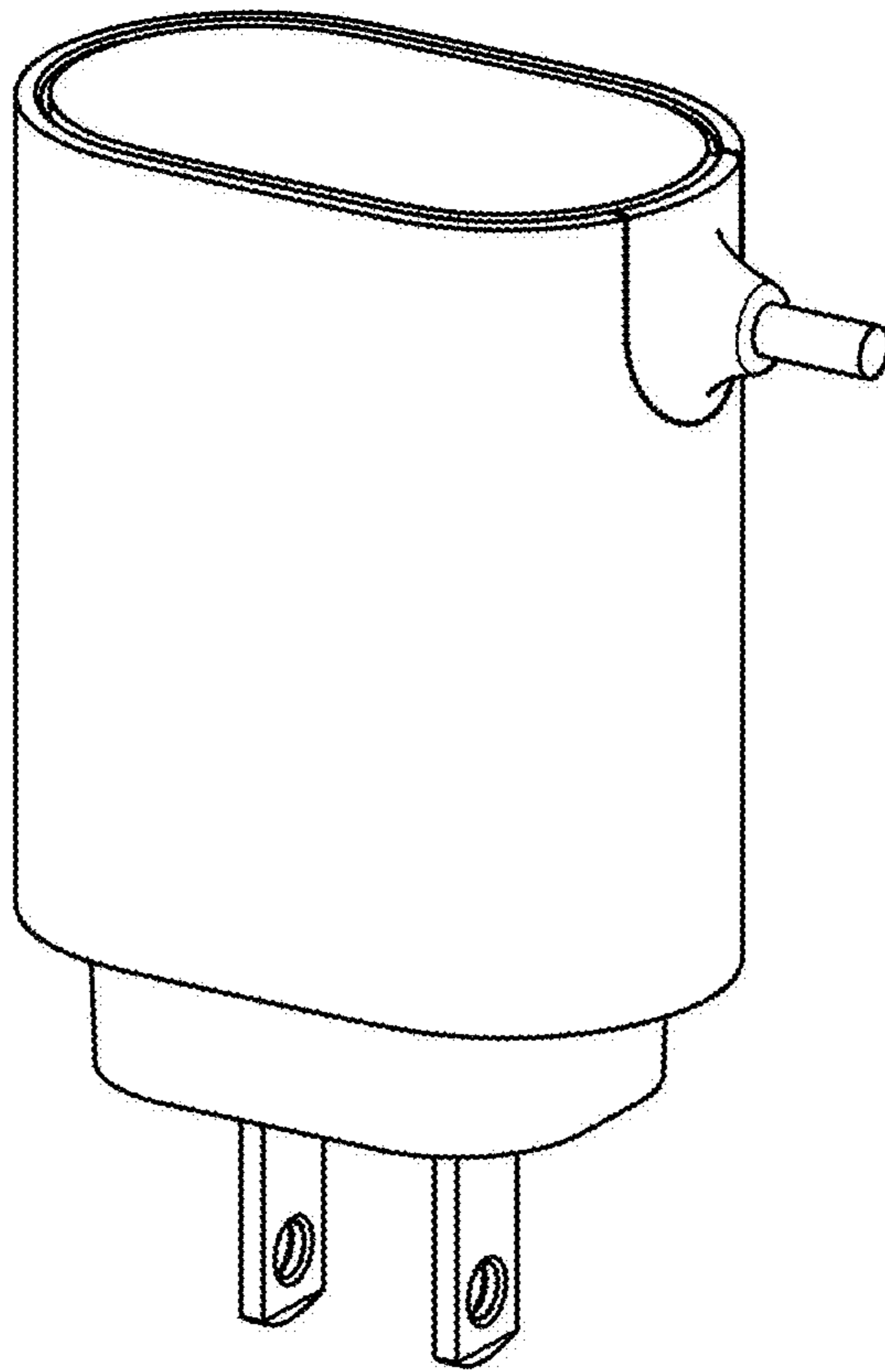

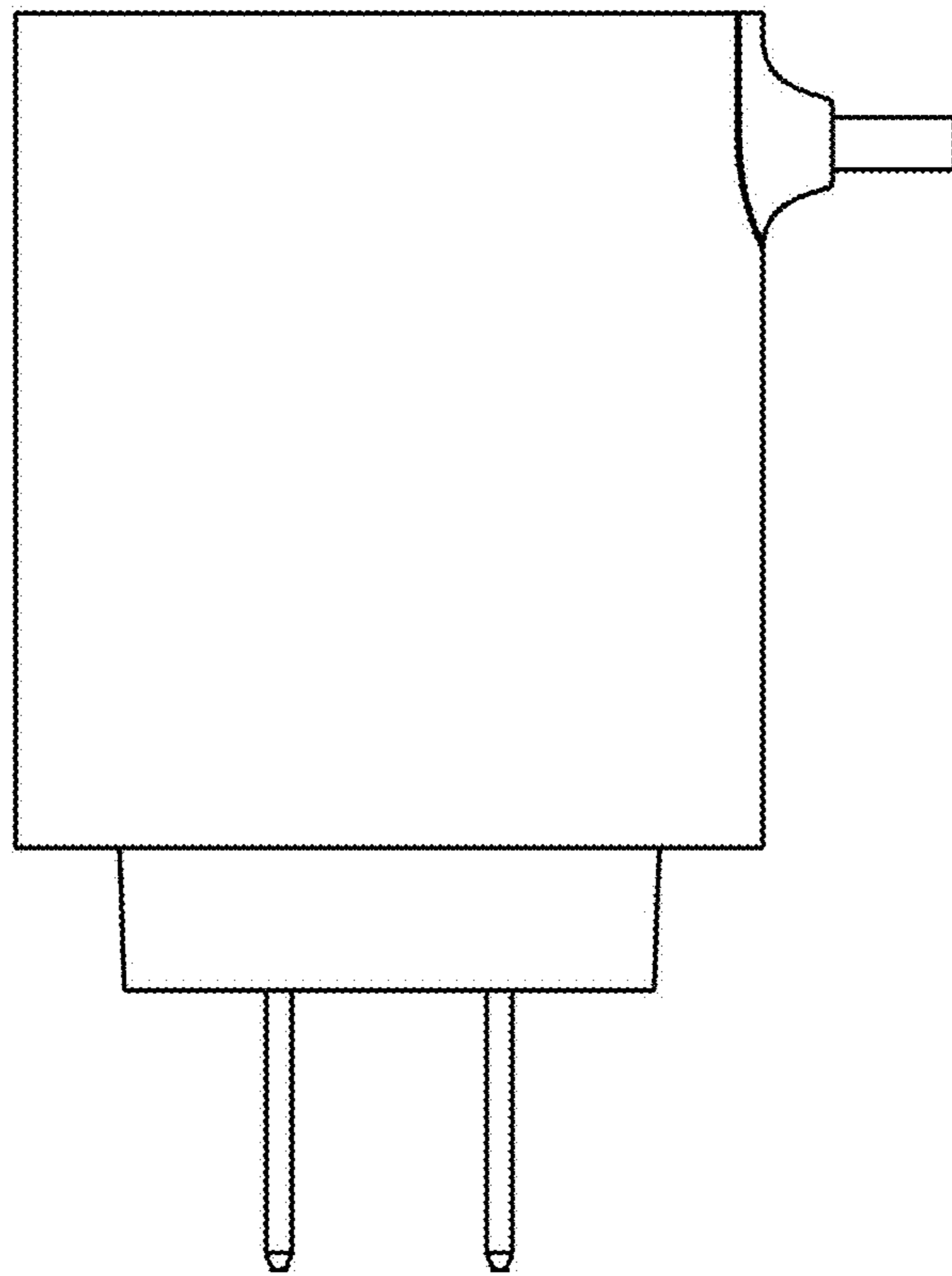

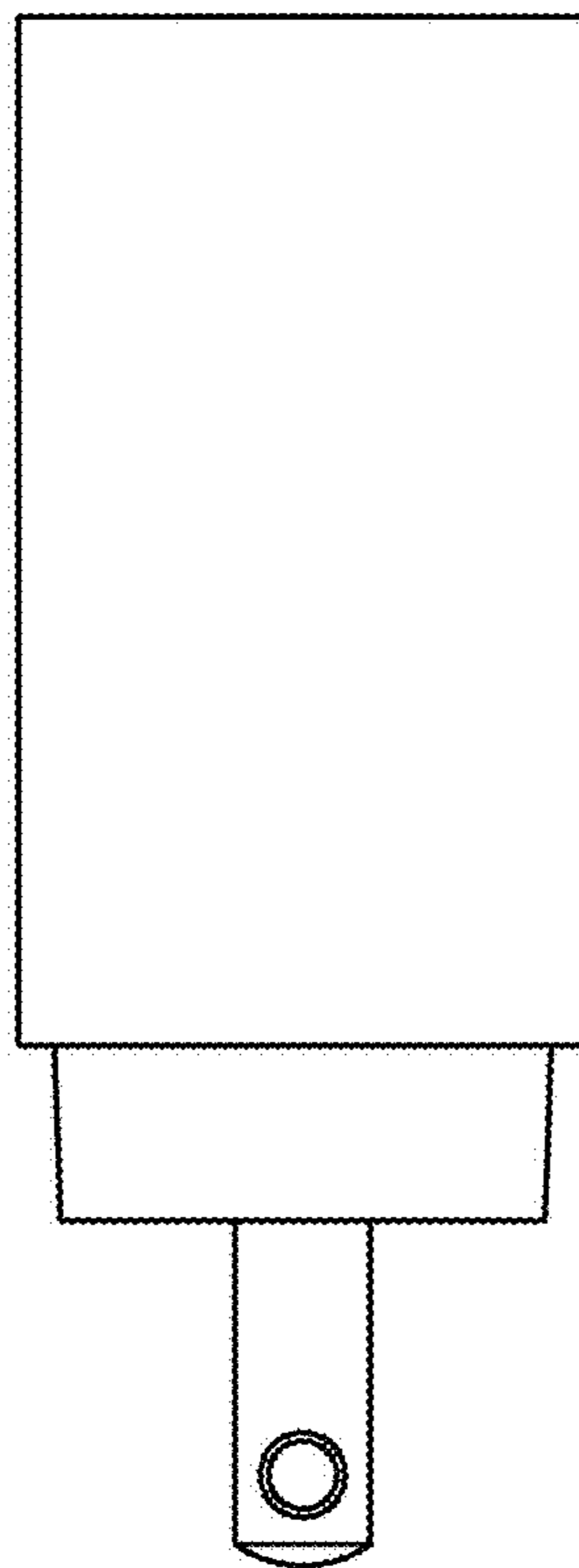

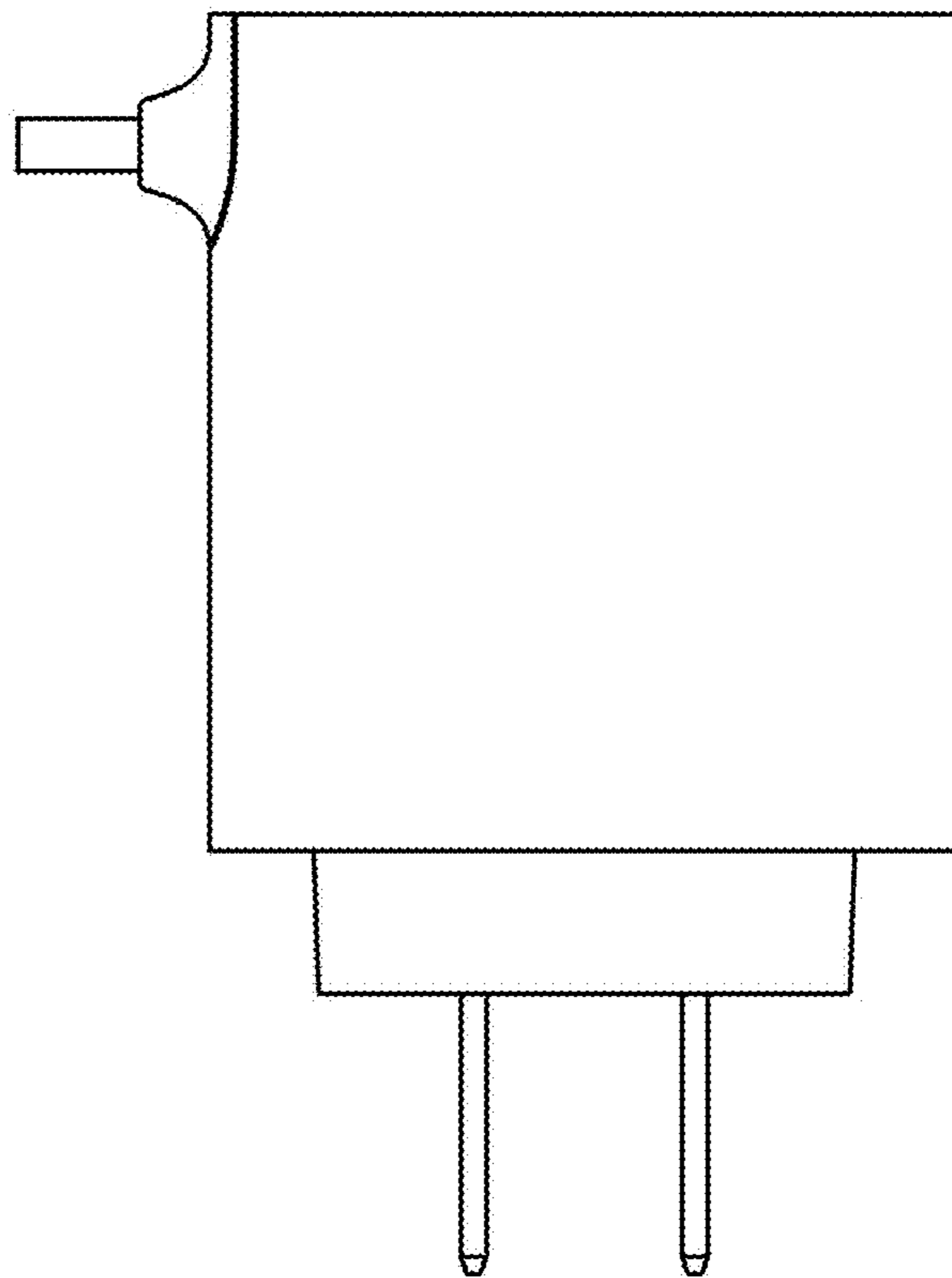

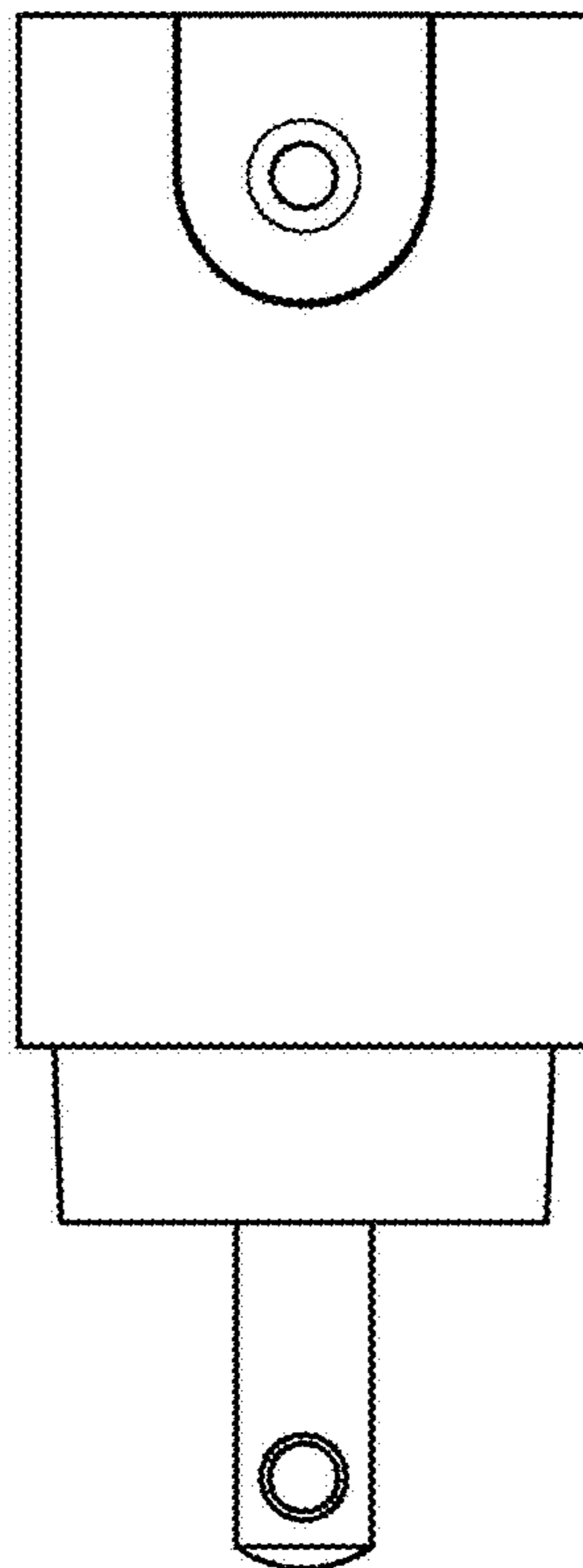

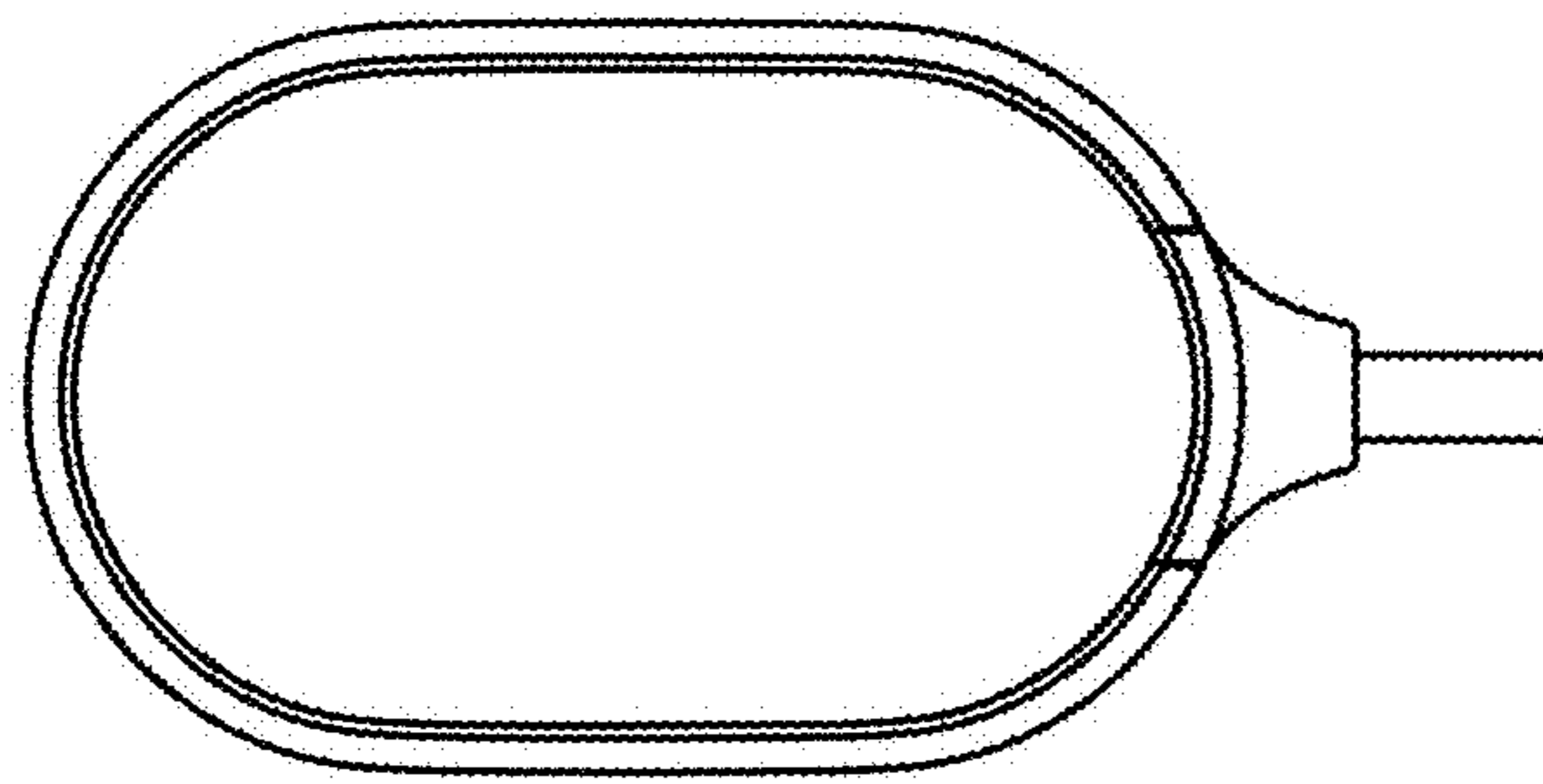

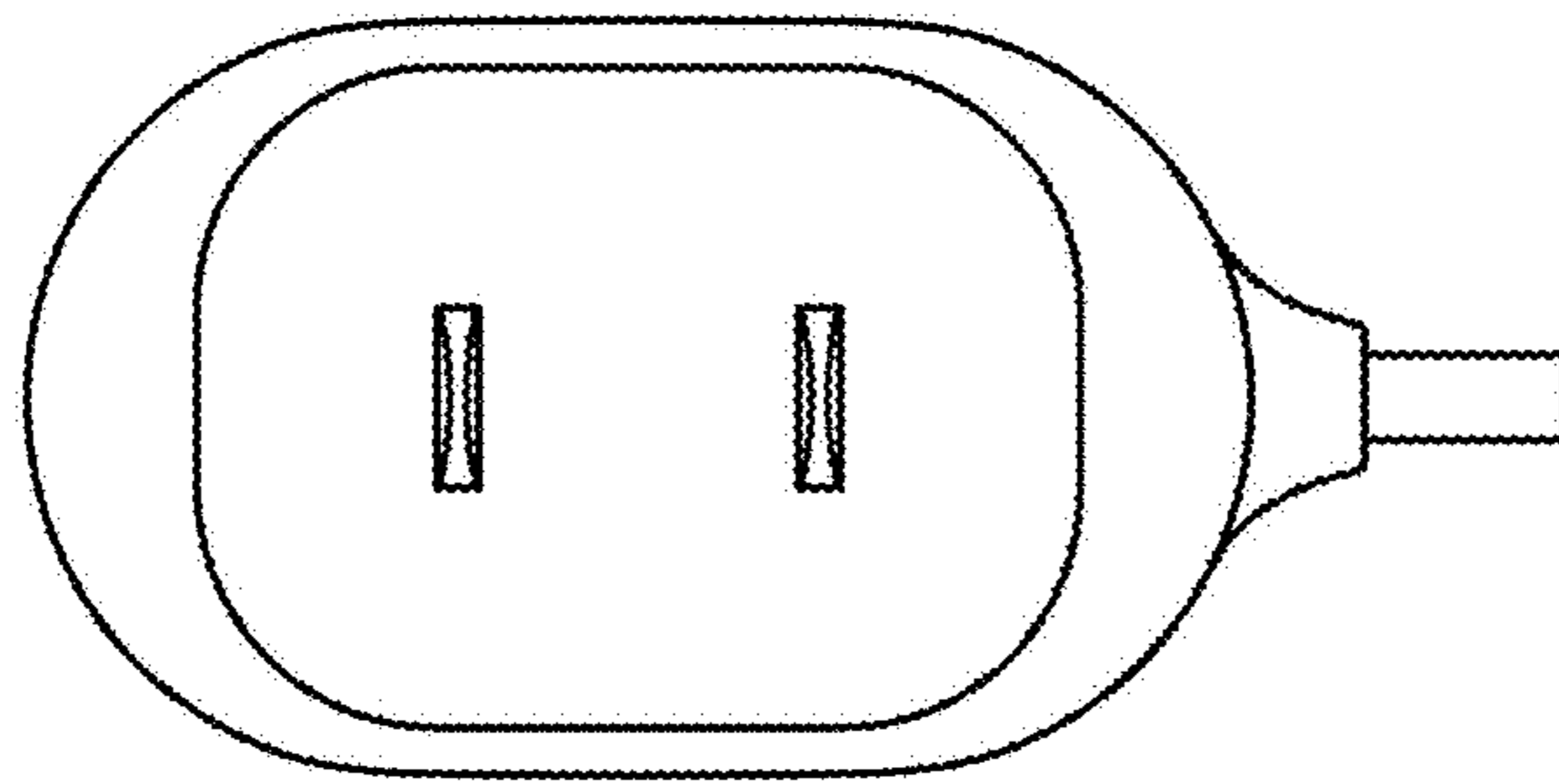

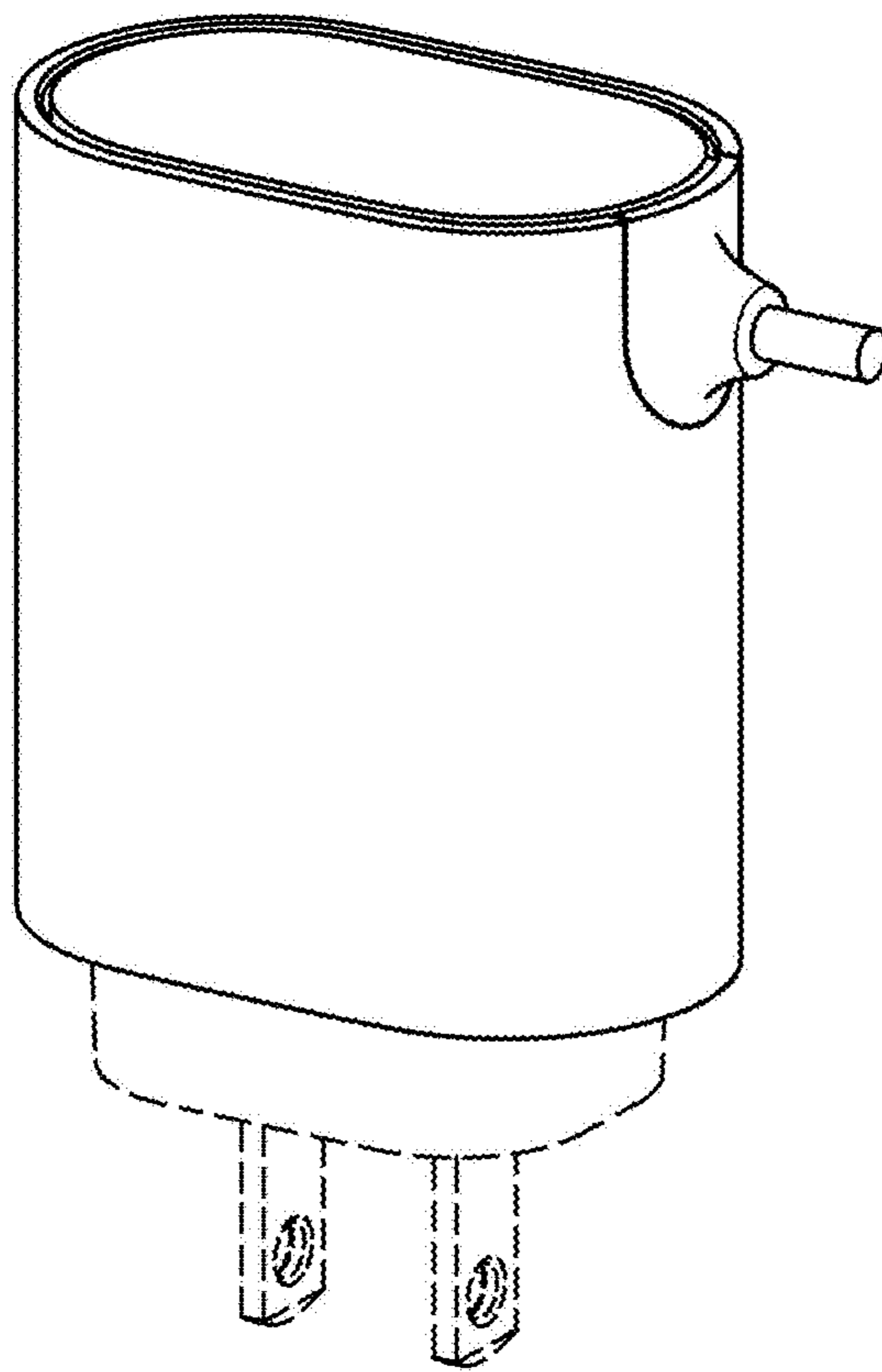

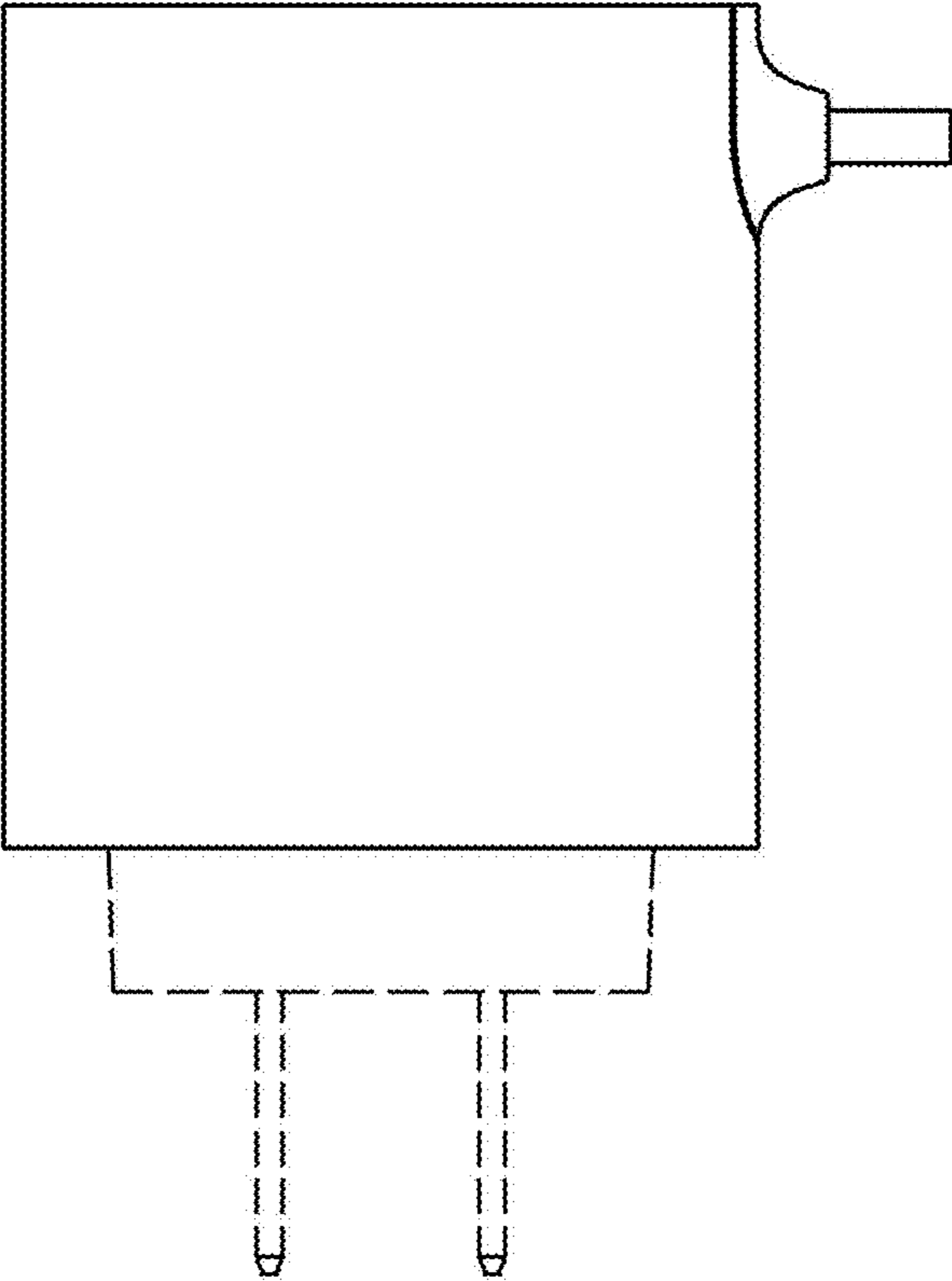

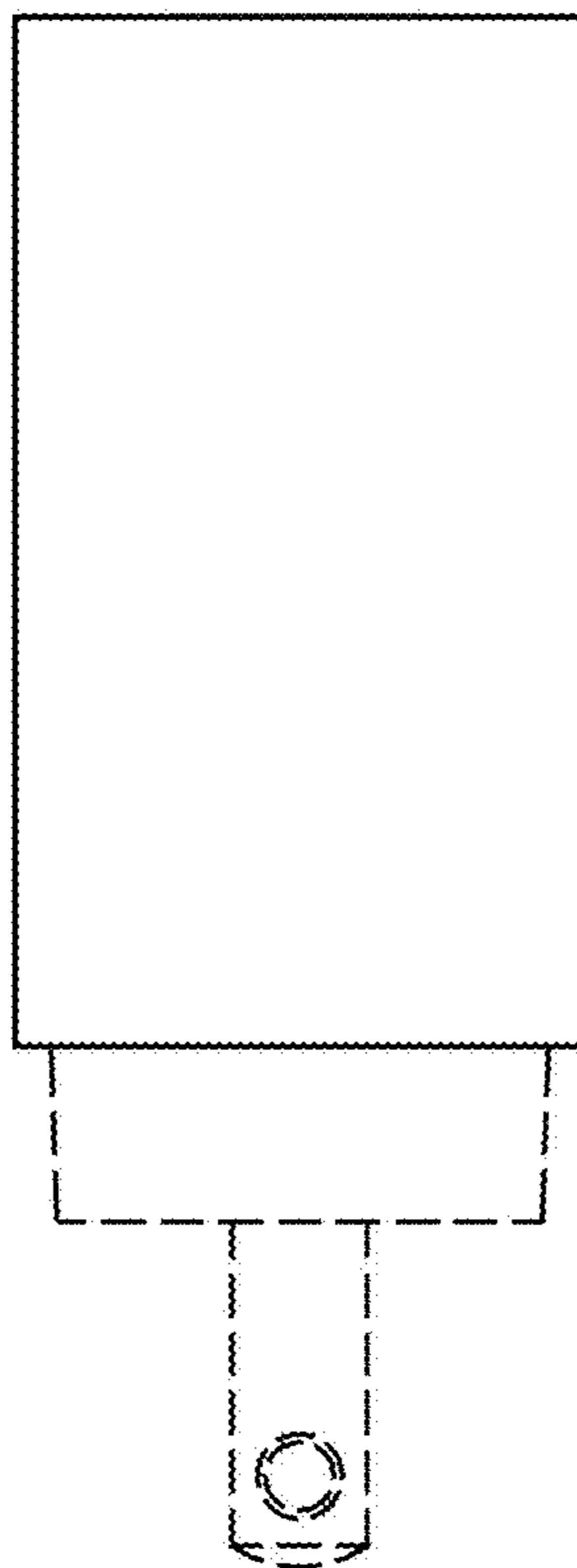

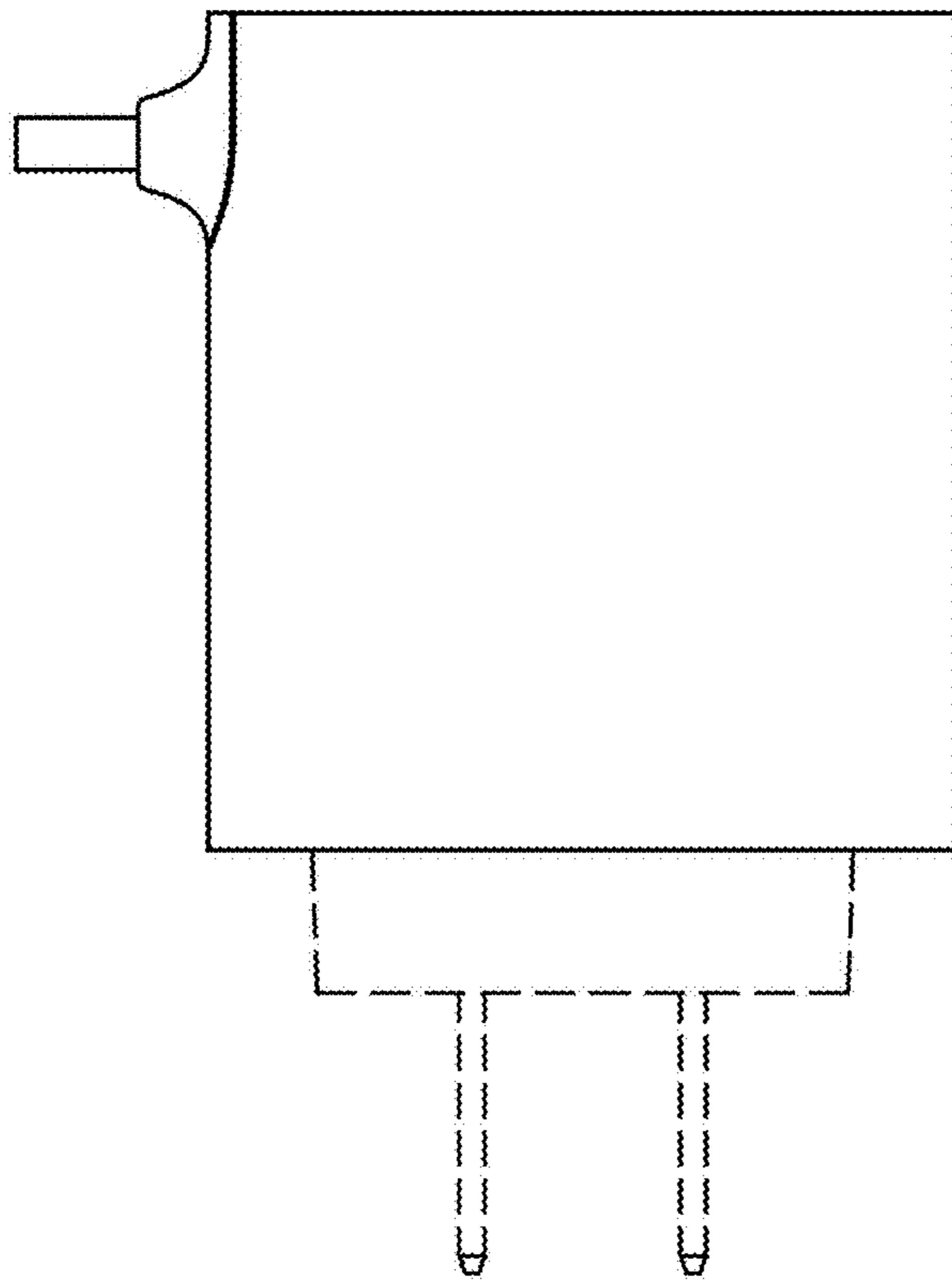

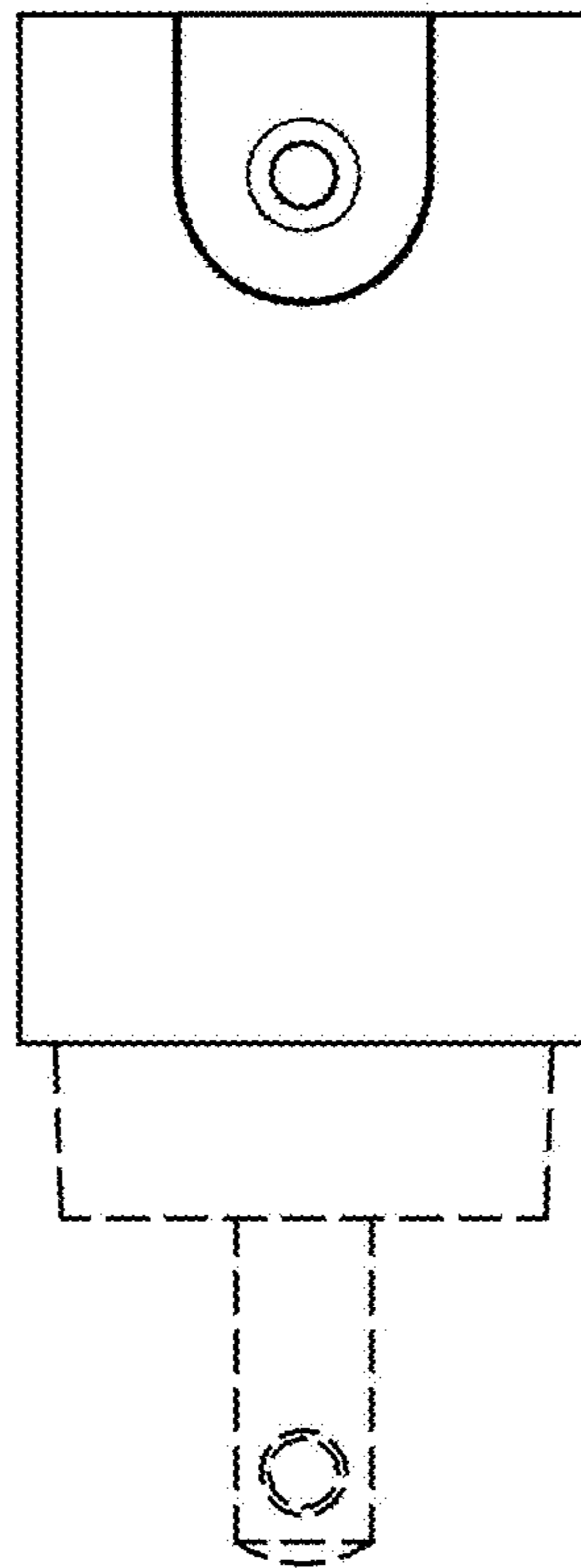

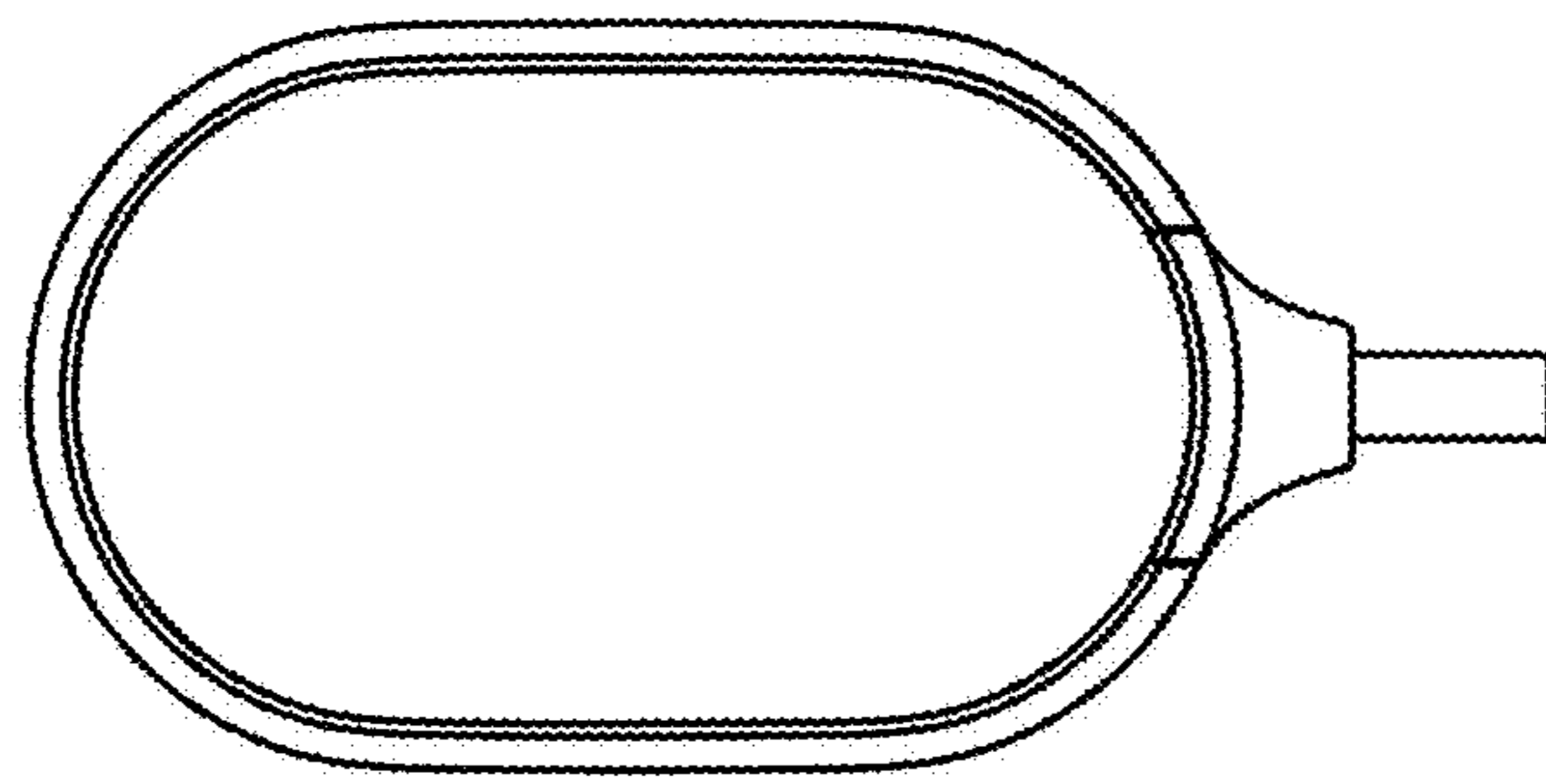

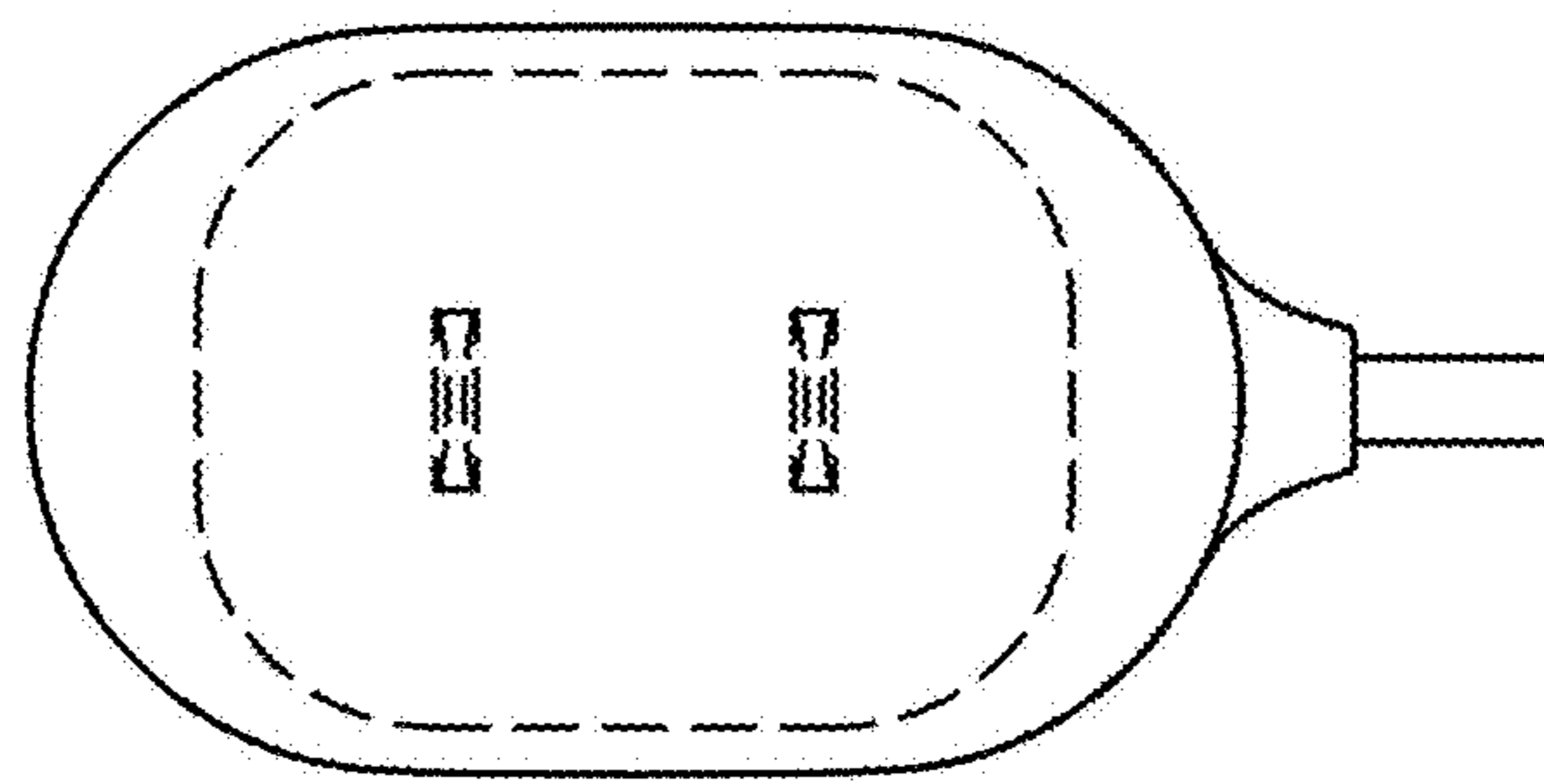
