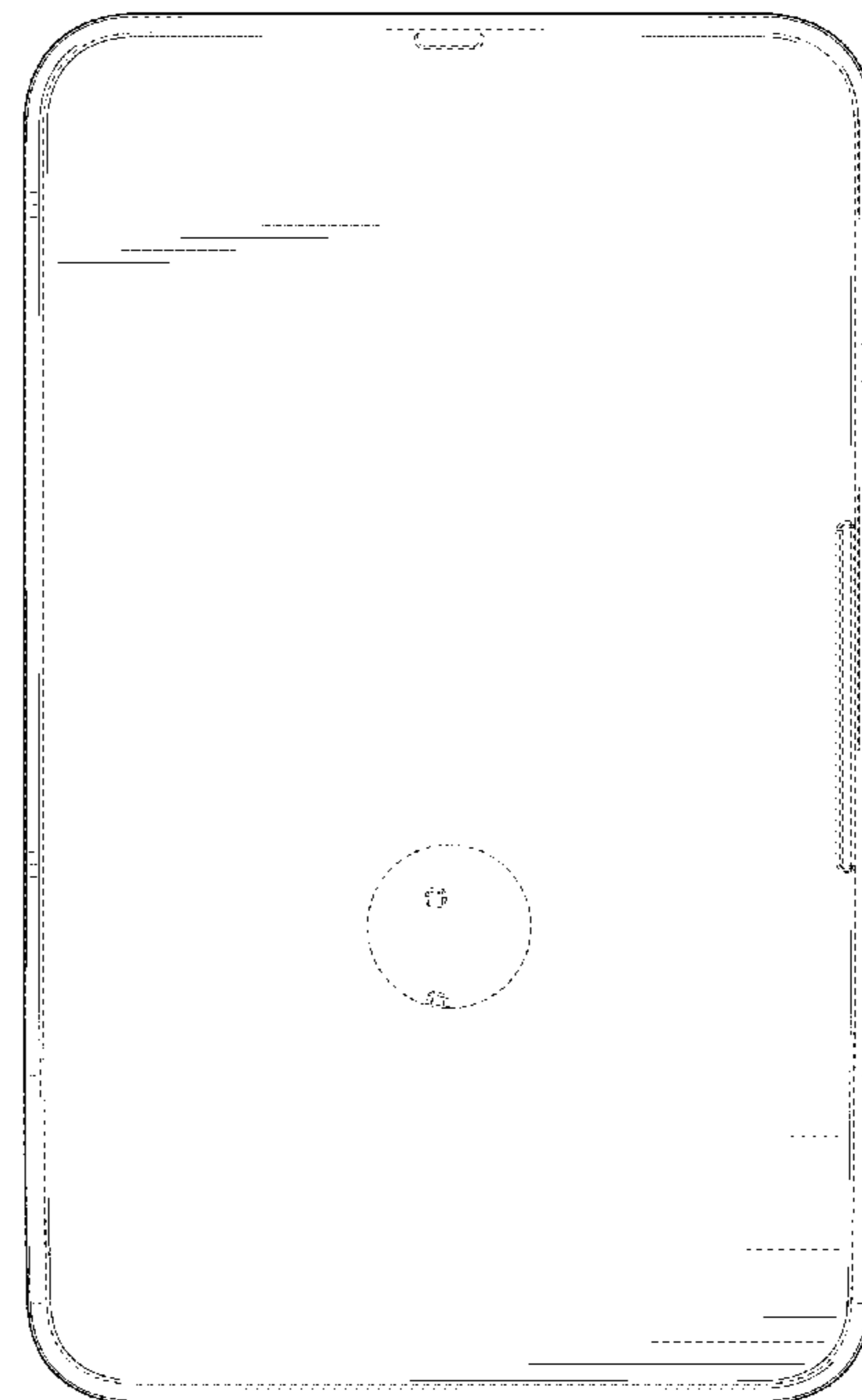
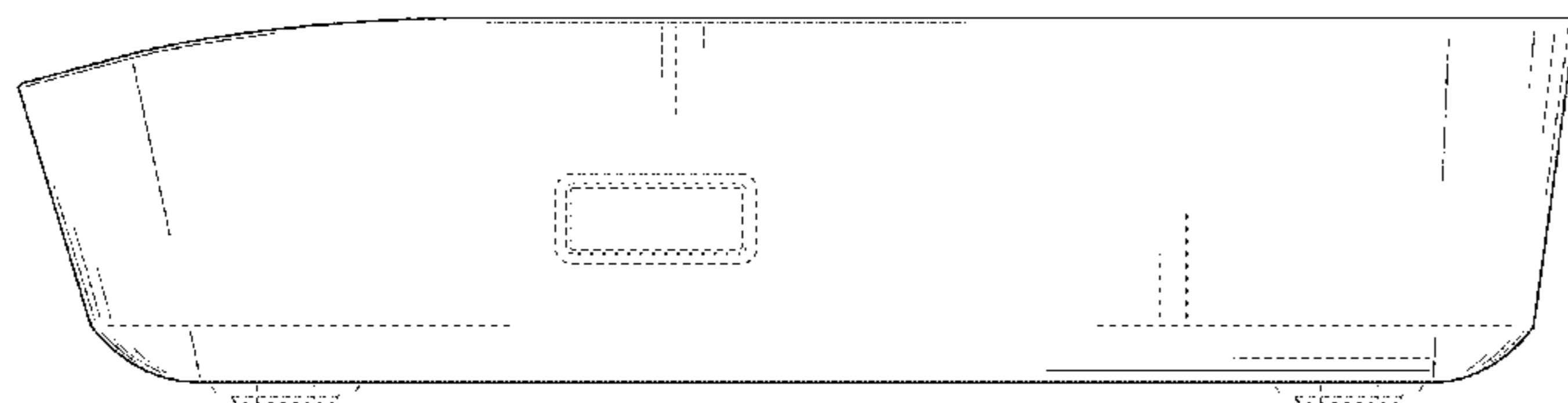
The ornamental design for a “device,” as shown and described.

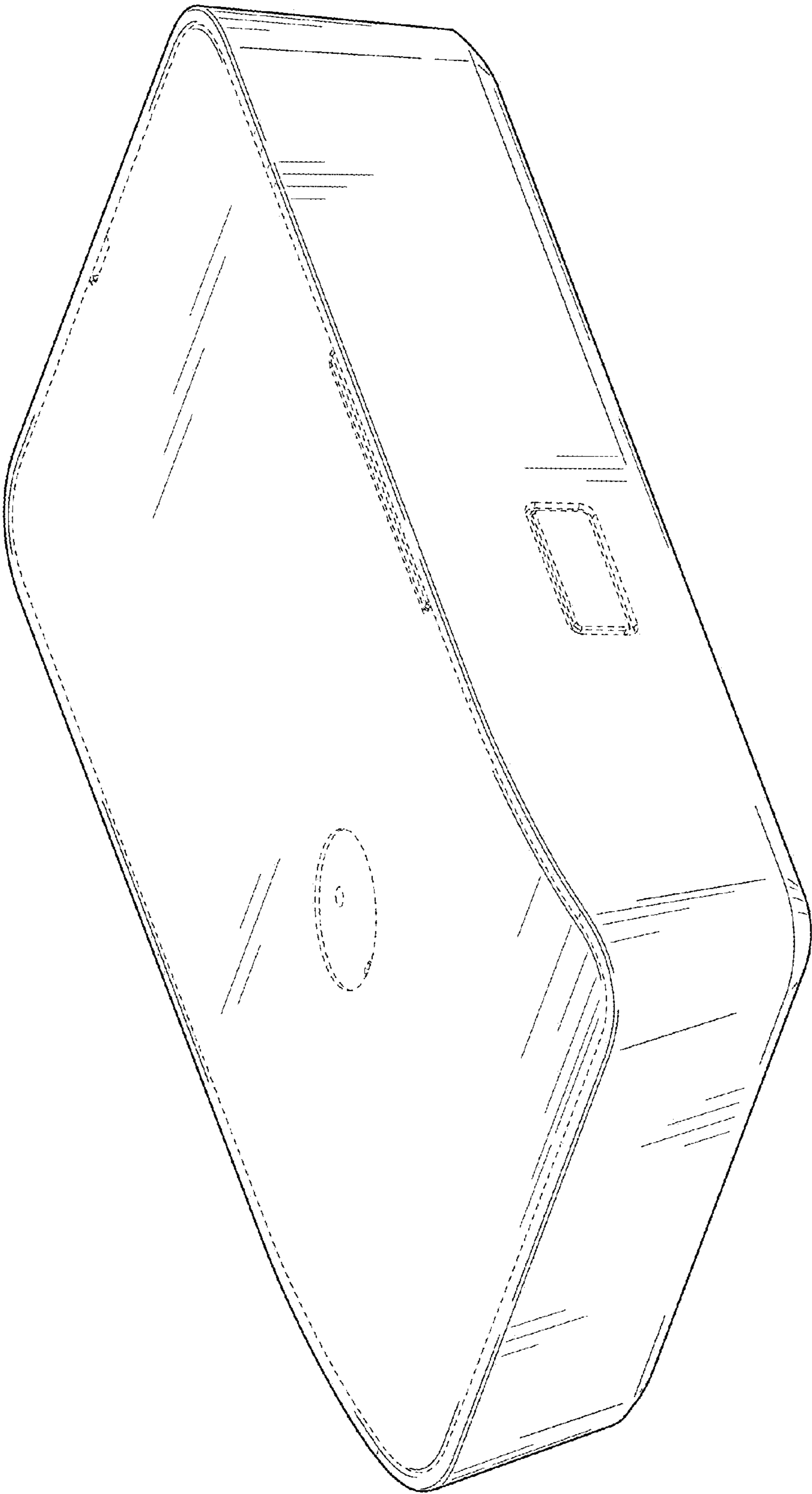

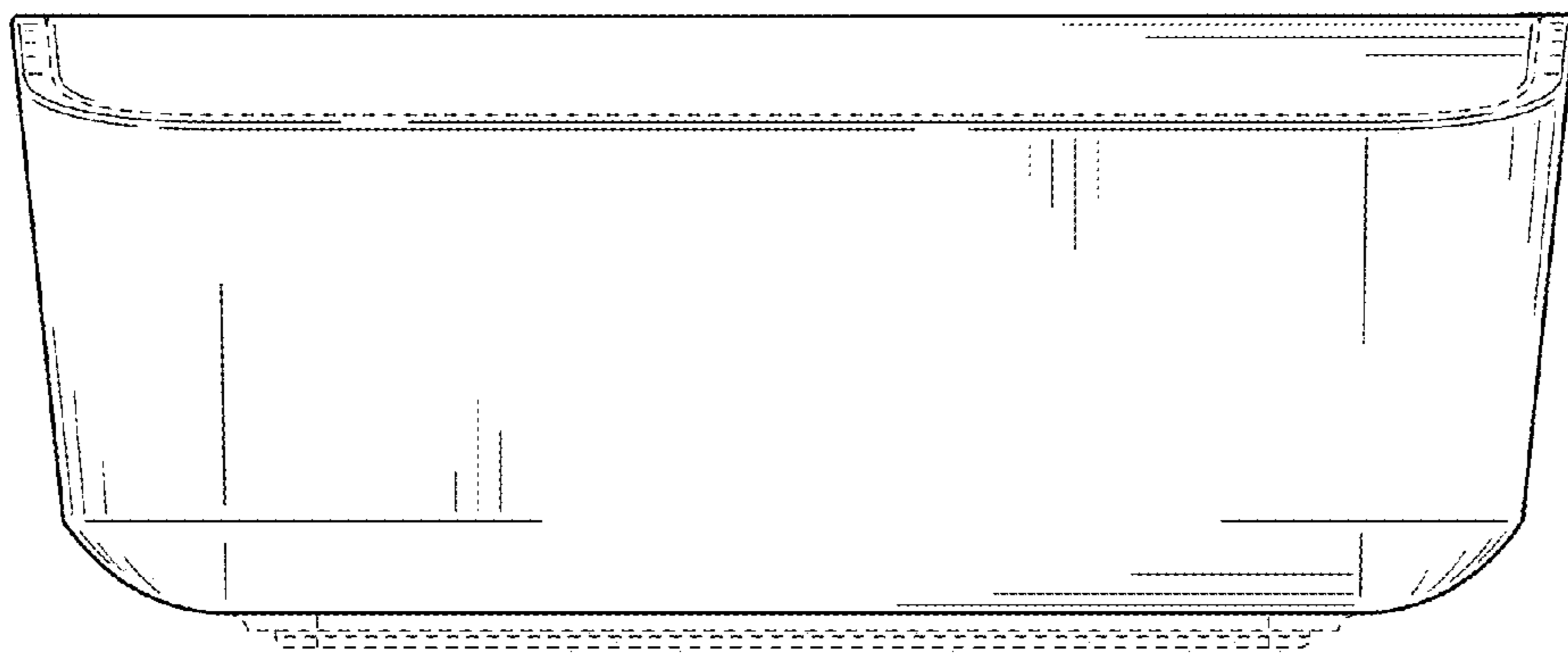

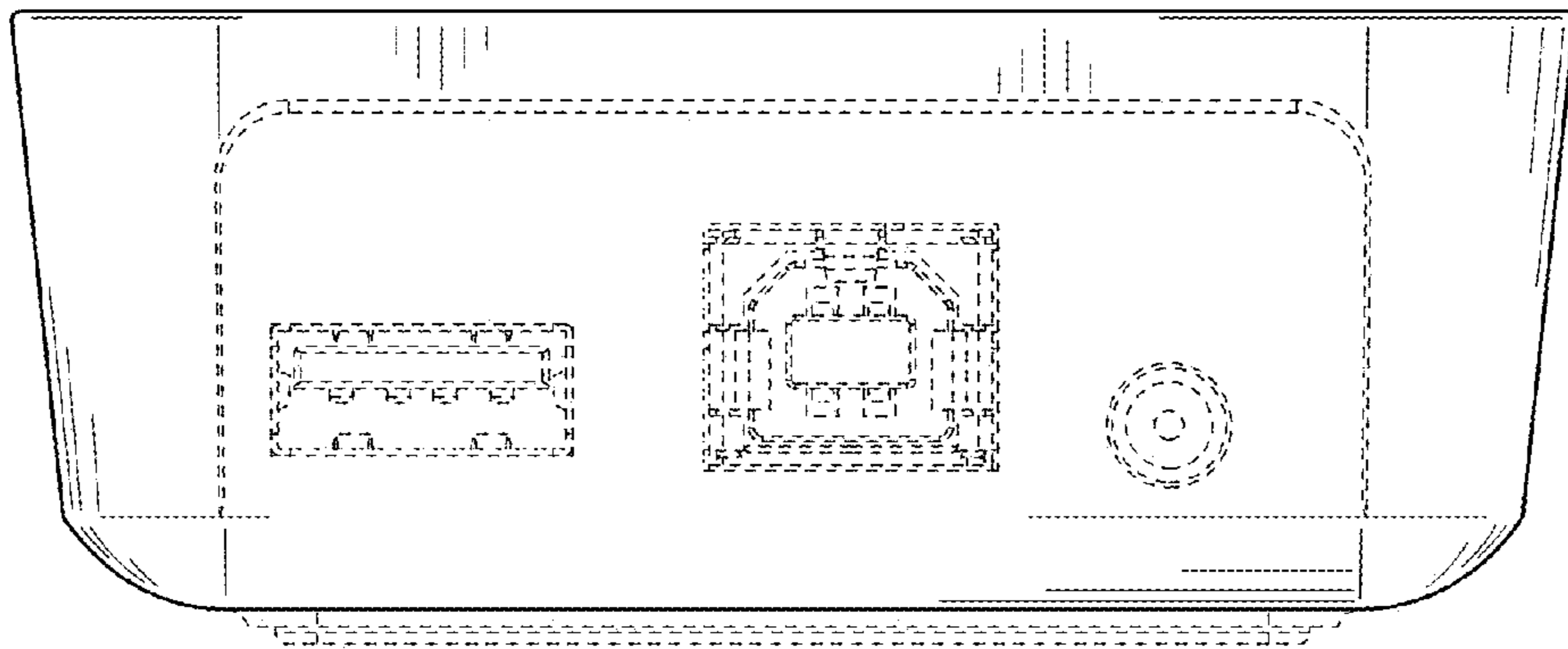

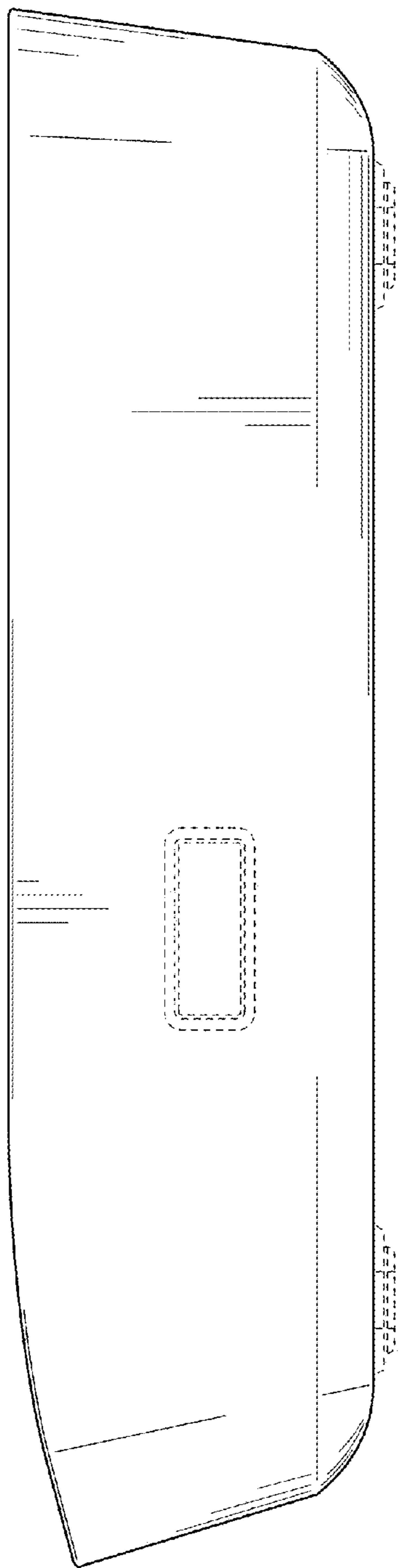

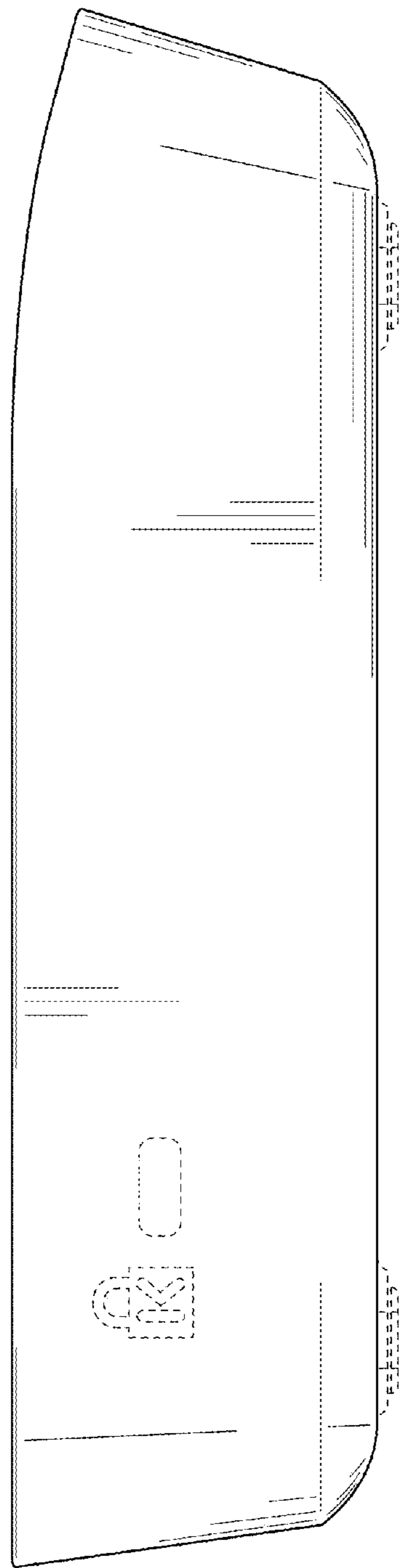

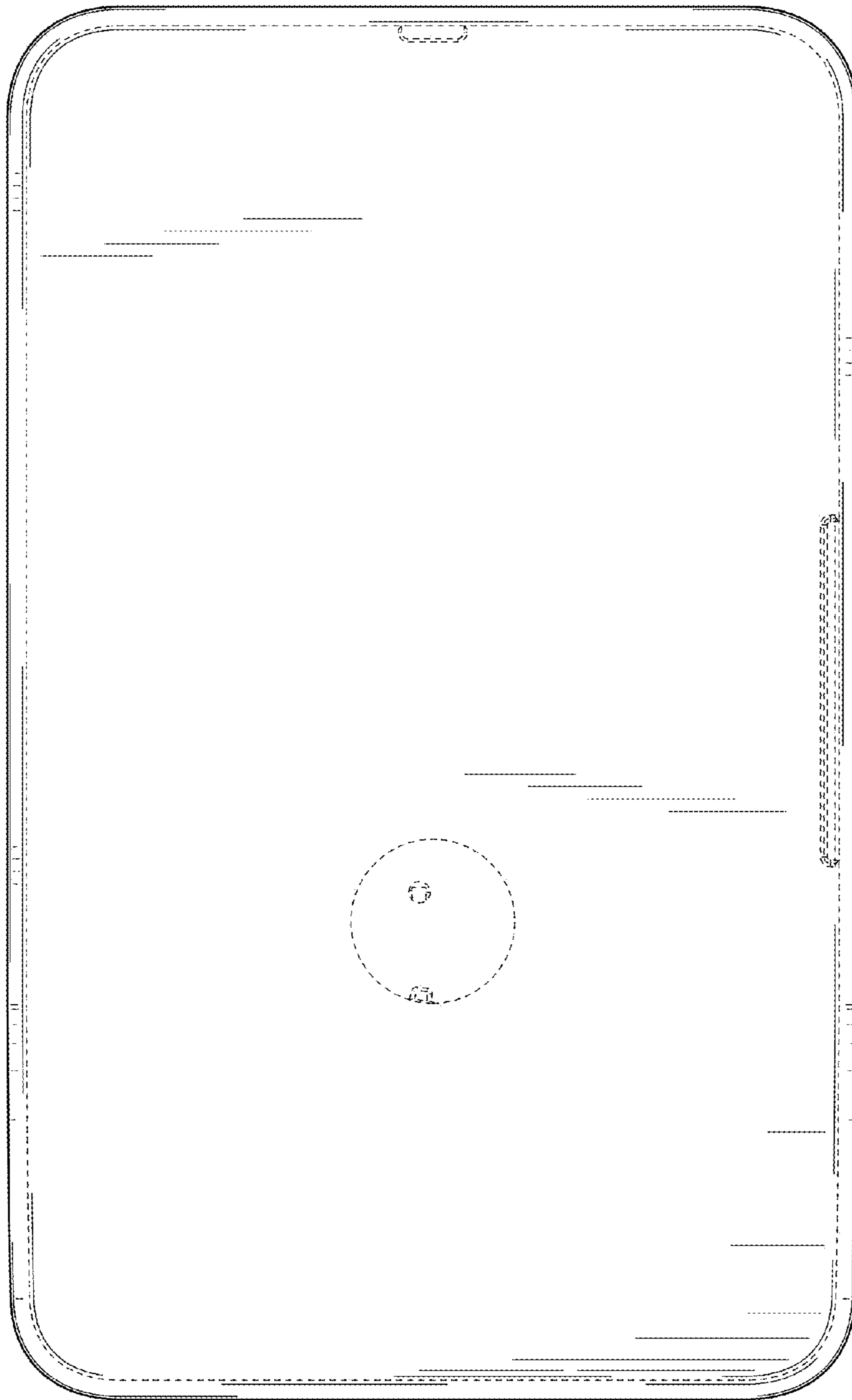

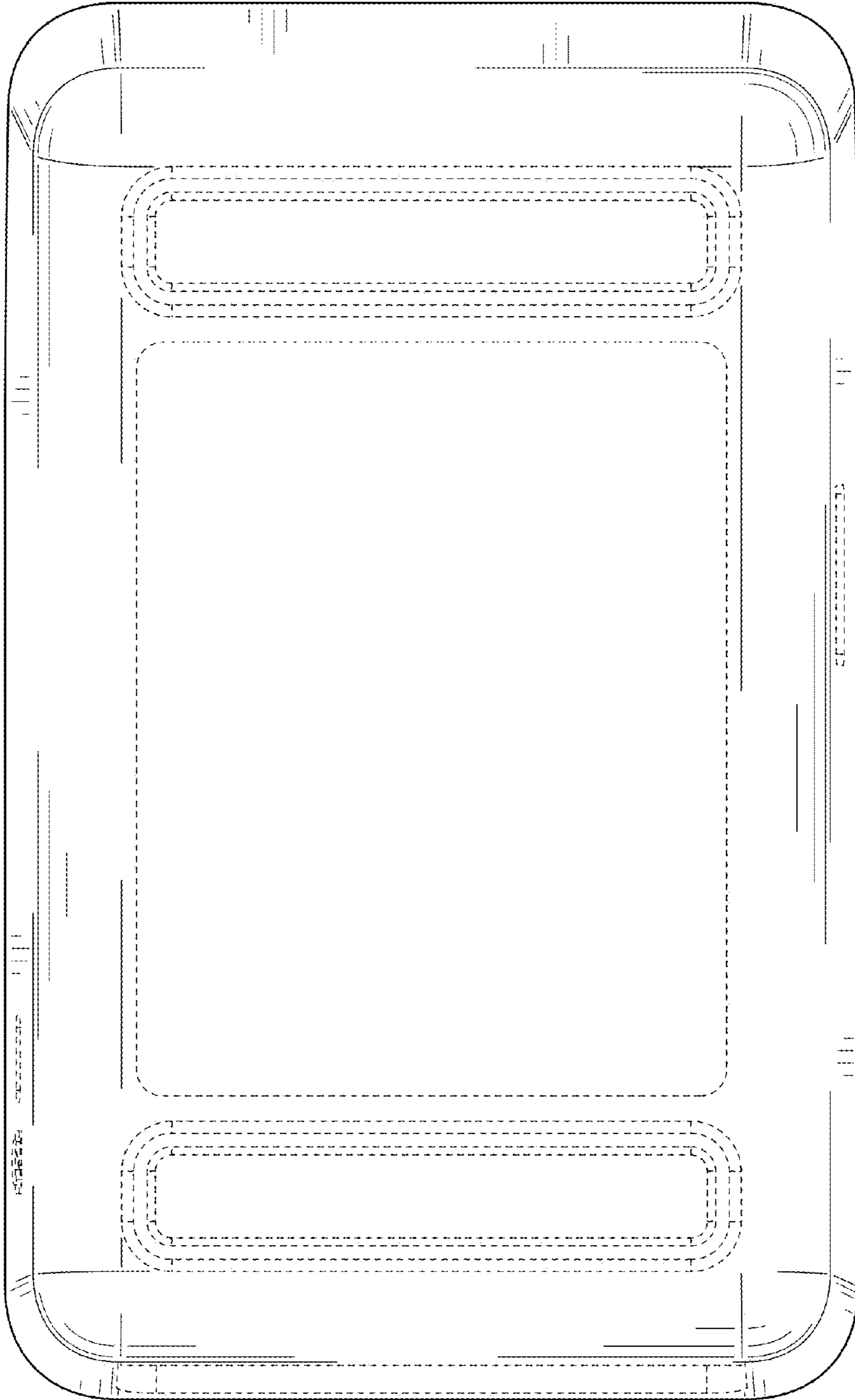

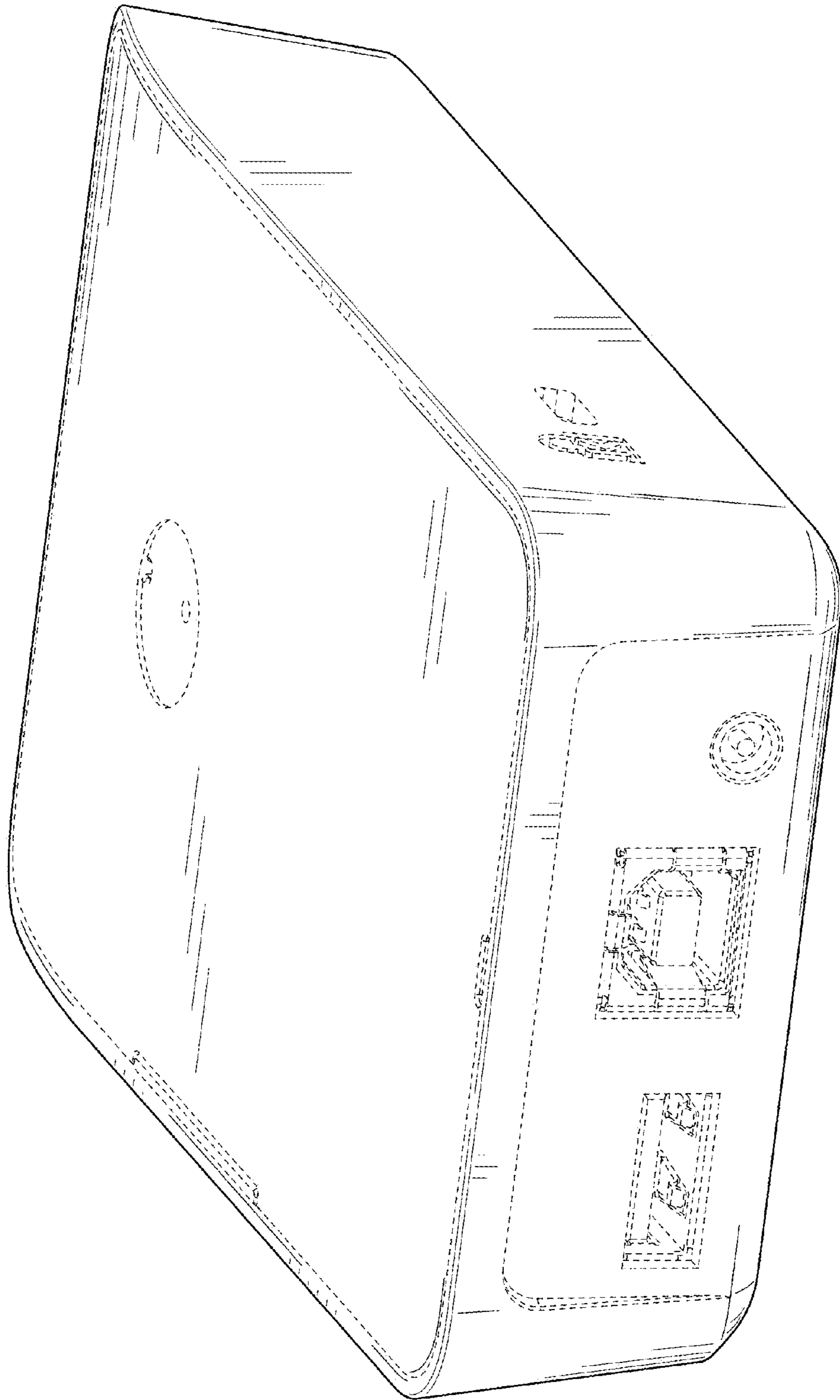
