FIG. 1 is a first image in a sequence for a display screen with animated graphical user interface; .

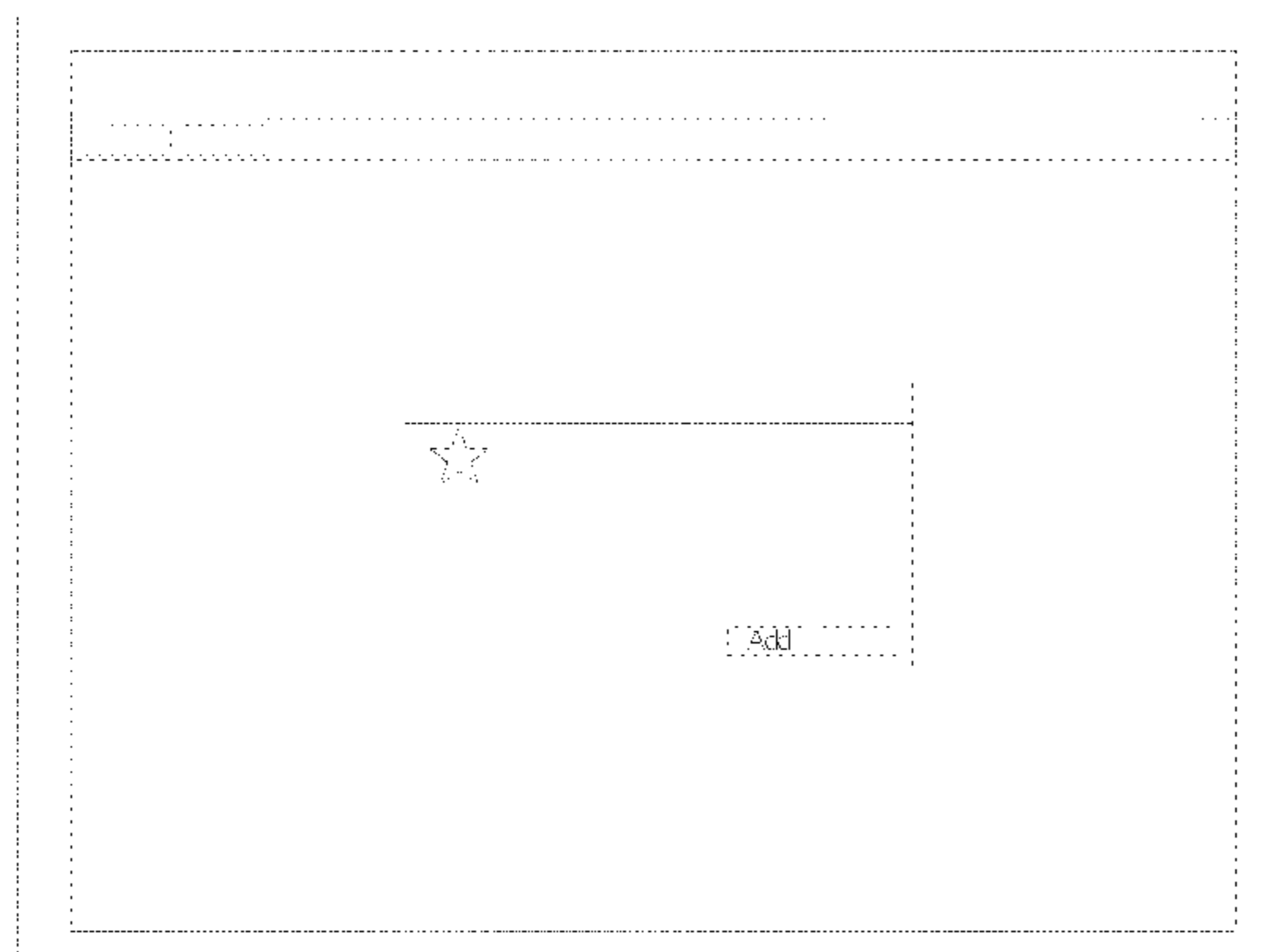

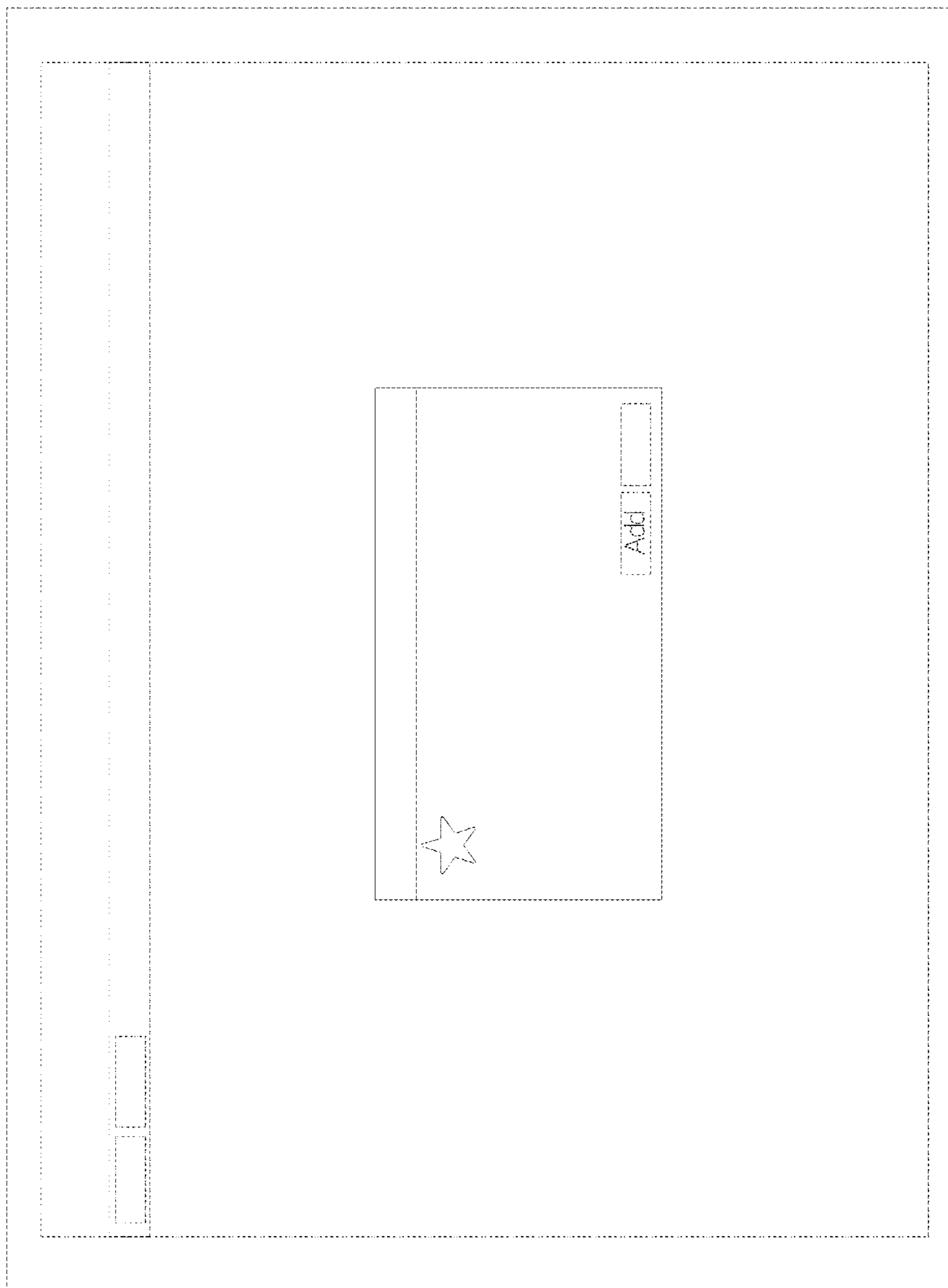

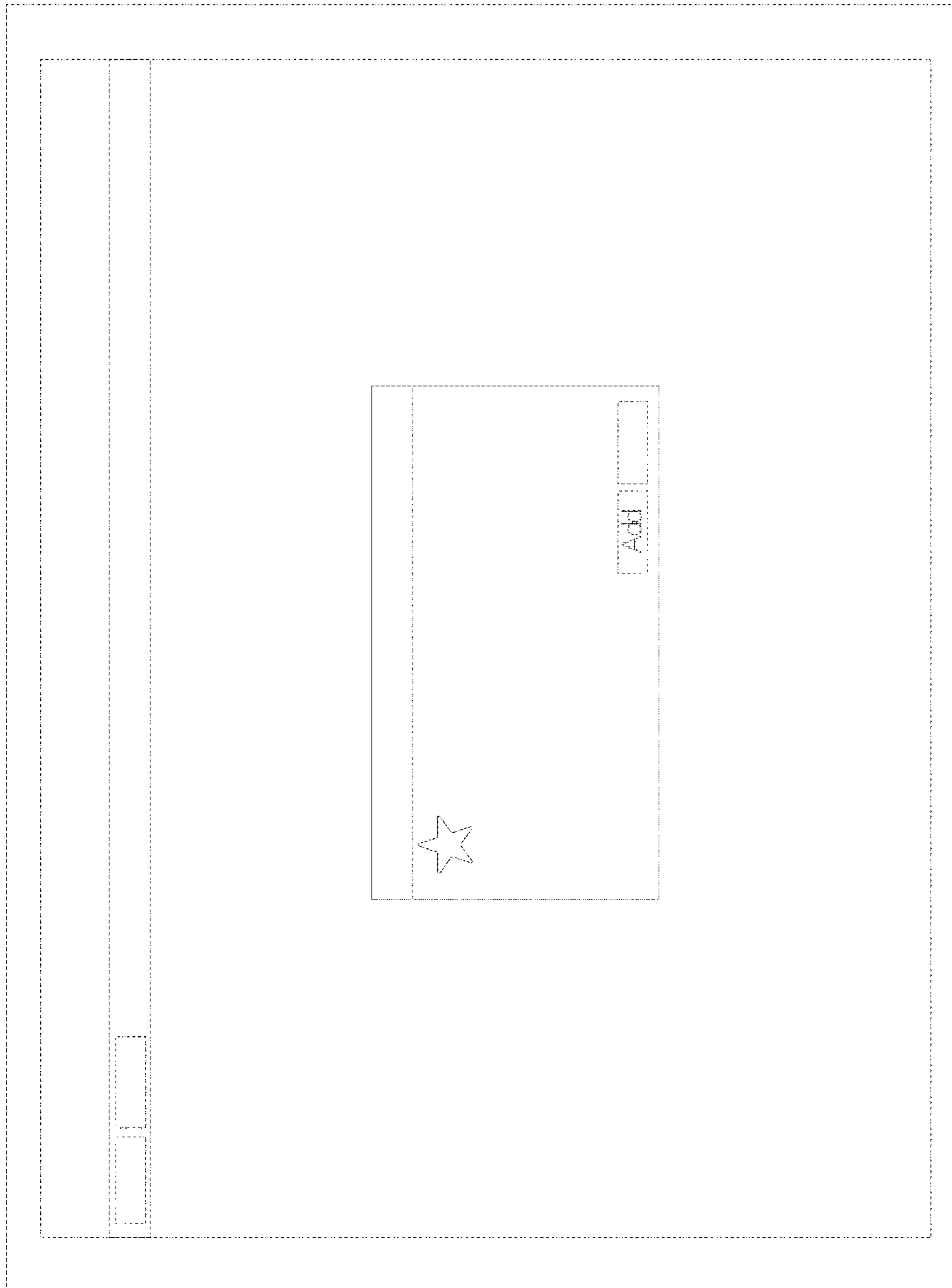
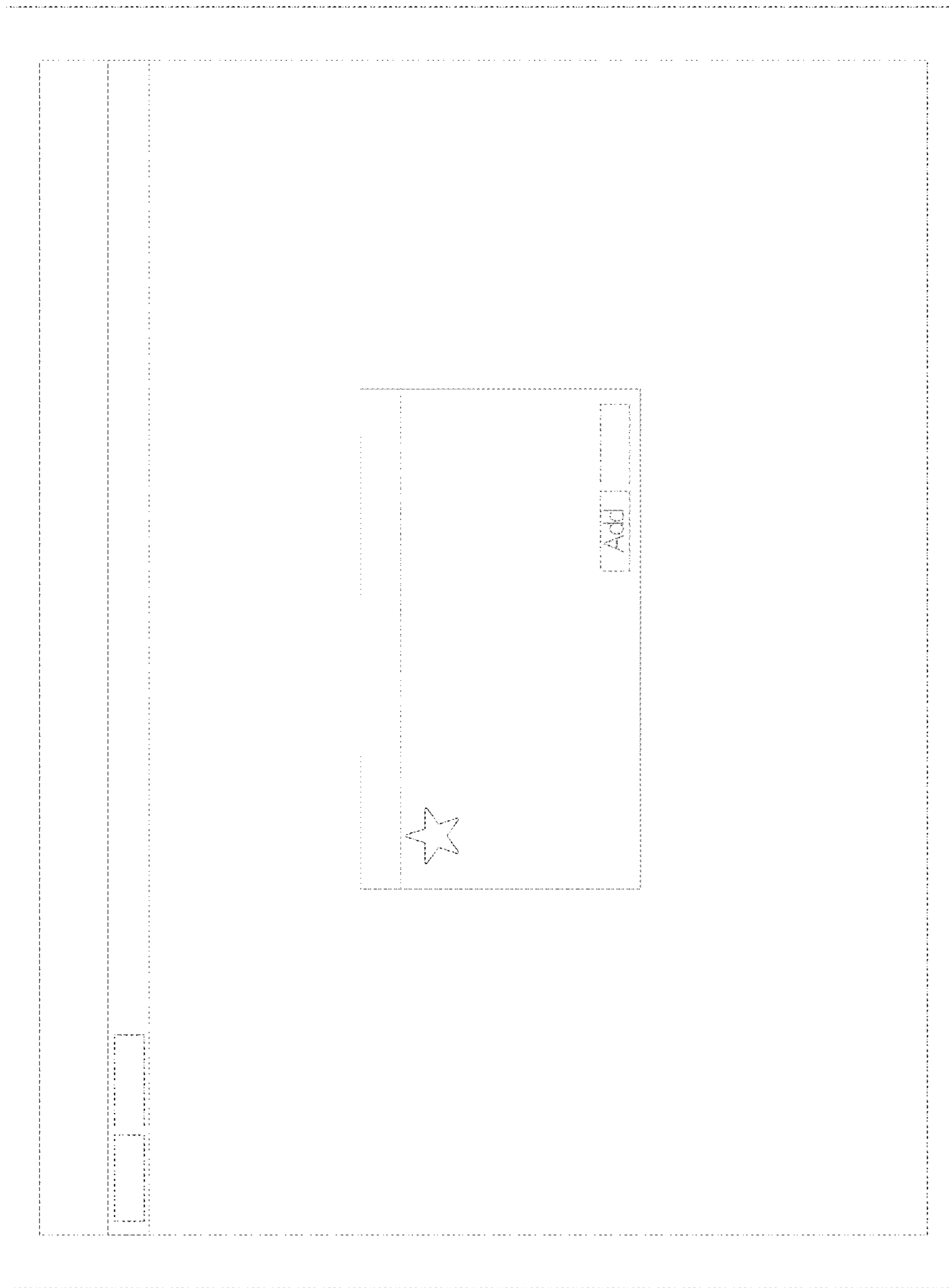

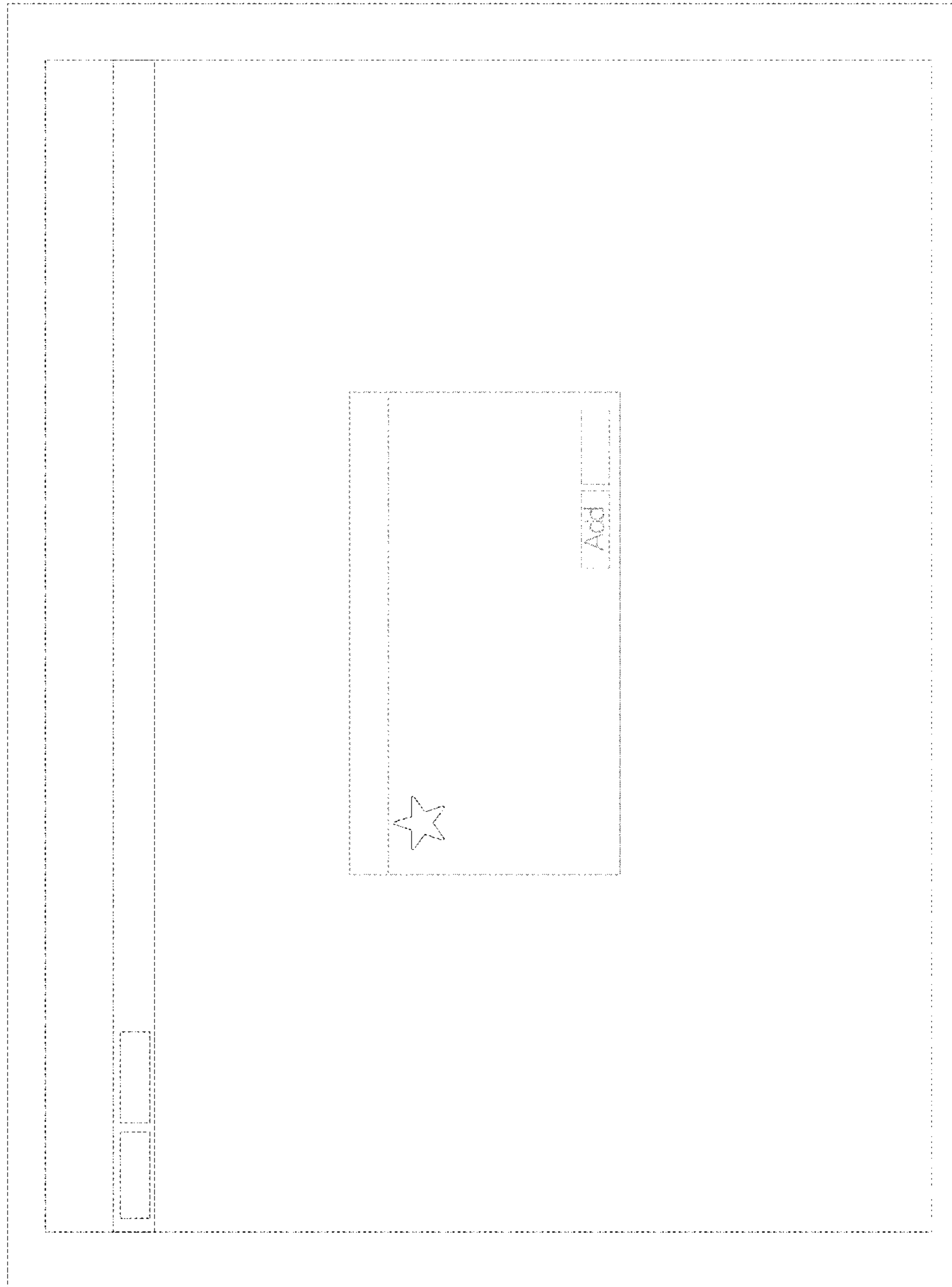

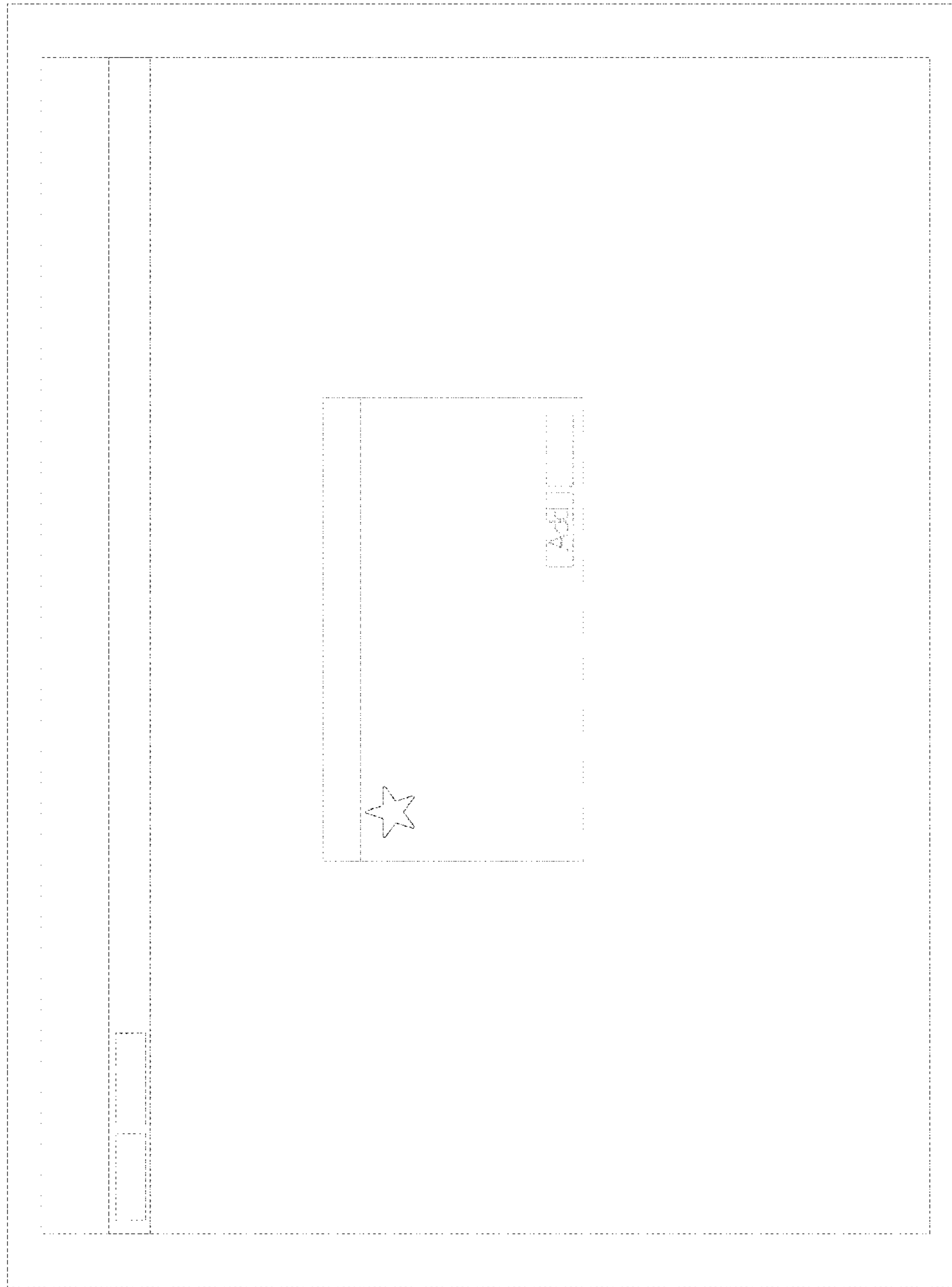

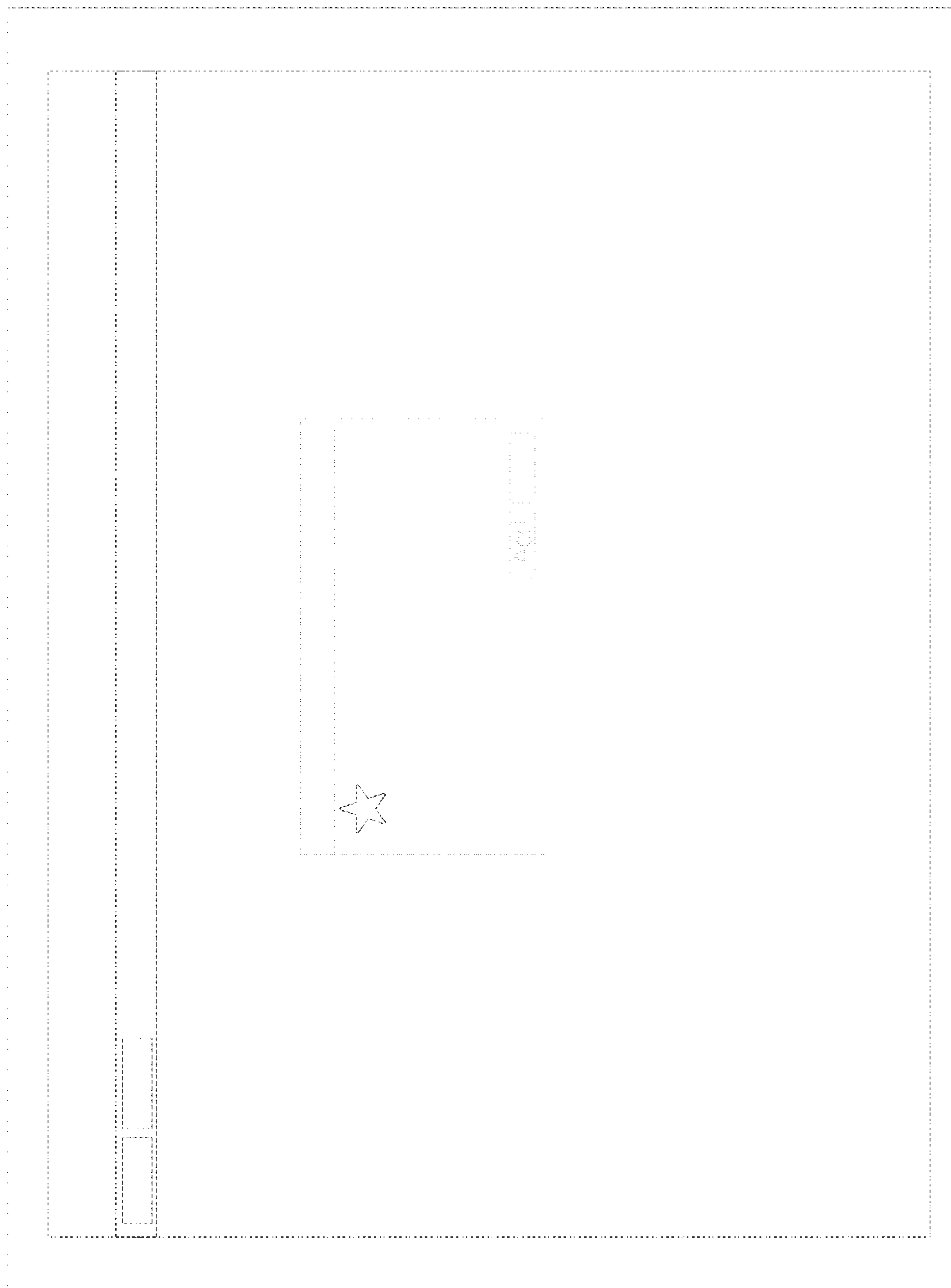

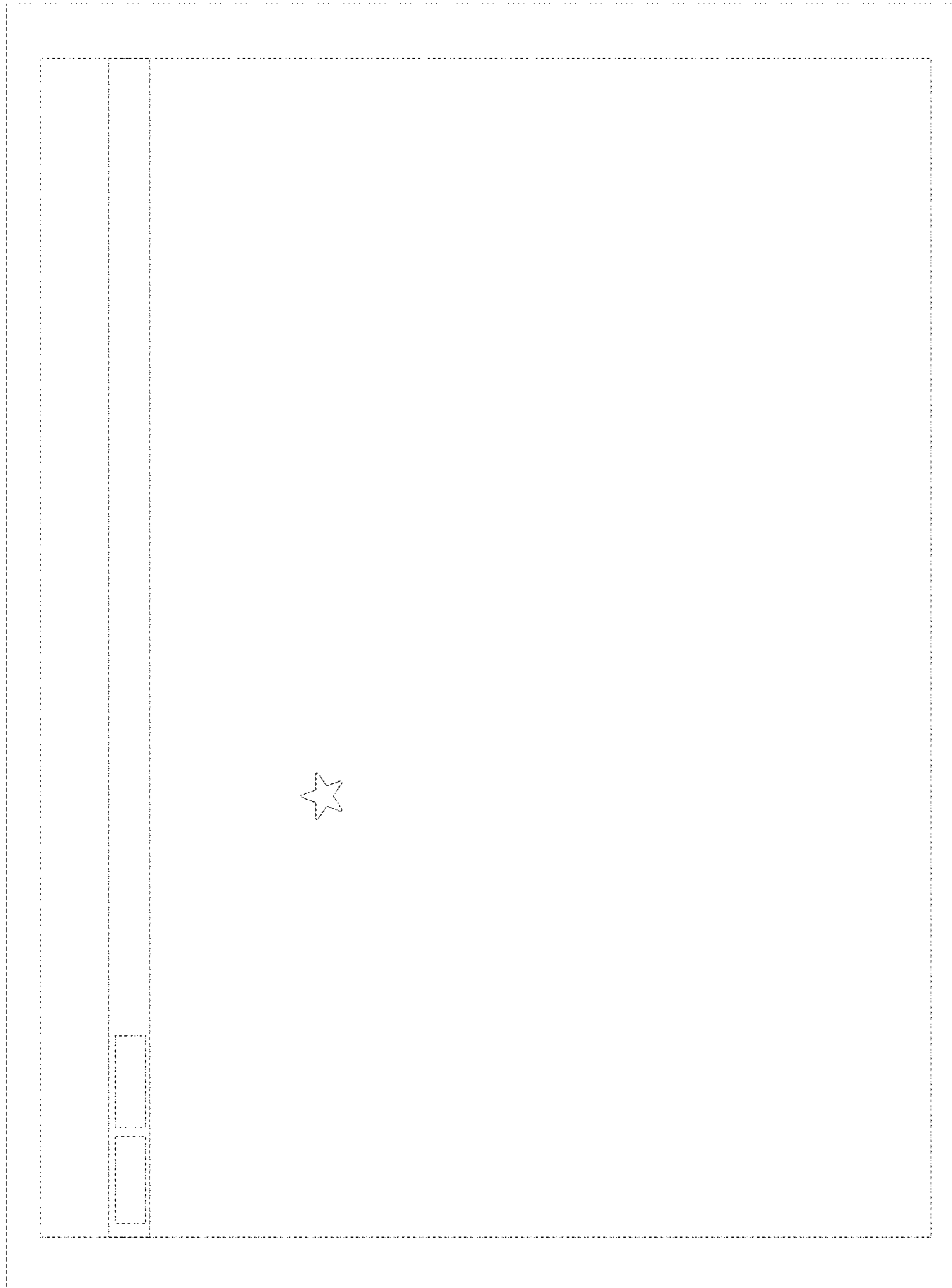

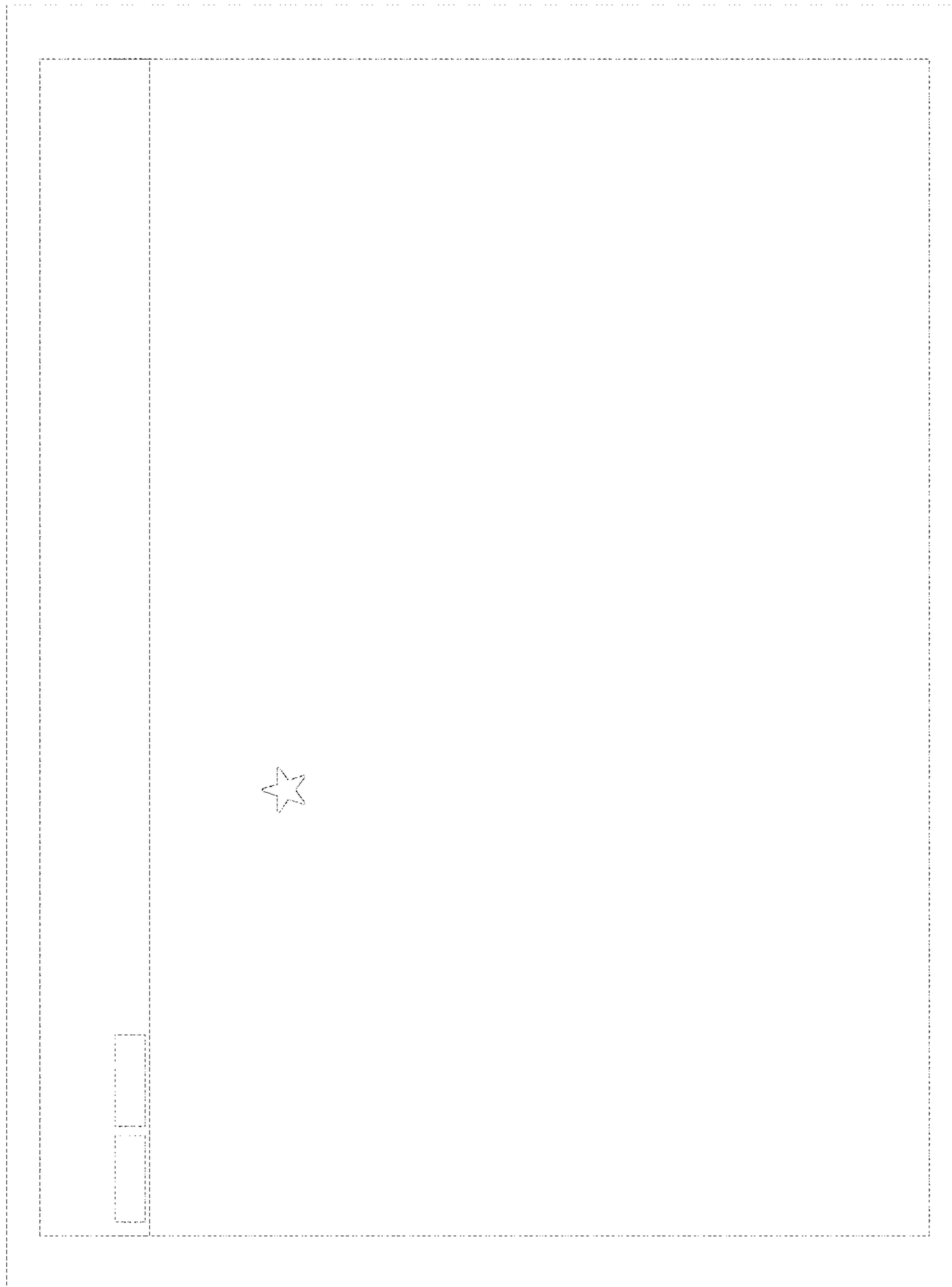

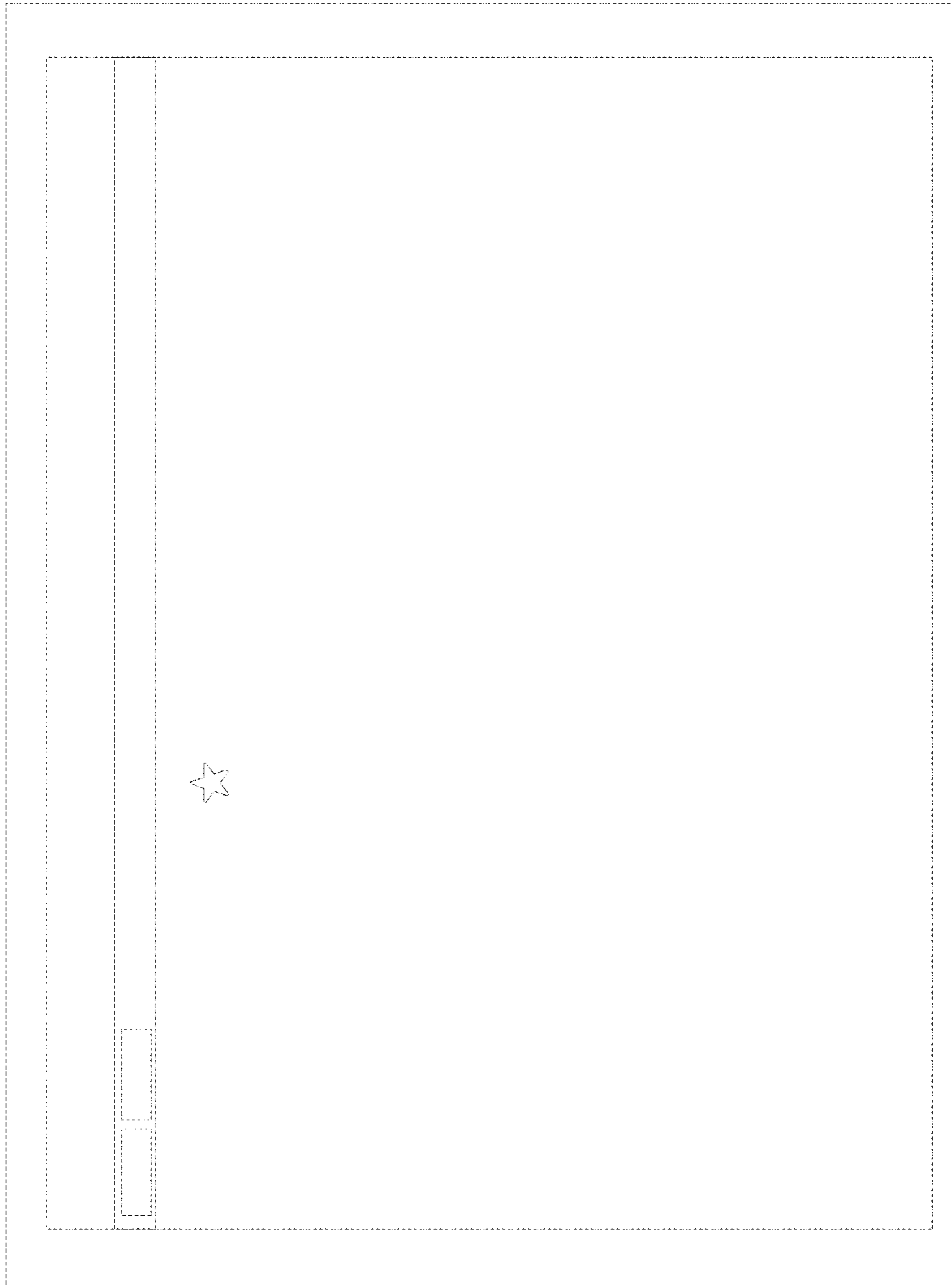

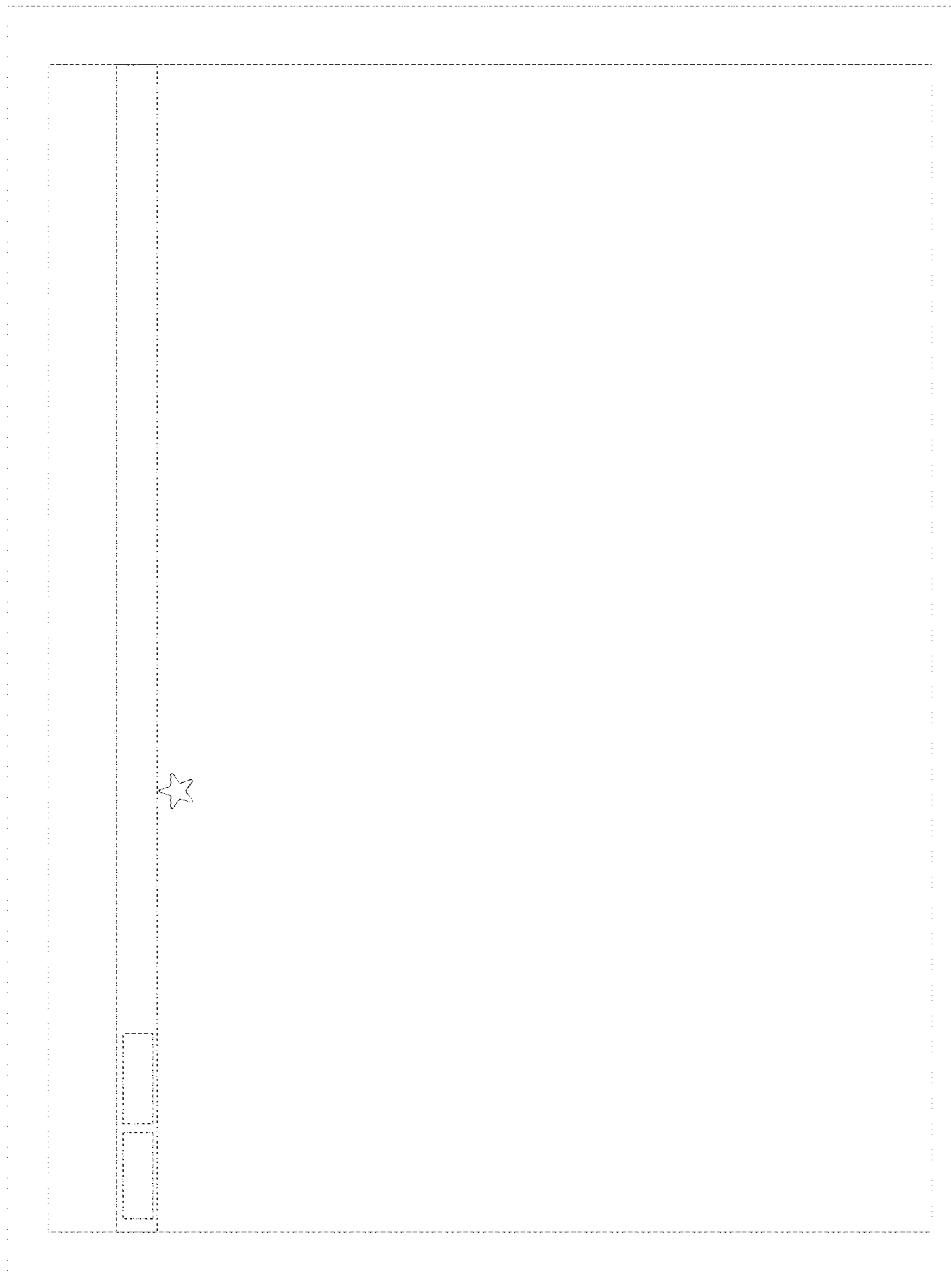

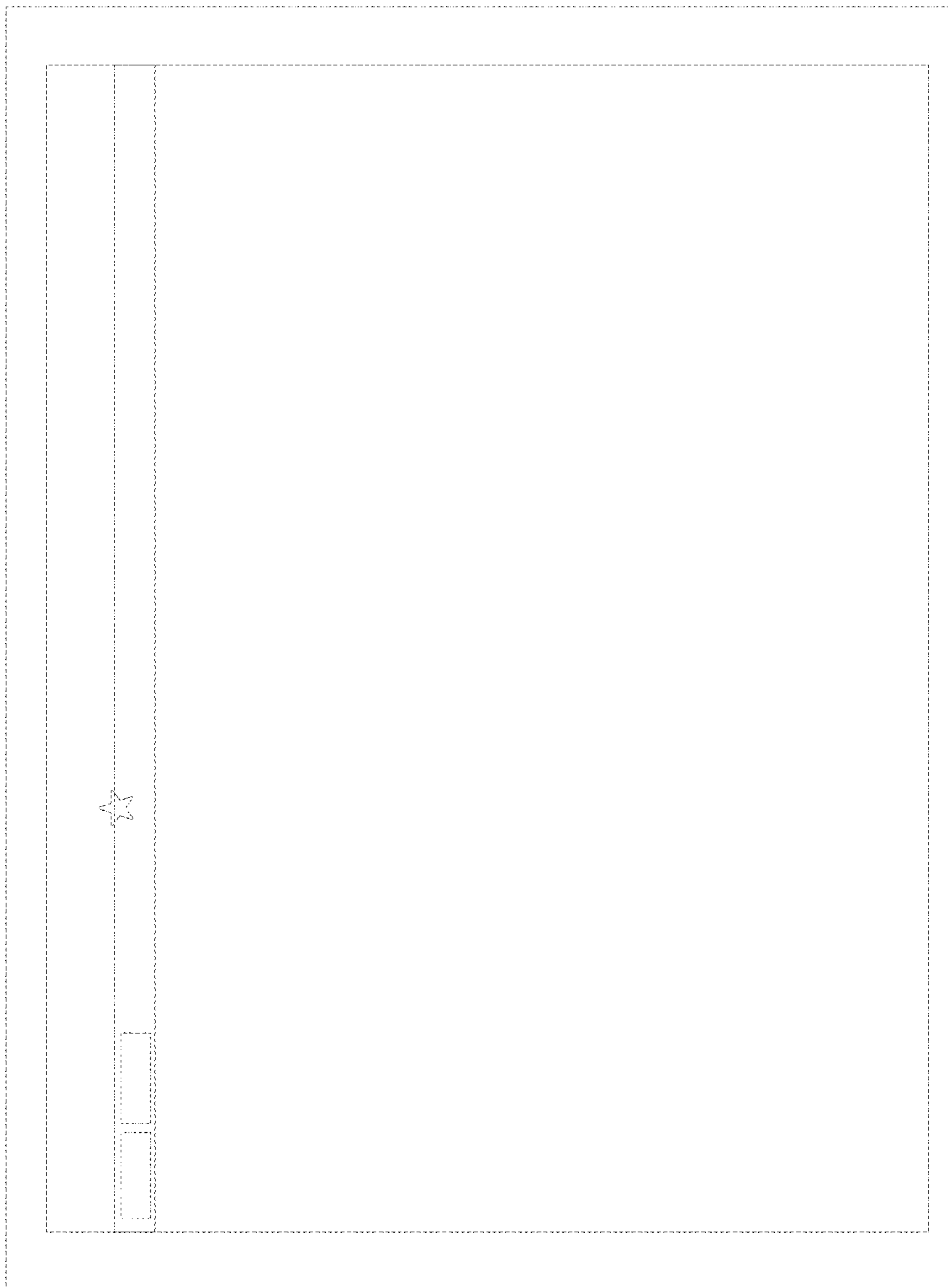

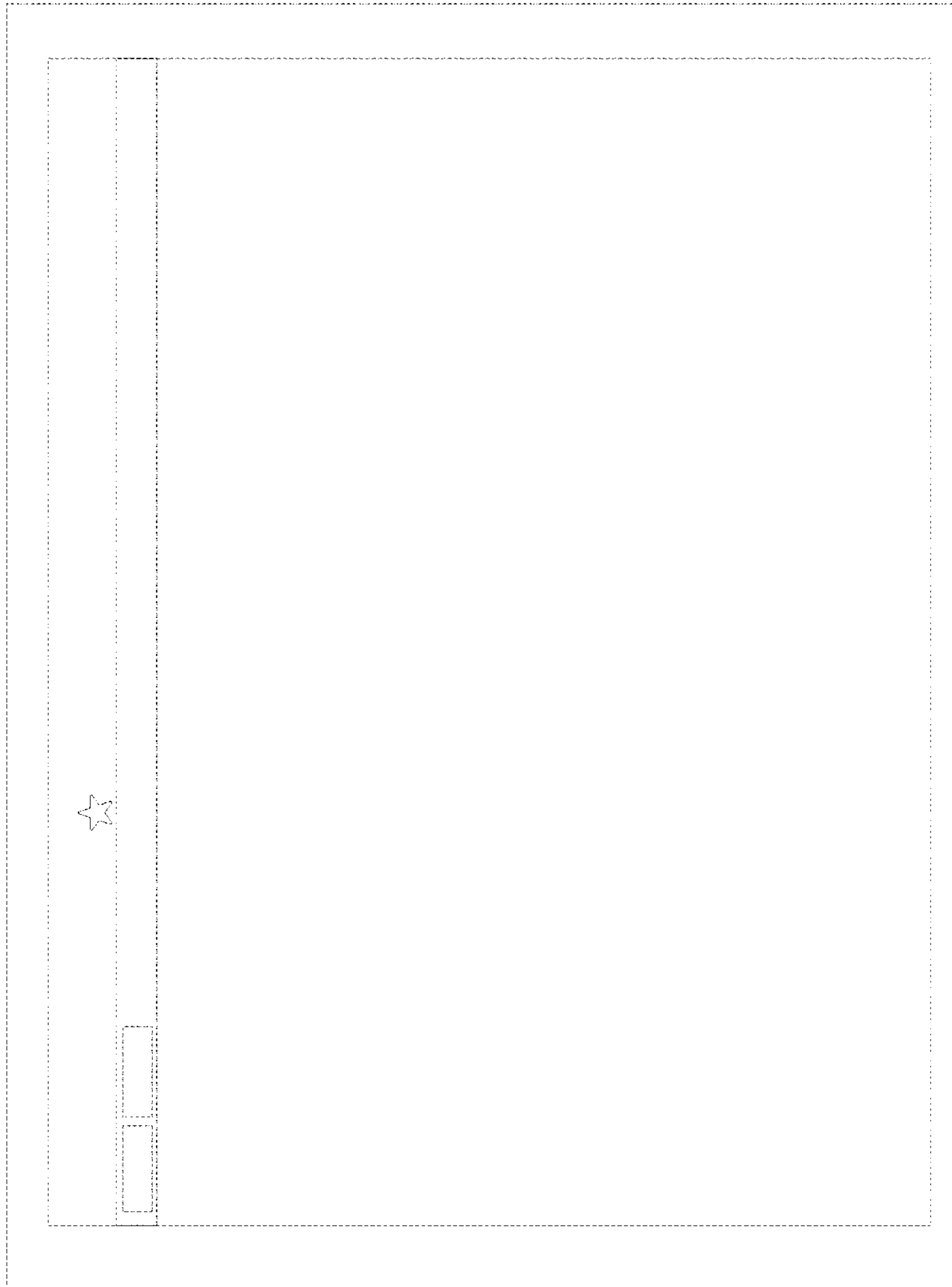
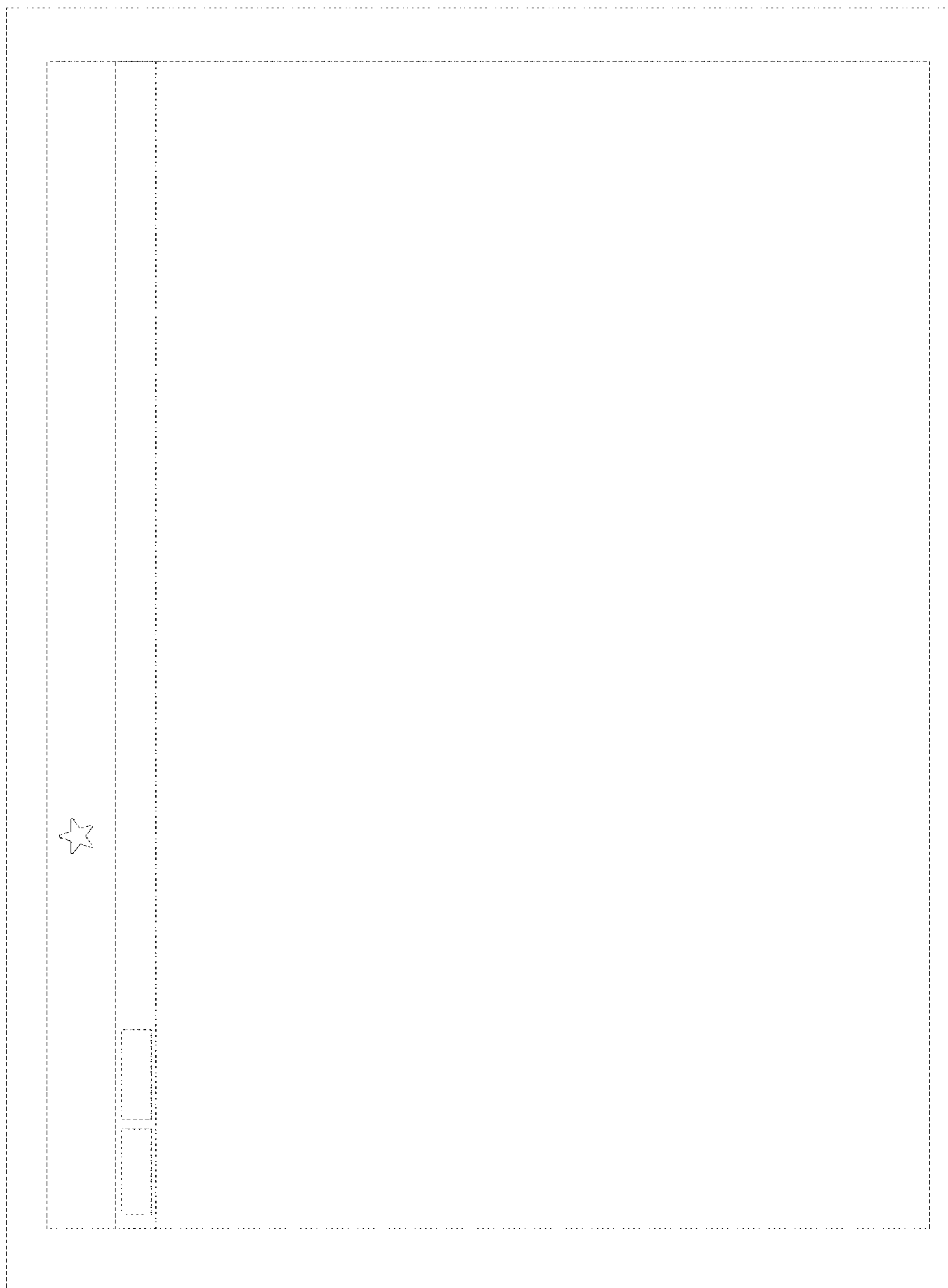

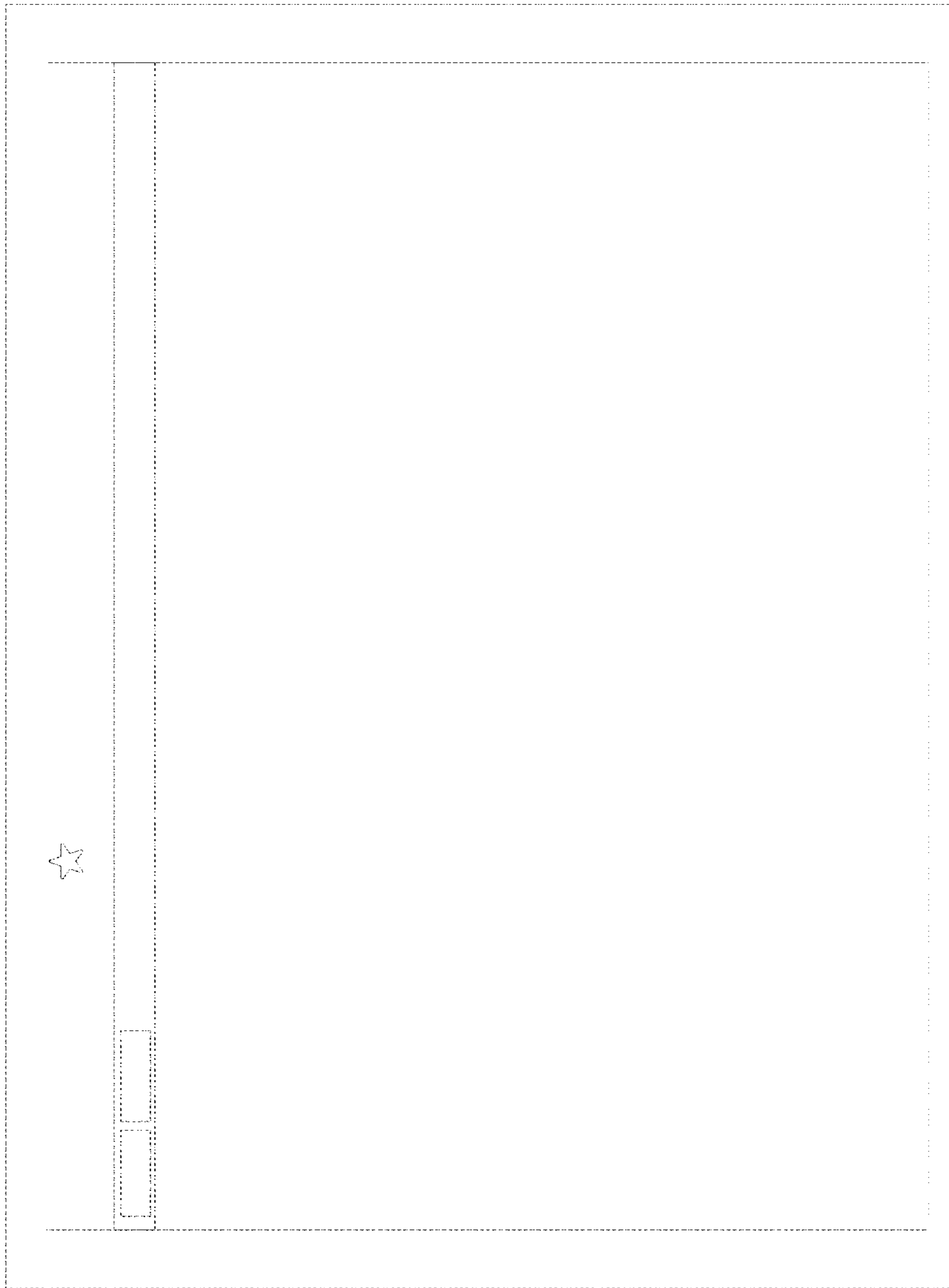
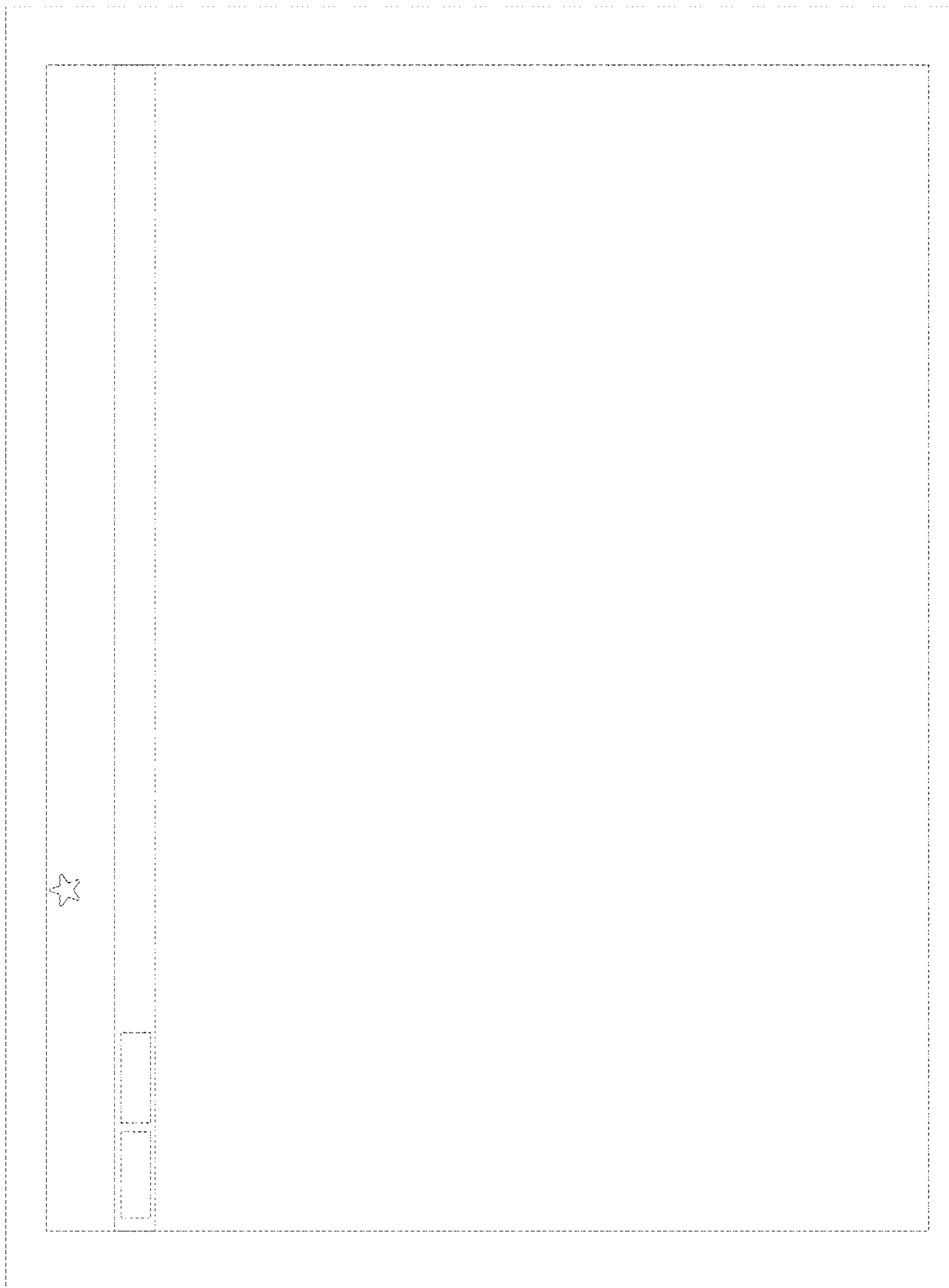

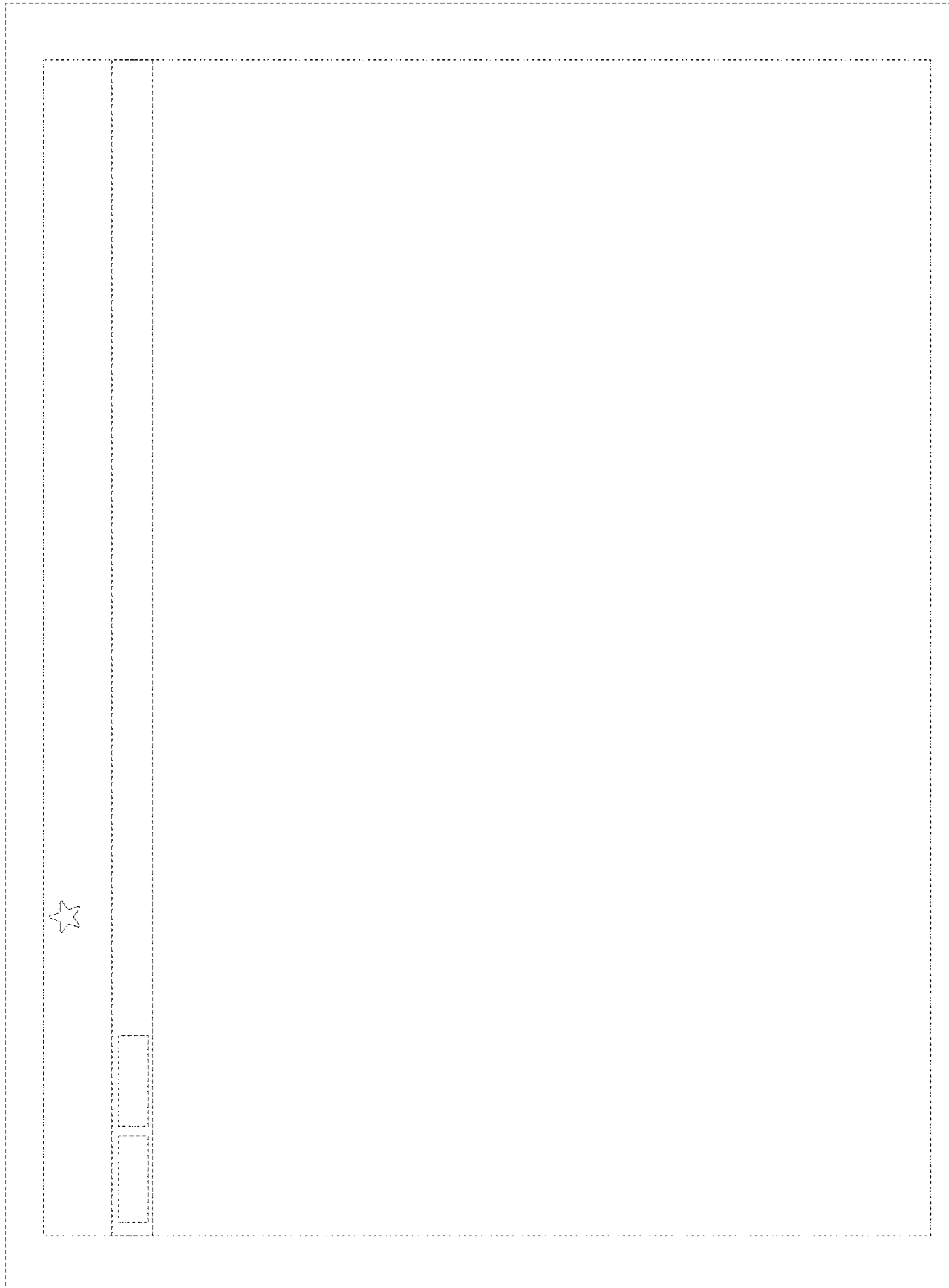

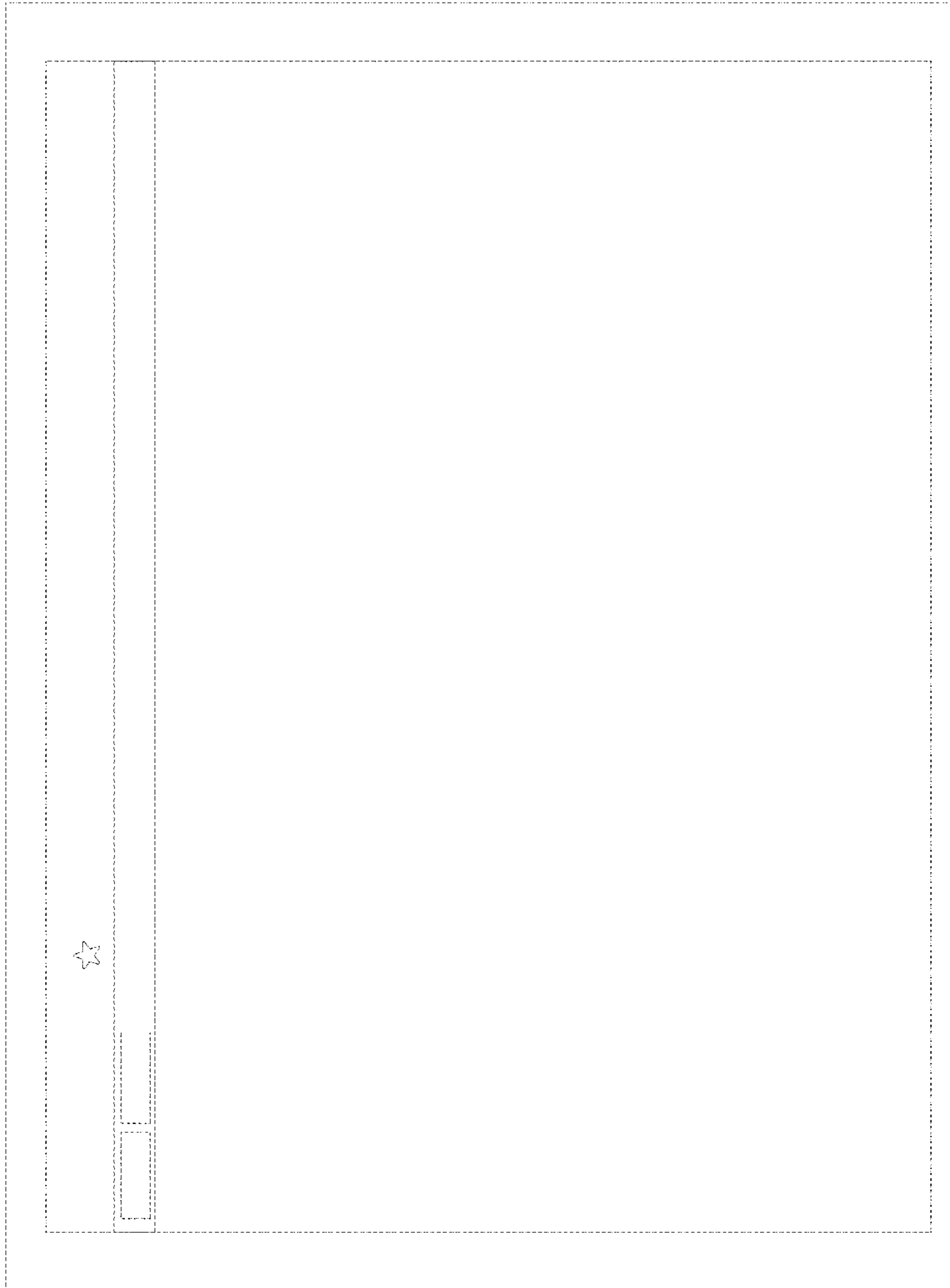

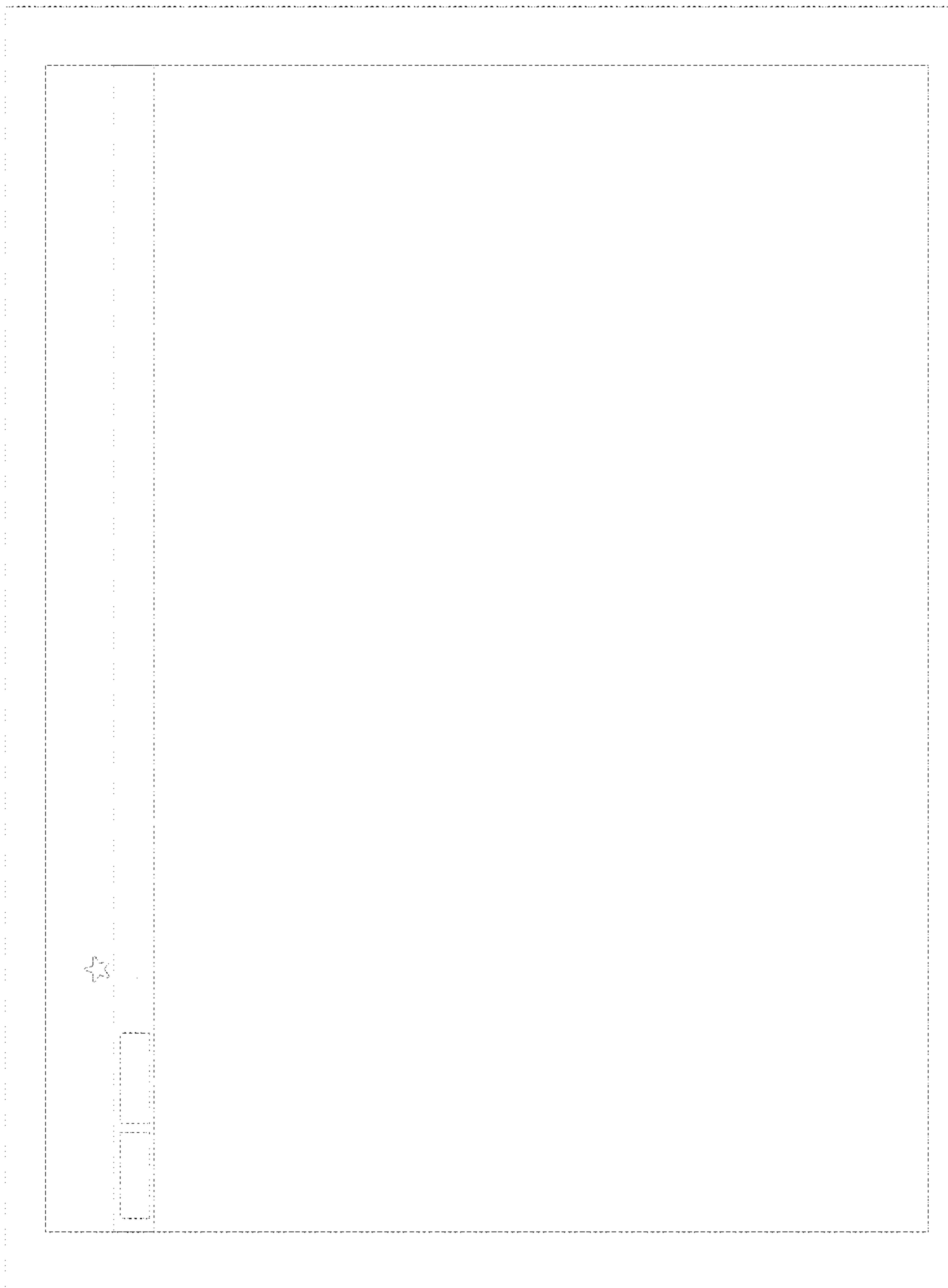

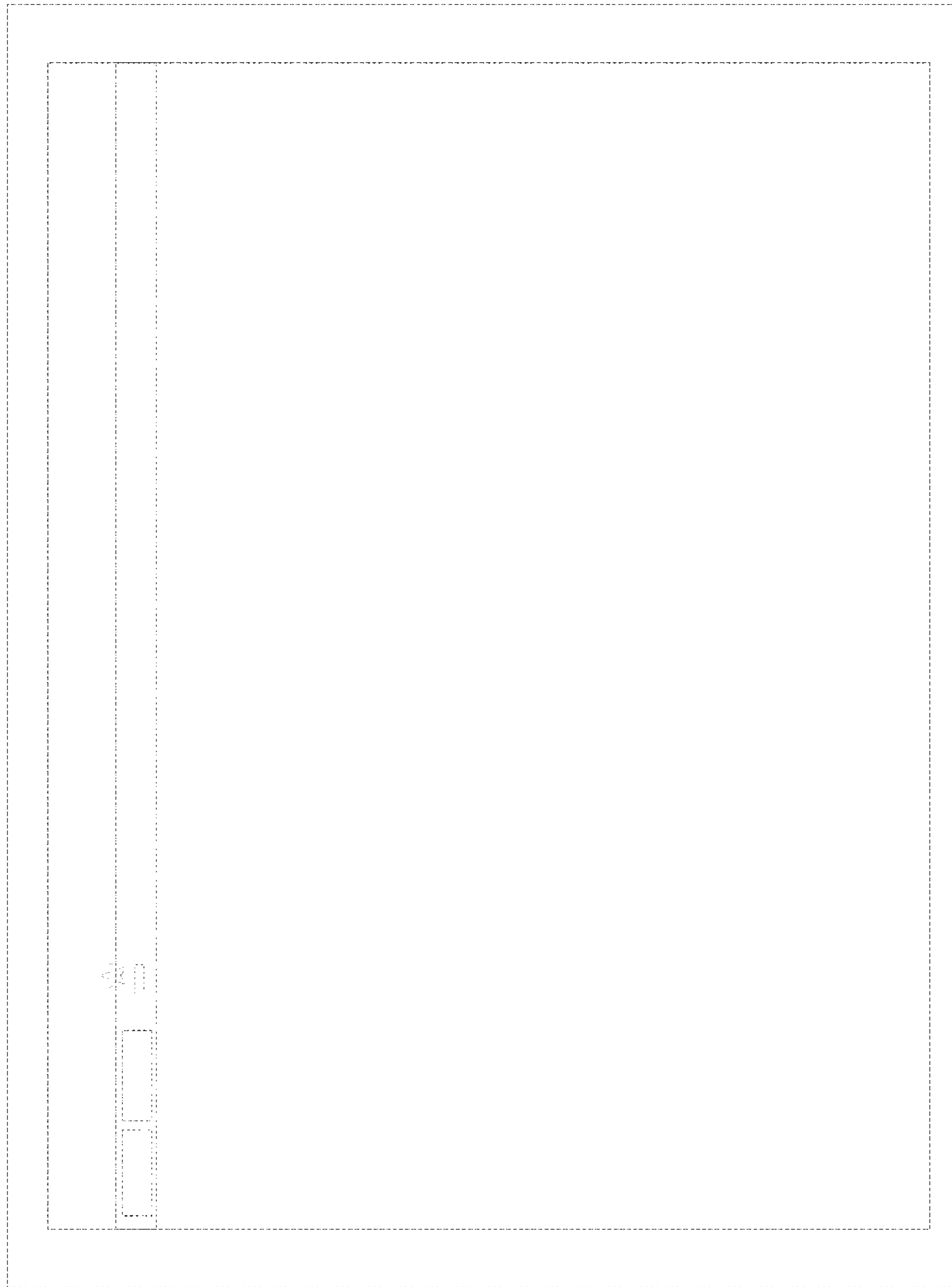

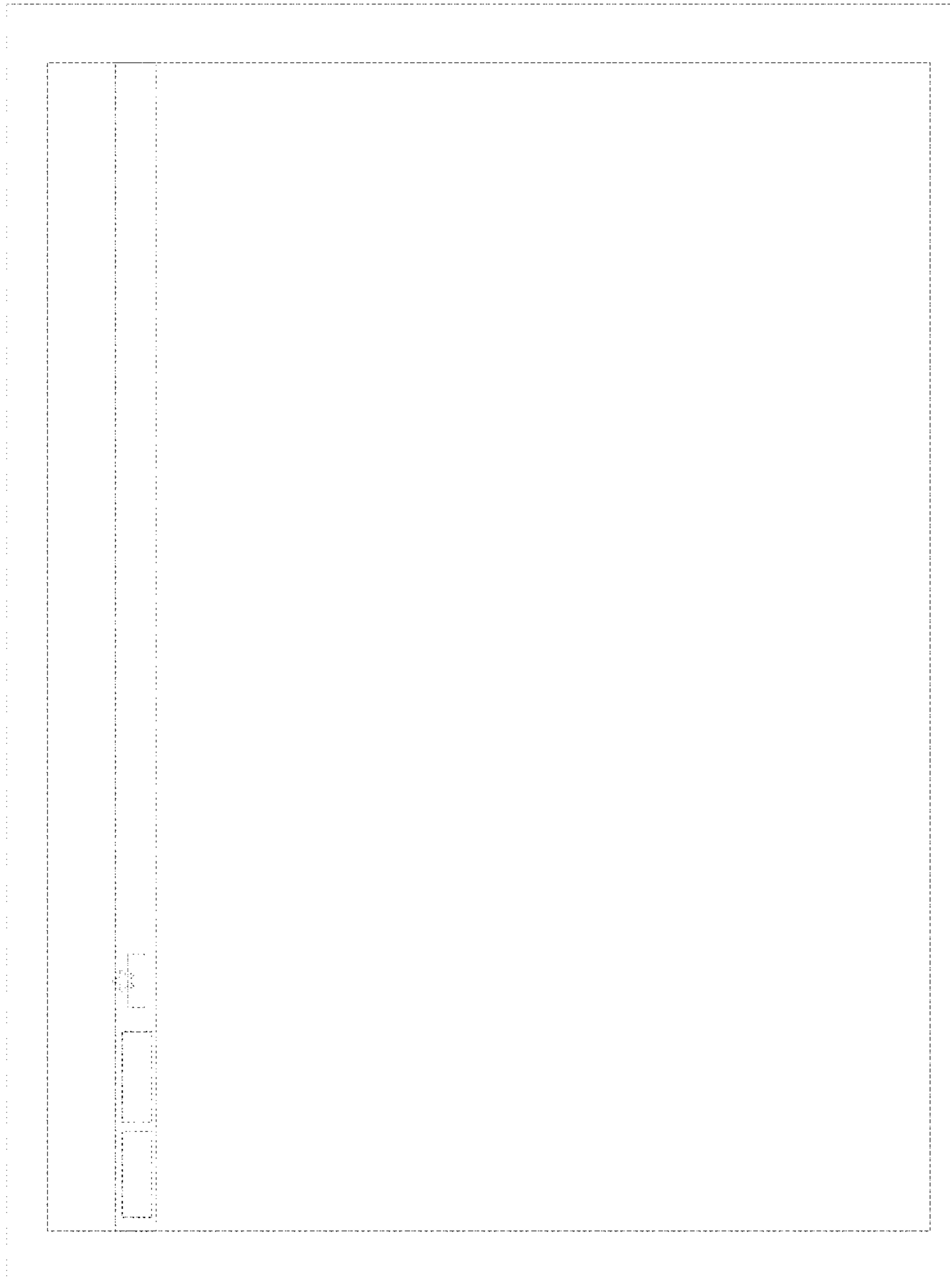

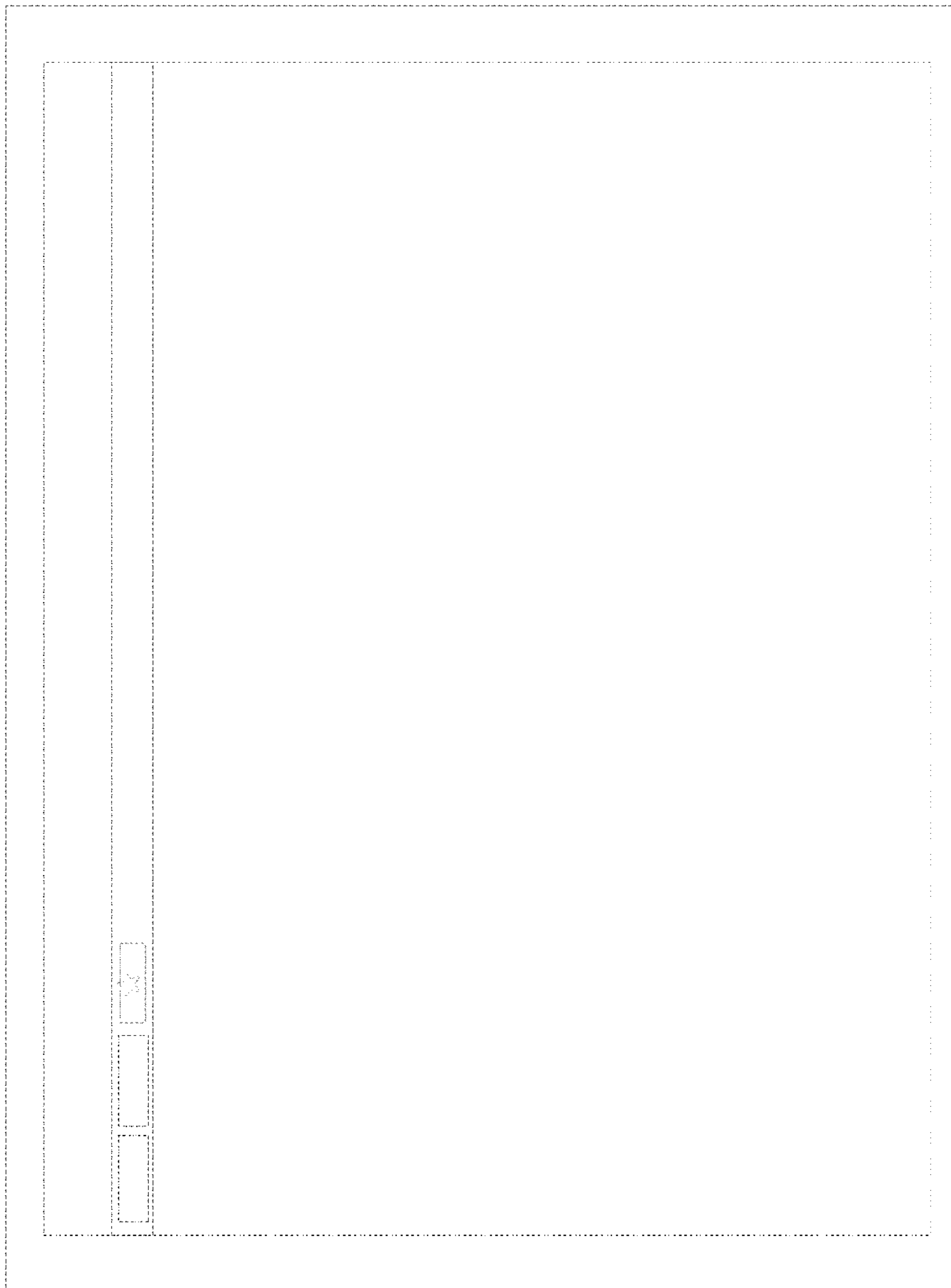

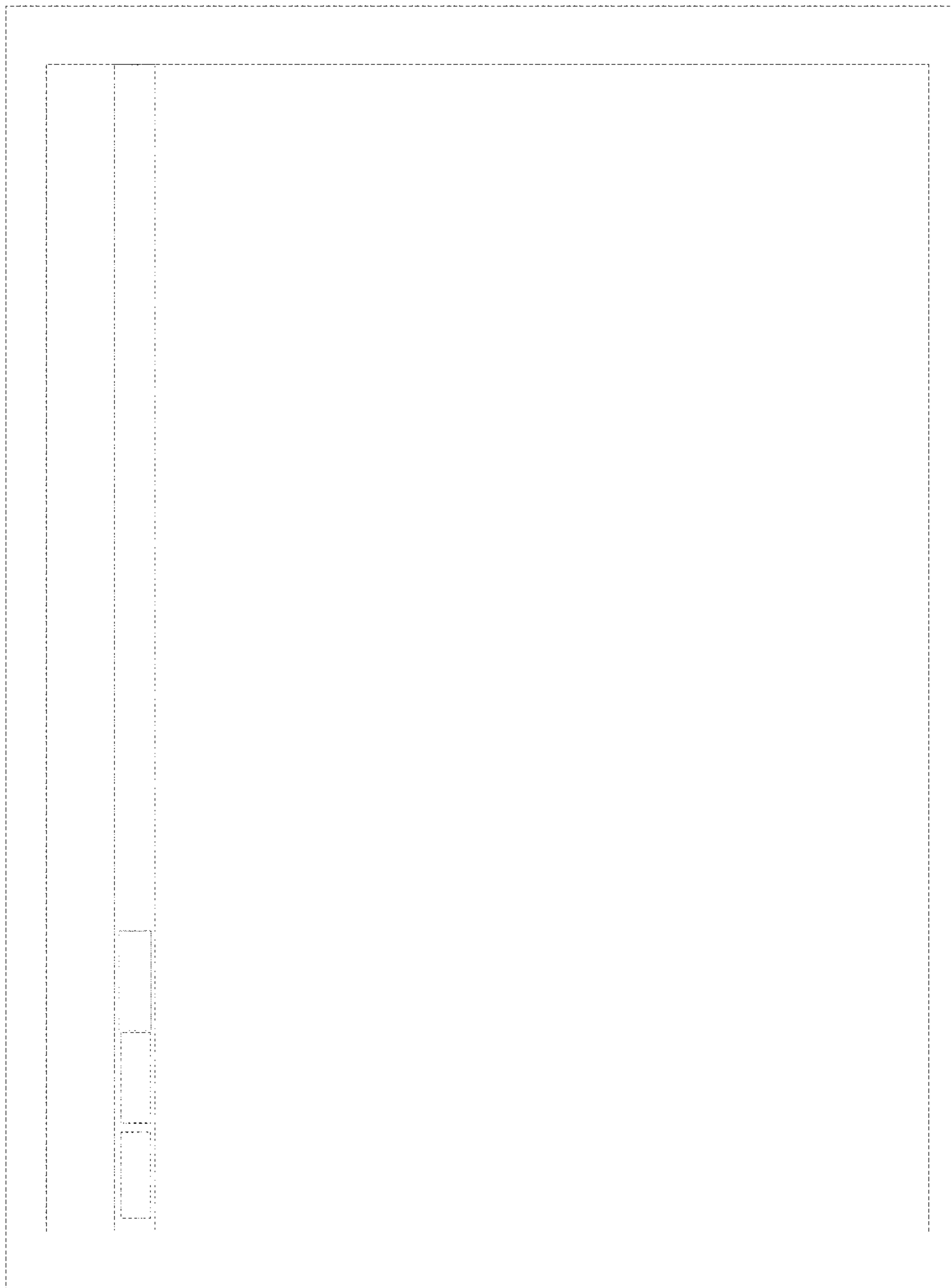

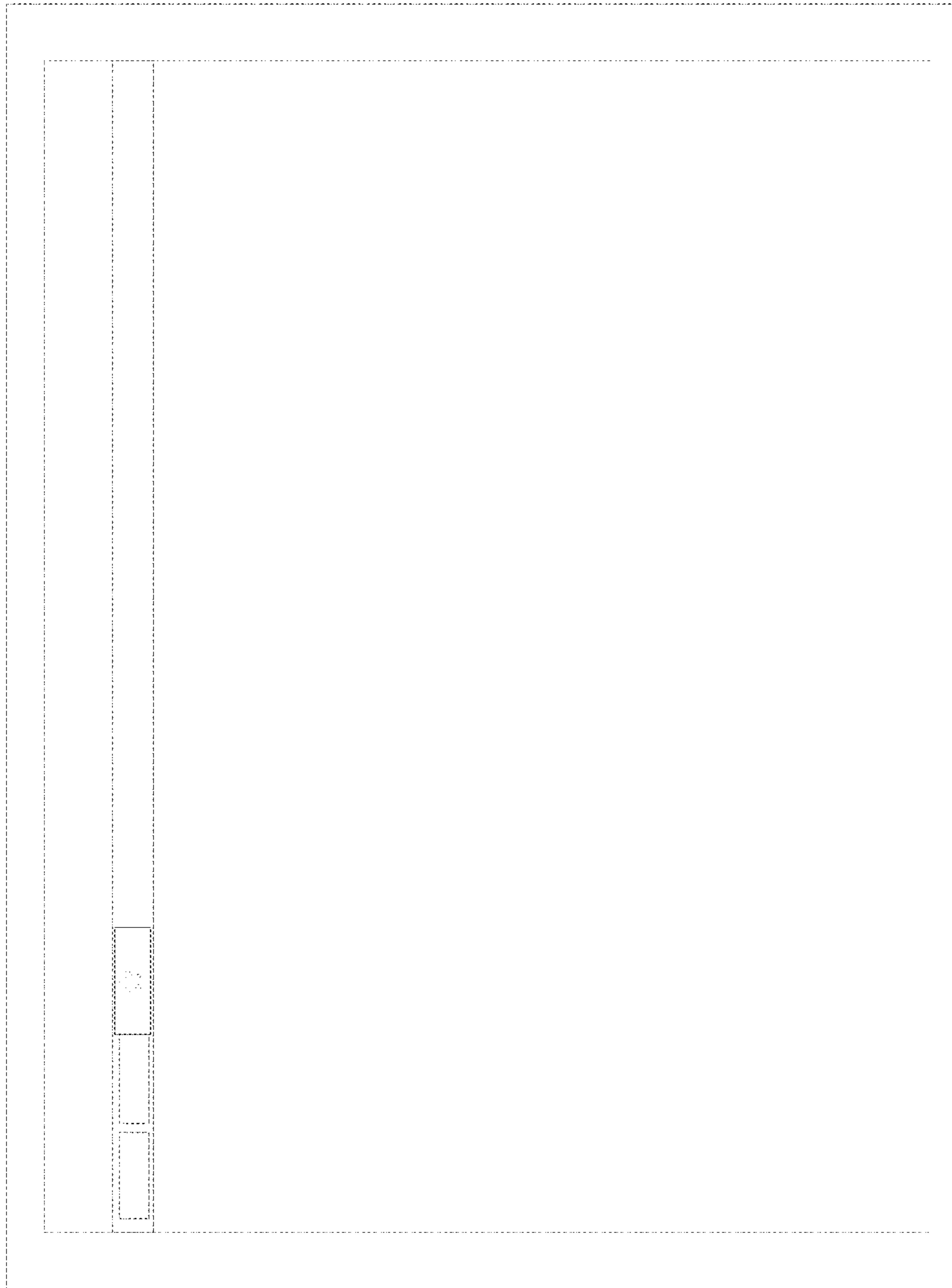

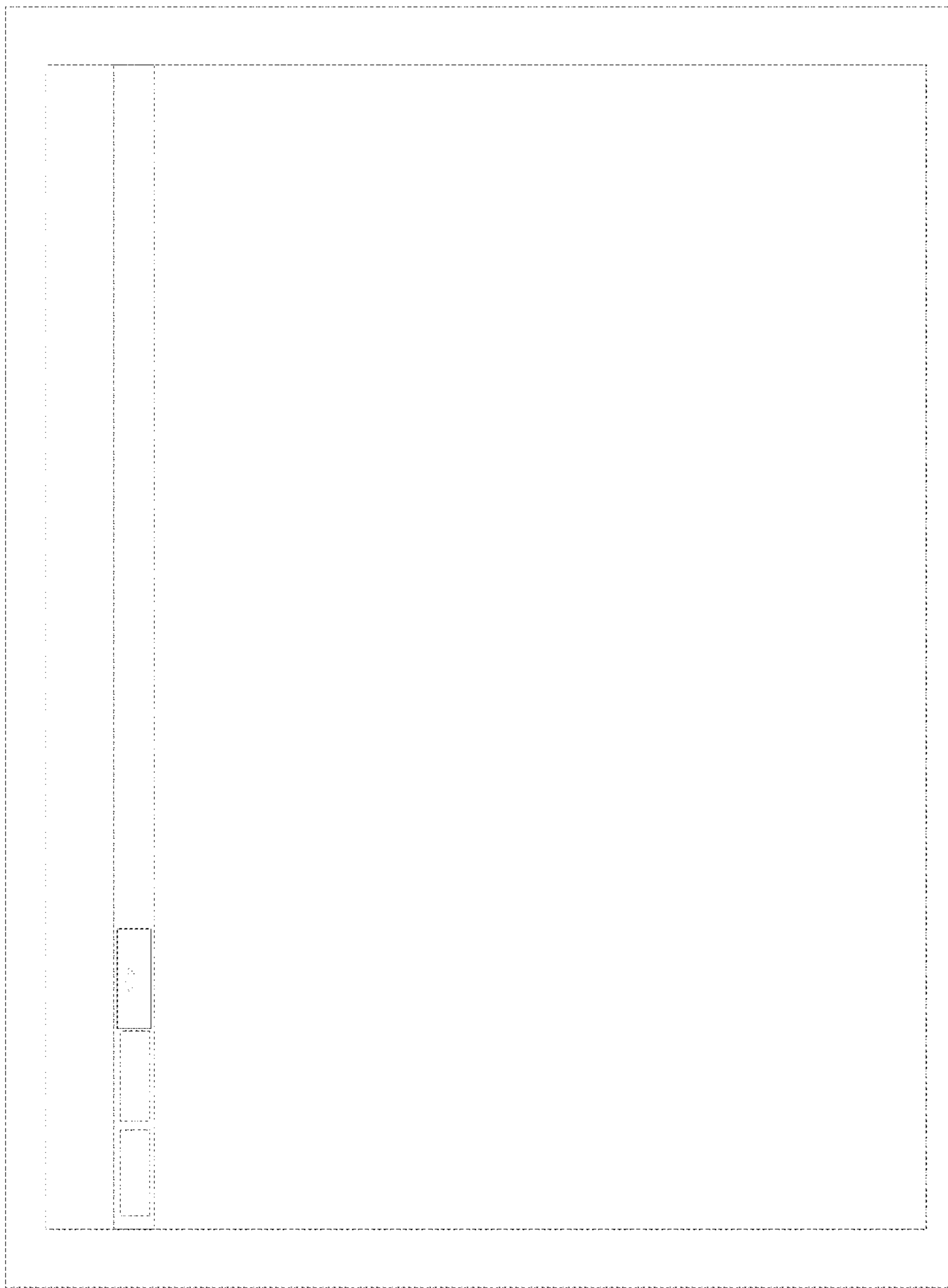

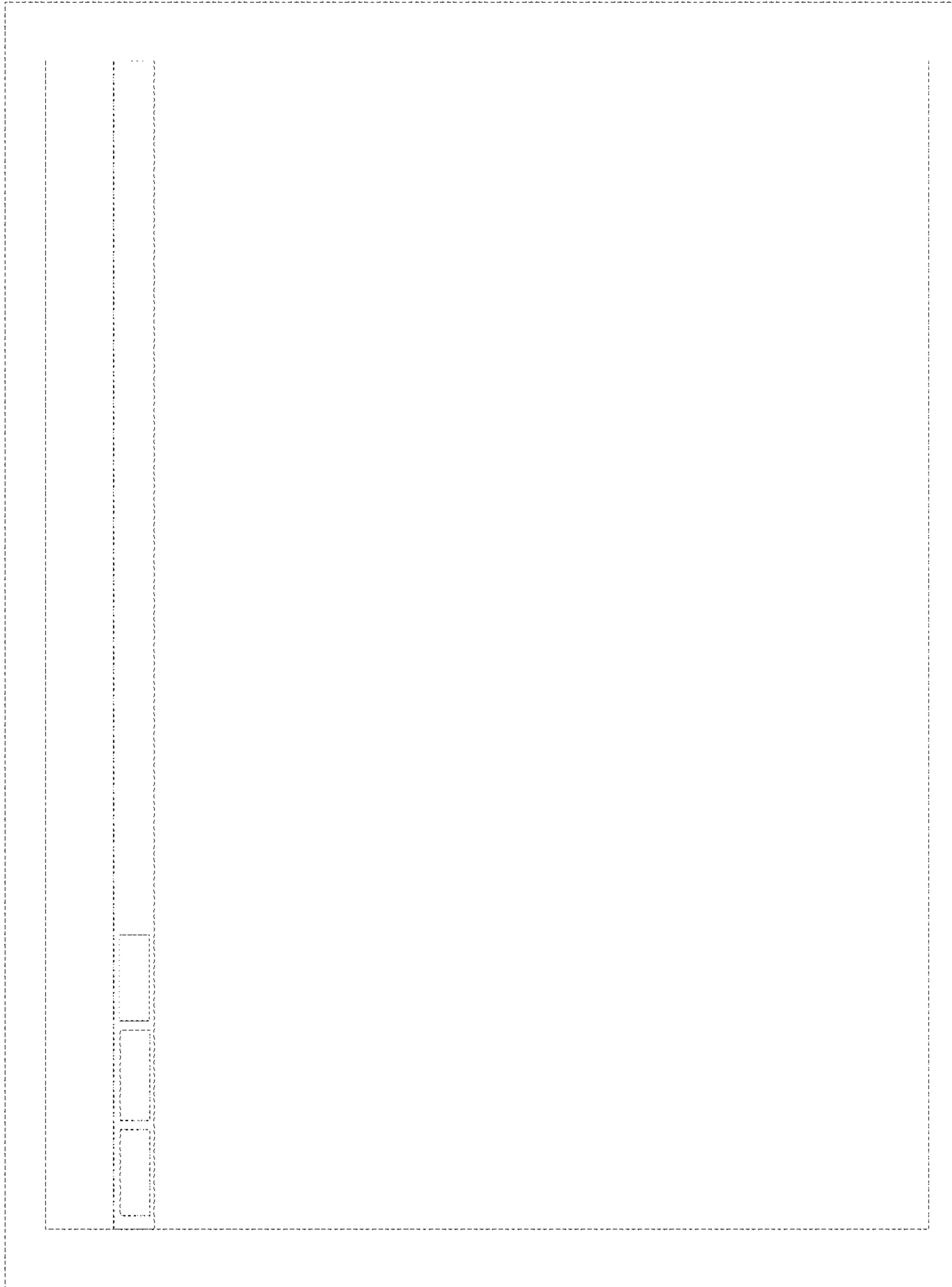

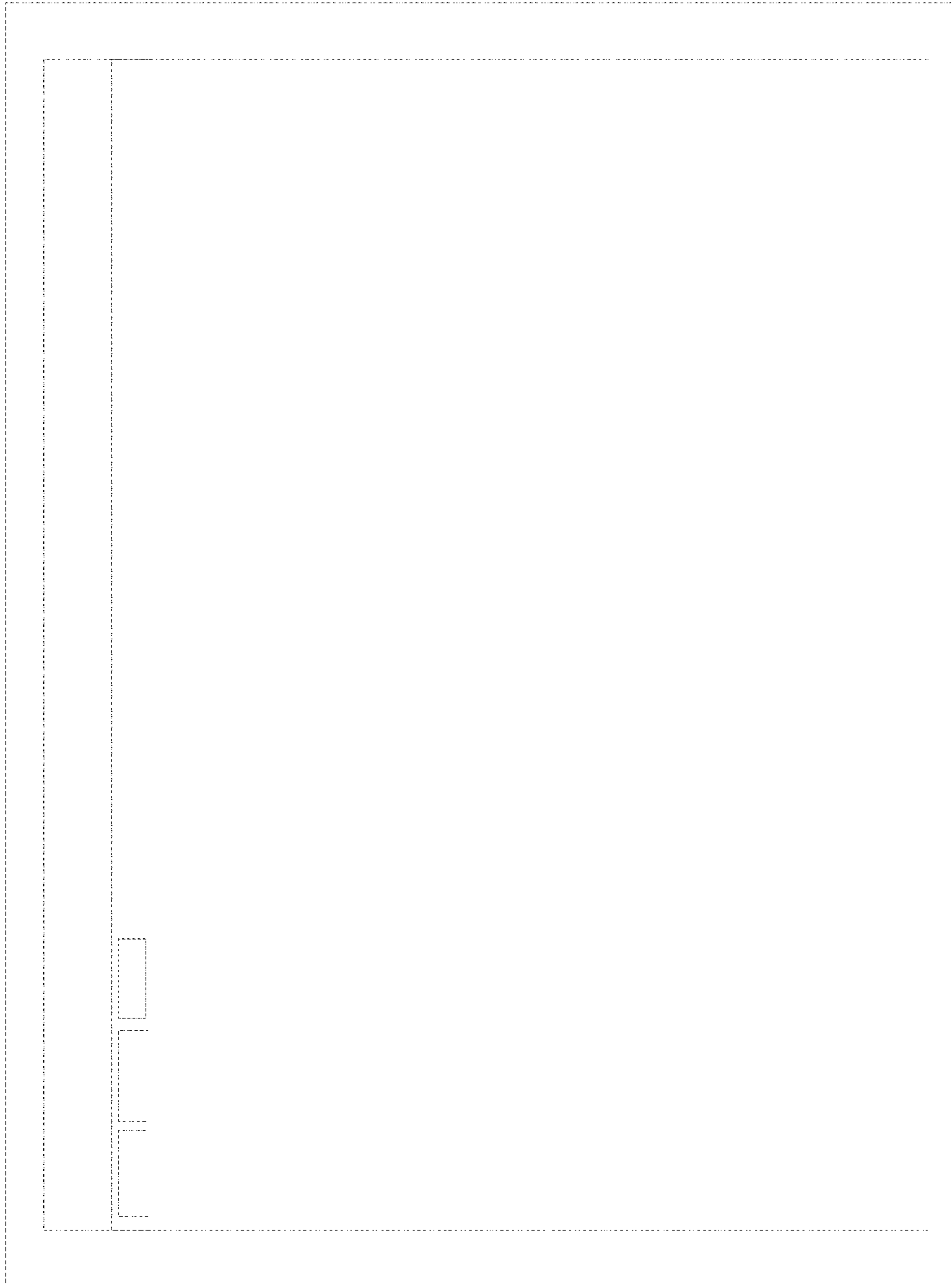

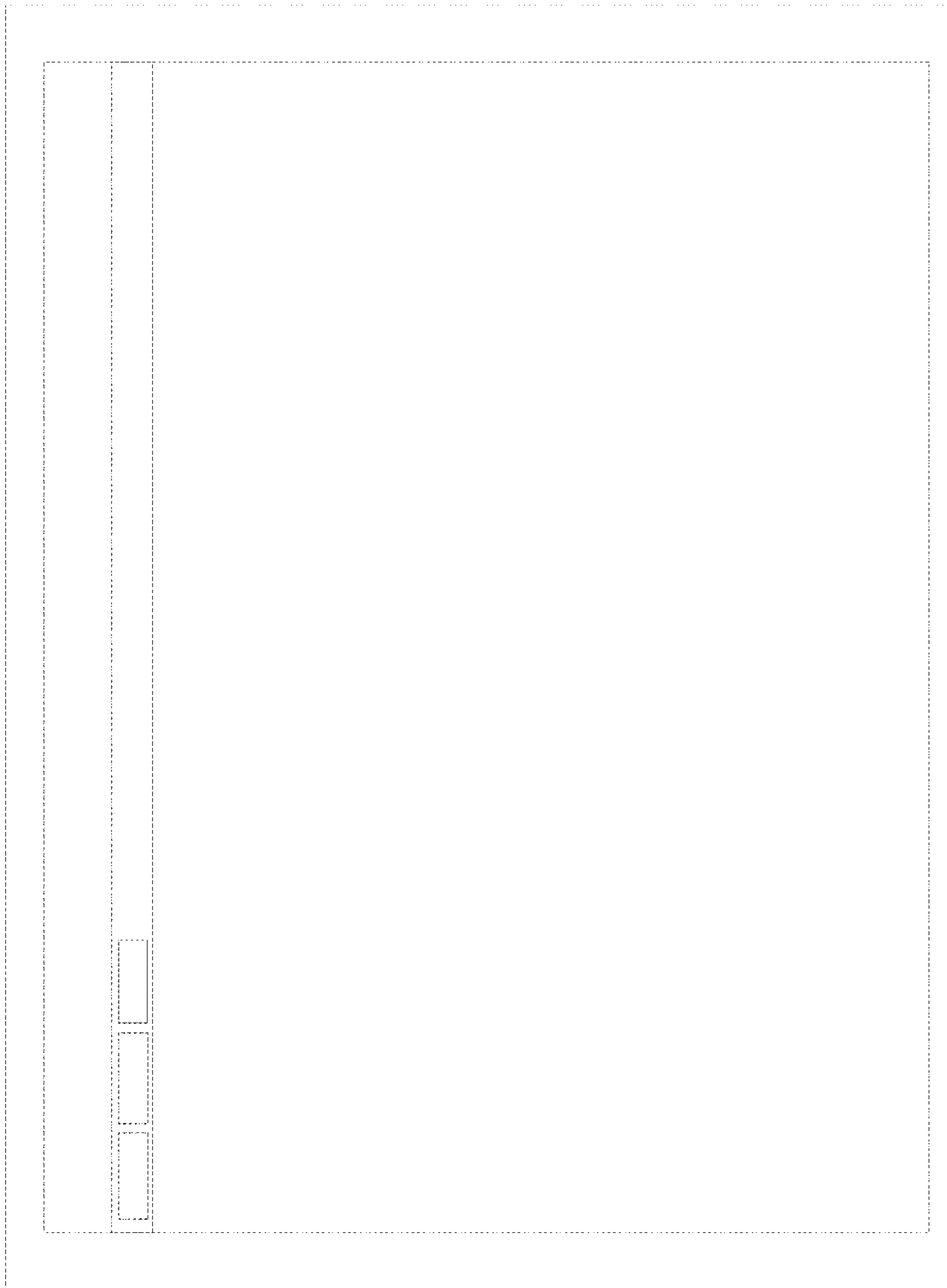

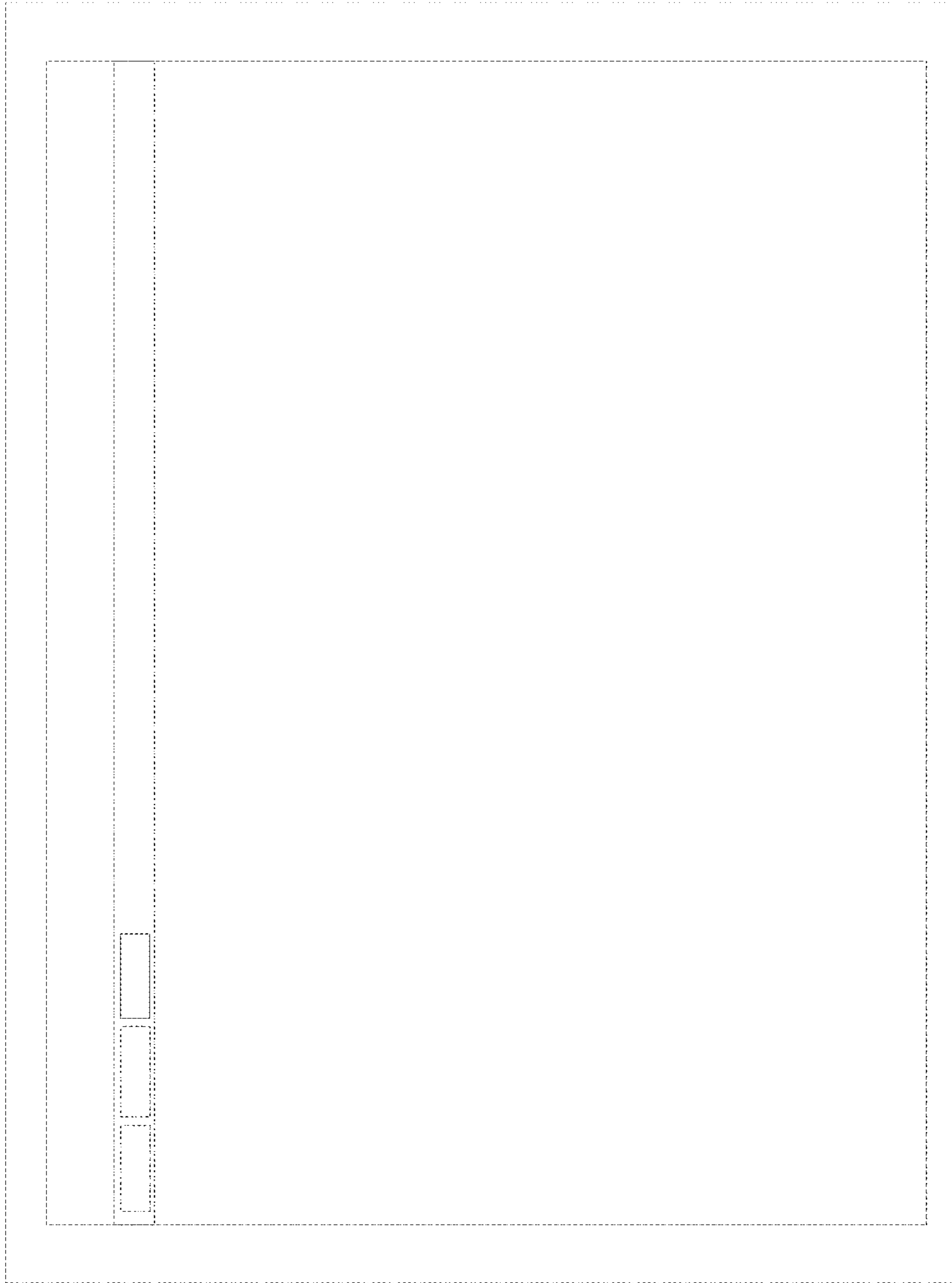
