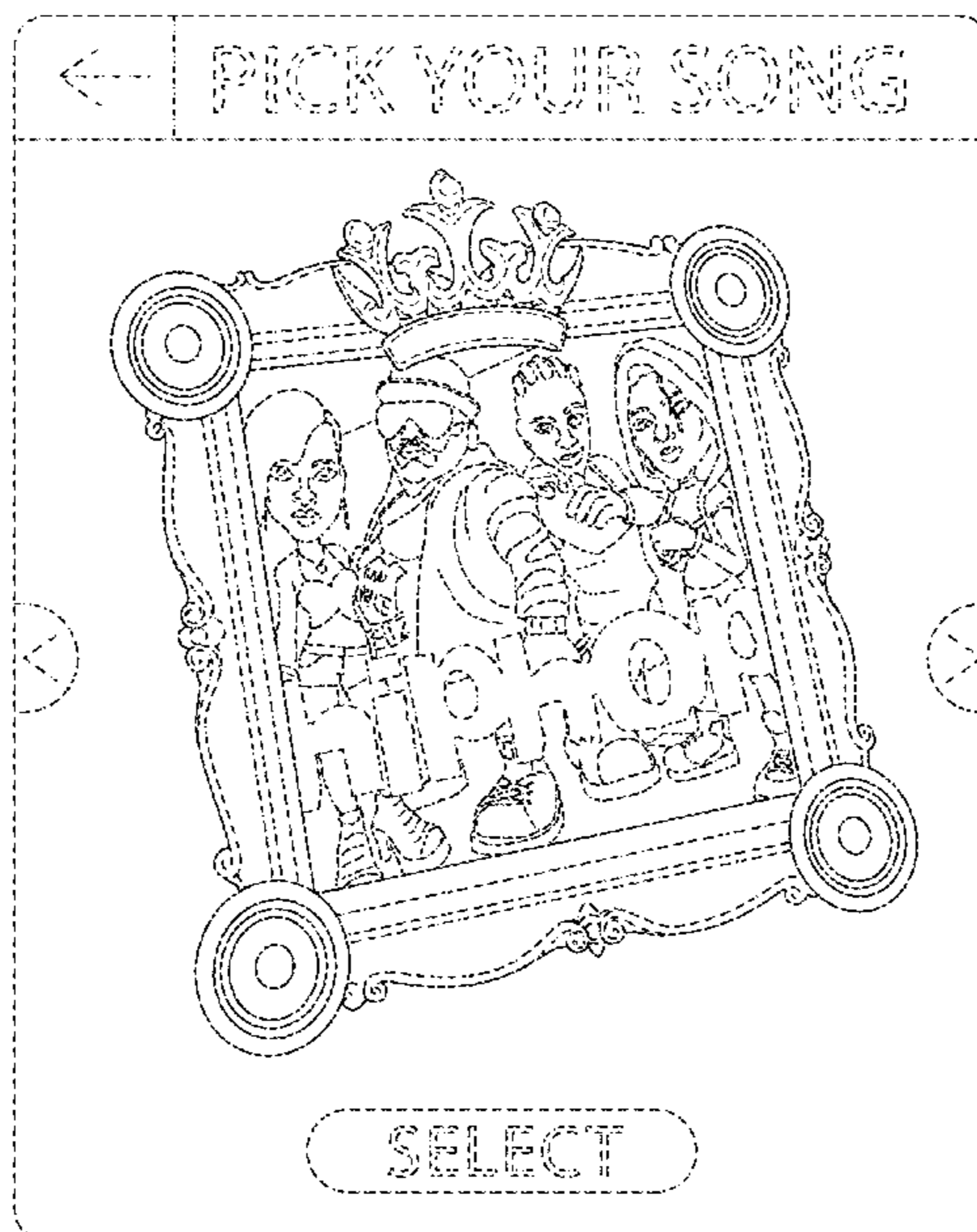
FIG. 1 is a front view of an embodiment of a display screen or portion thereof with icon showing our new design in a first environment.

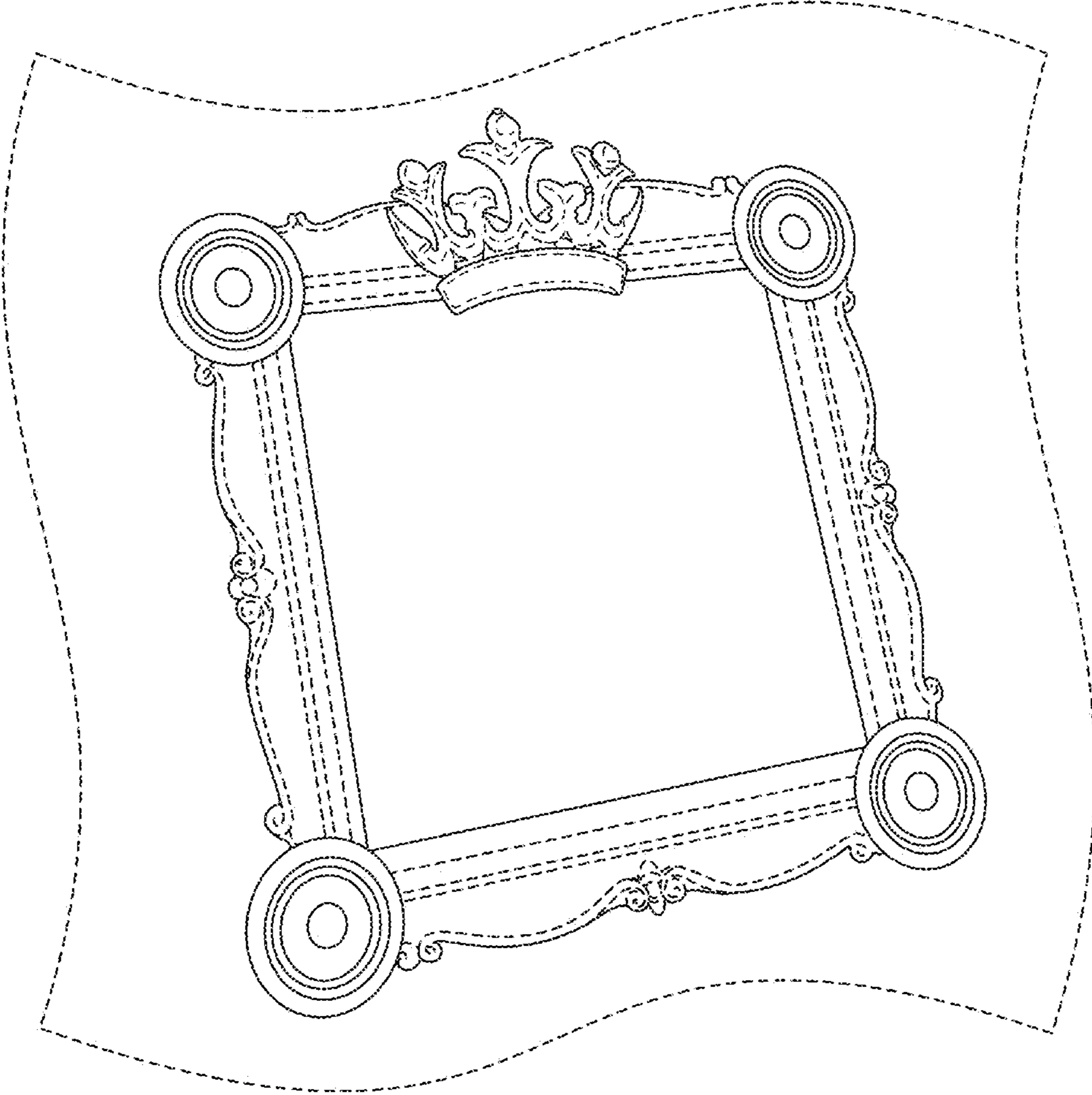

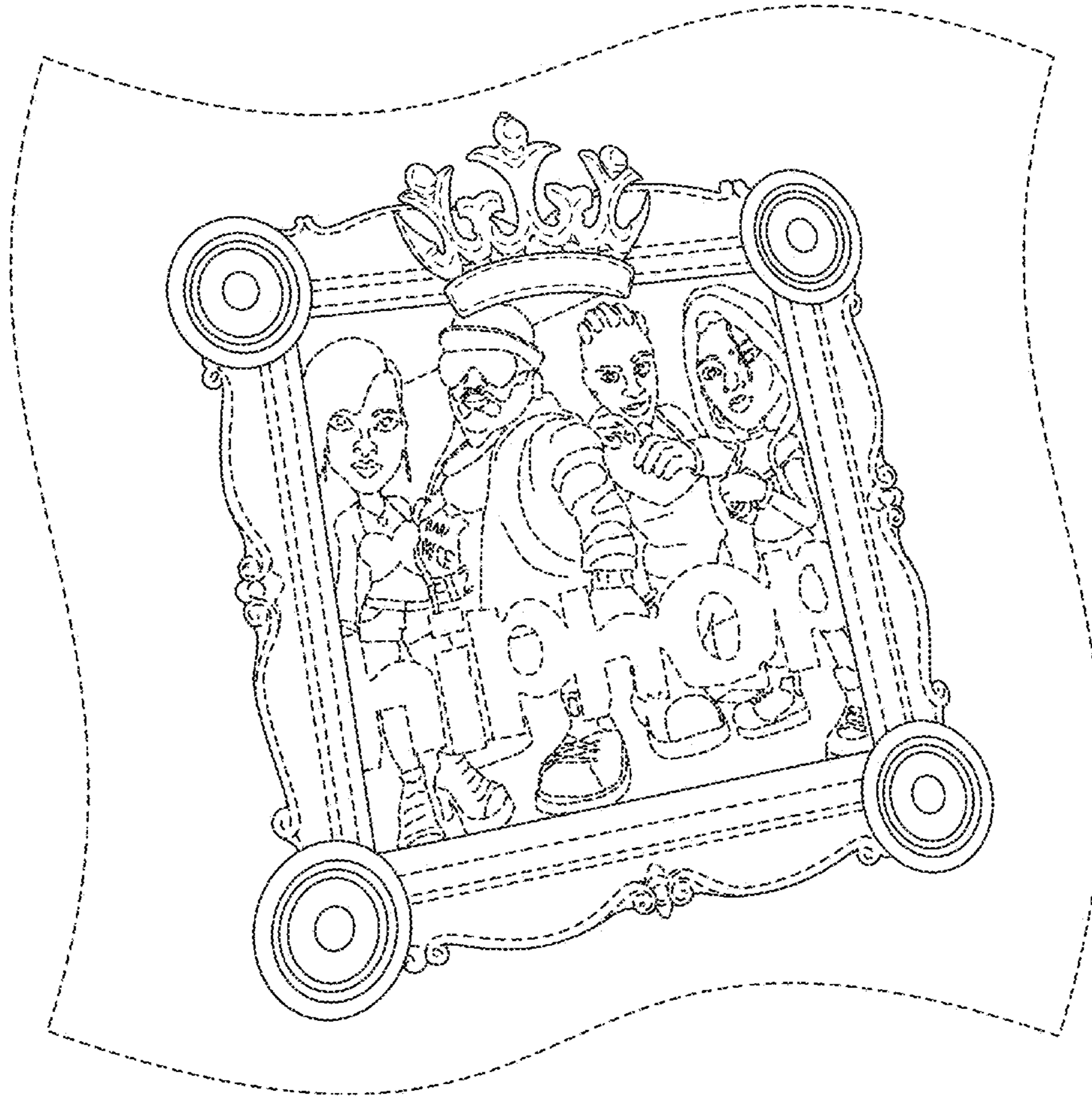

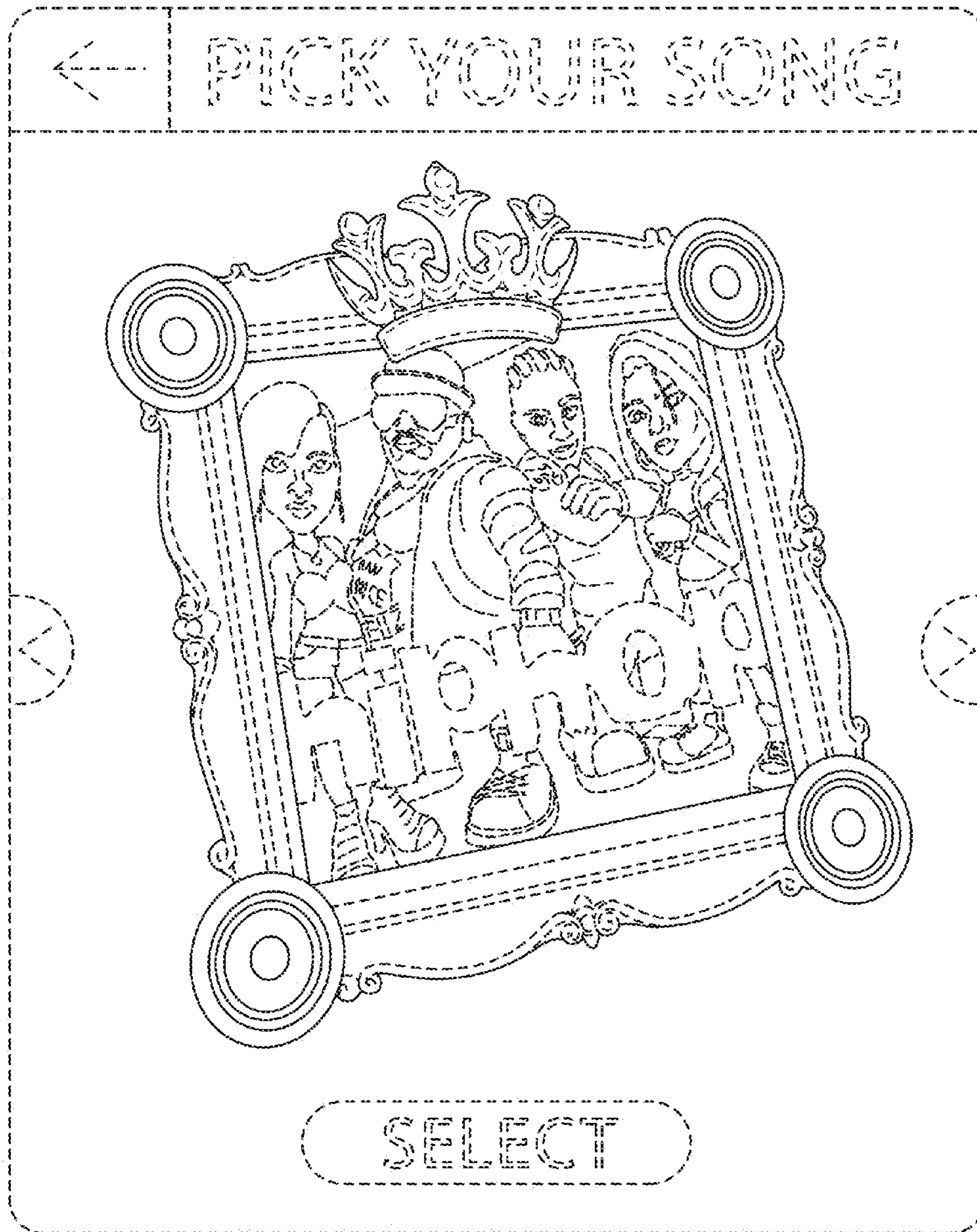
