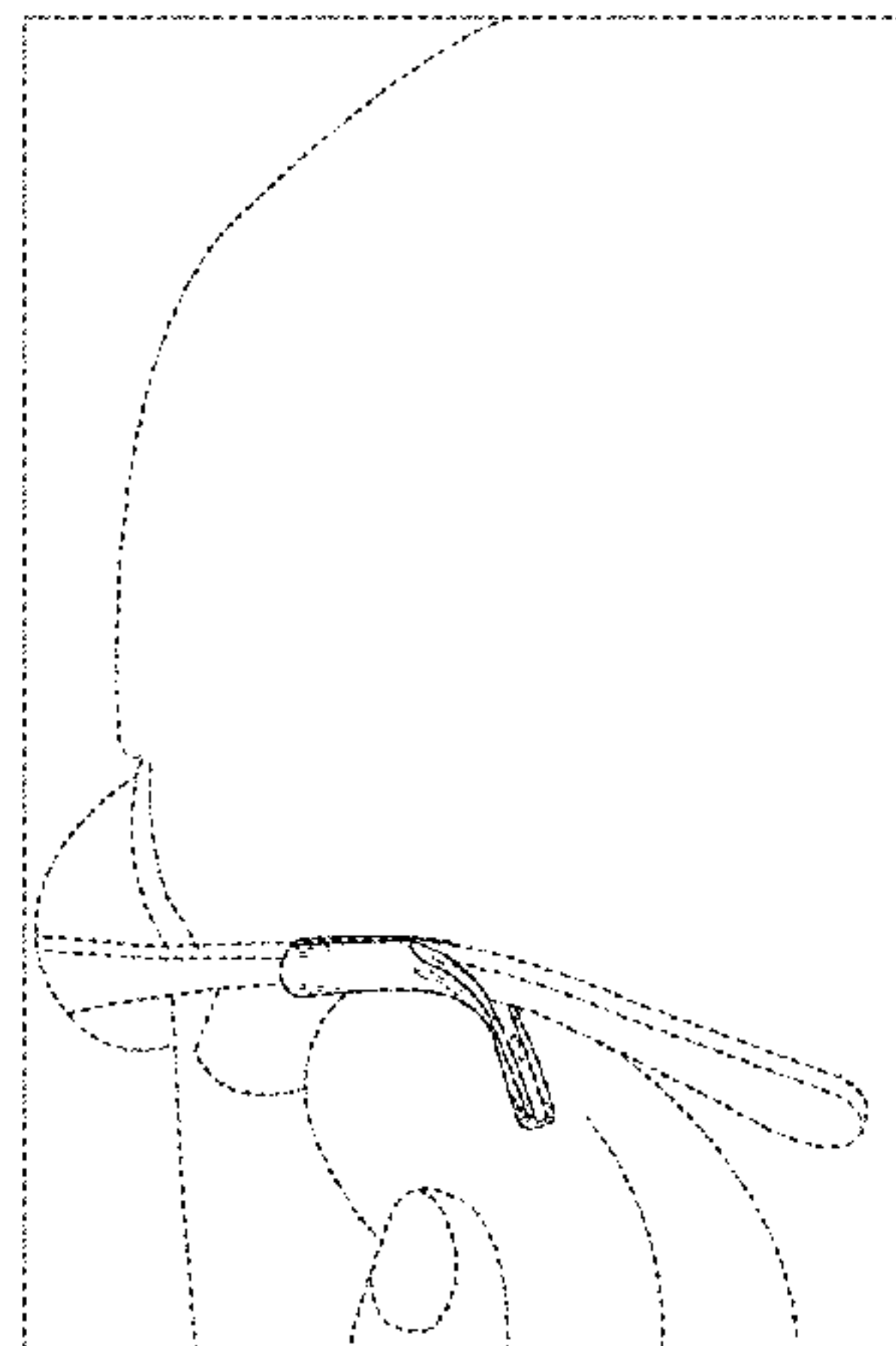
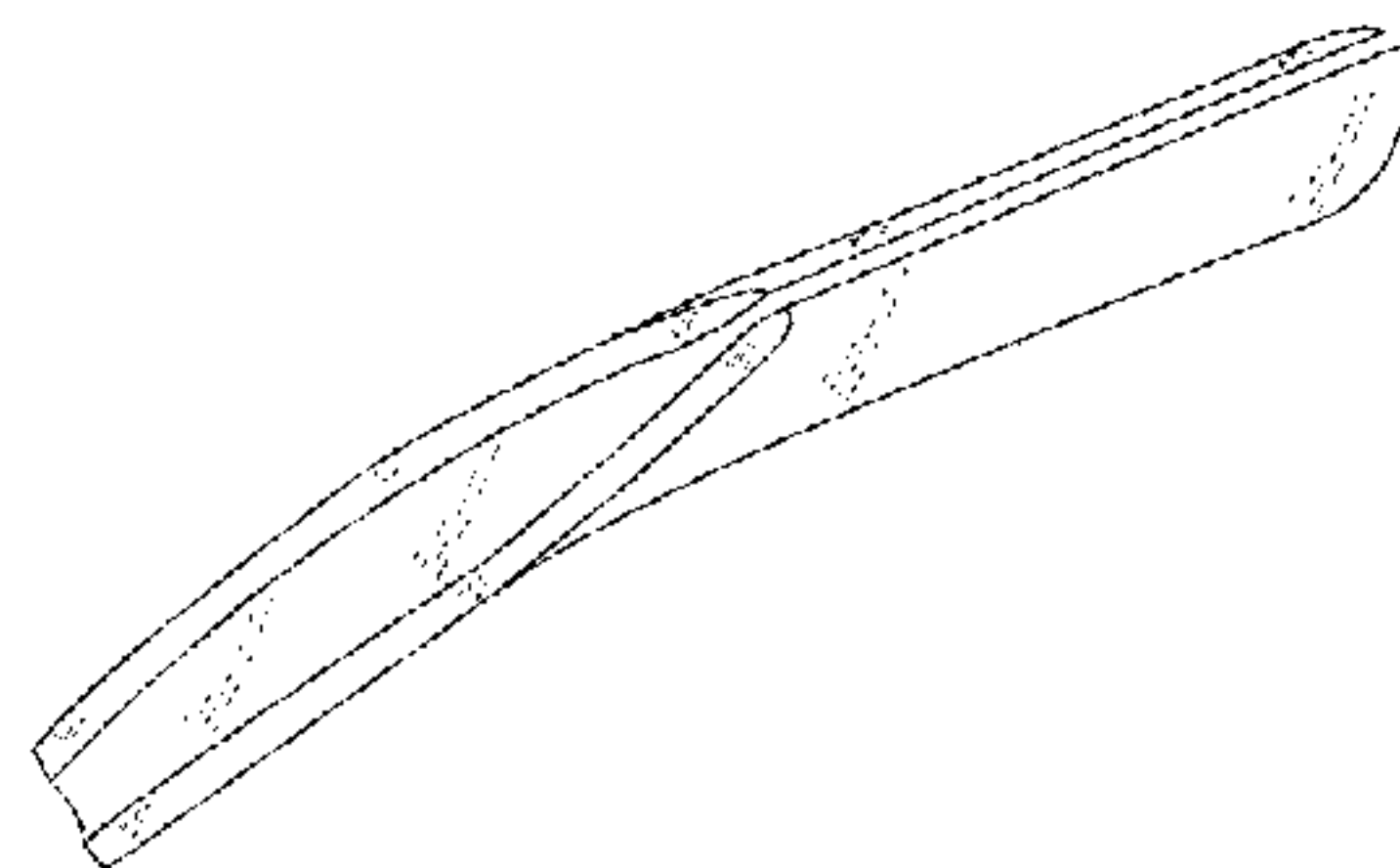
(57) **CLAIM**

The ornamental design for an eyeglasses holder, substantially as shown and described.

DESCRIPTION

FIG. 1 is a side perspective view of an eyeglasses holder in accordance with an embodiment of the present design;
 FIG. 2 is a side perspective view of two eyeglasses holders as shown in FIG. 1 attached to a pair of eyeglasses;
 FIG. 3 is a side perspective view of the eyeglasses holder shown in FIG. 1 attached to a pair of eyeglasses and mounted on a user's head;
 FIG. 4 is a front elevation view of the eyeglasses holder shown in FIG. 1;
 FIG. 5 is a rear elevation view of the eyeglasses holder shown in FIG. 1;
 FIG. 6 is a right side elevation view of the eyeglasses holder shown in FIG. 1;
 FIG. 7 is a top plan view of the eyeglasses holder shown in FIG. 1; and,
 FIG. 8 is a bottom plan view of the eyeglasses holder shown in FIG. 1.
 In a preferred embodiment, the nature of this product is as a eyeglasses holder, which is primarily useful for securing eyeglasses to the head of a user.
 The left side elevation view is not shown because it is a mirror view of the right side elevation view.
 Any broken line showing throughout the drawings forms no part of the claim.

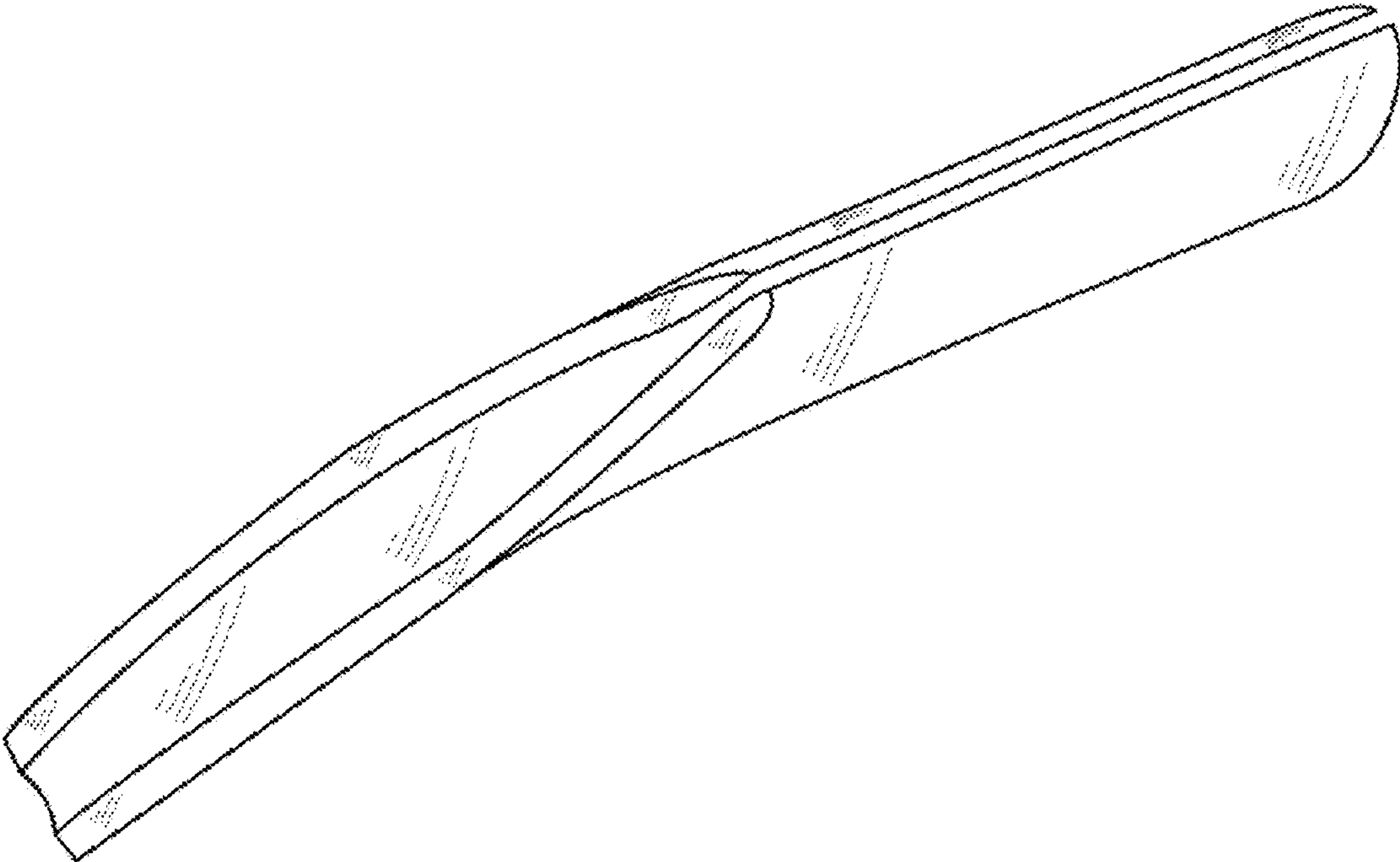

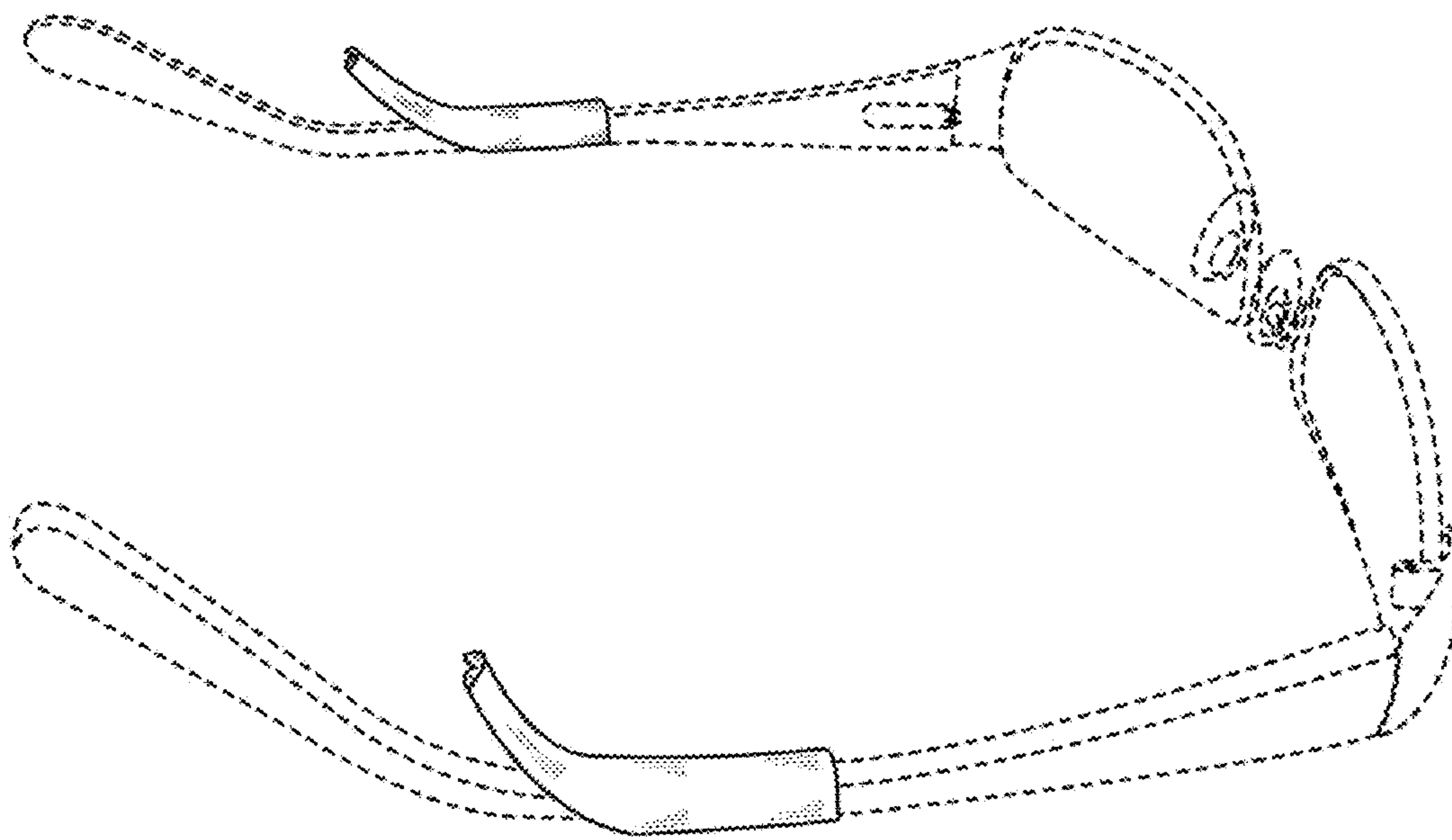

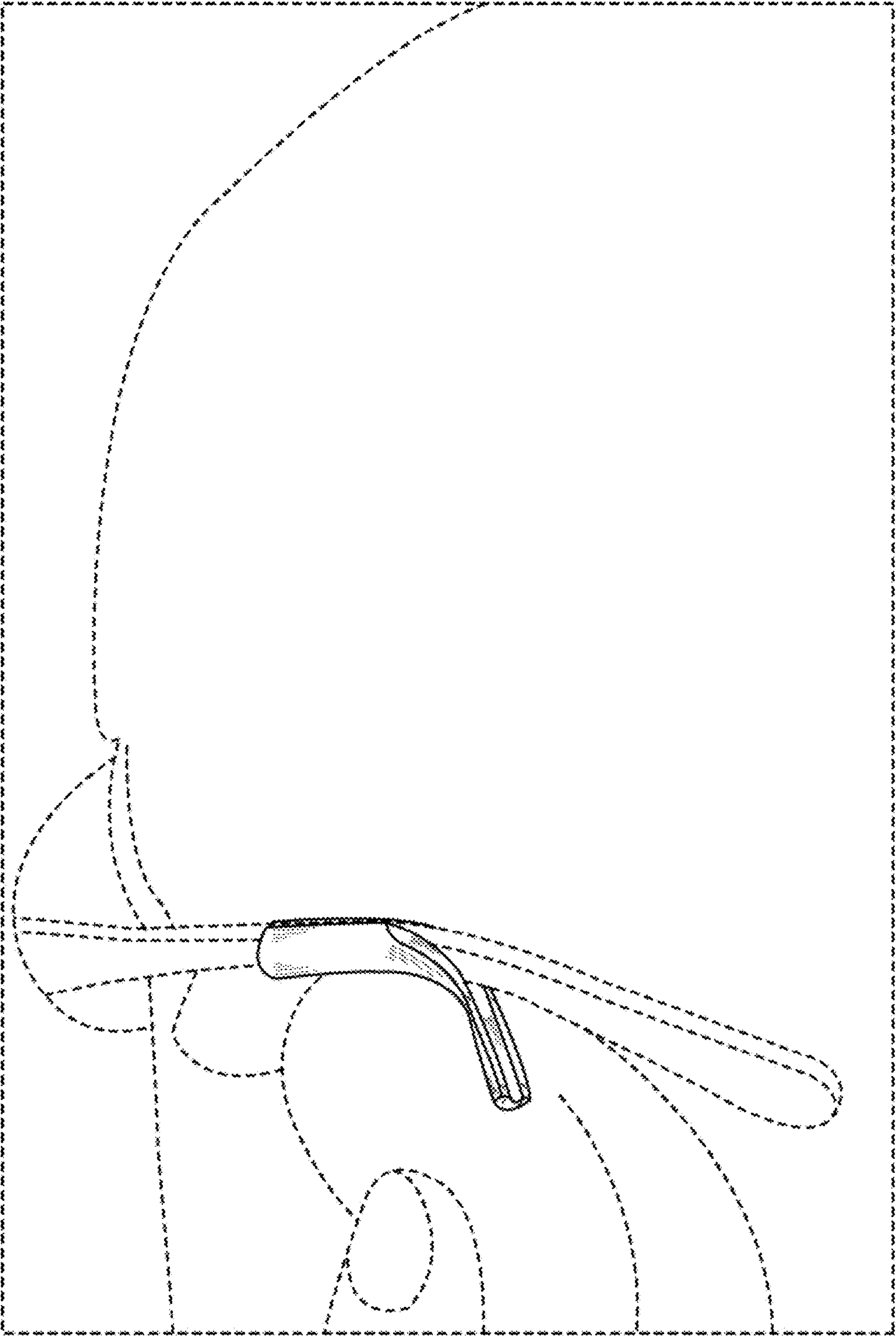

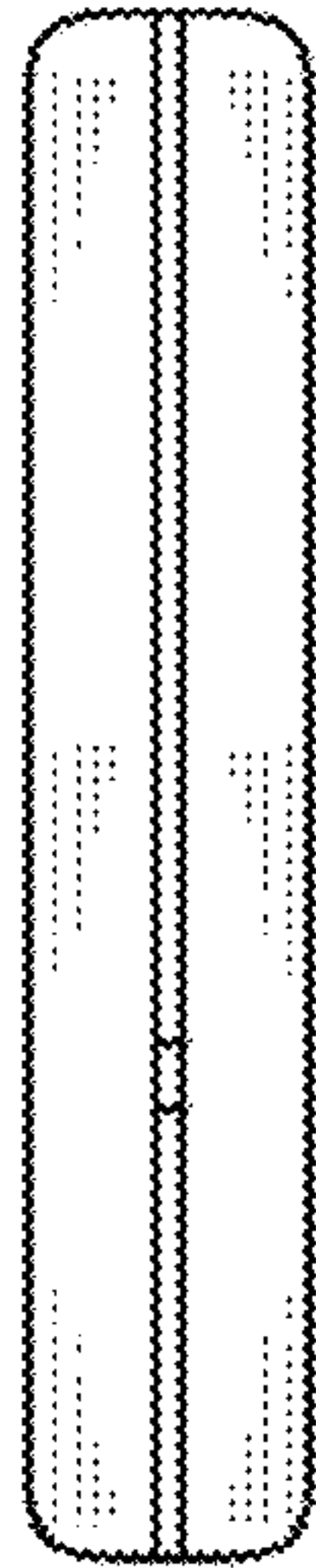

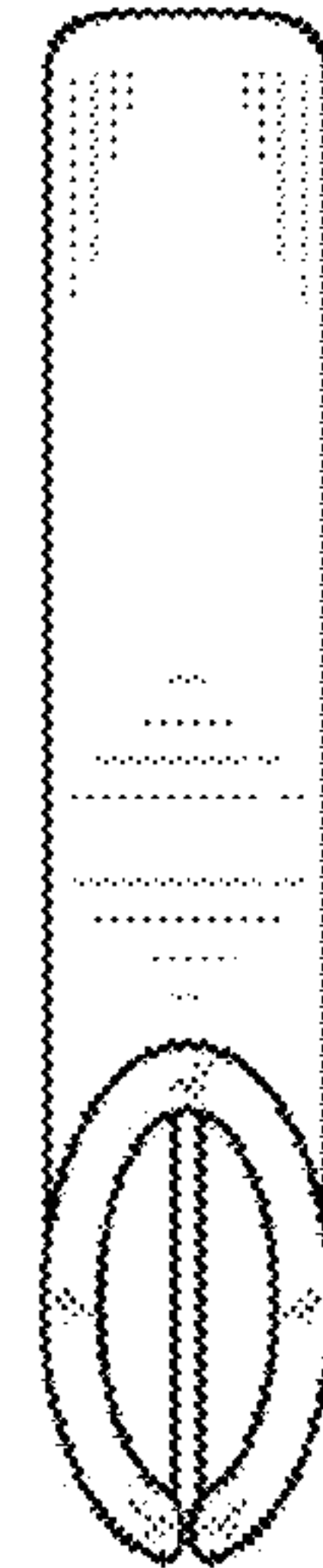

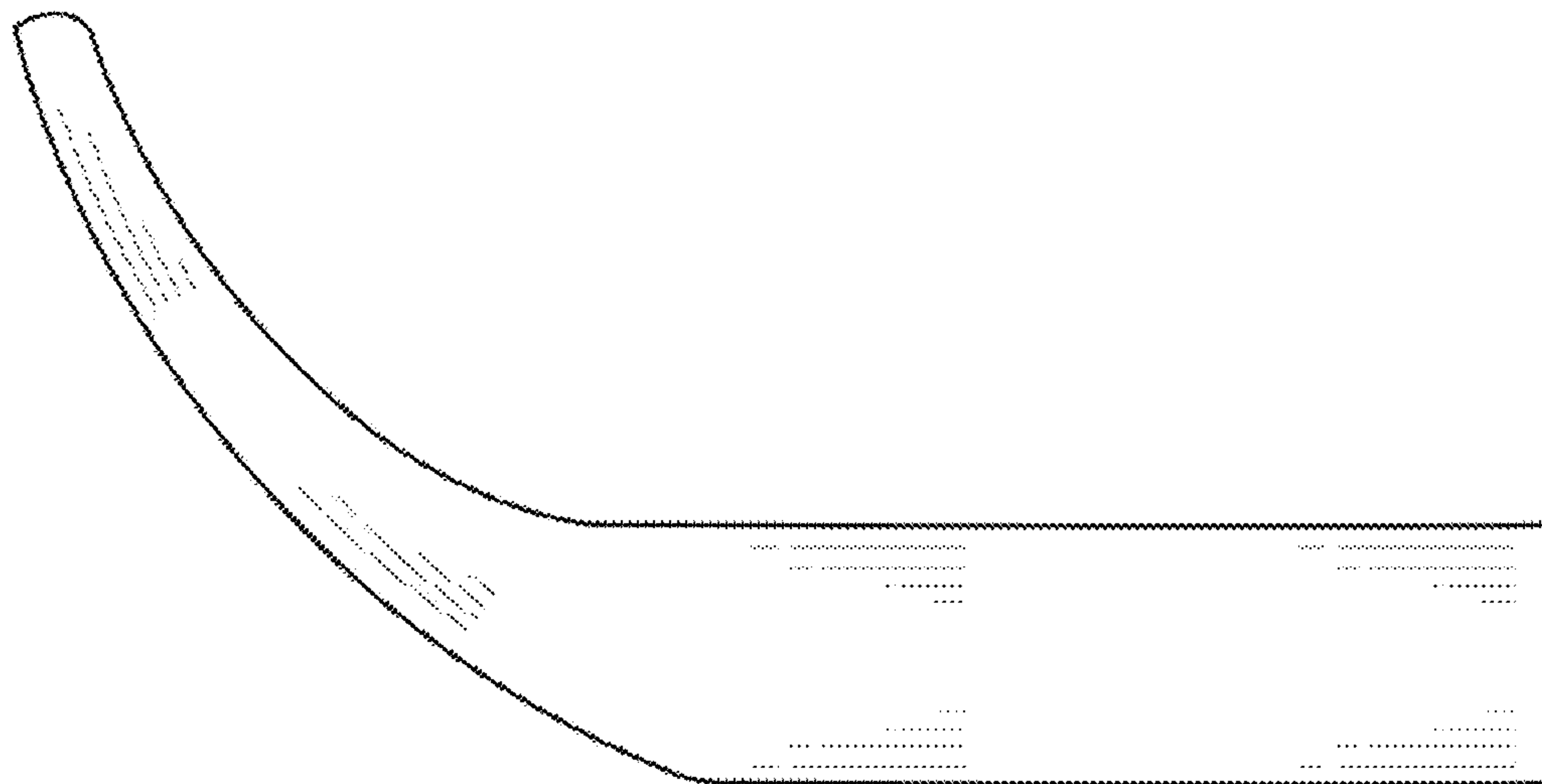

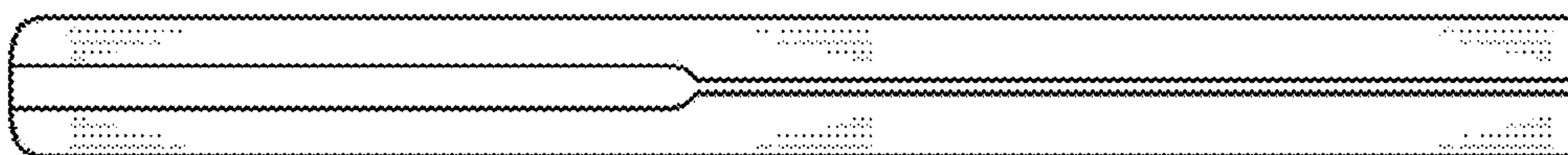
