FIG. 6 is top plan view thereof; and,

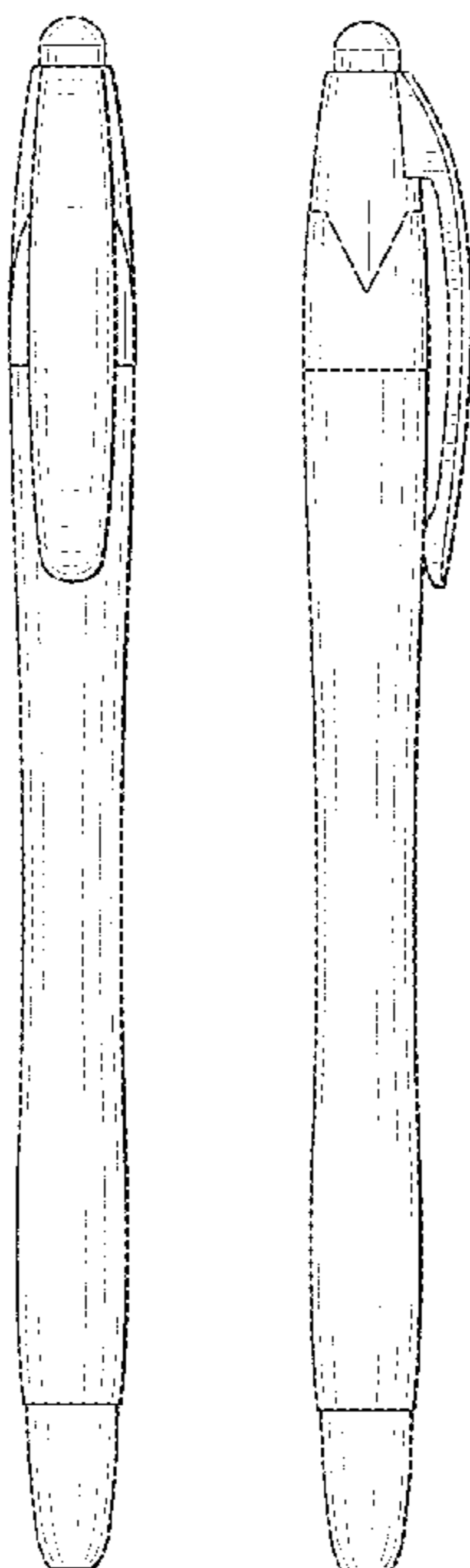
FIG. 7 is bottom plan view thereof.

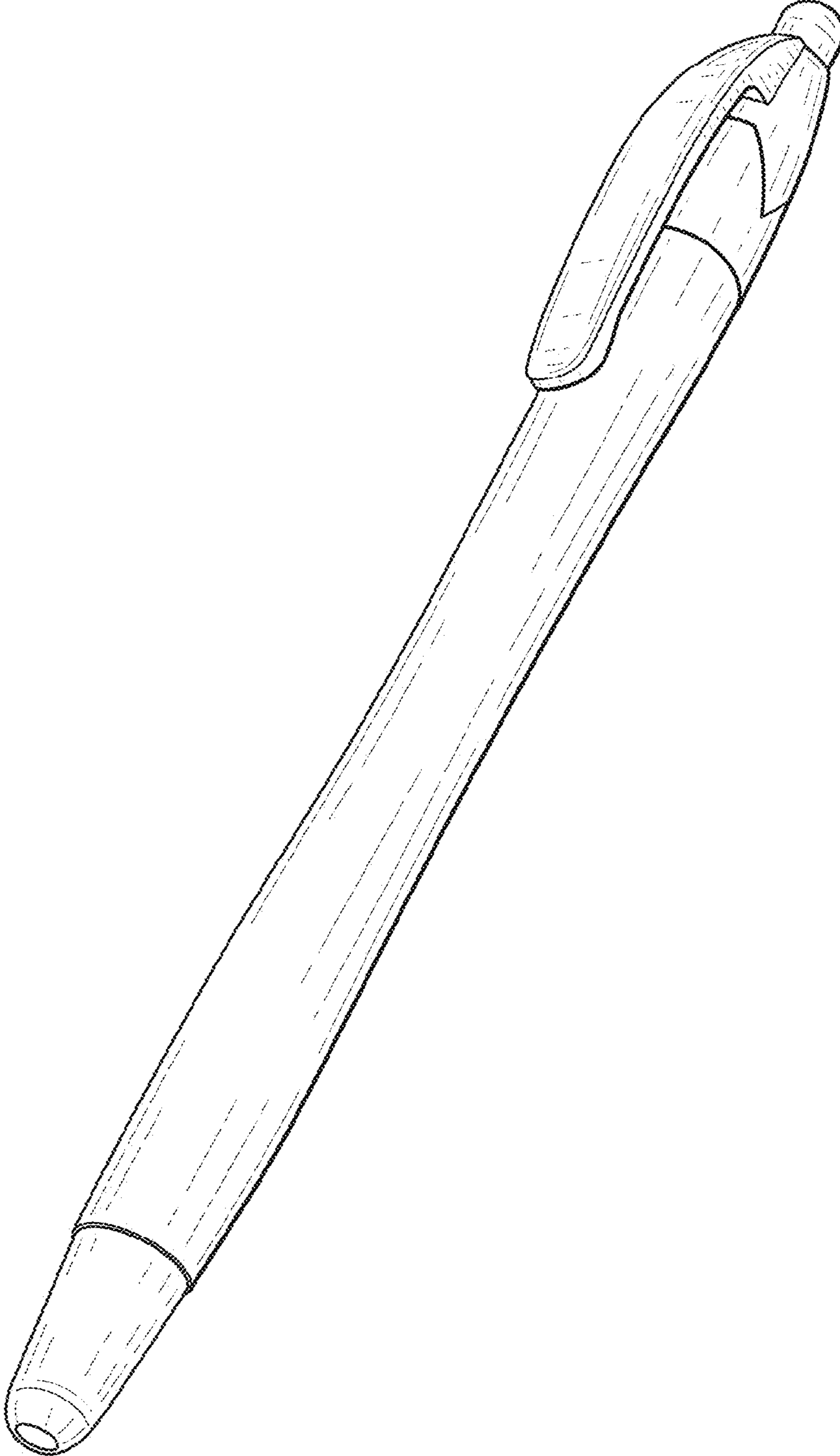

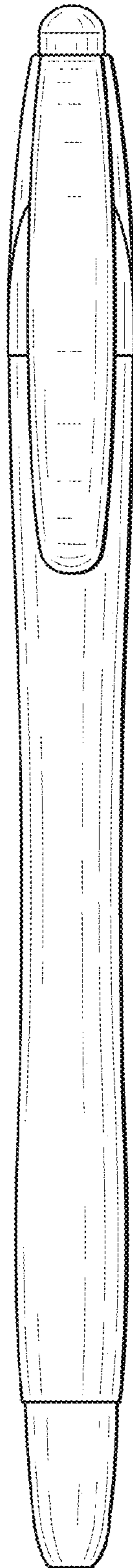

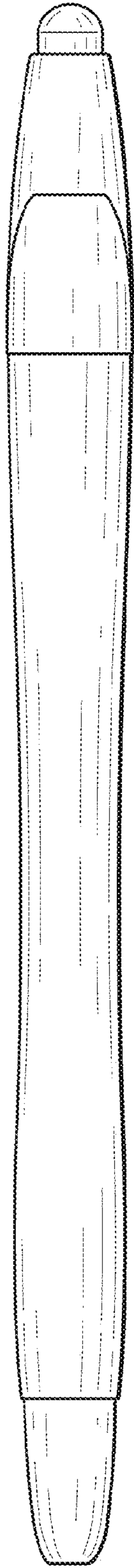

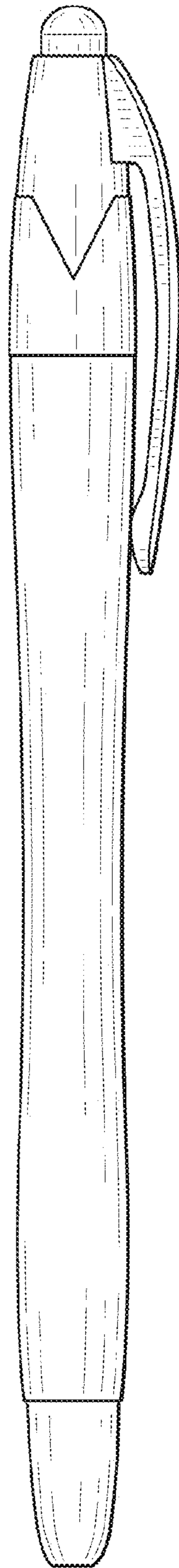

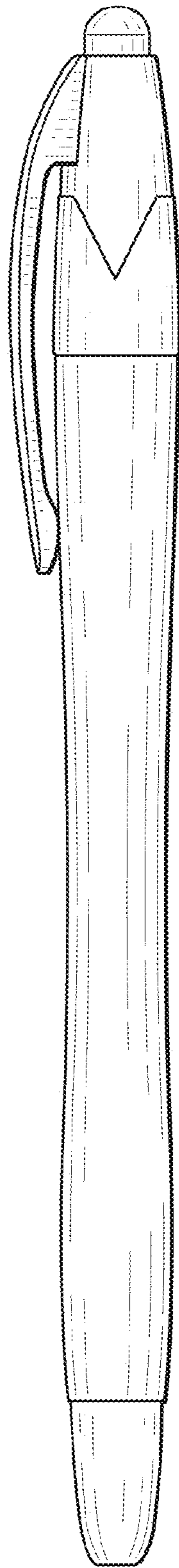

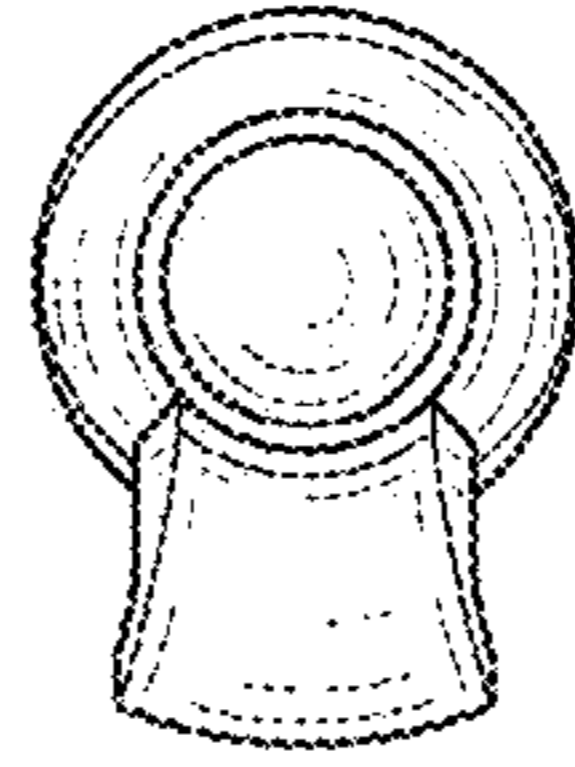

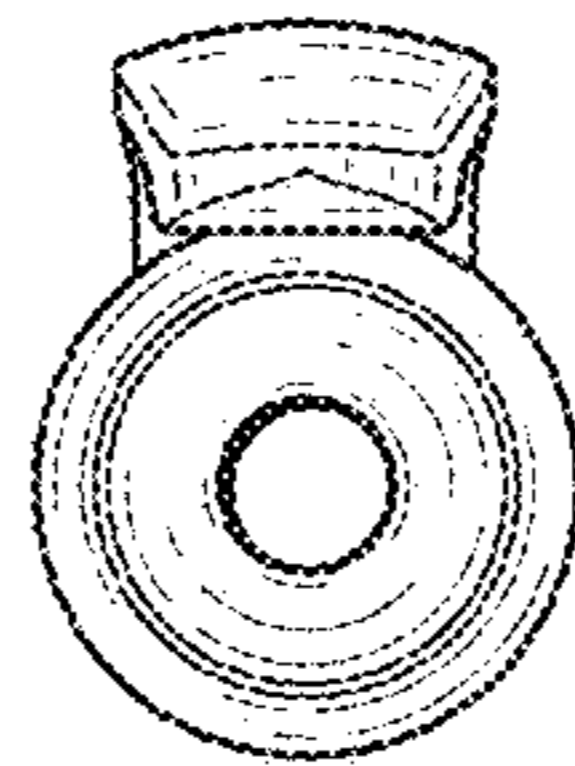
