(57) **CLAIM**

The ornamental design for a water filter mount assembly, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the first embodiment thereof, with dotted lines indicating a filter element of indefinite length;

FIG. 2 is a side view thereof (the view is the same from all sides thereof with the dotted lines indicating a filter element of indefinite length);

FIG. 3 is a top view thereof;

FIG. 4 is a bottom view thereof;

FIG. 5 is an exploded perspective view thereof, with the dotted lines indicating a filter element of indefinite length;

FIG. 6 is a perspective view of a second embodiment thereof, with dotted lines indicating a filter element of indefinite length;

FIG. 7 is a front view thereof (the rear view is a mirror-image thereof with the dotted lines indicating a filter element of indefinite length);

FIG. 8 is a top view thereof;

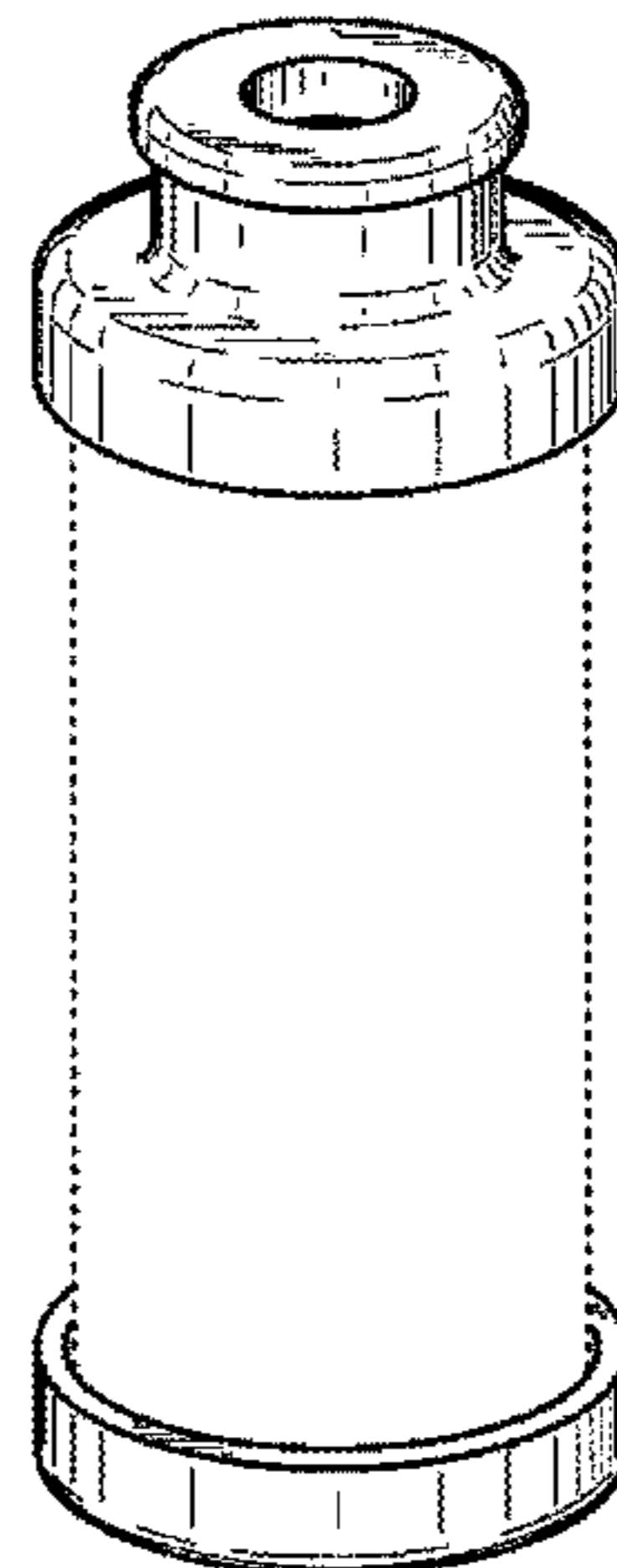
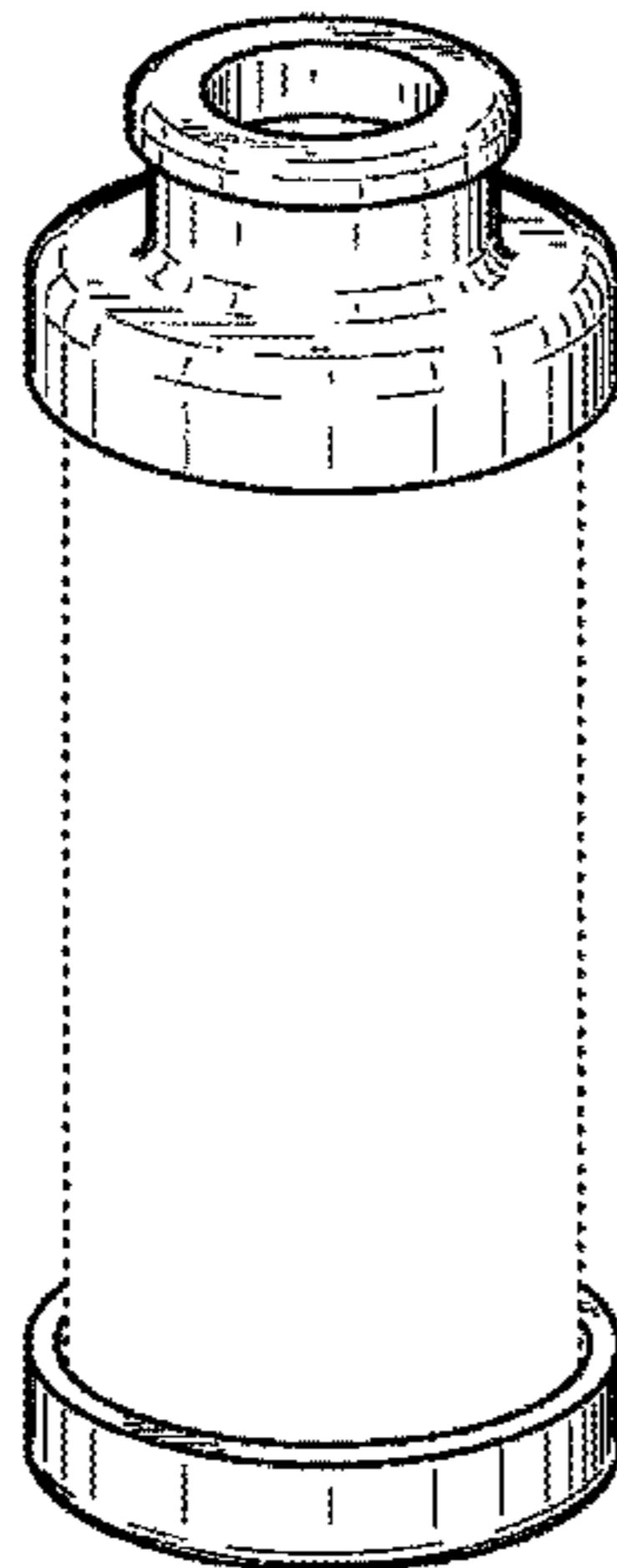
FIG. 9 is a bottom view thereof; and,

FIG. 10 is an exploded perspective view thereof, with the dotted lines indicating a filter element of indefinite length.

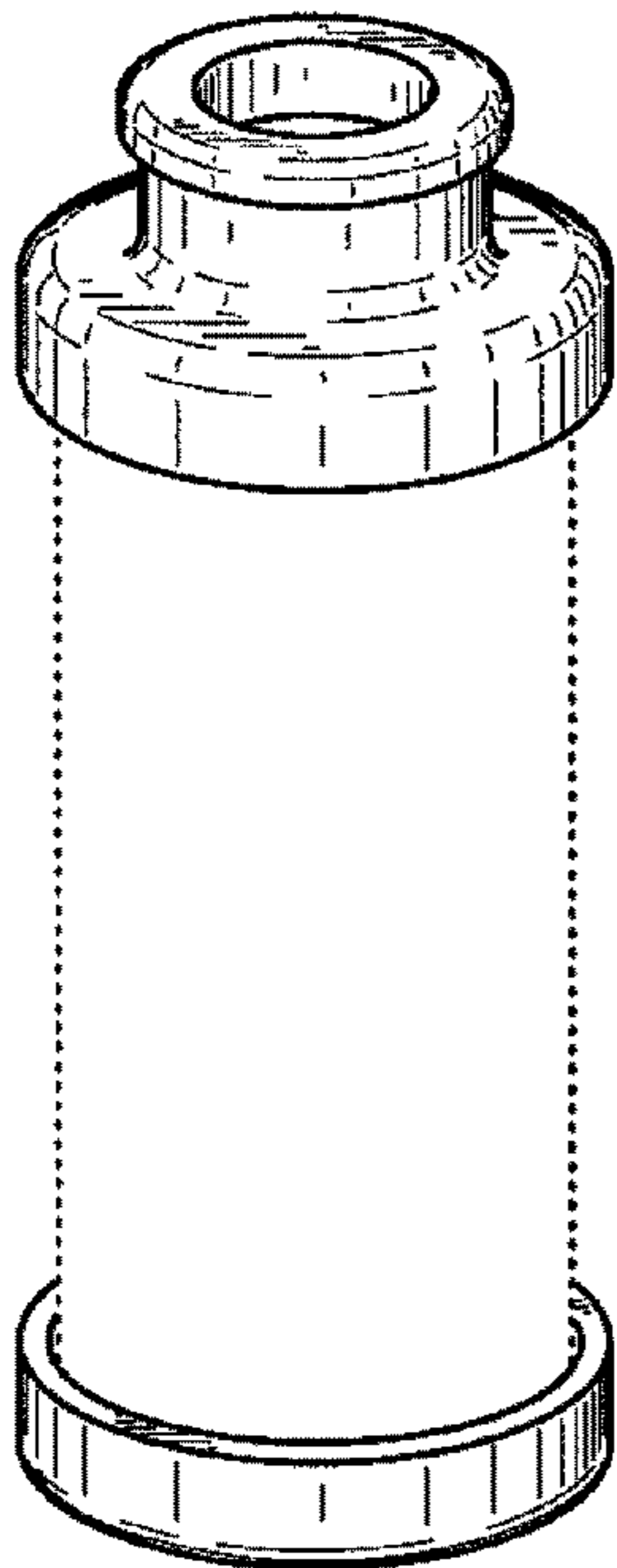

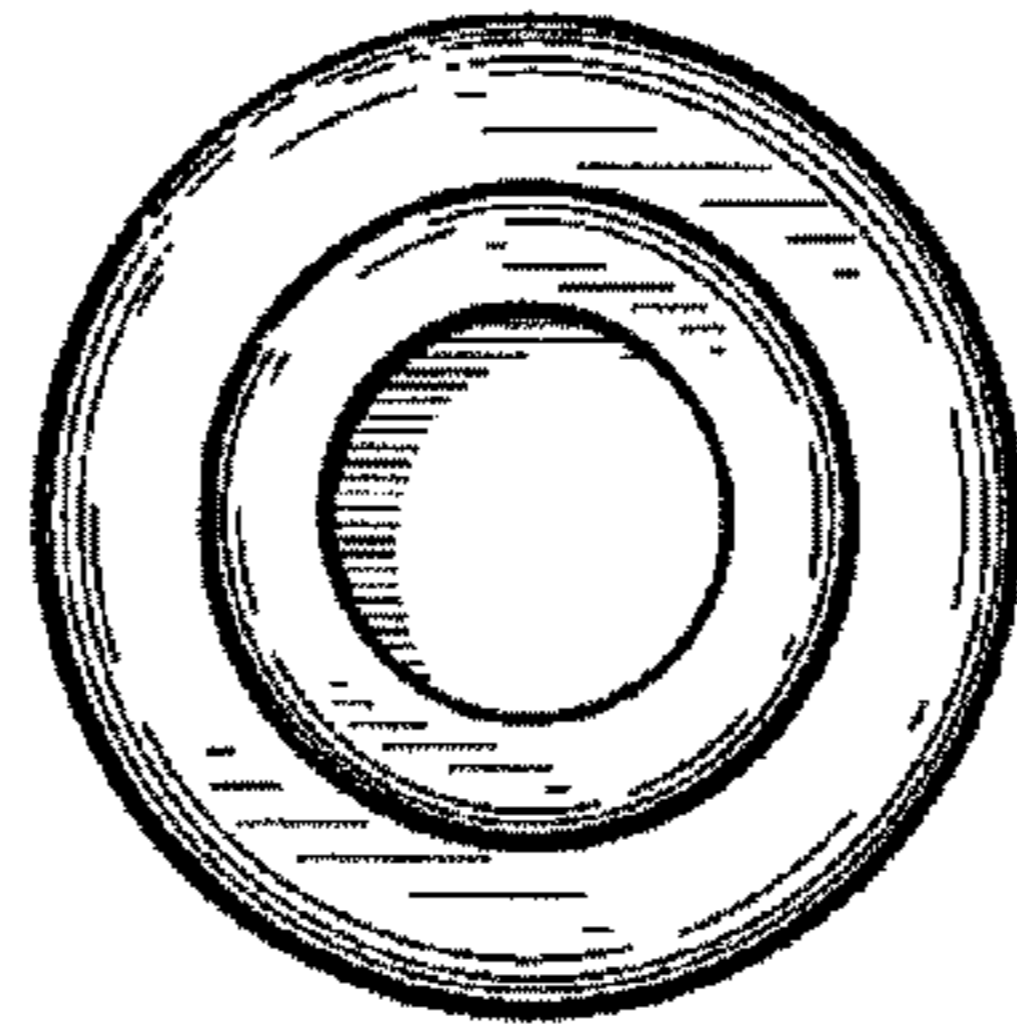

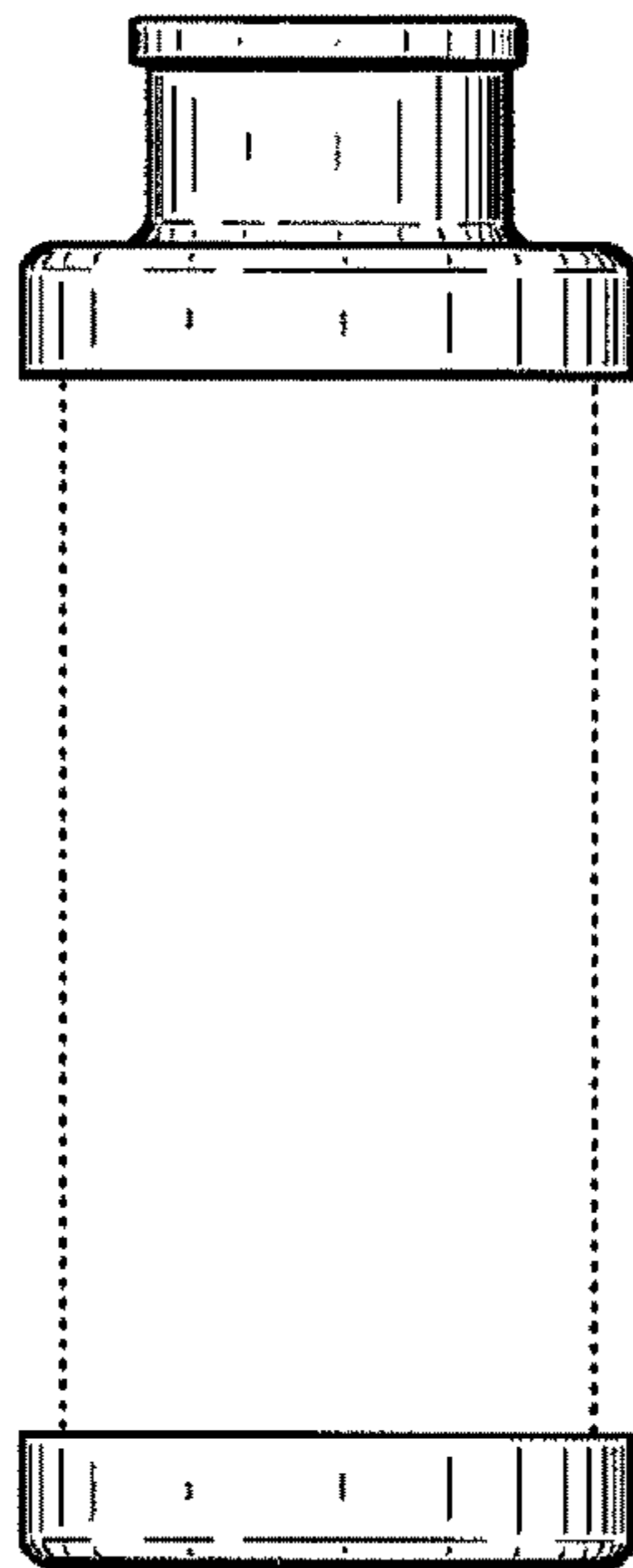

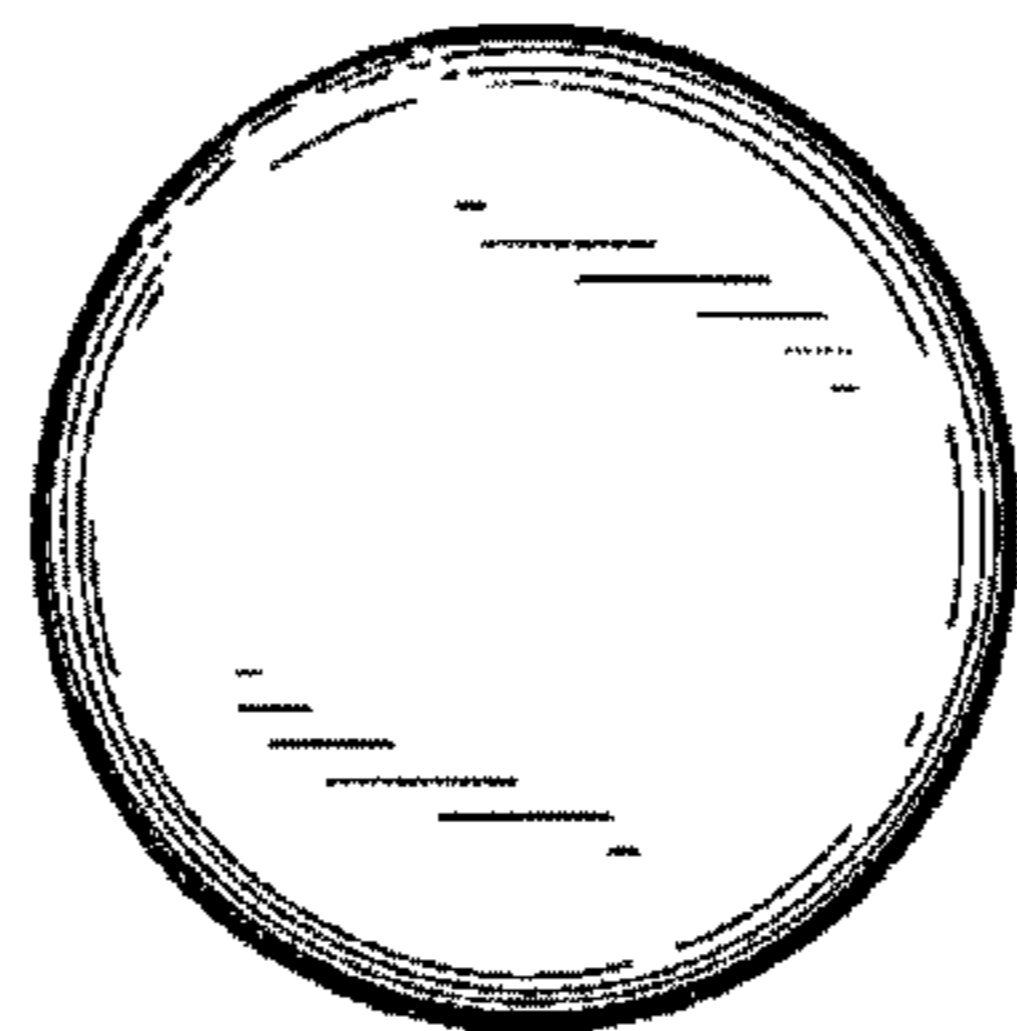

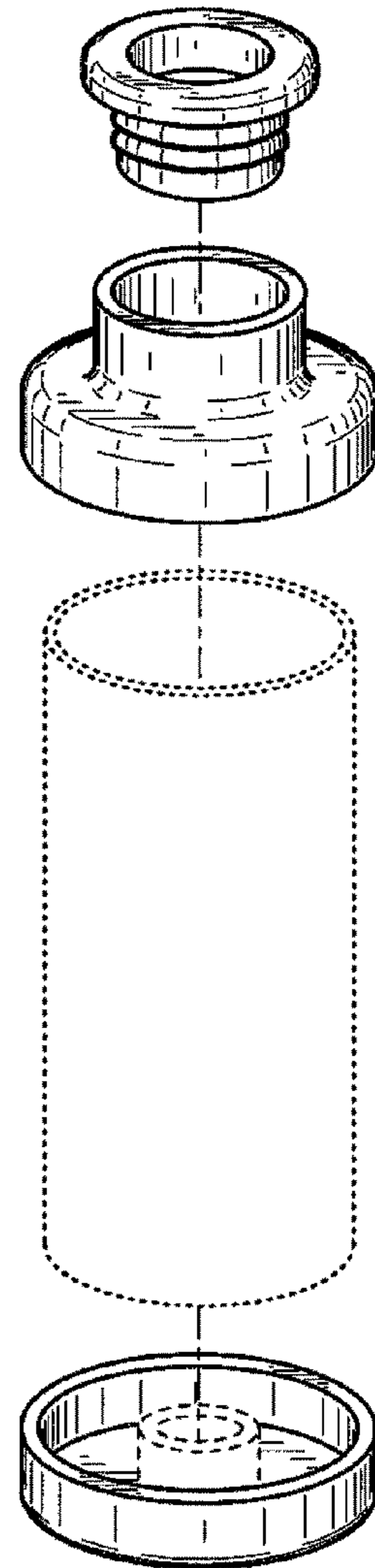

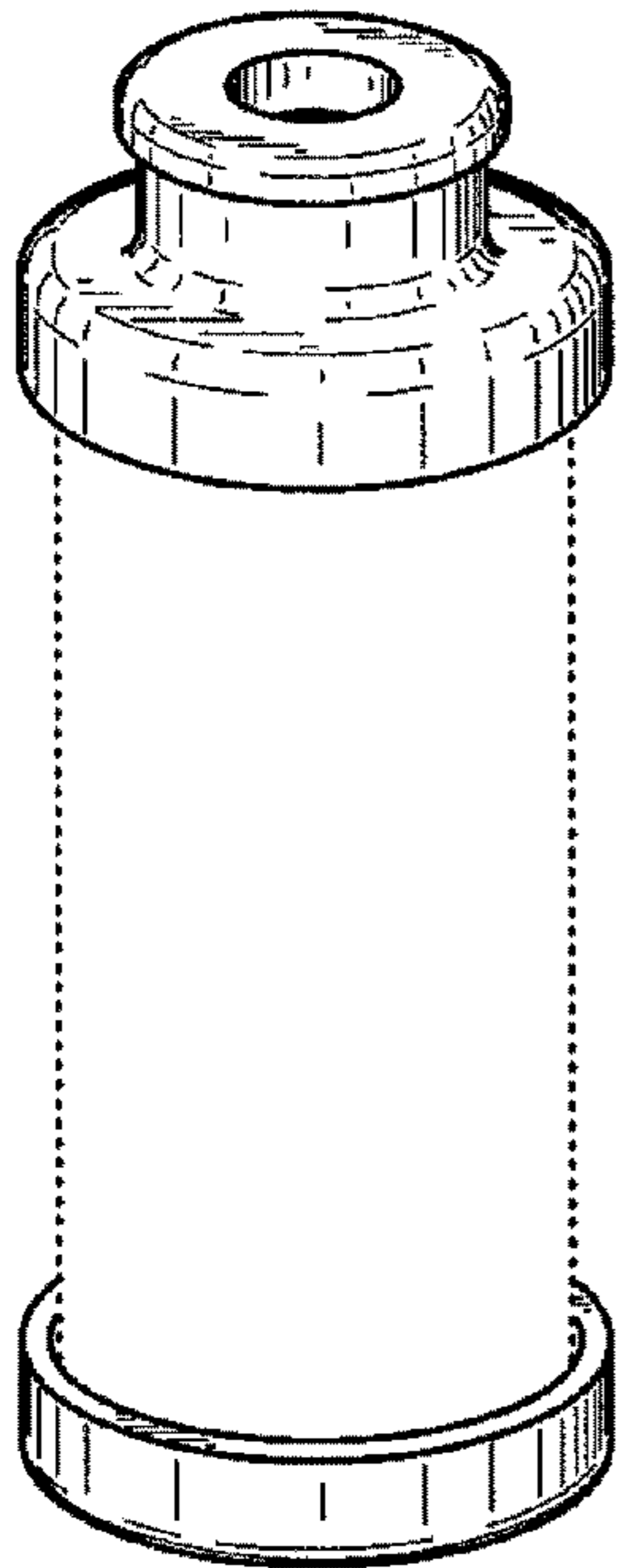

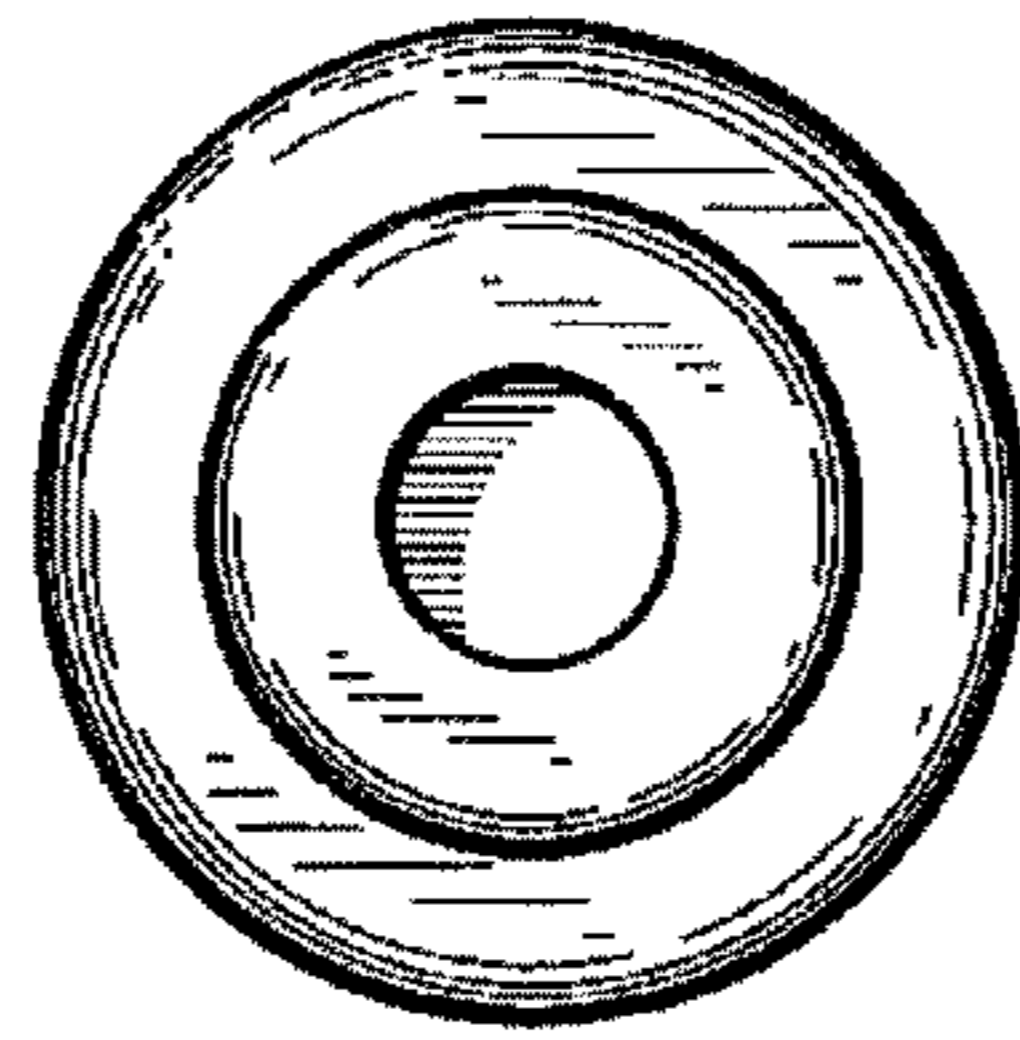

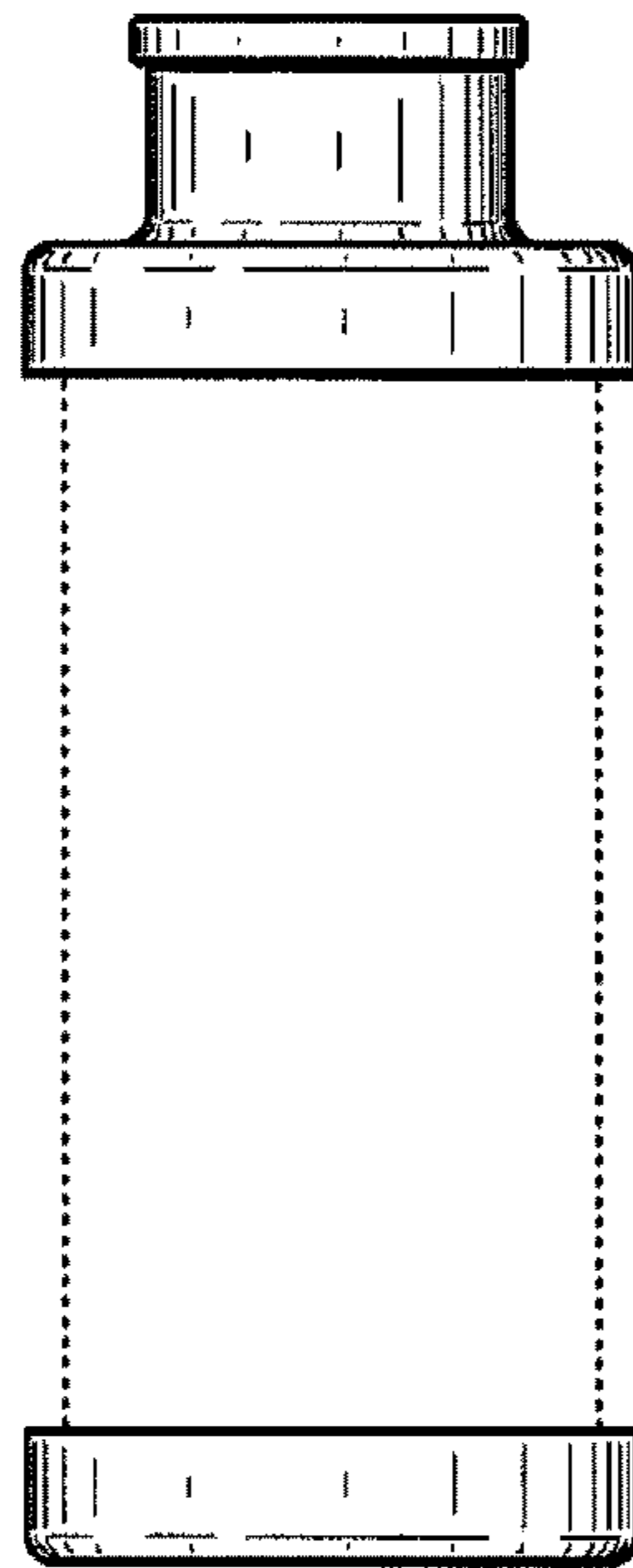

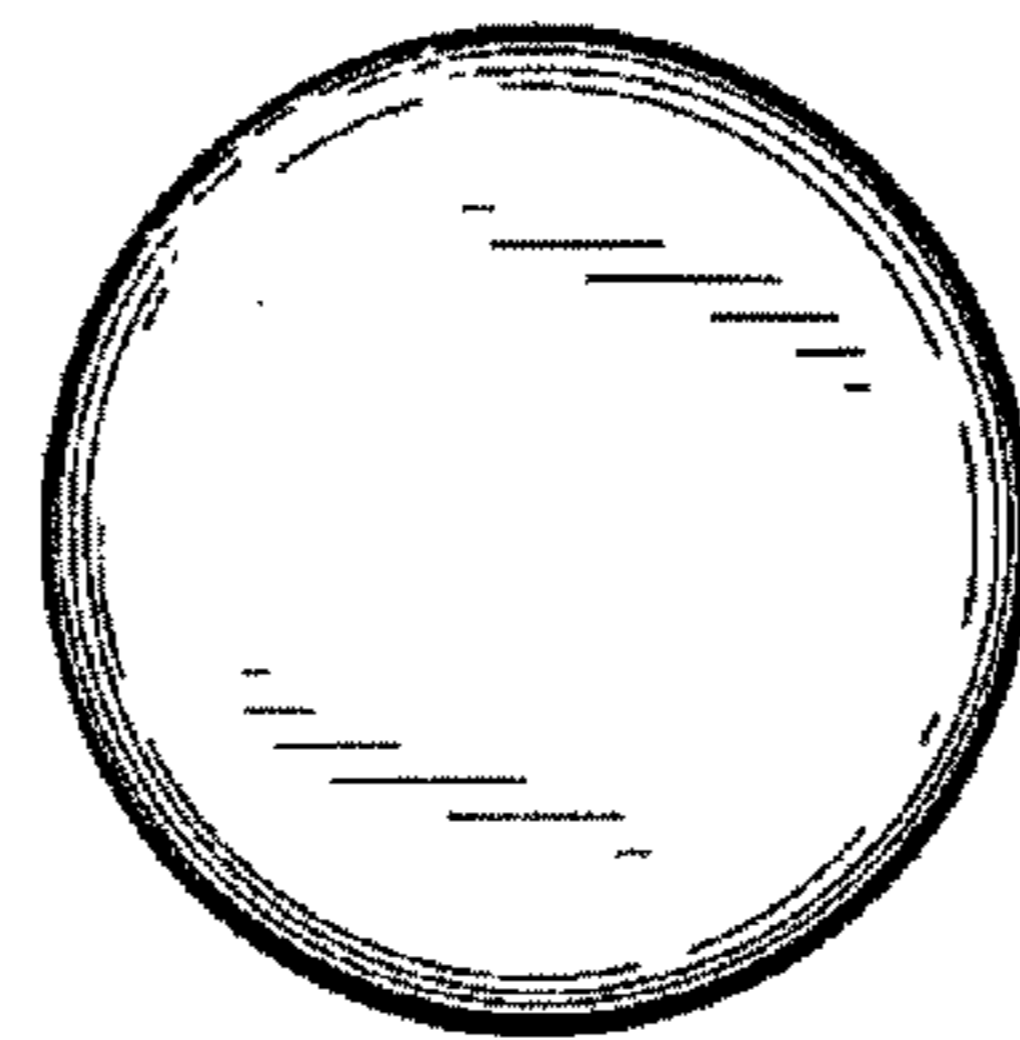

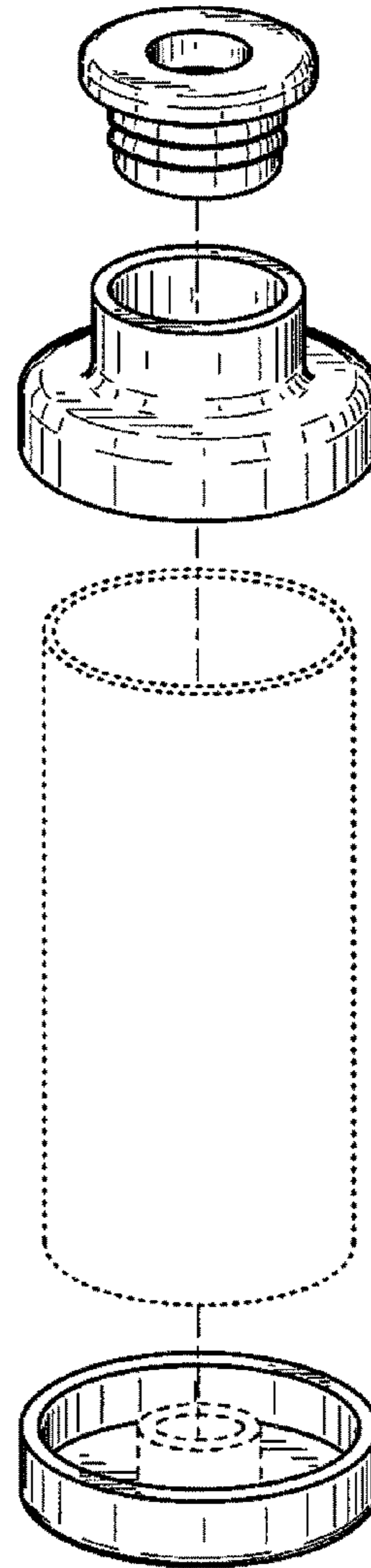
