FIG. 11 is a left-side view of the design of FIG. 8;

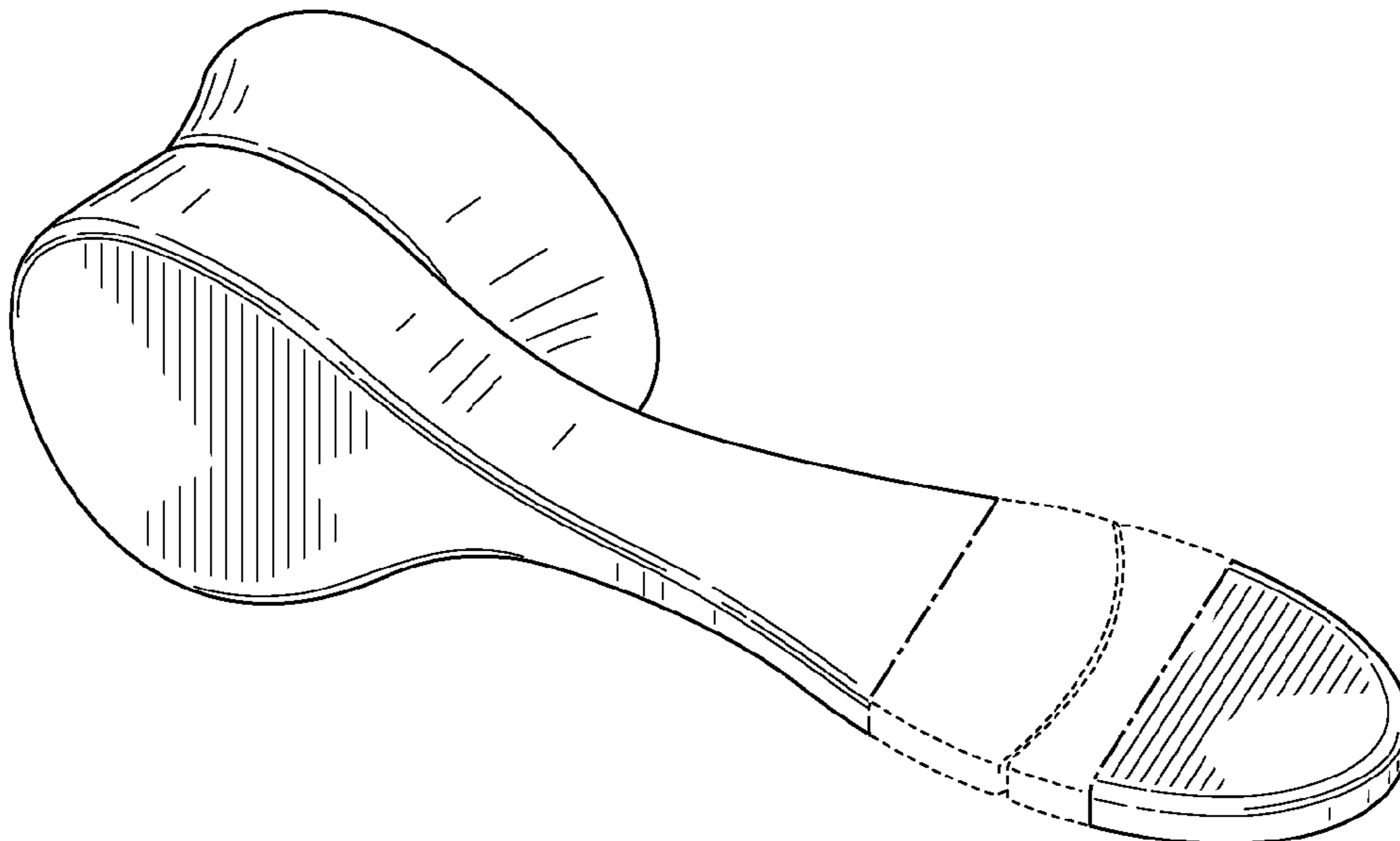
FIG. 12 is a right-side view of the design of FIG. 8;

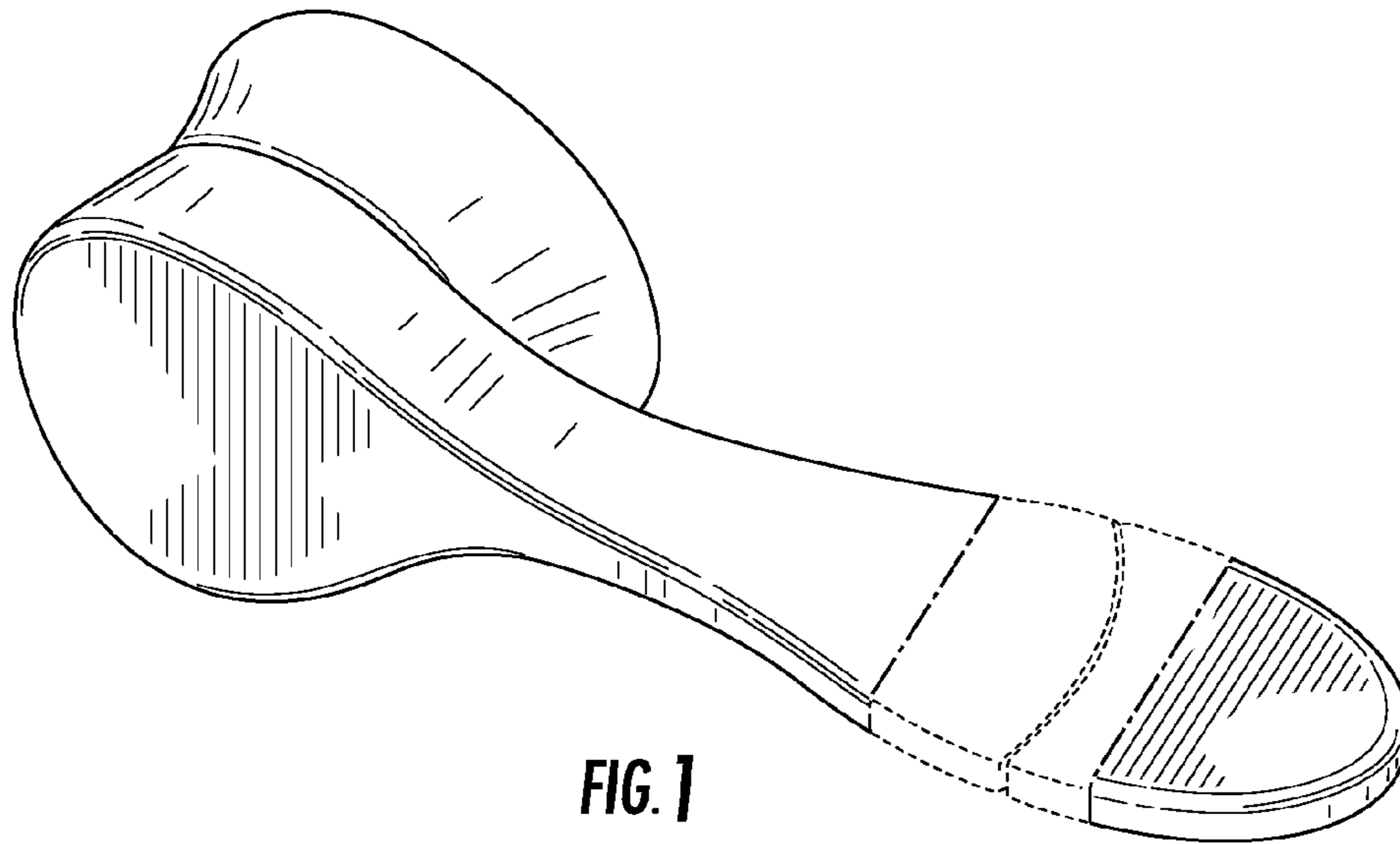

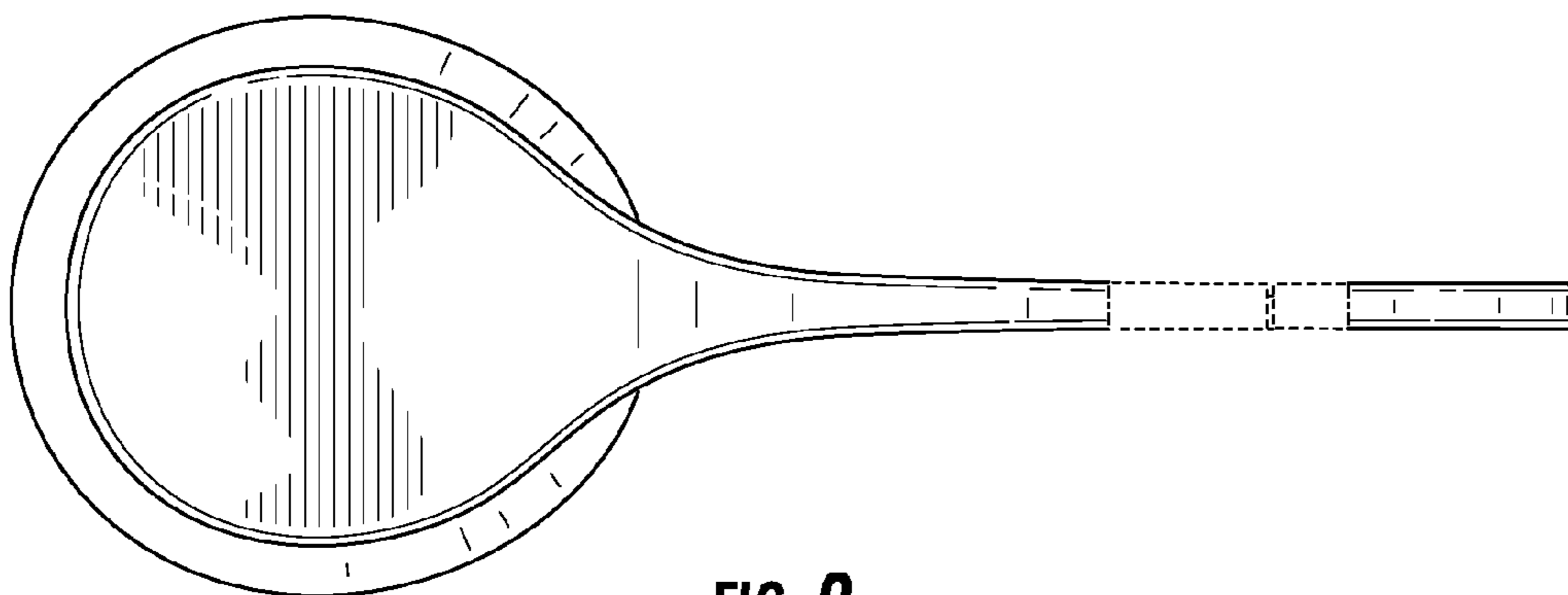

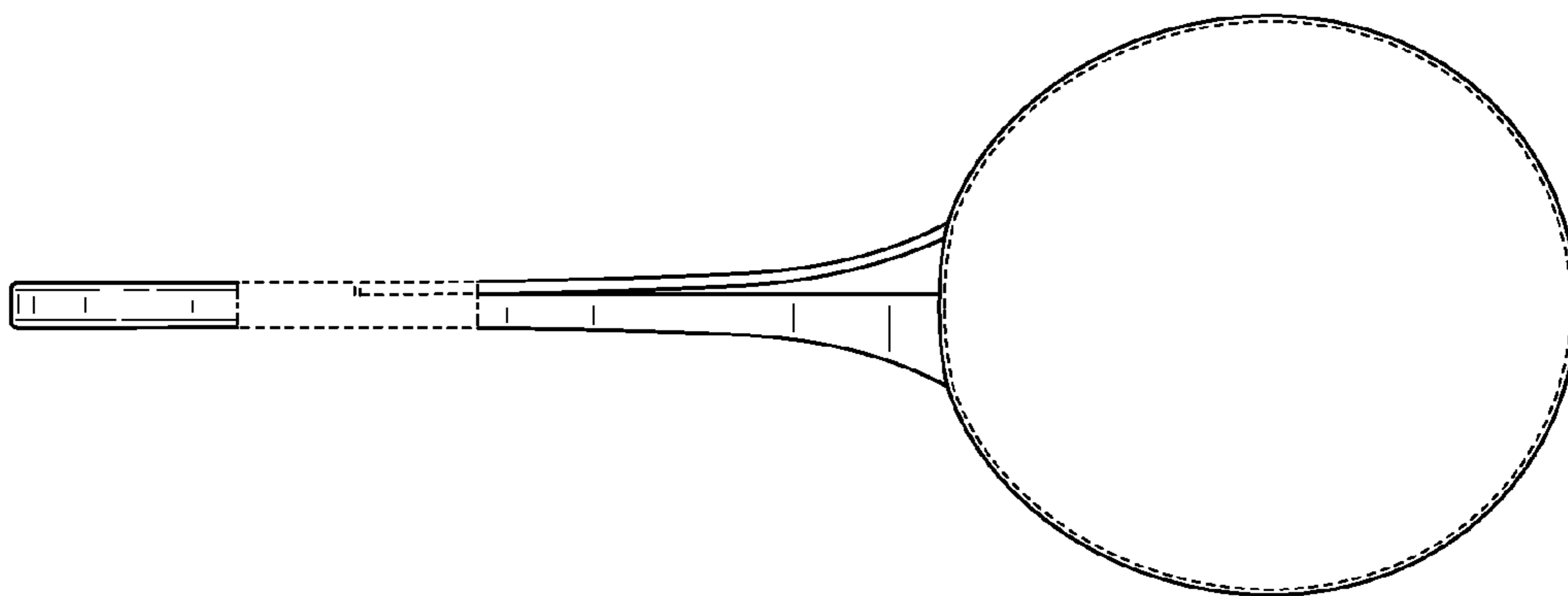
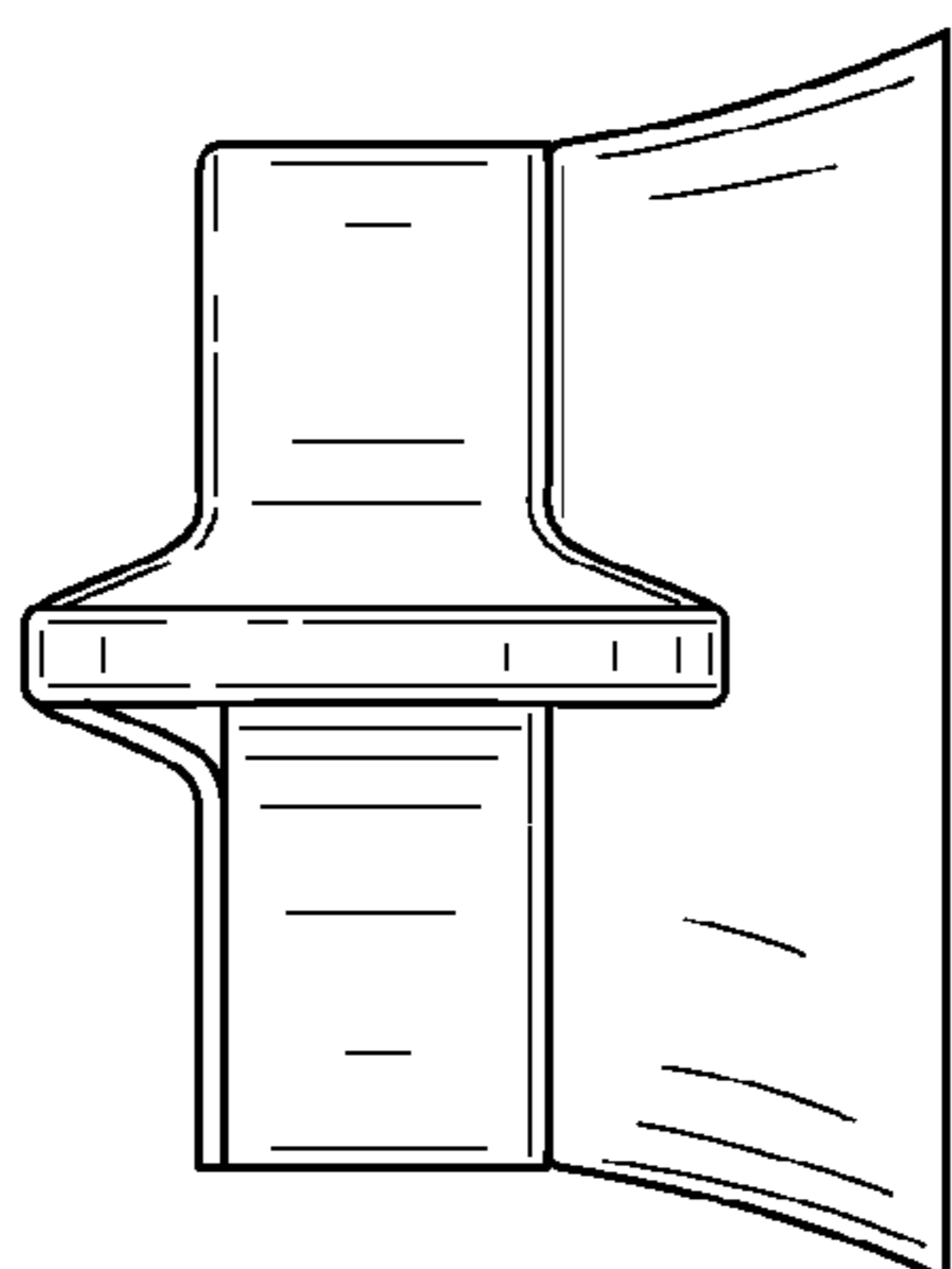
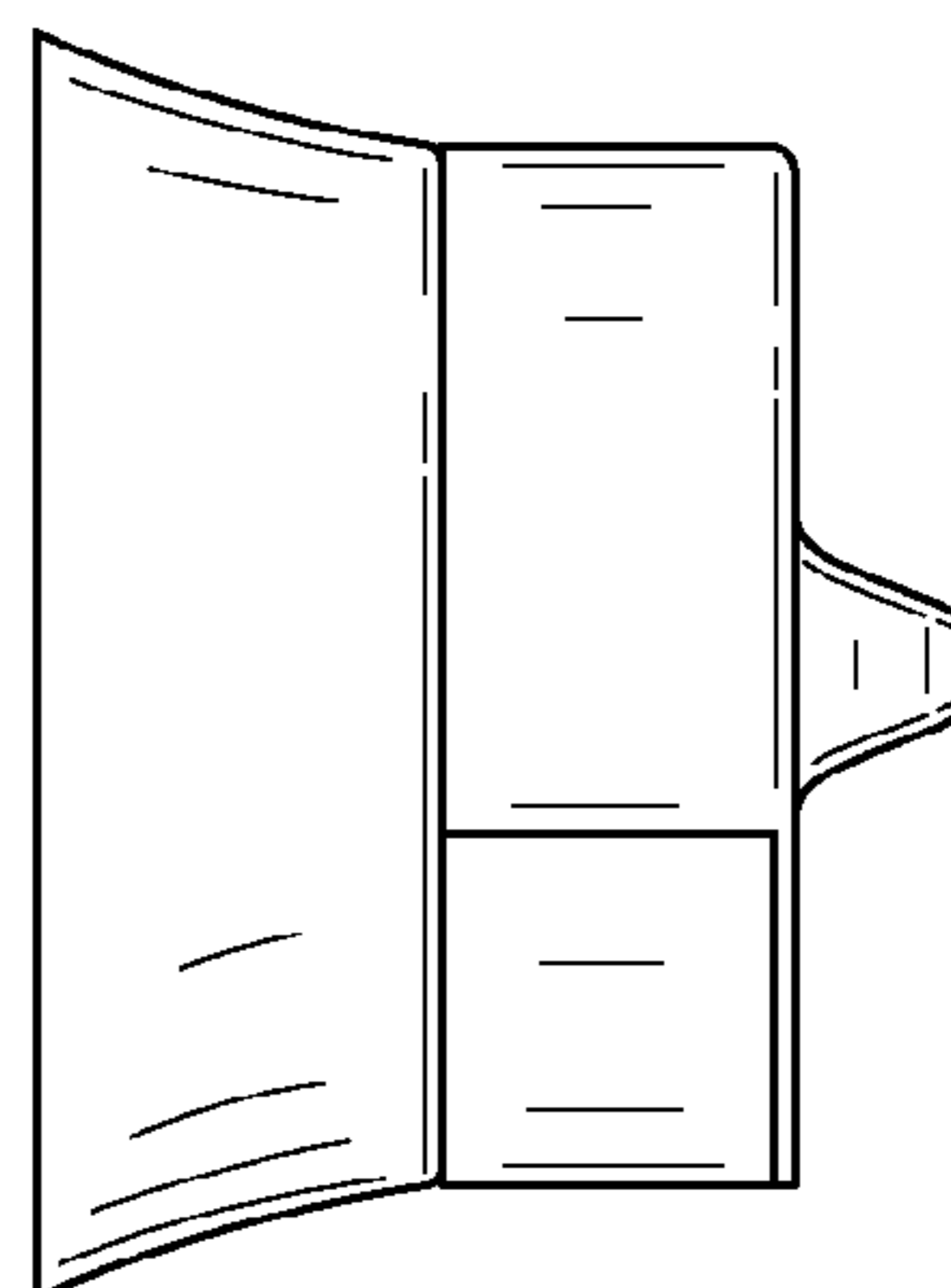


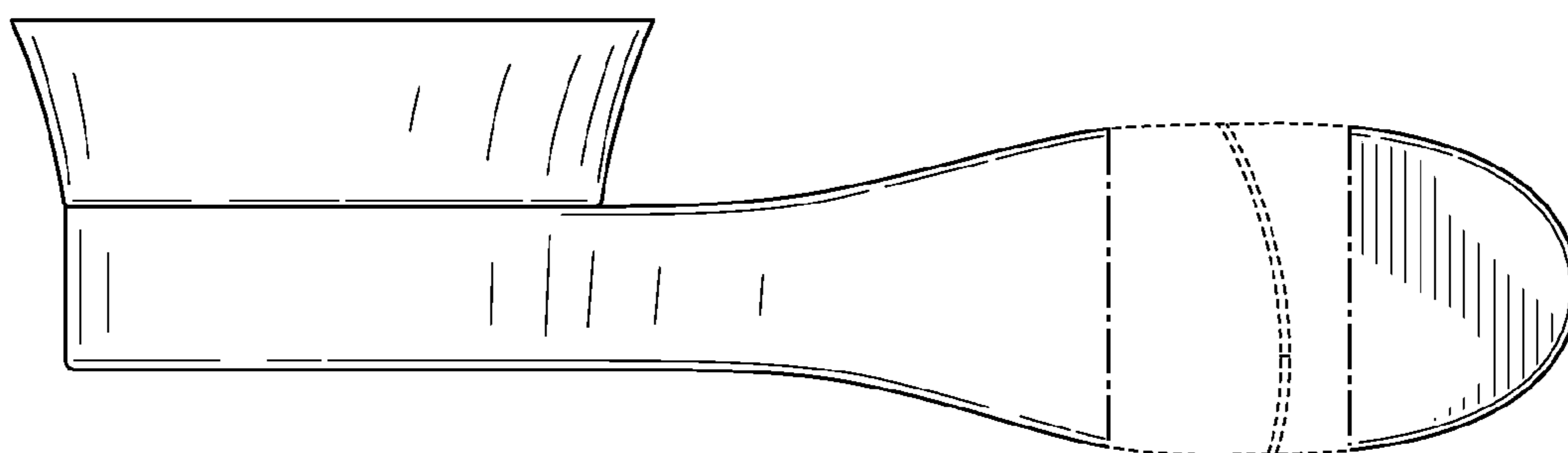

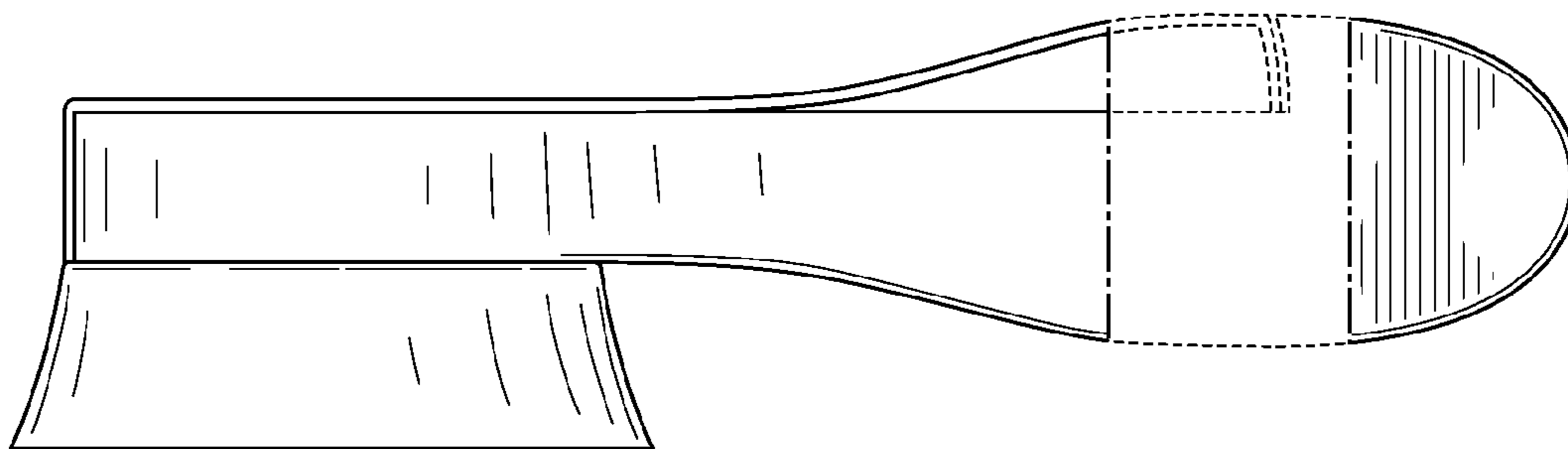

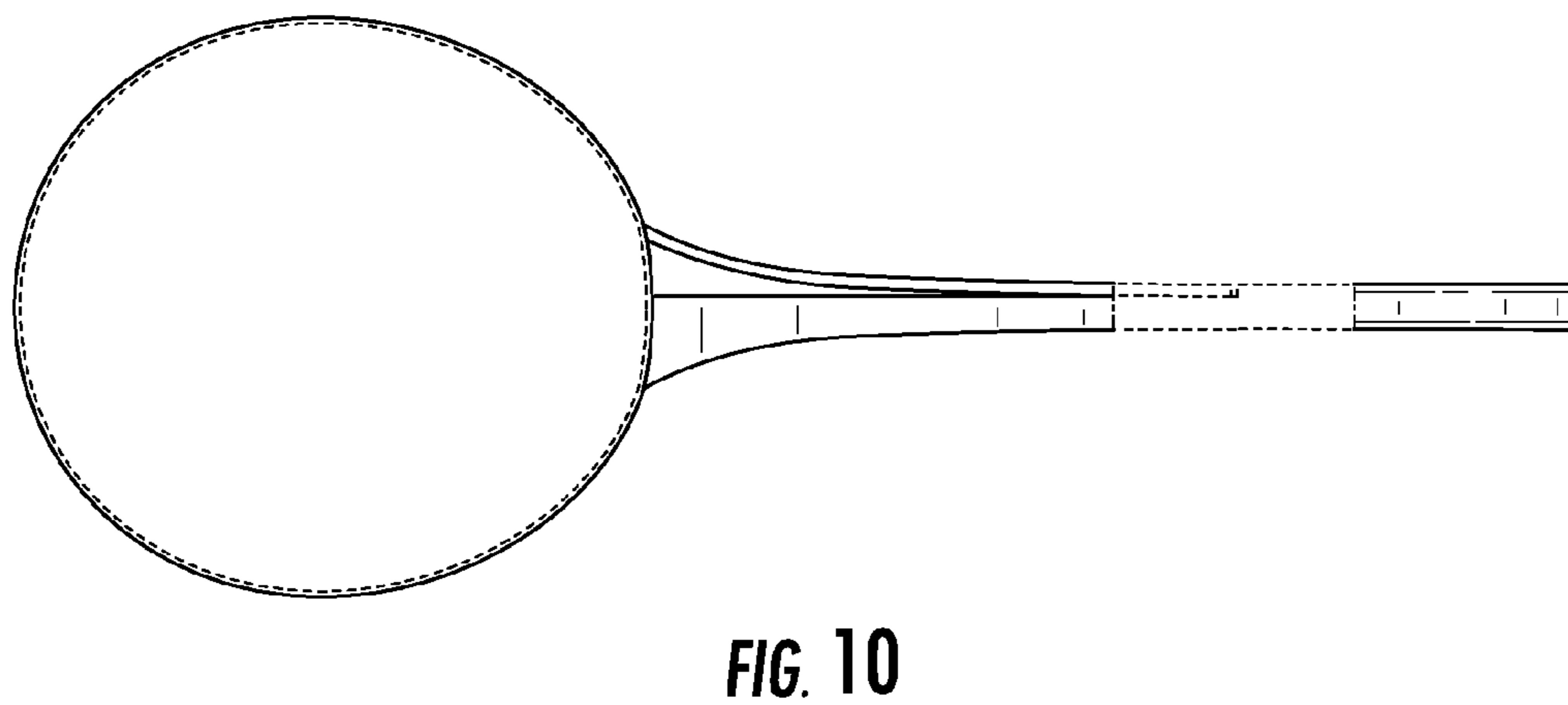
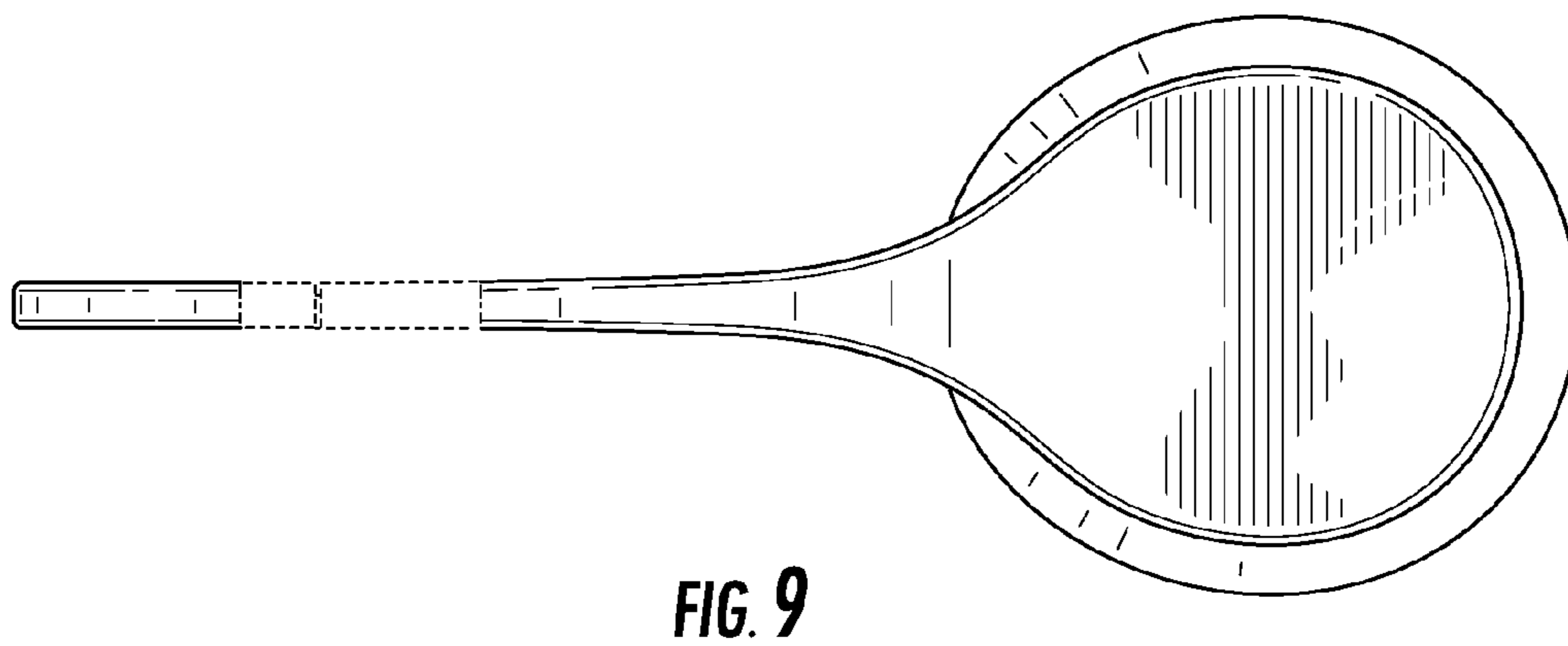
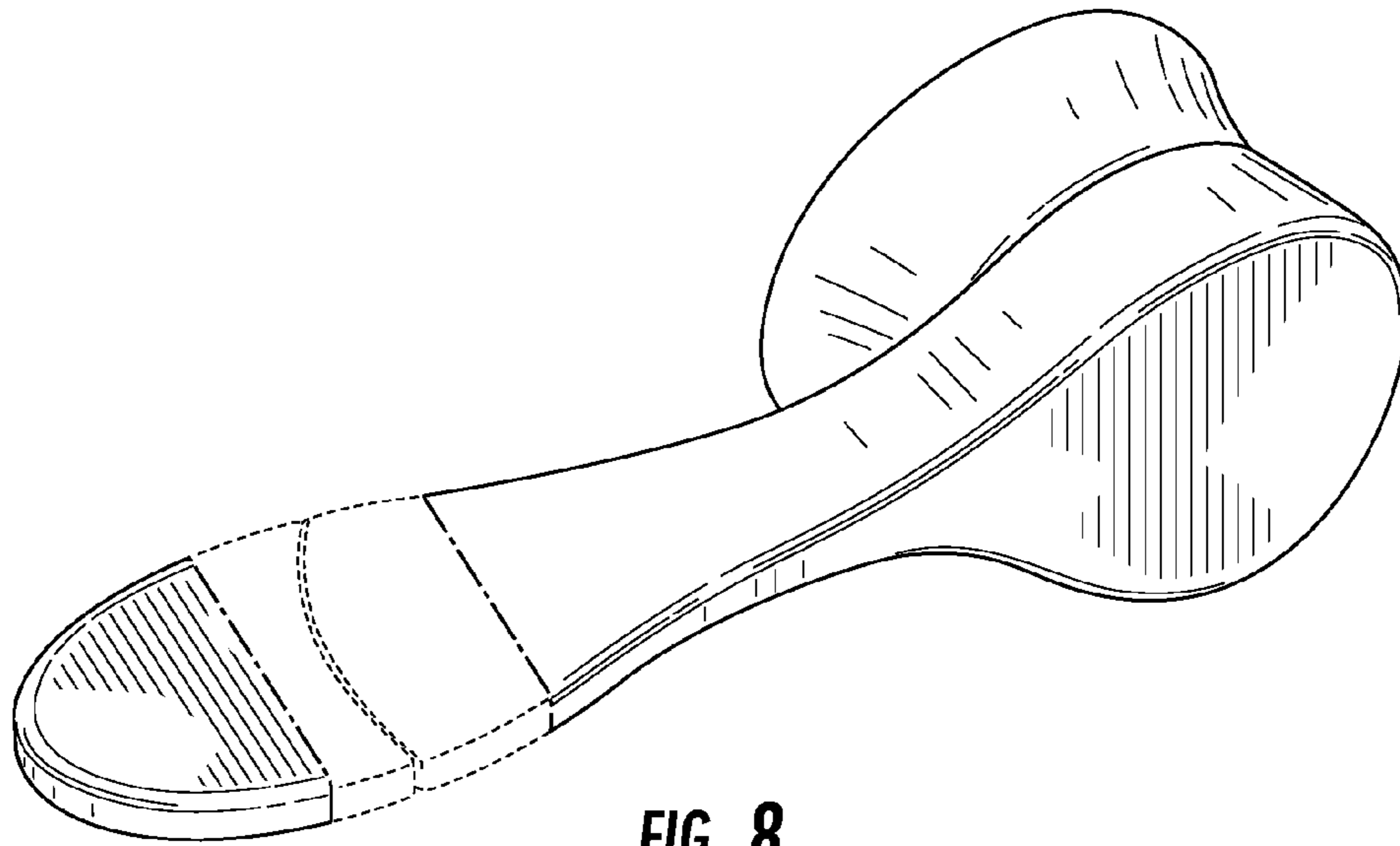

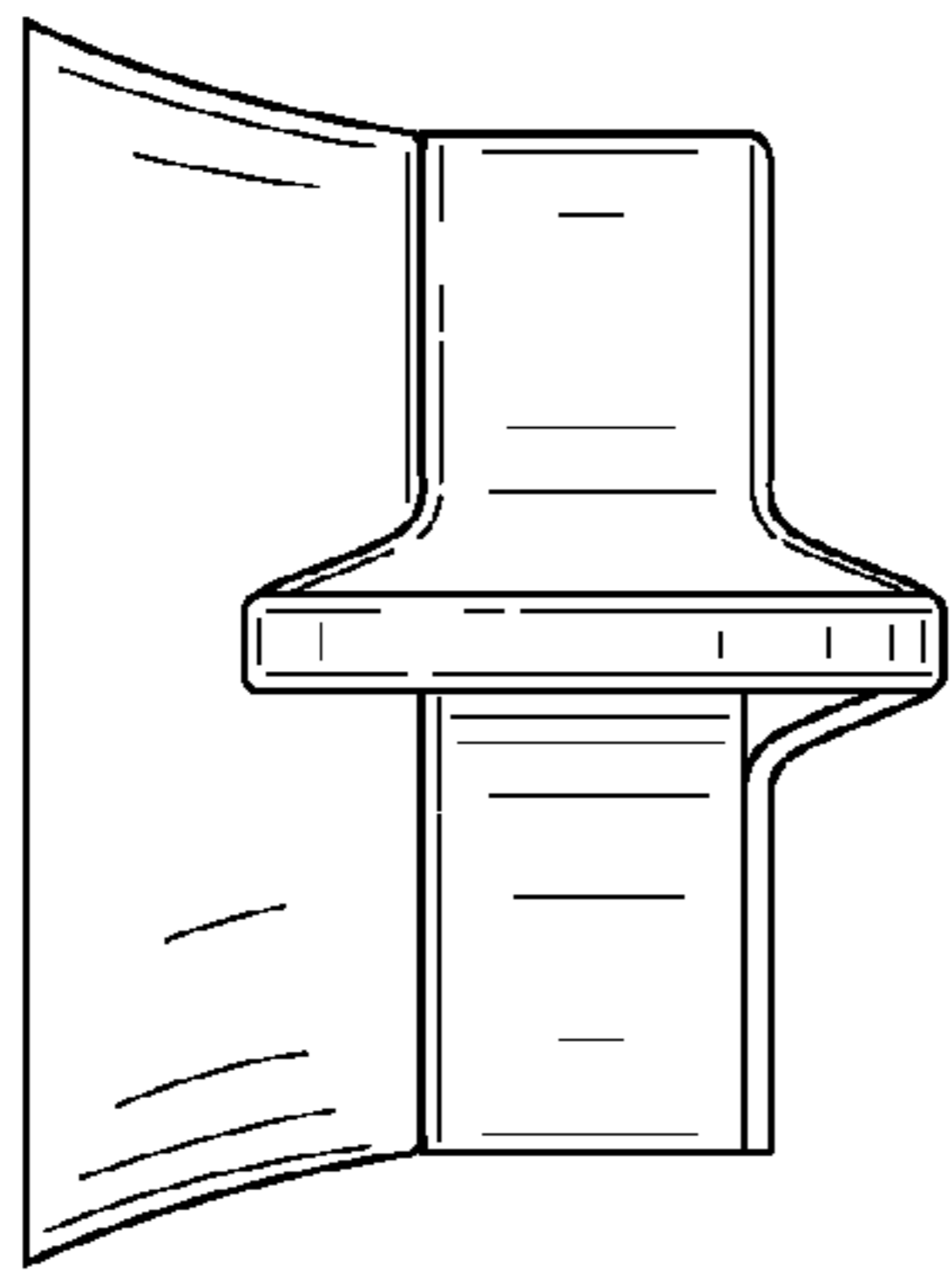

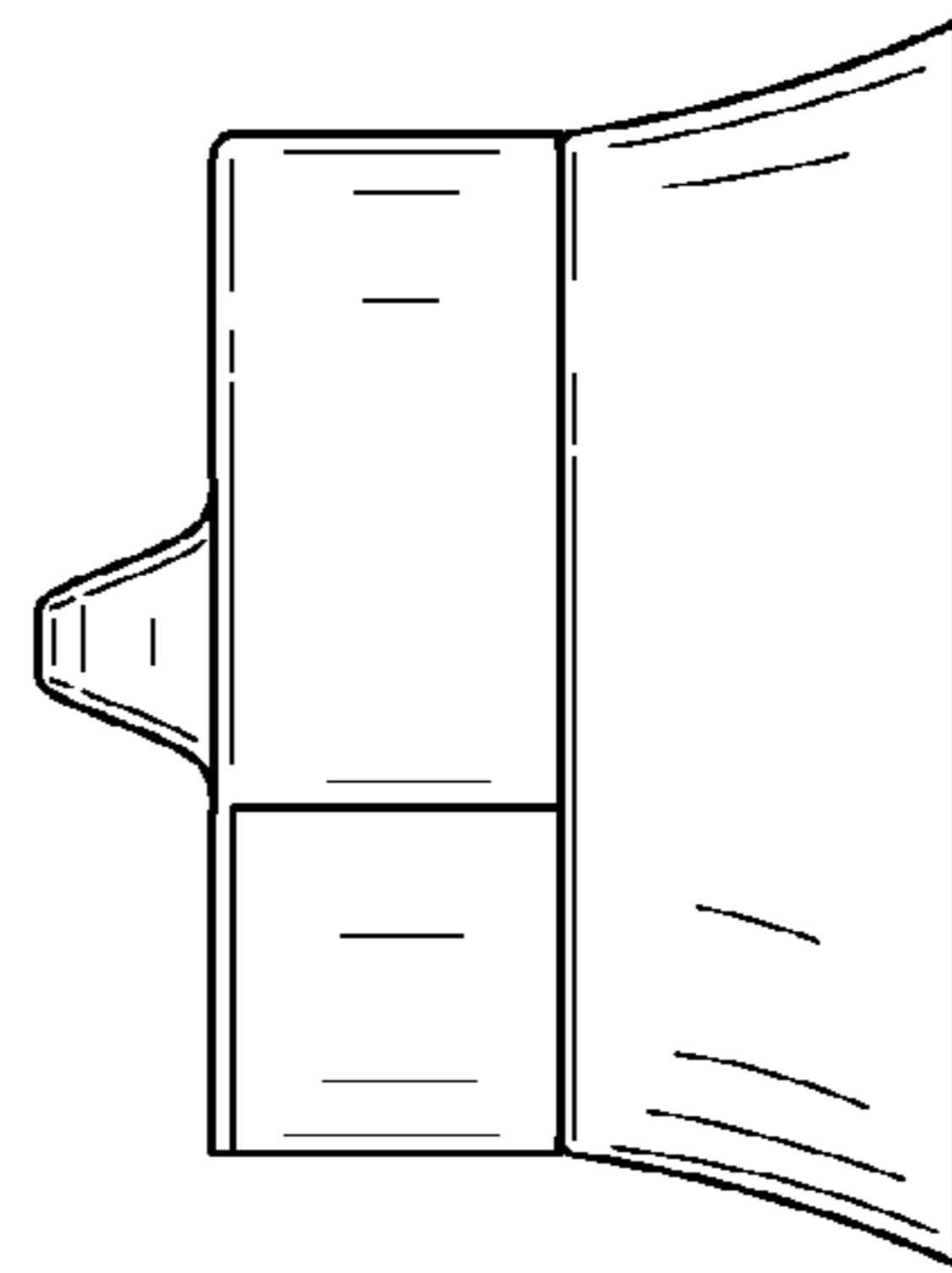

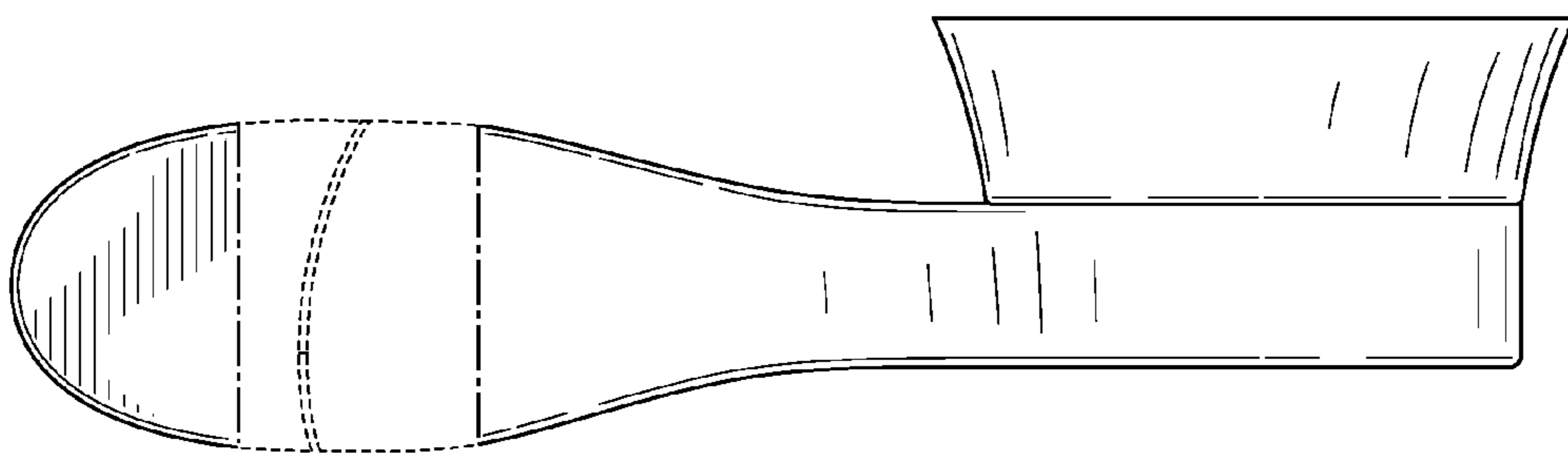




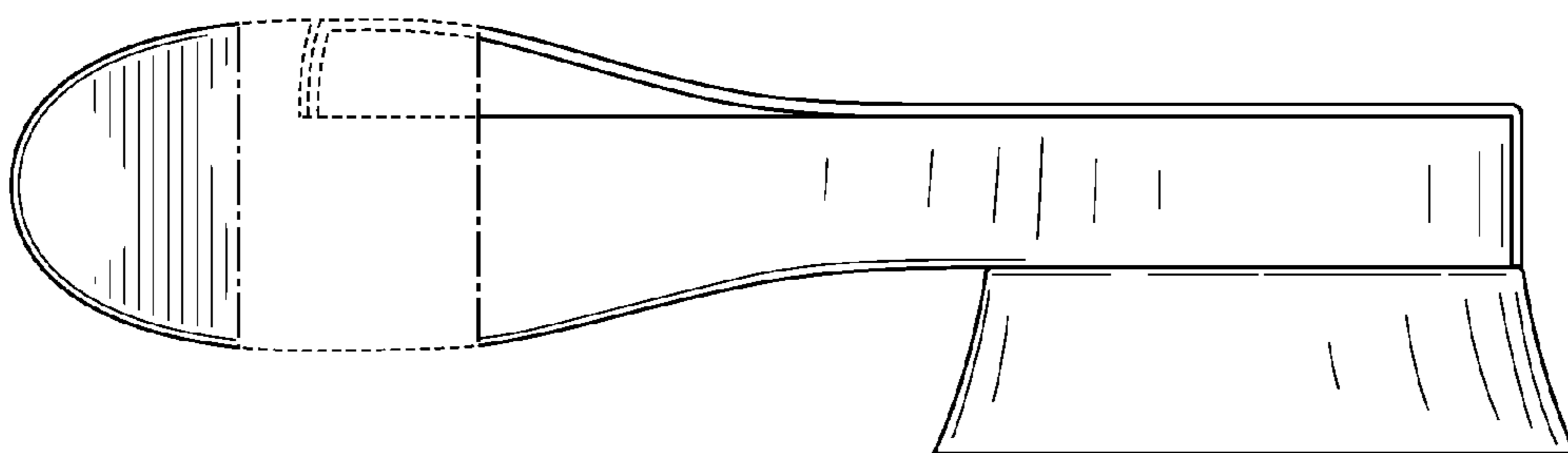
