FIG. 3 is a right side view of the claimed design;

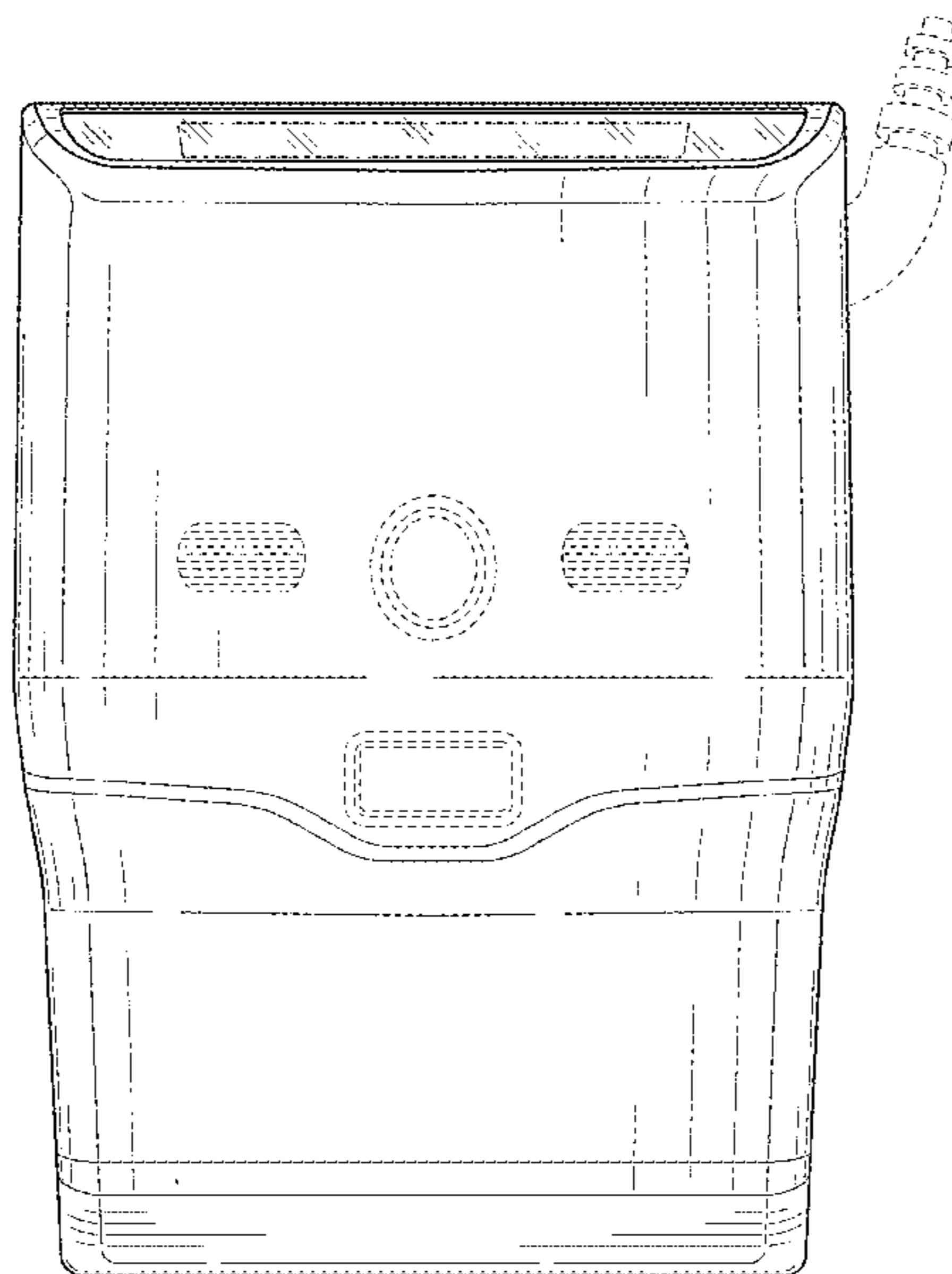
FIG. 4 is a back view thereof;

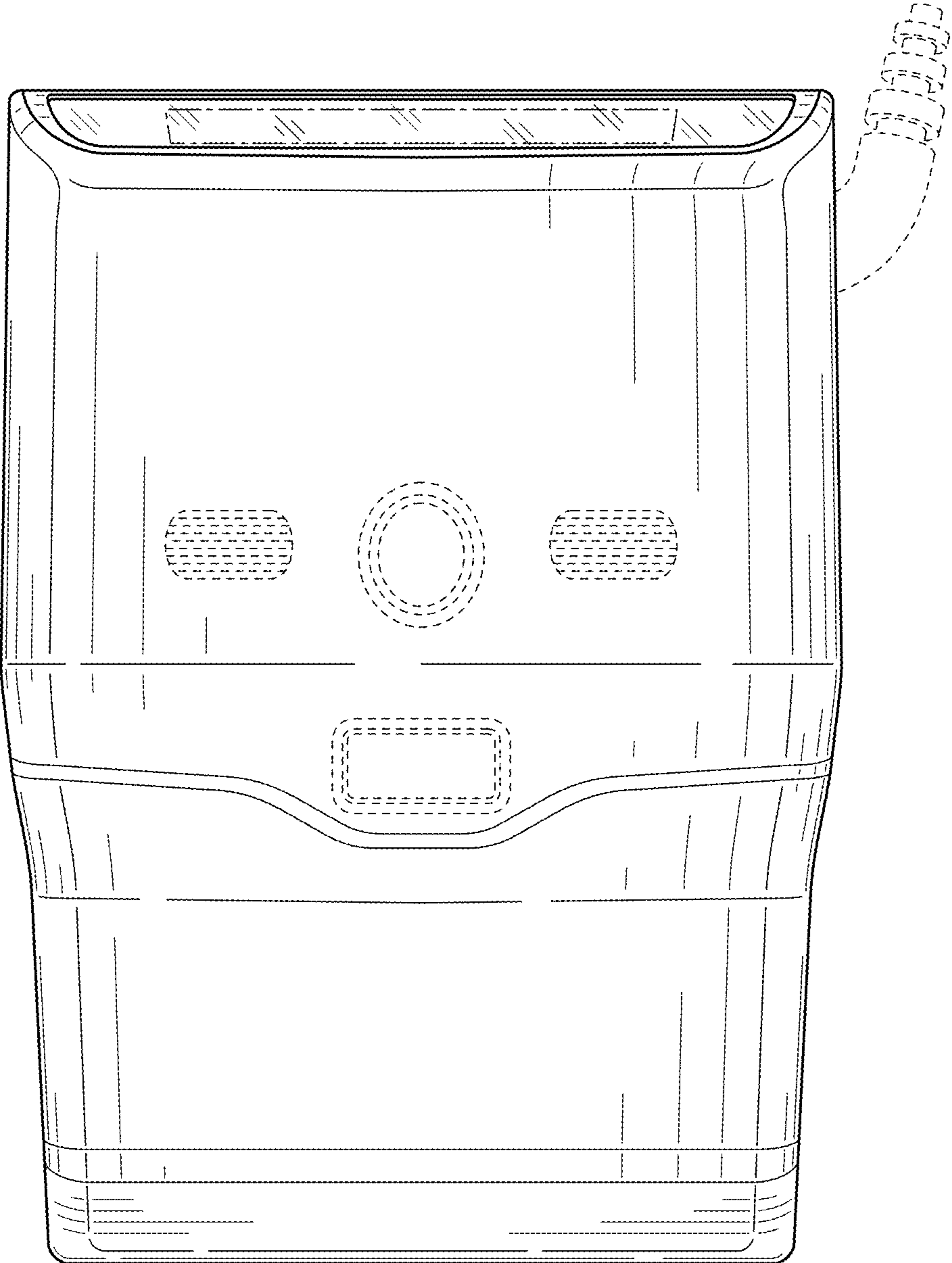

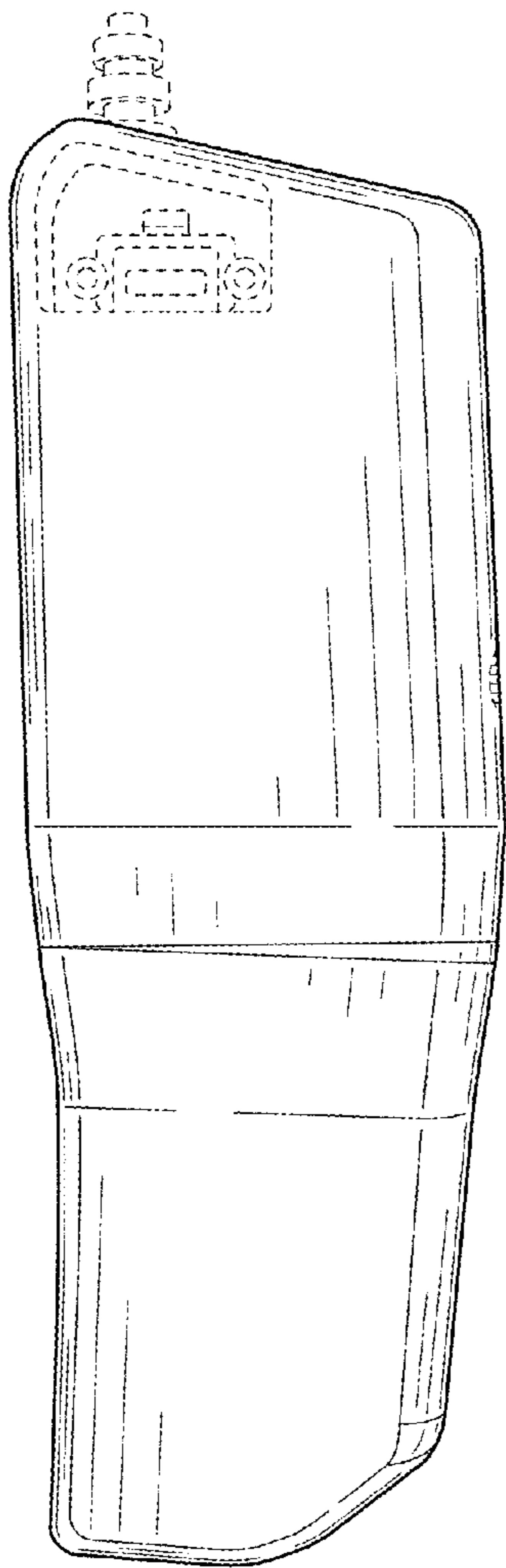

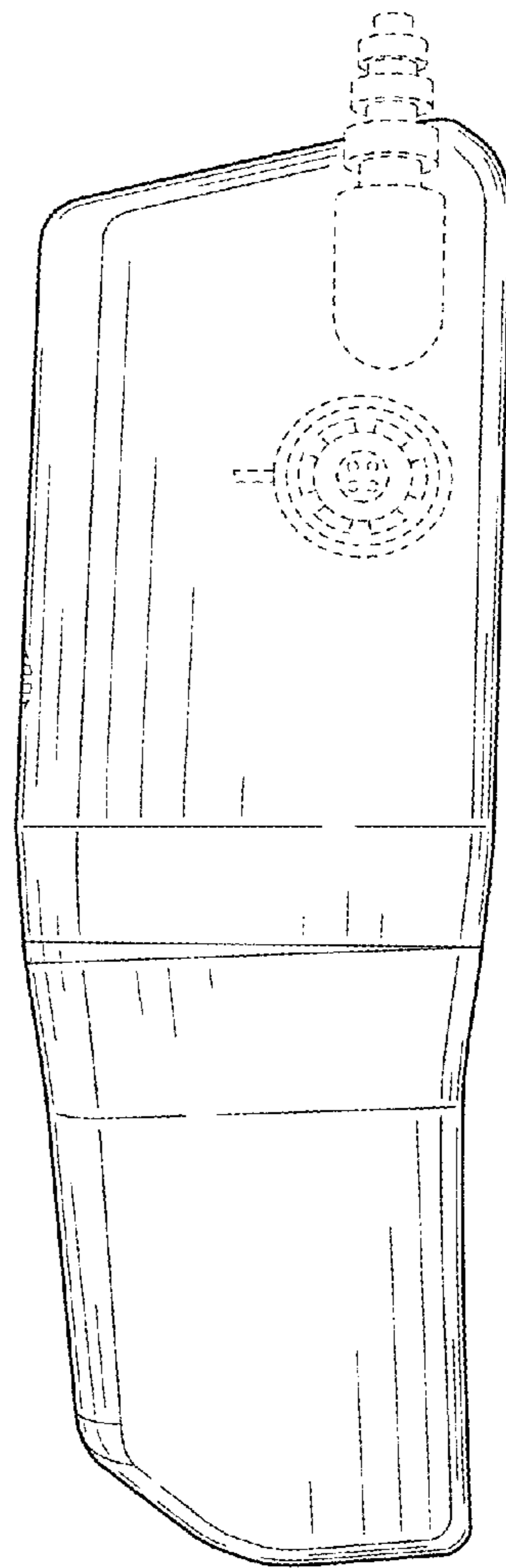

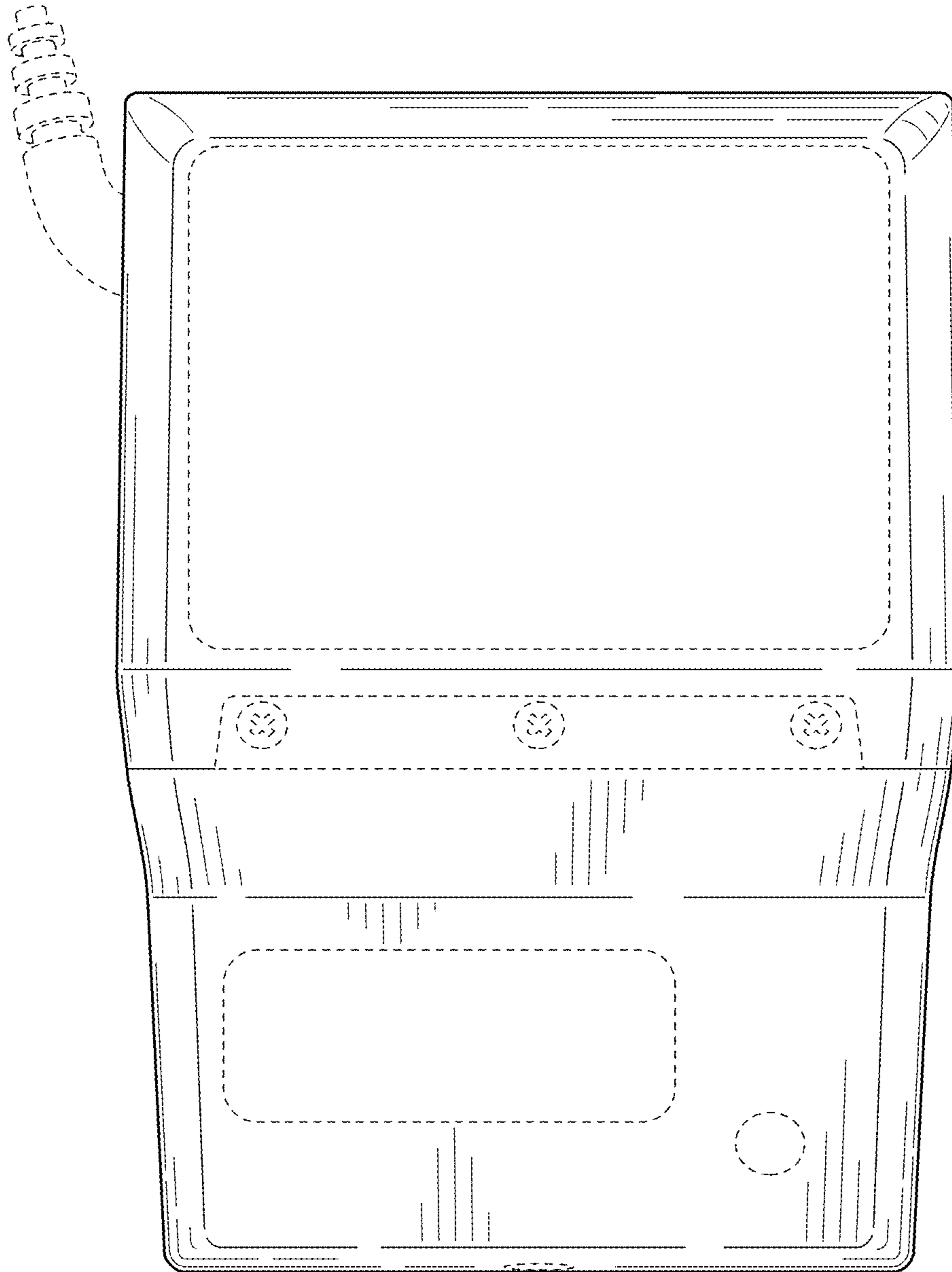

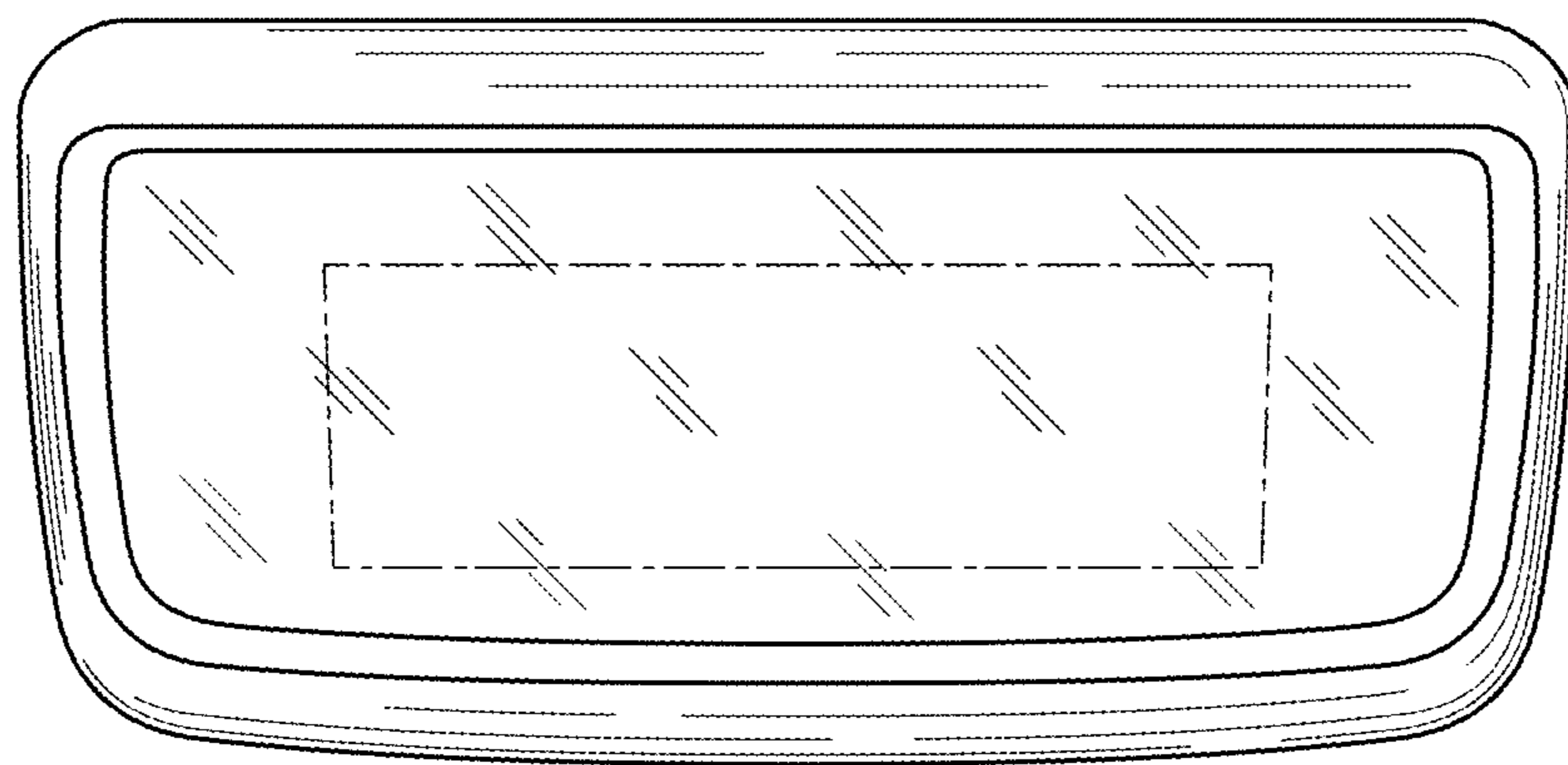

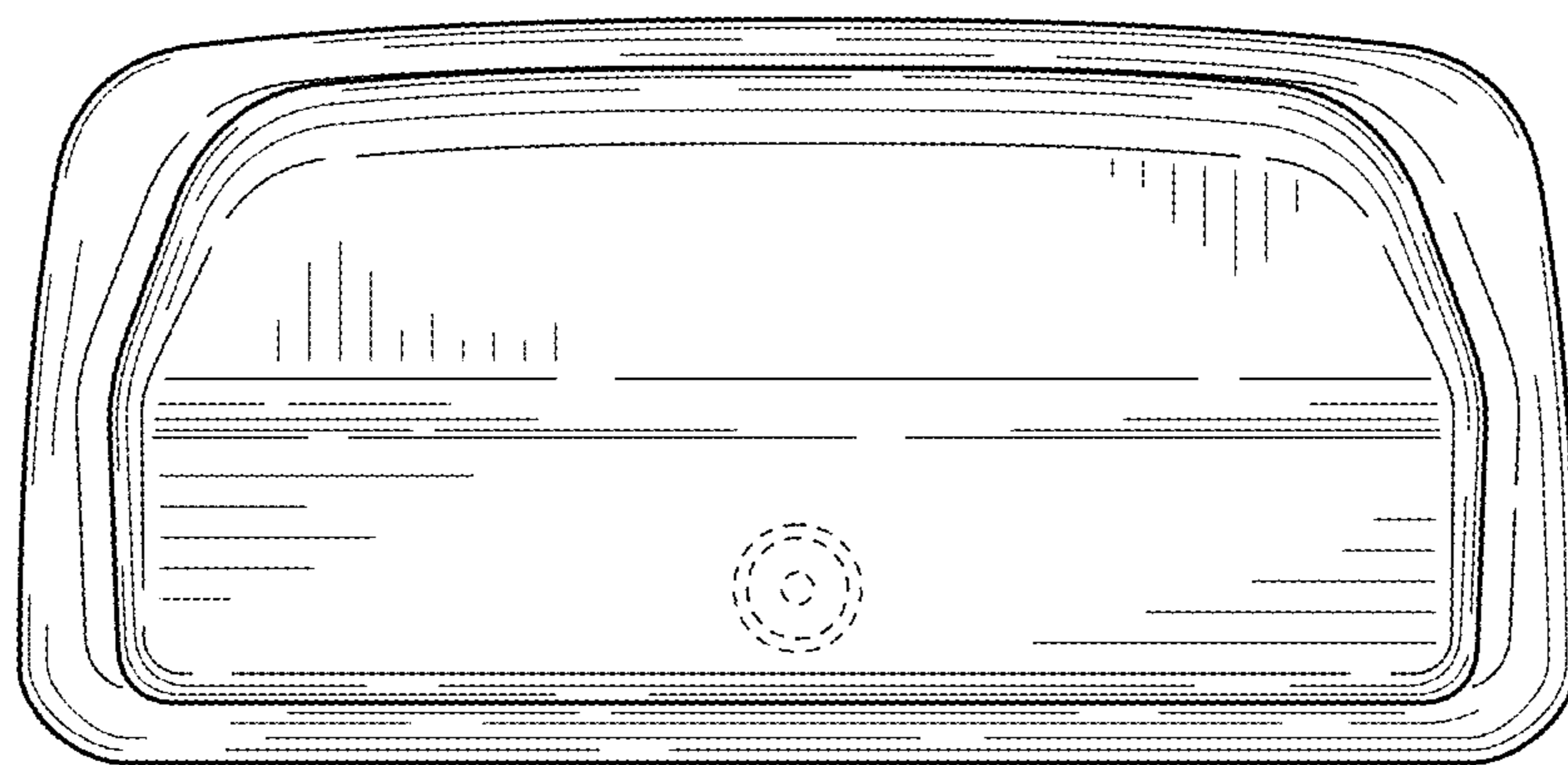
