(57) **CLAIM**

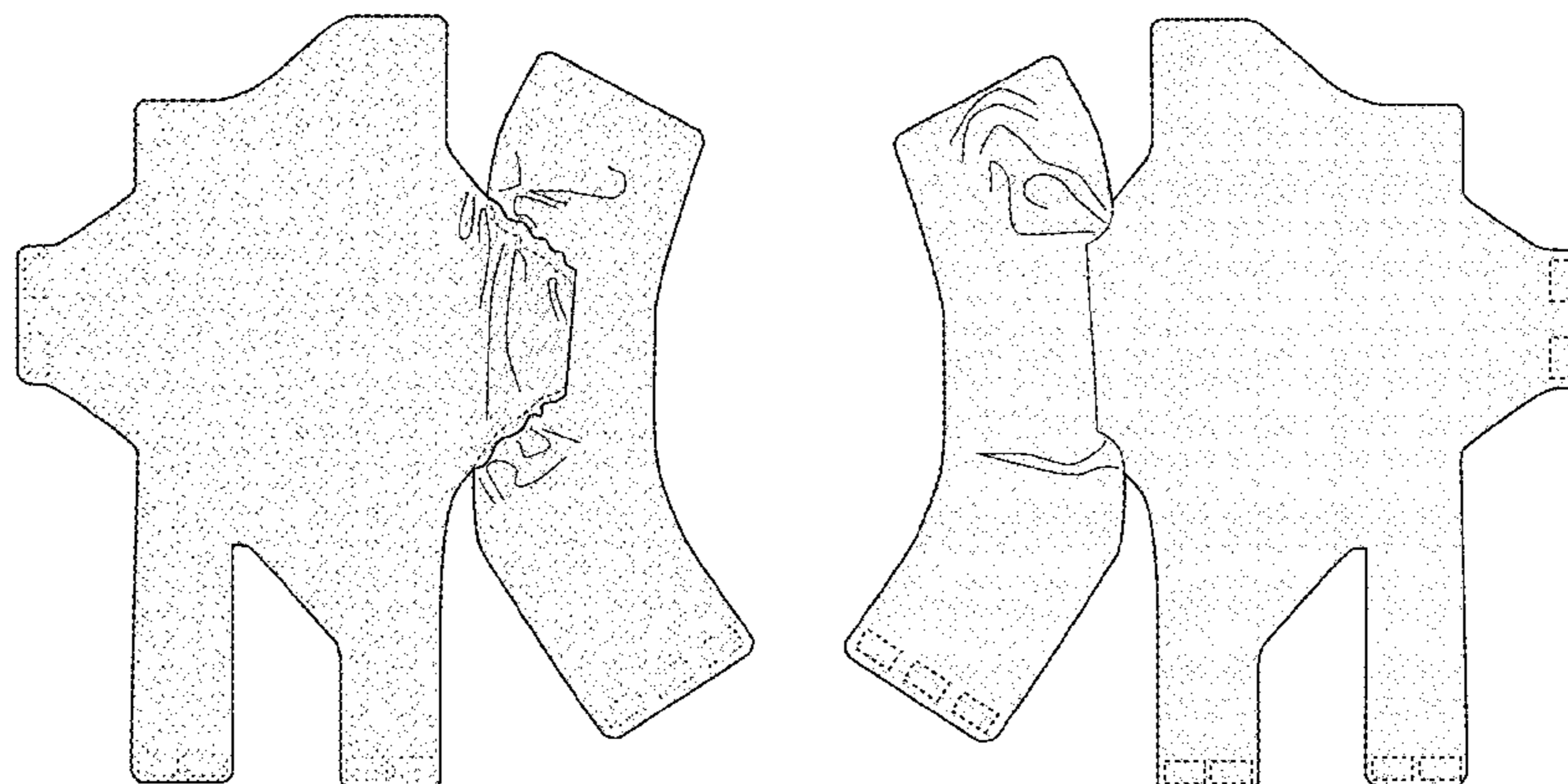
The ornamental design for a foot wrap, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a flattened sewn top view of a foot wrap, embodying the new design;  
 FIG. 2 is a flattened sewn bottom view of a foot wrap, embodying the new design;  
 FIG. 3 is a front view of a foot wrap wrapped around a foot, embodying the new design;  
 FIG. 4 is a back view of a foot wrap wrapped around a foot, embodying the new design;  
 FIG. 5 is a right view of a foot wrap wrapped around a foot, embodying the new design;  
 FIG. 6 is a left view of a foot wrap wrapped around a foot, embodying the new design;  
 FIG. 7 is a top view of a foot wrap wrapped around a foot, embodying the new design; and,  
 FIG. 8 is a bottom view of a foot wrap wrapped around a foot, embodying the new design.

The lighter, thicker broken lines in FIGS. 3-4 in a box shape illustrate features that form no part of the claimed design. Also the longer, lighter dashed lines in FIGS. 3-7 illustrate environmental structure that forms no part of the claimed design. Other dashed lines, such as in FIGS. 1, 2, 4, 6, and 8 represent sewn stitches and are a part of the claimed design.

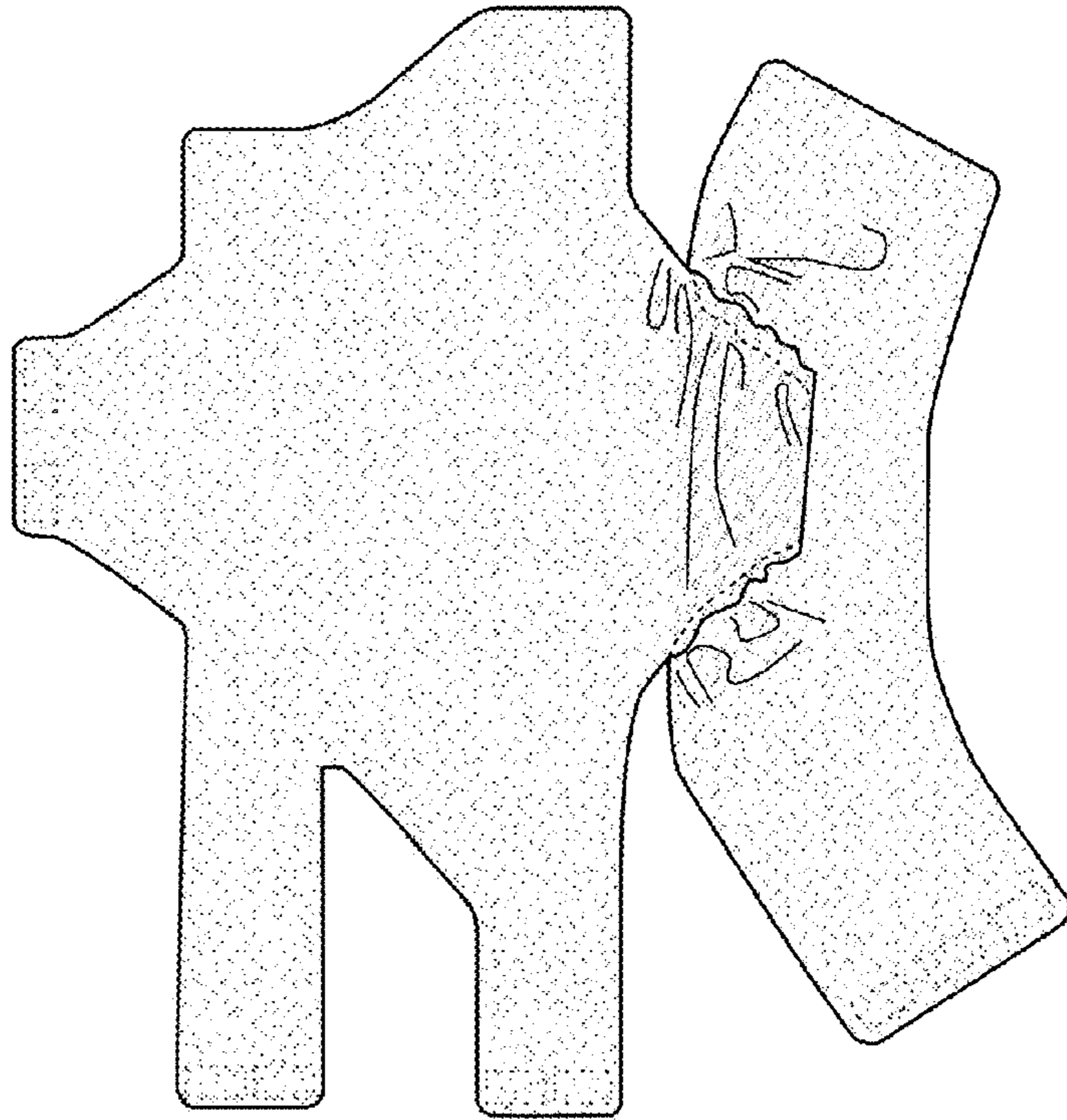

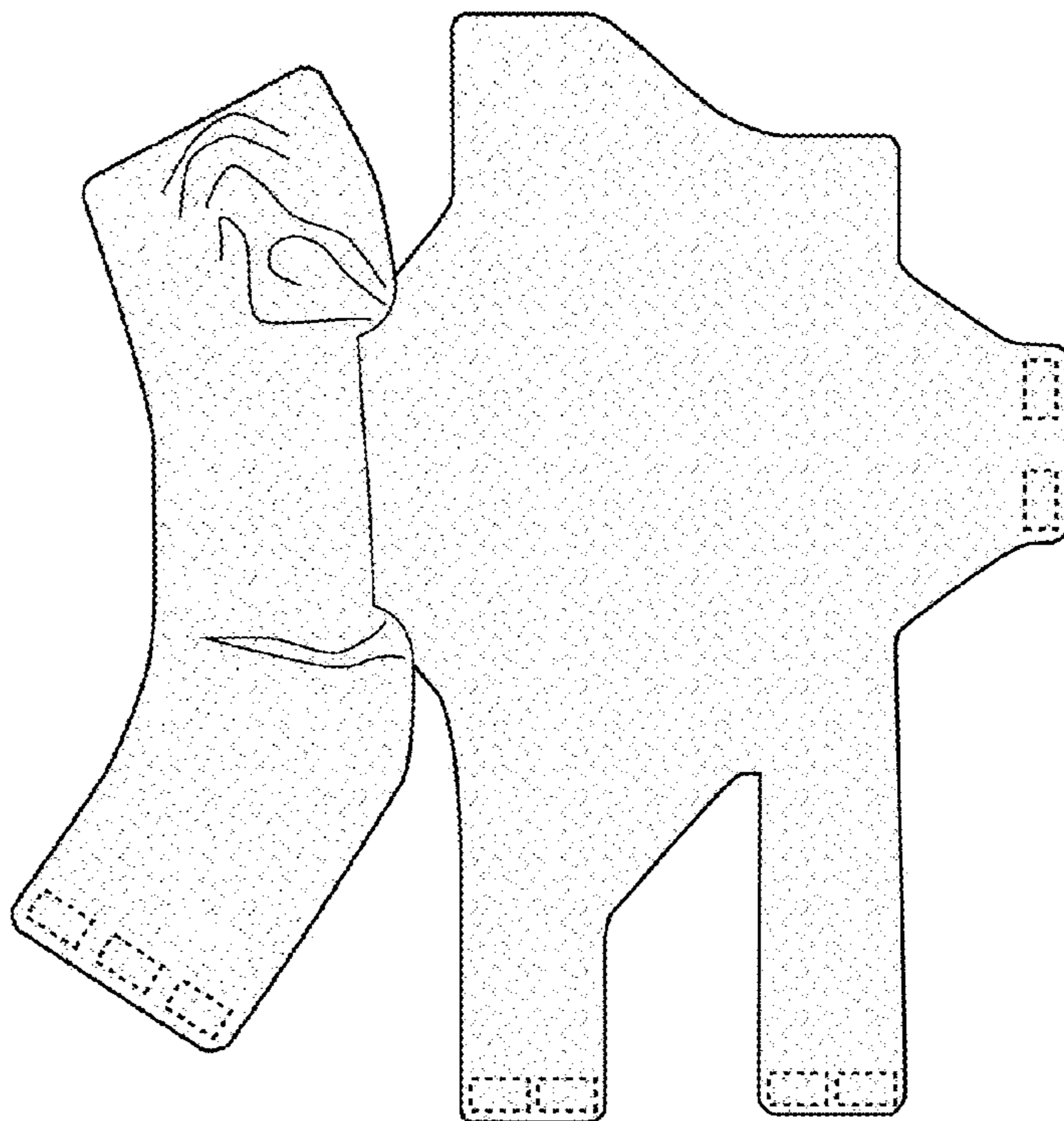

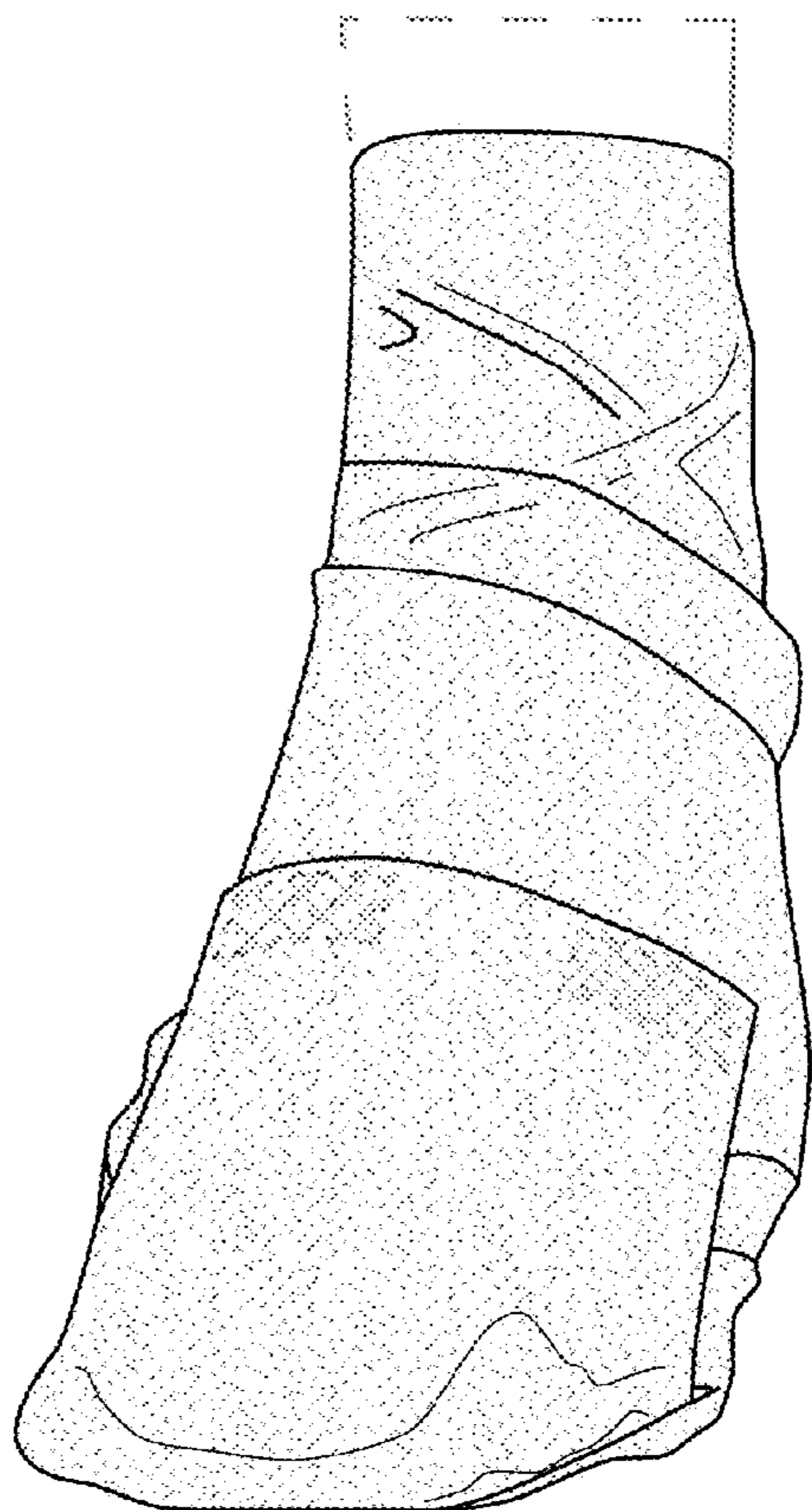

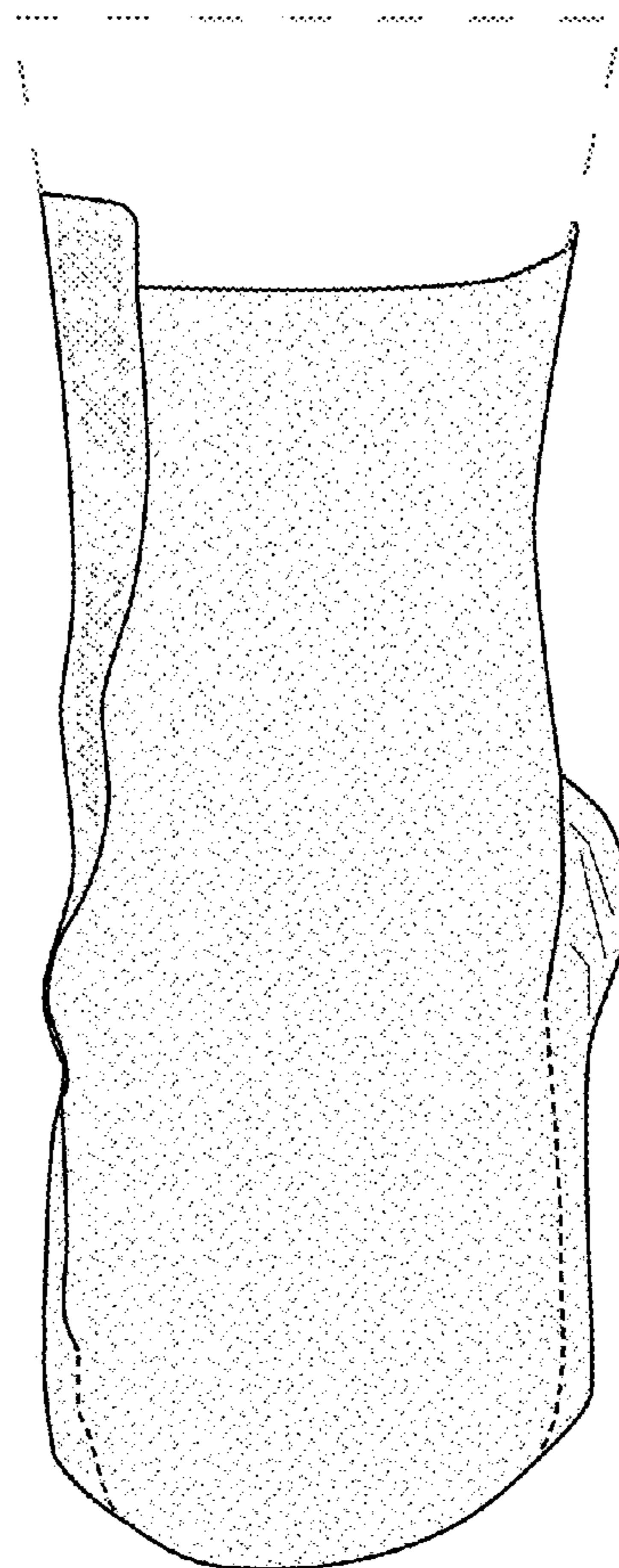

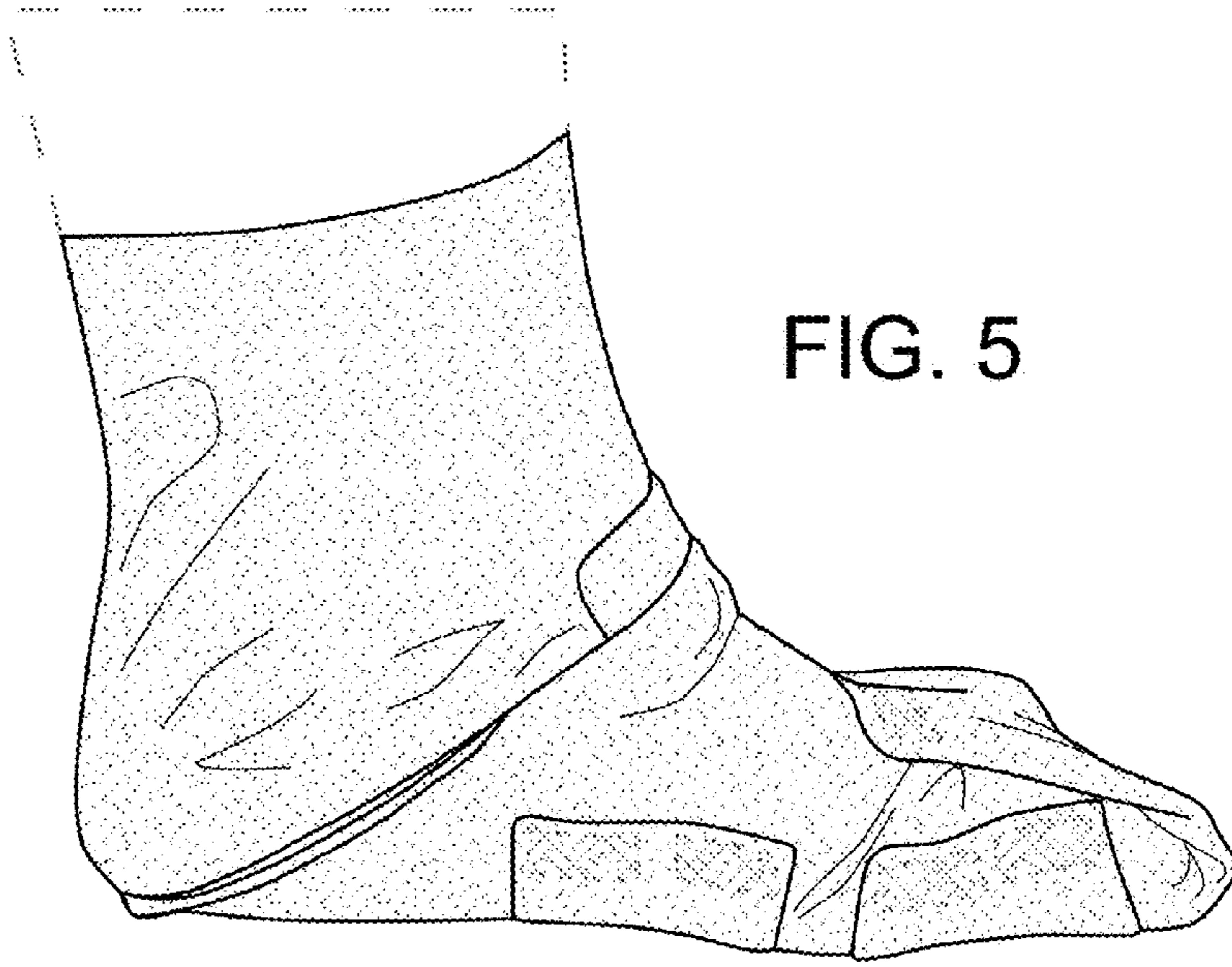

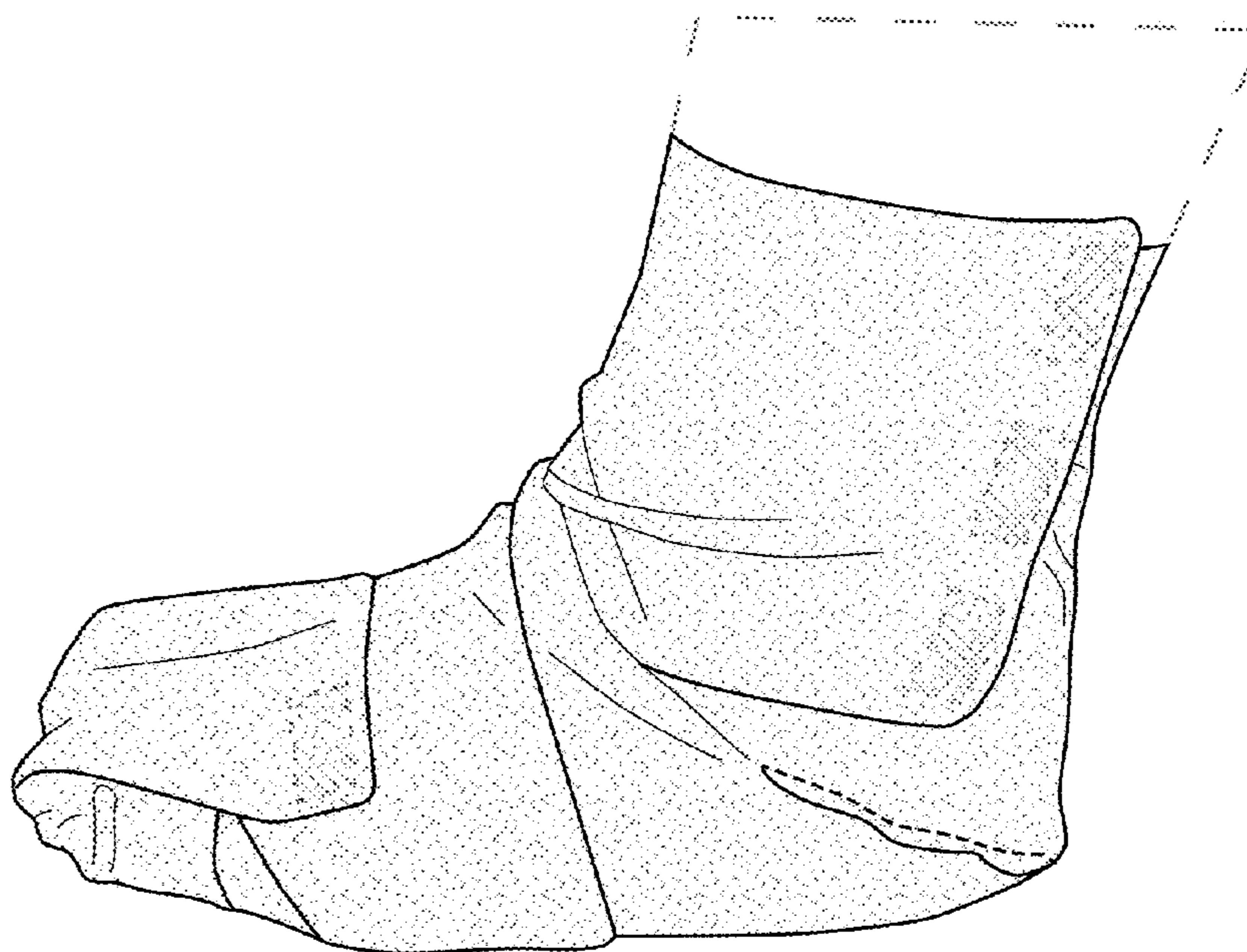

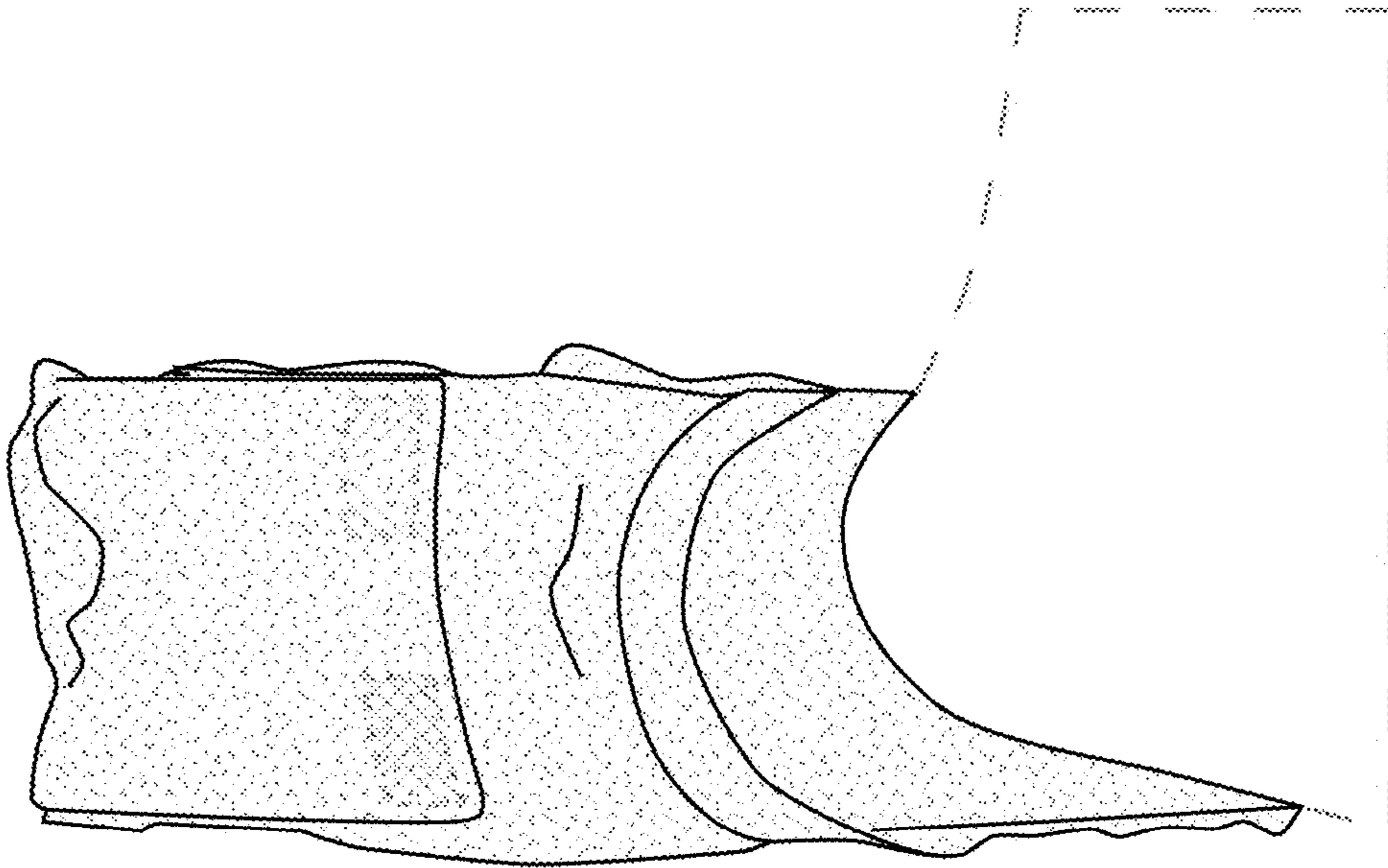

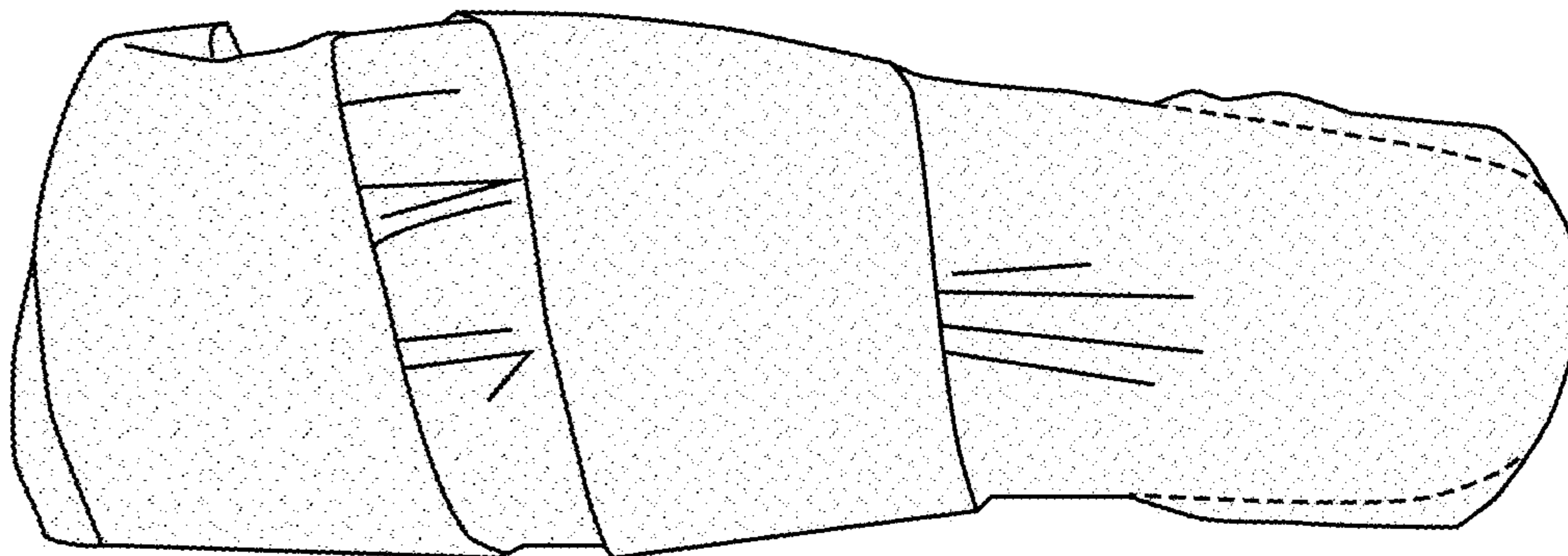
