DESCRIPTION

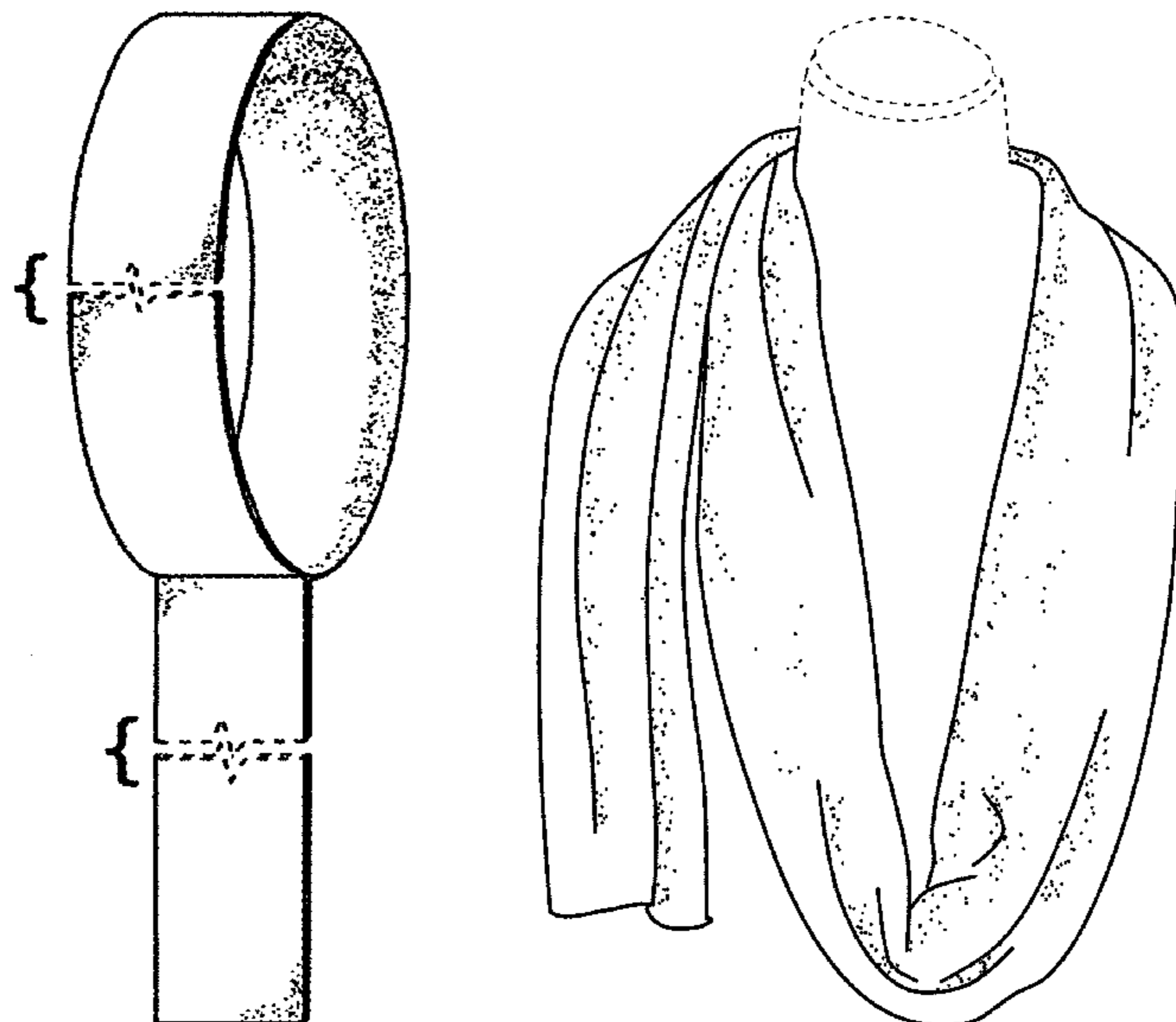
FIG. 1 is a front perspective view of my new scarf design, the rear perspective view being a mirror image thereof;

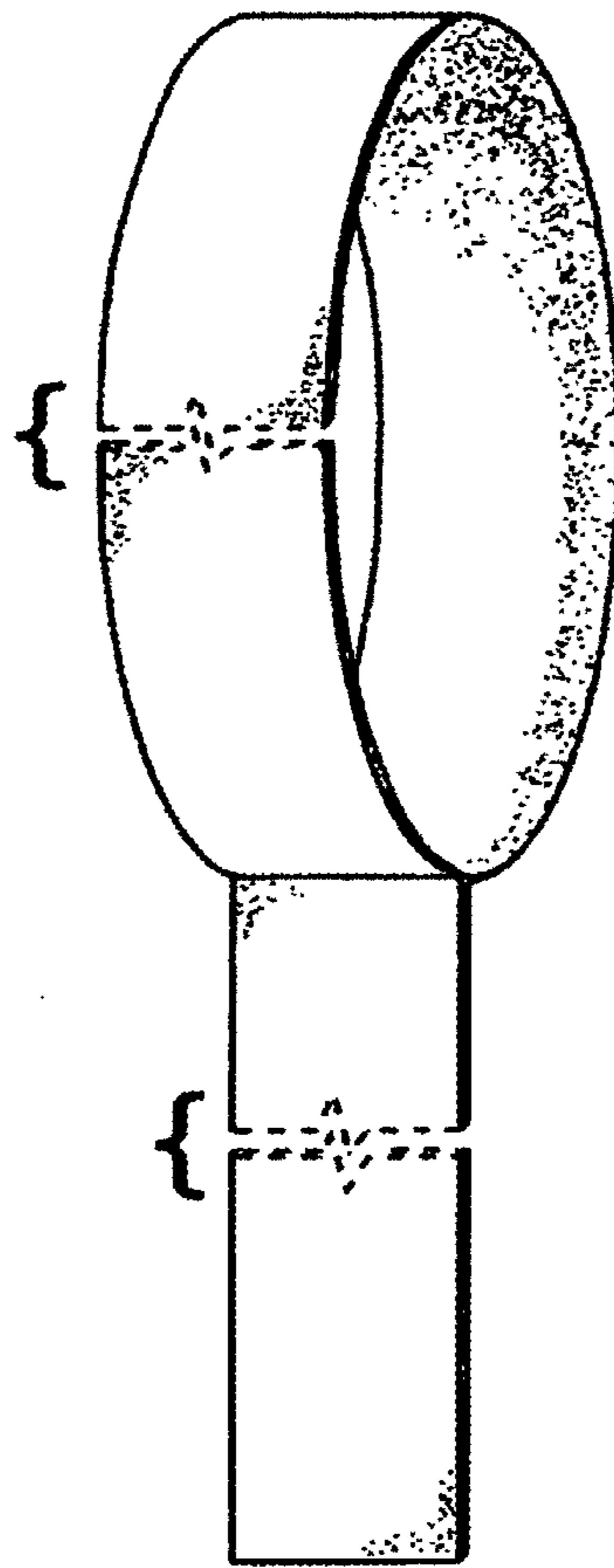

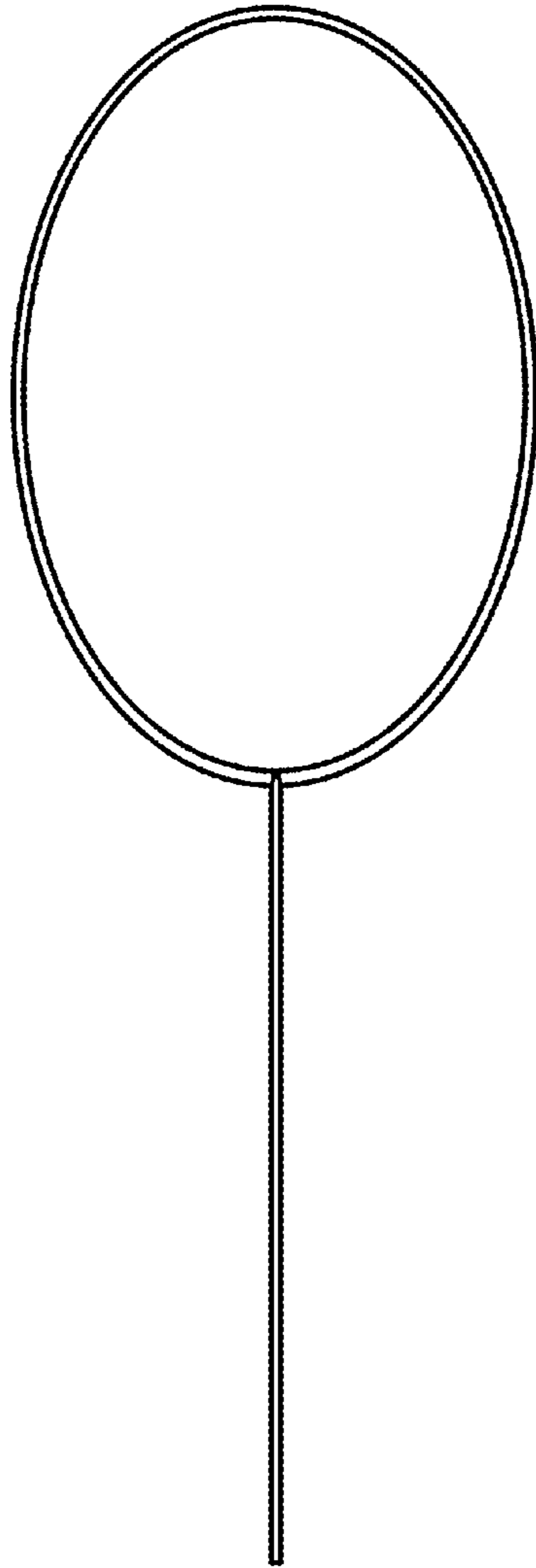

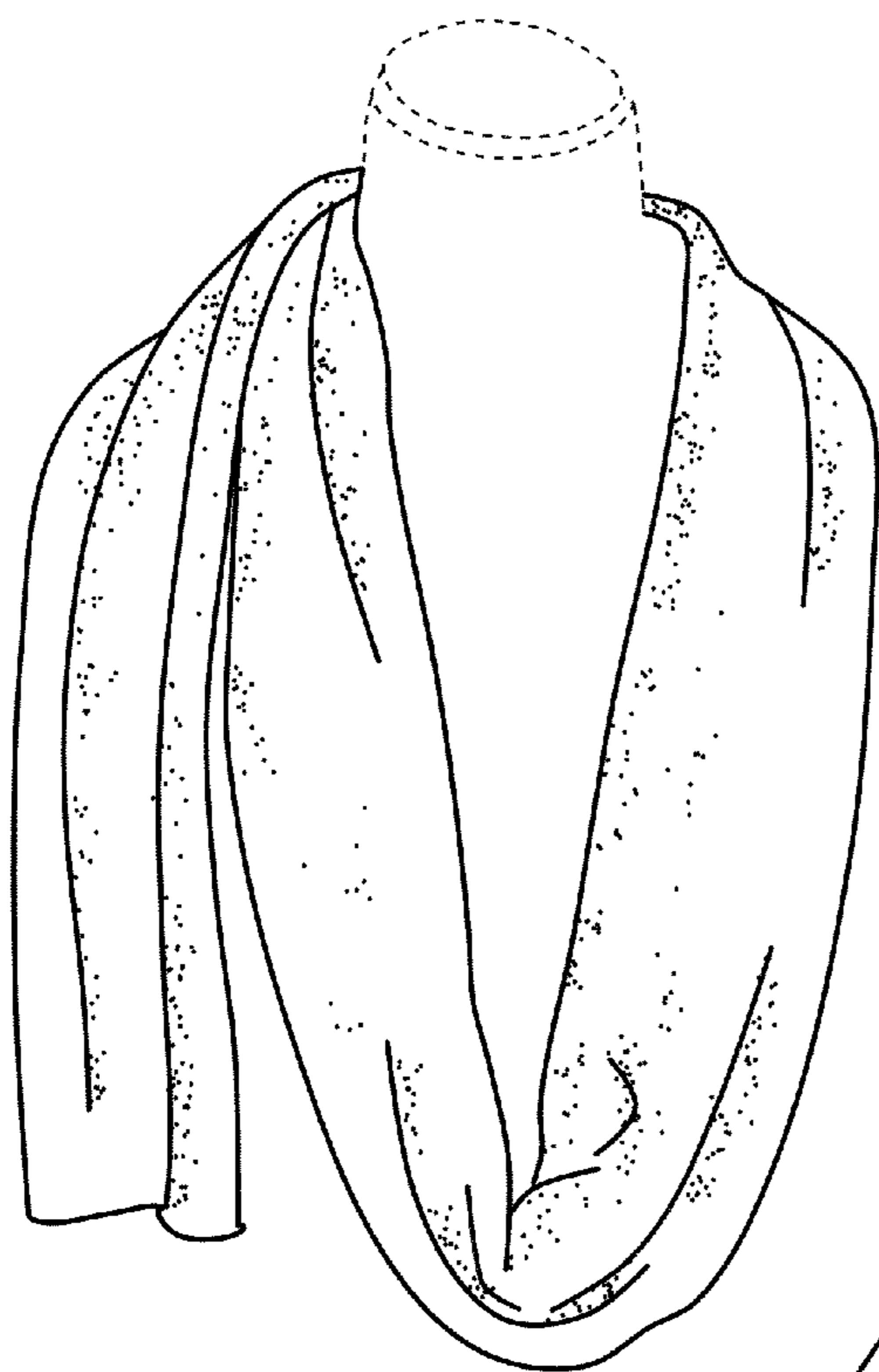

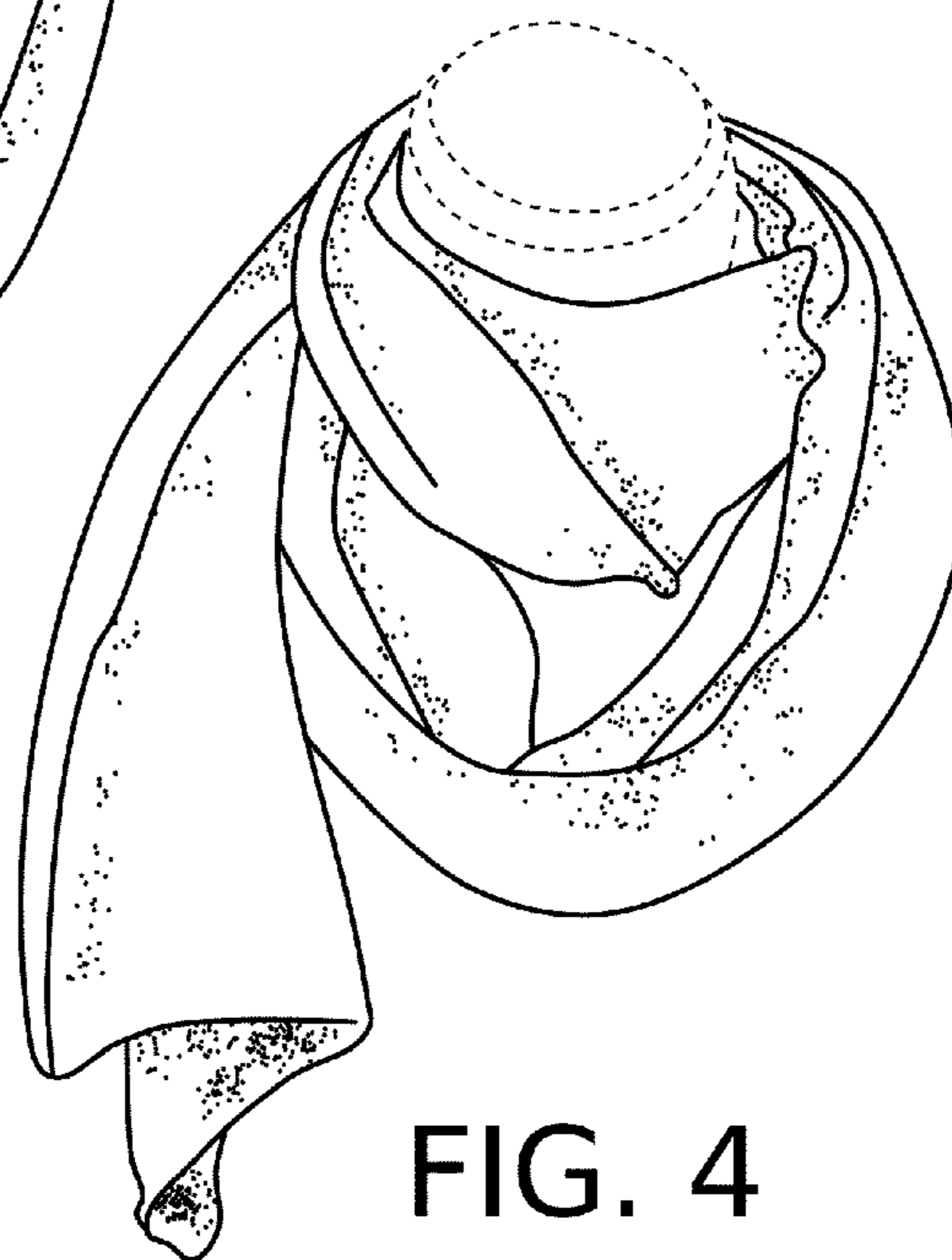
