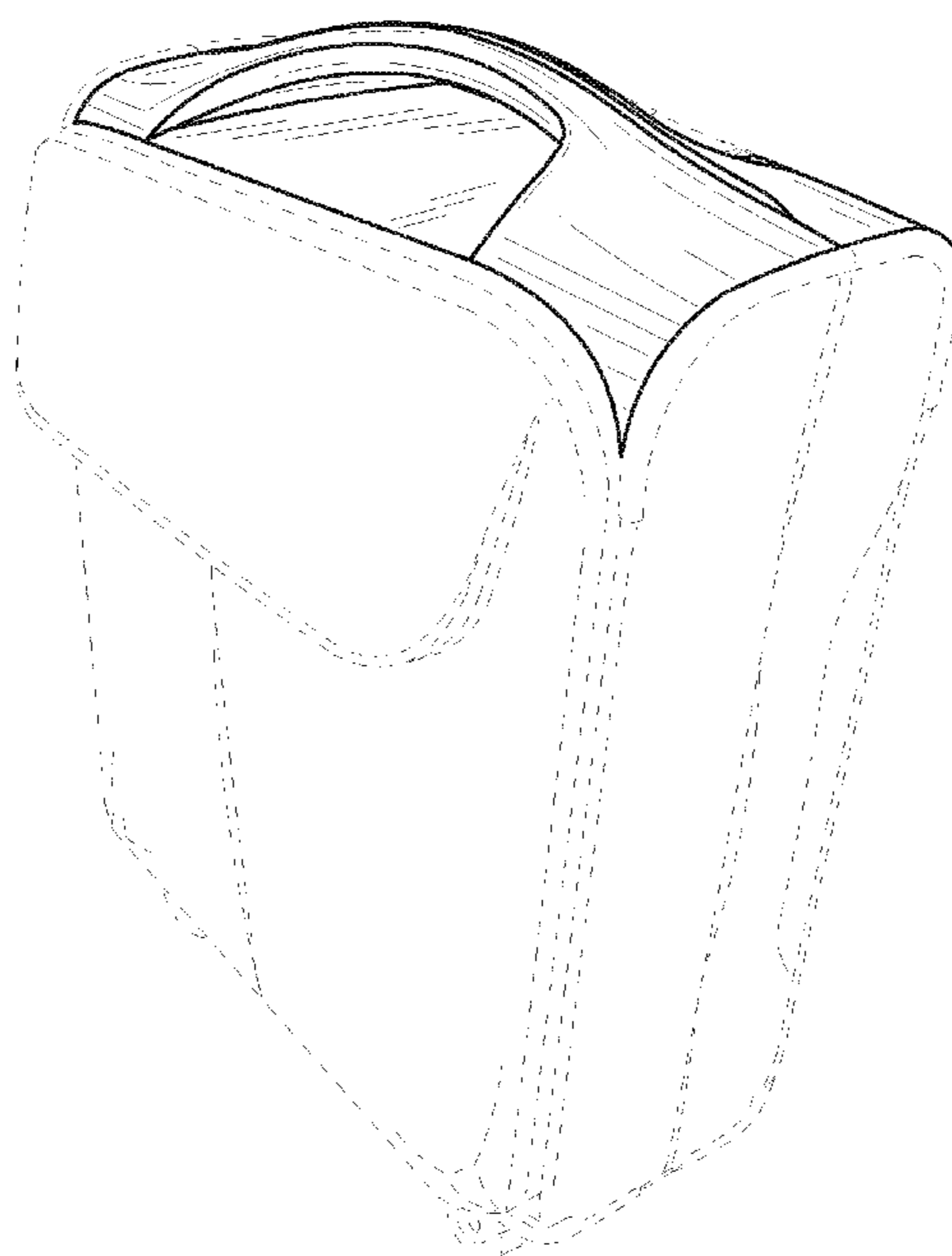
FIG. 1 shows a front perspective view of a luggage handle, the luggage handle shown on a luggage case;

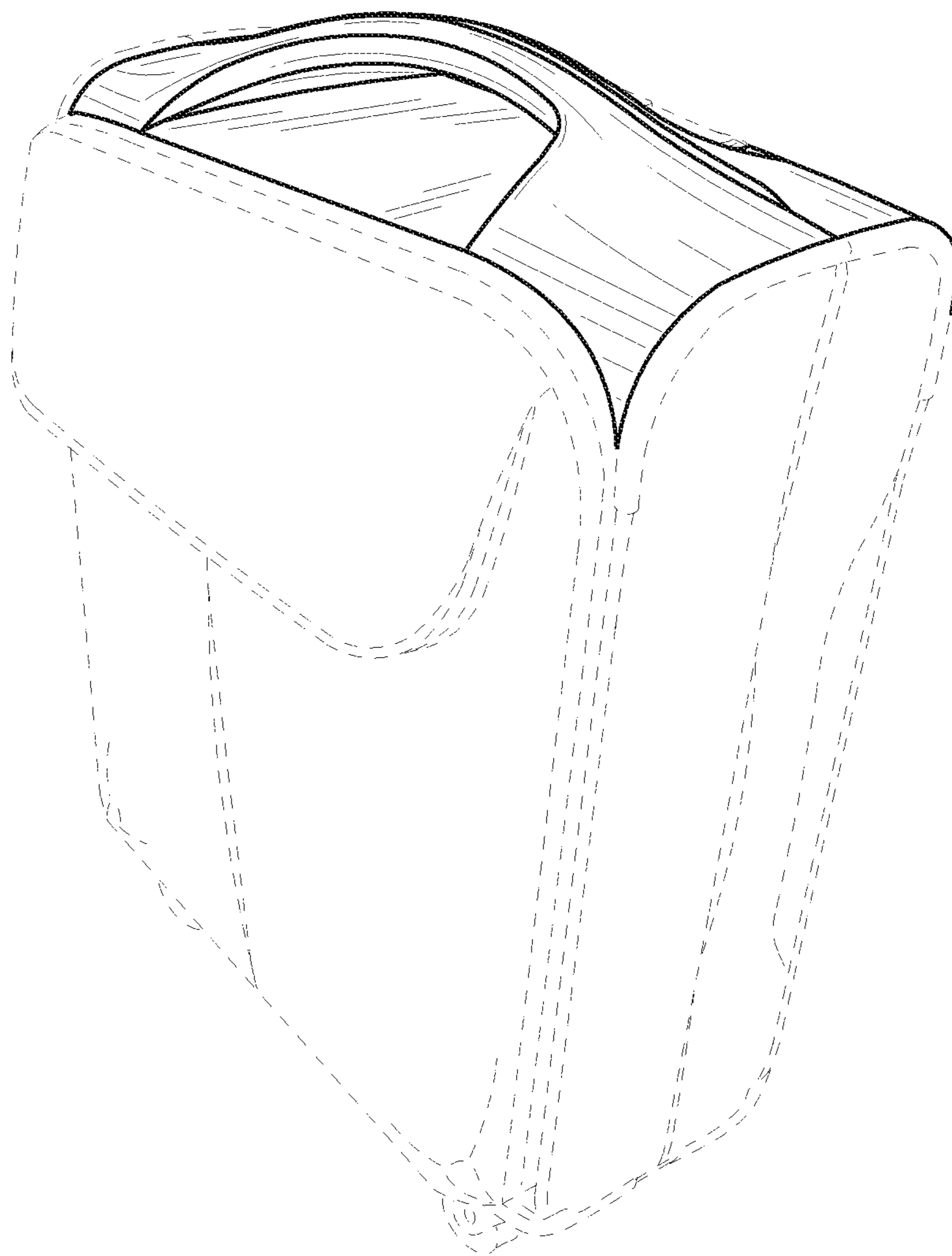

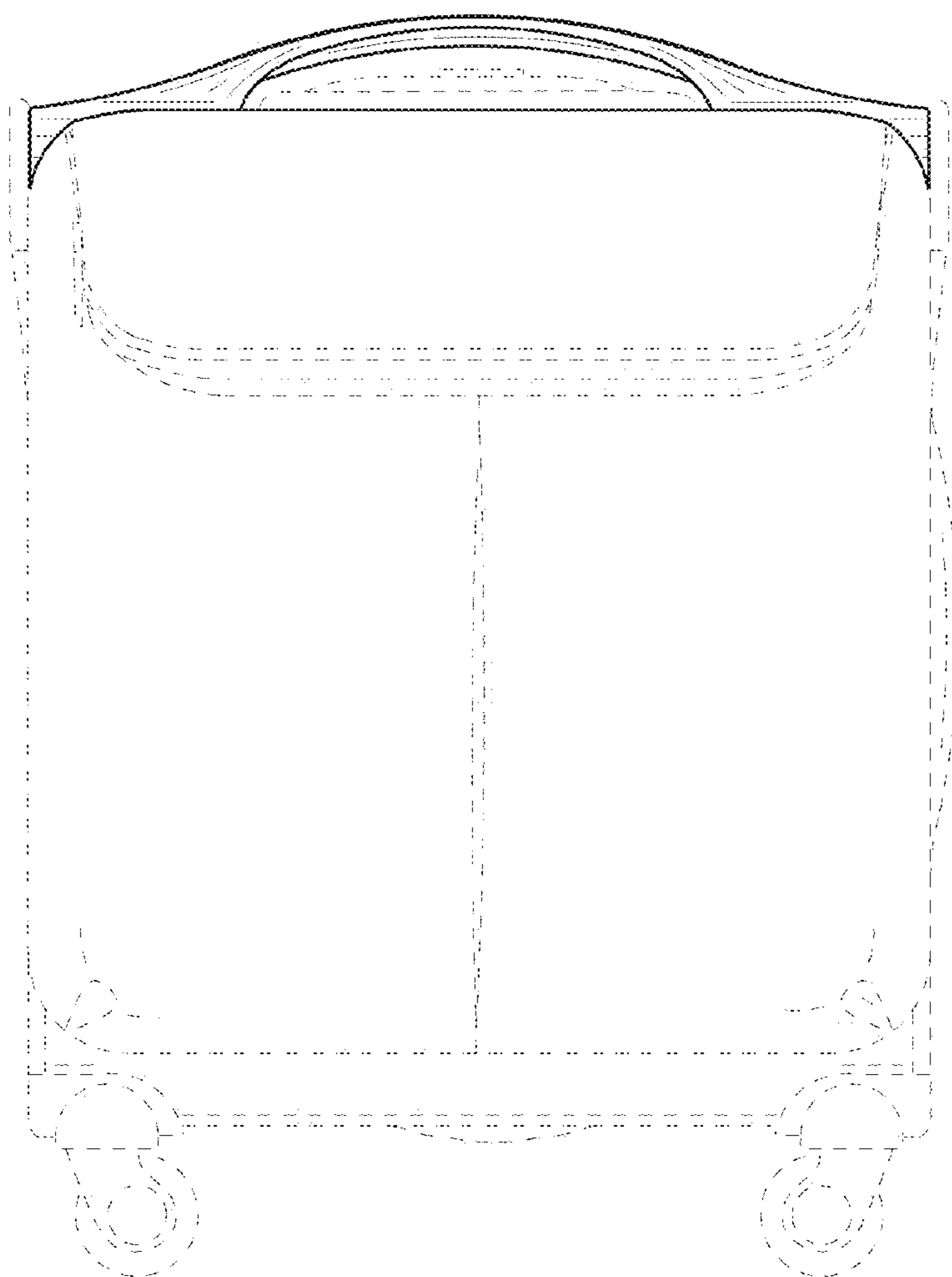

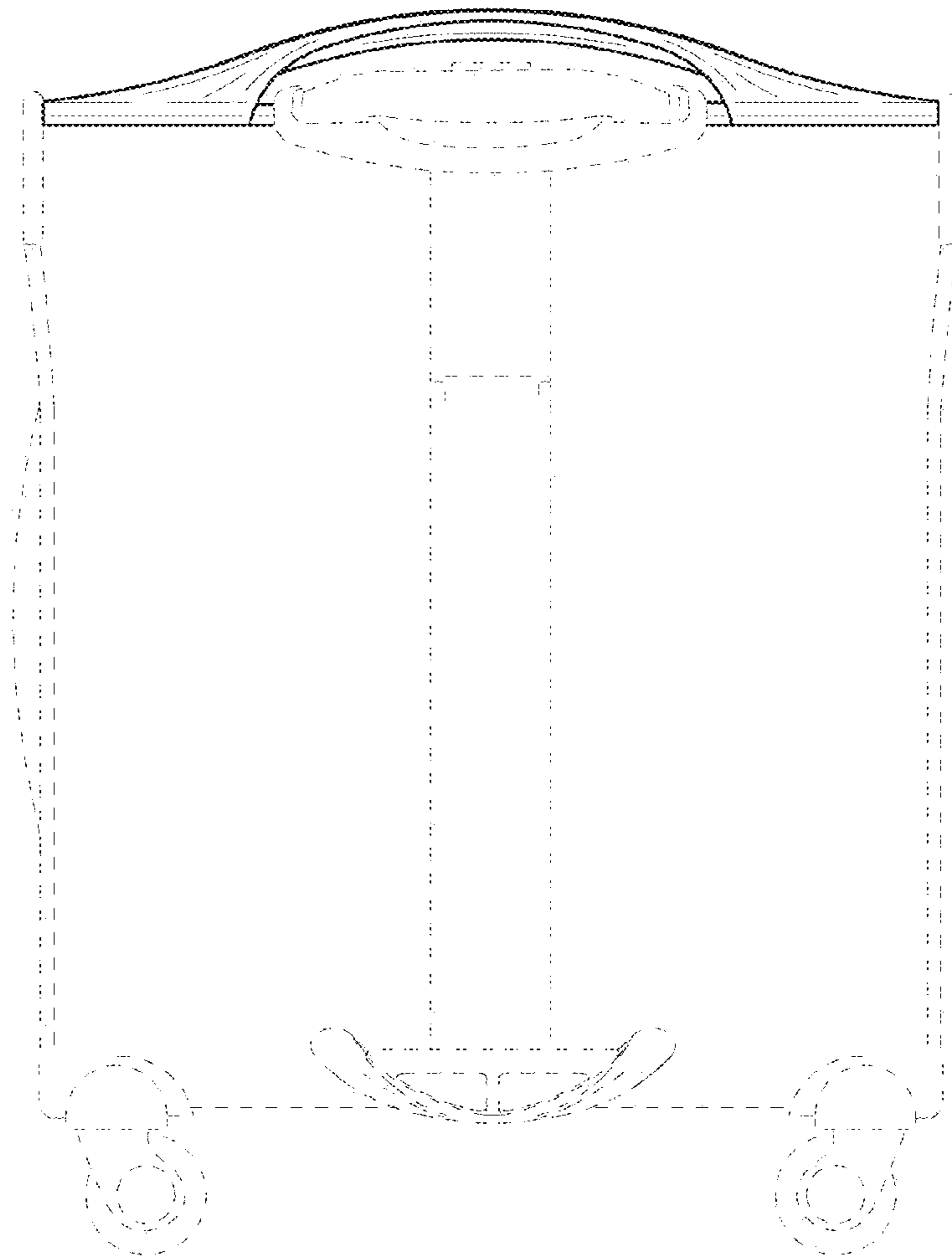

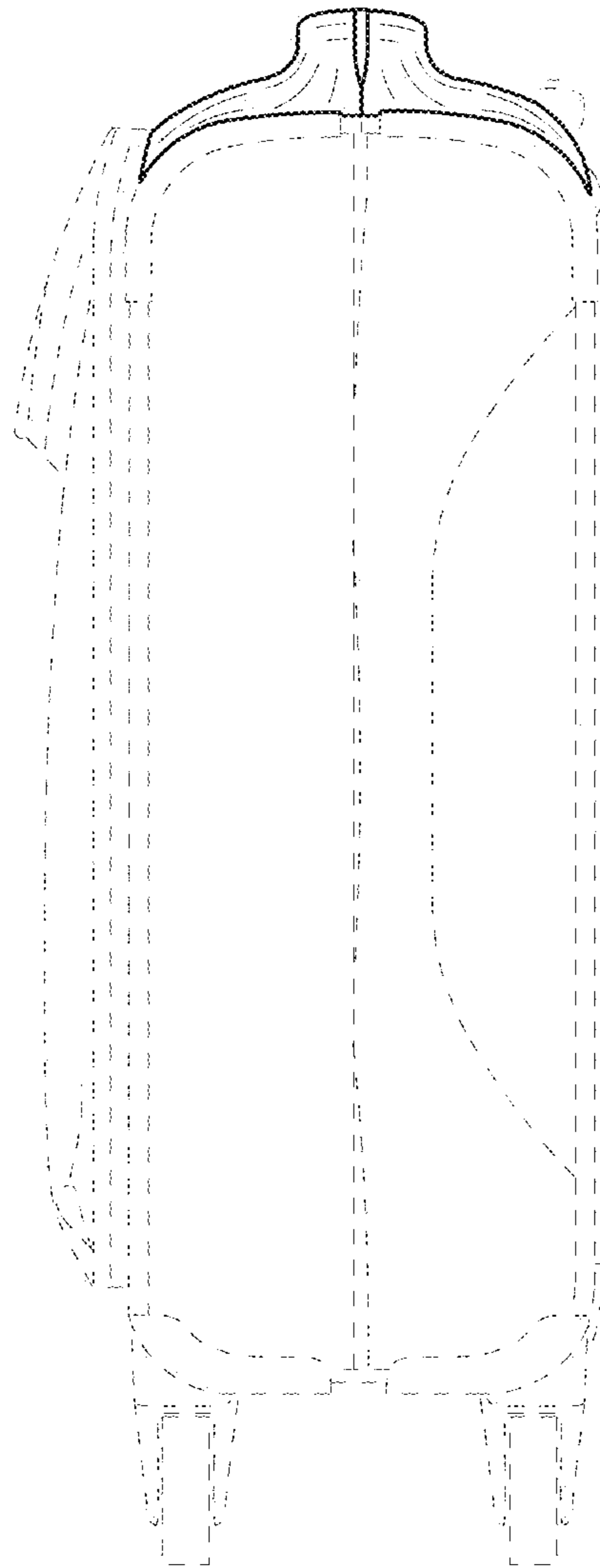

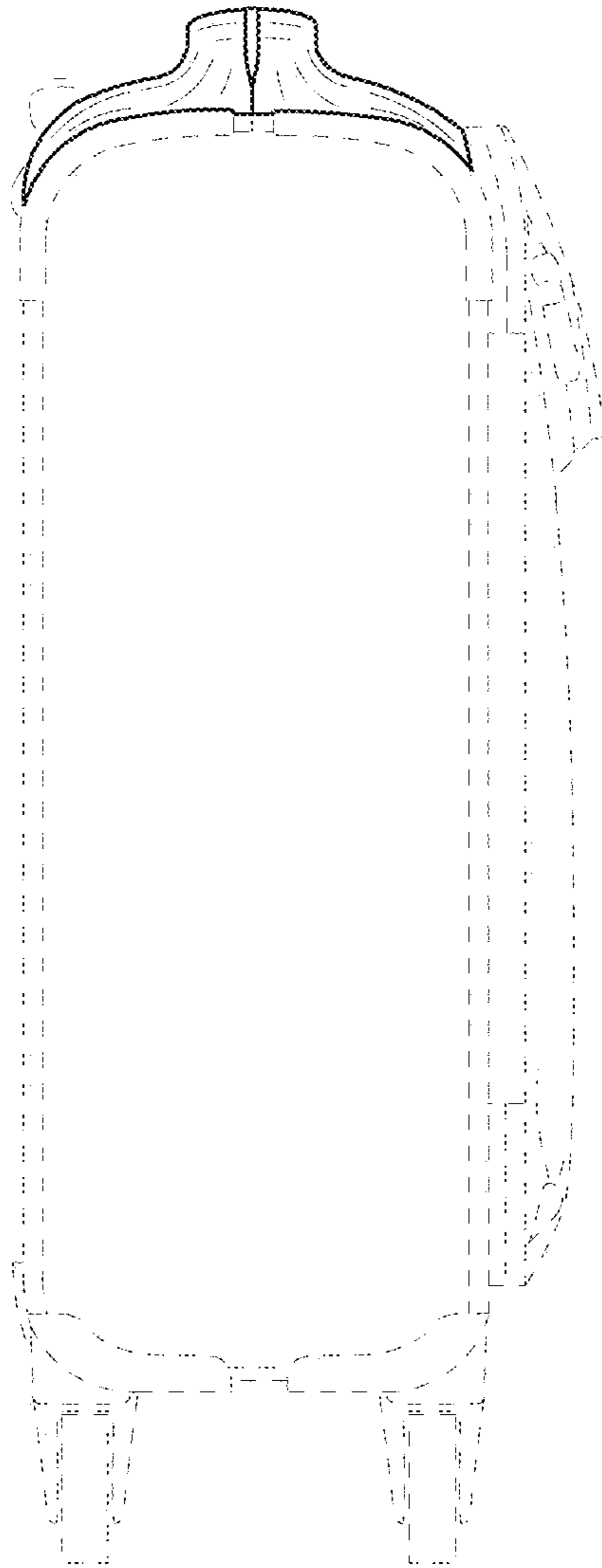

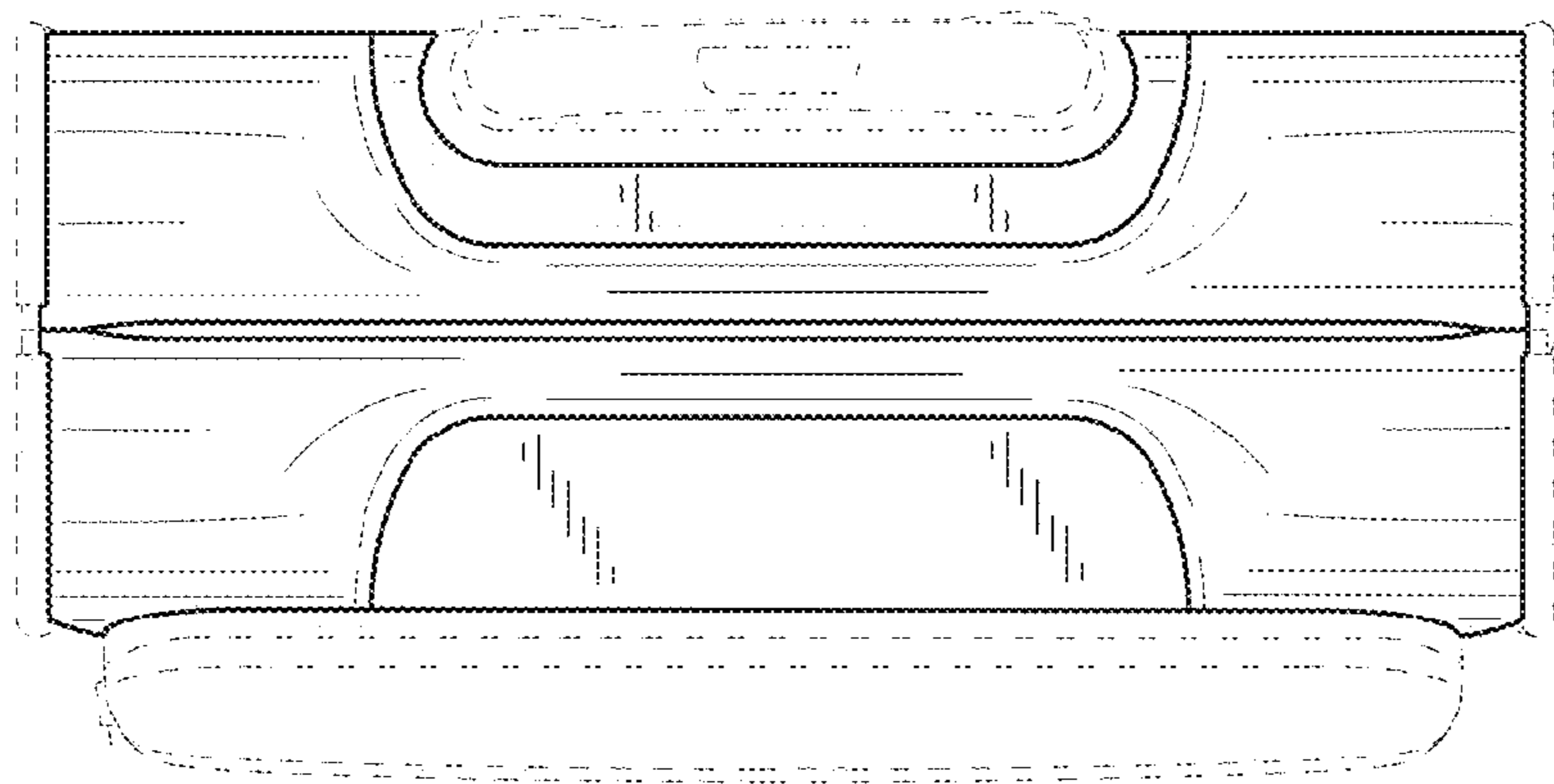

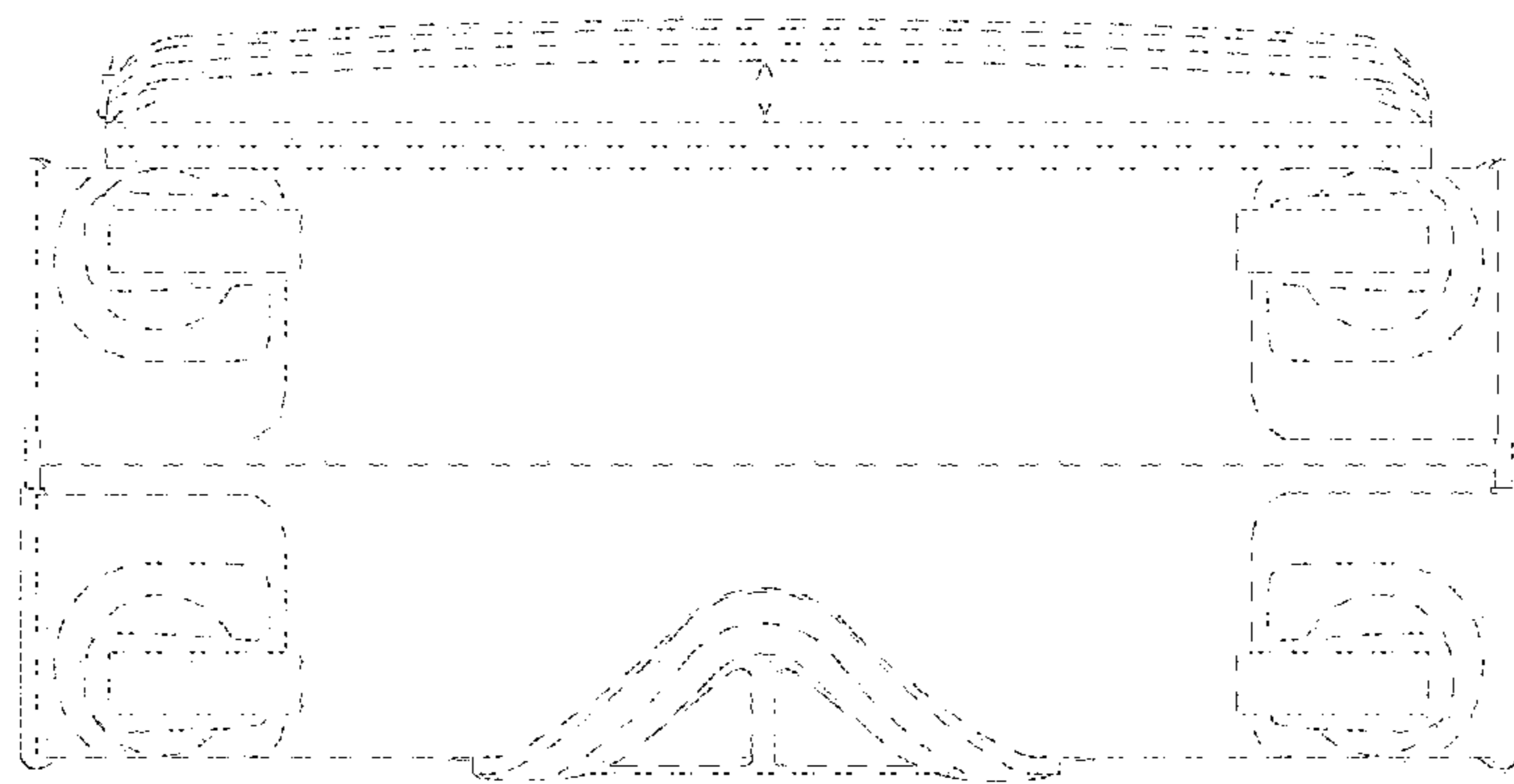
