(57) **CLAIM**

The ornamental design for a flexible sample of a countertop replica, substantially as shown and described.

DESCRIPTION

FIG. 1 is a front view of the flexible sample of a countertop replica, in which the flexible sample includes a veining pattern.

FIG. 2 is a top end view of the flexible sample of a countertop replica shown in FIG. 1.

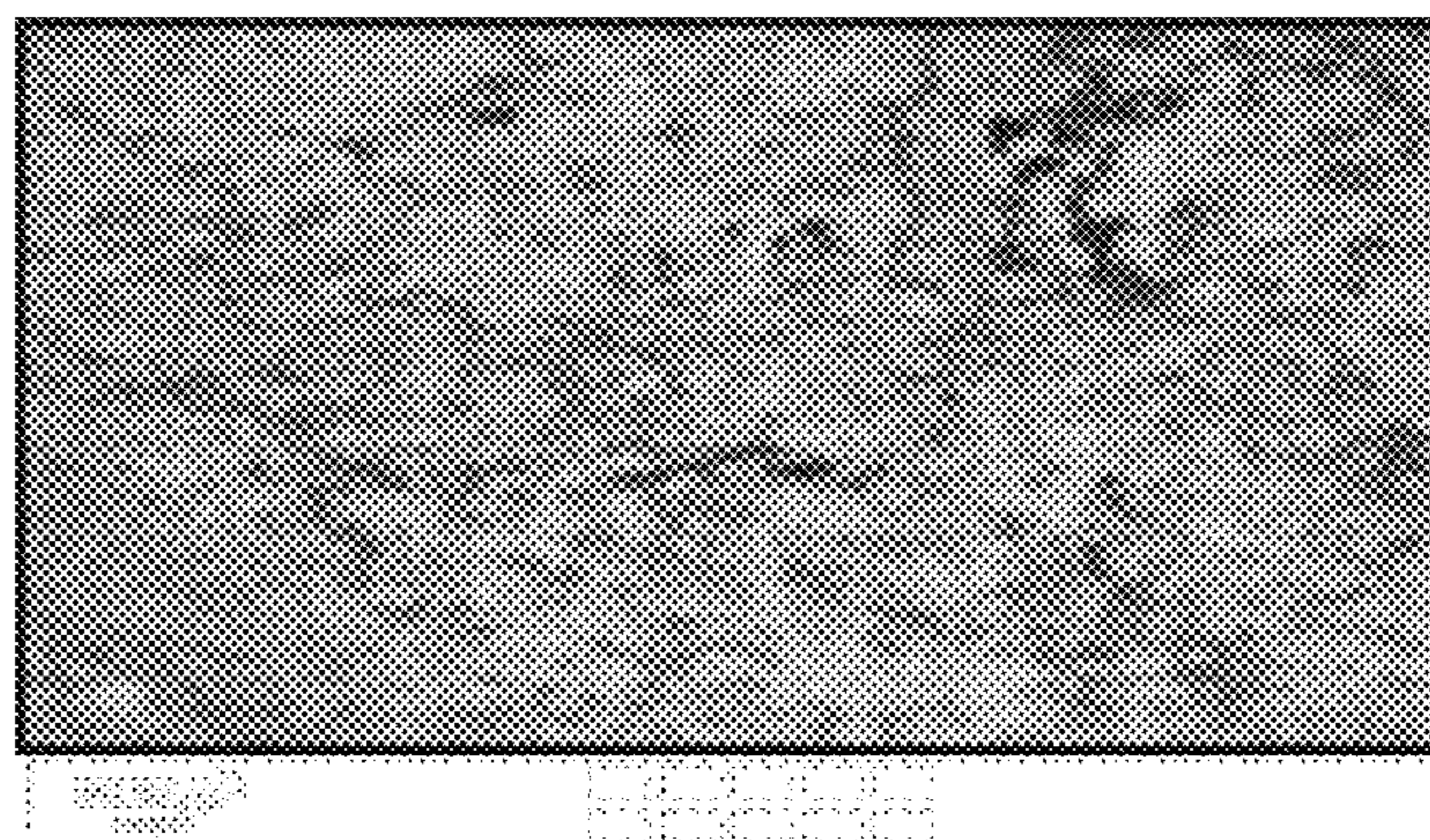
FIG. 3 is a lower end view of the flexible sample of a countertop replica shown in FIG. 1, taken from the lower end having the optional header.

FIG. 4 is a left side view of the flexible sample of a countertop replica shown in FIG. 1; and,

FIG. 5 is a right side view of the flexible sample of a countertop replica shown in FIG. 1.

The broken lines shown are included for the purpose of illustrating portions of the flexible sample of a countertop replica that form no part of the claimed design.

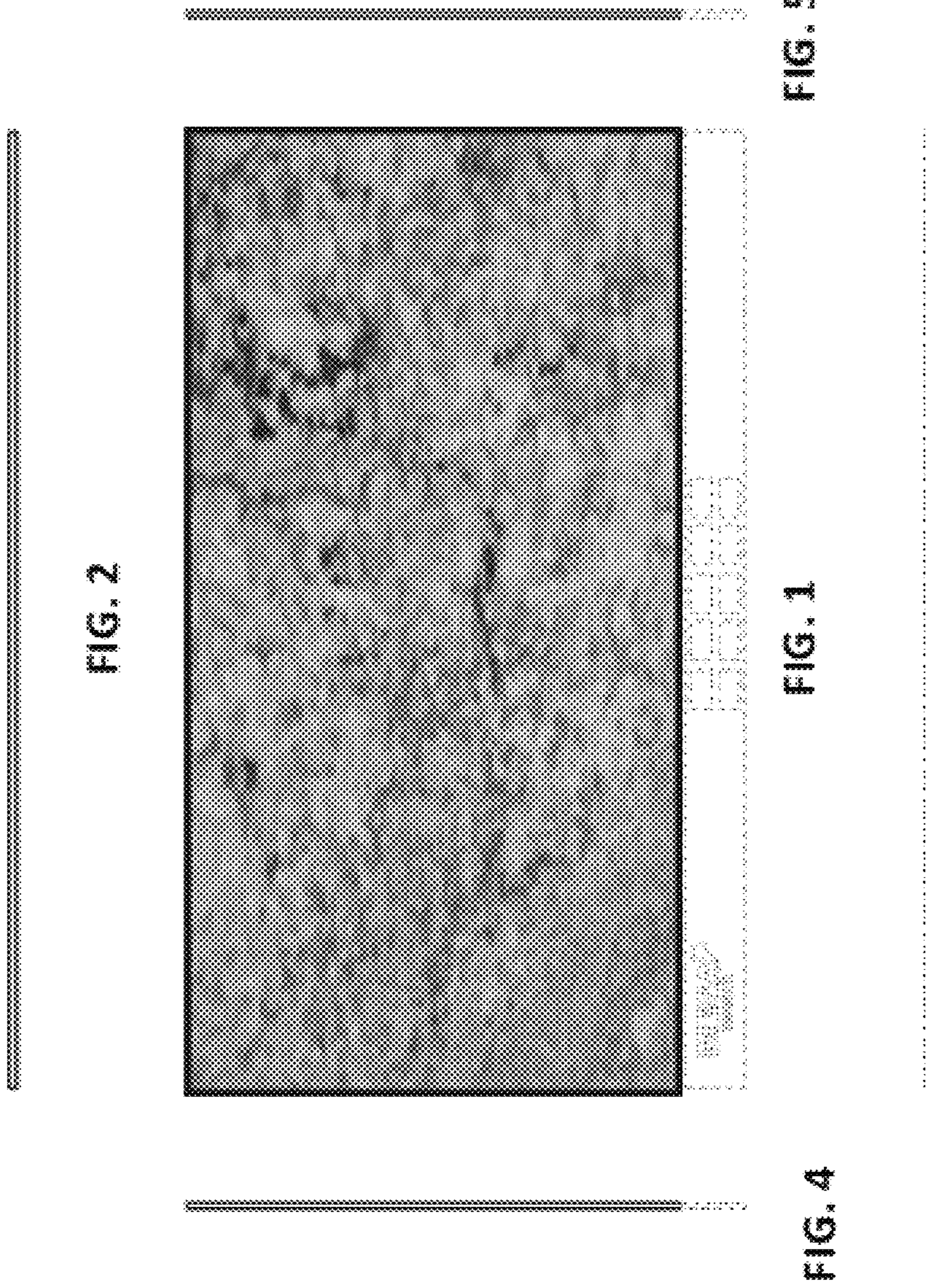
