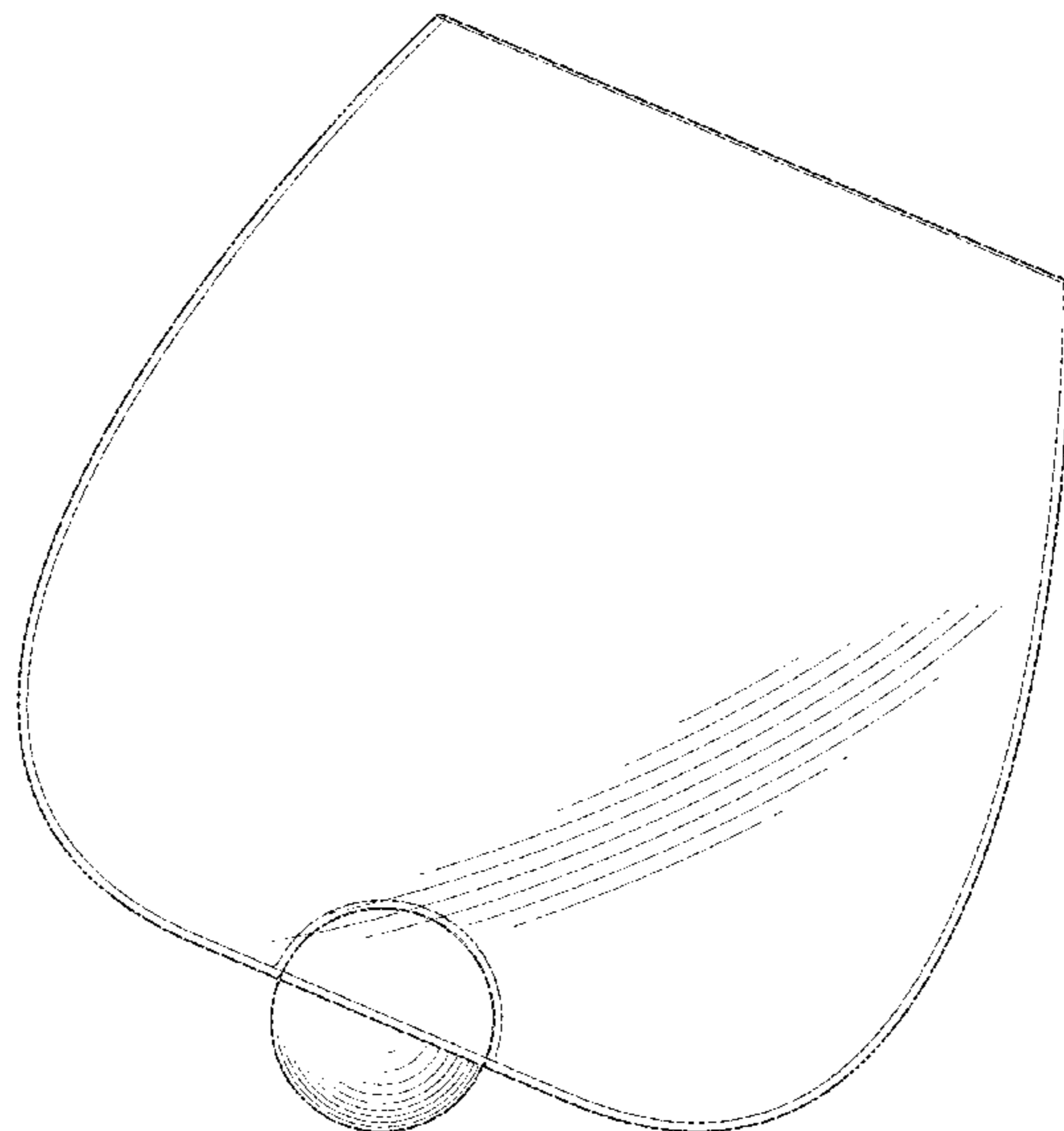

DESCRIPTION

FIG. 1 is a perspective view of a wine according to the present invention having a ball portion in a lower portion of the wine glass.
FIG. 2 is a side view of the wine glass illustrated in FIG. 1.
FIG. 3 is a bottom perspective view of the wine glass illustrated in FIG. 1.
FIG. 4 is a top perspective view of the wine glass illustrated in FIG. 1.
FIG. 5 is a side and top perspective view of the wine glass illustrated in FIG. 1; and,
FIG. 6 is side and bottom perspective view of the wine glass illustrated in FIG. 1.

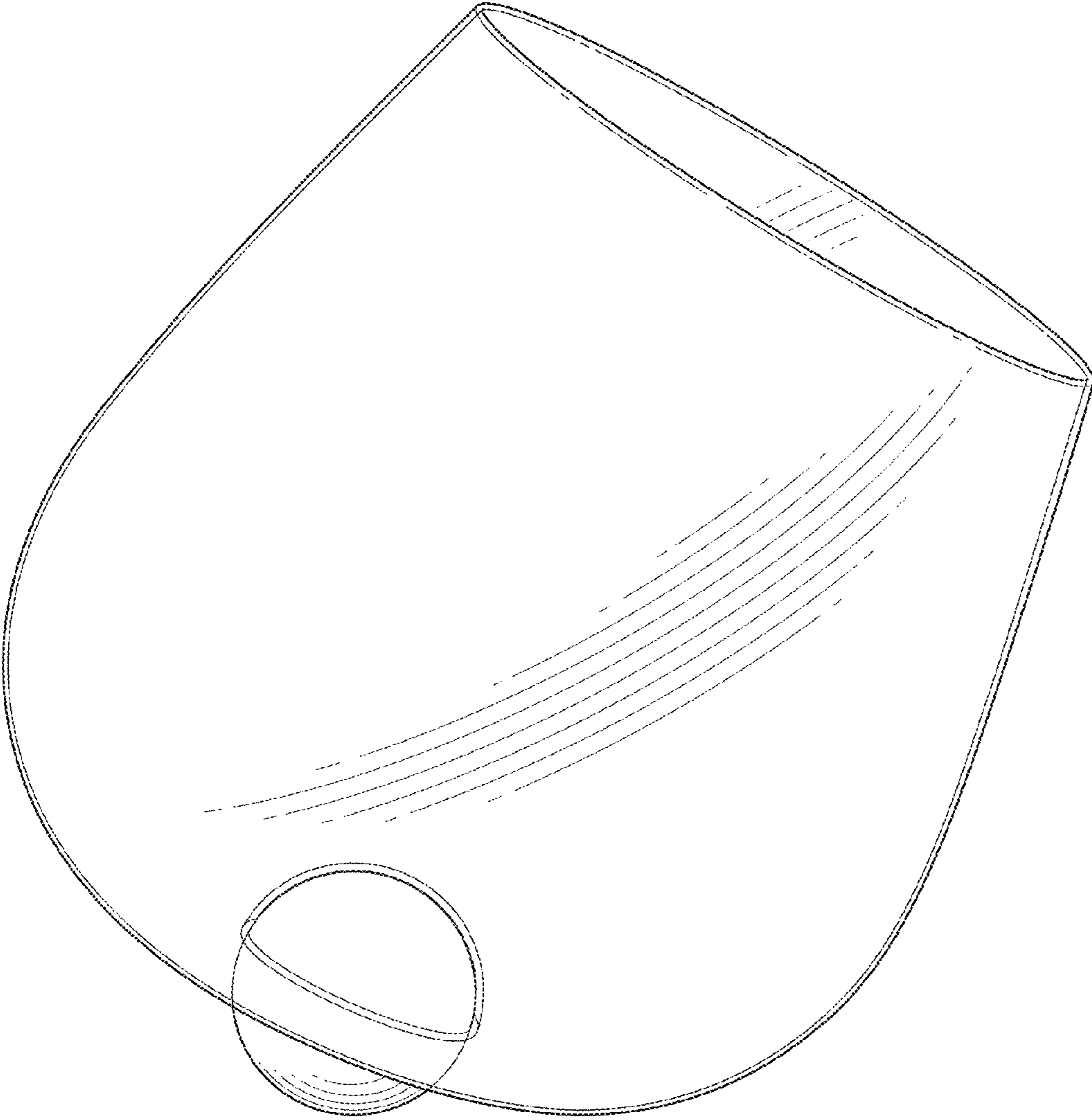

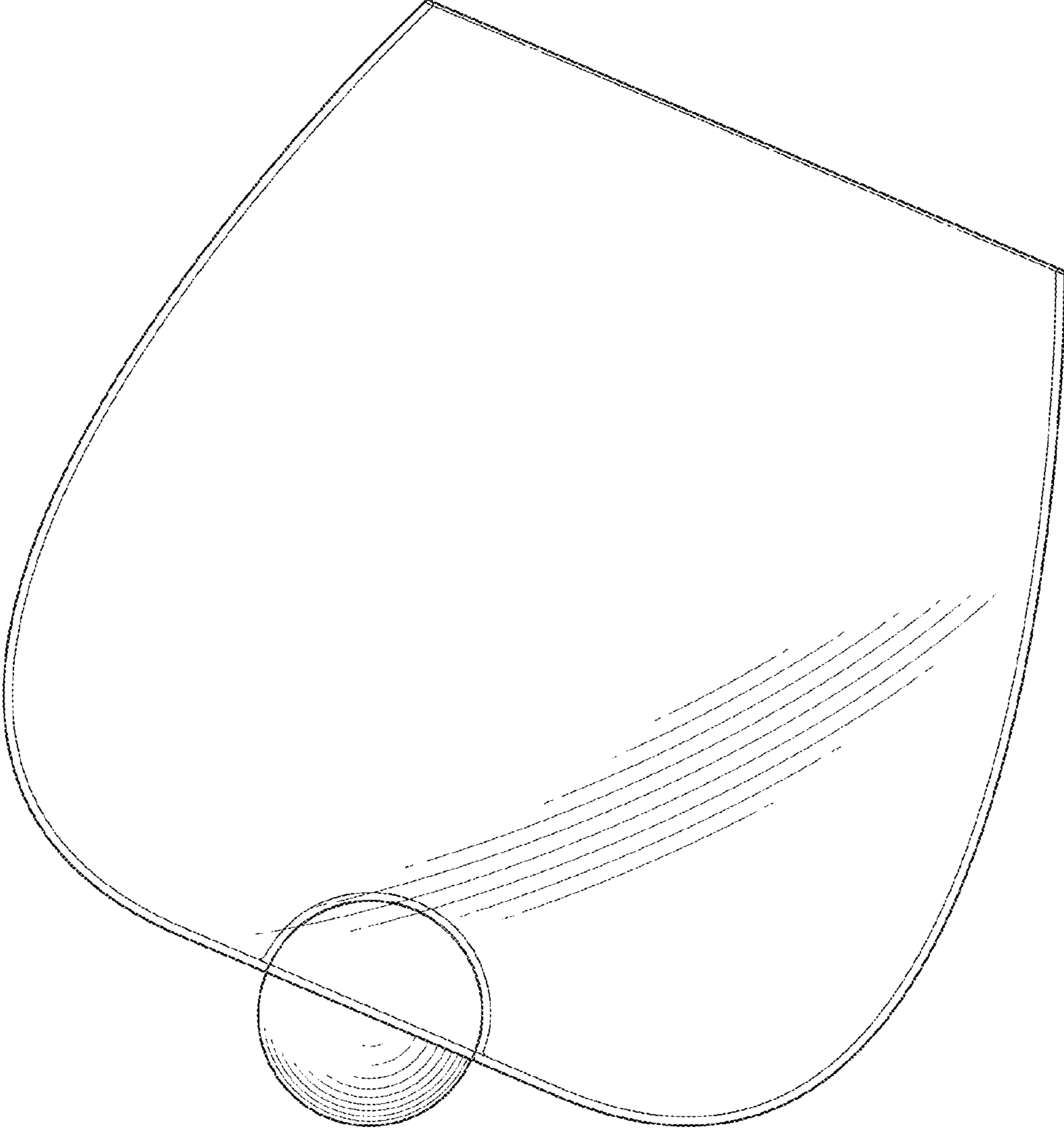

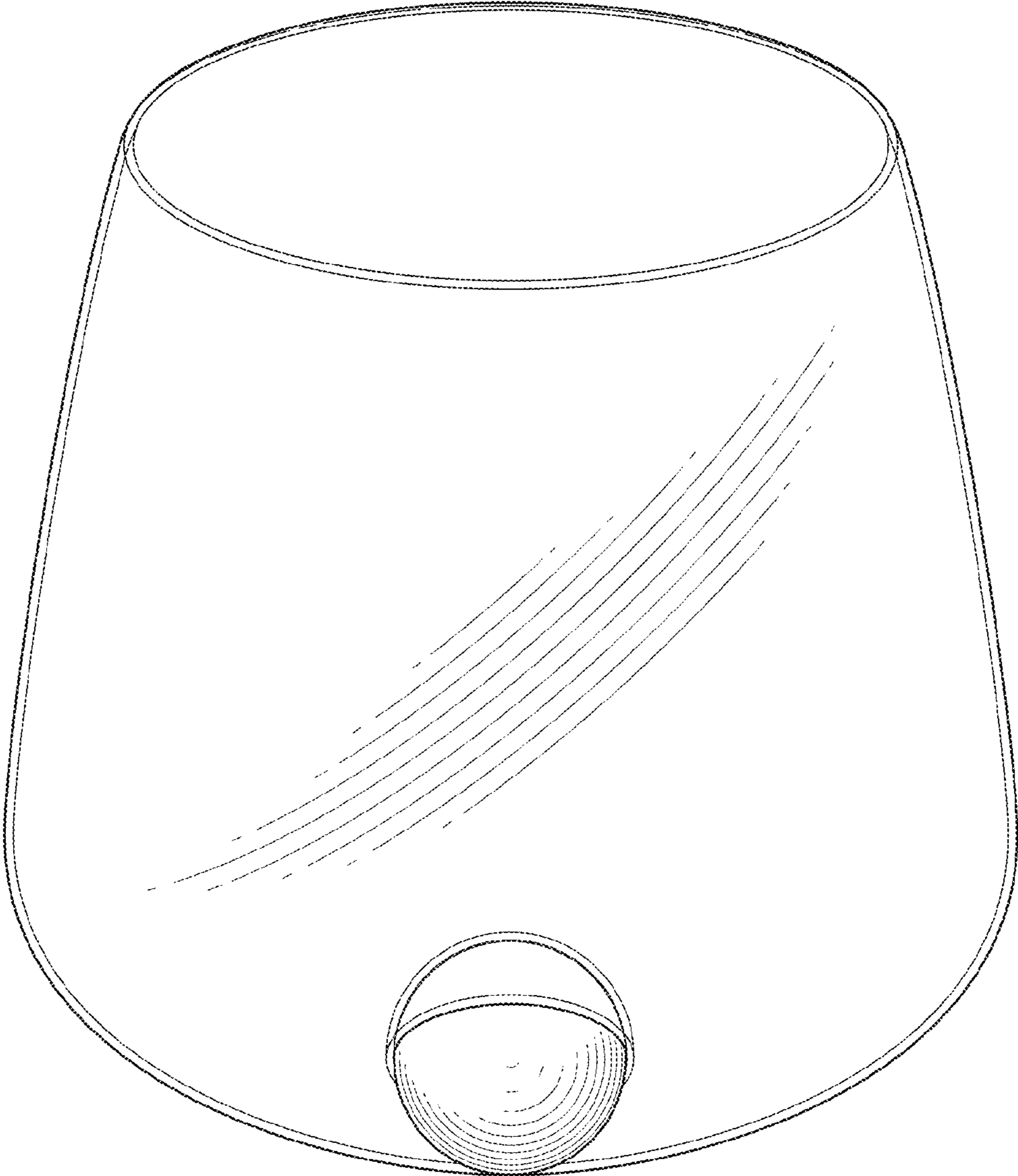

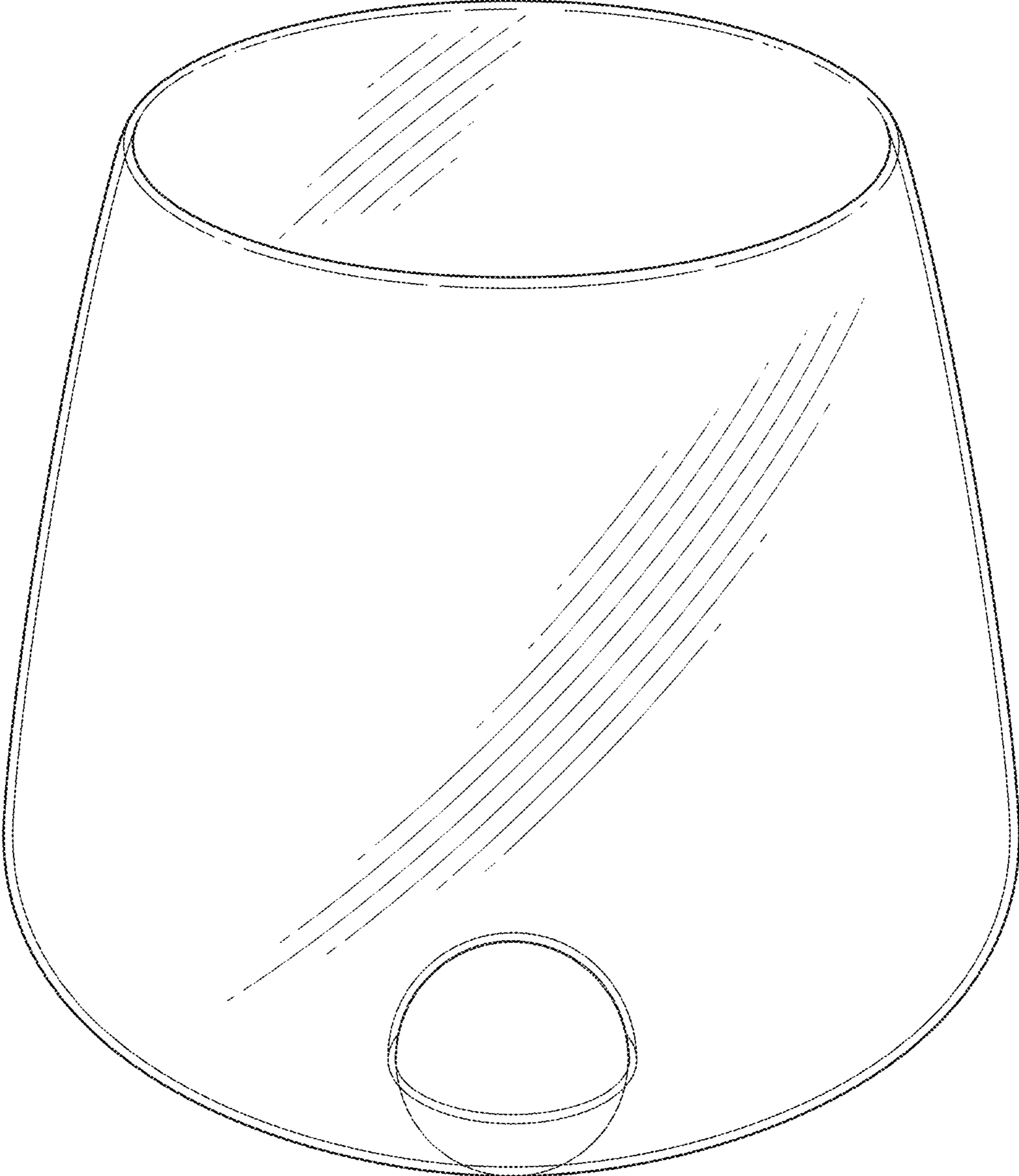

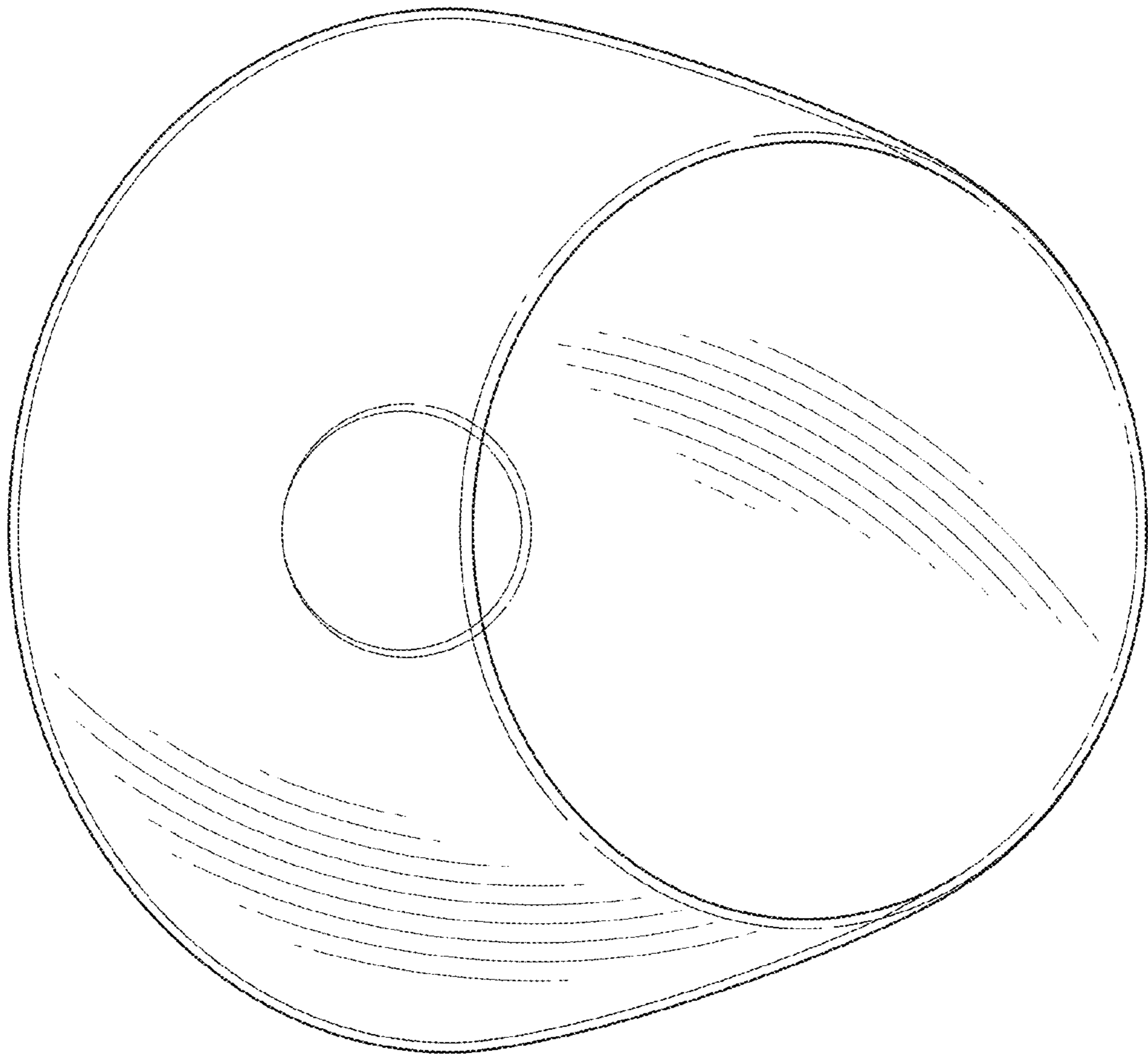

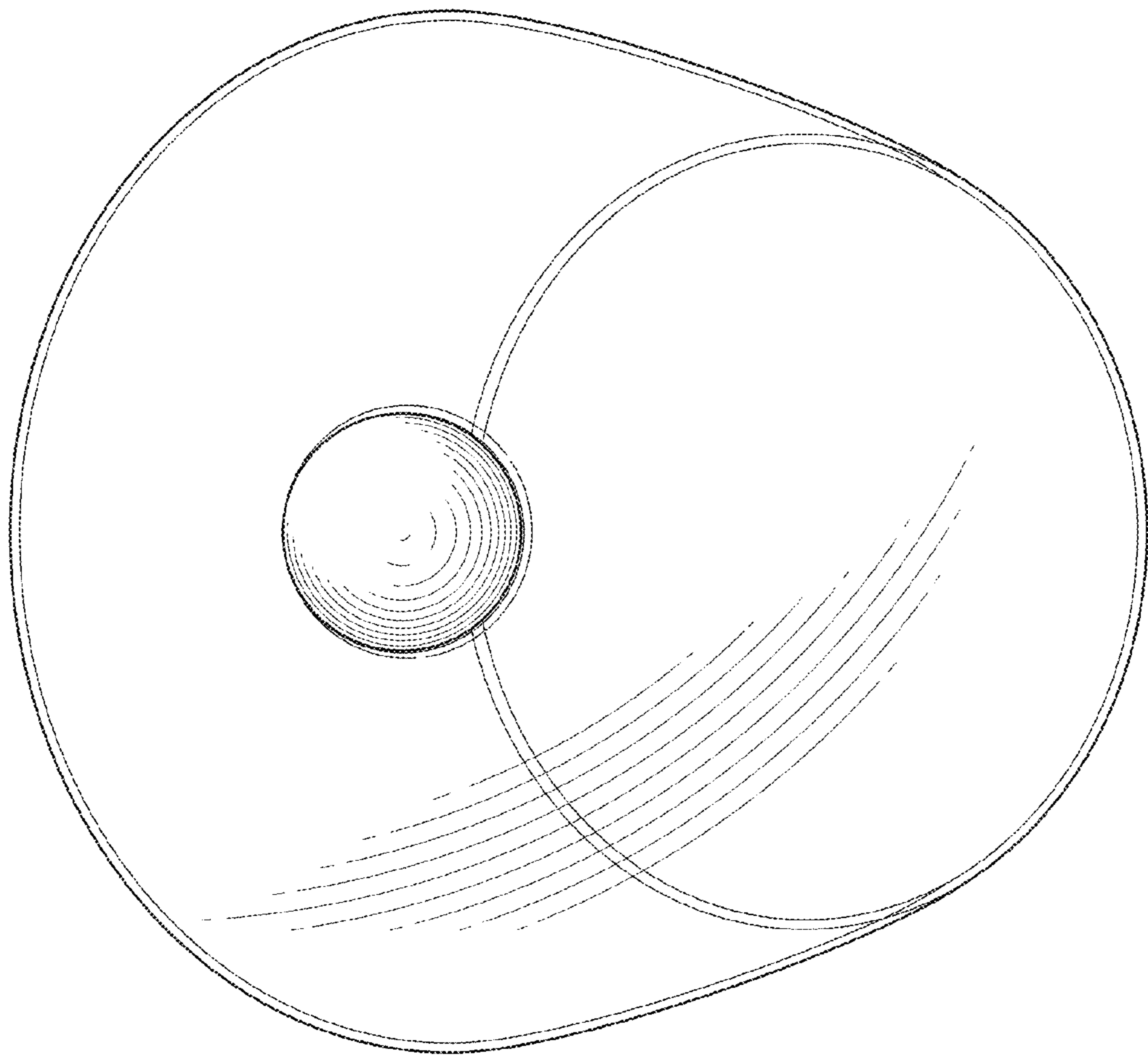
