(57) **CLAIM**

The ornamental design for a jewelry hangtag, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a jewelry hangtag according to the present invention;

FIG. 2 is a front perspective view of the jewelry hangtag of FIG. 1, with the top portion of the hang tag folded behind the bottom portion of the hang tag;

FIG. 3 is a first side view of the jewelry hangtag of FIG. 1;

FIG. 4 is a front view of the jewelry hangtag of FIG. 1;

FIG. 5 is a second side view of the jewelry hangtag of FIG. 1;

FIG. 6 is a rear view of the jewelry hangtag of FIG. 1;

FIG. 7 is a top view of the jewelry hangtag of FIG. 1;

FIG. 8 is a bottom view of the jewelry hangtag of FIG. 1;

FIG. 9 is a front perspective view of a jewelry hangtag according to the present invention;

FIG. 10 is a front perspective view of the jewelry hangtag of FIG. 9, with the top portion of the hang tag folded behind the bottom portion of the hang tag;

FIG. 13 is a second side view of the jewelry hangtag of FIG. 9;

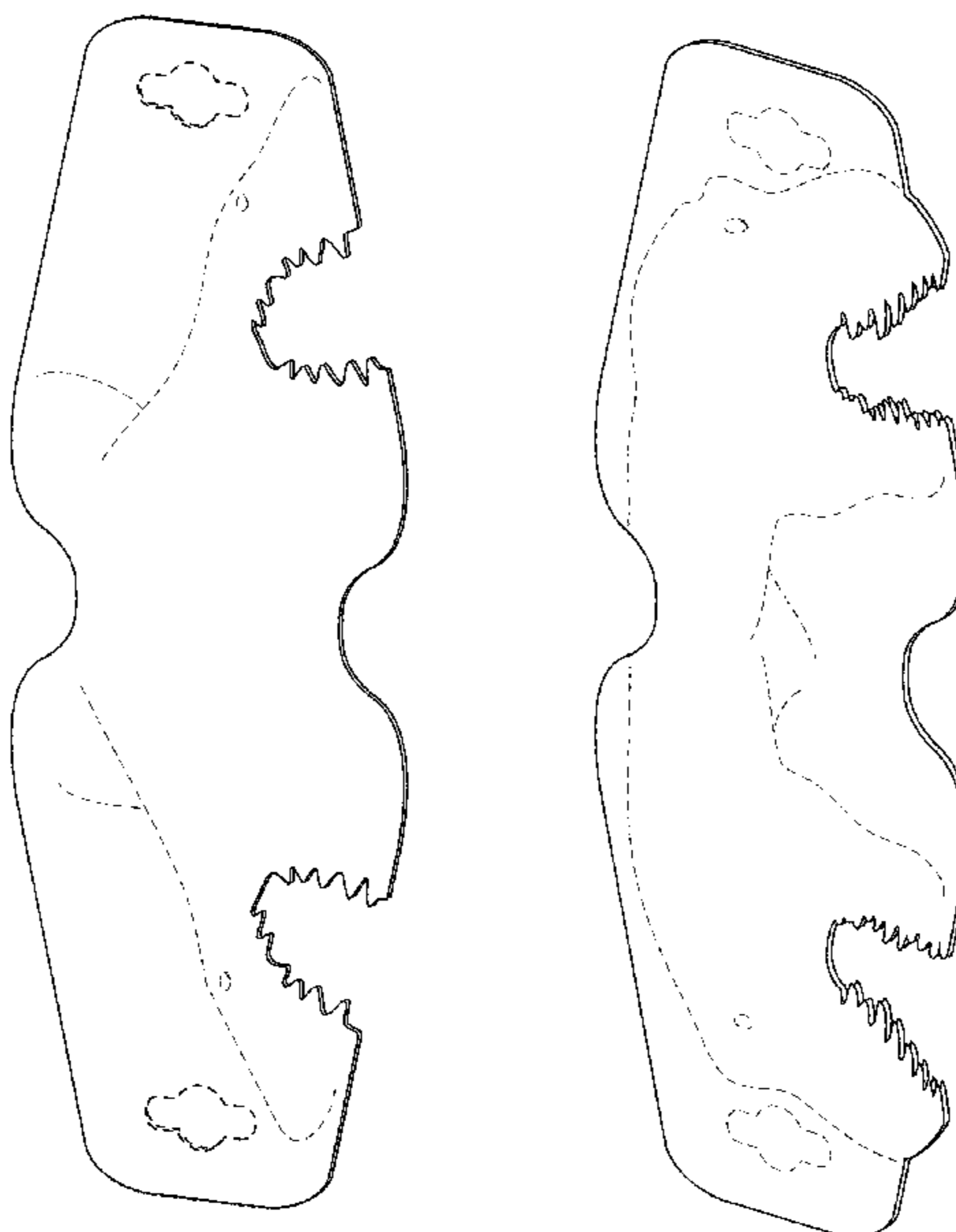
FIG. 14 is a rear view of the jewelry hangtag of FIG. 9;

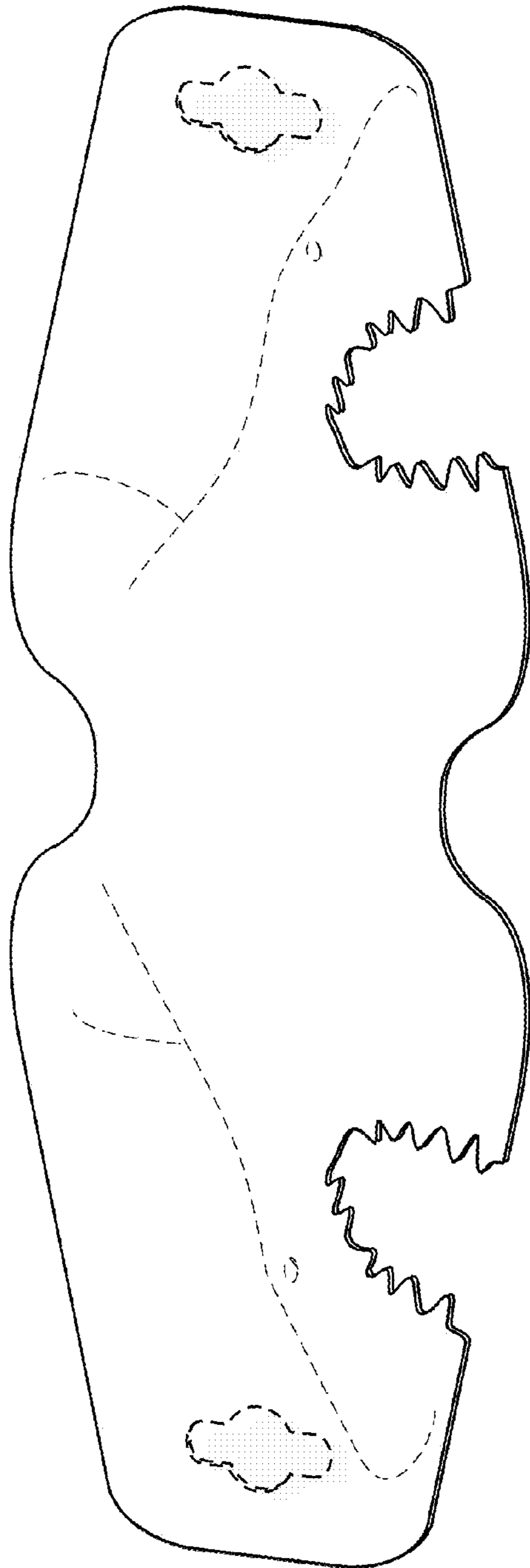

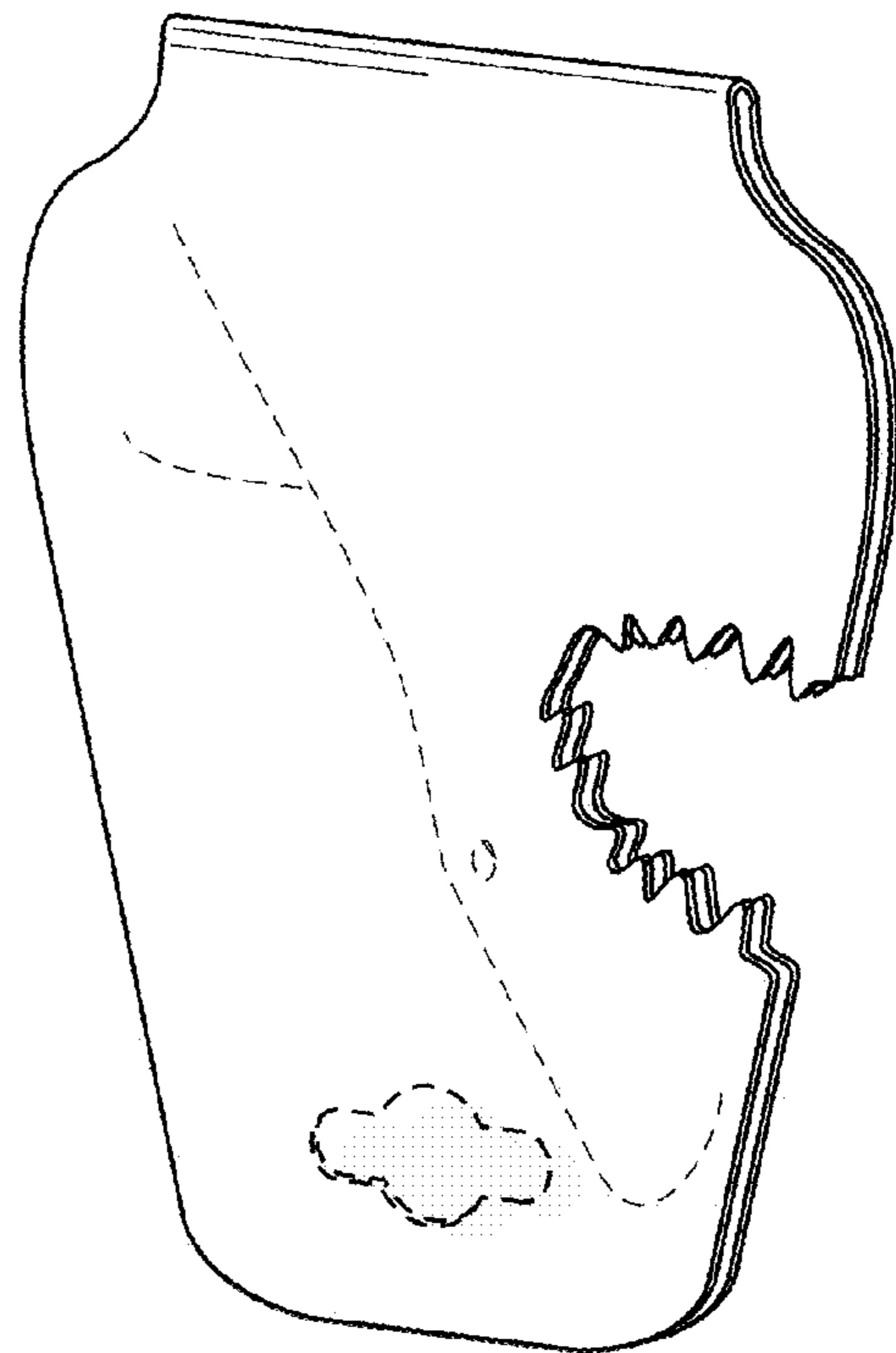

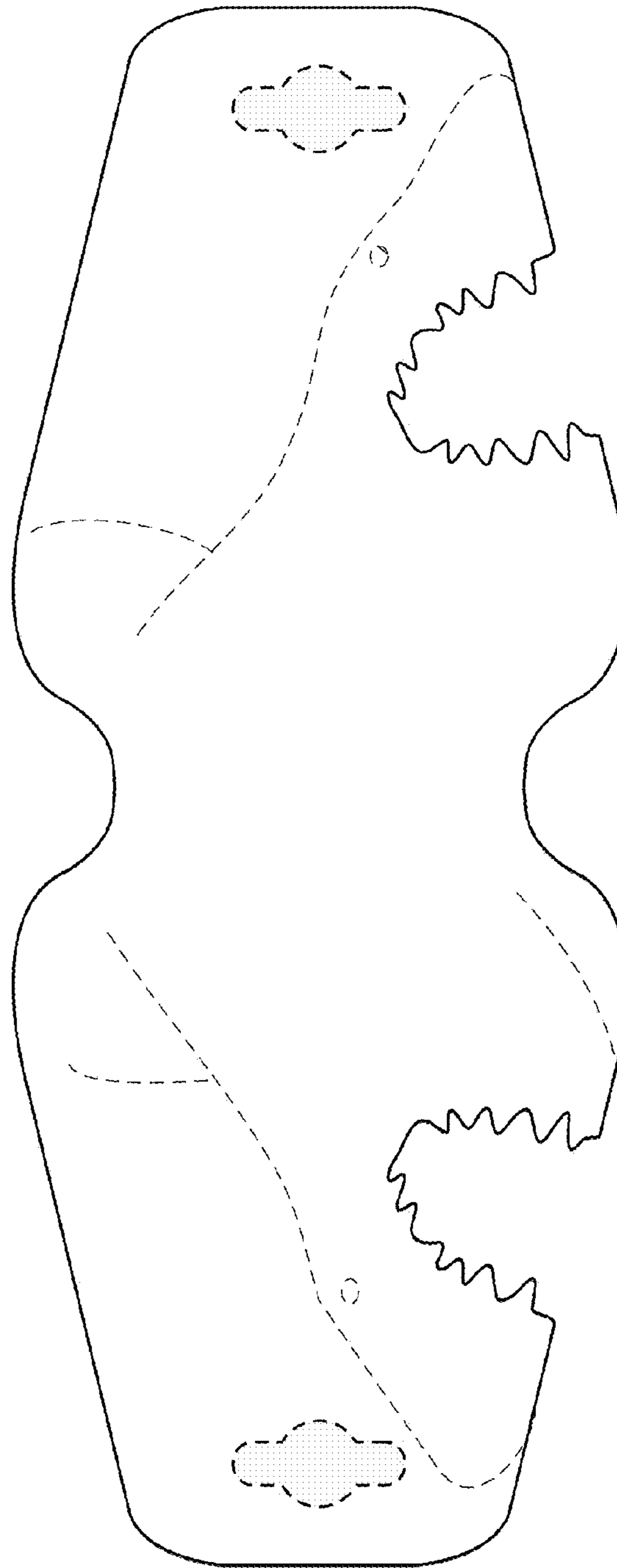

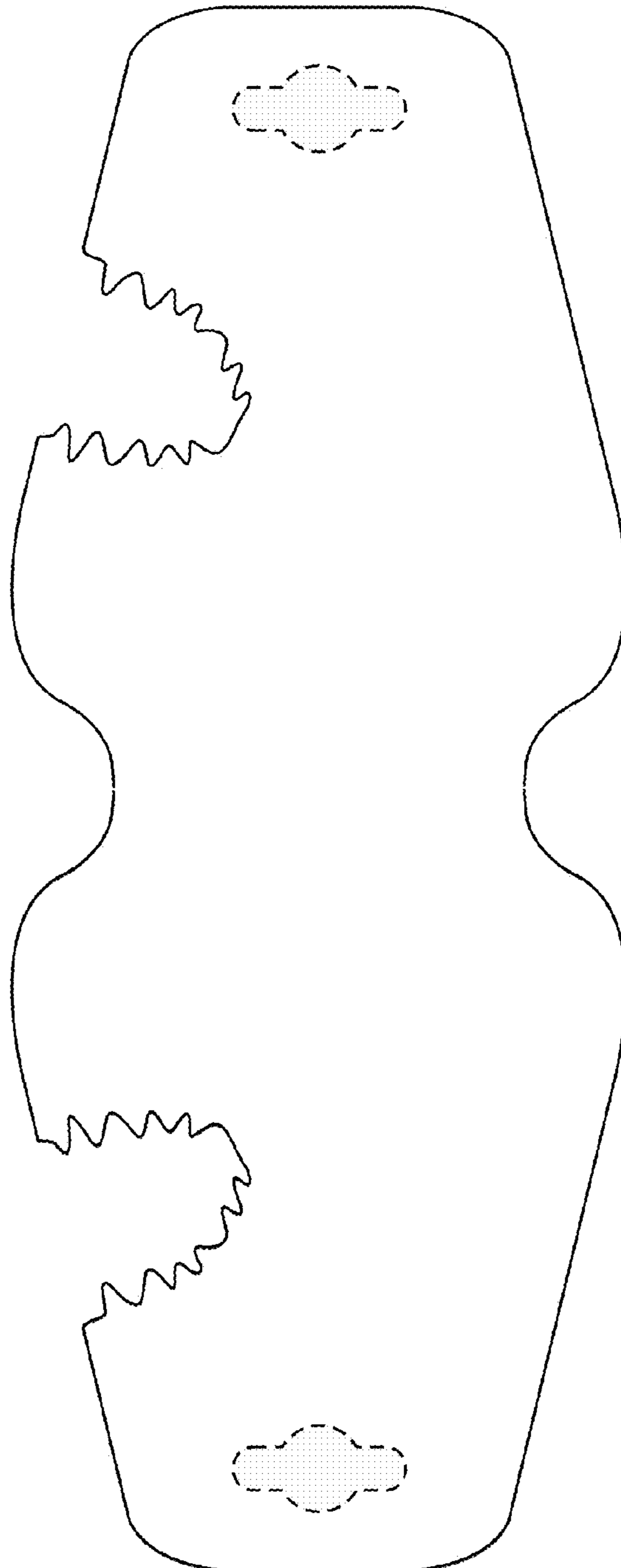

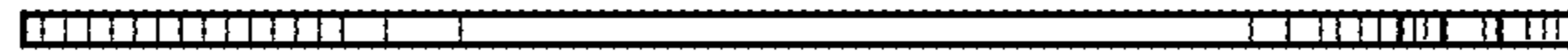

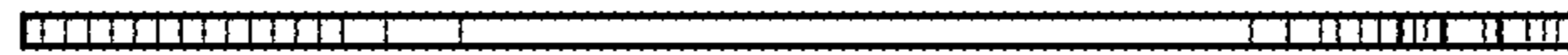

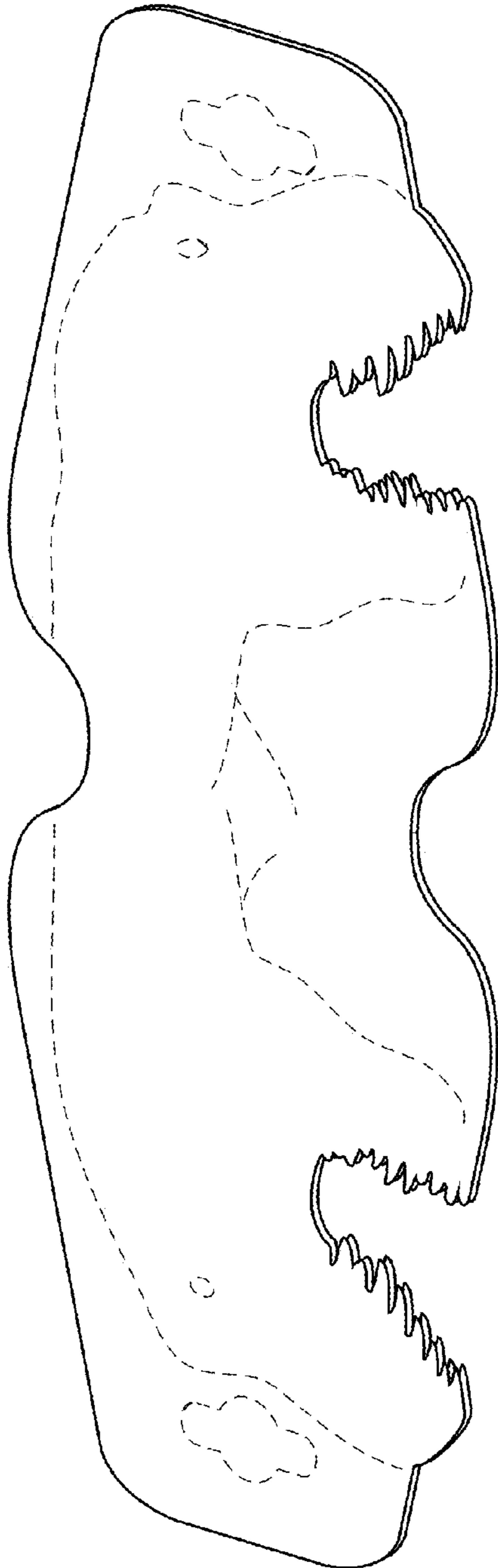

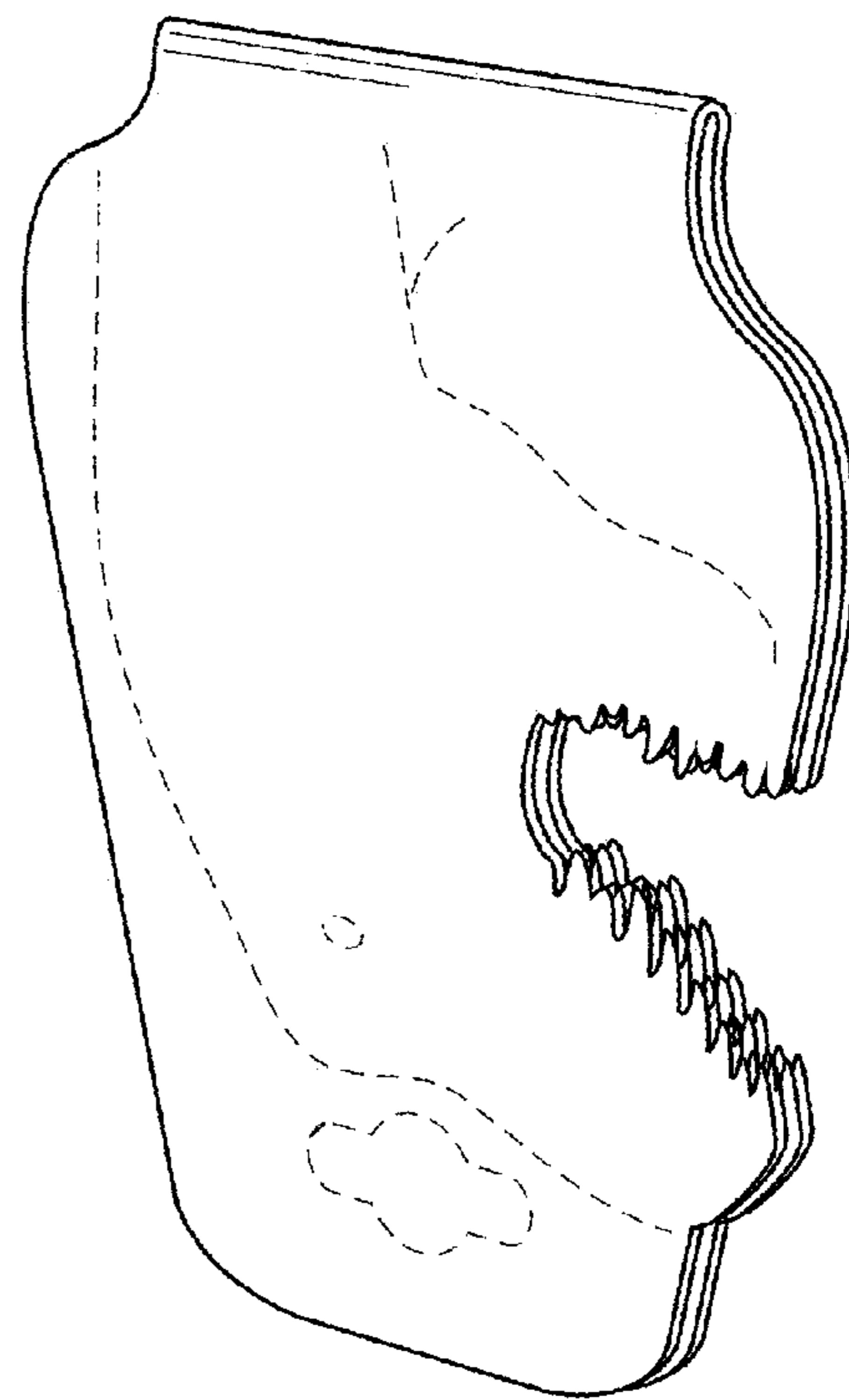

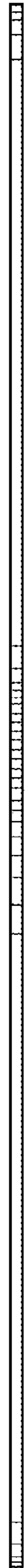

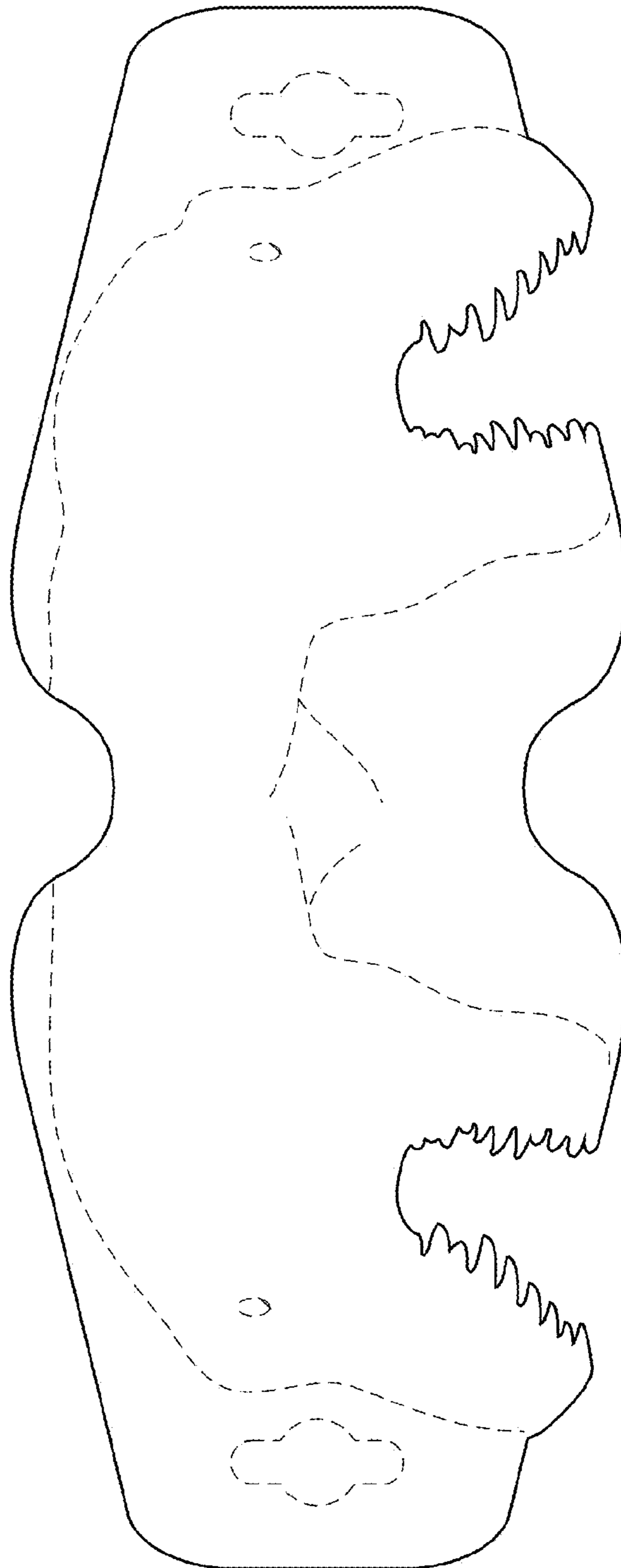

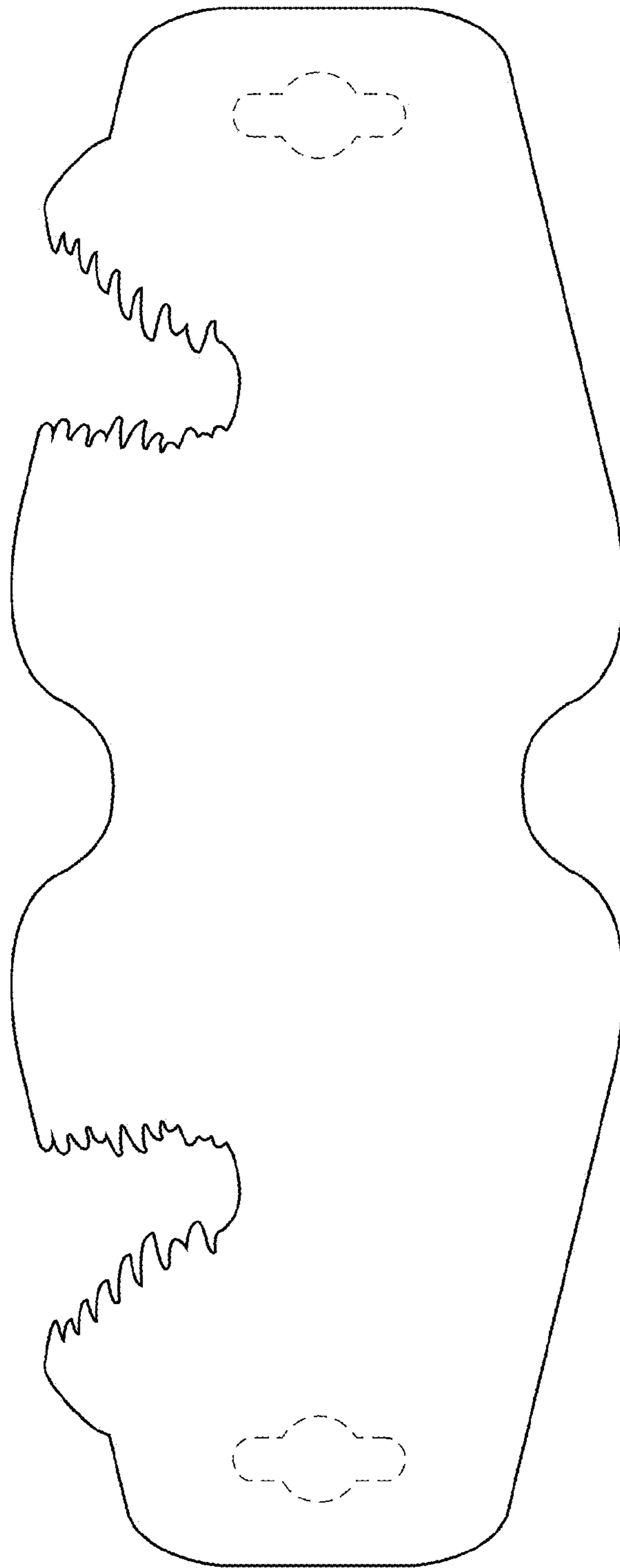

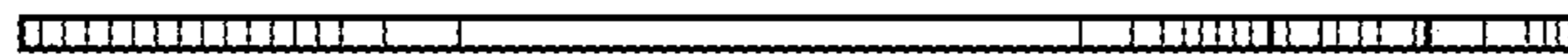
