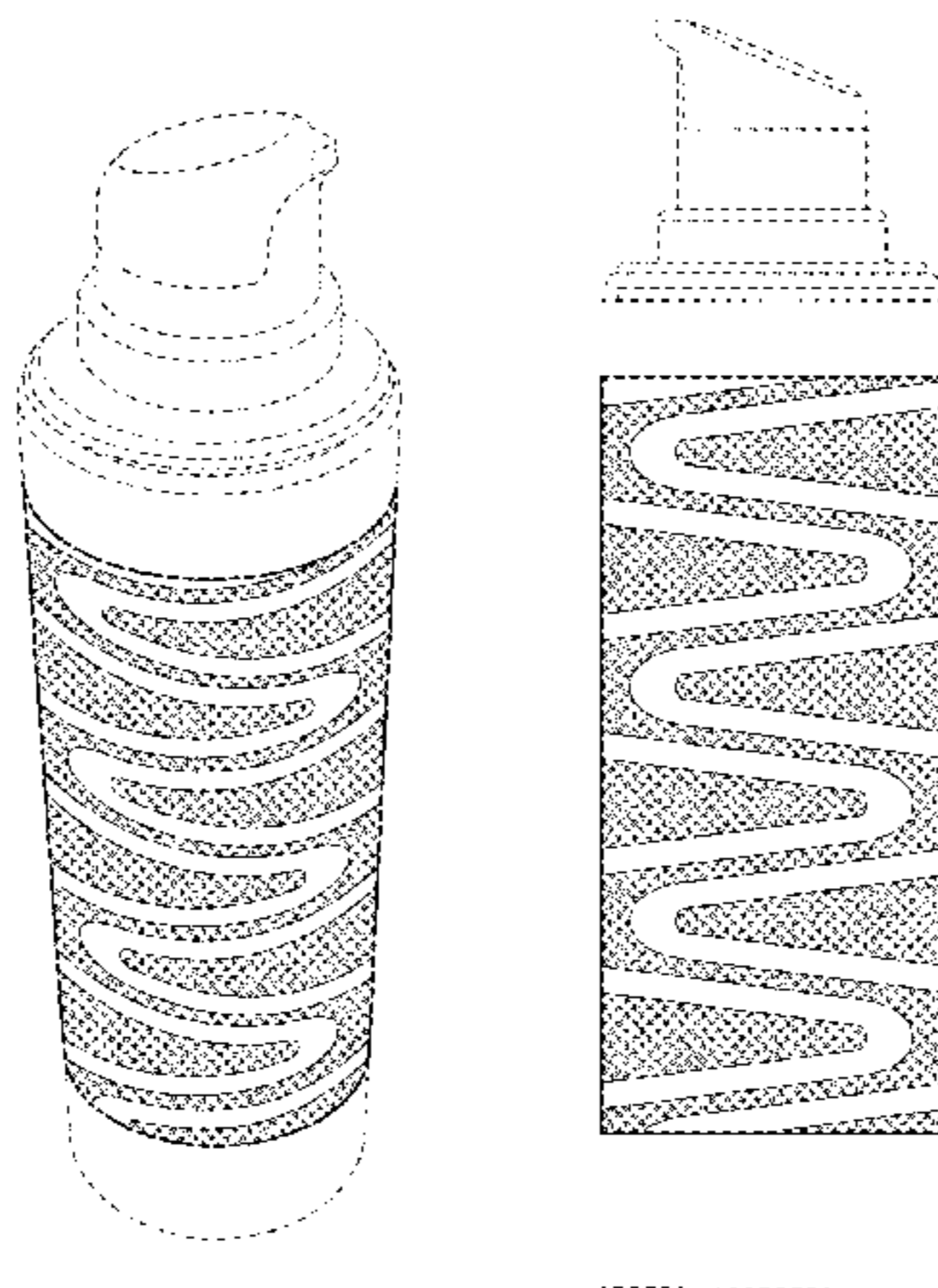
(57) **CLAIM**

The ornamental design for the cosmetic product package, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a cosmetic product package showing our new design;
FIG. 2 is a left side view of the cosmetic product package of FIG. 1;
FIG. 3 is a back view of the cosmetic product package of FIG. 1;
FIG. 4 is a right side view of the cosmetic product package of FIG. 1;
FIG. 5 is a top view of the cosmetic product package of FIG. 1; and,
FIG. 6 is a bottom view of the cosmetic product package of FIG. 1.
The broken lines are included for the purpose of illustrating the portions of the cosmetic product package that form no part of the claimed design.
The gray scale shading within the zig-zag pattern represents color contrast consonant with the visual appearance shown in the drawings.

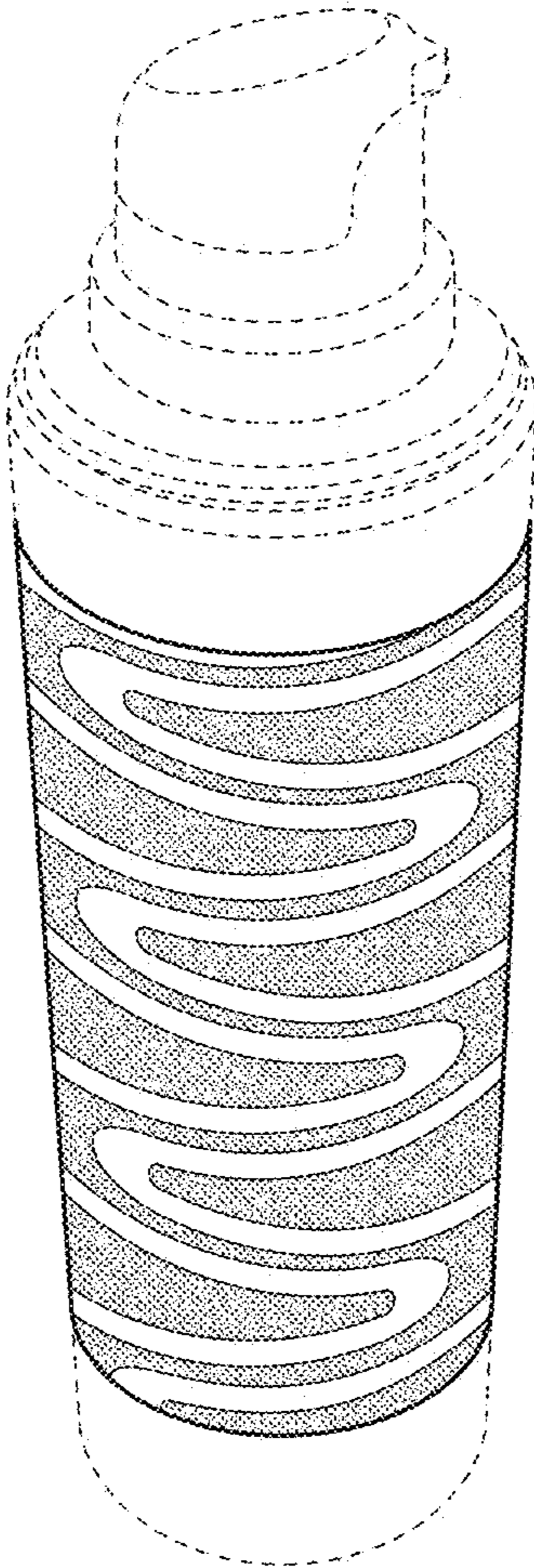

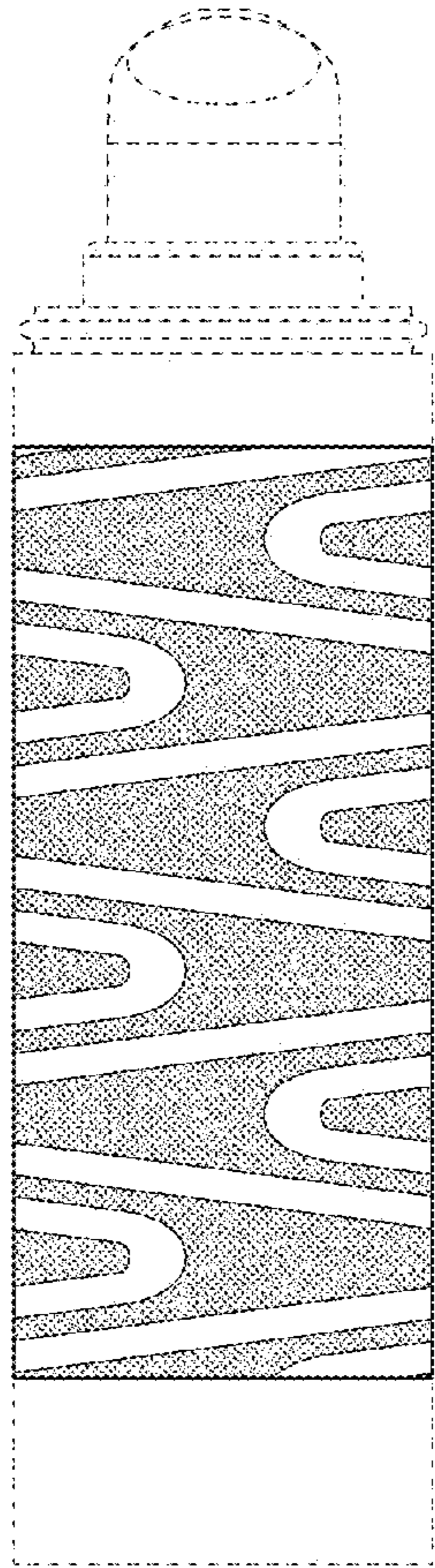

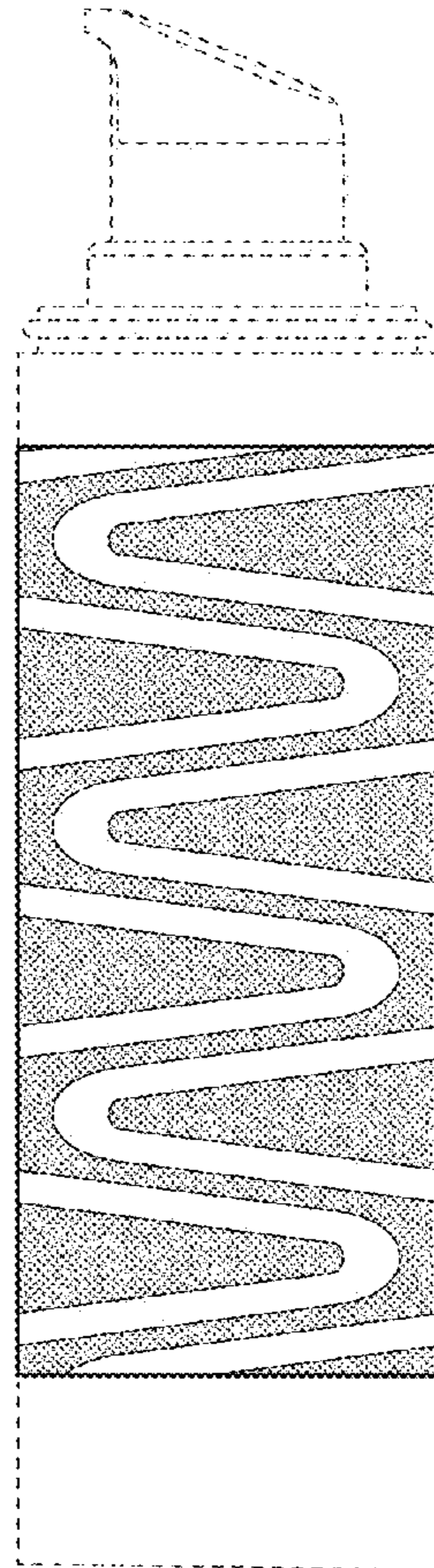

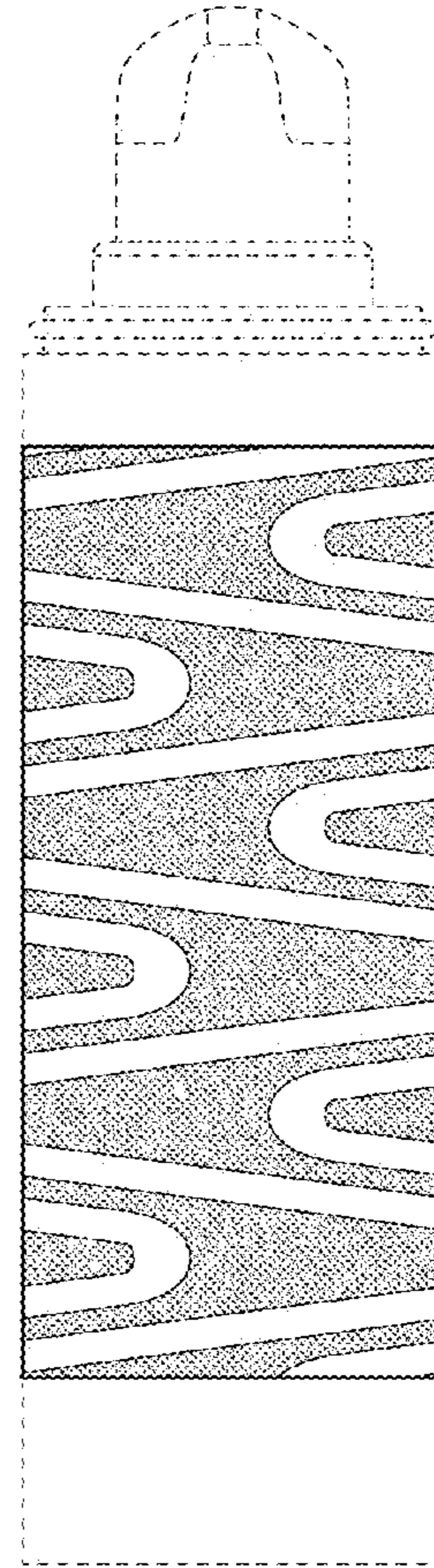

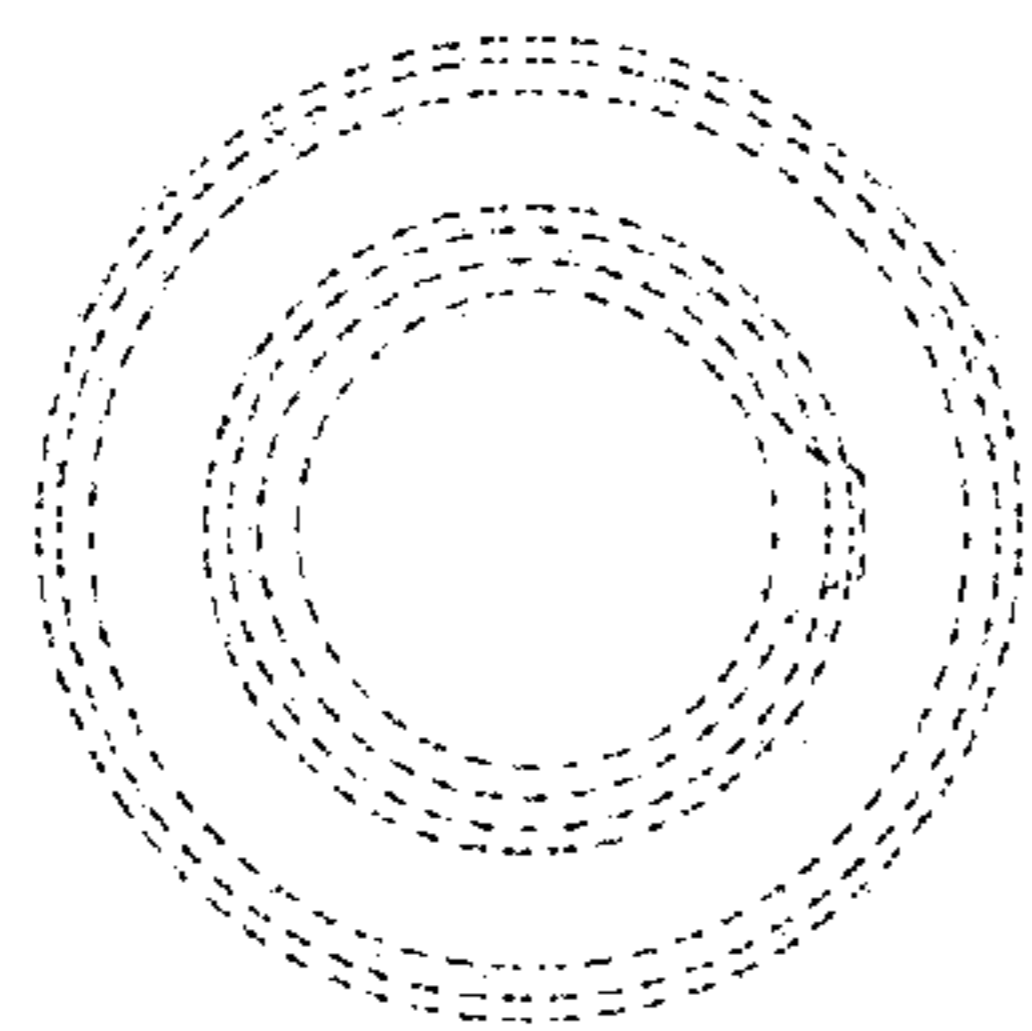

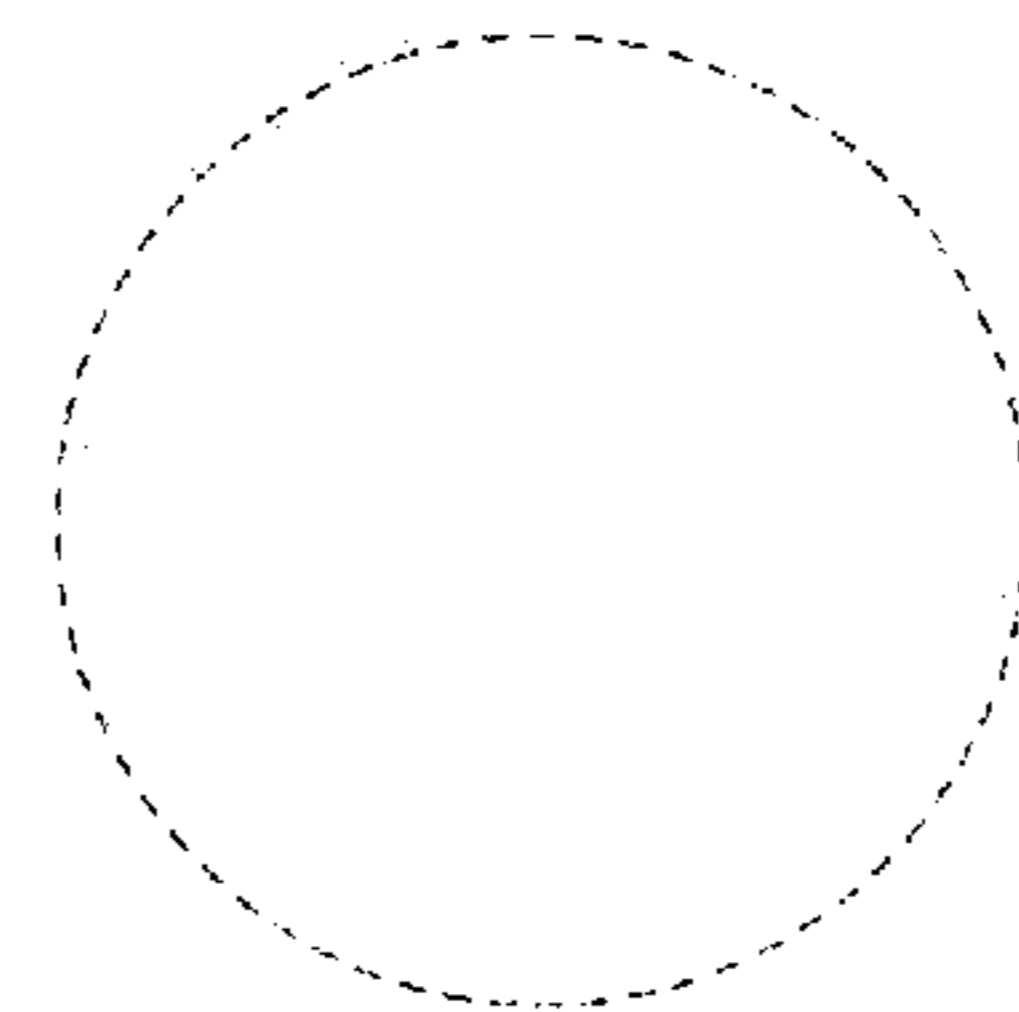
