The ornamental design for a bottle, as shown and described.

DESCRIPTION

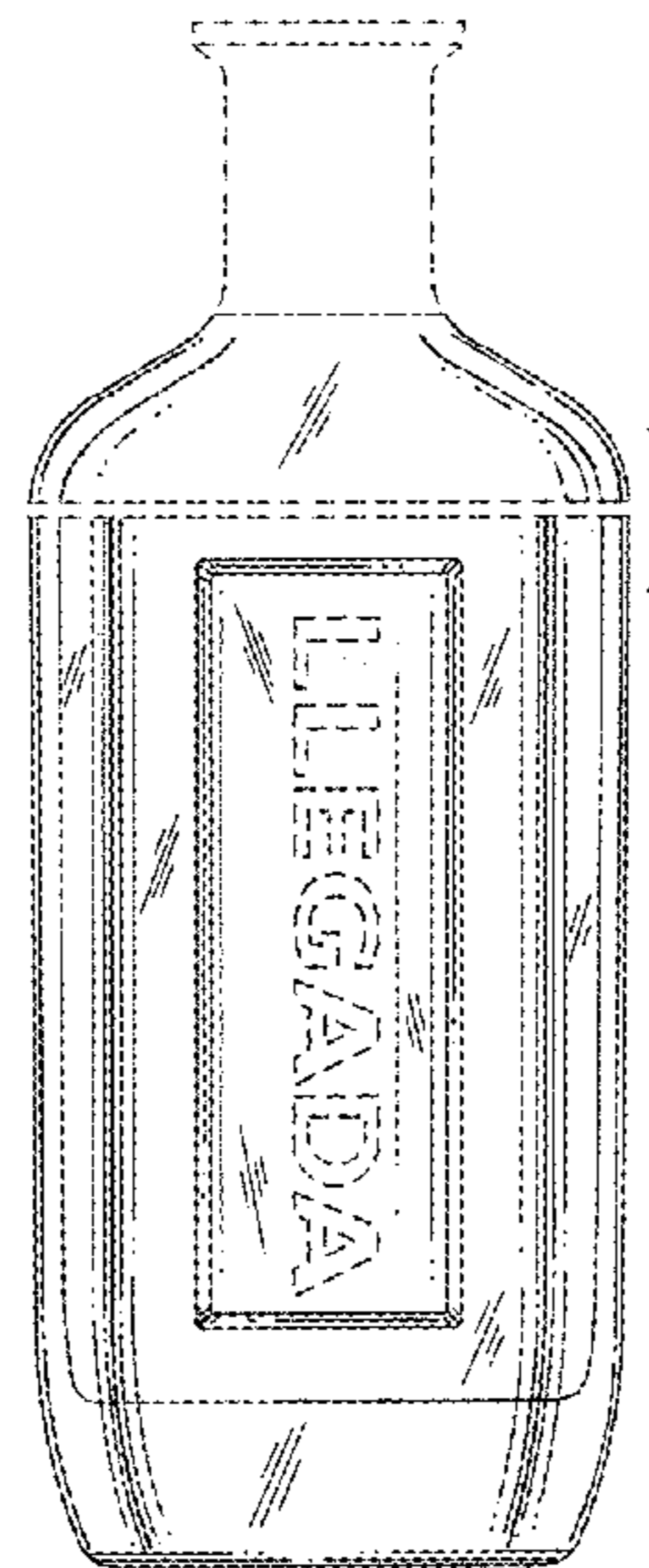
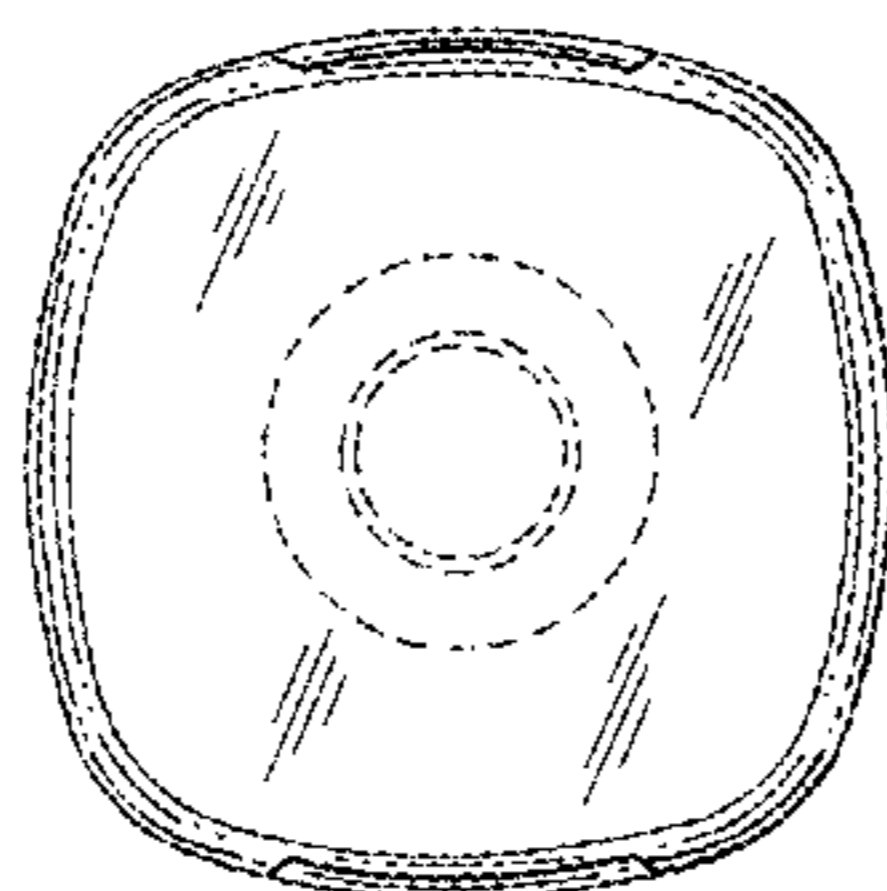
FIG. 1 is a top, plan view of a bottle showing our design; FIG. 2 is a front elevational view thereof; FIG. 3 is a right side elevational view thereof, the left side elevational view being a mirror image except for the unclaimed text on the front and rear sidewalls; FIG. 4 is a bottom plan view thereof; and, FIG. 5 is a rear elevational view thereof.

The dash-dash-dash-dash broken lines shown in the drawing views are included for the purpose of illustrating environmental structure and form no part of the claimed design.

The dot-dash-dot-dash broken lines shown in the drawing views define the boundaries of the claimed design and form no part thereof.

The two bracketed, horizontal broken lines shown just below the shoulder in newly numbered drawing FIGS. 2, 3, & 5 represent indeterminate height.

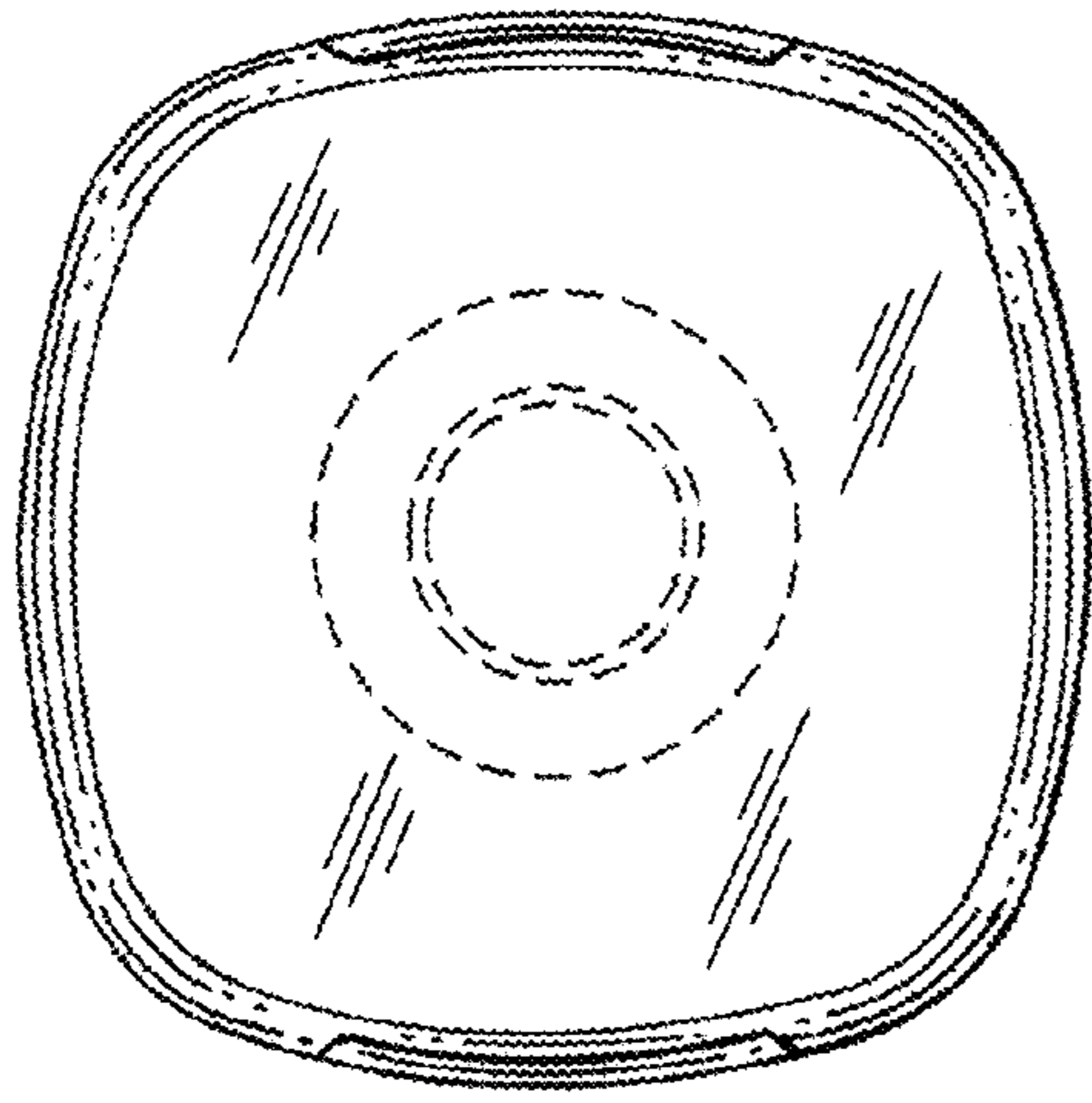

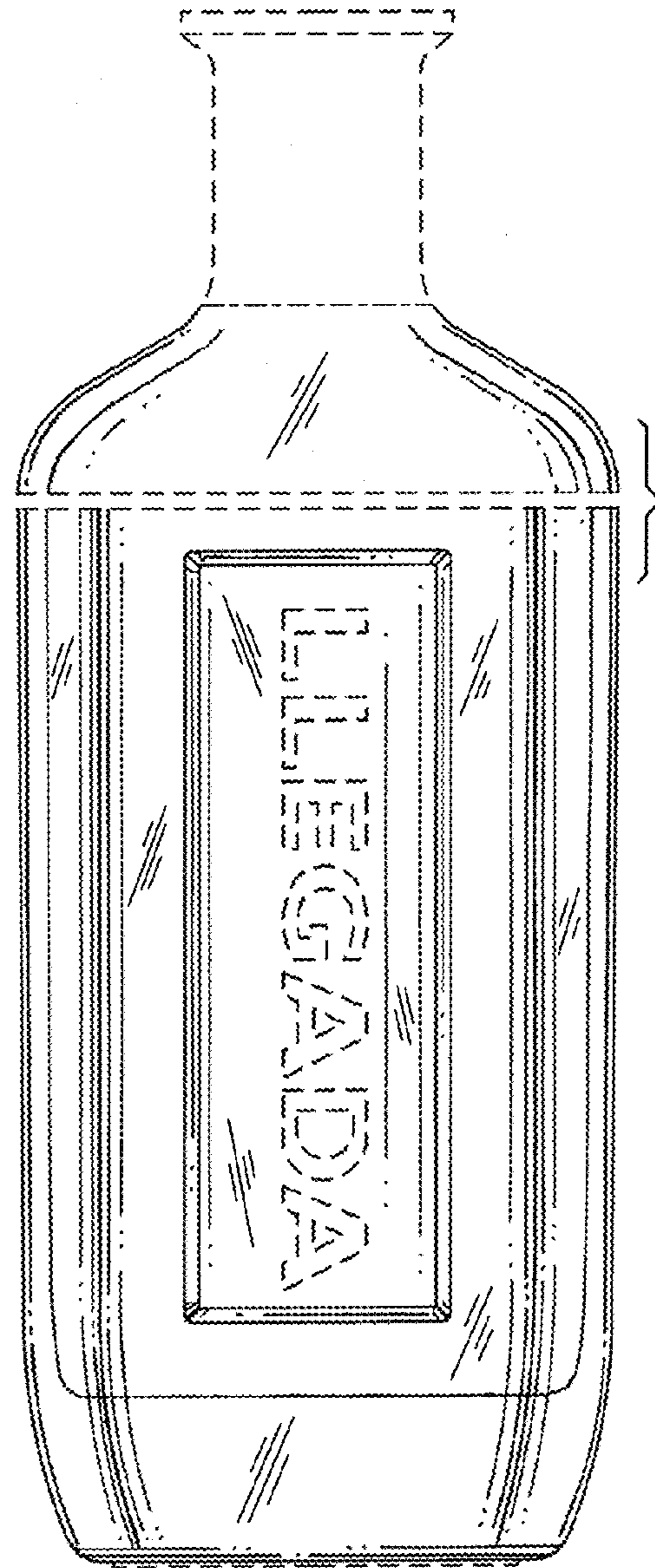

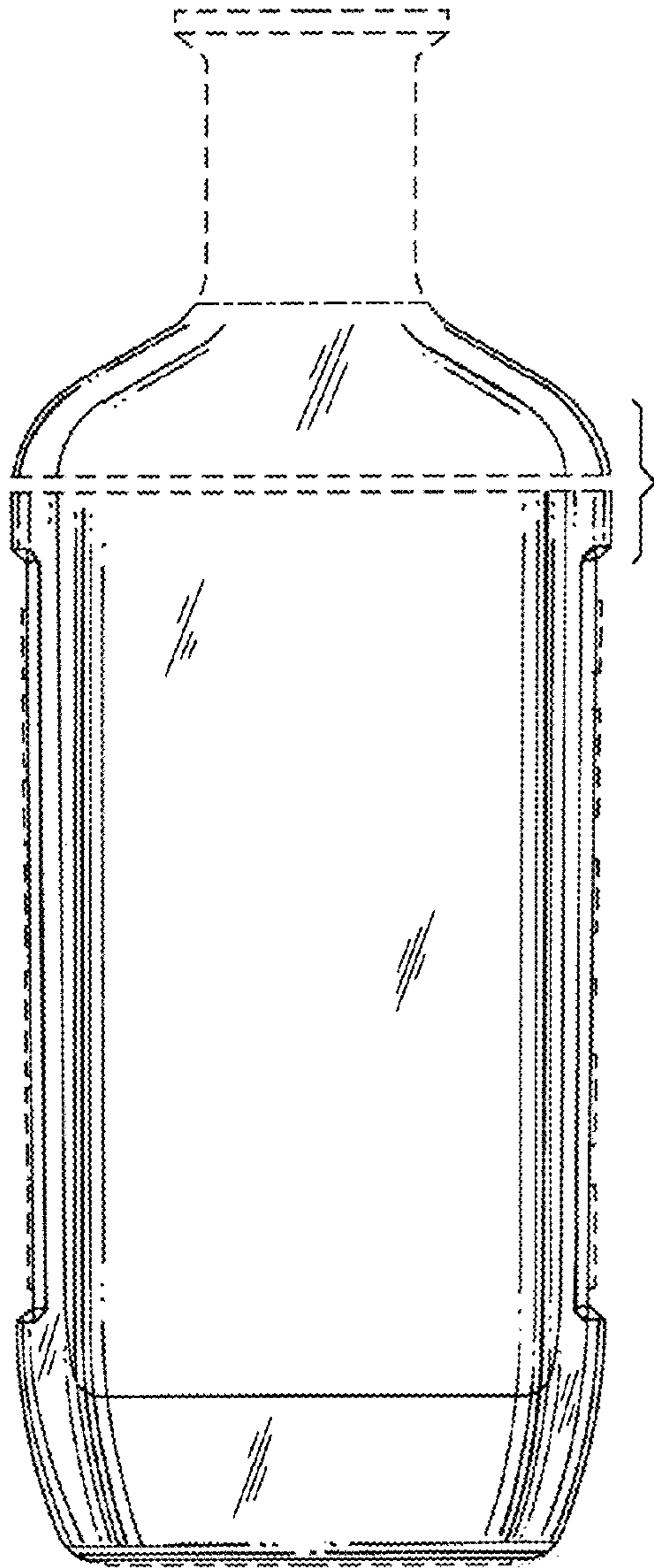

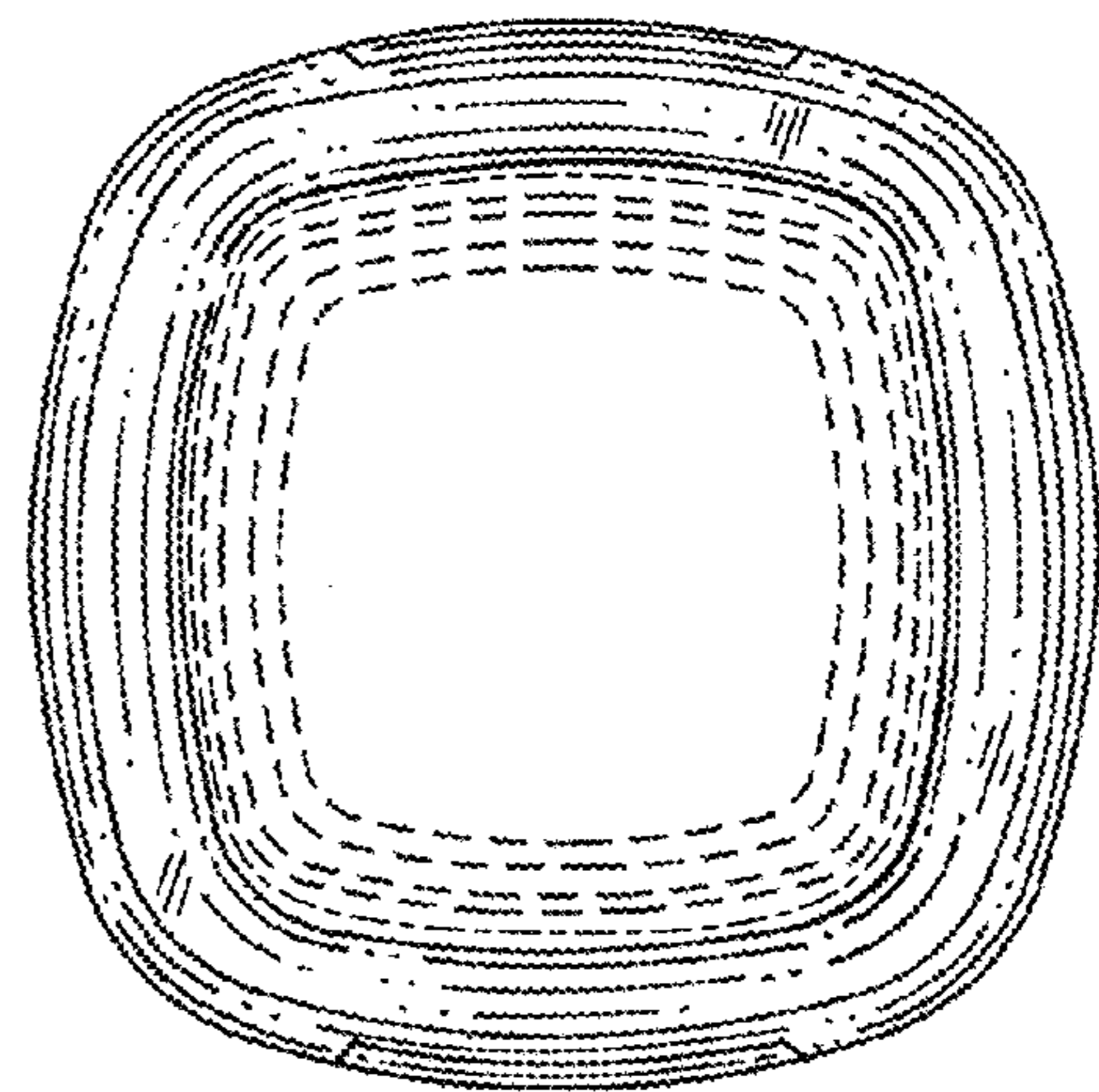

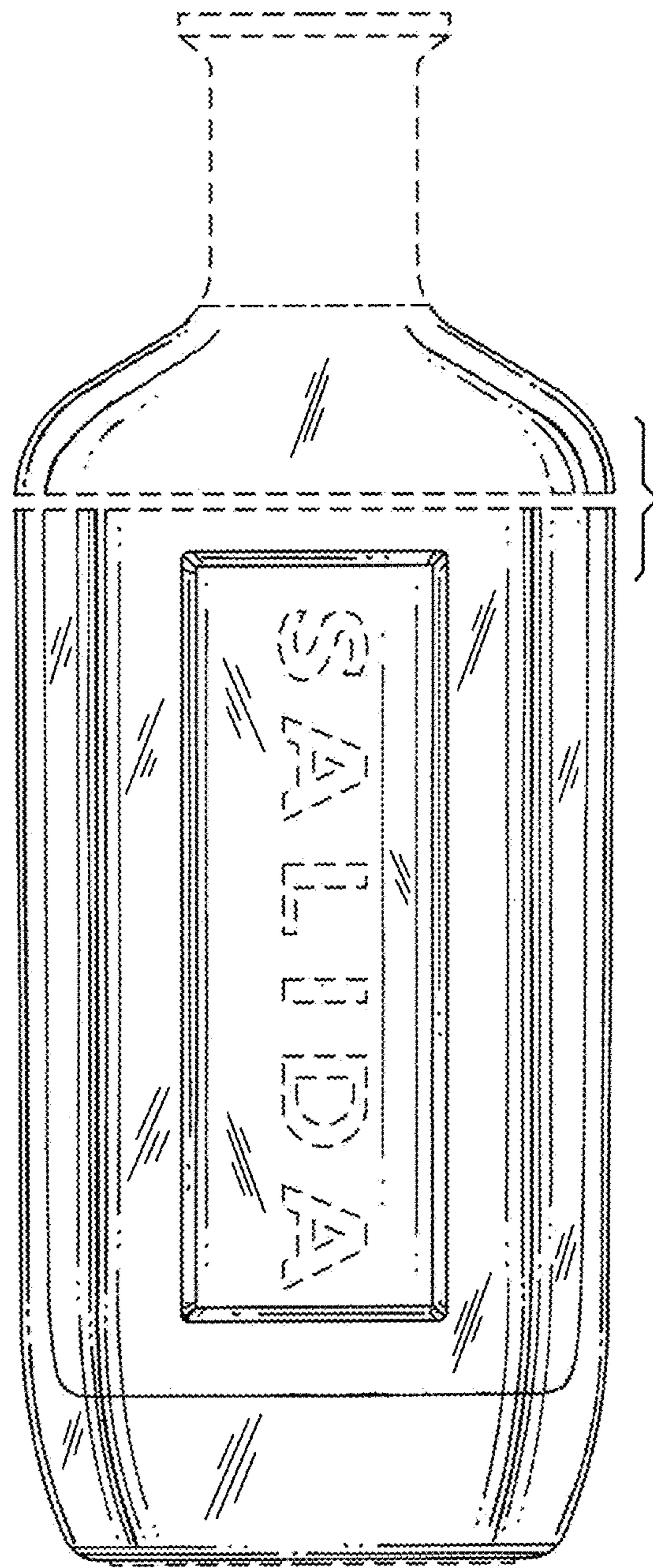
