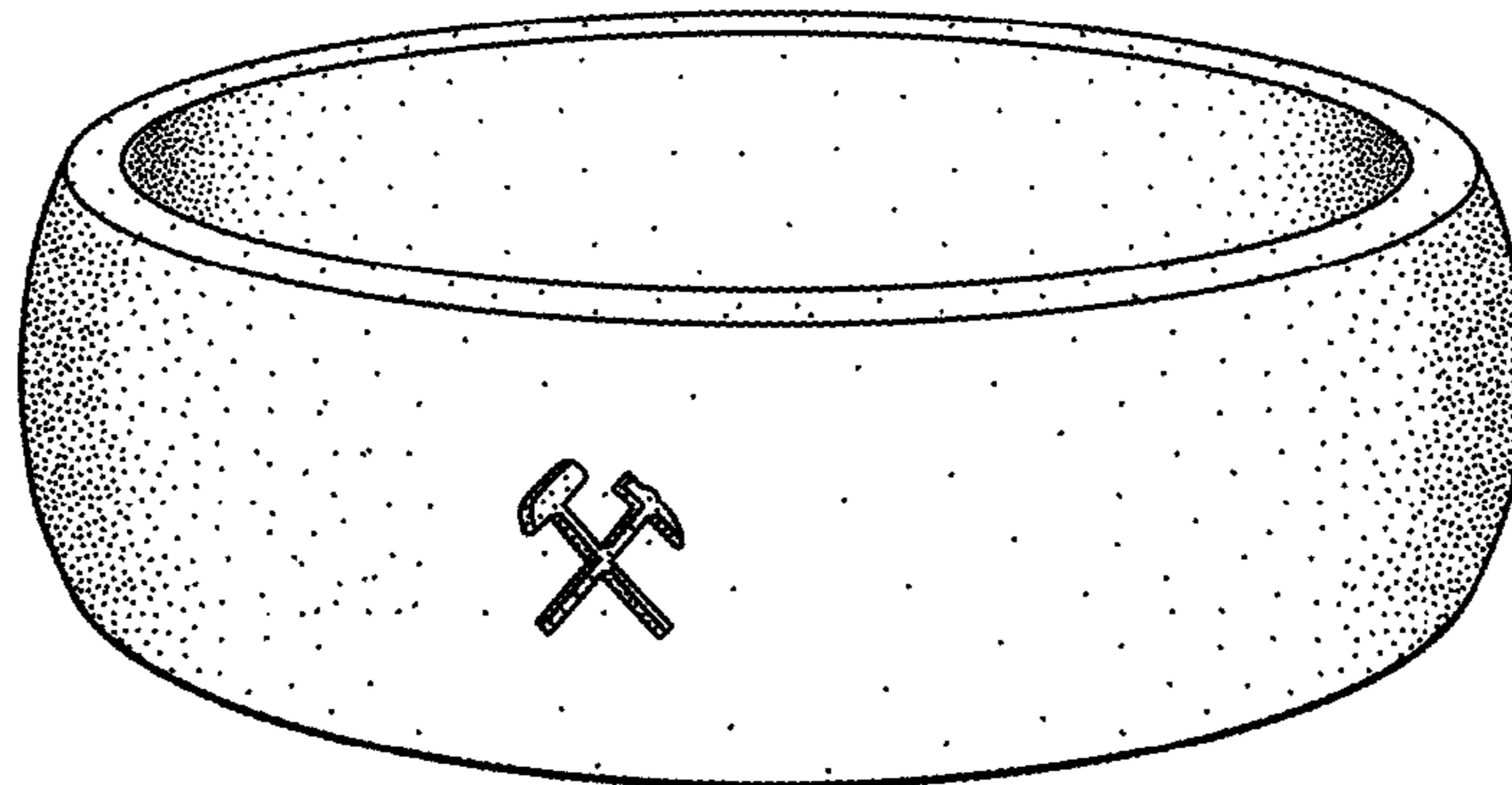
(57) **CLAIM**

The ornamental design for a wearable ring, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, right perspective view of a wearable ring showing our new design;  
 FIG. 2 is a right side view thereof, wherein the left side is a mirror image of FIG. 2;  
 FIG. 3 is a top view thereof;  
 FIG. 4 is a front view thereof; and  
 FIG. 5 is a rear view thereof; and,  
 FIG. 6 is an enlarged fragmentary view of FIG. 1 showing a portion of the claimed design.  
 The even length broken lines in FIG. 6 are imaginary lines that are included for reference purposes only and form no part of the claimed design.

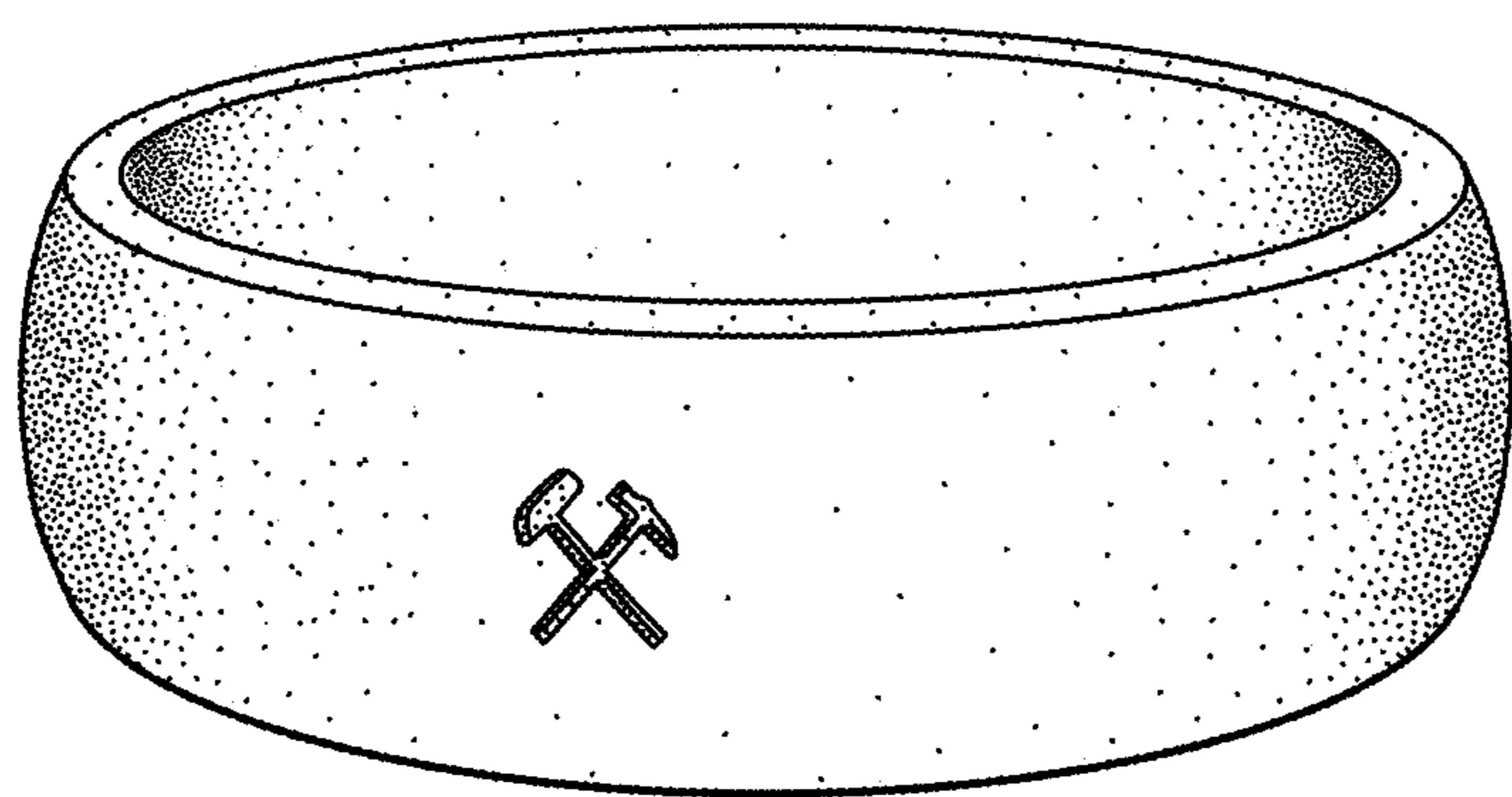

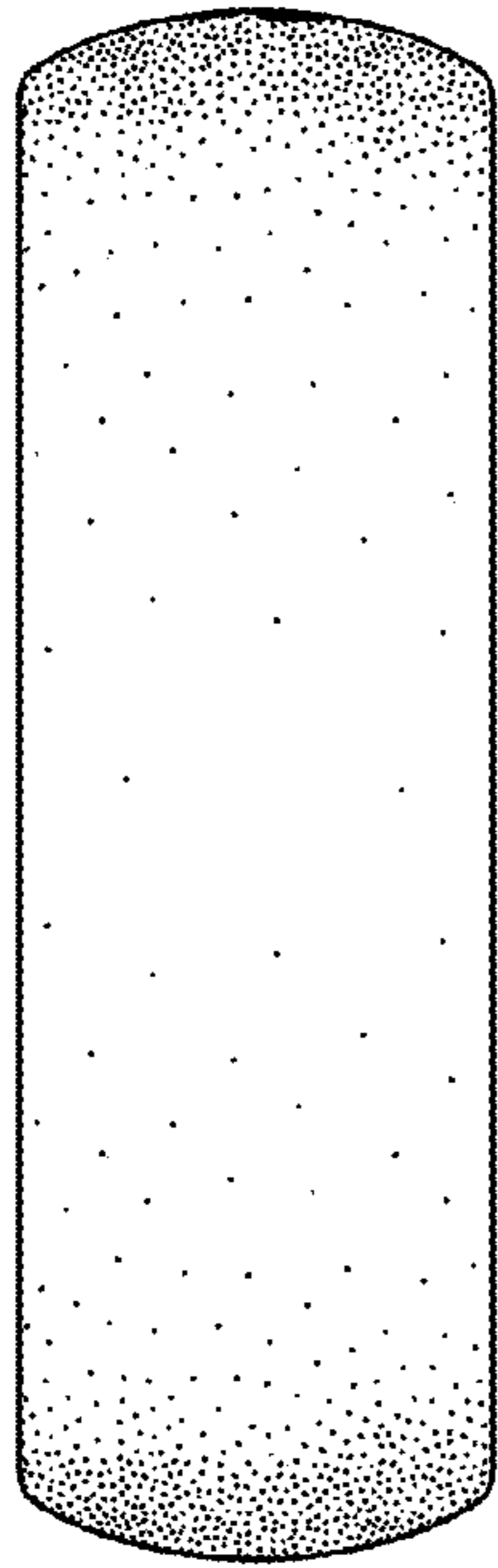

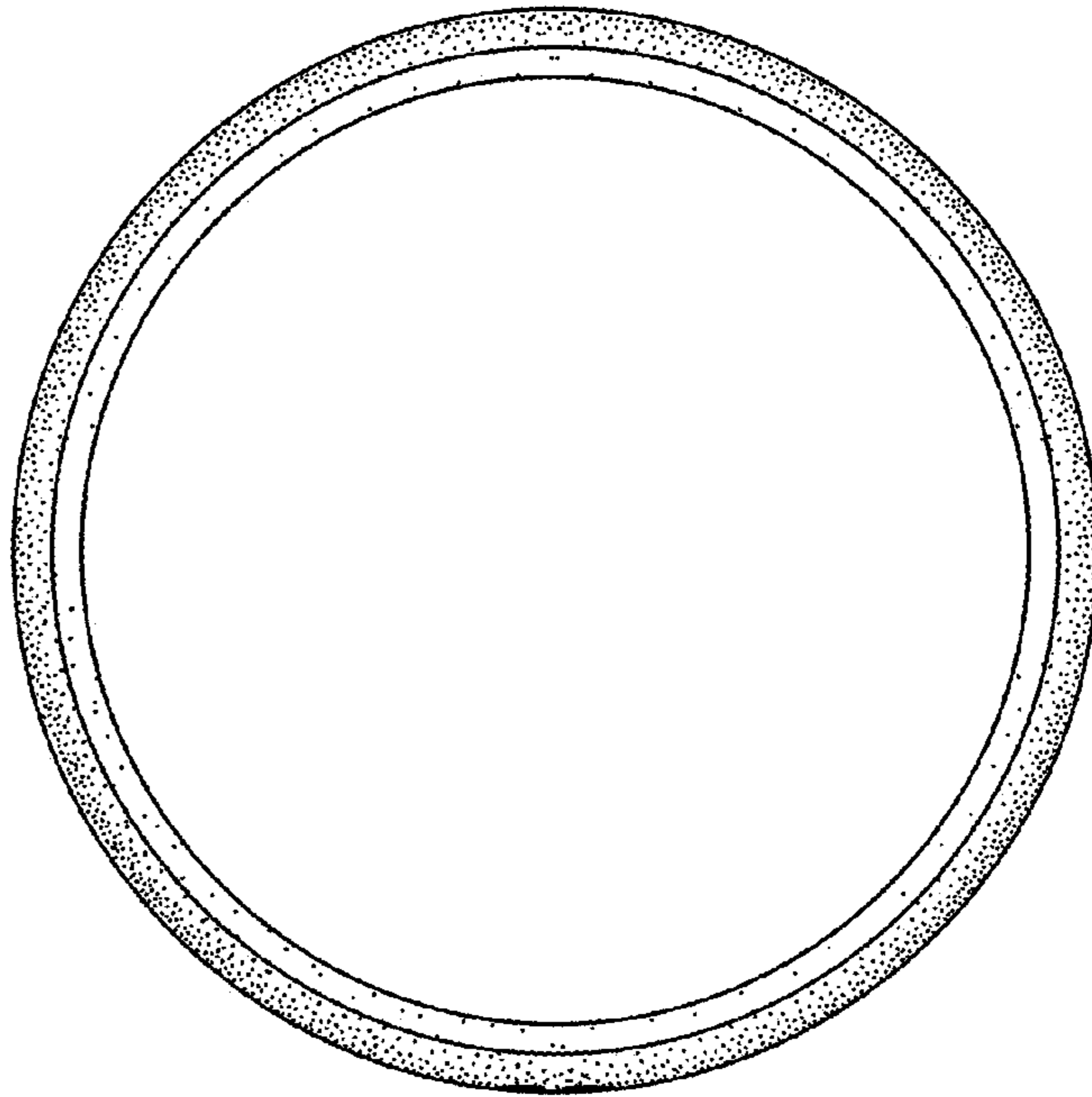

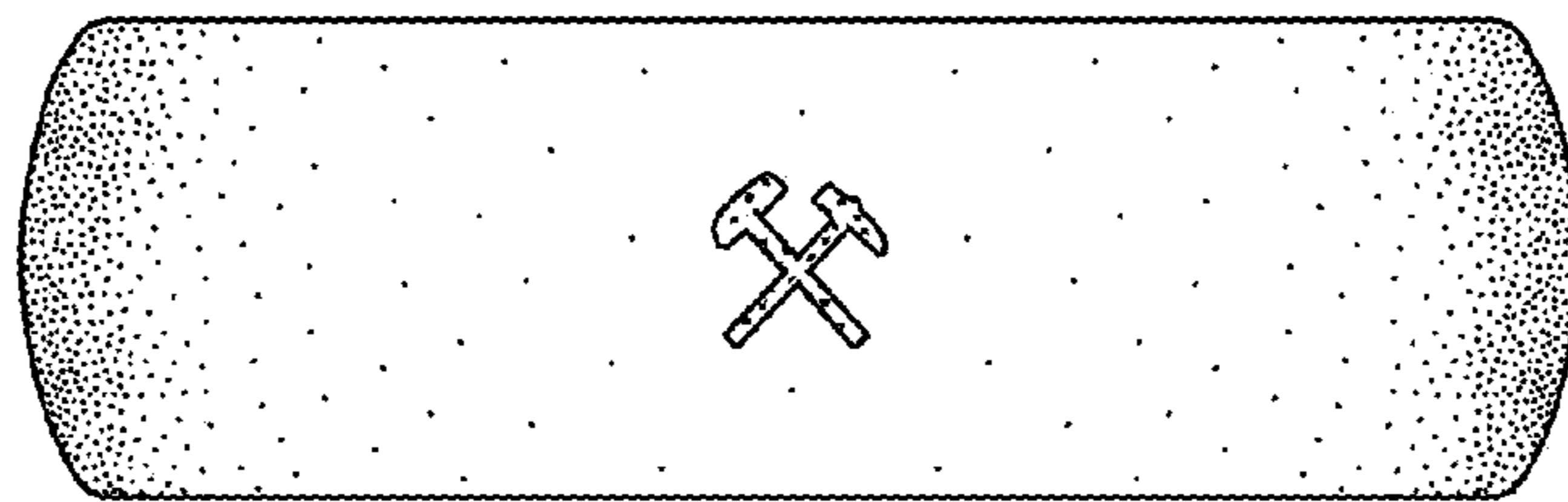

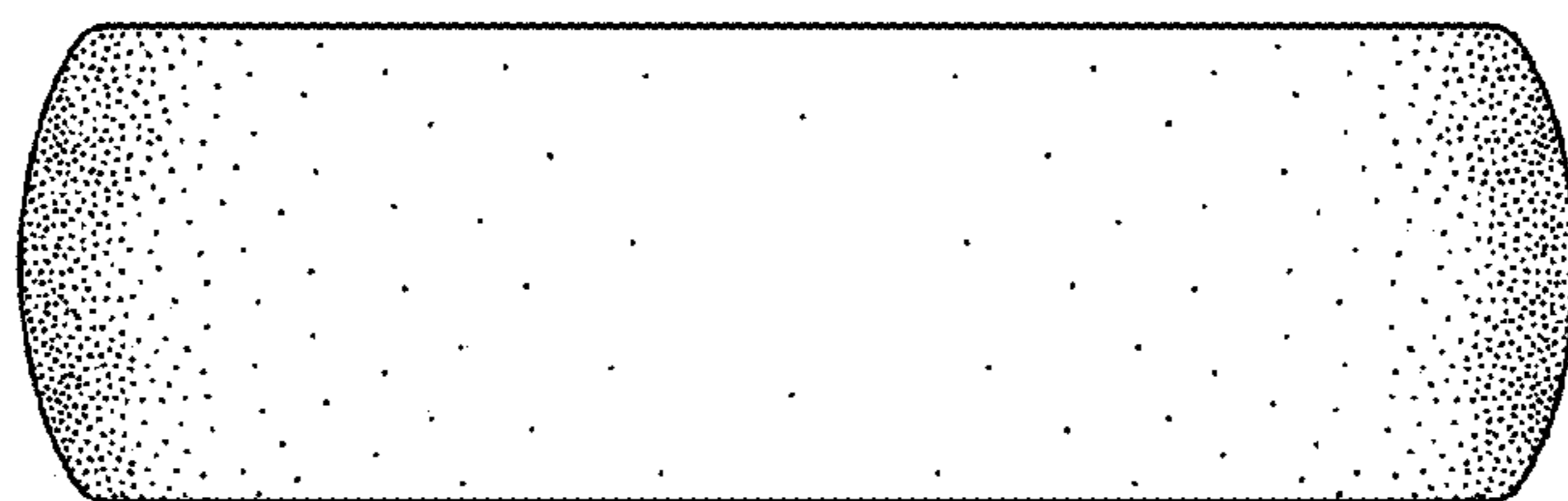

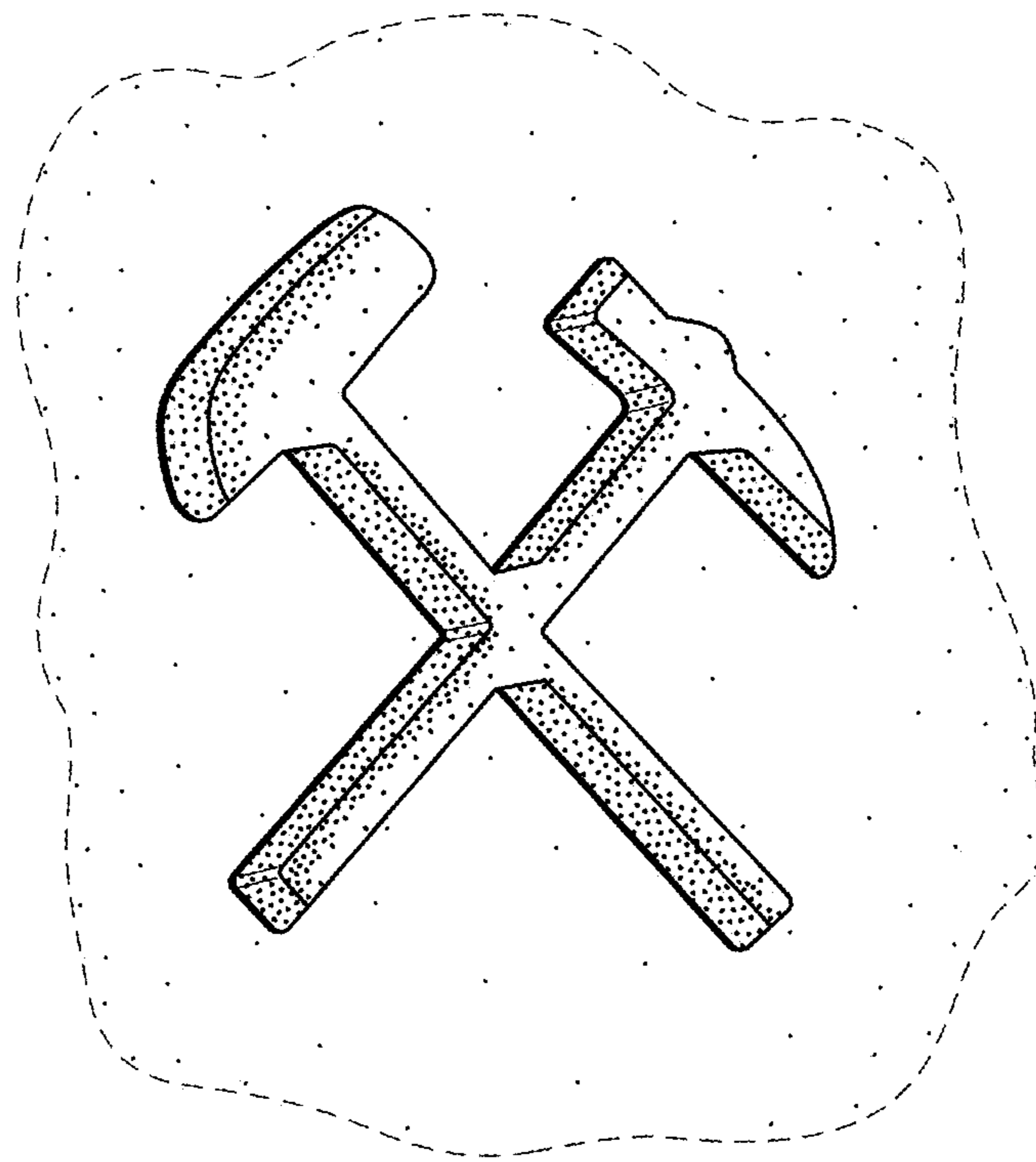
