FIG. 10 is a rear elevational view thereof with the top thereof down;

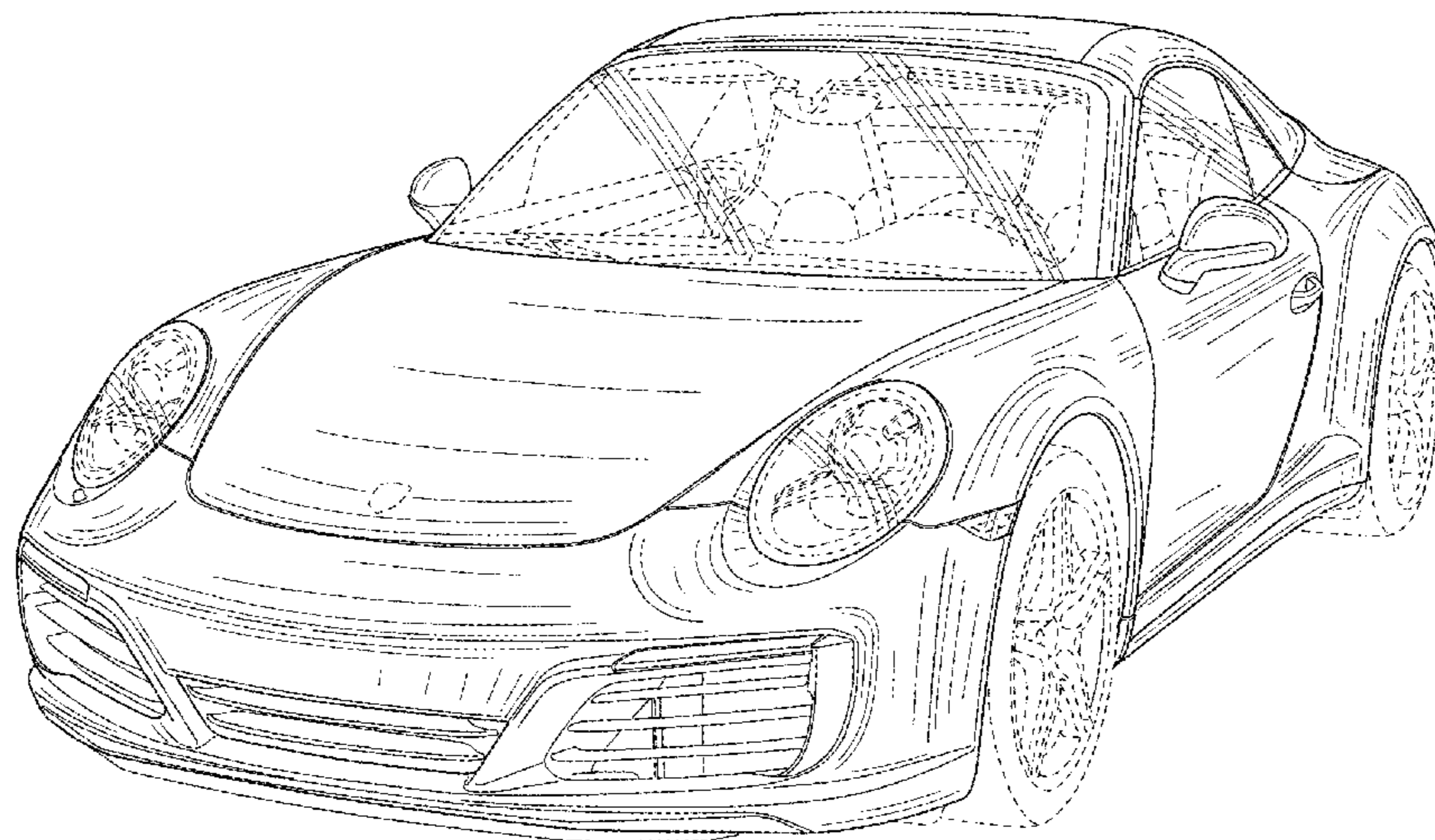
FIG. 11 is a side elevational view taken from the right side in FIG. 8;

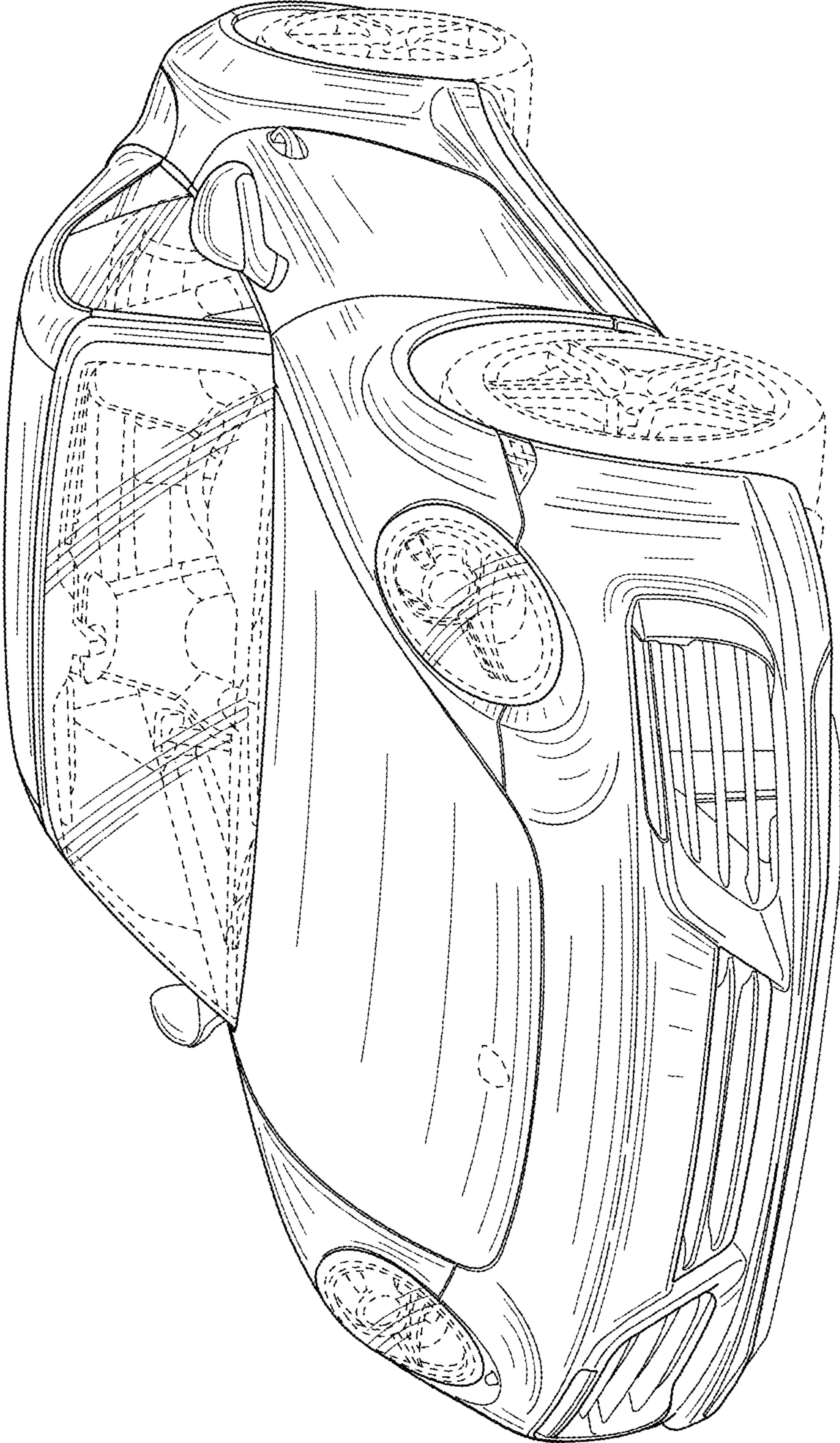

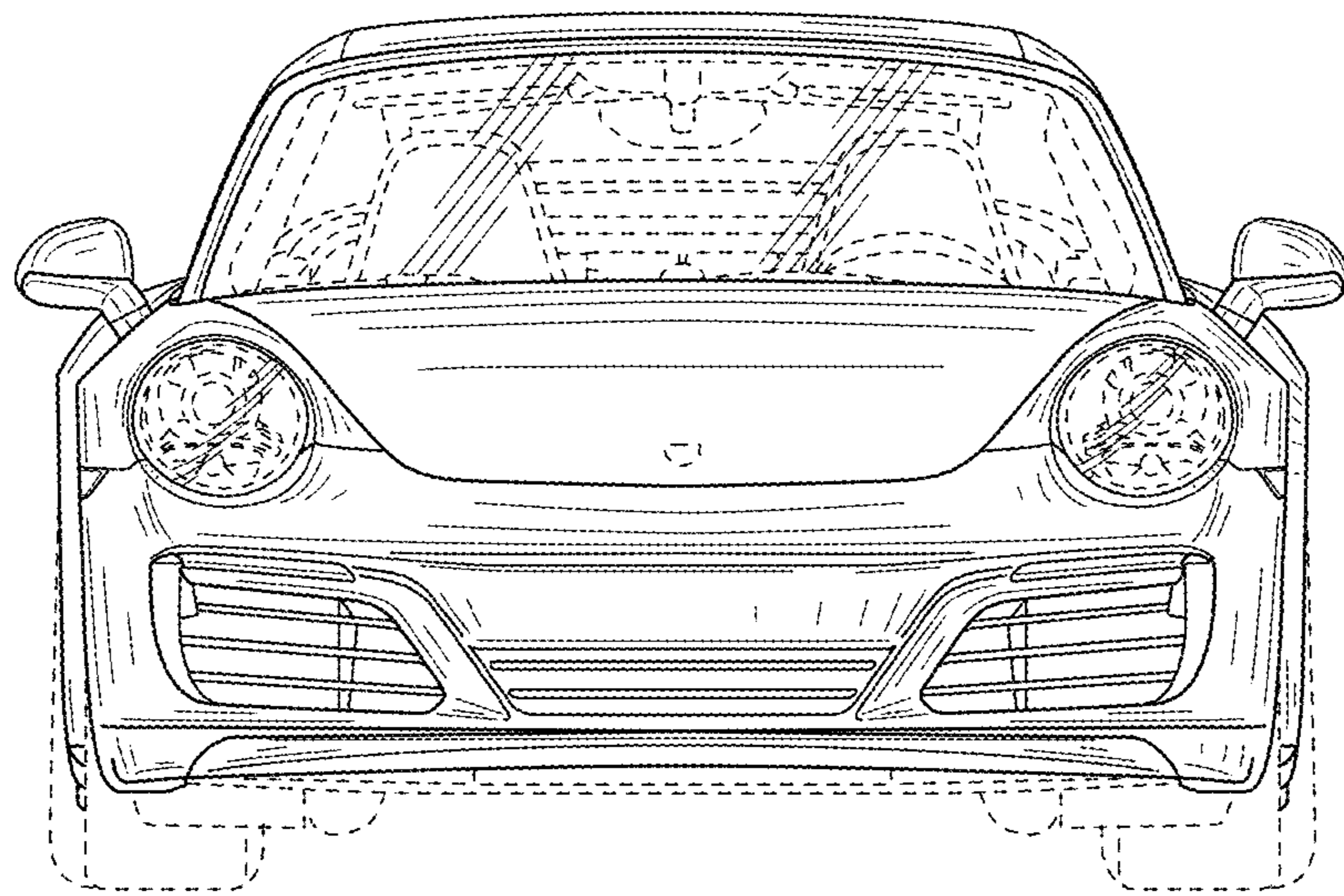

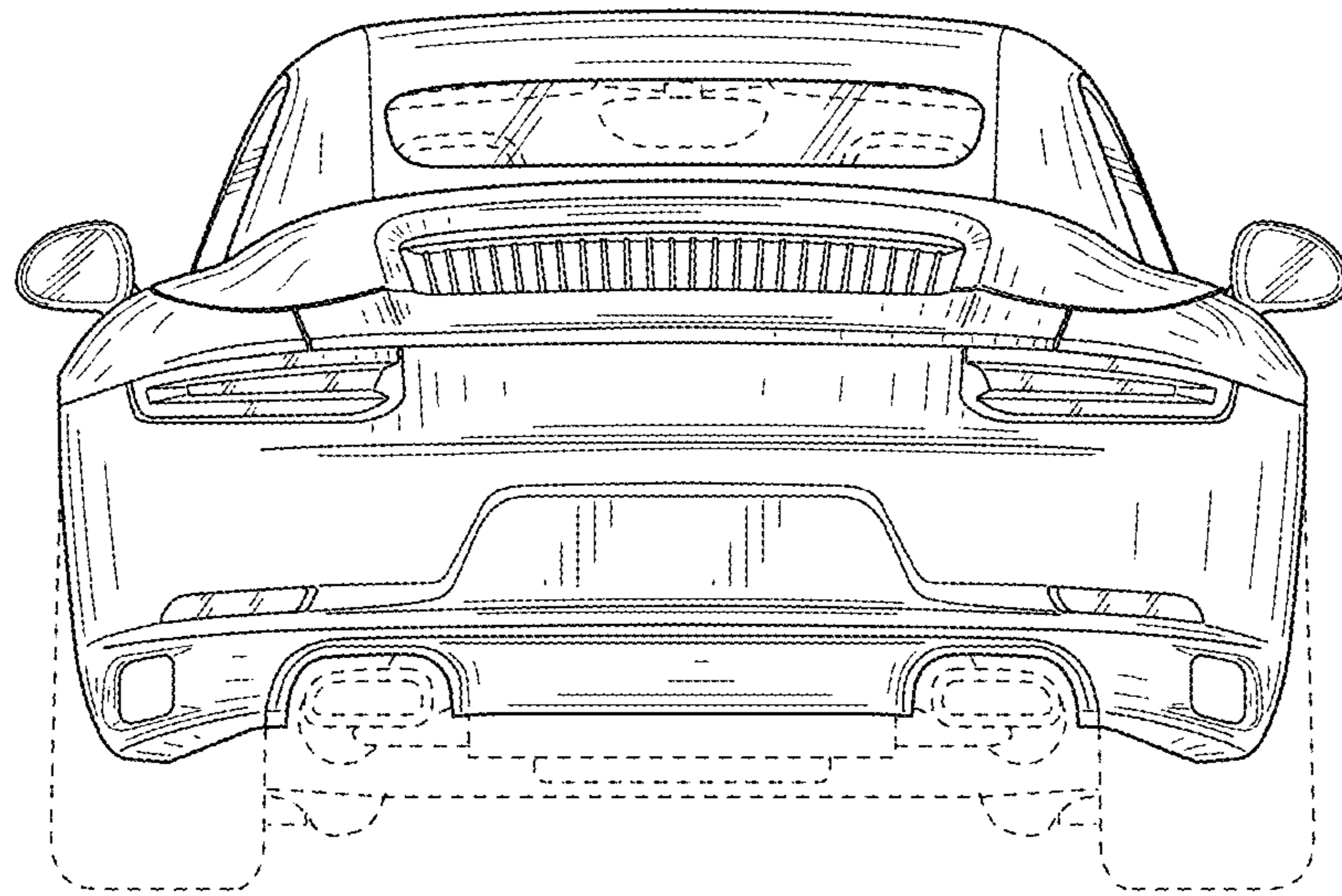

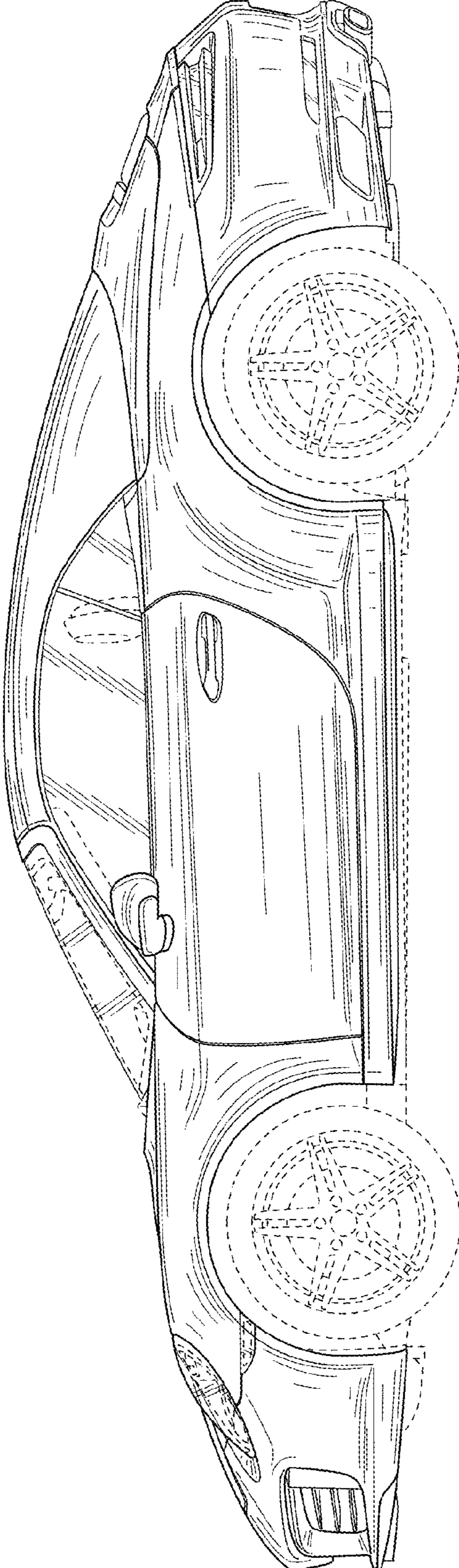

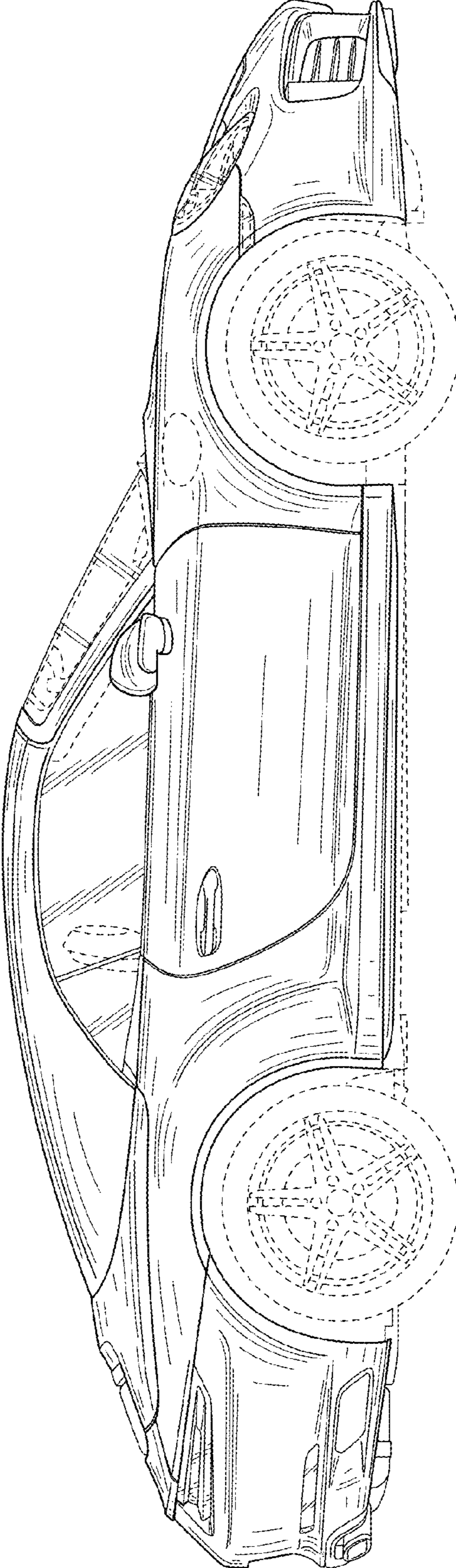

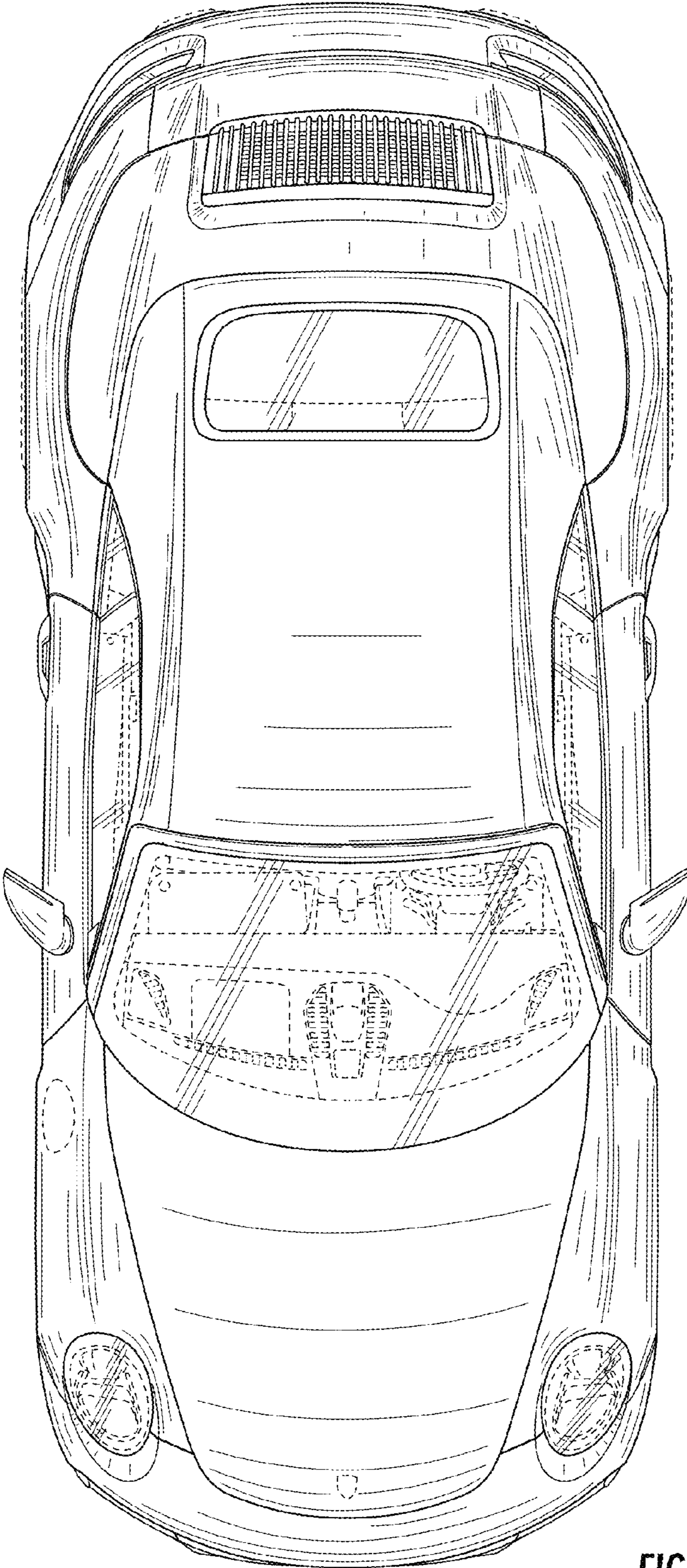

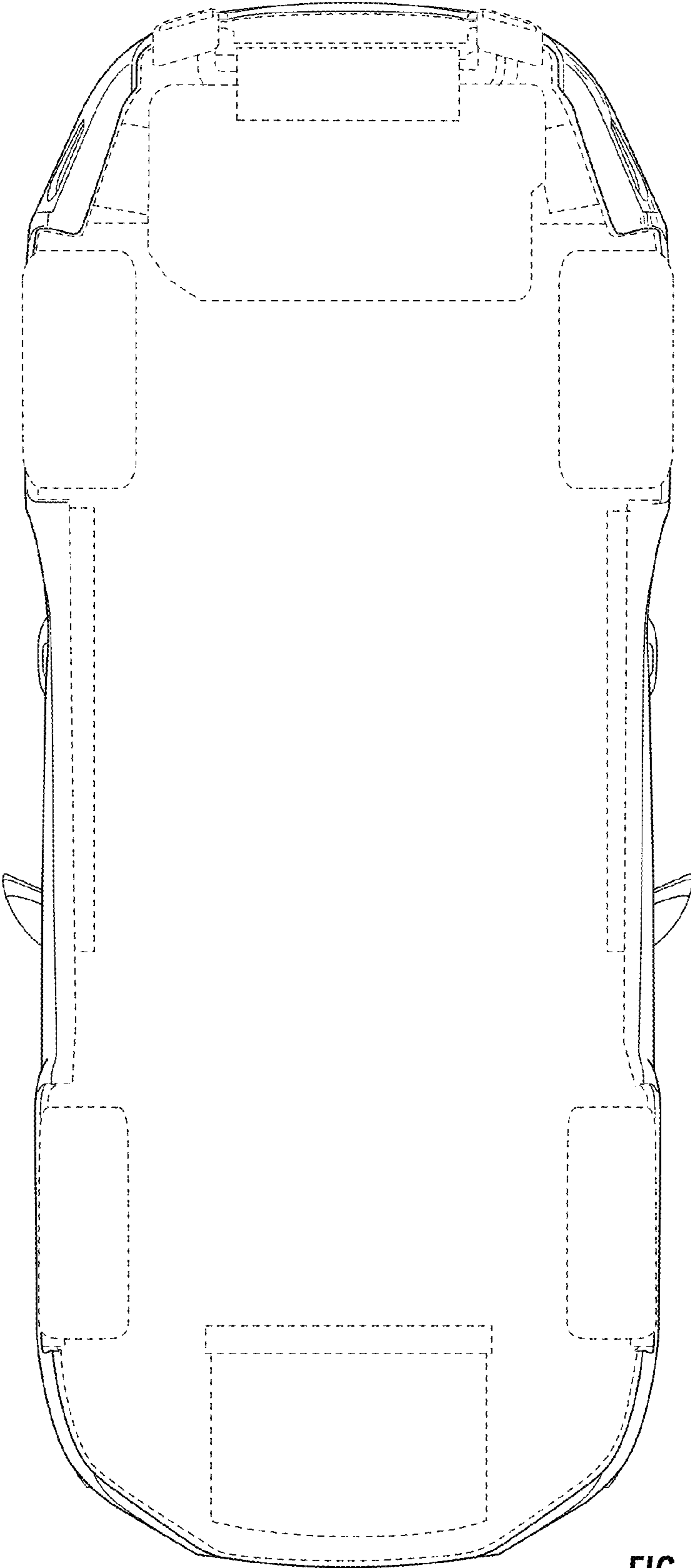

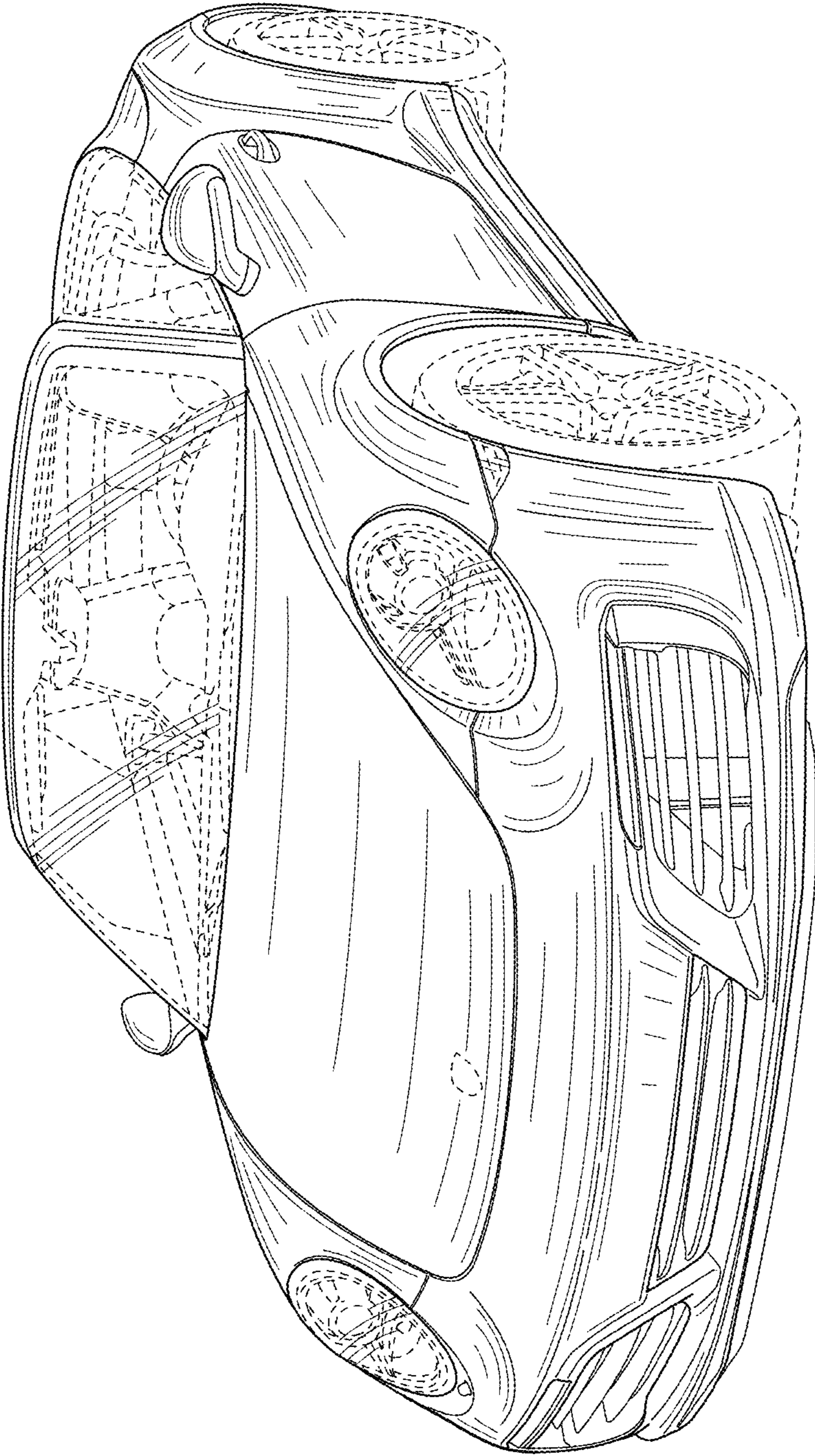

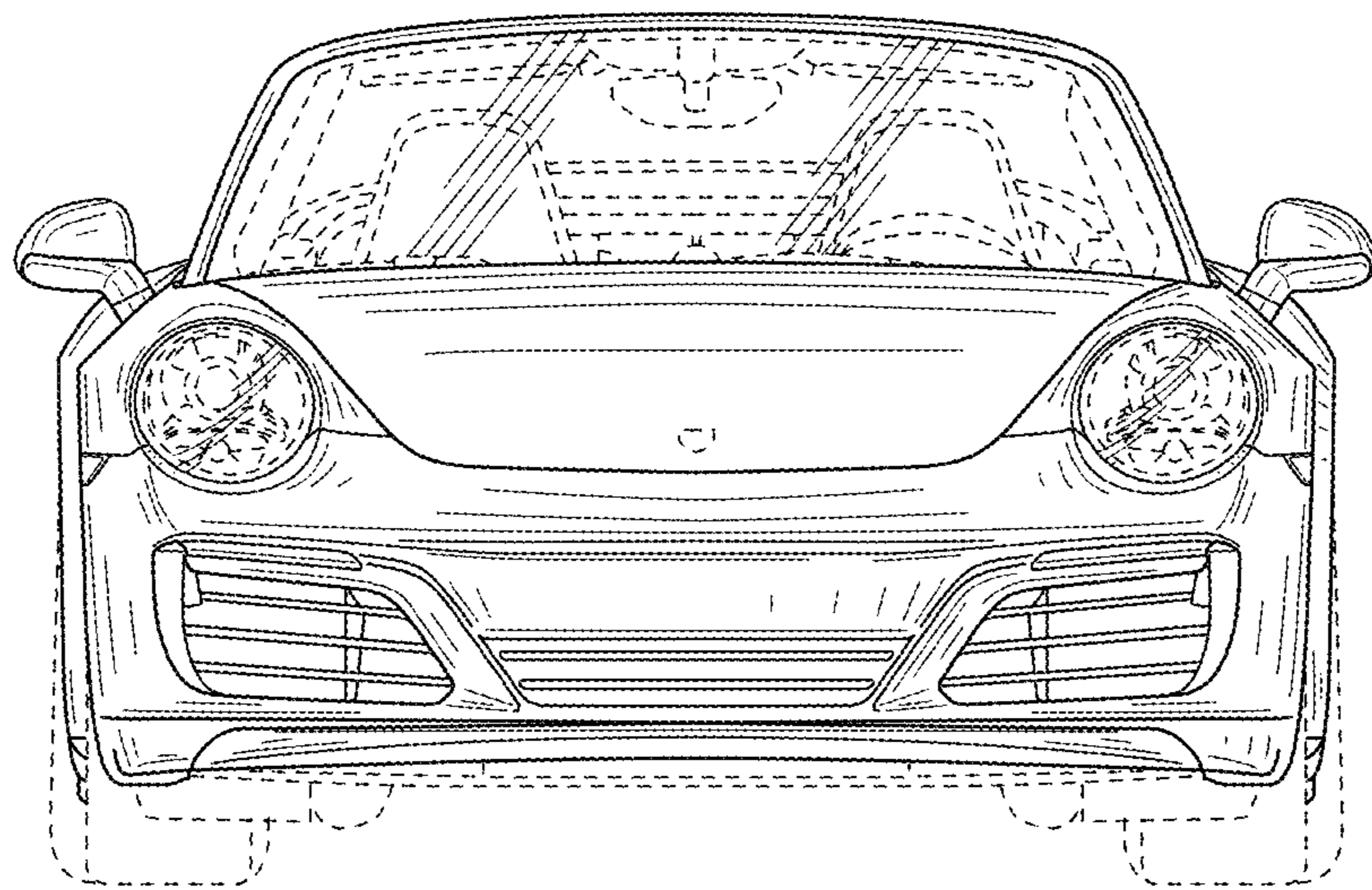

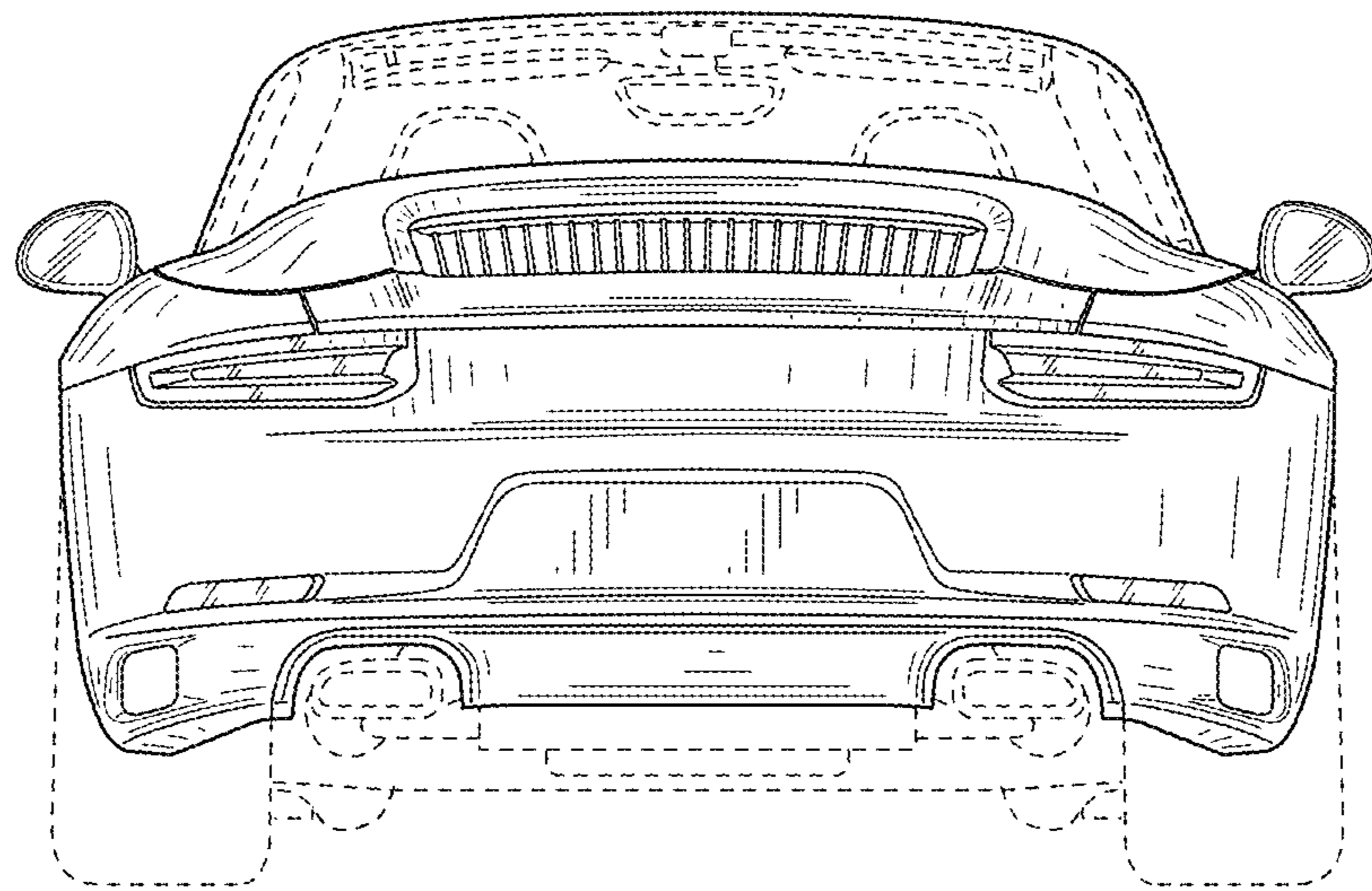

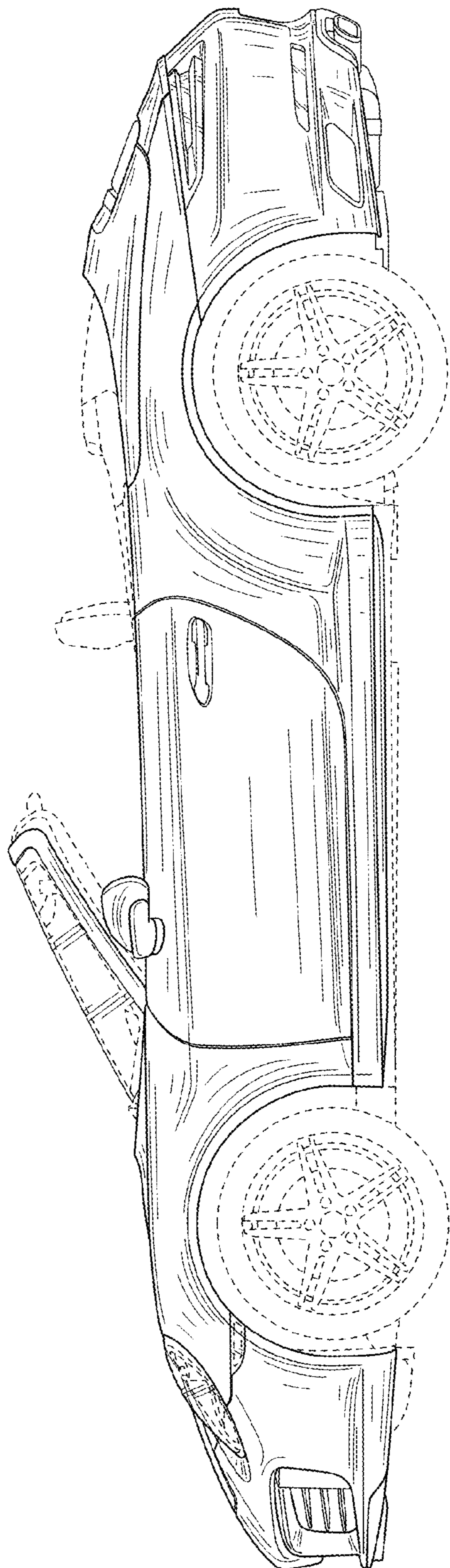

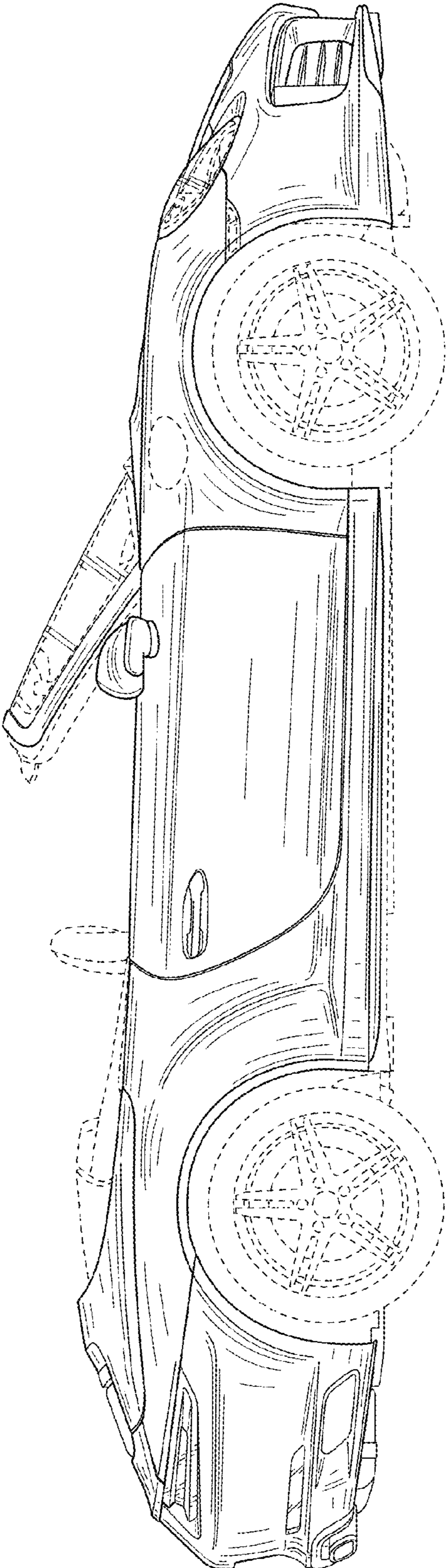

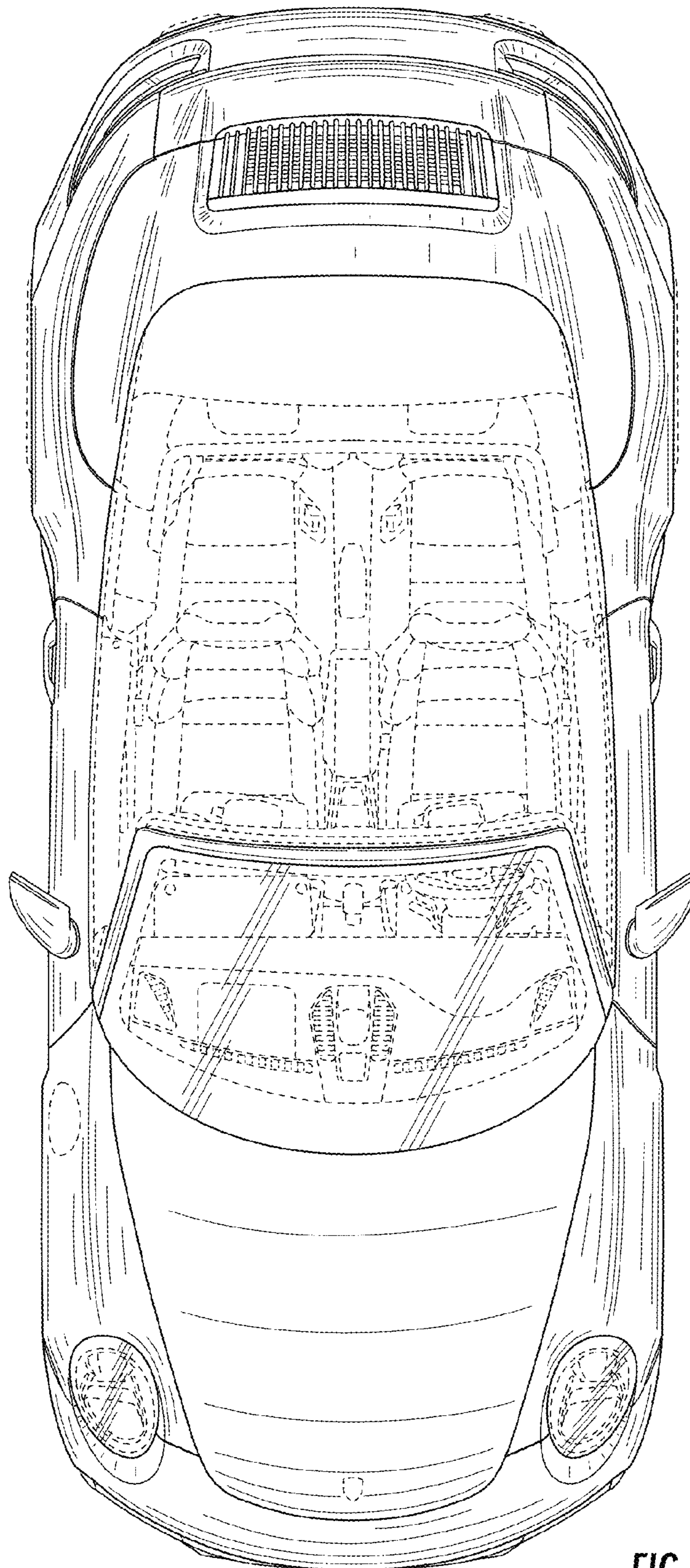
