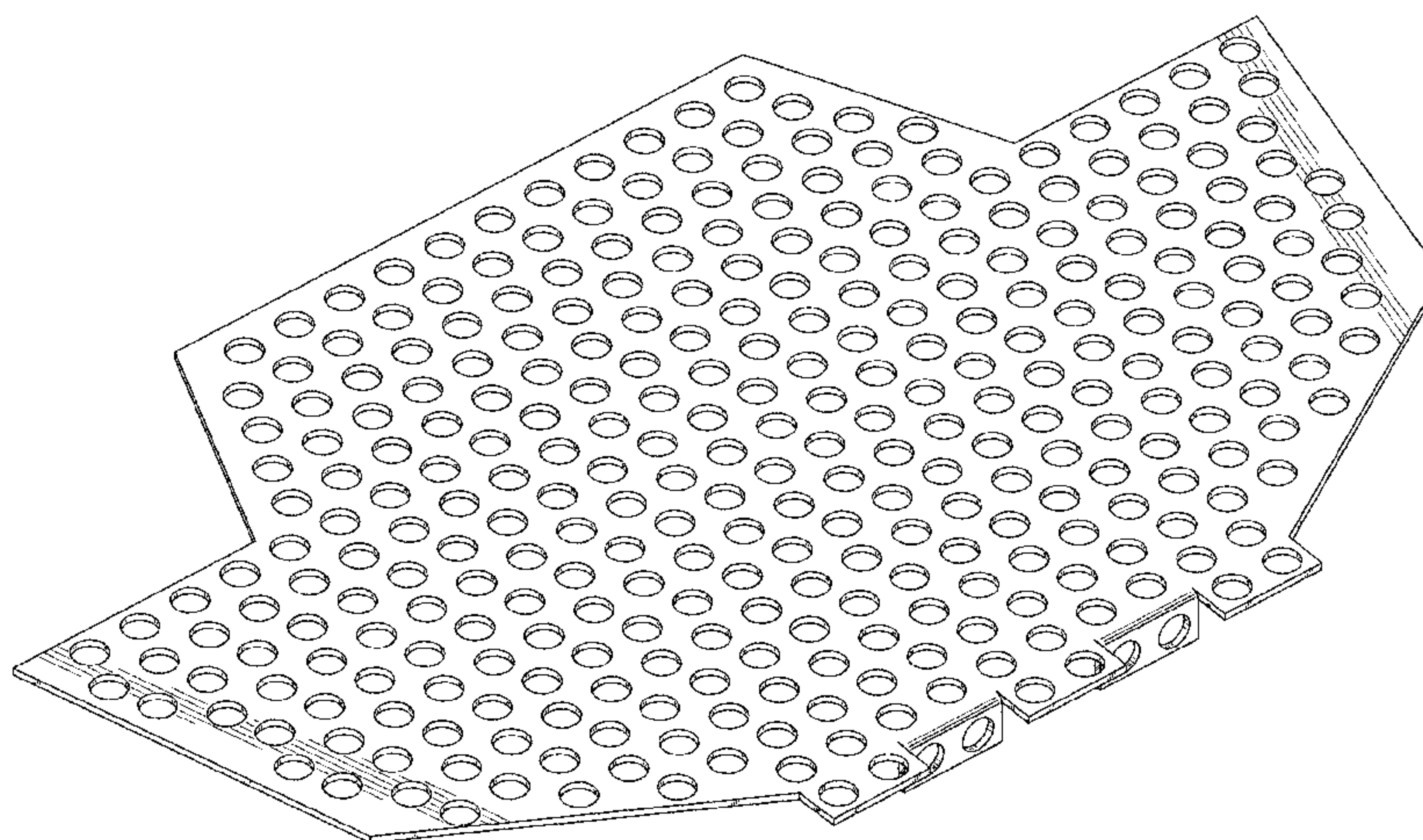
(57) **CLAIM**

The ornamental design for an all-terrain vehicle radiator guard, as shown and described.

**DESCRIPTION**

FIG. 1 is a top and front perspective view of the all-terrain vehicle radiator guard;  
FIG. 2 is a front elevation view thereof;  
FIG. 3 is a rear elevation view thereof;  
FIG. 4 is a left side elevation view thereof, the right side elevation view being a mirror image;  
FIG. 5 is a top plan view thereof; and,  
FIG. 6 is a bottom plan view thereof.

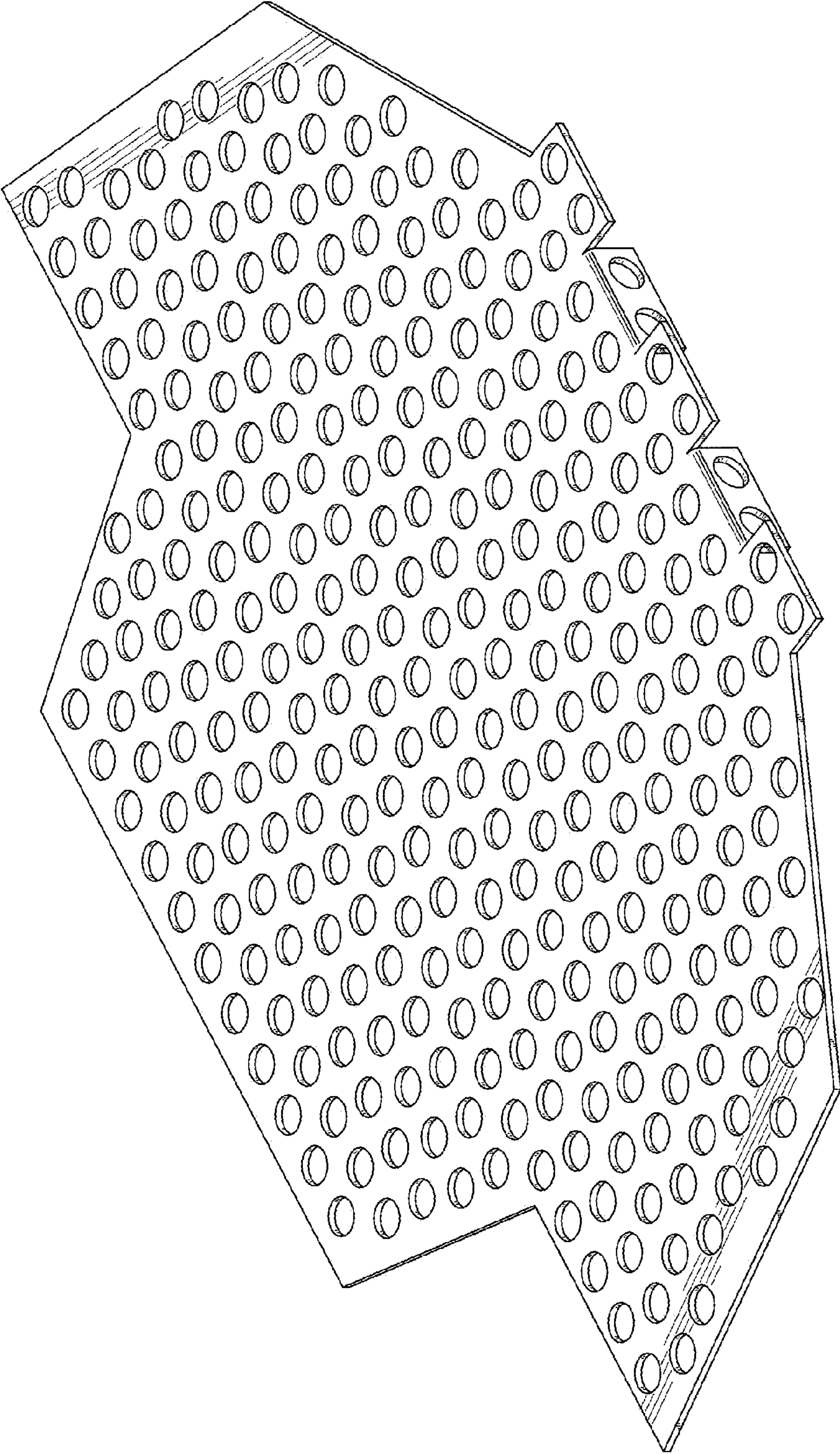

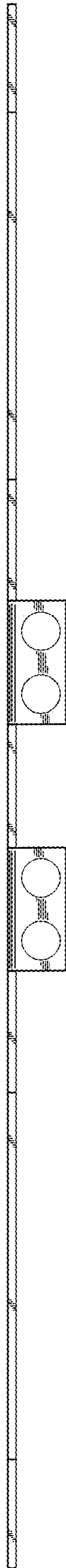

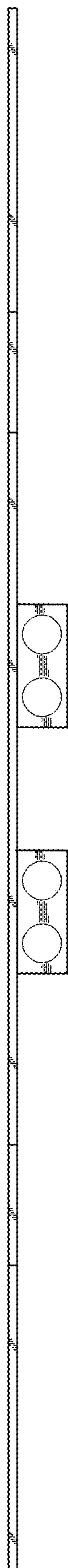

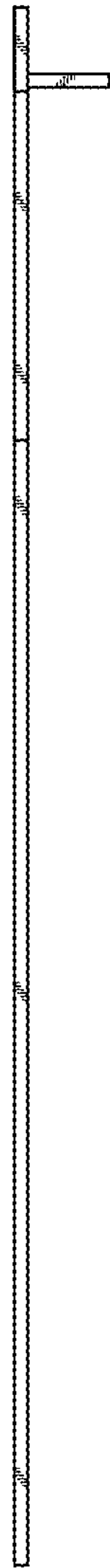

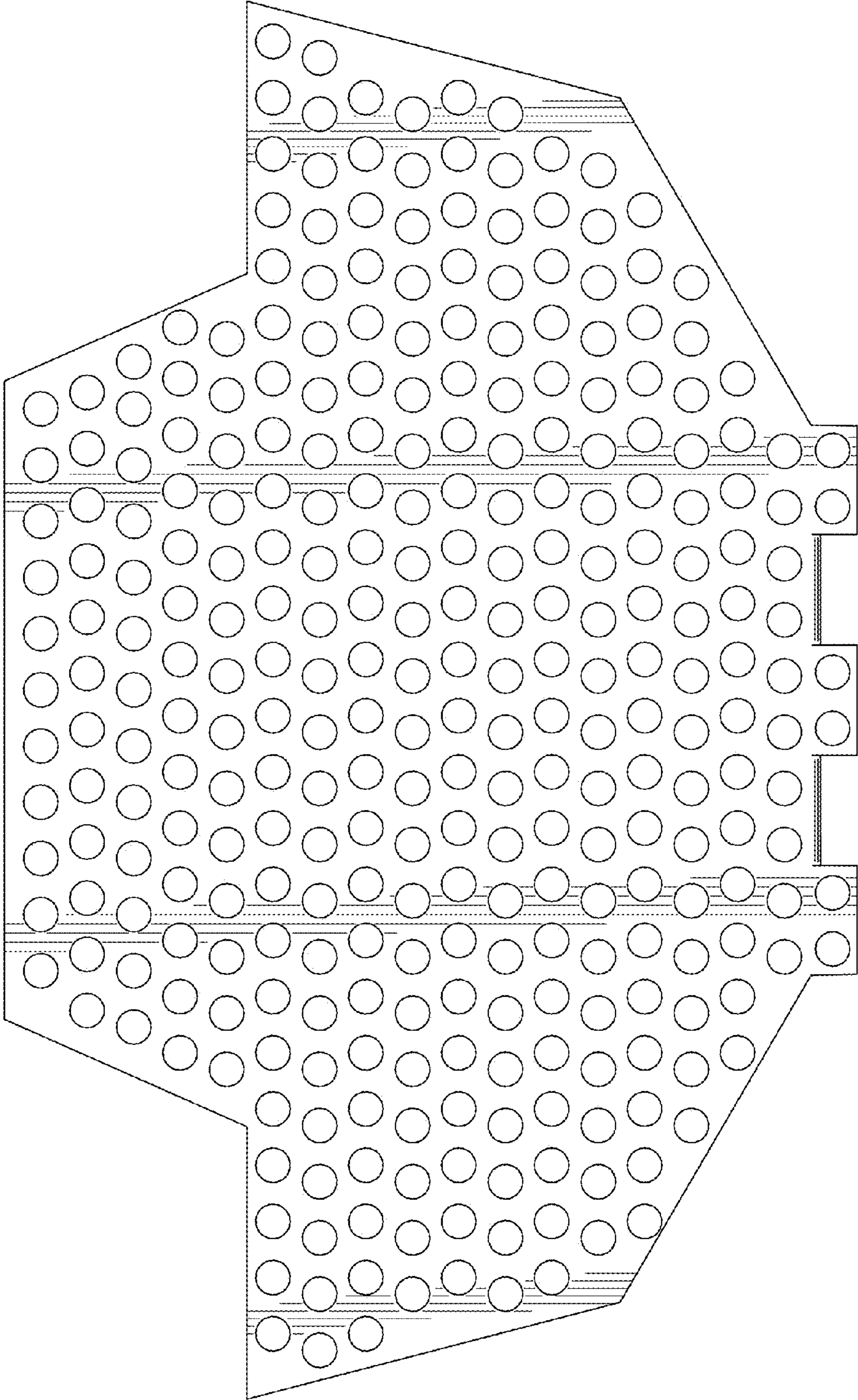

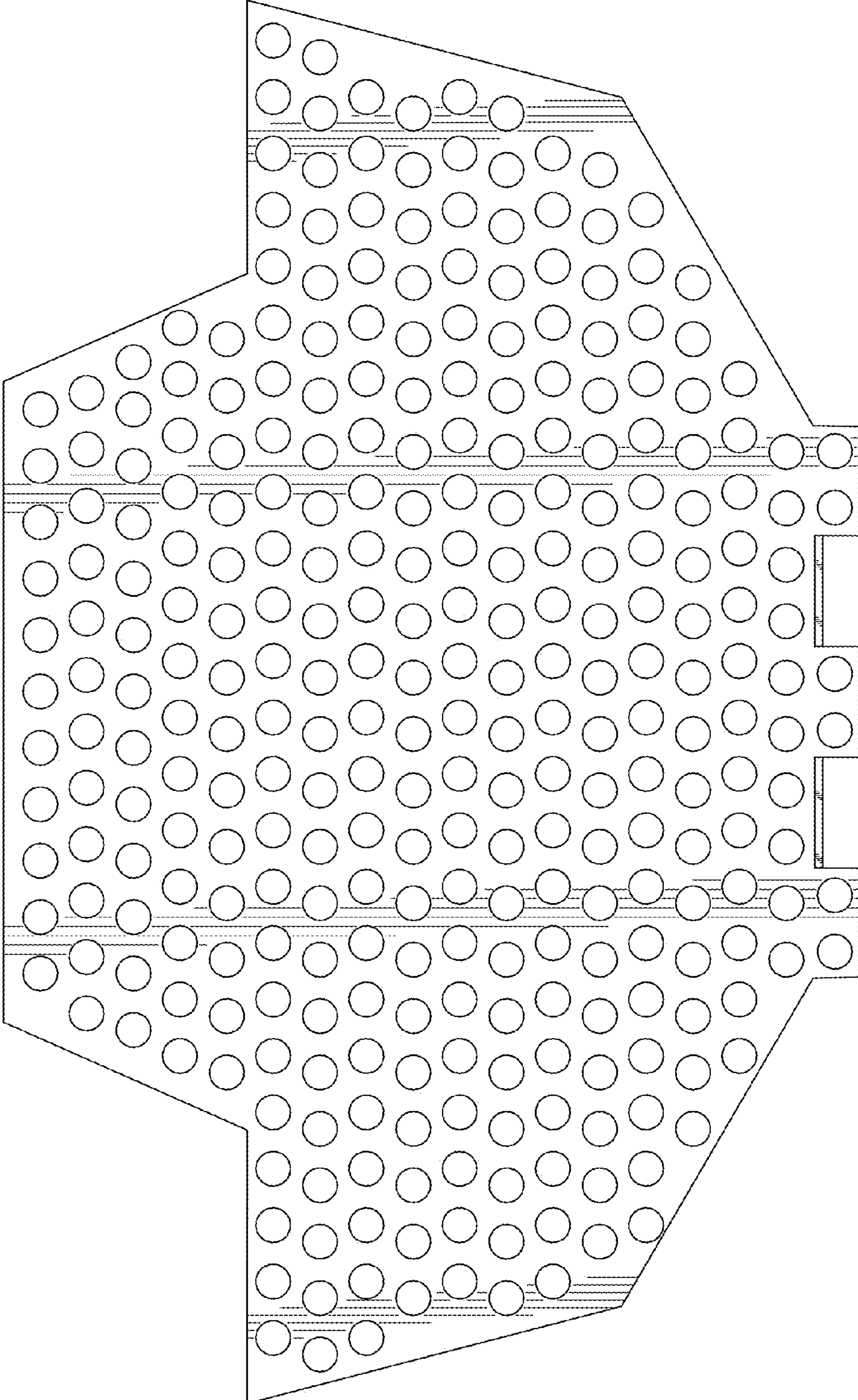
