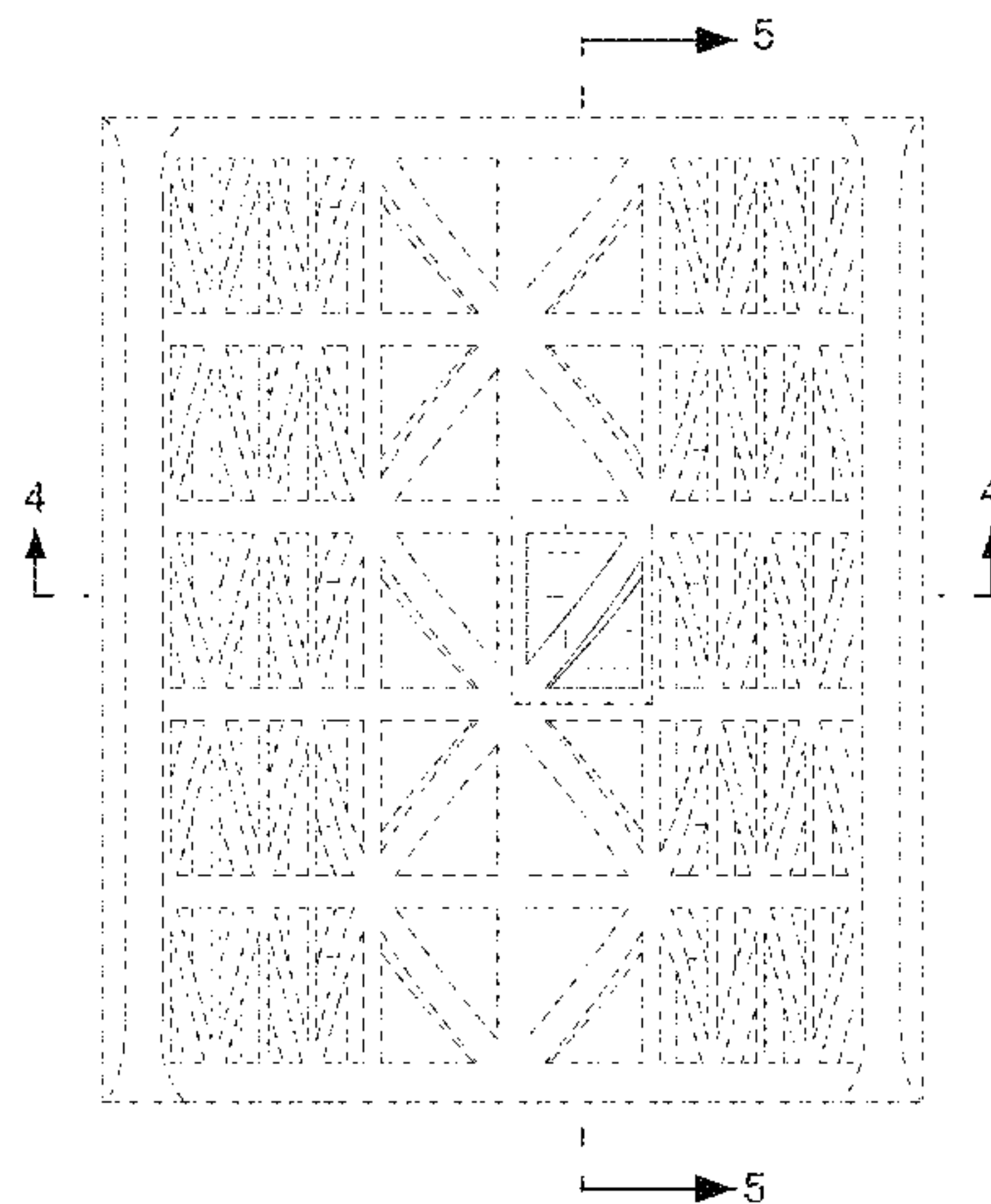
FIG. 1 is a perspective view of a gripping surface for crimping

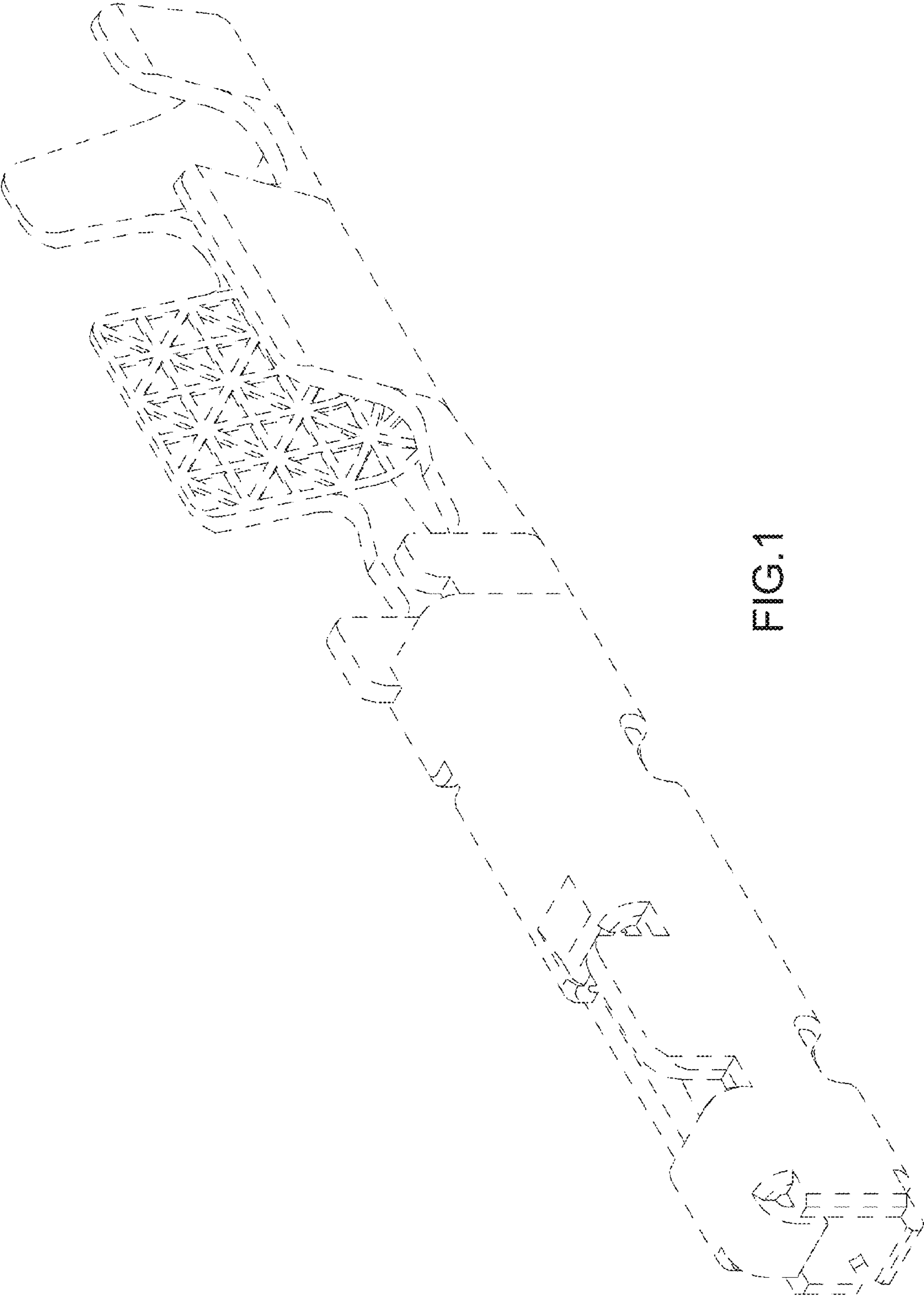

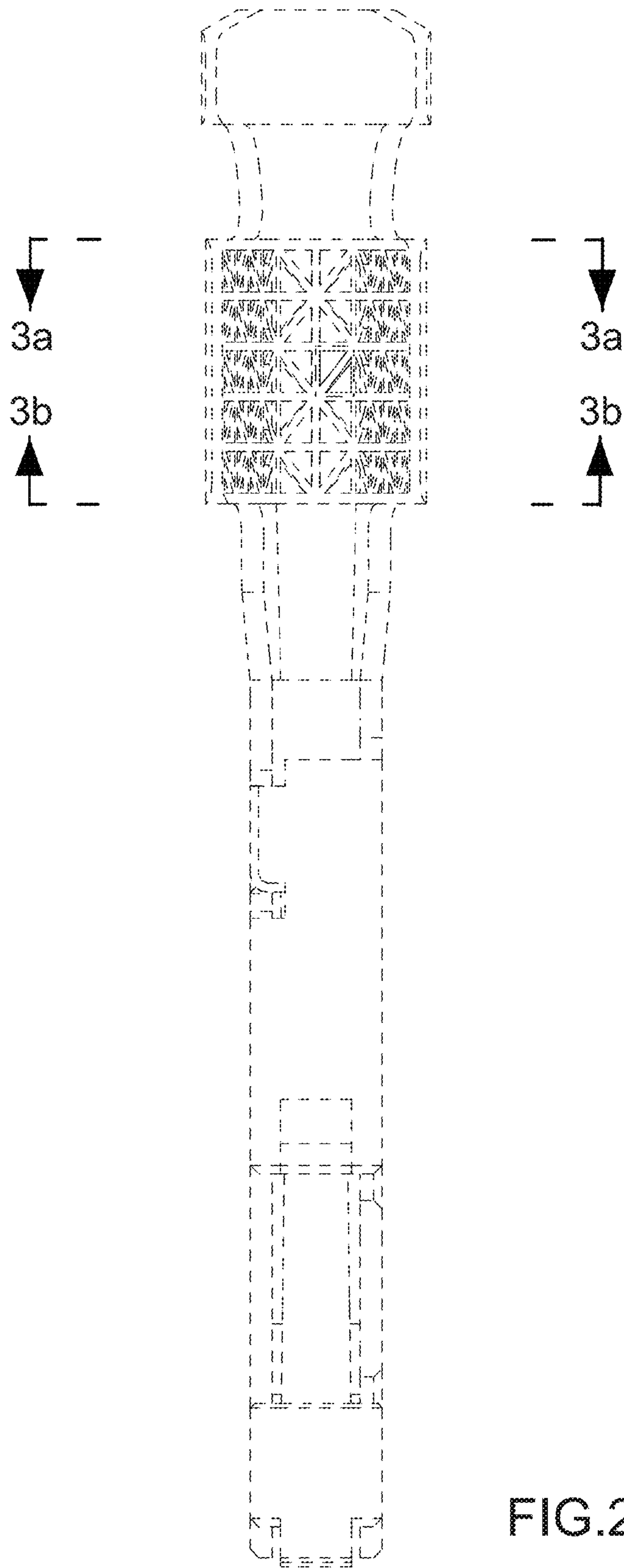

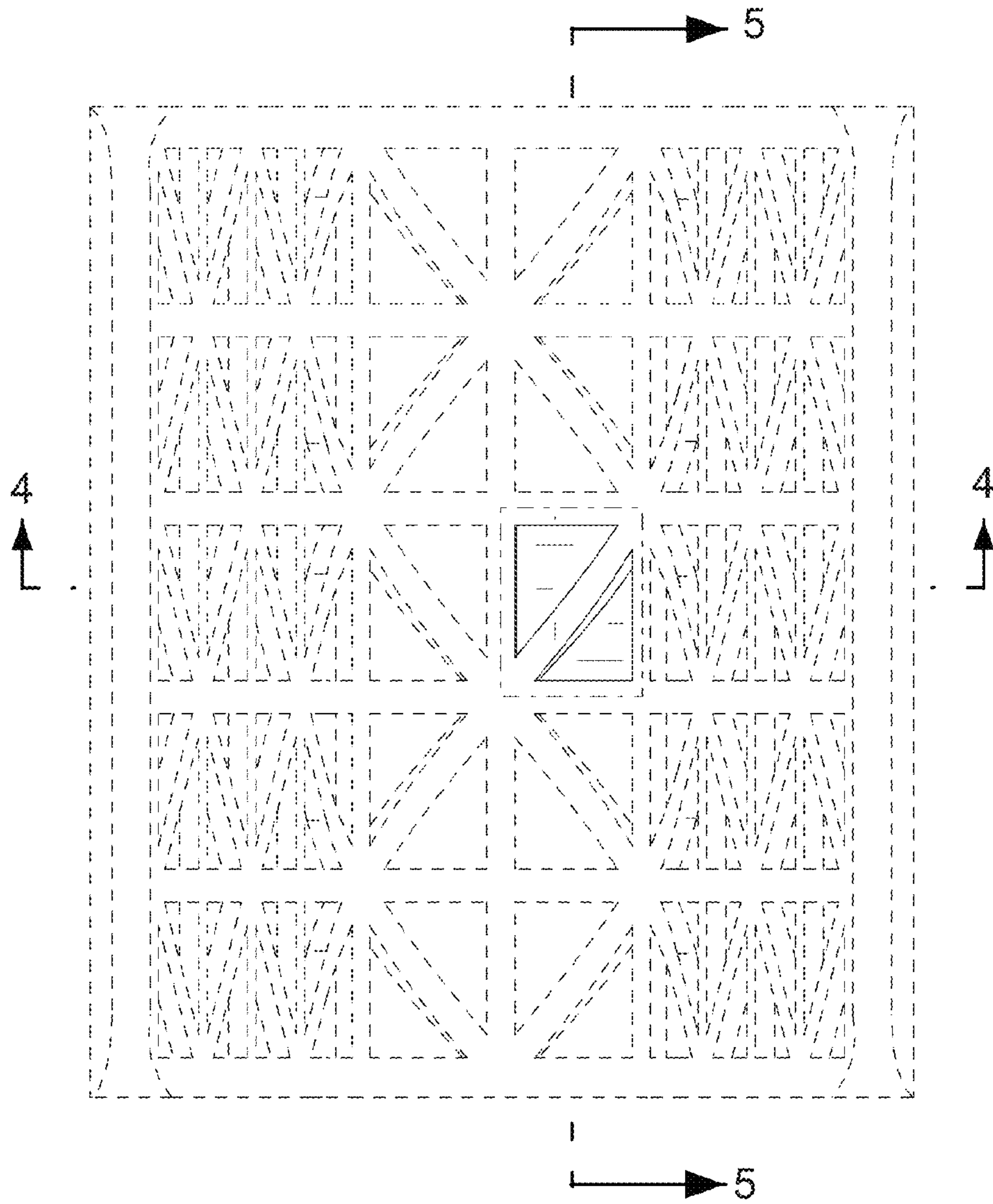

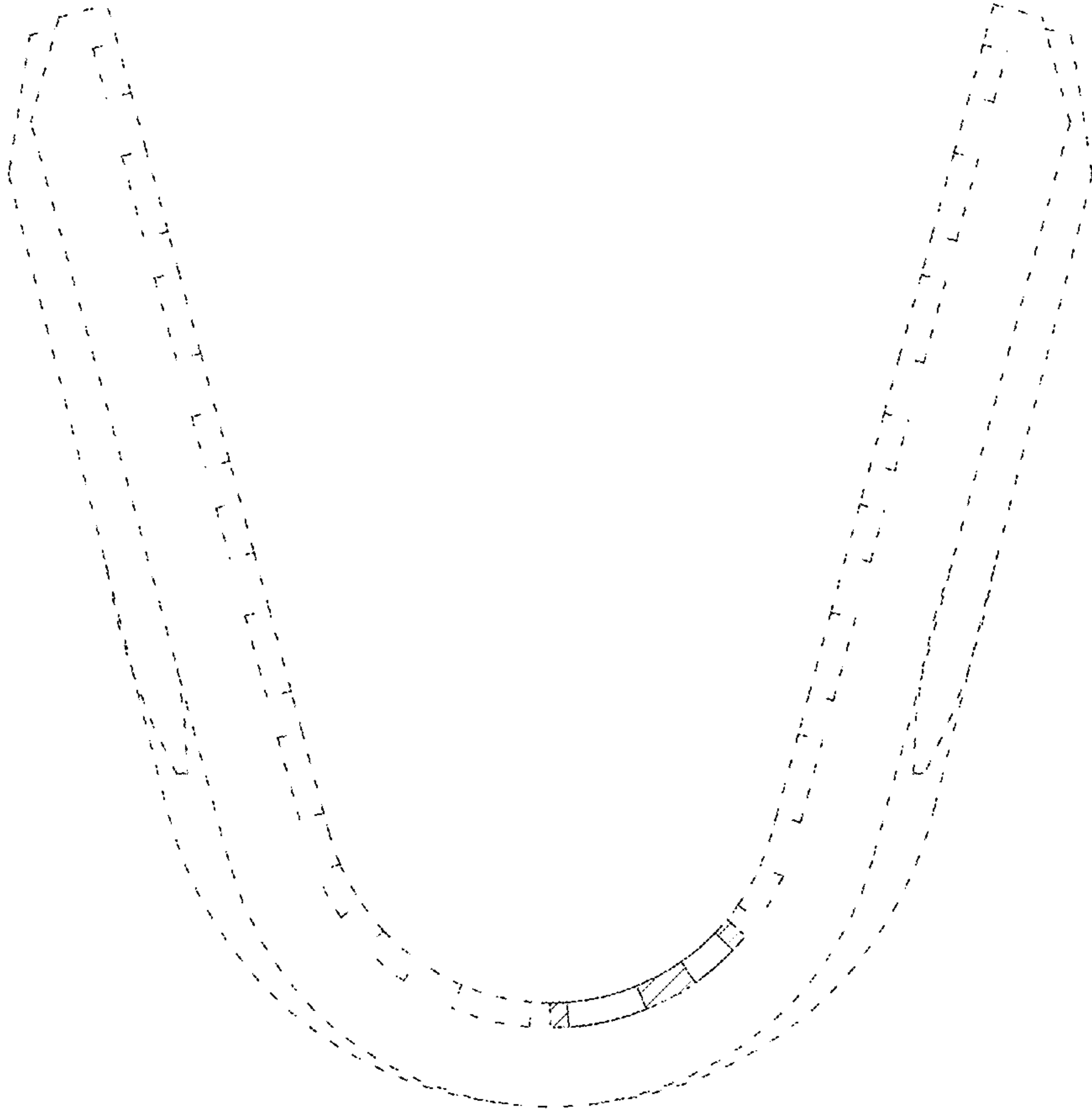

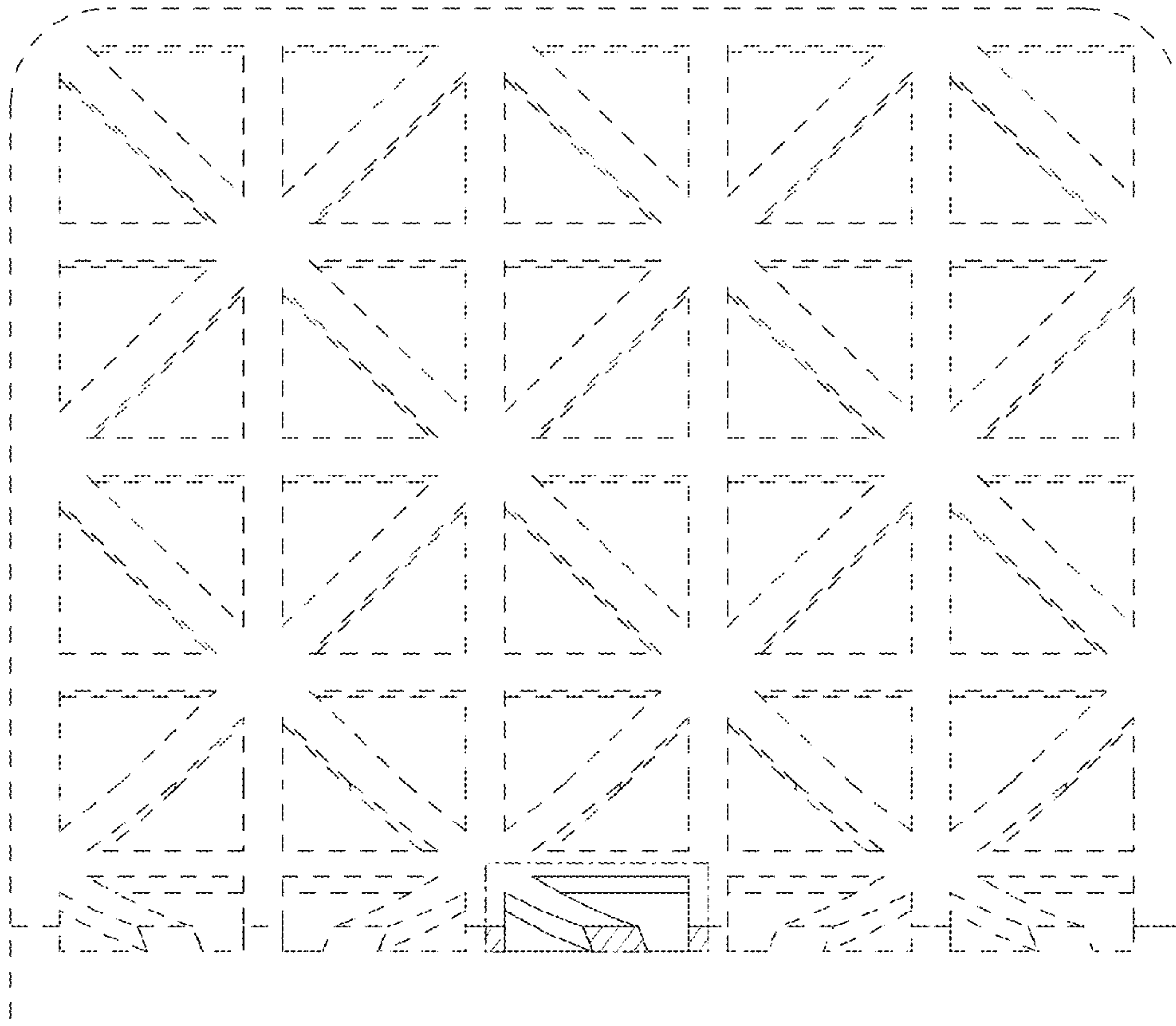

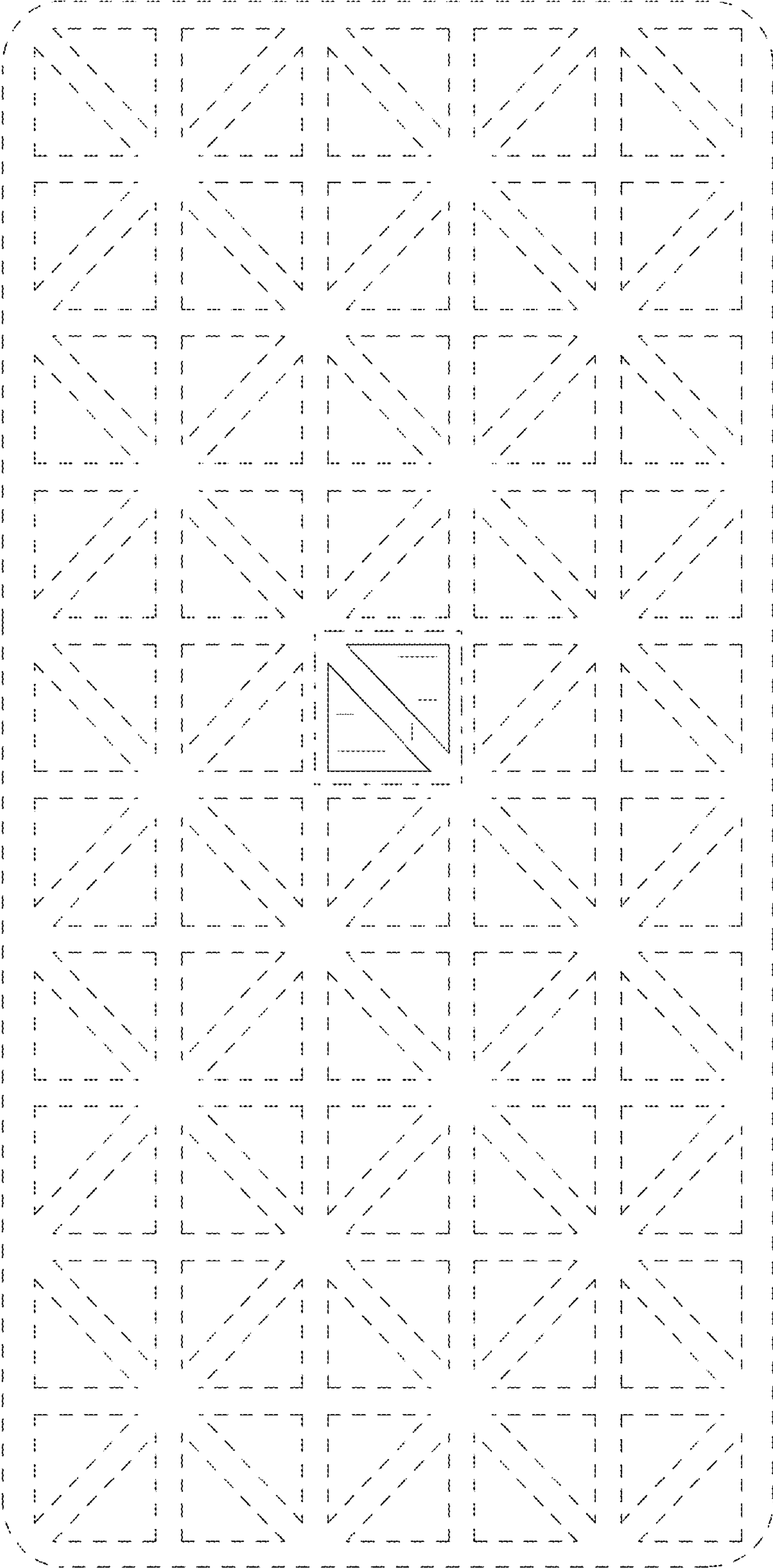

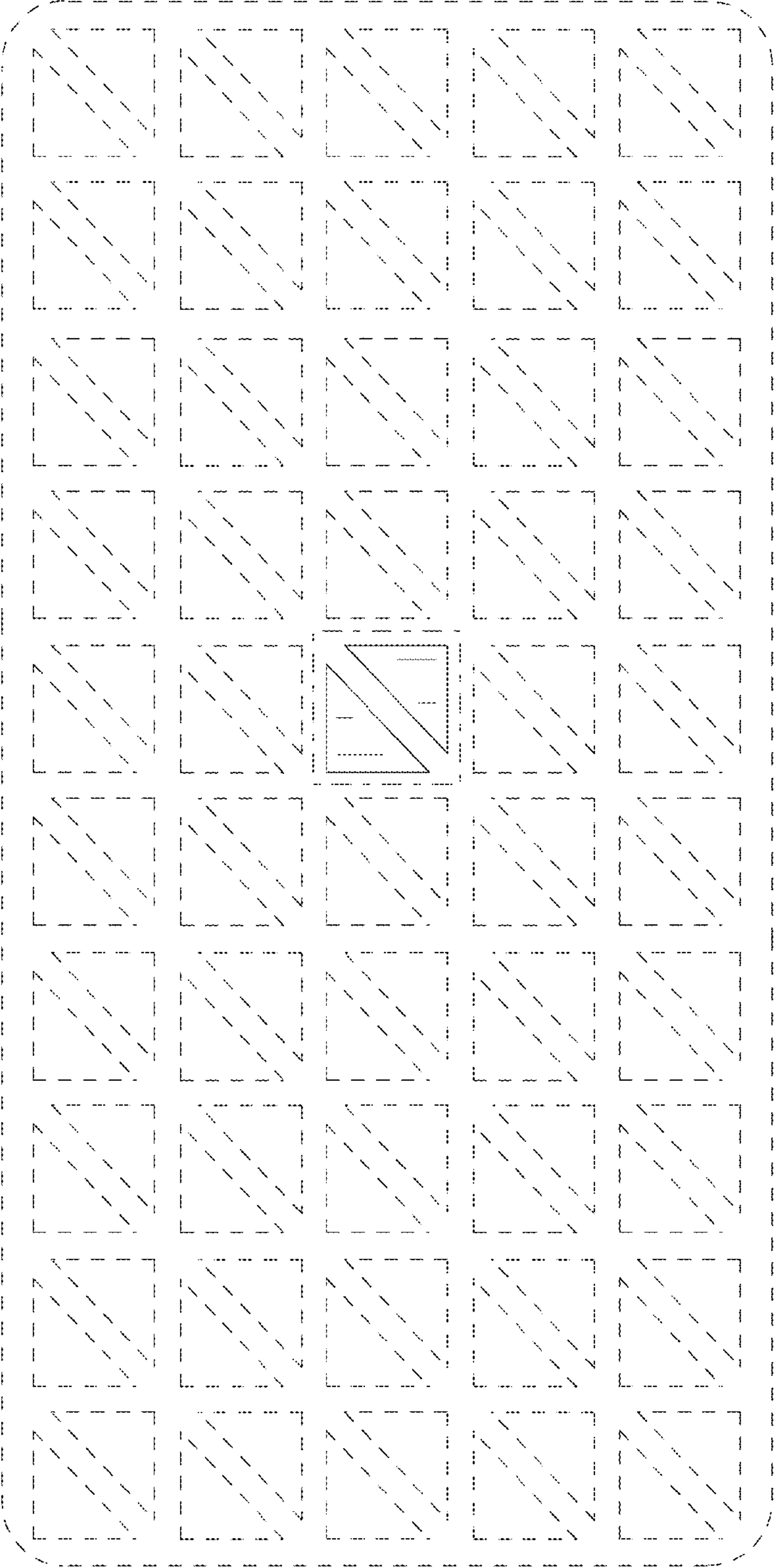
