DESCRIPTION

FIG. 1 is a perspective view taken from the top, front, and left side of the owl shaped sound machine of the present invention.

FIG. 2 is a front elevation view of the owl shaped sound machine of FIG. 1.

FIG. 3 is a left side elevation view of the owl shaped sound machine of FIG. 1, the opposite side being nearly a mirror image thereof.

FIG. 4 is a rear elevation view of the owl shaped sound machine of FIG. 1.

FIG. 5 is a top plan view of the owl shaped sound machine of FIG. 1; and,

FIG. 6 is a bottom plan view of the owl shaped sound machine of FIG. 1.

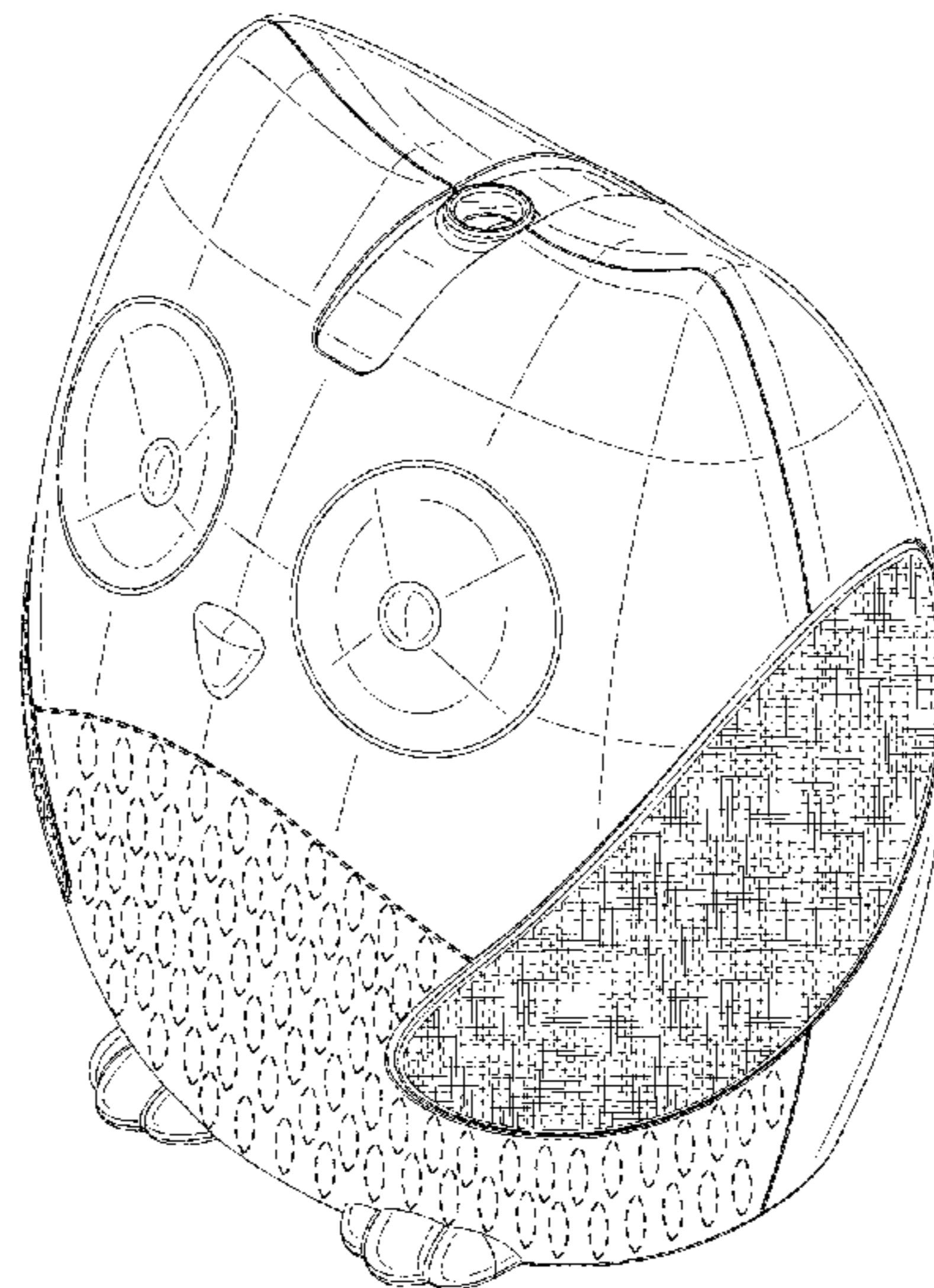

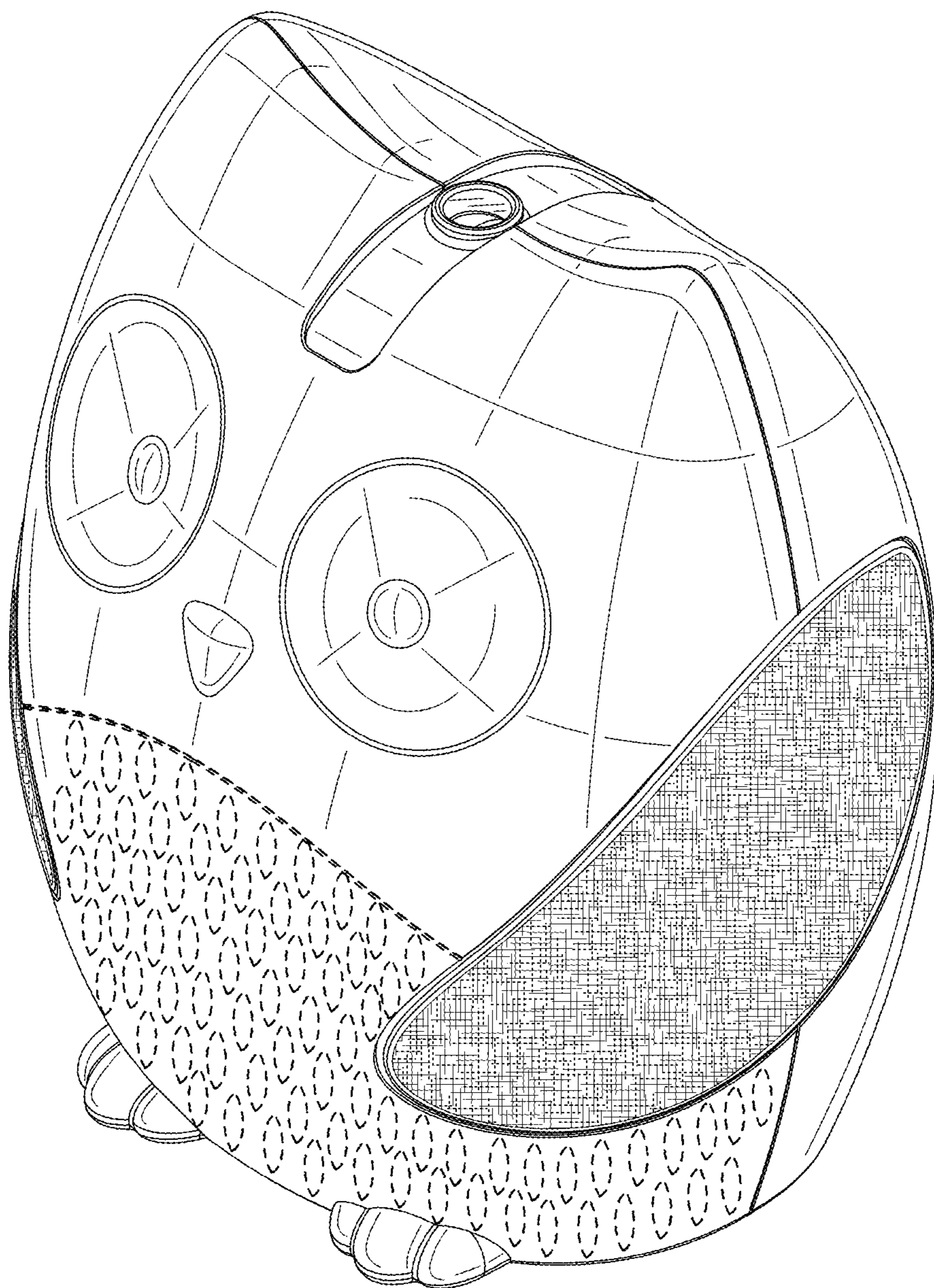

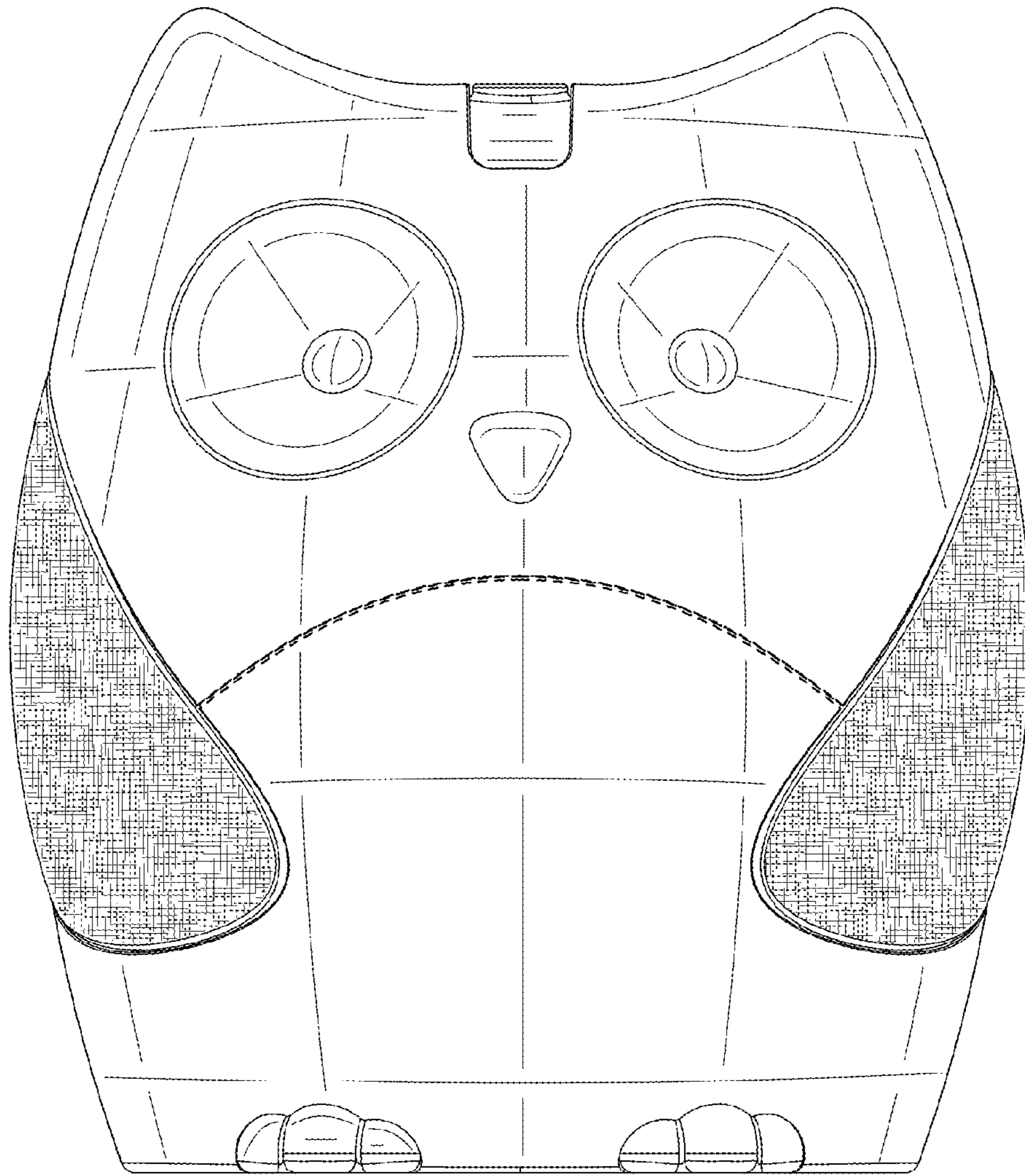

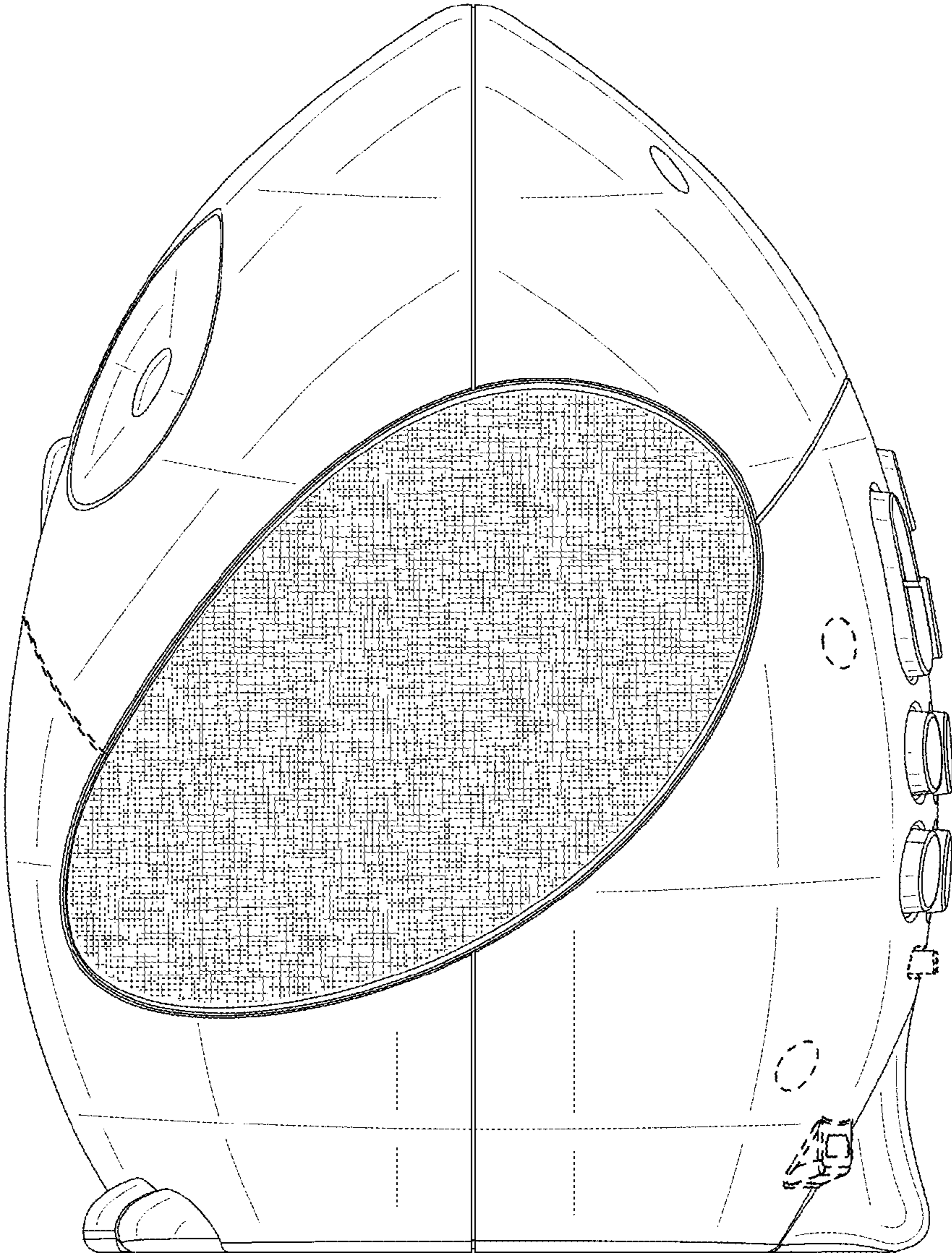

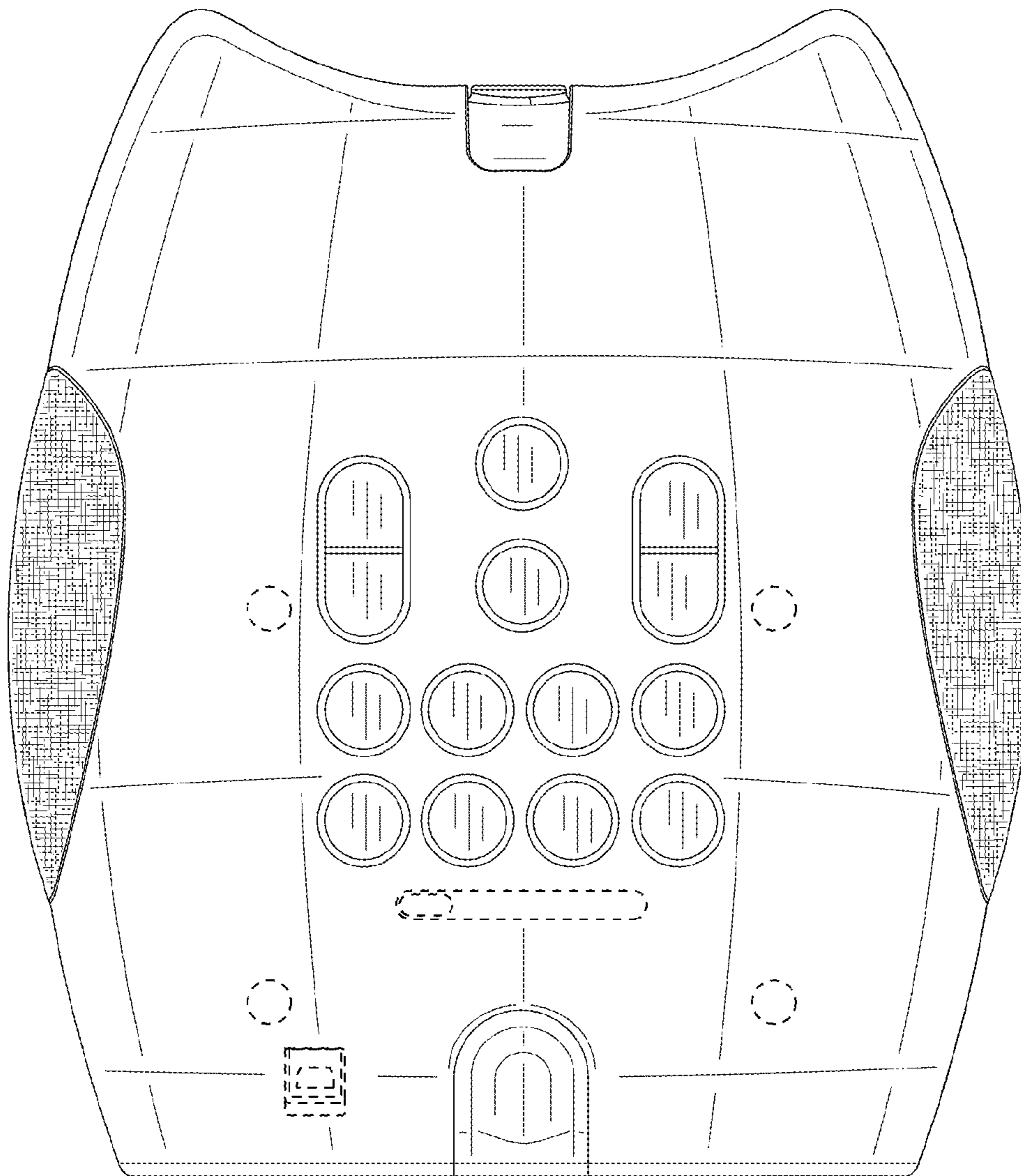

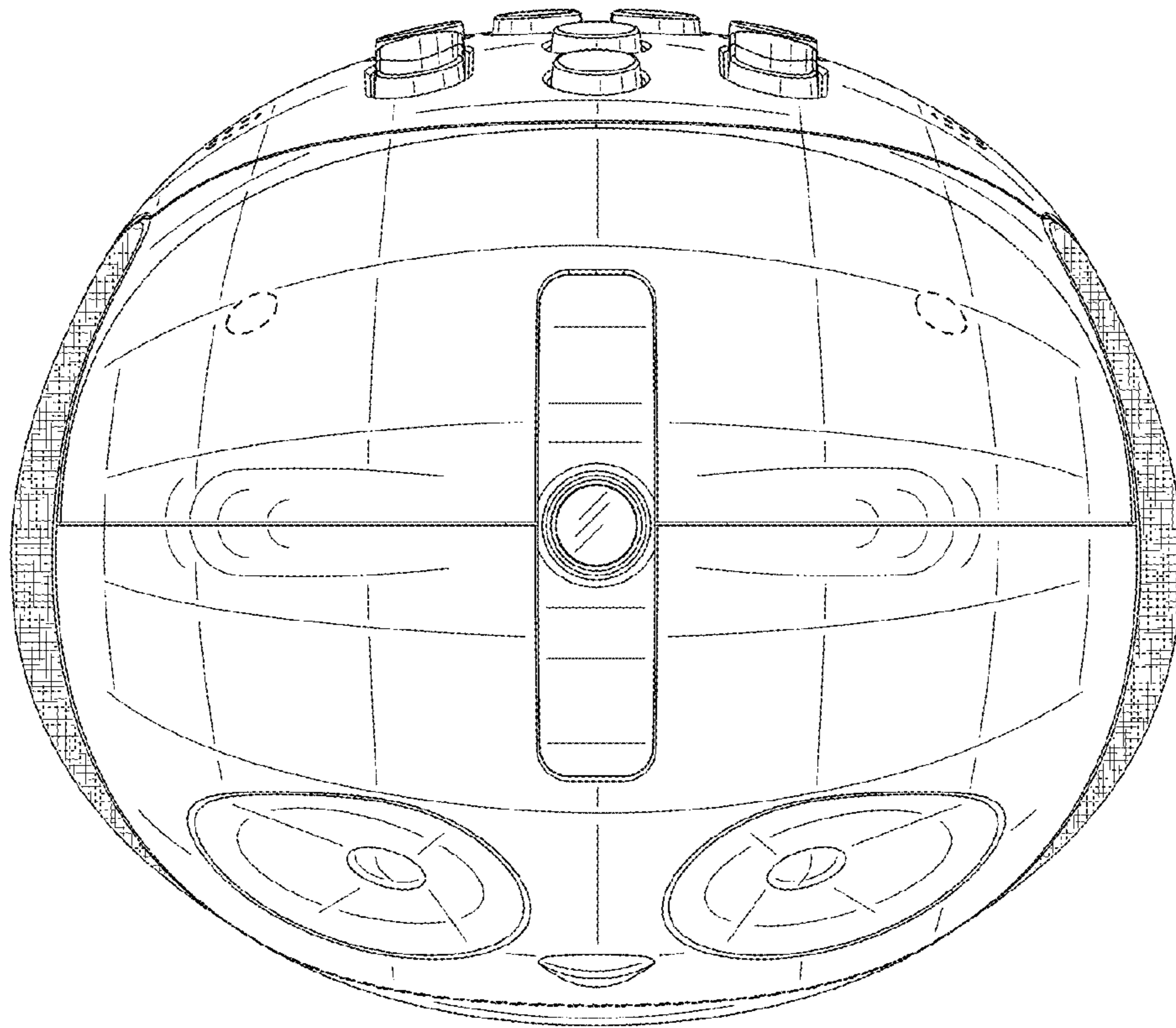

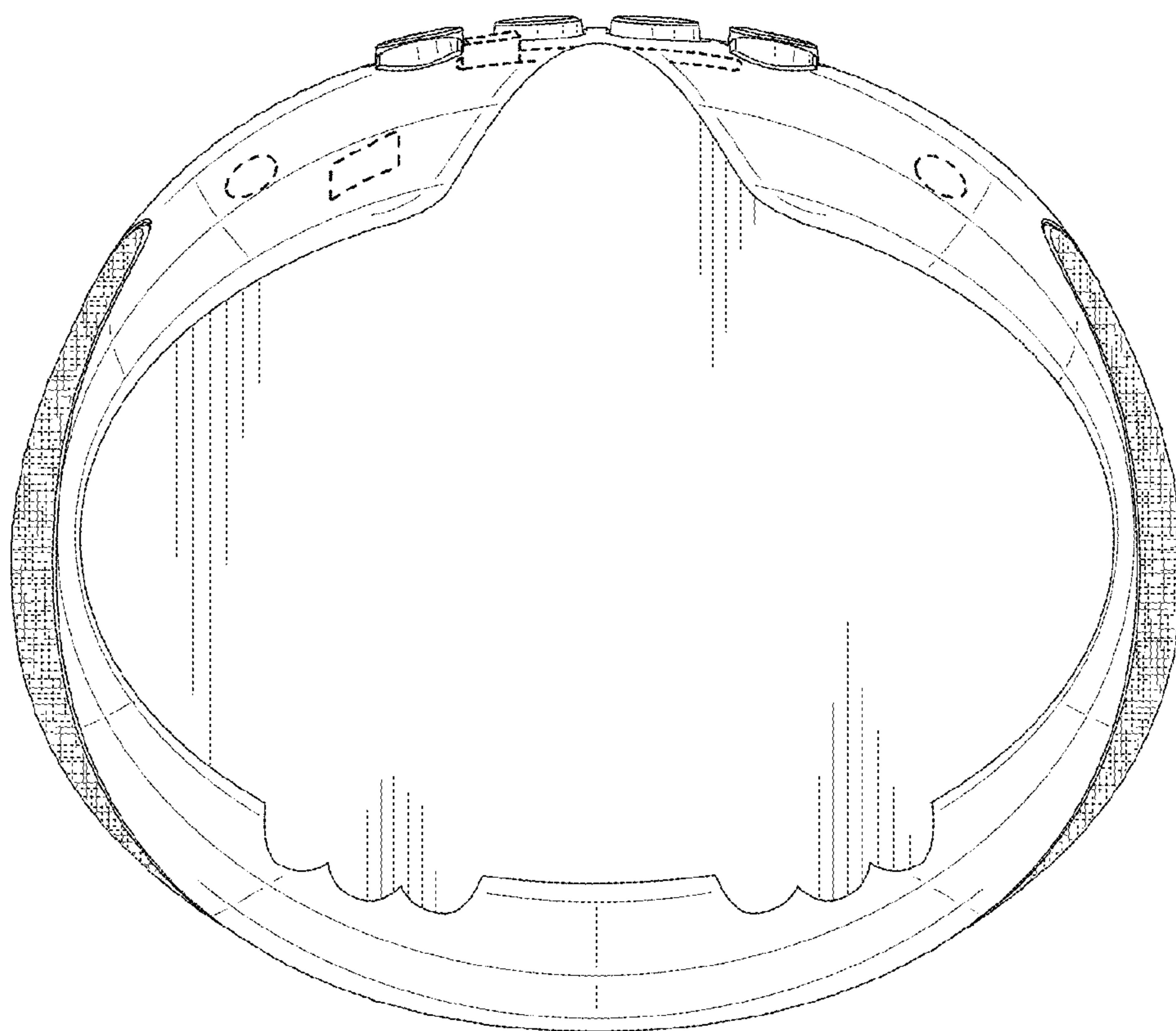
