(57) **CLAIM**

We claim the ornamental design for a display of a multimedia terminal with transitional graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a first image of a display of a multimedia terminal with transitional graphical user interface showing our new design:

FIG. 2 is a second image thereof;

FIG. 3 is a third image thereof;

The broken lines in FIGS. 1-13 represent unclaimed portions of the display of a multimedia terminal with transitional graphical user interface and form no part of the claimed design.

The appearance of the transitional image sequentially transitions between the images shown in FIGS. 1-13. The process or period in which one image transitions to another image forms no part of the claimed design.

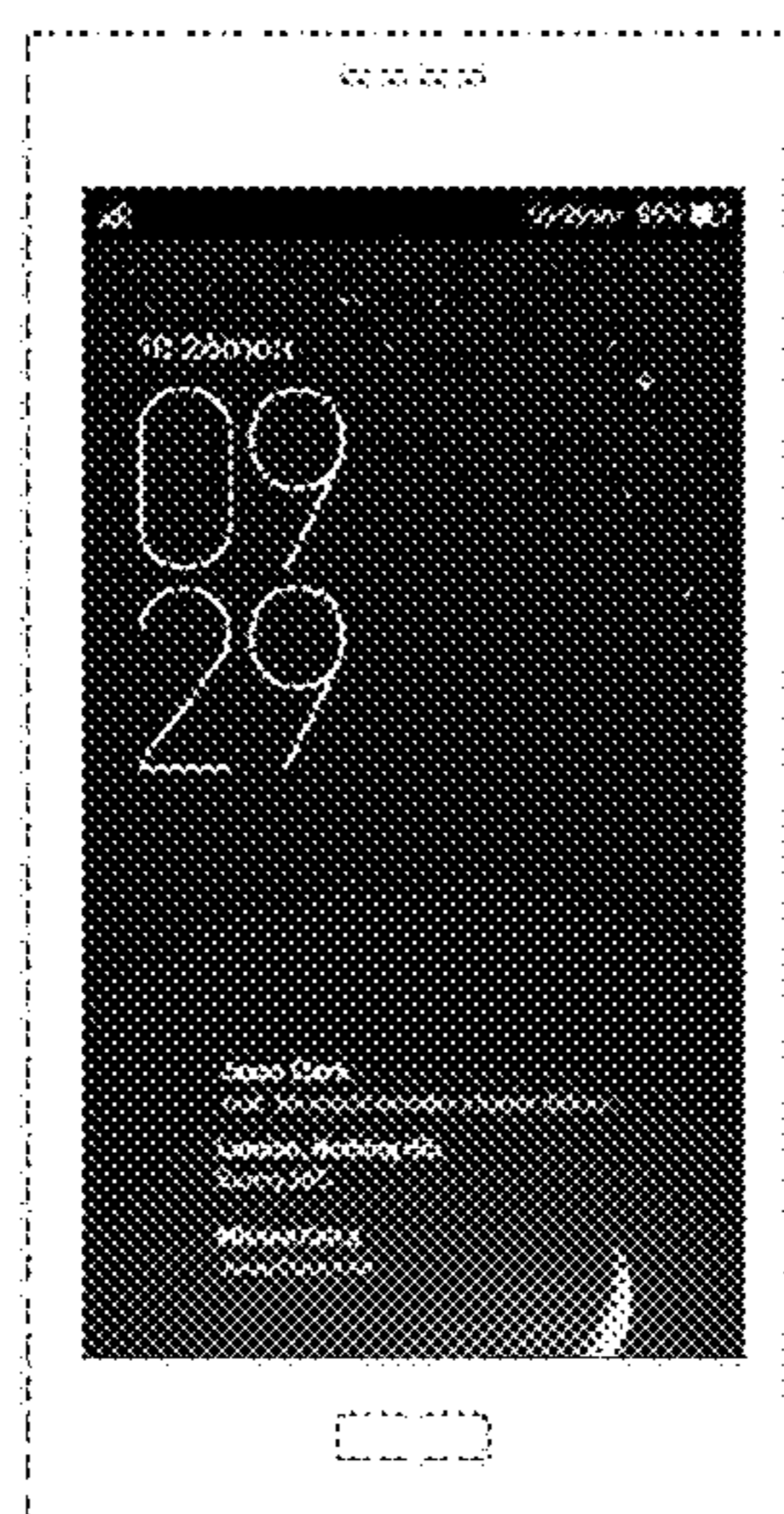

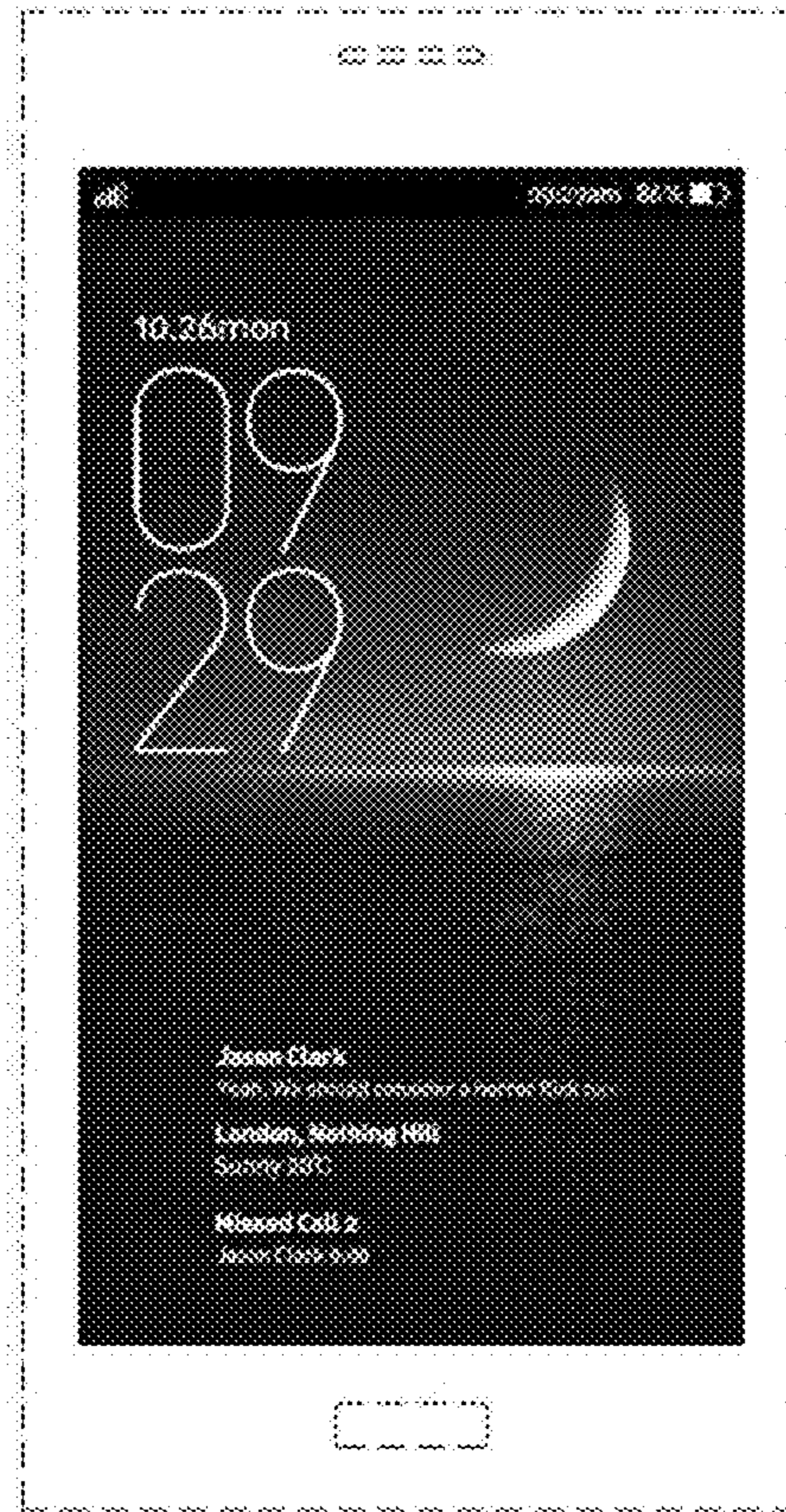
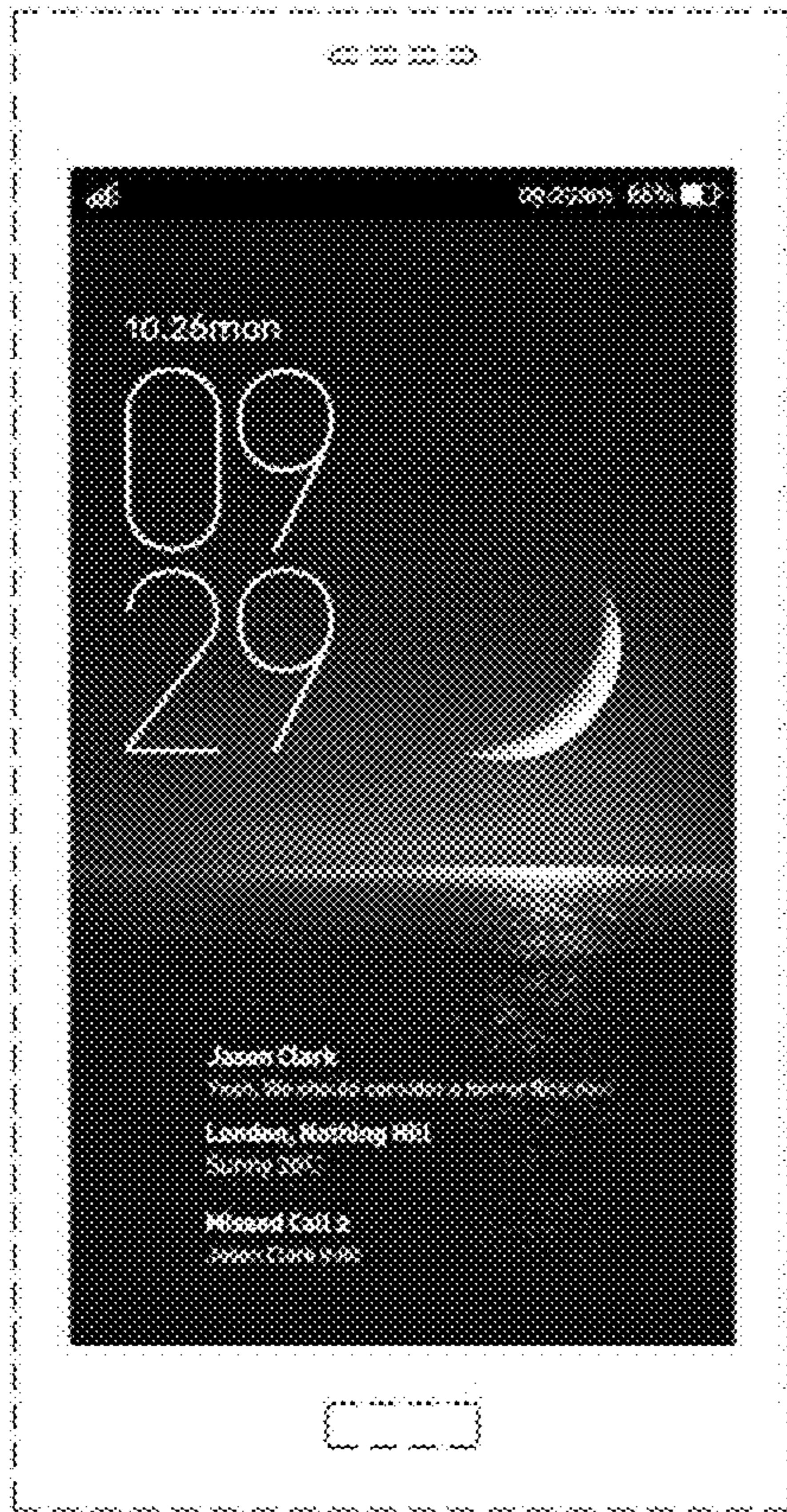

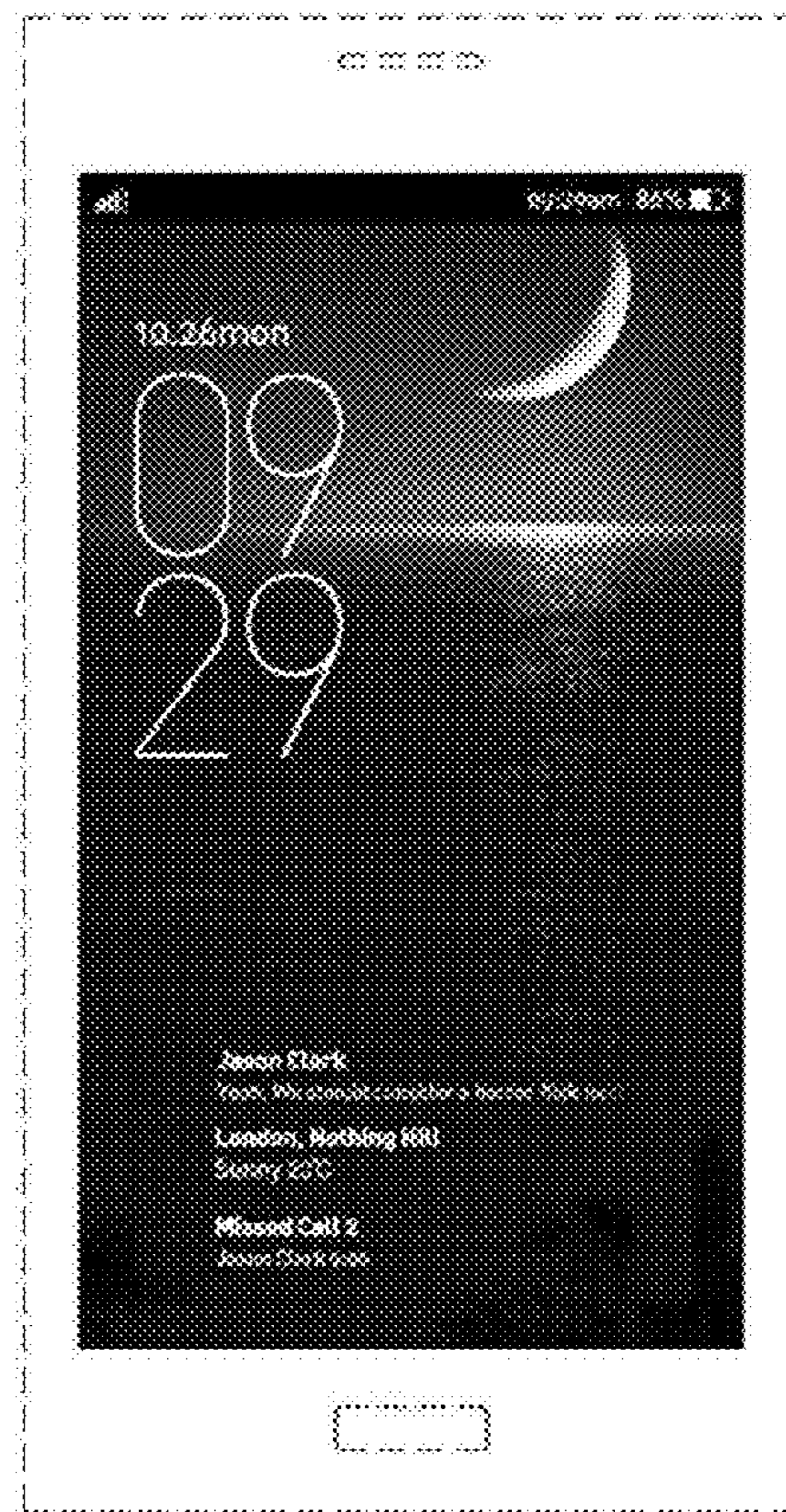
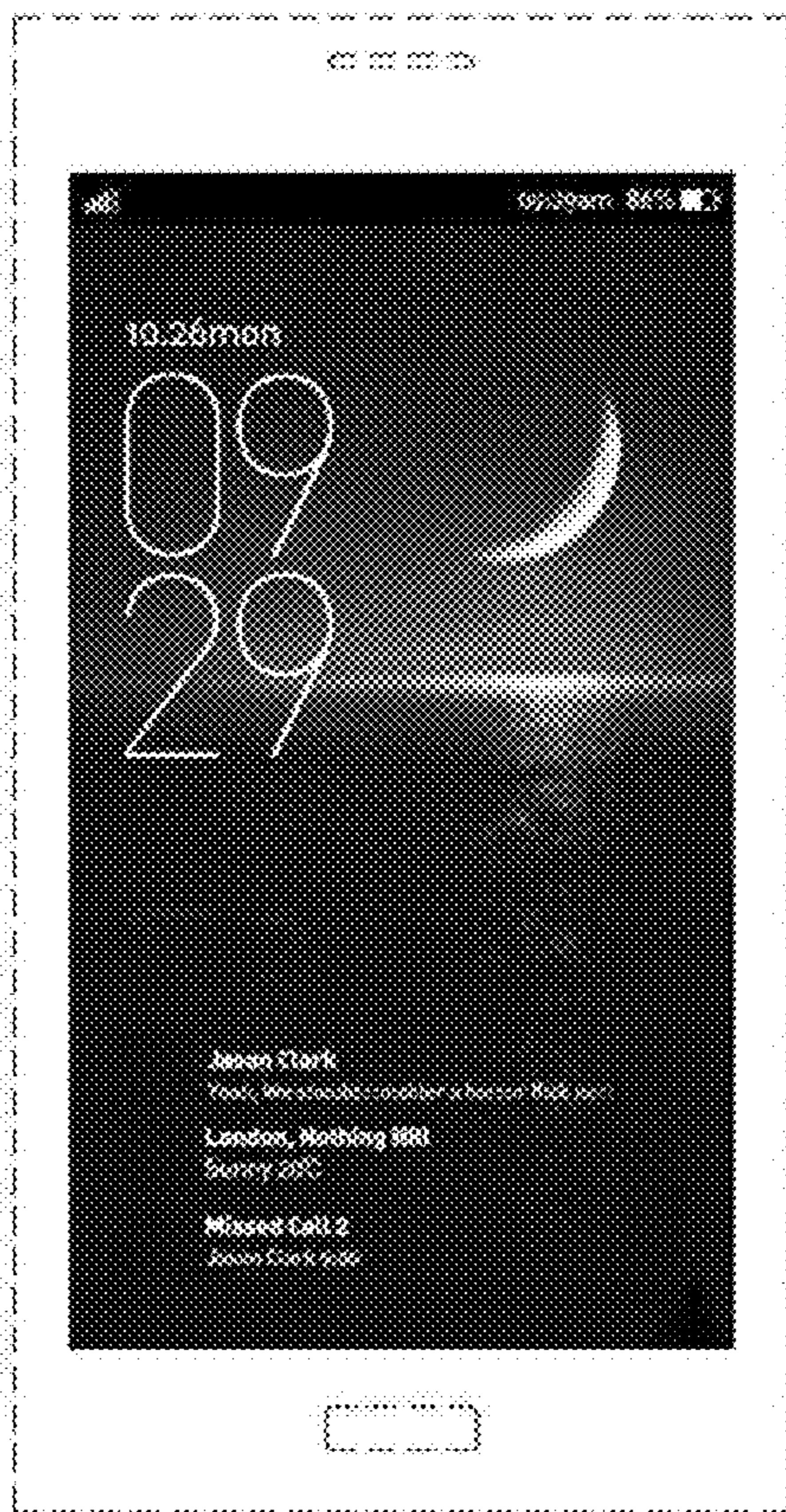

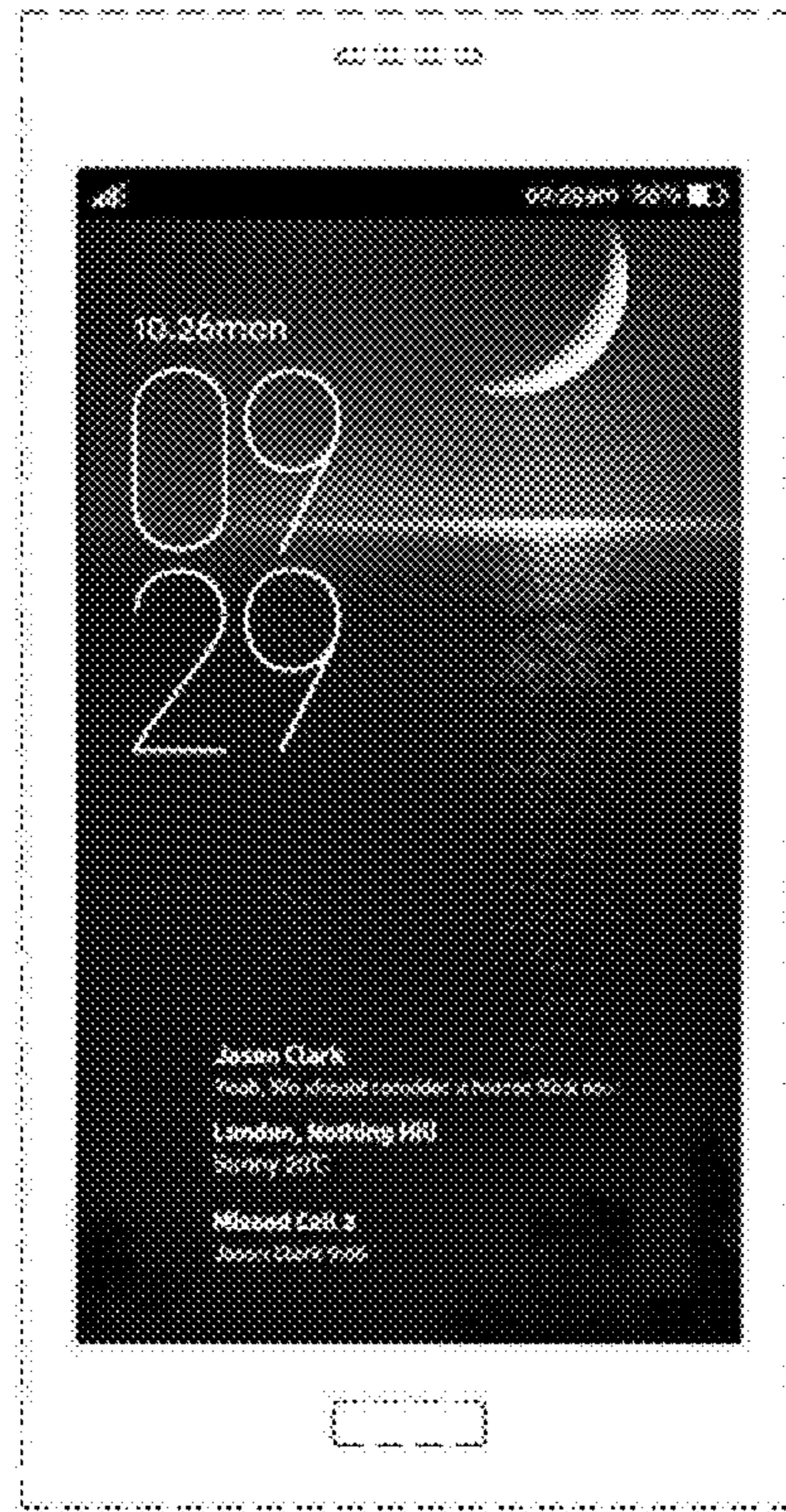

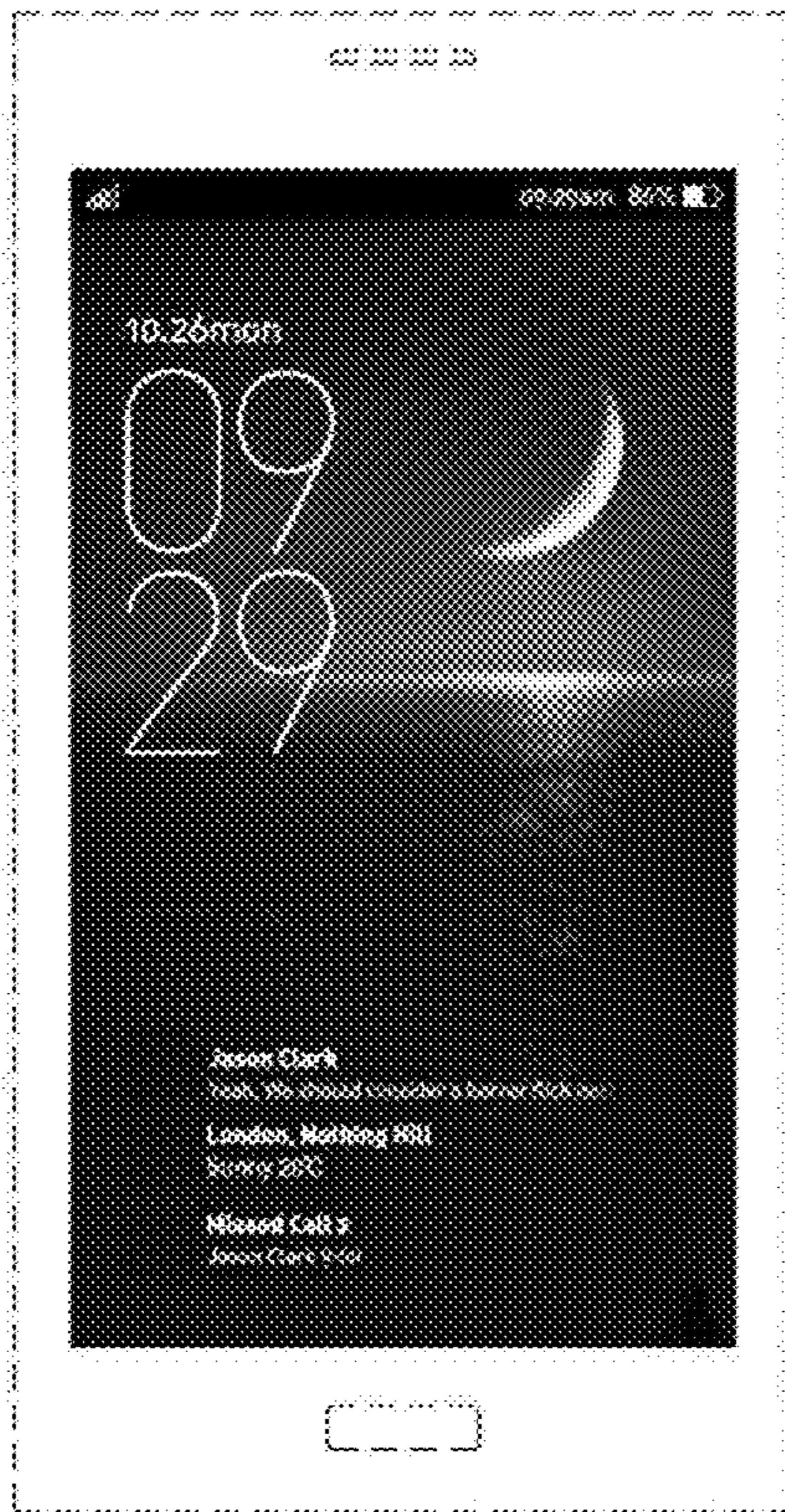

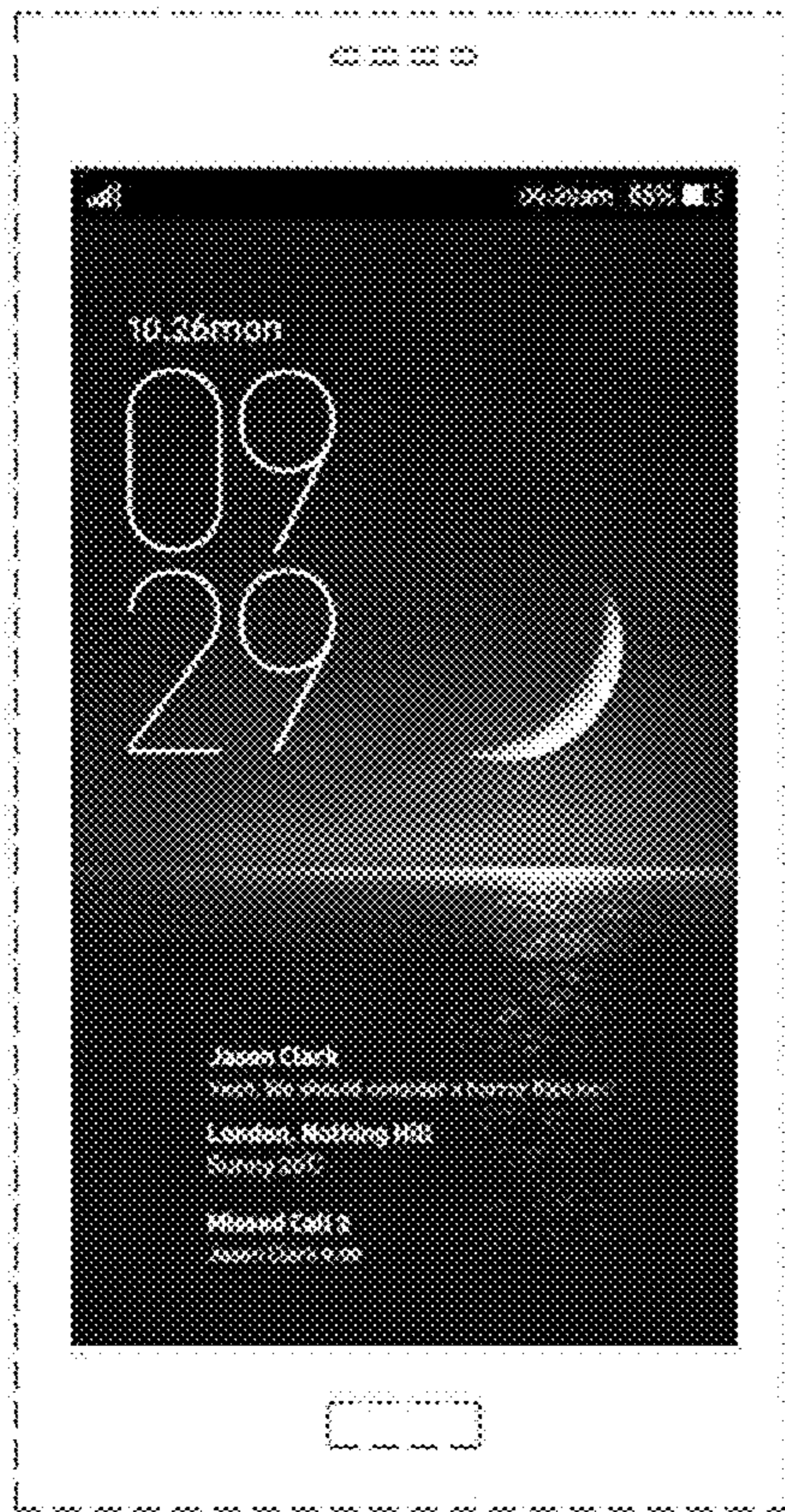
