(57) **CLAIM**

The ornamental design for a financial transaction card, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a financial transaction card showing our design; and, FIG. 2 is a front view of the financial transaction card shown in FIG. 1.

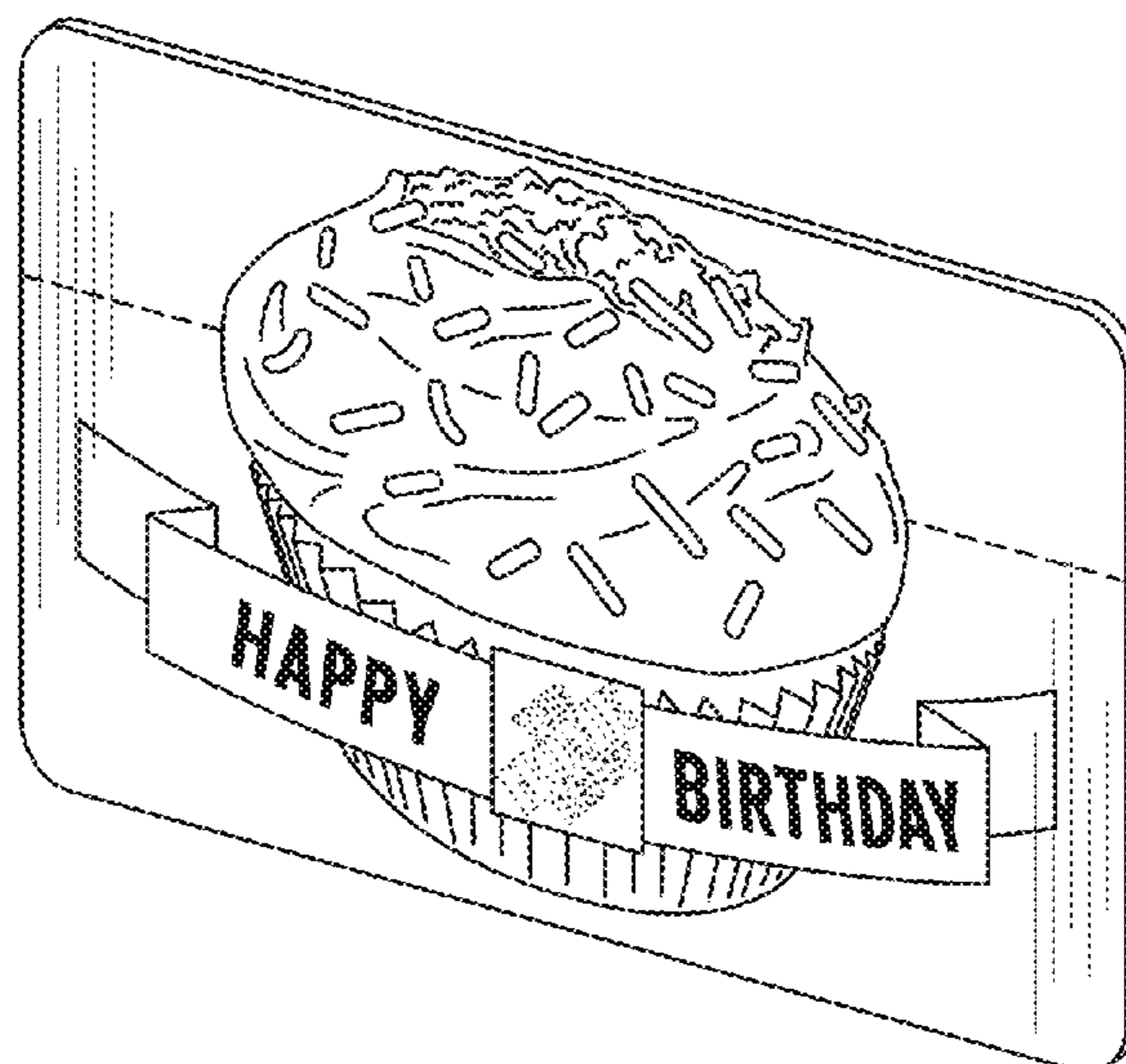

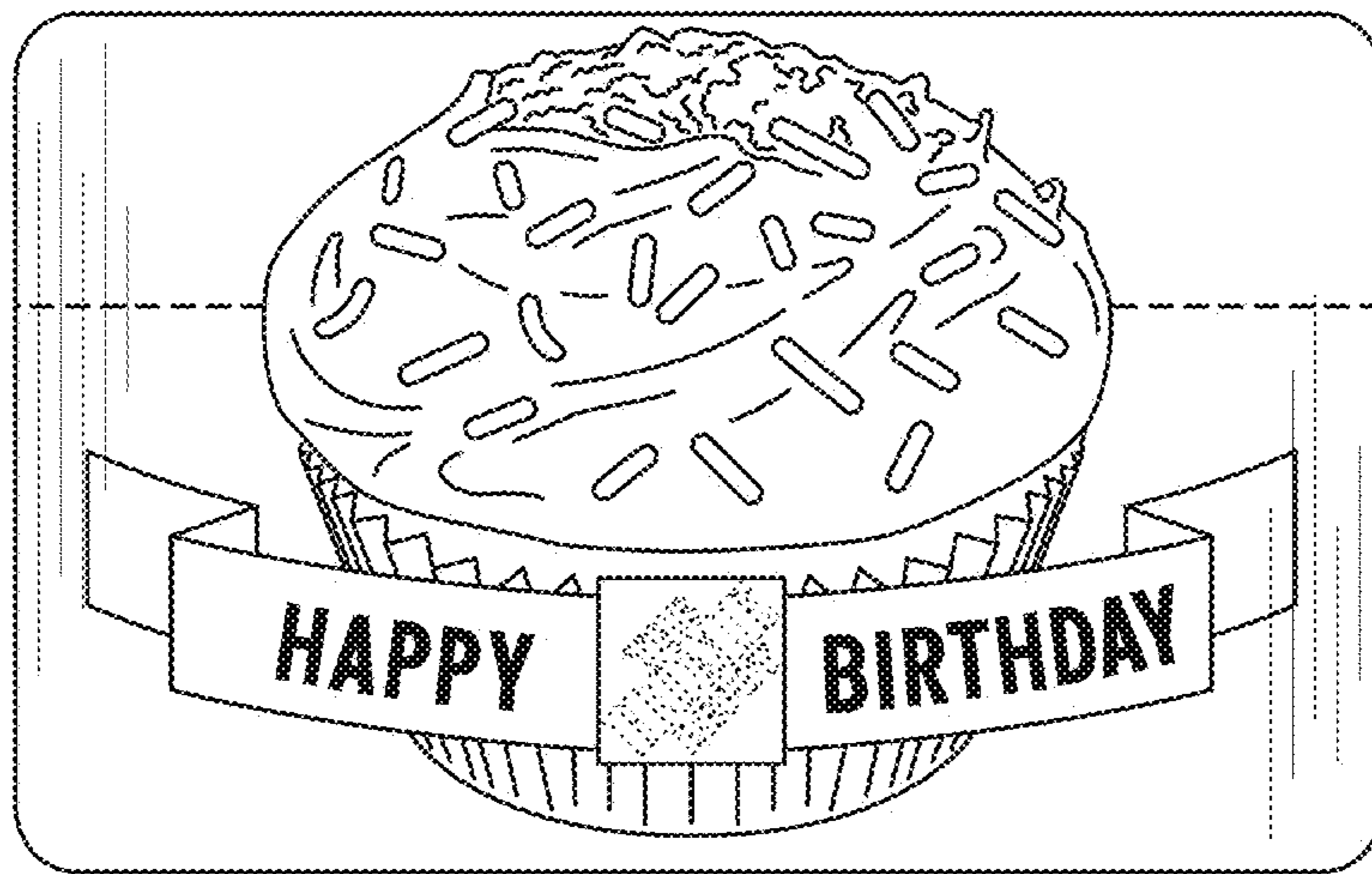
